# M ultiscale simulations in simple metals: a density-functional based methodology

We present a form alism for coupling a density functional theory-based quantum simulation to a classical simulation for the treatment of simple metallic systems. The form alism is applicable to multiscale simulations in which the part of the system requiring quantum -mechanical treatment is spatially conned to a small region. Such situations often arise in physical systems where chemical interactions in a small region can a ect the macroscopic mechanical properties of a metal. We describe how this coupled treatment can be accomplished e ciently, and we present a coupled simulation for a bulk alum inum system.

#### I. IN TRODUCTION

In perform ing computer simulations of complex physical systems, a premium is placed on accuracy and e ciency. Typically, one of these qualities can be in proved at the expense of the other. In recent years, a new approach has em erged that addresses a class of problem s in which important small-length-scale phenomena are conned to a small region of the system but can have an im pact on the behavior over a much larger scale. A typical case is the tip of a crack, where localized chem ical reactions m ay a ect the strength of interatom ic bonding, which in turn can in uence in a dram atic way the macroscopic mechanical properties of the solid. Such problem s fall under the rubric of \m ultiscale" phenom ena, requiring a treatm ent that addresses in portant aspects at each scale. The novel feature of this type of simulation is to use an accurate but com putationally dem anding m ethod to treat the region of the system in which small-length-

scale degrees of freedom are in portant, and a faster but

less accurate m ethod with the sm all-length-scale physics

 $\cos - \alpha$ M ultiscale approaches rely on successfully coupling the two (or more) regions involved, which is referred to as seam less coupling. There is no single notion as to what constitutes a seam less coupling, but generally the coupling should be accomplished in such a way that the ctitious boundary between the two regions, which only exists in the coupled simulation and not in the real system, does not introduce any physical consequences. For instance, recently several papers have dealt with the issue of ensuring that phonons are not re ected by the boundary between the two coupling methods [1, 2]. In the consumm ate multiscale method, the resulting energetics or dynam ics is indistinguishable from what would result from a calculation with the accurate method applied to the entire system . This ideal would be achieved only if the two simulation methods involved were seam -

lessly m atched at the boundary, and further, only if the part of the system treated by the faster, less accurate m ethod was indeed free of im portant sm all-scale physics. Another important but obvious characteristic of a good multiscale m ethod is that the computational overhead of perform ing a coupled simulation is not signi cant. More speci cally, the computation time for the coupled simulation should be on the order of com putation tim e required for the accurate m ethod to treat the sm all detailed region, since the time required for the less accurate m ethod to treat the rest of the system is typically several orders smaller; nothing is gained if the coupling is so costly that the coupled method takes as long as using the accurate m ethod to treat the whole system . W hen the approach requires coupling a quantum mechanical method to a classical method, additional complications arise because of the presence of electronic degrees of freedom in the quantum mechanical region; thus boundary conditions on the electron wavefunctions must be imposed at the interface between the regions. Density functional theory (DFT) provides a signi cant simpli cation over more direct quantum mechanical methods in that the calculation of ground state energies and forces requires the minimization of a functional of the electron density

(r) only  $\beta$ ]. Thus, in principle boundary conditions need only be imposed on (r). This statement only applies to the formulation of the problem that does not invoke the explicit calculation of electronic wavefunctions (the most common way of implementing DFT actually does involve individual electronic wavefunctions, the so-called K ohn-Sham orbitals[4]). C oupling an approximate DFT calculation that is based on the electronic density alone to a classical interatom ic potential should be more straightforward than coupling an orbital-based quantum mechanical method to a classical method.

The present article describes a form alism for concurrently coupling a system consisting of two regions, one treated with density functional theory (without invoking electronic wavefunctions) and the other with a classical interatom ic potential. Due to the type of approximations involved, the present approach is particularly well suited for simple m etallic system s; we emphasize, how ever, that

this is not an inherent limitation of our approach, but rather a limitation imposed by the shortcom ings of the methodologies employed for the treatment of the various parts of the system, and if these are eliminated the approach could be generally applicable. In section II, other methodologies for coupling multiple simulation approaches and their relevance to the present methods are discussed. In Section III, the formalism of the present class of coupling methods is established. In Section IV, details of implementing the methods and achieving e – ciency are presented and some tests of the method are reported in Section V.F inally we conclude in Section V I with a discussion of the results of the tests.

# II. BACKGROUND

A large num ber of concurrent multiscale m ethods [5, 6, 7] approach the problem of coupling two di erent simulation m ethods by writing the energy of the whole system as

where here and throughout the article, I refers to the sm all region where detailed physics are relevant, and II refers to the rest of the system .  $E_1$  [I] represents the energy of region I with region II providing appropriate boundary conditions,  $E_2$  [II] represents the energy of region II in the same sense, and E [I + II] represents the total energy of the combined system . Eq. (1) expresses the total energy of the system as the energy of region I evaluated with the accurate simulation m ethod 1, plus the energy of region II evaluated with the faster simulation m ethod 2, plus an energy of interaction between the two subsystems. Typically, the crux of a multiscale m ethod lies in its handling of E <sup>int</sup>. A lthough tautological, Eq. (1) can be rearranged to yield an expression for the interaction energy:

This expression contains no new content, and merely serves to de ne E  $^{int}$  [I;II], but nevertheless provides direction towards its calculation.

The QM /M M m ethods are designed to achieve a goal sim ilar to that of the present m ethod, nam ely the coupling of a quantum -m echanical simulation with classical potentials, but in the context of covalently bonded organic m olecules. In such system s, bonds are localized and typically can be associated with two atoms at either end. The strategy offen employed in QM /M M m ethods to couple quantum m echanics to molecular m echanics is as follows[8]: the system is divided into QM and M M regions with a boundary that cuts across covalent bonds;  $E_{QM}$  is evaluated for the QM subsystem, plus additional link atom s' placed on the M M side of the severed covalent bonds to m in ic the system rem oved from the QM region;  $E_{MM}$  is evaluated for the M M subsystem without the link atom s; and  $E_{QM \to M}$  consists of energy term s such as bond-bending term s that are left out of  $E_{QM} + E_{MM}$ . A sim ilar methodology was developed by B roughton et al.[7] for quantum -classical coupling in silicon, the prototypical covalently-bonded bulk material. Such approaches rely on a som ew hat articial partitioning of the total energy (e.g. into bond-bending and bondstretching term s), and hence lack a de nition that could be readily generalized. But due to the locality of physics in covalently-bonded system s for which QM /M M methods are appropriate, errors introduced at the QM /M M boundary typically do not manifest them selves throughout the system.

In m etallic system s, how ever, the situation is quite different. Bonds are not localized or associated with a distinct pair of atom s. The embedded-atom picture [9, 10] provides a more apt description of the situation. In the embedded atom picture of a simple metallic system, the density of the system is approximately the sum of charge densities of isolated atoms, and the energetic contribution of an individual atom to the system energy is approximately the embedding energy of the atom in a hom ogeneous electron gas. This picture, in various form s[10, 11, 12], has been used to great e ect to create classical pair functionals form etals. The success of these potentials in capturing the energetics of simple m etallic system s, com bined with their foundation on density functional theory argum ents, make them ideal candidates for evaluating  $E_2$  [II] in the present form alism .

The notions of the embedded-atom m ethod can be extended to describe the energetics of a m etallic region (region I) within anotherm etallic region (region II); region I is embedded within region II. The exact nature of the embedding can be form ally written in the m anner of Eq. (1) with density functional theory arguments. We rst decide which ions will be associated with region I and which will be in region II, and we will denote those sets of nuclear coordinates by R<sup>I</sup> and R<sup>II</sup>. We denote the set of all nuclei with R<sup>tot</sup> R<sup>I</sup> [R<sup>II</sup>. A coording to the Hohenberg-K ohn theorem, the total system energy, within the Born-O ppenheim er approximation, is given by m inim izing a functional of the total charge density:

In order to be explicit, by  $E_{DFT}$  [; fR g] we mean:

where  $T_s$  is the non-interacting kinetic energy functional,  $E_H$  is the Hartree energy,  $E_{xc}$  is the exchange-correlation energy, and  $V_{psp}$  is the ionic pseudopotential. Thus  $E_{DFT}$  represents the combined electronic and ion-ion (M adelung) energy.

If <sup>tot</sup> is partitioned into two sub-densities, <sup>I</sup> and <sup>II</sup>, such that <sup>tot</sup> = <sup>I</sup> + <sup>II</sup>, then the  $E_{DFT}$  can be partitioned:

where E <sup>int</sup> is de ned as in Eq. (2). By varying the totalenergy with respect to <sup>I</sup>, we nd that the potential felt by <sup>I</sup> is equal to the sum of the potential from region I alone, plus an embedding potential  $V_{emb}$  (r) that com pletely represents the e ect of region II upon region I:

By using di erent approximations for the terms in Eq. (6), di erent coupled m ethods are obtained. W esolow ski and W arshel[13], building on the form alism of Cortona [14], used this partitioning to describe an e cient DFT method. In their scheme E [I] and E [II] are treated with Kohn-Sham DFT, but E int is evaluated with \orbitalfree" density functional theory (OF-DFT), i.e. pure density functional theory in which the Kohn-Sham orbitals are not used and the non-interacting kinetic energy is approximated with an explicit functional of the density [15, 16, 17, 18, 19]. This allow s E [I] and E [II] to be alternately minimized in the embedding potential of the other. G ovind et al.[6] utilized the partitioning of Eq. (5) to obtain a quantum chem istry (QC)/DFT coupled method. There  $E_1[I]$  was calculated with QC,  $E_2[II]$ with DFT, and again E  $^{\rm int}$  was based on OF-DFT. They used this method to explore the electronic structure of m olecules adsorbed on m etal surfaces. Recently K luner et al.[20] have extended this form alism to treat adsorbed m olecules in their excited state.

# III. FORMALISM

The present m ethod follows in the same vein as the last few examples, to achieve a DFT/classical potential coupling. The general idea of the present m ethods is as follows.  $E_1[I]$  is to be calculated with DFT.  $E_2[II]$  is calculated via a classical potential. A choice can be m ade for the calculation of  $E^{int}$ , which results in distinct coupling m ethods, which we exam ine in detail below.

## A. Classical interaction energy

E int can be calculated using the classical potential:

A lthough this interaction energy is intended to represent the same DFT interaction energy that appears in Eq. (5), it is not contradictory to use the classical potential to evaluate it, since the classical potential energy, evaluated for a given ionic con guration R, can be viewed as an approximation to the DFT functional that has been m inim ized with respect to the density; that is:

This choice of interaction energy results in a total energy of:

In this scheme, the forces on all atoms in region II are identical to forces on corresponding atom s if the classical potential were used for the entire system; i.e. the DFT region has no e ect on these atoms. If the cuto length of classical potential is  $r_{c}$ , then atom s that lie within region I and are farther than rc from the boundary will experience a force entirely from  $E_{DFT}$  [I]; these atom s feel a force no di erent than corresponding atom s in a DFT calculation of region I. The force on atoms in region I that are within r<sub>c</sub> of the boundary do not com e entirely from E<sub>DFT</sub> [I], but also have contributions from  $E_{cl}[I + II] = E_{cl}[I]$ . These contributions should in principle be corrections to the surface forces experienced by these atoms from  $E_{DFT}$  [I]. Classical potentials have been developed to m in ic the energetics, forces, and geom etries obtained from DFT calculations of various conqurations, including surfaces [21]; such potentials should be particularly apt for the present coupling scheme.

The implementation of this method demands nothing beyond what is required for a DFT calculation and a classical potential calculation. It should be noted, how ever, that the DFT calculation,  $E_{DFT}$  [I], is a non-periodic calculation, and if OF-DFT is to be used, special considerations m ay need to be made for the calculation of non-periodic system s[22].

# B. Quantum interaction energy

A Itematively E int can be calculated more accurately with a quantum mechanical method. Although we only represent region II by the coordinates of the ions of region II atoms and calculate the energetics with a classical potential, there is an implicit charge density <sup>II</sup> associated with  $E_{cl} \mathbb{R}^{II}$ ] via Eq. (8). Because of this, we can consider a more sophisticated coupling scheme where the interaction energy is based on density functional theory. However, in order to compute the interaction energy via DFT when all we know about region II is an approximation of its charge density, the traditional Kohn-Sham scheme of DFT is not suitable. In the Kohn-Sham scheme, we start with a potential and obtain the density and energy of electrons in this potential. Instead, we need a means of calculating the energy of a system of electrons given their density. OF-DFT allows us to do

this. Thus we can write down the interaction energy in term  $s \circ f \circ F \rightarrow F T$  energy functionals:

At rst glance this seems like a useless scheme, because if DFT is used to calculate E<sup>int</sup> [I;II], we may as well use DFT to calculate E [I + II], and thus no com – putational expense is saved with the coupled method. But because of the nature of many of the useful OF– DFT functionals, this turns out not to be the case. If E<sup>int</sup> [I;II] is calculated with OF-DFT, for typical approxim ate kinetic energy functionals the computation in Eq. (10) will require a computation time that is on the order of the computation time required to compute E<sub>OF</sub> [I], the small subsystem, rather than the time required to com – pute E<sub>OF</sub> [I + II]. This is because signi cant cancellation is implicit in E<sub>OF</sub> [I + II] E<sub>OF</sub> [II].

The existing approximate kinetic energy functionals di er in accuracy and computational e ciency. Moreover, di erent choices of functional can be made for the evaluation of E [I] and E <sup>int</sup>, which further increases the number of possible coupling m ethods. This possibility is important because the degree to which the computation of E <sup>int</sup> can be made e cient depends on the choice of kinetic energy functional and the functionals that will most e ciently treat E <sup>int</sup> are not necessarily accurate enough to treat the interactions within E [I].

Regardless of the choice of kinetic energy functional, the evaluation of E <sup>int</sup> [I;II] within this coupling scheme requires knowing the electronic density of region II, <sup>II</sup> (r). In the present method, <sup>II</sup> (r) is approximated as the sum of atom ic charge densities <sup>at</sup> (r) centered at the region II nuclei:

This approximation is supported by the embedded-atom picture of simple metallic systems. In principle,  $^{\rm at}(r)$  could be a non-spherically symmetric density. For example, if the arrangement of the region II atoms is always close to the bulk lattice arrangement, then a non-spherically-symmetric charge density that reproduces the bulk charge density when periodically tiled may be more appropriate. However in this article  $^{\rm at}(r)$  is always taken to be spherically symmetric.

The density in region II is never explicitly represented in the calculation, but is given a precise form via Eq. (11). Thus region II is entirely described by the ionic coordinates R<sup>II</sup>, and <sup>II</sup>, the form of which is needed to evaluate E<sup>int</sup>, is im plicitly determined by R<sup>II</sup>.

The second coupling method is sum marized by the expression for the energy as a function of nuclear coordi-

nates within the method:

The last term,  $E_{DFT}$  [<sup>I</sup>; R<sup>I</sup>], is written as such (and not as  $E_{OF}$  [I]) to emphasize that we could choose to com – pute it either with a K ohn-Sham -type calculation or with OF-DFT, but utilizing a more accurate kinetic energy functional than the other OF-DFT terms. This would allow for three distinct levels of accuracy in the calculation: K ohn-Sham accuracy within region I, OF-DFT accuracy for the coupling between regions I and II, and the accuracy of the classical potential in region II. In this case, <sup>I</sup> would consist of a set of K ohn-Sham orbitals, <sup>I</sup>(r) = <sub>i</sub> j<sub>i</sub>(r) f, and we would minim ize over the <sub>i</sub>:

However, this interesting possibility is not explored presently; instead we use the same type of  $OF \rightarrow DFT$  calculation for the last four terms of Eq. (12). It should be noted that in this case the last two terms cancel, and then the total energy is given by:

# C. Orbital-free DFT and approximate kinetic energy functionals

O rbital-free DFT is a necessary part of the second coupling m ethod, because the electronic structure of region II is represented only in terms of its density via Eq. (11); thus in order to utilize that information,  $E^{int}m$  ust be based only on the charge density and the ionic coordinates. Here we describe some key ideas of OF-DFT.

H ohenberg and K ohn  $\beta$ ] showed that the ground state energy of a system of electrons moving in an external potential is given by m in in izing a density functional. K ohn and Sham [4] wrote a useful partitioning of this energy functional:

where  $T_{\rm s}$  is the non-interacting kinetic energy functional,  $E_{\rm H}$  is the Hartree energy,  $E_{\rm xc}$  is the exchange-correlation energy, and  $V_{\rm e~i}$  is the ionic potential. By introducing a set of ctitious non-interacting particles, we can obtain a set of single-particle equations, the Kohn-Sham equations, that allow for the evaluation of E [] with an approximate  $E_{\rm xc}$ . The Kohn-Sham method results in an exact evaluation of  $T_{\rm s}$ [] for the density  $_0$  that minimizes E [], but the method does not provide a means of evaluating  $T_{\rm s}$ [] for an arbitrary density .

The K ohn-Sham partitioning of the energy, Eq. (17), has turned out to be useful beyond the K ohn-Sham m ethod. Because a number of lim its of the exact non-interacting kinetic energy functional  $T_s$  [] are known [23],  $T_s$ [] has been approximated by explicit density functionals constructed to satisfy one or more of these known lim its. The orbital-free DFT m ethods are based on m inimizing E [] with  $T_s$  replaced with an approximate kinetic energy functional.

OF-DFT methods are typically more computationally e cient than the Kohn-Sham method. If the approximate  $T_s$  can be evaluated with an amount of computation that scales linearly with the system size, usually denoted by the total number of atom sN, then minimizing  $E_{OF}$  [] will require an amount of computation linear in the system size (O (N) method). Since within OF-DFT all terms of the energy are explicit functionals of the density, there is no need for ctitious orbitals, and the density (r) is the only represented variable. Thus, there is no need to solve the single-particle Schodinger equations for the tribute methods.

ctitious particles while maintaining their orthogonality, operations which typically require most of the computationale ort in the Kohn-Sham approach and scale as a high power of the system size (O (N<sup>3</sup>) or higher). Moreover, with the density (r) as the only quantity of interest in the system, the OF-DFT methods use less memory than the Kohn-Sham method, since the latter requires the storage and update of a number of ctitious orbitals proportional to the system size, each of which consumes twice the storage (as complex quantities) needed for the density alone.

In addition to computational advantages, unlike the K ohn-Sham method, the total energy functional  $E_{OF}$  [] can be evaluated for a given (r). This property makes OF-DFT a suitable candidate for computing E <sup>int</sup> [<sup>I</sup>; <sup>II</sup>] in the second coupling method discussed in the previous subsection.

The number of available approximate kinetic energy functionals is sizeable, and the choice of functional is made based on considerations of e ciency and the types of systems to be treated. Because the systems to be considered are simple metals with free-electron-like charge densities, an important property that should be included in the approximate kinetic energy functional is the correct linear response around uniform densities:

where  $F^{\uparrow}$  is the Fourier transform , and  $_{\rm Lind}$  (k) is the Lindhard response function:

with  $k_F$  = (3  $^2$   $_0)^{1=3}$  and x = k=2k\_F .

A signi cant number of e cient functionals have been developed that satisfy the linear response lim it for a particular chosen average density [15, 16, 17, 18, 19]. Such functionals often consist of several term s that are localor localized functionals, such as the T hom as Ferm i energy and the von W eizsacker functionals, plus one or m ore convolution term s:  $\frac{7}{2}$

By choosing the kernel K (r) properly, the approximate functional can be made to satisfy the correct linear response, Eq. (18), around some chosen uniform density  $_0$ . Numerical tests indicate that among the current available e cient kinetic energy functionals, the ones of this form are most suitable for simple metallic systems.

How ever, kinetic energy functionals that contain a convolution part with a long-ranged kernelm ake the e cient evaluation of E <sup>int</sup> [I;II] m ore di cult; the consequences of this will be discussed in the following section.

## IV. IM PLEM ENTATION OF COUPLING

#### A. Classical interaction energy

The calculation of the energetics and ionic forces within the rst coupling scheme described above involve only DFT calculations and classical potential calculations. However, if an ionic relaxation is to be done on the whole system, there are several possible techniques, the optim alchoice depending on the system being relaxed.

If the partitioning of the system into regions I and II is such that the time required to calculate E<sub>DFT</sub> [I] is com parable with the computation time of  $E_{cl}[I + II]$ , then ionic relaxation of the total system may be done by using a gradient-based m inim izer such as conjugate gradients m ethods or quasi-New ton m ethods like BFG S [24]. If, on the other hand, the system partitioning is such that the time required to evaluate  $E_{DFT}$  [I] is considerably more than that required for the computation of  $E_{cl}[I + II]$ , as is often the case, then an alternate relaxation scheme may be more e cient. The total system can be relaxed by using a gradient-based m in im izer on the region I system alone, while fully relaxing the region II ions between each ionic update of region I. G radient-based m in im izers like BFGS are only e ective if the gradients involved are indeed gradients of an underlying object function. It is not immediately apparent that such is the case in this alternate-relaxation scheme, but we can dem onstrate it as follows.

The energy calculated with the rst coupling scheme, as a function of all ionic coordinates, is given in Eq. (9). A secondary function that only depends on the region I ionic positions can be de ned as:

The useful aspect of E<sup>0</sup> is that its gradient with respect to R<sup>I</sup><sub>i</sub> can be easily evaluated:

where the second term on the right of Eq. (22) vanishes because all derivatives are evaluated at the minimum of E [R<sup>tot</sup>] with respect to R<sup>II</sup>. This result is analogous to the Hellmann-Feynman theorem [25]. The introduction of the E<sup>0</sup> function allows for the following relaxation algorithm:

m inim ize E  $\mathbb{R}^{tot}$ ] with respect to R <sup>II</sup> while holding R <sup>I</sup> xed. This only involves the classical potential, E <sub>cl</sub>  $\mathbb{R}^{tot}$ ].

Calculatem in  $_{I} E_{DFT} [I; R^{I}]$  and  $E_{cl} R^{I}$ , and the forces on the region I ions. Using Eq. (23) the gradient of  $E^{0}$  is obtained.

Perform a step of a gradient-based m in in ization of E  $^{\rm 0}.$ 

## Repeat until the system is relaxed.

In this manner, the number of DFT calculations perform ed is greatly reduced, albeit at the expense of more classical potential calculations.

## B. Quantum interaction energy




FIG.1: An illustration of the partitioning of the system according to the coupling method with quantum interaction energy.

Im plem entation details of the second coupling m ethod require m ore elaboration. One in portant point is that  ${}^{\rm I}$ must be con ned to lie within a nite volum e <sup>I</sup>. This region should have signi cant overlap with the region where <sup>II</sup> lies, in order to provide coupling of the two regions. But if <sup>I</sup> were not con ned to a nite volume <sup>I</sup>, it could in principle spread throughout the combined system, and during the course of m in in izing with respect to <sup>I</sup> (Eq. (12)), we would essentially be performing a DFT calculation of the whole system . On the other hand, <sup>I</sup> should be chosen large enough so that <sup>I</sup> is not articially conned. In the test system s we exam ined, we found that when increasing the size of <sup>I</sup>, a point is reached where the results (e.g. the shape of I and the forces on the ions) change little. The con nement of <sup>I</sup> within <sup>I</sup> is illustrated in Fig. 1.

The second coupling m ethod m aintains e ciency due to the cancellation that occurs when  $E_{OF}^{int}$  is computed. Consider the computation of a local term of  $E^{int}$ ; such as the exchange-correlation functional within the local density approximation [3] (LDA):

where  $f_{xc}()$  and we have used the fact that <sup>II</sup> (r) = <sup>tot</sup> (r) for r  $\geq$  <sup>I</sup>. Thus calculation of  $E_{xc}^{int}$  is an integral over <sup>I</sup> and not the entire system, which dem onstrates our criterion for e ciency. Any local functional of will obviously be calculated e ciently in the same m anner. We note that when the same kinetic energy functional is used for the interaction energy and  $E_{OF}$  [I] (which is the case for the tests performed in this paper), the cancellation exhibited in Eq. (16) occurs. In this case, it is wasteful to compute the interaction energy as in Eq. (24) and then compute and add on  $E_{xc}$  [<sup>I</sup>], as it exactly cancels the second term of Eq. (24). Instead, we compute directly the follow ing quantity:

Sim ilar considerations apply to the other parts of the energy which are simple functionals of the density. The only term that does not fall in this category is the interaction kinetic energy  $T_s^{int}$ , when it involves more sophisticated functionals with convolution terms such as Eq. (20). For this case, we have developed an appropriate efficient m ethodology, the derivation of which is contained in appendix A.

Particular attention must be paid to the non-local terms of E<sup>int</sup>. As usual, cancellation occurs between electron-electron, electron-ion, and ion-ion terms that eliminates long-ranged interactions. The Hartree inter-

action energy is given by:

where  $V_{psp}$  (r) is the pseudopotential representing the ion, and we have used Eq. (11) to express <sup>II</sup> (r) as a sum of <sup>at</sup>. Finally the ion-ion interaction energy is given by:

Both  $V_{elec}^{at}(\mathbf{r})$  and  $_{ij}(\mathbf{R})$  are short-ranged functions in which the 1=R dependence of the constituent term s cancel.

W ithin the second coupling method: (1) we minimize the energy with respect to <sup>I</sup>, and (2) we calculate the forces on all of the ions and update their position. In order to minimize the energy with respect to <sup>I</sup>, the derivative  $E^{int} = I$  (r) needs to be calculated for r 2 <sup>I</sup>. This derivative can be evaluated e ciently for the local functionals like  $E_{xc}$ :

Evaluating this combined contribution to  $E^{int} = I$  is a 26 m ple matter of evaluating  $V_{elec}^{at}$  for region II ions located near the boundary with region I. And so the gradient of the total energy with respect to I is:

The calculation of the ionic forces proceeds di erently for region I and region II ions. Calculation of the region I ionic forces is facilitated by the Hellm ann-Feynm an theorem [25]. If we denote the part of the energy (Eq. (12)) that is minimized with respect to <sup>I</sup> by  $G[_{;R}^{I}; R_{;R}^{II}]$ :

where the last term in Eq. (37) vanishes because we have minimized G with respect to <sup>I</sup>, and so  $G = {}^{I}j_{min} = 0$ . So the forces on the region I ions are determined solely by the terms of G that explicitly depend on R<sup>I</sup>; these terms are the electron-ion energy and the ion-ion energy. U sing Eq. (30), the force on the ith region I ion is given by:

Thus it can be seen from Eq. (39) that forces on region I ions are given by the sum of the electron-ion and ionion forces present in subsystem I alone, and short-ranged interactions with region II ions that are nearby region I. The forces on the region II ions come mostly from the classical potential, but they have contributions from E <sup>int</sup> [I;II] because <sup>II</sup> is a function of R <sup>II</sup><sub>j</sub>. Since we have not m inim ized with respect to <sup>III</sup>, there is no Hellm ann-Feynman simplication when calculating the forces on region II ions, and all terms in the interaction energy contribute. The force on the jth region II ion is given by:

with analogous expressions for other local contributions that m ay exist in the kinetic energy functional such as the Thom as Ferm i energy. These local force contributions are only non-zero for region II ions with an atom ic density that extends into <sup>I</sup>. It is also worth noting that the integral in Eq. (41) need not be carried out over all of <sup>I</sup>, but only over the intersection of <sup>I</sup> with <sup>at</sup> (r R  $\frac{1}{4}$ ).

The Coulomb contributions to the region II ionic forces are given by:

T his contribution also is non-zero only for region II ions near the boundary of  $\ ^{\rm I}$  .

If a more sophisticated kinetic energy functional with a convolution term like Eq. (20) is used in E<sup>int</sup>, then such a term adds considerable complication to the calculation of the forces on region II ions, but these contributions nonetheless die o as we move farther from region I. Thus within the fram ework of this coupling scheme, the forces on region II ions take the intuitively satisfying form of being equal to the force that arises from the classical potential, plus a correction force for ions near the boundary of I.

If the partitioning of the system between parts I and II is such that region I requires much longer computation than region II, the second coupling method, like the rst, allows for an e cient algorithm for ionic relaxation. We de ne a di errent partitioning of the ions as follows: we denote by R<sup>I<sup>0</sup></sup> the set of region I ions plus all region II ions R<sup>II</sup><sub>j</sub> for which the interaction force  $0E^{int}=0R^{II}_{j}$ is not negligible, and we denote by R<sup>II<sup>0</sup></sup> the rest of the




FIG. 2: A cut-away view of the test system . W hite atoms belong to region I, and dark atoms belong to region II. For the coupling method with quantum interaction energy, the region  $^{\rm I}$  is shown by the white cube.

R<sup>II</sup> ions. The point is that the forces on the R<sup>II<sup>0</sup></sup> ions only depend on the classical potential (as seen from Eq. (40)), and also that <sup>I</sup> does not depend on the R<sup>II<sup>0</sup></sup> ions (as seen from Eq. (34)). Thus the same algorithm for relaxing the system in the rst coupling scheme can be used, but with R<sup>I</sup> replaced with R<sup>I<sup>0</sup></sup>, and R<sup>II</sup> replaced with R<sup>II<sup>0</sup></sup>. That is, before each relaxation step of the R<sup>I<sup>0</sup></sup>, the R<sup>II<sup>0</sup></sup> are to be fully relaxed.

# V. TESTS

In order to test the present coupling m ethods, we have focused on a simple coupled system that is readily analyzed. The system consists of 10 10 cubic unit cells (4 atom s each) of crystalline fcc alum inum. The innermost 2 2 unit cells (32 atom s total) are considered to be region I, and all atom soutside are considered to be in region II. Region II, which is treated with the classicalpotential, is treated as a periodic system in order to rem ove e ects of surfaces from the simulation. So in fact the test system consists of an in nite array of 32-atom Alclusters treated quantum mechanically, embedded in an Albuk treated by classical potentials. O byiously, if there is good coupling between region I and region II, the entire system should simply behave like pure bulk fcc A l, m aking it easy to evaluate the quality of the coupling. This test system is illustrated in Fig. 2.

In all of the present tests, region I is treated with OF-DFT. However, the particular kinetic energy functional used diers among the tests. The Al ions are represented with the Goodwin-Needs-Heine local pseudopotential[26]. For all tests, the classical potential used is the glue potential of E roolessi and A dam s[11], which has the embedded-atom method (EAM) form :

The EAM potential has been scaled both in r and in energy:

and with chosen so that the potential yields precisely the same lattice constant and bulk modulus of fcc Alsimulated with OF-DFT employing the particular kinetic energy functional used in that test. This is in accord with the philosophy that the coupled simulation should behave as if the accurate m ethod were used for the entire system . But this procedure is also done so that a \fair" assessment of the coupling itself can be made; we wish to exam ine errors in the present coupling m ethods them selves and the approxim ations involved in them, but not the errors com ing from a trivial incom patibility between energy methods. To make the classical potential even more compatible with the OF-DFT method, we could re-determ ine the form of the classical potential using the m ethod that E reclessi and A dam s originally used to develop their potential [21]: perform a large number of reference energetic calculations of Alusing OF-DFT, and nd the EAM -type potential that best reproduces these results. This would be a rather involved procedure, so we have chosen to simply scale the potential.

## A . Test of classical interaction energy m ethod

In the rst coupling method (Eq. (9)), the energetics of region I was treated with OF-DFT, and the kinetic energy functional used was one developed by W ang et al.[19], with a density-dependent kernel, and parameters f;; ;  $g = f5=6+\frac{P}{5}=6;5=6-\frac{P}{5}=6;2:7;0:183 \text{ A}^3 \text{ g}$  (in the notation of Ref. [19]). This functional has six convolution terms of the form of Eq. (20). The classical potential was scaled to m atch the lattice constant (4:033 A) and bulk modulus (55.7 GPa) of foc Al obtained by this kinetic energy functional.

The system was initially arranged in the perfect foc lattice con guration The forces on the region II atom swere identically zero, since they come entirely from  $E^{cl}[I+II]$ , which is at a minimum in the initial con guration. How – ever, the forces on the region I atom s are not zero, as the OF-DFT and EAM forces do not perfectly cancel each other. The average magnitude of the force di erence per atom between the OF-DFT and EAM calculations of region I was 0:34 eV/A. These initial forces on the region




FIG.3: Test of coupling m ethod with classical interaction energy. (a) The forces on the region I atom s when the atom ic positions are at the perfect lattice positions. The force factors are scaled so that a vector of length one lattice constant corresponds to 1 eV /A. (b) The relaxed region I and 2 atom ic positions shown in white and black, respectively. The perfect lattice sites are drawn as gray spheres of a slightly sm aller radius.

I atom s are shown in Fig. 3(a), with the drawn force vectors scaled so that a force of 1 eV /A would extend one lattice constant. Then the coupled system was relaxed. A fler relaxation, it was found that the atom ic positions deviated from the correct fcc lattice positions by an average of 0:004 A per atom . The average deviation of just the region I atom swas 0:076 A per atom . The atom ic deviation is shown in Fig. 3(b), in which the relaxed atom ic positions for the region I and region II atom s are drawn as white and black balls, respectively, and the correct lattice positions are drawn as gray balls of a slightly sm aller radius. Note that only the four (100) layers that include region I are shown. From this diagram it can be seen that in general the relaxed atom ic positions deviate from the the perfect lattice positions by bulging out from region I slightly, with the deviation decreasing with increasing distance from region I.

# B. Test of quantum interaction energy m ethod

The second coupling method was applied to the same simple test system. The kinetic energy functional employed was again from Ref. ([19]), but in this case it was a functional with a density independent kernel, with param eters f; g = f5=65=6g. A di erent functional was chosen for this test because of its simpler form : it contains only one convolution term of the form of Eq. (20), while the functional used in the test of the rst coupling m ethod had six. This m akes the evaluation of the kinetic interaction energy, T<sub>s</sub><sup>int</sup>, simpler. Furtherm ore, this functional perform swell for structures that do not deviate much from the bulk system. This functional was found to be inapplicable to the test of the rst coupling method, because in that approach the calculation of  $E_{OF}$  [I] amounts to an isolated cluster; in that case, there is no embedding potential from region II and the m in im ization with respect to <sup>I</sup> does not converge. For bulk fcc A l, how ever, this sim pler functional em ployed to test the quantum interaction energy method, perform s quite well producing an equilibrium lattice constant of 4:035 A and a bulk m odulus of 71:9 G Pa.

A nother aspect of the second coupling m ethod is the choice of atom ic density functions <sup>at</sup> representing <sup>II</sup> through Eq. (11). Two di erent choices of <sup>at</sup> were tried. One choice, <sup>at;gas</sup>, was the valence density from a K ohn-Sham calculation of an isolated A l atom, represented with the same pseudopotential[26]. The other choice, <sup>at;cryst</sup> was again a spherically symmetric charge density chosen such that the charge density that results from periodically superposing it on an fcc lattice m ost closely m atches the charge density com ing from an OF-DFT calculation of bulk fcc A l. The desired spherically symmetric charge density <sup>at;cryst</sup> (r) m inim izes:

where <sup>fcc</sup> (r) is an in nite fcc lattice of delta functions, denotes convolution, and is one unit cell; <sup>fcc</sup> (r) is the valence charge density of the fcc crystal. In reciprocal space, this becomes:

$$S_{Q} \sim^{\text{at;cryst}} (Q) \sim_{Q}^{\text{fcc}^{2}}$$

where  $S_Q$  is the structure factor. This is minimized by requiring:




FIG.4: The two atom ic densities used to represent  $^{\rm II}$ .

where h  $_{\mathbb{Q}}$  denotes an averaging over reciprocal lattice vectors Q of length Q. This  $^{\text{at;cryst}}(\mathbb{Q})$  was then used to construct a radial charge density  $^{\text{at;cryst}}(\mathbf{r})$  that was commensurate with  $^{\text{at;cryst}}(\mathbb{Q})$  at the values of Q where the latter was de ned. The two charge density choices are shown in Fig. 4.

The second coupling m ethod was tested on the same system used to test the rst coupling m ethod. W ith the second m ethod, how ever, we must choose the form of the atom ic density representing <sup>II</sup>, and the extent of the region <sup>I</sup>. W ith respect to the choice of <sup>I</sup>, we have found the following general behavior: if <sup>I</sup> is chosen to be too sm all, then after m inimization with respect to <sup>I</sup>, there is an excess buildup of charge near the boundary of




FIG.5: Results for the quantum interaction energy method. (a) and (b) are contour plots of <sup>tot</sup> with <sup>II</sup> given by superpositions of <sup>at;gas</sup> and <sup>at;cryst</sup>, respectively. The boundary of <sup>I</sup> is shown with a dashed line, and the positions of the region I atom s lying in this plane are indicated by (+), and region II atom sby (). (c) and (d) show the di erence between these two densities and the \correct" density coming from a purely OF-DFT calculation of the whole system.

<sup>I</sup>. This in turn results in a net attraction of the region I ions toward the boundary of <sup>I</sup>. This is remedied by an increase in the size of <sup>I</sup>. W hen <sup>I</sup> is increased further still, the results (the ionic forces, and <sup>I</sup>) are found to change only very slightly. We note that regardless of the size of I, the total density is always found to be continuous at the boundary due to the high energy that the kinetic energy functional assigns to a discontinuity in the density. In Fig. (5) we have plotted the total charge density after m in im izing with respect to <sup>I</sup>, with <sup>II</sup> given by (a) a superposition of <sup>at;gas</sup>, and (b) a superposition of at; cryst. The particular slice of the charge density is a (100) plane that passes through one of the central atom ic planes of the region I cluster. In (c) and (d) we have plotted the di erence between these coupled charge densities and the density of this system when com puted entirely with OF-DFT. In general, using  $^{
m at; cryst}$ results in a more accurate total charge density. From (c) and (d), it is clear that the superposition of at; cryst reproduces the pure OF-DFT crystal charge density better than <sup>at;gas</sup> both for points r well within <sup>I</sup>, as well as at the boundary of I.

It turns out, however, that the forces on the ions, for both choices of  $^{\rm at}$ , are comparable. A loc comparable is the am ount of deviation from the perfect lattice positions upon atom ic relaxation for both choices. The exact num – bers for these quantities for both coupling m ethods and the two choices of  $^{\rm at}$  are sum m arized in Table I.

# VI. CONCLUSIONS

The coupling of classical and quantum simulation in simple m etals involves a set of challenges quite di erent than those for the coupling of covalently-bonded m aterials and m olecules, and hence requires a di erent set of approaches. We have presented here two m ethods for com bining classical and quantum m echanical simulation of simple m etals. Both are based on a similar partitioning of the energy of the system, but they di er in how the energy of interaction between the classical and quantum m echanical parts of the system are treated. We have presented num erical im plem entations that allow both coupling m ethods to be e cient.

W ithin the rst coupling method, in which the interaction energy is determ ined from the classical potential, forces in the classical region are fully determ ined by the classical potential. Forces in the quantum region are determ ined by both classical and quantum energetics, the quantum energetics dom inating wellw ithin the quantum region. A major practical advantage of this approach is that, if region I contains many dierent atom ic species while region II contains only one atom type, there is no need for a classical potential for each species and their interactions; if the various species of atom s are wellw ithin region I, then the potential representing them does not matter at all as interactions in this region are treated purely with quantum mechanics.

W ithin the second coupling m ethod, in which the interaction energy is determ ined via OF-DFT, forces in the classical region are determ ined m ostly by the classical potential, with quantum contributions to atom ic forces near the boundary of the regions. Forces in the quantum region are determ ined fully by quantum energetics. W ithin the quantum region, the charge density accurately reproduces the correct charge density, and sm oothly joins with the im plicit density (given by a sum of atom ic densities) of the classical region.

Test results indicate that the second coupling m ethod yields m ore accurate forces on the atom s in the quantum region than the rst method, but that the rst method yields m ore accurate forces for the atom s in the classical region. This may be due, to some extent, to the lessaccurate OF-DFT method used in the test of the second coupling method. The rst coupling method also yielded a better relaxed structure, probably due to its better treatm ent of forces on the classical atom s. How ever, unlike the rst m ethod, the second coupling m ethod results in a more accurate charge density within the quantum m echanical region, allow ing for an accurate treatm ent of physical problem s such as the introduction of im purities, where the background density is important. We also nd that a superposition of atom ic charge densities can reproduce the actual charge density well for a simple metallic system, given an appropriate choice for the atom ic charge density; this allows for a sm ooth density transition at the boundary between regions.

C learly, an important issue a ecting the coupling quality for both m ethods is the agreem ent between forces from the DFT m ethods; within both m ethods there are atom s whose forces are determ ined by a combination of quantum and classical energetics, and the m ore closely the two energetics agree, the better the coupling will be. An improvement in the quality of the coupling m ight be obtained if the classical potential employed in region II is optim ized to closely reproduce the DFT energetics; this is also in accord with the multiscale philosophy that a coupled simulation should act as if the m ost accurate  ${\tt m}$  ethod were used to  $\sin{\tt u}$  late the entire system .

APPENDIX A: EVALUATING THE IN TERACTION ENERGY FOR COMPLEX KINETIC ENERGY FUNCTIONALS

W e describe here how the interaction energy can be efciently calculated when the approxim ate kinetic energy functional used is of a more complicated form, containing a convolution term of the form of Eq. (20). That is, we will describe a method for evaluating:

where we have de ned  $f_1(r) = f(I(r))$ ,  $f_{12}(r) = f(I(r))$ ,  $f_{12}(r)$ f(I(r) + II(r)), and so on. Then we de ne two new functions,

Note that F (r) and G (r) are zero for points r  $\neq$  <sup>I</sup>. Using F and G we can re-express Eq. (A1) as:

W e point out that if this interaction energy is being calculated in a coupled simulation in which the energetics of region I are calculated using the same kinetic energy (i.e. E [I] and E <sup>int</sup> [I;II] being treated at the same level of theory), then the nalterm of Eq. (A 3) is equal to and will cancel with the corresponding term in E [I].

So with Eq. (A 3) we have expressed  $T_{K}^{int}$  purely in terms of intergrals over <sup>I</sup>; the problem is now reduced to e ciently calculating the functions (K f<sub>2</sub>)(r) and (K g)(r) for points r within <sup>I</sup>. A straightforward integration for each point r 2 <sup>I</sup> is not an option, because K (r) is typically long-ranged, and thus determ ining (K  $\frac{5}{2}$ )(r) at one single point r would require an integration over the volume of the whole coupled system, which would be highly ine cient. We now describe a method for determ ining (K  $\frac{5}{2}$ )(r), and (K g)(r) can be determ ined with precisely the same method.

In earlier work [22] we have developed a method for efciently evaluating convolutions like Eq. (A 4) when the convolution kernel K (r) is of the particular form typically encountered in kinetic energy functionals involving convolution term s[15, 16, 17, 18, 19]. We will invoke this method to determ ine (K  $f_2$ ). In this method, the kernel is t in reciprocal space with the following form :

where  $P_i$ ,  $Q_i$  are complex thing parameters. The kernels encountered in many kinetic energy functionals are well-t with this form, with 4 terms. The kernel in real space can be expressed as the sum of the inverse Fourier transform of each term of Eq. (A 5):

i.e. they are solutions to (com plex) Helmholtz equations which can be solved with conjugate-gradient-based m ethods [27]; such m ethods are e cient and only involve operations within <sup>I</sup>. The solutions to Eqs. (A 10) are only well-de ned when boundary conditions for (K<sub>i</sub>  $f_2$ ) (r) are supplied.

W e propose the use of D irichlet boundary conditions. The value of (K  $_{i}$   $f_{2}$ ) (r) for points r on the boundary of <sup>I</sup> can be found by evaluating the convolutions, Eqs. (A 8). Because of the regular nature of <sup>II</sup> (r), being the sum of atom ic densities, an e cient m ethod for evaluating these convolutions exists. The form of the convolution that needs to be evaluated is:

If f ( ) were a linear function, then this would reduce to a sum of pair functions. For many kinetic energy functionals, f ( ) is not linear, but equal to some power of





FIG. 6: A demonstration of the Taylor expansion of Eq. (A 12) compared to a direct Taylor expansion of f() =  $^{1:5}$  about  $_0 = 1$ .

: f() = . This leads us to consider a Taylor expansion of f() about some average density  $_0$ . This Taylor expansion su ers in places where  $^{\rm II}$  (r) is near 0, which occurs, for instance, in the center of  $^{\rm I}$ . An expansion that is much more accurate down to small values of is obtained if we Taylor expand the function h() f()= and express f( $^{\rm II}$ ) in terms of this expansion:

In Fig. 6 we illustrate the e ectiveness of (A12) com – pared to expanding f() directly when f() =  $^{1:5}$  and  $_{0}$  = 1. A lthough the h-expansion is taken only to rst order, while the f-expansion is taken to second order, the h-expansion is seen to be more accurate at sm all .

Upon substitution of the expansion of Eq. (A 12) in the convolution, Eq. (A 11), we nd:

 $L_{i}^{(1)}$  is the convolution of an atom ic density with K<sub>i</sub>(r).  $L_{i}^{(2)}$  (R;R<sup>0</sup>) is the convolution of the product of two atom ic densities with K (r), and consequently vanishes

when the two atom ic densities do not overlap. The integrand is non-zero only where the overlap occurs. It thus makes sense to express  $L_i^{(2)}$  in terms of new coordinates, illustrated in Fig. 7:

In the case of a spherically symmetric <sup>at</sup> (r),  $L_i^{(1)}(R)$  is a function only of  $\Re$  j and M<sub>i</sub>( $R_c$ ;  $R_{rel}$ ) will depend only on  $\Re_c$  j  $\Re_{rel}$  j and R<sub>c</sub> R<sub>rel</sub>. We now argue that the dependence on R<sub>c</sub> R<sub>rel</sub> is weak. We can write the expression for M<sub>i</sub> as:

The integrals over the odd powers of r in the expansion of K $_i$  vanish by symmetry. Thus if we truncate the series at rst order, the rst order term vanishes, leaving only the 0th order term :

Truncating the expansion of K<sub>i</sub> at the rst order is reasonable, because K<sub>i</sub>(r) oscillates around the Ferm iw avelength of the system, a length scale close to that of <sup>at</sup>. This approximate form, Eq. (A17) will behave quite badly at small R<sub>c</sub>, because K<sub>i</sub> diverges at the origin, and the radial averaging of this divergence that occurs in Eq. (A15) is not rejected in Eq. (A17). Thus we replace K<sub>i</sub>( $\Re_c$ ) there with the convolution of K<sub>i</sub> with a G aussian of unit weight and a variance r<sub>0</sub> given roughly by the length-scale of the overlap regions of the atom ic

densities (i.e. som e fraction of the range of <sup>at</sup> (r)):

Summarizing these results, we not that we can approximately evaluate (K  $_{i}$  f) as:

where the sum mation over  $\langle j; k \rangle$  indicates that we need only sum over pairs of region II atoms with overlapping densities. The derivation of Eq. (A 20) involved several approximations, and thus is not expected to be precise. We only propose that Eq. (A 20) be used to generate the boundary conditions for Eqs. (A 10) that determ ine the (K<sub>i</sub>  $f_{2}$ )(r) within region <sup>I</sup>, and we have found that the resulting (K<sub>i</sub>  $f_{2}$ )(r) is more dependent on the source term than the boundary conditions. Nevertheless, because of the inaccuracies of Eq. (A 20), we de ne a new region, <sup>I°</sup>, that contains and extends a bit beyond <sup>I</sup>, and we use Eq. (A 20) to obtain the boundary conditions for points r that lie on the boundary of <sup>I°</sup>, and we solve Eqs. (A 10) for all r 2 <sup>I°</sup>, so that the

resulting (K  $_{i}$   $f_{2}$ ) (r) are accurate for all r 2 <sup>I</sup>.

T hus we have all the pieces necessary to compute  $T_K^{int}$ . In sum m ary, we do this as follows:

U sing Eq. (A) 20), we can evaluate (K  $_{i}$  (f) (r) and (K  $_{i}$  (g) (r) for points r on the boundary of a region  $^{I^{0}}$  that is slightly larger than  $^{I}$ .

Using those boundary conditions, the Helm holtz equations (A10) are solved, yielding (K i f)(r) and (K i g)(r) for all points r 2  $I^0$ .

Then (K f)(r) and (K g)(r) are constructed with Eq. (A7), and we can evaluate  $T_K^{int}$  via Eq. (A3).

Ther kernel interaction energy  $T_K^{\text{int}}$  also gives a sm all contribution to the forces on region II atoms near the 1-2 boundary. By di erentiating Eq. (A1), we nd:
