Neel-D im er Transition in Antiferrom agnetic Heisenberg Model and Decon nement of Spinons at the Critical Point

Quantum phase transition from the Neel to the dimer states in an antiferrom agnetic (AF) Heisenberg model on square lattice is studied. We introduce a control parameter—for the exchange coupling which connects the Neel (=0) and the dimer (=1) states. We employ the CP  $^1$  representation of the  $s=\frac{1}{2}$  spin operator and integrate out the half of the CP  $^1$  variables at odd sites to obtain a CP  $^1$  nonlinear—model. The elective coupling constant is a function of—and at =0 the CP  $^1$  model is in the ordered phase which corresponds to the Neel state of the AF Heisenberg model. A phase transition to the dimer state occurs at a certain critical value of  $^1$ C as increases. In the Neel state, the dynamical composite U (1) gauge—eld in the CP  $^1$  model is in a Higgs phase and low—energy excitations are gapless spin wave. In the dimer phase, a connement phase of the gauge theory with s=1 excitations is realized. For the critical point, we argue that a deconnement phase, which is similar to the Coulomb phase in 3 spatial dimensions, is realized and  $s=\frac{1}{2}$  spinons appear as low—energy excitations.

Quantum phase transition (QPT) is one of the most interesting problem in these days. It is offen argued that the simple Ginzburg-Landau theory does not apply to certain class of the QPT's. In this paper we shall study  $s=\frac{1}{2}$  antiferrom agnetic (AF) Heisenberg model on 2-dimensional square lattice with nonuniform exchange couplings,




FIG. 1. Numbering and dimer picture cross symbol is odd site, and spot symbol is even site. Solid line means that its correlation is stronger than dotted lines.

where x denotes site of the spatial lattice, j is the direction index (j=1;2) and  $S_x$  is the spin operator at site x. We rename the even lattice sites x=(0;i) where o denotes odd site and the index i=1;2;3 and 4 speci es its four nearest-neighbor (NN) even sites (see Fig.1).

The exchange couplings  $J_{x\,j}=J_{o\,i}$  are position dependent and we explicitly consider the following case which corresponds to the dimer conguration,

where 0 1 is a control parameter which connects the uniform Heisenberg model to the dimer model.

It is not so di cult to derive the CP  $^1$  eld-theory model, from Eq.(1) $^4$ . The spin operator  $S_x$  can be expressed in terms of the CP  $^1$  variable  $z_x = (z_x^1; z_x^2)^t$  as

where ~ are the Paulim atrices and the CP  $^1$  constraint  $_{a=1;2}$   $\dot{y}_x^a \dot{f} = 1$  guarantees the magnitude of the localized spin as  $\frac{1}{2}$ .

From our assignment of  $J_{\text{oi}}$  (2), it is obvious that  $J_{\text{ol}}$  is larger than the others. We use the path-integral formalism and parameterize the C P  $^1$  variable  $z_{\text{o}}$  by refering to  $z_{\text{ol}}$   $z_{\text{e}}$ ,

where  $p_o$  is a param eter,  $e^i$  is a phase factor and  $z_e=i\ _2z_e$ . At vanishing temperature(T), spins tend to point antiparallel their NN spins, and then the parameter  $p_o$  can be treated as a small parameter. Calculation is rather long but straightforward<sup>4</sup> and we obtain an e ective eld theory of the AF Heisenberg model under study,

where D  $z_x$  = (0 + iA ) $z_x$ , A =  $iz^y$ 0 z is the U (1) gauge eld,  $_x$  is the Lagrange multiplier for the C P  $^1$  constraint and  $L_B$  is the Berry phase term. We have rescaled the imaginary time and x as taking the continuum limit (the spatial coordinate x in Eq.(5) denotes the even site of the original lattice). The elective coupling constant  $f_e$  and the speed of light" c, which is often set unity, are explicitly given as

where a is the lattice spacing of the original lattice and  $f_{A\,F\,H}\,=\,2^{D}\,\overline{2}a$  and  $c_{A\,F\,H}\,=\,\frac{^{D}\,Z_{a\,J}}{h}$  .

Here we should comment on the Berry phase terms,  $L_{\rm B}$ , which appear in the CP $^1$  nonlinear—model representation of the AF Heisenberg model. First we consider AF spin chains in one dimension in order to obtain important insight for the e ect of the Berry phase terms. For the uniform AF chains, the Berry phase reduces to the -term (i d dxF $_{\rm x}$ ) with = . The gauge dynam-ics crucially depends on the value of and only the case of = (mod 2), the deconnement phase is realized. Topologically nontrivial congurations are suppressed by the -term when = .

On the other hand for the bond-alternating (BA) AFH eisenberg chain with  $J_x=J+(1)^x\ J$ , the value of the parameter is  $=\frac{J-J}{J+J}$ , and therefore the above suppression by the -term does not occur and gauge dynamics is essentially the same with the =0 case. Then the connement of the spinon  $z_x^a$  occurs, and low-energy excitations are gapful s=1 excitations  $n_x=\frac12z_x^y\sim z_x$  even for a very small value of J. This is nothing but the spin-Peierls transition.

For the 2-dim ensional uniform AF Heisenberg model, the Berry phase term similarly appears as  $L_B=\frac{i}{2} \sum_{x=x} A_x$ , where  $_x=1$  ( 1) for even (odd) site x (of the lattice with the lattice spacing  $^{\frac{1}{2}}$  Za for the CP  $^{\frac{1}{2}}$  m odel (5)) and  $A_x$  is the area enclosed by the curve given by the time evolution of  $n_x$  ( ). It can be proved that it gives only vanishing contribution for an arbitrary sm ooth con guration. However for singular con gurations like instantons (monopoles), the Berry phase is nonvanishing and it gives term s like  $L_B=i\frac{1}{2}\sum_{i=1}^4\sum_xi^im_x^i;$  where  $i^{\frac{1}{2}}$  are 0;1;2;3 (i=1;2;3;4), respectively and  $m_x^i$  is the instanton number. The index i refers to the four dual sublattices of the original lattice.) From the above  $L_B$ , it is obvious that the cancellation mechanism of the instanton contribution occurs by the destructive interference unless  $m_x^i=4$  (mod 4).

For the nonuniform cases which are considered in this paper, the coe cient of the Berry phase term becomes irrational as in the case of the BA spin chains and therefore cancellation of instanton e ect does not occur or at least weakens. Then we can expect that the (global) phase

structure of the e ective gauge model for the nonuniform AF Heisenberg model is the same with that of the CP $^1$  model without the Berry phase term s. More com $^-$ ments will be given after showing results of nonperturbative studies on the gauge dynamics.

It is straightforward to obtain the e ective potential of = h  $_x$ i and  $z^2$  =  $hz_x^2$ i by integrating out  $z_x^1$ ,

where the cuto  $=\frac{p_{\overline{2}}}{a}$ . The e ective potential  $V_e$  indicates that there exists a critical coupling  $f_c=\frac{4}{a}$ . The existence of the phase transition has been verified by the numerical calculation of the equivalent 0 (3) nonlinear model in (2+1) dimensions  $f_c=0$ . In the weak-coupling region  $f_c=0$ , the spontaneous symmetry breaking occurs and  $f_c=0$  and  $f_c=0$ . As a result, the Higgsphase is realized in the gauge-theory terminology. Low-energy excitations are gapless spin waves which are described by  $f_c=0$ . In the strong-coupling phase  $f_c=0$ ,  $f_c=0$ 

The elective coupling  $f_e$  in (6) is the decreases as increases but above certain value of it starts to increase and goes to in nity at the dimer limit = 1. In the uniform case = 0,  $f_e$  (= 0) <  $f_C$  and this means that the ordered N eel state is realized at the vanishing T in the AF H eisenberg model in two spatial dimensions as it is now widely believed. The behavior of the elective coupling  $f_e$  () shows the existence of a critical value at which the phase transition occurs. This result indicates that the strong-coupling phase of the CP model (5) corresponds to the dimer phase in which the ground state is nothing but spin-singlet pairs formed by the alternative strong exchange couplings and excitations have  $f_e$  1. In fact this N eel-dimer transition was observed by the numerical calculations some years ago<sup>8</sup>.

Hereafter we are interested in the critical point at  $f_e=f_\mathbb{C}$  which separates the Neel and dimer phases. In order to investigate that \phase", study on the gauge dynam ics is required. At  $f_\mathbb{C}$ , h  $_x\,i=hz_x^a\,i=0$ . E ective action of the gauge eld and the eld  $_x$  is obtained by integrating out the gapless spinon eld  $z_x^a$  (a = 1;2). The resultant e ective action becomes nonlocal and therefore it is possible for the gauge dynam ics to belong to dierent universality class from that of the usual gauge theory in 2+1 dimensions. By the continuum eld-theory calculation, the elective action of the gauge eld A is obtained as

where ~(p) is the Fourier transform ed eld of  $_{\rm x}$ . Equation (9) shows that uctuations of the eld  $_{\rm x}$  are strongly suppressed at large distances. In the C P  $^1$  m odel on the 3-dim ensional space-time cubic lattice, a similar expression of the action  $L_{\rm A}$  and L is obtained by the hopping expansion of  $z_{\rm x}^a$  (a = 1;2). In thee ective action  $S_{\rm A}$  of the compact gauge eld U =  $e^{iA}$ , the following nonlocal terms appear

where the sum mation over closed loops includes loops of an arbitrary large size, j j is the length of and the param eter is estimated as  $\frac{1}{2d}$  for m assless  $z_x^a$  with the dim ension of the lattice d = 3. We shall focus our interest on the gauge dynamics of the above nonlocal action which is one of the most important problems in the theoretical studies on the strongly-correlated electron system s in these days and is still controversial. At present it is known that there exists only the con nem ent phase in the (2+1)-dim ensional compact U (1) gauge theory without matter couplings.9 However phase structure is not clear when the U (1) gauge eld couples to matter elds, particularly gapless matter elds 10 14. In particular in Ref. 10;11, it is argued that a decon nement phase is realized by the gapless ferm ion couplings. Simple mean-eld type argum ent is not applicable for the nonlocal gauge system s and num erical studies are required.

We shall study lattice gauge model with a nonlocal action which is related with (10) but slightly more tractable. The sum mation over in  $S_A$  (10) becomes (logarithmically) divergent for the congulation  $U=1^{15}$  since the massless relativistic bosons  $z_x^a$  (a = 1;2), which appear at the critical point, give divergent hopping expansion for U=1. From the above discussion we shall consider the following (2 + 1) dimensional lattice gauge model with the long-range interaction in the ^ direction,

where W  $_{\rm x}$  (n) = U  $_{\rm 0}$  (x)U  $_{\rm 0}$  (x + ^)  $_{\rm 0}$  (M + n^), N is the system size in the ^ direction and  ${\rm g_i}$  (i = 1;2) are coupling constants for the time and spatial directions, respectively. From action (11), it is obvious that the gauge model under study has nonlocal coupling in the ^ direction whereas it has the usual local Maxwell-type correlation in the spatial directions. Reason why we take the action (11) is that the ^ direction terms logarithm ically divergent for U = 1 and also Monte-Carlo simulations are easier for the model than those with full-nonlocal interaction terms. We think that studies of the model (11)

give important insight for the full-nonlocal gauge system (10). More comments on this point will be given after showing the results of the Monte-Carlo simulations of the model (11).




FIG.2. Fluctuation of energy as a function of  $g_1$  is plotted for the xed  $g_2 = 1.0$  and 3.0. Lattice size is  $12^2 - 16$  and  $9^2 - 12$ . The results show the existence of a phase transition.




FIG.3. The correlations of Polyakov lines as functions of their distance are plotted. The results for  $g_1=0.12$  and 0.14 are shown in (a), and one for  $g_1=0.16$  is shown in (b). Value of  $g_2$  is xed as  $g_2=1.0$ . The results show the existence of the con nem ent-decon nem ent phase transition.

We studied phase structure of the model (11) by the M onte-C arlo simulations of the standard M etropolis algorithm . We calculated the uctuation of the energy E, ie., h(E hEi)<sup>2</sup>i, as a function of the coupling  $g_1$  for xed  $g_2$ . The results are shown in Fig 2 for  $g_2 = 1.0$  and  $g_2 = 3.0$ , and they indicate the existence of a phase transition at critical coupling g<sub>1C</sub> 0:14 and  $g_{1C}$  0:13, respectively. We varied the system size and veried that the peak gets sharper as the system size increases. This means that the transition is of second order. In order to investigate gauge dynamics in each phase we calculated the correlations of the Polyakov lines G (') =  $hP(x)P^{y}(x + \hat{1})i$  $_0$  ( $\mathbb{N} + \mathbb{N}$  ^). In Fig.3, we show where P  $(x) = U_0(x)$ the results of G (') for various values of g1 and it is obvious that the behavior of G (') changes at  $g_1 g_{1C}$  from constant for large '. Then the ln G (') / 'to G (') phase transition from the con nement to the decon nem ent phases occurs as g1 increases.

Numerical calculations show that the spatial coupling of the gauge eld and larger system size enhance the decon nement phase. From the above results we expect that the full-nonlocal gauge model (10), which results from the integration of the massless relativistic boson  $z_{\rm x}^{\rm a}$  at the criticality, is in the decon nement phase. In fact

1 corresponds to (10) in which the coupling constant  $g_1$ the dam ping factor j balances the entropy factor of the paths .

In the decon nem ent phase of (11), topologically nontrivial con gurations are suppressed and the eld-theory result (8) gives a qualitatively correct picture. Charges interacting through A have the potential V (r) / 1=r where r is the spatial distance between the two charges.

Let us com m ent on the e ects of the Berry phase. Since  $L_B$  is neglected in (11), one m ay doubt the decon nem ent phase transition observed above. However, as the Berry phase generates extra phases for topologically nontrivial con gurations in the path integral, the Berry phase enhances the decon nement. In fact without these extra phases, all instanton con gurations contribute additively to disorder the gauge system . Thus the existence of the decon nem ent phase in the gauge system (11) guarantees its existence even in the presence of the Berry phase. Sim ilar argum ent was used for the decon nem ent transition at nite T 18, which is established at present.




FIG. 4. Schem atic phase diagram of the Heisenberg model. Phases A,B and C are the Higgs (Neel), Coulomb (critical) and con nem ent (dim er) phases, respectively.

We sum marize the phase structure of the original spin m odel. In the region <  $_{\text{C}}$  ( $f_{\text{e}}$  <  $f_{\text{C}}$ ), the low-energy excitations are the massless spin waves whereas in the region >  $_{C}$  (f<sub>e</sub> > f<sub>C</sub>), they are s = 1 excitations  $n_x$ . On the critical point = C ( $f_e = f_C$ ), the gauge dynam ics is in the \C oulom b" phase and the low-energy excitations are the s = 1=2 bosonic spinons  $z_x^a$  (a = 1;2) which are interacting with each other by the potential 1=r. The spin correlation function decays algebraically both in the Neel state and at the criticality but exponent is di erent. In the Neel state, the spin operator is given  $asS_x = \frac{1}{2}z_x^y \sim z_x \quad hz_x^y i \sim z_x$  $z_x^1$  w hereas at the criticality  $n_x$ , the bilinear of  $z_x^a$  and  $z_x^{ay}$  (a = 1;2). Phase structure of the nonuniform AF Heisenberg model is schematically shown in Fig.4.

Recently a similar phase transition from the Neel to the dim er states was discussed19. There they conclude that instanton e ects are irrelevant at the critical point. Our num erical investigation is consistent with their result but our study shows the long-range interactions of the gauge eld, which appear as a result of the coupling to the m assless boson  $z_x^a$ , play an essentially important role. Results of more detailed studies on the long-range gauge
