A n explanation for the glass-like anom aly in the low -tem perature speci c heat of incom m ensurate phases

A n explanation for the glass-like anom aly observed in the low-tem perature speci c heat of incom – m ensurate phases is proposed. The key point of this explanation is the proper account for the phason damping when computing the them odynam ic magnitudes. The low-tem perature speci c heat of the incom m ensurate phases is discussed within three possible scenarios for the phason dynam ics: no phason gap, static phason gap and a phason gap of dynam ical origin. Existing NM R and inelastic scattering data indicate that these scenarios are possible in biphenyl, blue bronze K $_{0:30}$ M oO $_3$ and BCPS respectively. Estim ates of the corresponding low-tem perature speci c heat are in reasonable agreem ent with the experiments.

Deviations from the Debye law observed in the lowtem perature speci c heat of incom m ensurate (IC) phases have attracted som e attention [1, 2, 3, 4]. It is observed, in particular, a quasi-linear-in-T contribution to this specicheat (C) at the low est tem peratures (. 1K) and, in some compounds [1, 2, 4], a maximum in C (T)=T³ at 10K. It is expected that these peculiartem peratures ities are connected to the low -energy excitations speci c to IC phases, i.e. the phasons. Theoretical discussions try to relate these phasons and the m entioned m axim um in C (T)=T³ [2, 4]. As a result, this maximum is usually ascribed to existence of a gap in the corresponding phason spectrum. The origin of the quasi-linear-in-T contribution, in contrast, has not been elucidated. Nevertheless, due to its sim ilitude to that observed in glasses, this contribution inspire som e speculations [4].

In this paper we show that these peculiarities in the low -tem perature speci c heat of IC phases have a natural explanation. This explanation is based on a speci c feature of phasons that is overlooked in the above cited works: the phason dam ping. In fact it follows from general considerations that, even in perfect crystals, phasons will be overdam ped for small enough wavevectors [5]. The phason damping in perfect crystals has a strongly dependence on tem perature and vanishes for T = 0 [6]. Such a tem perature-dependent dam ping, how ever, is not consistent with the NMR [7,8] and the inelastic neutron scattering data [9, 10, 11] reported for the IC phases in which we are interested: the dam ping inferred from these experiments is twelve orders of magnitude stronger than the calculated for perfect crystals (see below). The phason dam ping in real crystals m ay then be due to defects. To the best of our know ledge, there is no theoretical calculations of such a defect-induced phason dam ping. A nyway, to our purposes, this dam ping can be estim ated from the above m entioned experim ents.

It is worth mentioning that, in some sense, phasons

in IC phases are analogous to vortons in superconducting vortex lattices. They both represent acoustical vibrations of the corresponding IC structure that, unlike to the ordinary acustical vibrations, are overdam ped for sm all enough wavevectors. In fact, it has already been found that vortons yield a linear-in-T contribution to the low-tem perature speci c heat of the corresponding vortex lattice [12, 13]. The key point of the theory we present below coincides with that of the mentioned works on vortex lattices: the proper account for the speci c therm odynam ic features of the dam ped oscillators (phasons in our case). M ention also that these speci c features have been found relevant even for \ordinary" crystals: optical vibrations in real crystals rem ain dam ped due to defects down to zero tem perature, so they may give an important contribution to the corresponding low-tem perature specic heat [14]. In this paper we shall concentrate on IC phases mainly because i) the smallness of the phason frequencies increases the importance of the phason dam ping and, consequently, of the corresponding contribution to the specic heat and ii) the existence of experimental data characterizing the phason dynam ics makes it possible to estim ate in order of m agnitude.

Let us rst consider, for the sake of illustration, the simple case in which the phason spectrum shows an static phason gap (due to \phase pinning," see e.g. Ref. [15]). If the corresponding wavevector-dispersion is negligible, the phason branch becomes analogous to an optical one within the E instein approximation. The corresponding contribution to the speci c heat can then be computed from the speci c heat of an harm onic oscillator C $_{\rm osc}$. But to describe correctly the low-tem perature regine in the IC phases, it is crucial to take into account the phason dam ping. This can be done by using the form alism of Refs. [12, 16]. As a result one obtains

with $!_0$ the natural frequency of the oscillator and the damping coe cient, i.e. the viscosity coe cient divided by the mass of the oscillator. Here $!_D^{-1}$ is a memory time associated with a D rude regularization of this viscosity damping (see, e.g., Ref. [16] and the Appendix). In further considerations the limit $!_D$! 1 is taken. In this limit, the regularized viscosity damping reduces to the \ordinary" one.




FIG.1: Speci c heat Eq. (1) divided by T³ of an harm onic oscillator for di erent dam pings. Here units have been chosen such that $k_B = \sim = 1$, the natural frequency of the oscillator as $!_0 = 1$ and the D rude frequency (see, e.g., Ref. [16] and the Appendix below) $!_D = 10^4$. A di erent scale in C $_{\rm osc}$ =T³ is used in the plot for = 10.

The dependence on temperature of the specic heat Eq. (1) of a damped harm onic oscillator can be seen in Fig. 1 for di erent values of the damping coe cient . In the undamped case (= 0), it is well known that this specic heat is exponentially small at low enough temperatures ($k_B T \sim !_0$). For any nite damping, how ever, the low temperature asymptotic for the specic heat Eq. (1) is linear-in-T:

In overdam ped case ($!_0$) this expression is valid for $k_B T \sim !_0^2 =$ while in underdam ped one ($!_0$), it does for $k_B T \sim !_0$.

It is worth noticing the qualitative sim ilitude, already at this level of consideration, between this speci c heat and that reported in IC phases [1, 2, 3, 4]. In particular in what concerns to the linear-in-T dependence at the lowest tem peratures, which is connected to the dam ping as we have seen. In the following we shall make more concrete considerations.

Let us then consider the Landau therm odynam ic potential (see e.g. Ref. [6, 10])

where $_1$ and $_2$ are the real and imaginary part of the complex order parameter $= (_1; _2)$. In the IC phase (a < 0), the equilibrium values can be taken such that $_1^{(eq)} = (_a=b)^{1=2}$ and $_2^{(eq)} = 0$. W ithin the scheme of no phason gap, which seems to be valid for biphenyl (see below), for small deviations of the order-parameter components from their corresponding equilibrium values: $_i = _i^{(eq)} + _i^0$, one has the follow ing equations of motion (see e.g. R ef. [6]):

Hence $_1$ is associated with longitudinal (am plitude) uctuations while $_2$ does with transverse (phase) ones.

In Eq. (5b) it is implicit that, as stated above, for small enough wave-vectors phasons are overdam ped due to the viscosity term $_2$. At low enough tem peratures

the phason contribution to the speci c heat will be linear-in-T . From Eq. (3), this contribution can be estimated as

for k_B T=- min(vk_m; $v^2 k_m^2$ =); where v^2 = c=m, = m and k_m represents the radius of the B rillouin zone. (Here it has been assumed that the damping is the same for whole phason branch.) This linear-in-T contribution to the low-temperature speci c heat of IC phases due to phasons will prevails over the D ebye one (due to acoustic phonons) at temperatures T . [=(vk_m)], where = (~=k_B) (V^3=v)^{1-2}k_m with V the velocity of sound.

Let us mention that, in accordance with Eq. (5a), amplitude uctuations of the order parameter (amplitudons) are also damped. In consequence, they also give a linear-in-T contribution to the speci c heat at the low – est tem peratures. However, this contribution is always

sm aller than phason one because, for a given wavevector, the am plitudon frequency is always greater than the phason one, the corresponding dam ping coe cient being sim ilar in both cases [see Eqs. (5) and (3)]. Indeed the am plitudon contribution to the low-tem perature speci c heat of the IC phases of interest is not essential to describe the corresponding experim ental data, so we shall om it this contribution if further considerations.

Let us now consider the scheme of a dynam ic phason gap [10]. In some compounds such as BCPS the coe – cients of the equations of motion for the order-parameter may have some frequency dispersion. A relatively simple dispersion is described in the phenomenological model developed in Ref. [17] to reproduce the central peak in the high-temperature phase of strontium titanate. Such a dispersion can be understood as a result of the linear coupling between the order-parameter and a relaxational variable = (1; 2) [10, 18]. The phason dynamics is then governed by the following equations of motion:

Let us emphasize that the most important in these equations is not the extra variable 2 by itself, but the frequency-dispersion that this variable yields in the phason dynamics. Strictly speaking, to reproduce the specic features of e.g. BCPS, i.e. gapped phasons and a central peak, it is only this dispersion what would be necessary (see below). However, to calculate the corresponding phason contribution to the speci c heat, it is convenient to bear in m ind that such a dispersion is obtainable from Eqs. (7) (see Appendix). Anyway, the resulting phason dynam ic is di erent at di erent tim e scales: while the slow oscillations are overdam ped (centralpeak), the rapid ones are not (gapped phasons) [18]. The phason contribution to the low-tem perature specic heat then naturally split into two term s: $C = C_{gph} + C_{cp}$ (see Appendix for further details). The form er:

is the contribution that can be ascribed to the (undamped) gapped phasons [19]. Here $!\frac{2}{2}(k) = {}^2 + v^2 k^2$, ${}^2 = d^2 = m$, $x_0(T) = \sim = (k_B T)$ and, assuming that vk_m , ' $\sim vk_m = k_B$. The latter contribution:

is due to damped phasons (central peak). Here $!_{cp}(k) = v^2 k^2 = (2 - m)$ and $0(x) = \frac{d}{dx} \frac{d}{dx} \ln x$ is

the trigamma function. The low-T asymptotic of this latter contribution is given by Eq. (6) by replacing $\frac{1}{2}$.

Prior to estimate the phason contribution to the lowtemperature specic heat in particular cases, let us see why this scheme of a dynamic phason gap is plausible in BCPS. (In short, this was already mentioned in Ref. [10].) From Eqs. (7) one can not the susceptibility associated with the phason:

where $e_2^2(k;!) = !_2^2(k) = \frac{2}{1+2!^2}$, and $(!) = \frac{2}{1+2!^2}$. According to this susceptibility, the spectrum of the inelastically scattered neutrons in the IC phase will show i) a central peak contribution and ii) a \gapped phason" contribution peaked at ! ' if . A lthough the centralpeak is not resolved by neutron scattering [10, 11], the analysis of the corresponding intensities show that the situation in BCPS is compatible with this scenario [10]. In what concerns to NMR experiments, one has to bear in m ind that NMR is a low-frequency probe. The corresponding Larm or frequency is then expected to be 1 (it is actually the case in BCPS, see such that $!_{
m L}$ below). In consequence, the phason susceptibility probed in these experim ents reduces to

and, therefore, no gap will be revealed by NMR. (It can be said that only the central peak part of the spectrum of the inelastically scattered neutrons is probed by NMR.) It is worth mentioning that form ula (11) was used in fact in Ref. [8]. This further gives a $!_{\rm L}^{1=2}$ dependence of the spin-lattice relaxation time, rst derived in Ref. [20].

W e are now in a position to estimate the phason contribution to the low-temperature specic heat in the IC phases of biphenyland BCPS, and in the charge-densitywave system blue bronze K $_{0:30}$ M oO $_3$:

i) Biphenyl. In accordance with NMR [7] and inelastic neutron scattering data [9], the scheme of no phason gap seems to be valid here (the corresponding gap should be . 10 M H z at least). From neutron scattering, the phason dam ping can be inferred such that 50GHz.Notice that such a damping, obtained at T = 3K, is twelve orders of m agnitude stronger than the one expected for a perfect crystal [6]. So defects must be the cause of the realdamping, although inducing no (observable) phason gap. Both phason and sound velocities can be estimated 10° cm s¹ [3, 9, 21]. Therefore, the linear-in-T as contribution due to phasons will prevail over the Debye one at temperatures . 1K. In addition, according to 10° erg cm 3 K 2 Eq. (6), it is obtained C = T10 for these low tem peratures. The experim ental value $0.5 \,\mathrm{erg}\,\mathrm{cm}^{-3}\,\mathrm{K}^{-2}$ [3] is smaller in this case, what shall be commented below.

ii) BCPS (dynam ic phason gap). From NMR and inelastic neutron scattering experiments [8, 10, 11], the corresponding damping can be inferred such that ² 10 G H z. Notice that no tem perature dependence is observed in this damping down to T = 19K, so it seems very probable that it remains unaltered down to very low tem peratures (as in biphenyl). A coording to Refs. [2, 21], $10^{5} \, {\rm cm \ s^{1}}$. both phason and sound velocities are also Then, the linear-in-T contribution due to dam ped phasons is expected to be the leading one at tem peratures. 10 $10^{\circ} \text{ erg cm}^{3} \text{ K}^{2}$, 1 K. It would be such that C =T what agrees in order of m agnitude with the observed experim entally [2]. In this case (dynam ic phason gap), in addition to this linear-in-T contribution there is a contribut ion due to undam ped gapped phasons $\mathbb{E}q$. (8)]. The phason gap can be estim ated as 100 G H z 1[0], so the maximum in $C = T^3$ observed at 1 2K can then be explained as a result of this latter contribution [19]. This has already noticed in Ref. [2].

iii) Blue bronze K_{0:30}M oO₃. Here, as well as in other charge-density-wave systems (see, e.g., Ref. [22] and the references therein), the scheme of a static phason gap seem s to be them ost appropriate one. In accordance with inelastic scattering data [23] this gap is 200 G H z, and the phason damping can be estimated as 800GHz. Both phason [24] and sound [1, 4] velocities can be in-3 10 cm s^1 . Consequently, a linear-in-T on with C=T 10 10 erg cm^3 K 2 is exferred as contribution with C=T pected due to the damping of the phasons (prevailing over the D ebye one at tem peratures . 1K) and, in addition, a maximum in $C = T^3$ at T ' 10 K due to the phason gap. This qualitatively describes the experim ental observations [1, 4]. M ention that in Ref. [25] it is questioned the explanation that the maximum in $C = T^3$ can be ascribed to gapped phasons: it is shown that a sim ilarm axin um arises due to the acoustic anisotropy of this system . In Ref. [26] it is pointed out that, how ever, acoustic anisotropy cannot explain why this maximum is so sensitive to the crystal quality. It is also worth mentioning that, given the relatively large an isotropy in the phason velocity [24], phasons can behave as overdam ped oscillations along certain directions. Bearing in m ind that an overdam ped phason branch in the one-dimensional case give rise to a contribution $T^{1=2}$ in the low-tem perature speci c heat [13], this could explain the deviation of the linear-in-T behavior observed experim entally in Ref. [4] at the low est tem peratures.

It is worth m entioning that, at present, the above contributions to the low-tem perature speci c heat due to the dam ping of the phason can only be estim ated in order of magnitude. It is true that the corresponding phason dynam ics has been extensively studied in a number of papers. However, the quantitative com parison of our results with the experim ental data would require, in particular, the know ledge of the phason dam ping for the whole phason branch. Unfortunately, these latter data are not reported in the literature and consequently, when carrying out the com parison of our results with experimental data, we are forced to make some assumptions. For instance that the phason dam ping is the same for the whole phason branch. These type of assumptions, at the present unavoidable, could be the reason for the overestimation of the linear-in-T contribution due the phason dam ping when com paring with experim ental observations. M ore precise estimates require m ore com plete experimental data (see Ref. [14] for a detailed discussion). Nevertheless, the agreem ent in order of m agnitude we have obtained indicates that the deviations from the Debye law observed in the very-low-tem perature speci c heat of IC phases are, the most probably, in regard to the phason dam ping. M ention also that the resulting linearin-T behavior is expected as a low-tem perature asymptotic lim it. It is well possible that in the above mentioned experiments this limit has not been fully achieved but rather are in an interm etiate (crossover) region, which could be the reason of the di erent power laws observed there.

In sum m ary, we have show n that the glass-like anom aly observed in the low-tem perature speci c heat of incom – m ensurate phases can be explained as a result of the phason damping. Three possible scenarios for the phason dynamic, reproducing the corresponding NMR and inelastic scattering data for biphenyl, BCPS and blue bronze K $_{0:30}$ M oO $_3$, are discussed. Estimates of the corresponding low-tem perature speci c heat are in reasonable agreem ent with the observed experimentally.

APPENDIX A:PHASON CONTRIBUTION TO THE SPECIFIC HEAT

The know ledge of the partition function Z of a system perm its the computation of the therm odynamic magnitudes. We are interested, in particular, in the specic heat: C = 1 [Q² (T ln Z)=QT²], where = 1= (k_B T).

Form ally, Z can be written as the path integral [16, 27, 28, 29, 30]

where $_{i}(r;)$ (r 2 V, 2 [0;~]) are the elds characterizing the system, S [$_{i}$] is the Euclidean (in aginarytime) action of the system, and the path sum is over the elds satisfying the appropriate boundary conditions. In what concerns to the ~ -space of the (in aginary) time variable , these boundary conditions are periodic ones for elds associated with bosons (to our purposes, it is su cient to consider here bosonic system s).

Among the elds characterizing the system, it can be identied the one associated with the degrees of freedom of interest, say (r;). Form al integration over all other degrees of freedom, i.e., over the set of elds f' $_{\rm i}$ (r;)g, gives

The reduced partition function Z $_{\rm red}$ results from the contribution due to the subsystem characterized by (r;). In contrast to the action in Eq. (A1), the elective action S $_{\rm e}$ [] in Eq. (A4) may be, e.g., a tem perature-dependent functional. It is because S $_{\rm e}$ [] arises from a partial integration. This procedure is well known, e.g., in the theory of phase transitions (see, e.g., Ref. [31] for an exposure in the classical case). It is worth mentioning that S $_{\rm e}$ [] has not to be herm itian necessarily. Relaxational processes can then be described within this form alism . We are interested, in particular, in the contribution to the speci c heat due to phasons (damped oscillators). Let us illustrate the method that further we shall use to calculate such a contribution considering rst the case of <code>\norm al"</code> phonons (undamped oscillators).

1. Noninteracting undam ped phonons: Path-integral calculation of the partition function

In the simplest case, the e ective Euclidean action for phonons can be taken as

where (r;) is a (bosonic) displacement eld. The rst term of this action is associated with the kinetic energy while the last two terms do with the potential one. The case a = 0 corresponds to acoustic phonons while $a \notin 0$ does with optic ones.

The rst variation of the action gives the corresponding equation of motion. According to Eq. (A 5) \pm reads

It is the case even for relaxational dynam ics. In the following, we shall take advantage of this point when calculating the contribution to the speci c heat associated with phasons.

2. Phason contribution to the speci c heat

a. Scheme of no phason gap

Let us now calculate the phason contribution to the speci c heat within the scheme of no phason gap. The procedure we shall follow is based on the results concerning to the damped harmonic oscillator, which can be found, e.g., in Refs. [16, 29]. Below we shall take the lim it $!_D$! 1 in which this regularized damping term coincides with the original one.
