## The decay of photoexcited quantum system s: a description within the statistical scattering model

A bstract. The decay of photoexcited quantum systems (examples are photodissociation of m olecules and autoionization of atom s) can be viewed as a half-collision process (an incoming photon excites the system which subsequently decays by dissociation or autoionization). For this reason, the standard statistical approach to quantum scattering, originally developed to describe nuclear compound reactions, is not directly applicable. Using an alternative approach, correlations and uctuations of observables characterizing this process were rst derived in Fyodorov YV and A hassid Y 1998 Phys. Rev. A 58 R 3375]. Here we show how the results cited above, and m ore recent results incorporating approach by introducing one additional channel.

M olecular photodissociation [1, 2, 3, 4, 5, 6] and atom ic autoionization [7] are examples of quantum -m echanical decay processes: excited quantum systems decay into one or several scattering continua (decay channels). The situation is illustrated schem atically in gure 1. An atom or a molecule is excited from its ground state or a low lying state jpi by a photon. Photoabsorption either results in direct excitation of the decay channels  $\underline{F}_{a,i}$  (where a = 1; :::;M) or in excitation of quasi-bound states jni (where n = 1; :::;N). Decay into a channel  $\underline{F}_{a,i}$  then proceeds via residual interactions between the quasi-bound states and the continua.

C orrelations and uctuations of the quasi-bound states determ ine the statistical properties of the indirect decay cross section. If the corresponding classical dynam ics is su ciently chaotic, these properties can be modeled by random matrix theory [8, 9, 10]. In reference [11] this approach was adopted to characterize the distribution and two-point correlations of the indirect photodissociation cross-section, in the absence of direct decay channels. The results of [11] were obtained by calculating the statistical properties of a resolvent of an elective non-H erm itian H am iltonian. Equivalently they may be obtained from eigenvector correlations [12, 13, 14] of the non-H erm itian elective H am iltonian. In the lim it of weak continuum coupling, cross-section correlations can be calculated using perturbation theory [15]. The results of reference [15] have been generalized in [16] where interference elects between direct and indirect decay paths in the photoabsorption cross section were studied.

How are the results obtained in [11, 15, 16] related to those derived for nuclear and m esoscopic scattering processes within the so-called statistical scattering m odel (also term ed the H eidelberg m odel [17, 18, 19, 10])? Since photodecay is a half-collision process [20, 21], the statistical scattering m odel as such is not directly applicable. In order to establish a connection to the statistical scattering m odel, it has been suggested [22] to introduce an additional channel representing photoexcitation. In this paper we show how to describe the decay of photoexcited quantum system s using this idea. Our results can be sum marized as follows: W e demonstrate that partial and total decay cross sections can be obtained from an extended (alm ost) unitary scattering m atrix by introducing an additional channel for photoexcitation and a linear transform ation rem iniscent of the \Engelbrecht-W eidenm uller" transform ation [23]. W e use that relation to obtain a non-perturbative result for the two-point correlation function of the total cross section in a random -m atrix m odel, which allow s for arbitrary coupling strengths between quasi-bound states, decay channels and the photoexcited initial state.

Let  $ji = ^{j}gi$  be the ground state dressed with the dipole operator  $^{.}$  The partialphotodissociation (photoionization) cross section into channela is proportional to [21, 24]

where the scattering wave function j <sup>(a)</sup> i is outgoing in channel a only. The total photodissociation cross section is given by

(M) is the number of open channels). We follow the approach adopted in [11, 16] where resonant and direct processes were treated separately by m eans of the Feshbach approach [25]: the H ilbert space of excited states is divided into a subspace of




Figure 1. Direct photoionization from an initial state jgi into the subspace of unbound states (M continuum channels  $E_a i$ , here: M = 3) with transition am plitudes  $a^{out}$ , and indirect photoionization via N bound states jni with transition am plitudes  $a^{in}$ . The states jni turn into resonances due to couplings to the continua with matrix elements W<sub>na</sub>.

bound states, and its com plem ent containing all unbound states. The vector ji is decomposed accordingly ji = j<sup>in</sup>i j<sup>out</sup>i. Choosing the bound space appropriately, the scattering problem projected onto the complem ent boses all resonant features. The H am ilton operator in the bound space is represented by an N N random matrix H<sub>0</sub>, with eigenstates jni, n = 1;:::N. The N dipole transition matrix elements to jni are denoted by  ${}^{in}_n$ , and  ${}^{in} = ({}^{in}_1; :::; {}^{in}_N)^T$ . Correspondingly, the M (energy-independent) dipole transition matrix elements from jri to the decay channels are  ${}^{out}_a$ , and  ${}^{out} = ({}^{out}_1; :::; {}^{out}_M)^T$ . The matrix elements of the residual interaction  $\hat{W}$  are denoted by W<sub>na</sub> =  $m \hat{W} \not = ai$ , and W<sub>a</sub> =  $(W_{1a}; :::; W_{Na})^T$  are the column vectors of W. For the total cross section, the following result has been obtained in [16]:

Here  $H_e = H_0$  i W W <sup>y</sup> is an elective non-Herm itian Ham iltonian. The partial cross section is given by

It can be shown by purely algebraic manipulations that, indeed,  $\prod_{a=1}^{P} \prod_{a} (E) = (e)$ . We now prove that the cross sections given in (3) and (4) can be expressed in

term s of the extended (1 + M) (1 + M) unitary scattering matrix

and  $F_e = H_0$  i V V <sup>y</sup>. This maps our problem onto the statistical scattering model. It is convenient to enumerate the channels from 0 to M, so that the new channel, referring to photoexcitation, gets the index 0. The corresponding column vector of V is scaled with a real positive parameter (which will be taken to zero at the end of the calculation). Now, consider transform  $S^0(E;) = u()S(E;)v^T()$ , where the matrices u() and v() are given by

The transform ation (6) is rem in iscent of an E = 0, u () and v () are not unitary. We now show that the cross sections (3) and (4) can be expressed in terms of the elements of S<sup>0</sup>(E;) as follows

In order to derive these relations, we compute the corresponding matrix elements of S  $^0\times$  ; ). Let 1  $\,$  a  $\,$  M :

 !  $H_e$  in the limit ! 0, we obtain expressions (3) and (4) for the cross sections. This is easily veried by inserting (9) and (10) into the left hand side of (7) and (8), respectively.

Equations (7) and (8) enable us to compute the average total cross section, as well as its correlation function, de ned as  $(2 + 1)^{1/2}$

Here is the average local distance between neighboring resonances, and h:::i denotes an energy average, often replaced by an ensemble average in theory. For simplicity,

we assume that the column vectors of V in equation (5) are pairwise orthogonal (see below). In this case, the average extended scattering matrix hS (E; )i is real and diagonal, with diagonal elements given by [26]

It has been used that the correlation function of two S-m atrix elements is di erent from zero only if one S-m atrix element is complex conjugated while the other is not (see reference [26] for details). Equation (14) expresses the autocorrelation function of the total absorption cross section in terms of correlation functions of elements of the extended scattering matrix, de ned in (5). U sually, the energy dependence of the autocorrelation function is mainly due to the energy dependence of the coupling parameters <sup>out</sup>, k <sup>in</sup> k<sup>2</sup> and <sub>1</sub>;:::; <sub>M</sub>. This dependence should be weak in order to allow energy averaging over a su ciently large window. In cases where the corresponding S-matrix correlation functions are available, equation (14) enables us to obtain the autocorrelation function of the total cross section in closed form.

As an illustration, let us assume time-reversal invariance for the collisional system and predom inantly chaotic dynamics in the large (N ! 1) bound space. Then, the required S-m atrix correlation functions are given by the Verbaarschot-W eidenm uller-Zimbauer (VW Z) integral [18]. Using a Fourier representation developed in [26] we obtain:

where  $x = u^2 (2r + 1) = (2u + 1)$ , and where  $a = T_a j_a^{out} j^2 = ({}^{\circ}_0 k^{-in} k^2)$ . As usual, it is more convenient to work with the transmission coe cients  $T_a = 4_a = (1 + a_a)^2$  to describe the coupling between the subspace of quasi-bound states and the decay channels. The functions a and ab are dened as follows:

In the special case of M = 1 open channel, a result corresponding to (15,16) was derived, by a di erent approach, in [27]. In the absence of direct processes (i.e., when all direct dipole transition amplitudes  $a^{\text{out}}$  are zero) equation (15) reduces to the result derived in [11]. Note that in (16), the lim it ! 0 has been taken. This implies that the transmission coe cient corresponding to the \photo channel" has to be set to zero.

In gure 2, the correlation function C(E;!) is shown: as obtained from equation (15), valid in the lim it of N ! 1, and as obtained from the numerical diagonalisation of nite matrices of size N = 128. In the presence of direct decay channels, nite-size e ects are seen to be somewhat larger, as compared with purely indirect decay.

We conclude with two remarks. First, the VW Z-integral can also be used to calculate the average of the partial photoabsorption cross sections. However, for the correlation functions of the partial cross sections no exact analytical form ulae are known. In this case one must use approximate results, such as the \rescaled" B reit-W igner approximation [15, 26]. Second, in theoretical studies of the statistical scattering model, it is often assumed that the channel vectors (the column vectors of V) are orthogonal to each other: one can always obtain the original scattering matrix by an appropriate unitary transformation from a simpler scattering matrix with orthogonal channel vectors.




Figure 2. Correlation function (11) of the total cross section, time-reversal invariant case, results according to equation (15) (lines) and from the numerical diagonalisation of random m atrices with N = 128 (sym bols). (a): without direct coupling (  $^{\rm out}$  = 0), M = 2, = 0:02 ( ), and = 0:5 ( ). (b): with direct coupling, M = 2, = 0:02,  $^{\rm out}_{j}$  = 2:5 ( ), and = 0:5,  $^{\rm out}_{j}$  = 0:5 ( ).
