Spin susceptibility of stabilized phase in the Pu-G a alloy is studied by measuring 69;71 G a NM R spectra and nuclear spin-lattice relaxation rate ${}^{69}T_1{}^1$ in the tem perature range 5 - 350 K. The shift (69 K) of the $^{69;71}$ GaNMR line and $^{69}T_1^{-1}$ are controlled correspondingly by the static and the uctuating in time parts of local magnetic eld arisen at nonmagnetic gallium due to transferred hyper ne coupling with the nearest f electron environm ent of the more magnetic Pu. The nonmonotonic with a maximum around 150 K behavior of 69 K (T) / $_{s;5f}$ (T) is attributed to the peculiarities in temperature dependence of the f electron spin susceptibility s,5f (T) in phase of plutonium. The tem perature reversibility being observed in 69K (T) data provides strong evidence for an electronic instability developed with T in f electron bands near the Ferm i energy and accompanied with a pseudogap-like decrease of $_{\rm s;5f}$ (T) at T < 150 K. The NMR data at high tem perature are in favor of the mainly localized character of 5f electrons in phase of the alloy with characteristic spin-uctuation energy (T) / T $^{0:35(5)}$, which is close to (T) / T $^{0:5}$ predicted by Cox et al. [J.Appl. Phys. 57, 3166 (1985)] for 3D K ondo-system above $T_{K \text{ ondo}}$. The dynamic spin correlations of 5f electrons become essential to consider for $^{69}T_1^{-1}$ (T) only at T < 100 K . However, no NMR evidences favoring form ation of the static magnetic order in - Pu were revealed down to 5K .

I. IN TRODUCTION

Intriguing electronic properties of plutonium and its alloys are studied intensively over many years bearing an exceptional position of these materials both in the modern nuclear energy technologies and the fundam entalphysics of actinides^{1,2}. Metallic plutonium lies in the actinide series at the boundary between neptunium with itinerant 5f electrons and am ericium, dem onstrating in its magnetic properties the localized character of 5f electrons. The rich phase diagram of plutonium ^{3,4} presents ve polym orphous transitions. The unique structural, transport and m agnetic properties of P u are determ ined by the degree of it inerancy for 5f electrons in each of the Pu allotropes. Many e orts are undertaken, at present, to elucidate the ground state of the f-electron system in -Pu and in stabilized phase Pu-Ga, Pu-Alalloys. Under theoretical consideration of the equilibrium macroscopic properties there is assumed either partially⁵ or totally^{6,7} localized character of 5f electrons, thus xing a presence of static spin correlations in the ground state of phase. At the same time, all of experimental studies regarding to the magnetic state of phase result in dynam ic f spin correlations, which developm ent with tem perature does not transform into static magnetic order at low T. The large electronic contribution to speci c heat at low tem perature^{2,8} and the abnorm ally low electrical conductivity in Pu-Ga alloy $3'^9$ are known as inherent electronic properties of the heavy ferm ions system, where f electrons are in the highly localized state. A growth on-cooling of the electrical resistivity in -Pu with the following rather broad maximum of (T) below 200 K

is associated with magnetic scattering of carriers at spin uctuations of f electrons⁹. A such contribution to (T) should be substantially suppressed in the coherent Ferm iliquid state form ed far below T_K 200 K in stabilized -Pu alloys⁸. The magnetic susceptibility (T) of the -Pu alloys Pu_{0:94}Ga_{0:06} and Pu_{0:94}Al_{0:06}⁹ followsmodi ed Curie-W eiss law at high tem perature, favoring the localized state of f electrons with $_{eff} = 1.2$ в.А gentle maximum of (T) near 150 K is explained again by a K ondo-type e ect which promotes a nonmagnetic ground state. The realistic treatm ent of the intra-atom ic Coulom b correlations perform ed for -Pu in Ref.6 predicts the structure of f band, im plying $5f^{5}$ -like atom ic con gurations of Pu with L = 5, S = 5=2 and J = 5=2. This feature leads to suppression of the spin m agnetism in -Pu. The suggested structure of f bands is essential for understanding of the weakly tem perature dependent susceptibility which is observed in the stabilized -Pu alloys⁹.

A coording to the equilibrium Pu-G a phase diagram ^{3,4} phase is a metastable structural state the stabilized of alloys at am bient pressure below 370 K. Indeed, under cooling below 150 K the partial m artensitic transform ation was observed with characteristic therm al hysteresis of the reverse transform ation on subsequent heating of the alloy above the room tem perature. The low-tem perature structural instability of the Pu-Ga alloys stabilized in phase at room T gives rise to additional complications in an analysis of such macro properties as speci c heat⁸, electrical resistivity¹⁰ and m agnetic susceptibility⁹. The more reliable data regarding to the spin uctuation regime of 5f electrons in phase of Pu are provided by the locally sensitive neutron scattering and NMR experiments. The results presented under such kind local studies can be considered as a key moment to clarify details of them ally-or pressure-induced structural instability both of the pure plutonium metal and the Pu-based alloys. Unfortunately, the early NMR studies performed in 60-s present a rather fragmentary raw of data regarding to the ²⁷A lNMR in Pu_{0:95}A $l_{0:05}^{11}$ or unsuccessful e orts in detection of the ²³⁹Pu NMR signal¹² without any subsequent analysis of the results obtained.

In this paper we report on ^{69;71}G a NM R being applied for the st time to trace the tem perature dependence of a spin susceptibility $_{\rm s;5f}$ (T) in the range 5 - 350 K for Ga-stabilized -Pu. The shift (^{9}K) of the $^{69;71}$ Ga NMR line (transition (1=2 ! + 1=2)) and ${}^{69}T_1$ are controlled correspondingly by the static and uctuating in time parts of local magnetic eld arisen at nonmagnetic gallium due to transferred hyper ne coupling with the nearest f electron environment of the more magnetic Pu. The reversible with T nonmonotonic behavior of 69 K (T) / $_{s:5f}$ (T) provides strong evidence for an electronic instability developed with T in f electron bands of -Pu similar to the observed by NMR in concentrated K ondo-system s of C e13,14. A such kind of instability may be considered as one of driving forces for the martensitic transform ation observed recently in Pu_{1 x}Ga_x (x < 0:04) alloys below 150 K. The NM R data at T > 100 K are in favor of the mainly localized character of 5f electrons in phase of the alloy with characteristic spin-uctuation energy (T) / $T^{0:35(5)}$, which is close to (T) / T^{0:5} predicted for 3D K ondo-system above T_K by C ox et al.¹⁵. The dynam ic spin correlations of 5f electrons become essential to consider for $^{69}T_1^{-1}$ (T) only at T < 100 K .

II. EXPERIMENT

The polycrystalline sam ple of -Pu alloy having a nominalG a concentration of 1.5 wt % was prepared as a thin plate (10 3.5 0.2 mm). Surface of the plate was mechanically polished with subsequent electrochem icaletching to rem ove any in purities and the oxide layer induced during preparation of the sam ple by machining from ingot of alloy. Immediately after cleaning the plate was housed under a dry argon atm osphere in a cylinder glass container, which nally was soldered from both sides for safety.

NMR m easurements were performed in magnetic eld H₀ = $!_{0}=_{Ga}$ = 94 kOe using a phase-coherent pulse spectrometer supplied with a quadrature receiver. The ^{69;71}Ga (I = 3=2) spectrum of central transition (1=2 ! +1=2) was obtained by Fourier transformation of the second half of the spin-echo signal followed the (=2)_x t_{del} ()_x pulse sequence. The frequency band excited by the pulse was about 100 kHz and the whole spectrum including all of transitions was measured by

sum m ation of subsequent Fourier-signals of an echo accumulated at di erent equidistant operating frequencies. Below 40 K where self-heating e ects should be taken into account we check additionally the temperature of sample with accuracy (T=T=0.02) by comparing the GaNMR line intensity measured at the di erent T.





FIG.1: 69 GaNMR spectrum in Ga-stabilized -Pu at 20 K. The dotted line shows the NMR line position 69 $_0$ = 96:103 MHz (H $_0$ = 94 kO e) in GaC $l_{\rm S}$ used as a standard reference.

III. RESULTS AND DISCUSSION

The ⁶⁹GaNMR spectrum for Pu-Gaalloy shown in Fig. 1 consists of a single nearly gaussian central line (1=2 ! +1=2) transition and a broad pedestal contributed by the satellite (1=2 ! 3=2) transitions. A similar pattern of the spectrum is observed for a powder of im perfect cubic crystals¹⁶. Thus local distortions of the cubic symmetry take place for charge environment of the Ga nuclei possessing by rather large electric quadrupole m om ent $^{69}Q = 0:168 \quad 10^{-24}$ cm $^{-2}$ and $^{71}Q = 0:106$ 10 24 cm 2 . Distribution of the electric eld gradient arisen due to cubic in perfections results in substantially broad pedestal of satellite lines with a width $(_{0}) / e^{2}QV_{zz}$. As found, below 100 K the pedestal width 69 ($_{\rm Q}$) 0:5 M H z stays unchanged thus indicating that cubic imperfections near the NMR probe -Ga are stable over the tem perature range 5-100 K for phase ofPu.Quadrupolebroadening e ects on the width of the $_{0}^{2} = _{0}$ is greatly central line _o (1=2 ! + 1=2) / reduced in high magnetic eld and its contribution to the width of ⁶⁹G a line does not exceed 2 kHz. By compar-






FIG. 2: The shift $\binom{69}{K}$ and the width $\begin{pmatrix} 0.5 \end{pmatrix}$ taken at a half of height of the $\frac{69}{71}$ G a NMR line (transition (1=2 ! + 1=2)) in stabilized phase of Pu-G a alloy versus T. The $\binom{69}{K}$ (T) data marked by the open circles () are obtained on heating the sample and solid circles () correspond to data obtained during further therm al recycling of the sample over tem perature range 5 - 350 K to testify reversibility with tem - perature of the K (T) data.

ing spectra m easured for two G a isotopes, which nuclear gyrom agnetic ratio di erentiate in ⁷¹ =⁶⁹ 126 tim es, we sure that the width of central line ($_{0:5}$) is m agnetic in origin. Its m agnitude is determ ined by a distribution of localm agnetic eld created at G a-sites by the nearest environm ent of the m ore m agnetic Pu. M agnetic broadening of central line exceeds m ore than three times the m axim ally possible contribution of classic dipolar eld, assum ing for such estim ate the ferrom agnetic spin order am ong twelve neighboring Pu with (5f) 5 m per Pu. The m ain contribution to the width of central line is expected due to the e ect of spin polarization of conducting electrons through RKKI coupling with 5f electrons of Pu.

A gradual increase of $_{0.5}$ with decrease of T evidences for the growth of the short-wave contributions to spin susceptibility of phase in alloy. However, a typical abnorm alsteep broadening of the NMR line favoring form ation any kind of static magnetic order in the -Pu was not observed down to 5 K. That is in line with the results of macroscopic magnetization M (H) measurements performed up to 5 T at T = 1.8 K for the very same sample of Pu-G a alloy.

In the alloy the peak of central line ($_{\rm p}$) is shifted to the higher frequency region with respect to NMR line

position 69 $_{0}$ = 96:103 MHz in GaC l_{3} used as a standard reference. Symmetric shape of the central line im plies that the $^{69;71}$ Ga NMR shift K = (p 0)= 0 is an isotropic quantity inherent for crystals of cubic point symmetry. The main part of K (T) data marked by the open circles () in Fig.2 were collected on heating the sam ple between subsequent measurements of the ⁶⁹Ga NMR spectrum. The K (T) data shown by solid circles () were obtained further during a therm al recycling of the sample over temperature range 5 - 350 K, to testify reversibility with tem perature of the K (T) data row. An absence of any hysteresis in K (T) data no any new line would be appeared in replicates of the NMR measurem ents on-cooling evidence strongly that we have deal with NMR line of Gasited in stabilized phase (the FCC $structure^{3,4}$) of the Pu-Ga alloy.

The Pu alloys stabilized by A 1^8 or G a^9 in phase rem ind in its electronic properties the heavy ferm ion behavior and keeping in m ind a such rem iniscence we consider the total NMR shift for nonmagnetic G a in phase as the K night shift K $_0$ arisen due hyper ne coupling with carriers in the conduction band. An elect of the additional uniform spin polarization of conducting electrons through RKKI like interaction with much less itinerant 5f electrons is taken into account as an additive term K $_{\rm f}$:

here H_f - an electric hyper nem agnetic eld created at the G a nuclei by the unpaired electron spin from 5f shell

of one of twelve neighboring Pu in FCC structure of phase. N_A - Avogadro's number and $_{s;5f}$ - the molar spin susceptibility of f electrons for stabilized phase of the Pu alloy.

The nonm onoton ic tem perature dependence of 69 K (T) with a maximum near 150 K pays on itself our attention. A similar maximum in (T) was revealed recently in measurements of static magnetic susceptibility for $P\,u_{0:94}G\,a_{0:06}$ alloy 9 and it was attributed to the K ondo anomaly f electrons in spin susceptibility $_{s}(q = 0)$ of the alloy. The great di erence in "modulation index" of K (T) (present work) and (T) (Ref. 9) for the stabilized phase Pu alloys with the very same concentration of G a is caused apparently by the T-independent Van V leck contribution dominating in $(T)^6$. The tem perature dependence of a spin contribution to (T) can be m asked by any kind of spurious contributions in m acroscopic m easurem ents of . O n other side, a puzzling sim ilarity in temperature dependences of K (T) and (T) lets us to put in further estimates that NMR shift of G a is almost determ ined by the second term in Eq. (1)which is proportional to $_{\rm s;5f}$. Then using a linear t of the ⁶⁹K (T) vs (T)⁹ plot with T as a parameter, we get an estimate of the e ective hyper nem agnetic eld $H_{f} = 23(6) \text{ kOe/}_{B}$.

Thus for the st time the temperature dependence of shift of the ${}^{69}\text{G}$ a NMR shift presented in this paper provides strong evidence for an electronic instability developed with temperature in f electron bands and accompanied below 150 K with a pseudogap-like decrease of spin susceptibility in stabilized phase of the Pu-G a alloy. Apparently, the similar changes in electronic system at low T take place in a phase of Pu stabilized by A l, if to take into account the tendency of decrease with temperature of the ${}^{27}\text{AlNMR}$ shift observed earlier in P u_{0:95}A l_{0:05}^{11,12}.

Further the tem perature dependence of spin-lattice relaxation rate of 69G a nuclei is considered to elucidate peculiarities in the low frequency spin dynam ic of felectrons in Ga-stabilized -Pu. Corresponding characteristic time interval T₁ for relaxation of longitudinal nuclear magnetization M $_z$ (t) to its equilibrium value M $_0$ was measured by an inversion-recovery technique using the t =2 pulse sequence. An intensity of echo form ed by central line of 69G a was measured as function of the time intervalt while is xed. Duration of pulse corresponds to inversion at t = 0 of the population between $m_I = 1=2$ and $m_I = +1=2$ levels in spin system of 69 Ga (I = 3=2). Subsequent recovery in time of $(M_0 M_z(t))$ was tted with an expression representing two exponents having characteristic time of ${\tt T}_1$ and $T_1=6$ and sum m ed with corresponding weights of 0.1 and 0.917.

The ⁶⁹G a spin-lattice relaxation rate data in stabilized phase of plutonium are plotted versus T in Fig.3. For nonmagnetic element G a surrounded in the alloy with much more magnetic actinide atoms of Pu the nuclear spin-lattice relaxation rate of G a is determined by two




FIG.4: Tem perature dependence of the characteristic energy of f spin uctuations (T) / $T_{1}TK$. Solid and doted lines for T > 100 K represent curves (T) / T $^{0:35\,(5)}$ (the best t for data taken above 100 K) and (T) / T $^{0:5}$ respectively. At T < 100 K the doted curve demonstrates behavior of (T) predicted by C ox et al. in Ref. 15 K ondo system at low tem perature region T < $T_{\rm K}$.

contributions:

The rst contribution $(T_1^{1})_K$ is caused by Ferm i-contact interaction of nuclear spin with conducting electrons and its crude estimate can be obtained from the well known K orringa relation, taken in the form accepted for the free electron gas model of metal:

where K_s is a K night shift. The second term in Eq.(2) determ ines the channel of nuclear spin relaxation caused by time-dependent uctuations of local eld determ ined by spin of f electrons through the RKKI interaction. Following T. Moriya¹⁸ the contribution $(T_1^{-1})_f$ is proportional to the q-weighted in aginary part of the dynamic spin susceptibility $_f(q; ! !_0)$ of f electrons:

Here H_f (q) is a structural form -factor, determ ining hyper nem agnetic eld at the G a nuclei from 5f electrons of Pu, $!_0$ - the nuclear Lam or frequency. If to ignore both the spin correlations among f electrons and the q-dependence of $_f$, then the general expression Eq.(4) for $(T_1^{-1})_f$ is reduced to the following one:

where z is a number of the nearest neighbor of Pu around 69 G a used as NMR and $_{s;5f}$ (T) is a static spin susceptibility of f electrons. Finally, by taking into account that for G a in alloy K $\frac{ZH_{f}}{B}$ s;5f we get:

Here ¹ is the characteristic energy of f spin uctuations, being inverse proportional to 1 - the rate of spin relaxation for 5f electrons of Pu. For com parison in strength of two terms in Eq.(2) we have drawn with dotted line in Fig. 3 the tem perature dependence of $(T_1^{-1})_K$ as estimated from the Korringa relation in Eq.(3). As seen, this contribution is roughly forty times less of the observed. Thus, one may suggest that spinlattice relaxation rate of G a nuclear spin is fully controlled in stabilized phase of Pu by uctuating in time magnetic elds off electrons. One can quantify the (T) behavior for stabilized -Pu over the tem perature range under this study by using expression Eq.(6) with H_{f} = 2.8 kO e/ $_{\rm B}$. The results obtained for (T) are shown by solid circles in Fig. 4. Above 100 K the characteristic energy of spin uctuations is increased following (T) / T^{0:35(5)} (corresponding thing curve is drawn by solid line in Fig. 4). A such behavior of (T) is close to (T) / T^{0:5} predicted by Cox et al.¹⁵ for K ondosystem s above the K ondo tem perature \mathbf{T}_{K} . A reasonable deviation of the (T)-data at T < 100 K from the behavior predicted by Cox et al.¹⁵ for the coherent Ferm iliquid state form ed below T_K (see dotted curve in Fig. 4) m ay indicate on importance of taking into consideration for $(T_1^{-1})_f$ of the antiferrom agnetic spin correlations between f-electron of the nearest Pu atom s. In accordance with Eq.(4) one can expect a sizeable grow th of the shortwave $(q \quad Q_{AF})$ contributions to $(T_1^{-1})_f$. Here Q_{AF} is a wave vector of the corresponding spin order, which would arise due to incom plete suppression of the spin degree of freedom for the f electron in the fram ework of conventional K ondo-scenario developed for system with heavy ferm ions.

IV. CONCLUSION

In sum m ary, we have m easured the tem perature dependence of the 69;71 G a K night shift and the nuclear spinlattice relaxation of 69 G a in G a-stabilized phase of the Pu-Ga alloy with a goal to elucidate the behavior of spin susceptibility s;5f (T) in phase of the alloy over the tem perature range 5-350 K. The reversible with T nonm onotonic behavior of the K hight shift evidences for the instability of the electron spectrum near the Ferm i energy developed in phase below 150 K and accompanied with a pseudogap-like decrease of the uniform (q 0) part of spin susceptibility. The experimental results regarding spin-lattice relaxation rate of ⁶⁹G a do not contradict to an assumption that phase stabilized by Ga in its electronic properties can de treated as the 5f-concentrated K ondo system with T_K 100 K. However it should to rem ark that unam biguous NMR conclusions concerning an itinerancy of 5f electrons in -Pu can be done after NMR studies at high tem perature of the stabilized

phase Pu-Ga alloys. These measurements are now in progress.
