# Berry's phase contribution to the anom alous Halle ect of gadolinium

W hen conduction electrons are forced to follow the local spin texture, the resulting B erry phase can induce an anom alous H alle ect (A H E). In gadolinium, as in double-exchange m agnets, the exchange interaction is mediated by the conduction electrons and the A H E m ay therefore resemble that of C rO<sub>2</sub> and other m etallic double-exchange ferrom agnets. The H all resistivity, m agnetoresistance, and m agnetization of single crystal gadolinium were measured in elds up to 30 T. M easurements between 2 K and 400 K are consistent with previously reported data. A scaling analysis for the H all resistivity as a function of the magnetization suggests the presence of a B erry's phase contribution to the anom alous H alle ect.

I. IN TRODUCTION

W hile many theories account for an anomalous Hall e ect (AHE), proportional to the magnetization of a material, these theories often predict e ects signi cantly smaller than those found in ferrom agnetic materials.<sup>1,2,3,4,5,6,7</sup> An even more signi cant de ciency of the conventional theories is that they predict an anomalous Hall resistivity that is proportional to a power of the longitudinal resistivity, and in the absence of a metal insulator transition cannot account for an AHE that peaks near the Curie temperature,  $T_c$ . Recent models based on a geometric, or Berry, phase have had great success in describing the AHE in double-exchange system s (e.g., manganites and chromium dioxide) and pyrochlores.<sup>7,8,9,10,11,12,13,14,15</sup>

The anomabus Hall e ect in chromium dioxide, a metallic double-exchange ferrom agnet,<sup>16</sup> was show n<sup>10</sup> to agree well with the description based on geometric phase rst suggested by Ye, et al.<sup>7</sup> In gadolinium, as in double-exchange magnets, the exchange interaction among localized (4f) core spins is mediated by the conduction electrons. The anomalous Hall e ect may therefore resemble that of CrO<sub>2</sub> and other metallic double-exchange ferrom agnets. Monte-Carlo simulations predict that the same spin-texture excitations that cause the anomalous Hall e ect in double-exchange system s are also intrinsic to Heisenberg ferrom agnets.<sup>17</sup> Thus it is reasonable to seek to explain the anomalous Hall e ect in other system s using the sam e theory.

G adolinium has a unexpectedly large anom alous H all e ect.<sup>18</sup> In particular, when the applied magnetic eld is parallel to the c-axis the anom alous H all resistivity peaks at  $_{xy}$  6 cm just below T  $_{\rm C}$ .<sup>19</sup> This makes it a good candidate for showing a maximum near 2/3 of its saturation magnetization as chromium dioxide does. Since gadolinium is metallic even above T  $_{\rm C}$ , conventional theories cannot explain a maximum in the H alle ect near the transition temperature.




FIG.1: Gadolinium resistivity vs.tem perature.

#### II. SAM PLE PREPARATION

A c-axis oriented gadolinium (99.99% purity) single crystal was purchased from M aTecK GmbH. Two cuts were m ade parallel to an in-plane axis direction, the sides were polished lightly to clean up rough edges from the saw cuts, and the c-axis plane was thinned as much as possible. The resulting shape is a rectangular prism with an approxim ately square cross-section, and irregularends. G old contact pads were sputtered onto the sides of the sam ple.

# III. EXPERIMENTAL RESULTS

D ata were taken using a Quantum Design Physical Property M easurement System (PPM S) in elds up to 7 T. The zero eld resistivity for the gadolinium crystal is shown in Fig. 1. An alternating current (37 H z) is applied along the a-axis. An abrupt change in slope occurs at the ferrom agnetic transition temperature. The residual resistivity ratio (R  $_{300 \text{ K}} = \text{R}_{4.2 \text{ K}}$ ) is 31. For Halle ect and m agnetization m easurements, the eld was applied




FIG.2: (Color online) G adolinium H all resistivity vs.reduced m agnetization.

along the c-axis. The dem agnetizing factor N = 0.5, and the saturation magnetization is 7.7  $_{\rm B}$  =G d. The large values of the Hall conductivity and the magnetization allowed for very precise measurements. Fig. 2 shows the Hall resistivity plotted vs. reduced magnetization (m = M = M saturation); these data were collected in elds up to 7 T. The Hall resistivity increases rapidly with magnetization below the Curie tem perature as dom ains are swept out. There is some indication that the data maxim ize at om when jn j 0:7. It is conventional jχyj 7 to separate the Hall resistivity into ordinary (OHE) and anom alous (AHE) contributions:  $xy = R_0 B_{in} + R_s_0 M$ , where  $B_{in} = {}_{0}H_{applied} + {}_{0}(1 N)M$ .  $R_{o}$  and  $R_{s}$  are the ordinary and anom alous (or spontaneous) Hall coefcients respectively. The uptums at large values of m are from the OHE, which is small, but not completely negligible.




FIG. 3: (Color online) G adolinium ordinary Hall coe cient vs. tem perature. This represents the best t to the data in elds below 7 T.R.S.Lee and S.Legvold's data are shown for com parison.<sup>19</sup>




FIG. 4: (Color online) Gadolinium anomalous Hall coe – cient vs. tem perature. Previously reported data are shown for com parison.  $^{19,20}$

It is di cult to make a reliable separation of the OHE and AHE contributions. To obtain the values shown in Fig. 3, we rst choose the anom alous Hall coe cient, Rs. Next, the corresponding term (linearly proportional to magnetization) is subtracted from the dataset. Then, a linear least squares t of H all resistivity versus internal eld is made. The value chosen for the anom alous Hall coe cient is adjusted until the tting error is minim ized. The best-tanom alous Hallcoe cients are shown in Fig.4. Thism ethod works even slightly above T<sub>C</sub>, because of the large dem agnetizing correction; At tem peratures signi cantly above T<sub>c</sub> the magnetization curves become linear in eld, and this method fails. The other disadvantage to this method is that the Berry's phase theories predict that the anom alous Hall resistivity is linear in magnetization near T<sub>C</sub> only for low values of m.

The low temperature ordinary Hall coe cient agrees with previously reported values (see Fig. 3).<sup>19</sup> The qualitative behavior is also sim ilar. R.S. Lee and S. Legvold report that the ordinary Hall coe cient of gadolinium has temperature dependence which di ers dram atically

from those of lutetium and yttrium and cannot be explained by a two-band m odel.<sup>19</sup> They obtained a Hallcoe cient which changes sign near 130 K (instead of 260 K, as seen in Fig. 3) and decreases even m ore rapidly as  $T_{\rm C}$ is approached. The most likely cause of these discrepancies is a problem with the separation of OHE and AHE. Lee and Legvold only applied 3 T, whereas the values reported here include data up to 7 T. Indeed, when a subtraction was attempted using the noisier 30 T data (see below), the ordinary Hall coe cient did not appear to change sign until T<sub>C</sub>. There are two possible explanations for this behavior. The sim plest is that the AHE is underestim ated, and the residual gives an apparent contribution to the OHE. The other possibility is that the sign change and the sharp increase in the magnitude of the Hall coe cient are real e ects (possibly due to exchange splitting of the conduction band). In this case, the decreasing m agnitude that we observe at higher elds




FIG.5: (Color online) Tem perature scaled Hall resistivity vs. reduced m agnetization.

and higherm agnetization m ay be the result of an anom alous H alle ect that is not strictly linear in m agnetization at high elds. This non-linearity, if real, would support the hypothesis that Berry's phase e ects contribute to the anom alous H alle ect in gadolinium. This contribution would decrease as the m agnetization increases, thus giving rise to the apparent eld dependence of the ordinary H all coe cient. The ordinary H all resistivity will not be subtracted from plots of the data because of this dilem m a.

If the anomalous Hall e ect results from the thermalexcitation of topological excitations, it is possible to use scaling relations for the magnetization and expected Skyrm ion density to obtain: $^{10}$

where D (x) is a scaling function of the scaling variable  $x = t=h^{1=()}$ , and t and h are the reduced temperature and magnetic eld respectively. A long the critical isotherm t 1  $T=T_{C} = 0$ , making <sub>xy</sub> a function of m only.

In an e ort to extend the results in the vicinity of the Curie temperature to larger values of m, we measured both the H all resistivity and magnetization at the N ational H igh M agnetic Field Laboratory in elds up to 30 T. The high eld data are consistent with those taken in the PPMS, but are noisier due to problems both with the vibrating sample magnetom eter and with pick-up from ripple in the B itter magnets. N onetheless, there is a clear tendency for the H all resisitivity to reach an extrem al value close to m = 2=3. This is shown in Fig. 5, where the closed symbols in the legend are from the PPMS measurements and the remainder from the 30 T experiment. The solid line is the Skyrm ion expression (Eq.1) using the critical exponents for gadolinium<sup>21</sup> and p (0) = 1.

## IV. DISCUSSION

C learly the data in Fig. 5 do not collapse well, yet suggest a tendency to t the Skyrm ion picture. The initial slope at  $T_c$ ,  $^0_{xy} = 15$  cm, depends on the Skyrm ion density and spin-orbit constant through:

A ssum ing  $n_e = 1$  carrier per G d atom, S = 7=2, and a Skyrm ion density lni 0.05 near  $T_c$ , we estim at a spin-orbit coupling constant of  $_{so}$  12 K.A lthough the t is consistent with the data, the data collapse is not so good. The spin-orbit coupling constant also seem s rather large. W e can m ake a rough estim ate of the spin-orbit coupling energy, as J. Ye et al.<sup>7</sup> have done for m anganite, from the H am iltonian:

Next we approxim ate the gradient of the potential using:

where  $r_d$  is the orbital radius, and a is the lattice constant. Then an approximation of the spin-orbit coupling, so, is given by:

J. Ye et al. called the middle term the  $\dim$  ensionless coupling constant appropriate for d-orbitals," and the – nalterm the band kinetic energy."<sup>7</sup> This rough estim ate of the spin-orbit coupling constant works out to be about 9 K for gadolinium.




FIG. 6: (Color online) A nom abus H all coe cient vs. resistivity squared. The residual resistivity has been subtracted. The ordinary H all coe cient has been neglected when converting R.S. Lee and S. Legvold's data from  $R_1$  to  $R_s$ .<sup>19</sup> The discrepancy in the plots is either due to an error in estimating the length between voltage contacts, or a system atic error in reading R.S. Lee and S. Legvold's data from their log-scale plot. The line is the side-jum p prediction using the experim ental coe cient for iron.<sup>1,3,5</sup>

Unlike CrO<sub>2</sub>, where only those electrons participating in the double-exchange contribute to the conductivity, G d has both s and d-electron contributions. It is not suprising, therefore, that the temperature dependence (below 160 K) appears to be dominated by side-jump processes ( $R_s / \frac{2}{xx}$ ),<sup>19</sup> as seen in a plot of  $R_s$  vs.  $\frac{2}{xx}$  in Fig. 6. A side-jump contribution, presum ably from those portions of the Ferm i surface that are not strongly spinpolarized, should be distinguishable from the Skyrm ion contributions, for which  $R_s / e^{E_c - (k_B T)} = (k_B T)$ .<sup>7,10</sup> As a further complication, R.S. Lee and S. Legvold's data show a low temperature sign change of the anom abus

Hall coe cient at a tem perature di erent from the tem perature at which the anom alous Hall coe cient changes sign; neither side-jum p nor Skyrm ion m odels can account for this. Extrapolation of the contribution proportional to the square of the resistivity predicts a much larger Halle ect above 200 K than is observed. The ordinary Halle ect has been neglected when converting R.S.Lee and S. Legvold's data.<sup>19</sup> Berger's prediction for the sidejump contribution is independent of the potential, so it should be essentially material independent, except for the enhancem ent due to band e ects.<sup>4</sup> U sing the rough estim ate calculated for iron (see Appendix A) gives a slope that is an order of m agnitude too sm all for both iron and gadolinium.<sup>5</sup> The straight line in Fig. 6 has a coe cient that is one order of magnitude larger than this estimate. This coe cient is consistent in magnitude with experimentalvalues for iron between 80 K and 267 K .1,3,5 W hile this term ts the low er tem perature data, it is clearly too large near  $T_{\rm C}$  .

W e next explore whether the anom abus Halle ect exhibits better scaling behavior if a side-jum p contribution is removed. W e assume, arbitrarily, that a small side-jum p process contributes to one sixth of the Halle ect at  $T_c$ , i.e.,

and that the rem ainder is due to Berry's-phase processes.




FIG.7: (Color online) Possible Berry's phase contribution vs. reduced magnetization. The estimated side-jump contribution accounts for one third of the Halle ect at T $_{\rm C}$ .

The subtracted term is strictly linear in the magnetization, with a tem perature dependence that depends on the square of the zero eld resistivity (excluding the residual resistivity). This side-jump contribution is of the same order of m agnitude as expected theoretically, as shown in the appendix. Figure 7 is a plot of the di erence versus reduced m agnetization, show ing a better collapse of the data at both low and high elds, with an extrem um in the vicinity of m = 0.6. The evidence for a decrease in the anom alous Halle ect at high elds is even more convincing after subtracting the conventional term . The line shown in Fig. 7 is the same as in Fig. 5, except the initial slope is reduced, and D(0) = 1 has been chosen. This same value for p(x) also provided a good t for  $C rO_2$ .<sup>10</sup> In this case the spin-orbit coupling constant required would be 9 K, in close agreem ent with our rough estimate.

## APPENDIX A:SKEW -SCATTERING AND SIDE-JUMP

M ore conventional explanations for the anom alous H all e ect include side-jum p and skew scattering.<sup>22</sup> Side-jum p scattering is when carriers scatter asymmetrically o im purities. Skew scattering is a process caused by interference between spin-orbit coupling and second order spin-

ip scattering.<sup>7</sup> In conventional ferror agnets, this theory yields values of R<sub>s</sub> two orders of m agnitude smaller than experimental data (according to some authors).<sup>6,7</sup> Since the carrier-electron spins must align with the localized core spins in double exchange systems, spin- ip scattering cannot occur, and therefore skew scattering cannot explain the H alle ect in m anganites and other systems with strong double exchange.

Karplus and Luttinger developed an early model for the anom alous Halle ect resulting from the spin-orbit interaction of spin-polarized conduction electrons.<sup>23</sup> Their m odel gave R  $_{\rm s}$  /  $^2_{\rm xx}$ , but Sm it criticized their m odel arguing that a periodic potential could not cause scattering and produce the anom alous Halle ect.24 Sm it's theory, known as skew scattering, is based on an isotropic scattering caused by the spin-orbit interaction .<sup>25</sup> A fter scattering o of an impurity, them om entum of the charge carriers is changed. Spin-orbit coupling makes scattering to one side m one likely; this gives rise to the Halle ect. Skew scattering is generally distinguished by  $R_s / xx^{5}$ but can also give terms proportional to the square of the resistivity. The quadratic term occurs at high in purity concentrations (simultaneous scattering from multiple impurities) and from phonon scattering (at least above the Debye tem perature).<sup>25</sup> Leribaux<sup>2,5</sup> estimates the phonon scattering contribution in iron as:

Som ew hat later, Berger proposed the side-jum p m echanism that yields R<sub>s</sub> /  $\frac{2}{xx}$ .<sup>4</sup> The side-jum p m echanism occurs when the center ofm ass of a carrier's wave packet is translated to the side while inside the scattering potential. The e ect can be envisioned by picturing light striking a window at an angle. The refractive index of the window results in a displacement of the light's path, but no change in direction because both glass/air interfaces are parallel. In general, this translation can be in any direction, but only asym m etric (due to the spin-orbit interaction) sideways jum ps will directly contribute to the H all e ect. K la ky and C olem an <sup>3,5</sup> estim ate the side-

Recently, the skew and side-jump mechanisms have been treated simultaneously using a model based on the K ubo form alism and the D irac equation.<sup>26</sup> Experimental results for single crystal iron show that the anomalous H all coe cient is proportional to the square of the resistivity between 75 K and room temperature.<sup>1,3,5</sup> The experimental coe cients, which range from 9:3  $10^2$  <sup>1</sup> cm <sup>1</sup> to 1:44  $10^3$  <sup>1</sup> cm <sup>1</sup>, are much larger than either estimate.<sup>1,3,5</sup> These results do not conclusively eliminate these mechanisms as the major source of the anom alous H alle ect, because the estimates are only valid to about one order of magnitude.
