E lectronic Structure of ZnCN i3

A coording to a recent report by Park et al, ZnCN i₃ is isostructural and isovalent to the superconducting (T_c 8 K) anti-perovskite, M gCN i₃, but shows no indication of a superconducting transition down to 2K. A comparison of calculated electronic structures shows that the main features of M gCN i₃, particularly the van H ove singularity near the Ferm i energy, are preserved in ZnCN i₃. Thus the reported lack of superconductivity in ZnCN i₃ is not explainable in terms of T_c being driven to a very low value by a small Ferm i level density of states. We propose that the lack of superconductivity, the small value of the linear speci c heat coe cient and the discrepancy between theoretical and experimental lattice constants can all be explained if the material is assumed to be a C-de cient -ZrCN i sim ilar to the analogous non-superconducting phase of M gCN i₃.

I. IN TRODUCTION

The appearance of superconductivity¹ near 8 K in the Ni-rich perovskite, MgCNi, has stimulated much interest not only because it is unusual in a com pound that is prim arily N i, but because the exact nature of the superconducting state and its m icroscopic origins are still being debated. Like the other unusual new superconductor, M gB₂, it has so far resisted e orts to increase the critical temperature signi cantly by chem ical substitution. Both Cu and Co doping on the N i site reduce the critical tem perature (T_c) , predictably due to band e ects (electron doping) in the former case and possibly due to spin uctuations in the latter^{2,3}. The transition temperature can be raised by 1 K through N isite doping³ with Fe, but this tem perature occurs in M gCN is $_{x}$ Fe_x with x = 0.05, and any further doping again reduces T_c. M g de ciencies or excesses have som e e ect on the sharpness and onset of the superconducting transition, but the optim al com position conductivity of M gC N is seem s m ost sensitive to the carbon site occupancy. Boron doping on the carbon site⁵ reduces T_{c} for relative B/C concentrations of up to 0.07 and elim inates superconductivity for any greater concentration. MgC_xNi_b with x < 1.0 rem ains a cubic perovskite but undergoes an isostructural transition^{1,5} to a sm aller volum e -phase that no longer superconducts.

Recently the synthesis of $ZnCN_{i_3}$ has been reported by Park et al⁶. Since $ZnCN_{i_3}$ is very sim – ilar to M gCN i₃ structurally, and (as we will show) electronically, the lack of a superconducting transition down to 2 K is quite unexpected. Understanding why superconductivity is seen in one com pound but not the other could be important in resolving remaining questions about the unusual behavior of M gCN i₃. The experimental data suggests⁶ that a strongly depressed density of states (DOS) (com – pared to M gCN i₃) at the Ferm i level (E_F) could be responsible for pushing the transition tem perature of ZnCN i₃ below 2 K. The results of a careful com pari-

son of the electronic structure of the two com pounds are presented here, and the required low ering of the DOS is shown to be absent. Because the reported lattice constants di er by 4%, we calculate the theoretical equilibrium lattice constants and explore the e ects of pressure on the electronic structure of each m aterial. We nd that discrepancies when com pared to M gCN is in DOS, in lattice constant, and in observations of superconductivity can be understood if the reported ZnCN is sam ples are C-de cient phase as are M gCN is sam ples with C de ciency.

II. CALCULAT IO NAL METHODS AND ELECTRONIC STRUCTURE

 $ZnCNi_3$ has the typical ABO $_3$ cubic perovskite structure, but with the oxygen atom s on the faces replaced by Niatoms. As Zn and Mg both have a form alvalency of 2⁺, ZnCN is is isovalent as well as isostructural with M gCN i, both residing in space group 221 (Pm $\overline{3}$ m). Calculations were carried out using W ien2k⁷, a full-potential, augmented plane wave + local-orbitalm ethod, and with the local density approximation (LDA) of Perdew and W ang⁸ to the exchange-correlation potential. The density is well-converged with 816 k-pts in the irreducible Brillouin zone. The sphere radii used were 2.1 a.u. for Zn/Mg, and 1.72 a.u. for both C and N i; the R km ax was set to 7.00. The experim ental lattice constants were used in the initial calculations for both M gCN is (a = 3.81 A) and ZnCN i₃ (a = 3.66 A). Compression and expansion percentages are given in term s of these experim ental values.

The electronic structure of M gCN is has been presented previously by several groups^{9,10,11,12}. The dom inant feature is a remarkable, sharp van Hove singularity 65 m eV below E_F , which was traced to an extremely at band around the M point (= $(1,1,0)_{\overline{a}}$) of the Brillouin zone. The electronic structure of ZnCN is is very similar to that of M gCN is. The sharp peak just below the Ferm i energy is still dom inant, though it is shifted slightly dow nw ard in energy by




FIG. 1: Top panel: $ZnCNi_3$ and $MgCNi_3$ at their reported equilibrium lattice constants. Middle panel: $ZnCNi_3$ at its own lattice constant and at that of $MgCNi_3$. The e ect of pressure is rather small. Bottom panel: $MgCNi_3$ and $ZnCNi_3$ both at the same lattice constant (that of $MgCNi_3$). D i erences in electronic structure are larger than can be accounted for by pressure alone, though still small.

approximately 30 meV and has broadened som ewhat (Fig. 1, top panel). In both compounds, the N i ions are two-fold coordinated with their nearestneighbors, the co-planar C ions. Hybridization between Mg/Zn and Ni ions is very small, consistent with the very similar electronic structures of the two compounds. The dispersion created by the two-dimensional bonding of Ni-d and C-p orbitals is responsible^{9,10} for the nearly dispersionless band centered on M . In ZnCN is, the situation is much the same, but the 4p states of the Zn ions, with which the Niions are four-fold coordinated, do participate weakly in the bonding states near the Ferm i energy. This weak bonding is three-dimensional, accounting for the slightly increased dispersion around the Mpoint as well as the low ered energy of the DOS peak.

The downward shift of the peak has the e ect of reducing the DOS at the Ferm ienergy (N (0)), with respect to that of M gCN i₃, by about 1 eV ¹, i.e. by about 20 %. This decrease relative to the M g compound is much less than what is necessary to account for the lack of superconductivity through conventionalBCS theory (see Section C).

A. Pressure Dependencies and Bulk M odulus

Expansion of the ZnCN i_3 lattice narrows the peak and brings it nearer the Ferm i level (Fig. 1 m iddle panel) that is, expansion makes it more M gCN i_3 like. This has the e ect of raising the DOS at the Ferm i energy, but the change is very small even for fairly large expansions. In ZnCN i_3 , an expansion of

12% by volume caused a change in the DOS of only 10%. MgCNis seems to be even slightly less sensitive than this. A calculation of ZnCN is at the equilibrium lattice constant of M gC N is show s, how ever, that the di erences in the electronic structures of the two compounds are due to more than sim ply volume. (See bottom panel of Fig. 1). The probable source of the sm all di erences in electronic structure is residual hybridization of N i-d and Zn-p orbitals. As the lattice is expanded the overlap between these orbitals decreases, but does not disappear com pletely. By looking at the orbitally-resolved character of the at band, we have observed that the amount of Zn-p character in ZnCNi, although m inor, is larger by nearly a factor of two than the amount of M g-p character in M gCN is.




FIG. 2: The bulk moduli and equilibrium volumes of M gCN i_2 and ZnCN i_3 . The experimental volumes are shown as vertical lines – that of ZnCN i_3 is smaller than the calculated value.

The calculated equilibrium volume of ZnCN is compares very favorably with the reported value, the latter being 0.53% smaller by lattice constant. How – ever, this result is som ew hat unusual in that the theoretical value is actually larger than the experimentalone. The calculated equilibrium value of MgCN is is 2% smaller in lattice constant than the experimental value. The discrepancy is in the more common direction, but larger than usual. The two energy vs. volume curves are shown in Fig. 2, along with the experimental volumes. The bulk modulus of ZnCN is taken at the theoretical volume is 251 GPa whereas

that of M gCN is taken at its own theoretical volume is 214 GPa. The M gCN is result is similar to that obtained through LM TO calculations³. Both these values are obtained by tting the M umaghan equation of state¹³ to an energy vs. volume curve and extracting the bulk m odulus through the relation: B = $V \frac{e^2 E}{eV^2}$. The smaller volume Zn compound is, as expected, harder than the M g compound. However, the bulk m oduli of these two compounds, calculated at their respective experimental volumes, dier by only 3.6%, with M gCN is being harder than ZnCN is. This is a consequence of nding the theoretical equilibrium value of ZnCN is above the reported value, while that of M gCN is below the reported value.

B. Electron-Phonon Coupling

The empirical value quoted for the electronphonon coupling constant, , in MgCN i₃ depends on the method by which it is obtained. Using the size of the jump in speci cheat at the superconducting transition and assum ing weak coupling BCS behavior yields¹ = 0.79. This method is obviously unavailable for ZnCN i₃ since no transition has yet been observed. can alternatively be derived by the more com m on method of com paring experim ental and theoretical results for the linear coe cient from speci cheat data:

There is some variation in the reported values of exp for M gC N i3. Som e sources^{1,6,14} place the value at around 29 mJ/molK² for the zero- eld value, while others^{15,16} cite a higher value of about 33.5 $m J/m ol K^2$. Using this range of values, we obtain = 1.5-1.75 for the Mg compound, in agreement with previous results derived in this way.9,17 However, using this methodology, a negative results for ZnCN is, due to the sm all $_{exp}$ = 6.77 reported⁶, less than 25% of that of M gCN is. This unphysical result highlights the discrepancy between experim ental and theoretical comparisons of these two com pounds. Large di erences in observed speci c heat data combined with very small di erences in calculated electronic structure properties produce this unphysical value for .

Furtherm ore, it is the ratio of the 's from the two di erent com pounds that stipulates that the DOS of the ZnCN i_3 sam ple must be signi cantly lower than that of MgCN i_3 . Park et al use the de nition in Eq. 1 along with their speci c heat data to put an upper bound on the value of the DOS of the Zn com pound relative to that of the Mg com pound at the Ferm i level.

It is clear from this equation that N $(0)_{Zn}$ takes its greatest value when $_{Zn} = 0$. The ratio then yields N $(0)_{Zn} = 0.41N (0)_{Mg}$. As mentioned above, there is no such large depression of the ZnCN is DOS as compared to the MgCN is DOS at the Fermi level. In fact, our calculated value of N $(0)_{Zn}$ exceeds the derived upper bound by alm ost a factor of two.

III. D ISCUSSION

M gCN is has now been studied fairly extensively, and we review some results that may be relevant. According to Ren et al.⁵, the carbon occupancy of M gCN is sensitive to preparation conditions and two di erent phases of the com pound em erge. The -phase is carbon depleted, while the phase is nearly stoichiom etric (carbon occupancy is 0.96). Both and phases share the same cubic space group, but the phase lattice parameter is 1.3% smaller and unlike the -phase, it does not superconduct. This is consistent with previous studies¹⁸ which found that T c decreases linearly with decreasing carbon concentration until eventually, at a carbon occupancy of around 0.88-0.89, a multi-phase region is reached in which bulk superconductivity no longer exists. The reported -phase occured at an occupancy of 0.75 at the carbon site⁵, wellw ithin this multiphase region. Shan et al^{16} found that the specic heat was 50% lower in the -phase than in the -phase. The -phase can then be distinguished from the -phase in three in portant aspects: it does not superconduct, it has a signi cantly smaller , and it's equilibrium lattice constant is 1.3% sm aller.

M ost if not all of the evidence regarding ZnCN is can be reconciled if we suppose that the phase reported by Park et al is a carbon de cient \setminus -ZnCN is" phase corresponding to -M gCN is. The electronic structure of the two com pounds is so sim - ilar that it is reasonable to assume that carbon de-

ciencies in the Zn structure would have much the same e ect as carbon de ciencies in the Mg structure. A ssum ing that the experim ental results for this com pound were taken from an -phase of ZnCN i_3 ,

all discrepancies between theory and experiment discussed in this paper disappear. A 1.3% increase in the lattice parameter would result in the common situation in which the theoretical value is smaller than the experimental one. If is multiplied by a factor of two, as it would be in moving from an

to phase, the value calculated using Eq. 1 has a value of 0.42, elim inating the non-physical negative result. P revious electronic structure calculations show that in M gCN i_3 , N (0) decreases dram atically as C concentration decreases¹⁶, resulting in suppression of the superconducting transition. Sim – ilar e ects would be expected for ZnCN i_3 .

Another striking di erence in the data between the Zn and Mg based compounds is a sharply increased lattice sti ness D. Even in the minimally doped alloy M g0:85Zn0:15CN is, an increase of 38% was observed 19 for $_{\rm D}$ and in the fully Zn substituted compound, the increase is 67%⁶. The addition of Zn in any concentration causes a volum e contraction and a concurrent hardening of phonon modes in general. In pure $M \text{ gC} N i_3$, the frequency of a very soft acoustic Nibased phonon mode is calculated in the harm onic approximation to become negative M direction of the $BZ^{20,21}$. along much of the A nham onic stabilization of this mode results in observed dynam ic displacem ents of the N i ions perpendicular to the Ni-C direction.²¹. This \breathing" distortion allow s each N i ion to move away from its two C neighbors and toward the empty interstitial

site. In a C de cient com pound, stress on the N i ions would be partially relieved by vacancies, reducing the advantage of such distortions and thereby increasing $_{\rm D}$.

IV. CONCLUSIONS

From our calculations, stoichiom etric ZnCN is and M gCN₃ are very much alike in both structural and electronic properties. The experim ental report of widely di ering speci cheat data and the lack of superconductivity down to 2 K seems highly unusual in light of the close similarity of these two com pounds. The rather large suppression of the DOS at the Ferm i energy required to interpret the experim ental results using BCS theory fails to m aterialize from the calculations. All results are in line with a ZnCN is phase that is carbon-de cient rather than stoichiom etric. Carbon de cient M gCN i is known to have a smaller volume than the stoichiom etric com pound, to have a strongly depressed , and to be non-superconducting. Our results suggest that the lattice constant of stoichiom etric ZnCN is likely to be larger than that which is reported (probably near 3.74 A), and that a depression of less than 20% in N (0) occurs. A truly stoichiom etric ZnCN is com pound would likely be superconducting at only a som ew hat low er tem perature than M gCN is.
