Phase diagrams of a classical two-dimensional Heisenberg antiferromagnet with single-ion anisotropy

A classical variant of the two-dim ensional anisotropic Heisenberg model reproducing inelastic neutron scattering experiments on La $_5$ Ca $_9$ Cu $_2$ 4O $_{41}$ M .M atsuda et al., Phys. Rev. B 68,060406 (R) (2003)] is analysed using mostly M onte Carlo techniques. Phase diagrams with external elds parallel and perpendicular to the easy axis of the anisotropic interactions are determined, including antiferrom agnetic and spin-op phases. M obile spinless defects, or holes, are found to form stripes which bunch, debunch and break up at a phase transition. A parallel eld can lead to a spin-op phase.

I. INTRODUCTION

The compounds $(La_1Ca)_{14}Cu_{24}O_{41}$ have been studied experimentally rather extensively in recent years. 1,2,3,4,5,6,7,8,9 They display interesting low-dimensional magnetic properties arising from Cu_2O_3 two-leg ladders and CuO_2 chains. In addition, for La_{14} $_xCa_xCu_{24}O_{41}$ there is an intriguing interplay between spin and charge ordering due to hole doping when x>8.

In particular, $\text{La}_5\text{C}\,\text{a}_9\text{C}\,\text{u}_{24}\text{O}_{41}$ exhibits, at low temperatures and small elds, antiferrom agnetic long range order associated with the CuO_2 chains which are oriented along the caxis. The Cu^{2+} ions in those chains carry a spin-1/2. The spins are ordered ferrom agnetically in the chains, while the interchain coupling in the ac{planes is antiferrom agnetic. The magnetic interactions between the ac{planes are believed to be very weak. The couplings in the ac{planes are anisotropic with an easy axis along the baxis, i.e. the magnet has an Ising-like character. 5,6,8,9 Holes may originate from the La and Ca ions, transforming Cu ions into spinless quantities, with a hole content of about 10 percent. 12

Experiments on La₅Ca₉Cu₂₄O₄₁ include them odynam icm easurem ents on the speci cheat, magnetization, and susceptibility^{5,8} as well as electron spin resonance⁶ and neutron scattering.3,8 M otivated by the experim ental ndings, dierent models have been proposed and studied. Firstly, a two-dim ensional Ising model has been introduced, 13,14 where the spins correspond to the C u^{2+} ions, and m obile spinless defects m im ic the holes. In addition to the ferrom agnetic intrachain and antiferrom agnetic interchain couplings between neighboring spins, a rather strong and antiferrom agnetic exchange between next-nearest chain spins separated by a hole is assumed. The model has been shown to describe, at low temperatures, antiferrom agnetic dom ains separated by quite straight defect lines which break up at a phase transition where also the long range magnetic order gets destroyed. The stripe instability is caused by an e ectively attractive interaction between the defects mediated by

the antiferrom agnetic interchain couplings.

Even more recently, a two-dimensional anisotropic Heisenberg model has been shown by Matsuda et al. to reproduce the measured spin-wave dispersions which supposedly result from the collective spin excitations of the Cu²⁺ ions in the ac{planes.9 Our subsequent M onte Carlo simulations on the classical variant of the model seem to indicate, however, that some of its therm odynam ic properties tend to deviate from experim ental ndings. 15 In particular, in an external eld along the b axis, at low tem peratures, the eld dependence of the susceptibility of the anisotropic Heisenberg model disagrees with the measured behavior. The disagreement can probably not be resolved by invoking quantum e ects. In particular, the critical tem perature of the model seem s to be signi cantly lower than the measured one, as can be seen by comparing results on related quantum and classical models. 10,11,15 Indeed, in this paper we will show that the qualitative properties of the phase diagram of the m odel are not a ected qualitatively by quantum e ects.

In any event, the classical variant of the model of M atsuda et al. deserves to be studied in more detail. Apart from the previous qualitative comparison 15 with experim ental data, the classical model is of genuine theoretical interest as well. Perhaps most interestingly, the phase diagram in the (tem perature, eld) {plane is worth studying in the context of two-dimensional anisotropic Heisenberg models. Due to the anisotropy, there is a spin-op phase when applying a su ciently high external eld along the baxis. In two dimensions, that phase has interesting properties as it is believed to be of Kosterlitz-Thouless type with spin correlations decaying algebraically with distance. Furtherm ore, the boundary line of the antiferrom agnetic phase as well as the transition between the antiferrom agnetic and the spin-op phase has been discussed controversially for anisotropic nearest-neighbor Heisenberg models. In three and higher dimensions, there is a bicritical point where the antiferrom agnetic, the spin-op, and the param agnetic phases meet. 16 As it is well known, such a point could occur in two dimensions only at zero temperature (M erm in-W agner theorem). A ctually, di erent scenarios have been proposed. ¹⁷ However, simulations and other analyses on classical models lead to controversial results. ^{17,18} Fairly recently, a S = 1=2 quantum version has been simulated suggesting a topology of the phase diagram with a tricritical and a critical end point. ¹⁹ Our work will deal with this aspect. Note that quasi two-dimensional anisotropic Heisenberg antiferrom agnets exhibiting a spin-op phase have attracted much experimental attention already some years ago. ^{20,21,22} Well-known examples are Rb₂M nCl₄ and K₂M nF₄. The approach of our study may be also useful for the correct theoretical analysis of models describing these materials.

Our main emphasis will be on a classical variant of the model by M atsuda et al. obtained from the spin-wave dispersions of $\text{La}_5\text{Ca}_9\text{Cu}_{24}\text{Oa}_1$. In addition, in an attempt to include possible e ects due to the holes, we shall extend the model by allowing for mobile defects following the previous considerations. In fact, the defects again form stripes which are destabilized at a phase transition. Bunching and debunching of the stripes are novel features. E ects of an external eld along the baxis will also be considered.

The layout of the article is as follows: In the next section, the model will be introduced. Its phase diagrams, without defects and applying external elds parallel and perpendicular to the easy axis of the magnetic interactions, will be presented in Sec. III. The possible in uence of defects on thermal properties will be discussed in section IV, followed by a sum mary.

II. THE MODEL, SIM ULATIONS, AND QUANTITIES OF INTEREST




FIG. 1: Sketch of the the magnetic interactions for the two-dimensional anisotropic Heisenberg model of Matsuda et al. The dots denote the sites of the Cu $^{2+}$ ions in the ac{plane of La₅Ca₉Cu₂₄O₄₁.

Following M atsuda et al., the magnetic properties of La $_5$ C a $_9$ C u $_2$ 4O $_{41}$ depend on the C u $^{2+}$ ions located in

the ac{planes, having a centered rectangular geom etry as depicted in Fig. 1. Based on their spin-wave analysis, the spins (S = 1=2) of the ions couple along the CuO $_2$ chains, i.e. along the caxis, through nearest neighbor, $J_{\rm cl}$, and next-nearest neighbor, $J_{\rm cl}$, exchange constants, with $J_{\rm cl}=0.2\,\rm m$ eV being antiferrom agnetic and $J_{\rm c2}=0.18\,\rm m$ eV being ferrom agnetic. The ferrom agnetic ordering in the chains is due to the strong antiferrom agnetic interchain couplings, see also Fig. 1: $J_{\rm acl}=0.681\,\rm m$ eV refers to the two nearest neighbors in the adjacent chain, and $J_{\rm ac2}=0.5J_{\rm ac1}=0.3405\,\rm m$ eV denotes the couplings to the two next-nearest neighbors.

Im portantly, there is an uniaxial exchange anisotropy favoring alignment of the spins along the baxis. Its contribution to the di erent couplings cannot be determ ined in the spin-wave analysis, and only its integral e ect on the gap in the dispersion is quantied. When going over to a classical description with spins of xed length, say, one, the total anisotropy may be mimicked by a singleion term . Such a term would be, of course, m erely a trivial constant and unphysical for a quantum system with S = 1/2. The single-ion term, avoiding am biguities in distributing the anisotropy am ong the di erent couplings, is quite reasonable in the classical variant. It leads to about the same transition temperature without eld as various exchange anisotropies of the same overall magnitude. 15 In addition, the entire phase diagram seems to be not a ected by the type of anisotropy. The anisotropy has been estimated from the gap energy to be D = 0.211m eV. Thence the Ham iltonian can be written as 9,15

where $S_{l,m} = (S_{l,m}^x; S_{l,m}^y; S_{l,m}^z)$ denotes the spin at the l{ th site in the m {th chain; refers to di erently oriented m agnetic elds, with = z for the eld parallel to the easy axis, and = x or y for a eld perpendicular to it, i.e. along the a or c axis.

Extending this Ham iltonian of M atsuda et al., we introduce defects $S_{l,m}=0$, induced by the holes originating from the La and Ca ions. We neglect direct interactions between the defects, and there are no couplings between a defect and a spin. Next-nearest neighbor spins in the

same chain, $S_{l,m}$ and $S_{1,2,m}$, with a defect in between them are coupled by the exchange constant J_0 (replacing J_{c2}), which we presume to be antiferrom agnetic and rather strong as before, i.e. of severalm eV 13 Specically, we choose $J_0=625\,\mathrm{m}$ eV .Thence, the Hamiltonian (1) is augmented by the term

with $n_{lm} = 0;1$ being the occupation variable of a spin

at site (l;m). The defects are allowed to hop to a neighboring site in a chain, transform ing the spin at that site into a defect and leaving a new spin with arbitrary orientation at its initial site. The probability of such a process is determined by the Boltzmann factor of the change in the magnetic energy, Eqs. (1) and (2), associated with the hop. ¹³ It is easily incorporated in Monte Carlo simulations.

As before, 13 we assume that defects are separated along the chain by at least one spin. The number of defects in each chain will be taken to be 10 percent of the number of sites in that chain. The defect concentration is then close to that in La₅C a₉C u₂₄O $_{41}$. 8 , 12

W e shall study the model, with and without defects, using, apart from ground state calculations, standard M onte Carlo techniques with local elementary processes changing at random ly chosen sites the spin orientation and moving defects to neighboring sites. In the \sin -

In addition, we recorded the magnetic susceptibilities , which may be computed from the uctuations or eld derivatives of the corresponding magnetizations, < M >, and the (nite lattice) staggered susceptibility $^{\rm S}_{\rm S}$ de ned by

To identify the type of transition from the antiferrom agnetic to the param agnetic and the spin- op phases, the fourth-order, size dependent cum ulant of the staggered m agnetization, the B inder cum ulant 23 U $_{\rm L}$, is rather use-

ulations, we consider lattices with the same number L of chains and of sites per chain, i.e. with a total of L² sites. Full periodic boundary conditions are employed. To study nite-size e ects allowing extrapolations to the thermodynamic limit, L! 1, we consider typically sizes ranging from L=10 to L=200. Each run consists of at least 10^6 and up to $5 \cdot 10^6$ M onte C arb steps per site. To obtain averages and error bars, we take into account the results of up to 10 realizations using dierent random numbers.

We compute both quantities of direct experimental interest as well as other quantities which enable us to determ ine critical properties and the phase transition lines. In particular, we recorded the speciecheat C, both from the uctuations and from the temperature derivative of the energy per site E. In the absence of defects, various magnetizations were computed. Especially, we recorded (i) the {component of the magnetization to study the response to a eld in the direction, with = x;y;z,

(iii) the square of the transverse sublattice m agnetization to describe the K osterlitz-T houless character of the spinop phase when applying a eld along the easy axis,

where $< (M_s^z)^4 > is de ned in analogy to <math>< (M_s^z)^2 > .$

In the presence of defects we studied, apart from the speci c heat, magnetization and susceptibility, also microscopic quantities describing the topology and stability of the defect stripes, 13,14 including the average minimal distance between defects in adjacent chains and the density of defect pairs. Results will be discussed in Sec. IV.

III. PHASE DIAGRAMS IN THE ABSENCE OF DEFECTS




FIG. 2: Phase diagram of the model without defects, with elds parallel, H $_{\rm Z}$, and perpendicular, H $_{\rm X}$, to the easy axis. (a) G lobal phase diagram, (b) details in the (T;H $_{\rm Z}$) plane. C rosses denote approximate locations of the tricritical point and the critical end point (see text).

W e analysed the anisotropic H eisenberg m odel of M atsuda et al. applying external elds along the easy axis (H $_{\rm z}$) and perpendicular to it (say, H $_{\rm x}$), and varying the tem perature, see the H am iltonian (1). The resulting phase diagram s are depicted in Fig. 2.

In the case of a eld H $_{\rm X}$ > 0 perpendicular to the easy axis one encounters, at zero tem perature and small elds, H $_{\rm X}$ < H $_{\rm X}^{\rm pm}$, an antiferrom agnetic ground state with the non-zero, eld-dependent z {component of the spins in each chain pointing in the same direction and alternating sign from chain to chain, S $_{\rm l,m}^{\rm z}$ = S $_{\rm l,m+1}^{\rm z}$. At zero tem perature and larger elds, H $_{\rm X}$ > H $_{\rm X}^{\rm pm}$, the magnetic eld term dominates, and the spins are aligned along the direction of the eld, S $_{\rm l,m}^{\rm x}$ = 1. The critical eld H $_{\rm X}^{\rm pm}$ is readily calculated. Inserting the values of the intrachain, J c1 and J c2, and interchain coupling constants, J ac1 and

 $J_{\rm ac2}$, as well as the spin anisotropy, D , as stated in the preceeding section, one gets H $_{\rm x}^{\rm pm}$ = 8.594:: m eV . C ertainly, this is an articial unit, which had to be transcribed into the standard unit Tesla, taking into account the g-factor and the actual spin value, when comparing results for non-vanishing elds quantitatively to experimental ndings. However, in the context of our analysis the articial unit will be su cient. In the following, the unit "m eV" will be suppressed in all expressions for the energy, $k_{\rm B}$ times temperature ($k_{\rm B}$ T), and the magnetic eld.




FIG. 3: Speci c heat vs. tem perature at xed elds H $_{\rm X}$ = H $_{\rm Z}$ = 0 (solid lines), H $_{\rm X}$ = 4.0 (dotted lines), and H $_{\rm Z}$ = 4.0 (dashed lines), for system s, without defects, of various sizes L.

At non-zero tem peratures, a critical line arises from $(T = 0; H_x = H_x^{pm})$ ending at $(T = T_N; H_x = 0)$, see Fig. 2a. The transition separates the ordered antiferrom agnetic phase with a non-zero staggered magnetization $< M_s^{z} j>$, see Eq. (4), from the disordered (param agnetic) phase, where $\langle M_s^z j \rangle = 0$. The phase transition is expected to be continuous and of Ising type, i.e. with the well-known critical exponents of the twodim ensional Ising model. The critical line has been obtained by xing either the temperature and varying the eld or by xing the eld and varying the tem perature. Then standard nite-size analyses on the peak positions of the speci c heat, T_m^{C} (L), were done. Indeed, these positions approach, for su ciently large system sizes, the critical temperature Tc of the in nite system like T_c T_m^C (L) / 1=L, which is consistent with the transition belonging to the Ising universality class. For illustrative purposes, som e raw data on the speci c heat are shown in Fig. 3. The therm albehavior of the staggered magne-




FIG . 4: Staggered m agnetization vs. tem perature for various elds parallel (H $_{\rm Z}$) and perpendicular (H $_{\rm X}$) to the easy axis, simulating system s, w ithout defects, of size L = 100.

tization is shown, for a few selected examples, in Fig. 4.

In the case of an external eld H $_{\rm Z}$ > 0 along the easy axis one obtains a m ore complex and m ore interesting phase diagram, see Fig. 2. In the ground state (T = 0),

one has to distinguish two critical elds, H $_z^{\rm sf}$ and H $_z^{\rm pm}$. For H $_z$ < H $_z^{\rm sf}$, the antiferrom agnetic structure, as described above, has the lowest energy. At larger elds, H $_z^{\rm sf}$ < H $_z$ < H $_z^{\rm pm}$, the spin- op state is stable. There the z{component of the spins in all chains acquires the same, eld-dependent value S $_z^{\rm sf}$ (H $_z$) > 0. The planar, xy{components of the spins are aligned parallel to each other in each chain, pointing in an arbitrary direction due to the rotational invariance of the interactions in the xy{plane, see Eq. (1). The xy{components of spins in neighboring chains point in the opposite direction because of the antiferrom agnetic interchain couplings. At H > H $_z^{\rm pm}$, one has a ferrom agnetic ordering with S $_z^{\rm sf}$ = 1.

For the set of couplings obtained from the spin-wave analysis, the critical elds are H $_z^{\rm sf}=1.808$:: and H $_z^{\rm pm}=7.75$. At H $_z=H_z^{\rm sf}$, the z{component takes the value S z (H $_z^{\rm sf}$) = 0.233::, corresponding to an angle of 76:5:: degrees formed by the z axis and the orientation of the spins.

The complete phase diagram in the (T;H $_{\rm z}$) plane consists of the antiferrom agnetic, the spin-op and the paramagnetic or disordered states, see Figs. 2a and 2b. The antiferrom agnetic phase exhibits long-range order with the staggered magnetization M $_{\rm s}^{\rm z}$ as order parameter. The spin-op phase has been argued to be of K osterlitz-Thouless character, $_{\rm pm}^{16,17,18,19}$ where transverse spin correlations, i.e. < S $_{\rm pm}^{\rm x}$ S $_{\rm pm}^{\rm x}$ of >, decay algebraically with distance $(1 - 1^0)^2 + (m - m^0)^2$. A coordingly, the transverse sublattice magnetization, see Eq. (5), being the order parameter of the spin-op phase in three dimensions, is expected to behave for T > 0 and su ciently large systems as

with g approaching 1/4 at the transition from the spinop to the paramagnetic phase, 24 and g=2 in the paramagnetic phase. Thence, the order paramater vanishes

in the K osterlitz-T houless phase as L $\,!\,$ 1 at all temperatures T > 0.0 f course, in the disordered phase spin correlations decay exponentially with distance.

While the existence of these phases for weakly anisotropic Heisenberg antiferrom agnets in two dimensions is undisputed, basic aspects of the topology of the phase diagram and especially the transitions between the antiferrom agnetic phase and the spin-op as well as the param agnetic phases have been discussed controversially, 17,18,19 and they may, indeed, depend on details of the model.

W e determ ined the boundary line of the antiferrom agnetic phase by m on itoring especially the speci c heat C , the (square of the) staggered m agnetization, < $M_{\rm s}^{\rm z}$) > and < $M_{\rm s}^{\rm z}$) > , the staggered susceptibility, $_{\rm s}^{\rm z}$, and the B inder cum ulant, U $_{\rm L}$, E q. (7). A few raw data for the speci c heat and the staggered m agnetization are included in Figs. 3 and 4.

The transition from the antiferrom agnetic to the disordered phase at low elds and high tem peratures is continuous and of Ising type. Its location, as displayed in Figs. 2a and 2b, follows from nite-size analyses of the various physical quantities. The data are consistent with a logarithm ic divergence of the specien heat as well as with the well-known Ising values for the critical exponents of the order parameter, = 1=8, and of the staggered susceptibility, = 7=4.

M ore interestingly, the transition from the antiferrom agnetic to the param agnetic phase eventually becomes rst order when increasing the eld and lowering the transition temperature, with a tricritical point at $k_B T_{tr} = 0.79$ 0.015 and $H_7^{tr} = 1.665$ 0.01. The boundary line of the antiferrom agnetic phase remains to be 1st order at lower temperatures when separating the antiferrom agnetic and the spin-op phase. The Kosterlitz-Thouless line separating the spin-op phase from the param agnetic (disordered) state hits the boundary of the antiferrom agnetic phase in a critical end point at $k_B T_{cep} = 0.75$ 0.015 and $H_z^{cep} = 1.675$ 0.01, see Fig. 2b. Note that the phase diagram has qualitatively the same topology as the one suggested for the spin {1/2 quantum version of the standard nearestneighbor antiferrom agnet with exchange anisotropy in two dimensions, in agreement with the classical version of that model as well. Therefore, we conclude that quantum e ects are of minor importance for the main features of the phase diagram.




FIG. 5: Binder cum ulant U (80;100), close to the boundary line of the antiferrom agnetic phase, as a function of temperature.

The tricritical point may be located by studying the B inder cum ulant. In the therm odynam ic lim it the value of the cum ulant at the transition point, $U_{L=1}$, is known to depend on the type and universality class of the transition. In simulations, $U_{L=1}$ can be estimated from systematic nite-size extrapolations of the intersection values of the B inder cum ulant for dierent system sizes L_1 and L_2 , $U_{L_1} = U_{L_2} = U (L_1; L_2).^{23}$ In Fig. 5, we depict results for U (80;100), obtained usually at xed temperature and varying the eld in the vicinity of the boundary of the antiferrom agnetic phase. O bviously, U (80;100) is

nearly constant at high temperatures, U 0:6, with a fairly rapid change around k_B T 0:80. This nding and further nite-size analyses on U (L1;L2) for other system sizes allow us, indeed, to approximately locate the tricritical point which separates the transition of Ising type, where $U_{L=1} = 0.6106:$; and the transition of rst order. Note that the value of U $_{L=1}$ m ay be slightly a ected due to the interactions J_{c1} , J_{c2} and J_{ac2} . If only the predom inant coupling J_{acl} were non-zero, the m odel is easily seen to be equivalent to a nearest-neighbor Heisenberg antiferrom agnet on a square lattice (cf. Fig. 1). Clearly, the Hamiltonian then respects the full symm etry of the lattice. Any of the couplings J_{c1} , J_{c2} and Jac2 destroys this lattice isotropy, leading to a spatially anisotropic system for which cumulant ratios usually exhibit (sm all) deviations from their \isotropic" values. 26,28




FIG. 6: Logarithm of the transverse sublattice m agnetization < M $_{xy}^{2}>$ versus the logarithm of the system size L at xed tem perature k_{B} T = 0:6 and for various $\,$ elds H $_{z}$, close to the boundary between the spin- op and the disordered phase.

To determ ine the boundary of the spin- op phase, we analysed the size dependence of the transverse sublattice m agnetization, < M $_{\rm xy}^2$ > . W eapply the criterion that the exponent g, see Eq. (8), is 1/4 at the transition. Typical data are shown in Fig. 6, demonstrating that the magnetization decays much more rapidly with system size in the paramagnetic phase than in the spin- op phase. To estimate the transition point, we determined the local slope (in a double logarithm ic plot),

from two consecutive system sizes, typically, L and L + 20. Indeed, when crossing the phase boundary by xing the temperature and lowering the eld, g_e (L), for large L, tends to jump from 2, characterizing the decay in the disordered phase, to 1/4 at the transition to the spinop phase. Deeper in the spinop phase, g_e decreases slightly.

The K osterlitz-T houless character of the transition between the spin- op and the param agnetic phases is also re ected in the thermal behavior of the specic heat C, which displays a non-critical maximum close to, but not exactly at the transition. Of course, from simulational data one cannot identify the expected essential singularity of C at the transition.

IV. EFFECTS OF DEFECTS

As discussed before, 15 experiments on La $_5$ Ca $_9$ Cu $_2$ 40 $_{41}$ in a eld H $_z$ along the easy axis provide no evidence for a sharp transition from the antiferrom agnetic to the spinop phase. Instead, when xing the temperature and increasing the eld, the antiferrom agnetic phase eventually becomes unstable against the disordered phase, and spinop structures seem to occur at higher elds only locally as indicated by a quite large, but non-critical maximum in the susceptibility. 5,8 The reason for this experimentally observed behavior is not understood yet. Tentatively, one possible explanation invokes the holes or defects, 13 which may drive the transition and suppress the spinop phase.

In the following, we shall explore this possibility by extending the classical variant of the anisotropic Heisenberg model of Matsuda et al. by adding defects as described in Sec. II. A ctually, ten percent of the lattice sites will be occupied by these spinless, mobile defects, in accordance with the experiments. We neglect the quantum nature of the holes and do not, e.g., include a kinetic energy or hopping term in the Hamiltonian as one would normally expect in the case of a doped quantum antiferromagnet. Of course, quantum e ects may play an important role for the phase behavior of the doped model. E.g., quantum uctuations lead to a non-zero mobility of the holes even at T = 0 where our spinless defects are static due to the absence of them all uctuations. Nev-

ertheless, our classical description is believed to provide some guidance to novele ects induced by the holes.

W ithout external eld (H $_{\rm Z}$ = 0) in the ground state (T = 0), the defects will form straight stripes perpendicular to the chains. Due to the next-nearest neighbor interactions, $J_{\rm c2}$ and $J_{\rm ac2}$, the stripes are bunched with two consecutive defects in a chain keeping the minimum distance of two lattice spacings with one spin in between the two defects. Such a bunching did not occur in the related Ising description, 13 where only nearest-neighbor couplings were assumed. In any event, the bunching may be suppressed, for example, by a pinning of the defects or repulsive interactions between the defects. The spins, in the ground state, are oriented along the z axis with an antiferrom agnetic ordering from chain to chain, as in the case without defects.






FIG. 7: Typical low temperature M onte C arb equilibrium con gurations showing (a) at $k_B\,T=0.3$, the bunching of defect lines, and (b) at $k_B\,T=0.6$, the onset of debunching, both for systems of size L=40. The open circles denote the m obile defects, while the arrows symbolize the z {components S_{lm}^z of the spins.

At low tem peratures, the bunching dom inates the typical equilibrium con gurations, as illustrated in Fig. 7a. U pon increasing the tem perature, the stripes tend to debunch, thereby gaining entropy, see Fig. 7b. The debunching is rejected by a steep decrease in the density of defect pairs, i.e. consecutive defects in the same chain separated by merely one spin. The pronounced drop takes place in a rather narrow range of tem peratures at roughly $k_{\rm B}$ T 0.55. However, the debunching seems to be a gradual, smooth process, without any thermal singularities.

A phase transition occurs at $k_B\ T_c$ 0.7, i.e. at a significantly lower tem perature than in the absence of defects. At the transition, the defect stripes destabilize. As for the Ising model with mobile defects, the stripe instability may be inferred from the average minimal distance d_a between each defect in chain m, at position $(l_a;m)$, and those in the next chain, at $(l_a^0;m+1)$, de ned by 13,14

dividing the sum by the number N $_{\rm d}$ of defects. This quantity increases rapidly at the transition. The transition is also marked in the simulations by a pronounced peak in the speci c heat and a drastic decrease in the sublattice magnetization, which is expected to vanish at T $_{\rm C}$ in the thermodynam ic limit.




FIG.8: Illustration of the ground state con gurations in an external eldH $_{\rm Z}>$ 0 for a system with four defects per chain; for (a) H $_{\rm Z}^{(1)}<$ H $_{\rm Z}<$ H $_{\rm Z}^{(2)}$, and (b) H $_{\rm Z}^{(2)}<$ H $_{\rm Z}<$ H $^{\rm sf}$.

Applying an increasing external eld H $_{\rm Z}$ > 0 along the easy axis, the results of the ground state calculation (for even numbers of at least four defects per chain) may be summarized as follows. First, one has to distinguish two elds H $_{\rm Z}^{(1)}$ and H $_{\rm Z}^{(2)}$. For 0 < H $_{\rm Z}$ < H $_{\rm Z}^{(1)}$ one keeps the same antiferrom agnetic structure with bunched defect stripes as in the case of vanishing eld. Then, for H $_{\rm Z}^{(1)}$ < H $_{\rm Z}$ < H $_{\rm Z}^{(2)}$, precisely one additional spin (pointing along the eld direction) is inserted between two consecutive defects in every other chain, see F ig. 8a. This con guration becomes unstable at H $_{\rm Z}$ = H $_{\rm Z}^{(2)}$, and now an additional spin pointing in the z direction is inserted between two consecutive defects in every chain (Fig. 8b). For simplicity and by analogy to the Ising

case, 13 we refer to these two ground state con gurations as "zig-zag" structures. The two elds H $_{\rm z}^{(1)}$ and H $_{\rm z}^{(2)}$ are readily found to be given by H $_{\rm z}^{(1)}=J_{\rm ac2}+J_{\rm c2}=2$ and H $_{\rm z}^{(2)}=2$ H $_{\rm z}^{(1)}$. Inserting the values of the interaction constants (see Sec. II) one obtains H $_{\rm z}^{(1)}=0.4305$ and H $_{\rm z}^{(2)}=0.861$. Note that broader regions of "inserted" spins are, however, not favored energetically even when increasing the eld. Instead, for larger elds, eventually a spin- op transition occurs at H $_{\rm sf}^{\rm sf}$, followed by a ferromagnetic structure at higher elds, as in the case without defects.




FIG. 9: Susceptibility z as a function of the magnetic $\;$ eld H $_z$ at xed temperature k_B T = 0.3, for a system of size L = 40. The inset shows the existence of a very weak maximum at H $_z$ 0.5.

The zig-zag structures lead to a stepw ise increase in the total magnetization, which gives rise to rather small maxima in the susceptibility $^{\rm z}$ at low temperatures, as depicted in Fig. 9. One observes a small, non-critical peak at H $_{\rm Z}$ 0.9, which is the remnant of the transition at T = 0 between the two zig-zag structures depicted in Fig. 8. Moreover, a very weak, non-critical maximum can be identified at H $_{\rm Z}$ 0.5 (see inset). This peak is associated with the zig-zag structure of Fig. 8a. At higher elds, a pronounced peak occurs signaling the transition to the spin-op phase.

W e found, however, no evidence for a phase transition at nite tem peratures associated with the small peaks in $^{\rm z}$. Instead, upon increasing the eld, straight stripes seem to transform gradually into zig-zag stripes, as for

the Ising model with mobile defects. The rst peaks already vanishes at about $k_B \, T$ 0.3, and the position of the second small peak shifts to somewhat higher elds and gets less pronounced as the temperature is increased. It disappears at about $k_B \, T$ 0.5, possibly due to the debunching. Obviously, the occurrence of zig-zag structures cannot be identified with the phase transition in La₅Ca₉Cu₂₄O₄₁ observed well below the onset of spinop structures.

Indeed, the anisotropic Heisenberg model with mobile defects still displays, at low temperatures, a sharp transition from the antiferrom agnetic phase, with straight or zig-zag defect stripes, to a spin- op phase, as signaled by a delta-like peak in the susceptibility z (see Fig. 9). The topology of the phase diagram in the ($T; H_z$) plane seem s to resemble that in the absence of defects, see Figs. 2a and 2b. A ctually, at the triple point (or critical end point) between the antiferrom agnetic, spin-op and param agnetic phases, located roughly at $(k_B T = 0.5; H_z = 1.7)$, the, presum ably, non-critical debunching line seems to meet as well. However, we did not attempt to map the phase diagram accurately, because obviously the introduction of defects does not su ce to reconcile the experim ental ndings on $La_5Ca_9Cu_{24}O_{41}$, showing no direct transition from the antiferrom agnetic to the spin-op phase. In fact, the possible destruction of the spin-op phase by the instability of the defect stripes tends to be hindered by the bunching of the stripes. Further investigations are desirable, but beyond the scope of the present study.

V. SUMMARY

We have analysed in detail a classical variant of a two-dim ensional H eisenberg antiferrom agnet with weak, uniaxial anisotropy proposed by M atsuda et al. to reproduce spin-wave dispersions measured in the magnet La $_5$ Ca $_9$ Cu $_2$ 40 $_{41}$. In particular, we determ ined the phase diagrams of the model applying elds parallel, H $_z$, and perpendicular, H $_x$, to the easy axis of the spin anisotropy.

In the case of a transverse eld H x (perpendicular to the easy axis), the transition from the antiferrom agnetic phase to the param agnetic phase belongs to the Ising universality class. The phase diagram in the case of a eld H_z pointing along the easy axis consists of the antiferrom agnetic, the spin-op, and the disordered (param agnetic) phases. Extensive analyses have been performed to locate the phase boundaries, partly motivated by conicting analyses of related models. Indeed, our analysis, studying especially the Binder cumulant and the transverse sublattice m agnetization, allows one to locate reasonably well both the tricritical point on the phase boundary between the antiferrom agnetic and the param agnetic phases as well as the critical end point between these two phases and the spin-op phase. Quantum effects seem to play no essential role for the topology of the phase diagram, which is in qualitative disagreem ent with experim ental observations on La₅Ca₉Cu₂₄O₄₁.

W e extended the classical variant of the model of M atsuda et al. by including spin less mobile defects m in icking the holes in La $_5$ C a $_9$ C u $_2$ 4O $_{41}$, thereby following previous suggestions on a related Ising model. In the antiferromagnetic phase, the defects, at low tem peratures and low elds, are found to form stripes as in the corresponding Ising case. However, due to next-nearest neighbor couplings, the stripes tend to bunch. The debunching, occurring at higher tem peratures, seems to be non-critical, albeit it takes place in a rather narrow tem perature range. A phase transition at which the antiferrom agnetic order is destroyed is driven by a destruction of the defect stripes loosing their coherency at the transition.

The model with defects has also been studied in the presence of a eld along the easy axis. There, a spin-op phase is observed as well, separated from the antiferromagnetic phase presumably by a transition of rst order. Therefore, we conclude that adding the mobile defects is not su cient to reconcile model properties with experimental ndings ruling out a direct transition from the antiferromagnetic to the spin-op phase. Perhaps a destruction of the spin-op phase may occur when the bunching is suppressed.

However, when interpreting our naings for the model with defects one should keep in mind that our descrip-

tion of the holes is a purely classical one. Q uantum uctuations reduce the clustering tendency of the holes and may also destroy the bunched structures that we nd from our classical ground state analysis. Thus the role of quantum e ects should certainly be investigated more carefully when comparing with actual experiments.

In any event, the models display various interesting behavior, and they may well contribute to arriving at a really satisfying theoretical description of the intriguing experim ental observations on the La $_5$ Ca $_9$ Cu $_2$ 4O $_{41}$ m agnets. Moreover, the methods used in our study may be helpful in analysing phase diagrams of other two-dimensional weakly anisotropic Heisenberg antiferrom agnets.
