Nuclear Magnetic Resonance Studies of -Stabilized Plutonium

Nuclear M agnetic R esonance studies of G a stabilized -Pu reveal detailed inform ation about the local distortions surrounding the G a impurities as well as provides inform ation about the local spin uctuations experienced by the G a nuclei. The G a NM R spectrum is inhom ogeneously broadened by a distribution of local electric eld gradients (EFG s), which indicates that the G a experiences local distortions from cubic symmetry. The K night shift and spin lattice relaxation rate indicate that the G a is dominantly coupled to the Ferm i surface via core polarization, and is inconsistent with m agnetic order or low frequency spin correlations.

Introduction

The investigation of the low temperature properties of plutonium and its compounds has experienced a renaissance in recent years, and several in portant experim ents have revealed unusual correlated electron behavior [1, 2, 3]. The 5f electrons in elemental plutonium are on the boundary between localized and it inerant behavior, so that slight perturbations in the Pu-Pu spacing can give rise to dram atic changes in the ground state character. In fact, Pu exhibits six allotropic form s in the solid state, with varying degrees of sym metry. The inability for band structure calculations to predict all six of these form s is testam ent to the complexity of the correlated electron behavior [4, 5]. - Pu, which exists between 576K and 720K, is the most technologically important form, and can be stabilized down to T = 0 by doping with Al, Ga or In, which substitute for the Pu sites [6]. In particular, Pu_{1 x} G a_x possesses the fcc structure and physical properties of -Pufor 0:020.x. 0:085. It is not obvious why the sm all am ount of the secondary element will stabilize the electronic structure of the phase, although clearly the slight perturbation re ects the itinerant-localization instability of the parent m aterial.

Several theories have en erged to try to explain the stability of the phase. One technological challenge of band calculations in Pu is the ability to predict local versus itinerant behavior for the ve 5f electrons, because the theoretical approaches for these two extrem es are fundam entally di erent. These models typically predict either non-m agnetic ground states, or ones where local Pu m om ents are retained [4, 7]. In principle, such predictions can be tested by various experim ental techniques.

N uclear m agnetic resonance (NM R) is ideal for probing m agnetic correlations and local structure. 239 Pu has a nuclear spin I = $\frac{1}{2}$, so in principle it can serve as a direct probe of the m agnetic correlations via the hyper ne interaction A between the nuclear (I) and the electronic (S) spins. However, for 4f and 5f nuclei, A is usually quite large (on the order of 1000 kO e/ _B), so that uctuations of of the electron spin S relax the nuclei so fast that their signal is rendered invisible. On the other hand, the hyper ne coupling to the nuclei of the secondary element (A 1, G a or In) are typically one to three orders of m agnitude sm aller, so by measuring the secondary nuclei one can gain considerable insight into the spin dynam ics of the system .

O ne of the challenges facing band theorists calculating the electronic structure of -Pu is the role of the secondary atom s. Recent x-ray absorbtion ne structure (XAFS) studies suggest that Pu lattice distorts locally around the G a sites [8]. C learly, these local distortions are caused by the electronic system , and should be captured by band structure calculations. Therefore, a detailed experim ental study of these local distortions puts important constraints on any theory. NMR is also ideal for probing these local distortions, and serves as a com plement to the XAFS data. Nuclei with spin I > $\frac{1}{2}$ experience electric quadrupolar interactions between the quadrupolarm om ent Q of the nuclei and the local electric eld gradient (EFG), V , where V is the crystal eld potential. G a $(I = \frac{3}{2})$ is therefore sensitive to the EFG at the impurity site.

In this paper we present K night shift (K), spin lattice relaxation rate (T_1^{1}) , and linewidth () data on the Ganucleus in a polycrystal sample of $Pu_{1 x}$ Ga_x for x = 0.017 between 4K and 100K. In the early 1970's, Fradin, Brodsky, and coworkers at Argonne perform ed the rst NMR experiments on -Pu stabilized with Al [9]. They found no evidence for any magnetic transition or the form ation of localm om ents. Our work on Ga stabilized -Pu provide the only new data since the pioneering work of Fradin, and we nd similar behavior. The Knight shift and T_1^{1} data behave as in a typical conductor, and we nd no evidence for either localm om ents at the Ga sites, or for strongly tem perature dependent spin uctuations [18]. On the other hand, we do not nd that the EFG at the Ga site vanishes, as expected for a site with cubic symmetry. Rather, the Ga spectrum is inhom ogeneously broadened by a distribution of EFG s.




FIG.1: The $^{69}{\rm Ga}$ NMR spectrum at 4K. The solid vertical line is the position of pure G a m etal, and the solid line through the data is a Gaussian t as described in the text.

This result suggests that there are local lattice distortions with a symmetry lower than cubic at the Ga impurities.

Experim ental

In order to avoid radiological contam ination of the NMR probe, we constructed an epoxy assembly to encapsulate the NMR coil as well as the Pu sample. How ever, since the Pu is subject to both self-heating as well as rfheating due to induced surface currents by the NMR pulses, it is crucial to establish a solid therm al contact to the sample. We therefore bored out the epoxy along the axis of the NMR coil, and secured frits (m etallic screens) at the ends to allow the cold H e gas to enter along the axis of the coil and establish a therm al contact with sample. The mesh of the frits is su ciently ne to prevent any external contam ination. This design allow sus to cool the sample down to 2K with no signi cant heating problem s, as m easured by the nuclear polarization.

The Ham iltonian of the Ga nuclei is given by:

where is the gyrom agnetic ratio, H_0 is the external eld, $_c = 3eQV_{cc}=20$, $= (V_{aa} V_{bb})=V_{cc}$, Q is the quadrupolar moment of the G a, and V are the com – ponents of the EFG tensor. The hyper ne interaction is given by $H_{\rm hyp} = I_{i}A_{i}$ §(r), where the sum is over the various spin contributions (conduction electrons, local spins). For a site with cubic symmetry, V vanishes, so the electric H am iltonian for the G a nuclei in -Pu is sim ply:




FIG.2: The K night shift () and susceptibility (solid line) of the G a versus tem perature. The susceptibility data are taken from [10]. IN SET: The K night shift versus bulk susceptibility.

K $_0$ is a tem perature independent orbital shift contribution, and A $_{\rm i}$ is the hyper ne coupling to the ${}^{\rm th}_{\rm I}$ com ponent of the electronic susceptibility, (T).


In Fig. (1) we show the Ga spectrum at 4K. Note that this spectrum consists of all three nuclear transi- $\frac{1}{2}; I_z =$ tions $(I_z = +\frac{3}{2} \$ + \frac{1}{2}; I_z = +\frac{1}{2} \$$ $\frac{1}{2}$ \$ $\frac{3}{2}),$ since the quadrupolar H am iltonian does not lift the degeneracy. The spectrum is broadened, how ever, by a distribution of EFG 's, as we discuss below . The center of the resonance is som ew hat low er in frequency than that of pure Gametal, indicating a di erent Knight shift. We t the spectra between 4K and 100K to a Gaussian; K and the rm s second m om ent, , are shown in Figs. (2,3). If we assume a single component of magnetic susceptibility, then following Eq. (3), we extract K_0 and A by plotting K versus , where T is an implicit parameter (see inset of Fig. (2). We nd $K_0 = 0.65\%$ and A = 80kOe/B.

Spin Lattice R elaxation

The spin lattice relaxation m easures the time scale for the nuclear spin system to acquire an equilibrium Boltzm ann distribution among the energy levels. Transitions between the nuclear levels are induced by time dependent

uctuating elds that are perpendicular to H_0 . The spin lattice relaxation rate, T_1^{-1} is give by:

where $A_{?}(q)$ is the spatial Fourier transform of the hyper ne coupling in the perpendicular direction, $_{?}$ "(q;!) is the dynam ical q-dependent susceptibility, and the sum is over the Brillouin zone. In this case, we expect that A is isotropic and q-independent, thus the spin lattice relaxation rate is sensitive to uctuations for all q, and any magnetic correlations or magnetic order should be rejected in T_{i}^{-1} .

W e m easured the ${}^{69}\text{GaT}_1^{-1}$ by inversion recovery. In Fig. (4) we show data at 4K, which shows a single exponential. In principle, the recovery of the I = $\frac{3}{2}$ G a can be more complex. However, since the satellites overlay the central transition (strictly speaking, the H₁ pulses have a bandwidth much greater than the EFG distribution) all nuclear levels are inverted by the pulses, and the recovery function simplie es to a single exponential of the form :

where M $_0$, f, and T $_1$ are t parameters. If the EFG were actually much greater, and the satellite transitions (I $_z$ =

 $\frac{3}{2}$ \$ $\frac{1}{2}$) were either too broad to observe, or m issing from the spectra for some reason, then the recovery of the observed central transition (I_z = + $\frac{1}{2}$ \$ $\frac{1}{2}$) would be of the form :

C learly, as observed in Fig. (4), the data indicate a single exponential, which supports the conclusion that the G a is located at cubic site. In the inset, we compare the

relaxation of the ${}^{71}\text{G}$ a with that of the ${}^{69}\text{G}$ a. The time scale for the ${}^{71}\text{G}$ a has been scaled by $({}^{71} = {}^{69})^2$ (see Eq. (4)); the fact that the data for both sets of isotopes fall onto the same line indicates a magnetic relaxation mechanism, rather than a quadrupolar one (as might be expected for structural uctuations, for example).




FIG.5: The spin lattice relaxation rate versus tem perature for the Ga (), and Al (, from [17]) in -Pu. IN SET: T_1TK^2 = versus T, where is given by the Korringa constant. The dotted line is a t to T_1TK^2 = = $S_0 (1 + (T=T_0)^2)$, where $S_0 = 0.046$, and $T_0 = 25K$.

In Fig. (5) we show the temperature dependence of T_1^{-1} . In conductors where the dom inant relaxation mechanism is by scattering with the conduction electrons via a single contact interaction, such as in the alkali earth metals, the Knight shift and the T_1^{-1} are related [11]: $T_1TK^2 =$, where the Korringa constant is given by: $= \frac{2}{B} = k_B \sim 2$. For convenience, we de ne S $T_1TK^2 =$, so for the simple case, S (T) is unity. C learly this quantity approaches a constant value at low tem peratures, as seen in the inset of Fig. (5). This result suggests the absence ofm agnetic correlations orm agnetic order of the Pu spins, which would likely contribute a strong tem perature dependence to T_1T .

The fact that S (T ! 0) 0.05 suggests that hyperne interaction in -Pu ism ore complex than in the alkali earth m etals. E lectron-electron correlations can give rise to an increase in S (T), however S > 1 is seen only in system s with a single hyper ne coupling [12, 13]. The fact that S (T) < 1 suggests that there is more than one hyper ne coupling mechanism to the conduction electrons. In particular, if there were two hyper ne couplings, A_1 and A_2 , to two di erent conduction bands, then the K night shift would be given by the sum $A_1 + A_2$,

whereas the spin lattice relaxation rate would be given by the sum of the squares $A_1^2 + A_2^2$, so that naively one m ight expect $T_1T K^2 = \frac{A_1 + A_2}{A_1^2 + A_2^2}$. If A_1 and A_2 have di erent signs, then the measured ratio can be less than unity, as we observe. In fact, the measured S (T ! 0) suggests $A_2=A_1=0.9$. A second, negative hyper ne coupling via core polarization is common in transition metals such as P latinum [14]. G iven the complex electronic structure of

-Pu, and the result that the f electrons have itinerant behavior, such a result is not surprising [15, 17].

A sseen in the inset, S (T) has a quadratic tem perature dependence; we t the data to S (T) = $S_0 (1 + (T = T_0)^2)$. In transition m etals, T_0 is a m easure of the energy scale on which the density of states has structure away from the Ferm ignergy. Speci cally, Yafet and Jaccarino nd $k_B T_0 = \frac{1}{h} = 3d^2 = dE^2 i_{E_F}$, where is the density of states [16]. C on parison with photoem ission data or band structure calculations is di cult, how ever, since $k_B T_0 = 2.2m$ eV is less than their typical energy resolution [4, 15].

Inhom ogeneous B roadening

W e now turn to the width of the NMR line. In principle, the resonance can be broadened by inhom ogeneities in H₀, by magnetic interactions with the other nuclei in the system, by local magnetic moments on the Pu sites, and by quadrupolare ects. The magnet has a hom ogeneity of 10ppm, so eld inhom ogeneities can be neglected. Let us de ne² as the second moment of the NMR line spectrum. For a nucleus with I > $\frac{1}{2}$ we expect quite




FIG.6: The hole-burning spectrum of 69 G a at 4K. The solid line is the spectrum after a narrow inversion pulse, and the dashed line is the spectrum with no prelim inary pulse.

generally:

where ${}^2_{m ag}$ is the contribution from m agneticm on ents in the system, 2_q is the contribution from non-zero EFG's at the nuclear site, ${}_nH_0$ is the contribution from the anisotropic susceptibility and dem agnetization elds in the powder, and 2_0 is the second moment of the nuclear dipole interaction. Note that $= {}^0$ corresponds to like spin coupling (for example 69 G a ${}^{-69}$ G a coupling) and




FIG. 7: The rm s second m om ent of the spectral line versus applied eld. The solid line is a t to Eq. (7), and the dotted line is the estim ated hom ogeneous linew idth.

€ ⁰ corresponds to unlike spin coupling (⁶⁹Ga⁻⁷¹Ga and ⁶⁹Ga-²³⁹Pu) [13]. These quantities can be calculated for the fcc Pu lattice with random ly located Ga atom s, and depend on the orientation of the eld with respect to the crystal param eters [13]. For our polycrystalline sample, the broadening is an average over the unit sphere; since ², ⁰ varies by less than 50% over the unit sphere we have chosen the (100) eld direction for concreteness. We nd $^{2}_{69:69} = 0.009 \text{G}^{2}$, $^{2}_{69:71} = 0.004 \text{G}^{2}$, and $\frac{2}{69:239} = 2:5G^2$. As seen in Fig. (3), the spectral broadening is much greater than the dipolar coupling. In order to determ ine the eld dependent contribution, we measured the linew idth as a function of applied eld, as seen in Fig. (7). Fitting the data to Eq. (7) we nd $(H_0 = 0) = 4:6G$, a value still greater than than dipolar second moment, so the NMR spectrum must be inhom ogeneously broadened by 4:3G 4:4kHz.

To test for inhom ogeneous broadening we perform ed a hole burning test by saturating a narrow fraction of the line. We applied a low power pulse to the system prior to a broad-band echo sequence; the spectrum is shown in Fig. (6). Clearly, the full spectrum consists of the superposition of several narrow intrinsic lines. Note

that the rm s second m om ent for the "hole" is 6.7G, a value on the order of the eld independent broadening, but still greater than the calculated value. How ever, the excitation pulse in this case was still greater than the hole linew idth (but narrow erthan tha full spectral linew idth), so it is doubtful that the measured hole linew idth re ects the intrinsic linew idth.

The inhom ogeneous broadening arises either from m agnetic m om ents in the system, or from a distribution of EFG s. In the latter case, we utilize the m easured hyper ne coupling to estimate the size of the putative m agnetic m om ent as 5 10 5 _B. Such m om ents would not be detected in bulk susceptibility m easurem ents. How - ever, neither nor K show any signi cant temperature dependence, as one m ight expect if these localm om ents were present in the system.

In fact, the most likely source of inhom ogeneous broadening is from a distribution of EFGs which contribute the the quadrupolar linew idth. One way to test for this is to compare the linewidth of the ⁷¹G a to that of the ⁶⁹Ga. However, we nd the surprising result that the ⁷¹G a width is 76% larger than that of the ⁶⁹G a, whereas the quadrupolar moment of the 71 Ga is 40% sm aller! (N ote, however, that the measured n's (see Eq. 7) of the two isotopes do follow the ratio of the gyrom agnetic ratios, as expected.) The reason for this discrepancy may be related to the fact that the sample had been held at tem peratures T < 100K for several days prior to the m easurem ents of the 71 Ga. At these tem peratures, the dam age to the lattice in icted by the radioactive decay of the Pu atom s is not annealed out, and is re ected in resistivity m easurem ents [18]. O ne expects that the EFG will re ect lattice dam age, thus it is reasonable that the inhom ogeneous broadening is due to lattice distortions.

In this case, the 4kH z broadening would correspond to a distribution of e^{69} QV_{cc}=h 27kH z in the local EFG at the G a site.

Any perturbation from cubic symmetry at the Ga site will give rise to a nite EFG and consequently contribute to the line breadth. XAFS studies of the Pu-Ga distances in -Pu indicate that the lattice contracts slightly around the Ga impurities [8], however it is not clear how the EFG will be modiled as a result. Further studies are needed to determ ine what fraction of the quadrupolar line broadening arises from radioactive dam age and what arises from lattice contraction around the Ga impurities.

D ecay of the E cho E nvelope

The decay of the echo envelope can provide inform ation about the like-spin coupling and the intrinsic linew idth. The spin echo is acquired by applying the pulse sequence 90 180, and occurs at a time 2 after the rst pulse. The integral of the spin echo is plotted versus ² in the inset of Fig. (3). In the lim it where ² is highly anisotropic, so that the like-spin nuclear coupling ism uch larger in a particular direction, the form of the echo decay can be solved exactly in term s of ² [19, 20, 21]. In this case, the echo decay is G aussian:

where $T_{2G}^{2} = 2^{2}$. However, for the dipolar couplings discussed here, we are not in such a lim it, and one cannot write down an exact form for the echo decay [22]. Nevertheless, we nd that the echo decay is indeed G aussian with a time constant T_{2G} 480 s. This value corresponds to a second m om ent of 0.105G², a factor 10 tim es larger than calculated. Even though we do not have an exact form for the echo decay for dipolar couplings, one would expect a priori that the m easured echo decay constant would be within an a factor of 2-3 of the like-spin second m om ent. Therefore, the fact that we nd such a disparity is surprising. If the like-spin coupling is in fact larger than we estim ated, then this result suggests one of three causes: (i) there exist indirect couplings between the Ga (unlikely due to their large spatial distances), or (ii) the e ective Ga-Ga distance is smaller, as m ight be expected for G a clustering, or (iii) the unlike P u spins are

uctuating quickly, so that there is a uctuating eld at the G a site that contributes to the dephasing of the G a spins [23]. XAFS studies of the G a distribution suggest that the G a is distributed uniform ly, so the most likely explanation for the enhanced echo decay rate is (iii) [8]. In fact, we do expect that the Pu nuclear spins have a very fast spin lattice relaxation rate, since they must have a large hyper ne coupling.

Conclusions

GaNMR in -Pu provides information both about the local structure and distribution of the G a atom s, as well as the electronic spin uctuations. We nd that for 1.7 atom ic percent doping, -Pu shows little evidence for local magnetic moments at the Pu sites, but that the hyper ne coupling between the G a and the conduction electrons probably contains a contact as well as a core polarization term. Furthermore, the NMR spectrum is inhom ogeneously broadened by a distribution of EFG's at the cubic sym m etric G a site. M ore detailed studies of the linew idth as a function of doping should yield in portant inform ation about the G a distribution. It is worth noting that these experiments were conducted at temperatures lower than the proposed K ondo tem perature of 200-300K [10]. Therefore, further studies at higher tem peratures m ay shed light on the presence of spin uctuations.
