Energy absorption in time-dependent unitary random matrix ensembles: dynamic vs. Anderson localization

We consider energy absorption in an externally driven complex system of noninteracting fermions with the chaotic underlying dynamics described by the unitary random matrices. In the absence of quantum interference the energy absorption rate W (t) can be calculated with the help of the linear-response K ubo form ula. We calculate the leading two-loop interference correction to the sem iclassical absorption rate for an arbitrary time dependence of the external perturbation. B ased on the results for periodic perturbations, we make a conjecture that the dynamics of the periodically-driven random matrices can be mapped onto the one-dimensional A nderson model. We predict that in the regime of strong dynamic localization W (t) / $\ln(t)=t^2$ rather than decays exponentially.

1. Introduction. Last years had revealed an increasing interest [1, 2, 3, 4] to the tim e-dependent random matrices, arising from the eld of condensed matter physics. The natural way to study a complex quantum system is to couple it to an external eld ' which enters the Ham iltonian H $['] = H_0 + V'$ as a parameter and can be controlled at will. Applying a time-dependent perturbation ' (t) gives access to quantum dynamics of the many-electron wave function governed by the Schrödinger equation i((t)=0t = H['(t)] (t). If the perturbation frequency and the relevant energies (e.g., the electron tem perature) are sm aller than the Thouless energy in the sample then it is possible to apply a universal description in terms of the random -m atrix theory (RMT) of an appropriate symmetry [5]. The resulting tim e-dependent theory is speci ed by twom odeldependent quantities, which should be determ ined m icroscopically [6]: the mean level spacing and the sensitivity of the parametric spectrum $h(@E_i=@')^2 i$ to the variation of the control parameter \prime .

The crucial quantity characterizing quantum dynamics of the system is the energy absorption rate

and its dependence on the form of the external perturbation ' (t). [In Eq. (1), HE (t) is the expectation value of the total energy of the system .] The standard approach to calculation of W is based on the K ubo linear response theory which expresses the energy absorption rate in term s of the matrix elements of 0H = 0t. For the standard W igner-Dyson random matrix ensembles one nds [7,8]:

is the level velocity autocorrelation function, with $E_i[']$ being the adiabatic levels of an instantaneous H am iltonian, and = 1 or 2 for the orthogonal (GOE) or unitary (GUE) symmetry classes, respectively. The K ubo dissipation rate (2) is ohm ic as it scales / v^2 regardless of the system's symmetry.

The sem iclassical result (2) was obtained neglecting quantum phenomena in dynamics. There are two types of interference e ects which may invalidate the sem iclassical description. The stone is related to the condition of continuous spectrum implicitly assumed in evaluating the Kubo commutator. For a closed system the Kubo formula (2) can be applied only at su ciently large v 2 = C (0) when the spectrum is Vĸ smeared by nonstationary e ects. For small v Vĸ the dynam ics is adiabatic and dissipation is due to rare Landau-Zener transitions between the neighboring levels. In this case the energy absorption rate becom es $v^{=2+1}$. The second statistics-dependent [7] with W interference e ect com es into play for re-entrant perturbations when the system is being swept through the sam e realization of disorder m any times. For a certain type of tim e-dependent perturbations, destructive interference in the energy space may lead to dynam ic local-

ization [9] and hence to the vanishing of the absorption rate.

Recently the rst quantum interference correction to the K ubo dissipation rate (2) for the orthogonal sym metry class was considered, taking into account both the original discreteness of the spectrum [3] and the e ect of weak dynamic localization [4]. The one-loop relative correction to W₀ contains a dynamic cooperon and evaluates either to a positive number $(v=v_k)^{2=3}$ for a linear bias ' = vt [3] or to a negative and growing in time correction / t for a monochrom atic perturbation switched on at t = 0 [4] (in this case the dynamic localization e ect is the most pronounced).

The purpose of the this Letter is to study the quantum interference correction to W_0 for the unitary symm etry class, that involves evaluation of the two-loop diagram s m ade of dynam ic di usons. We will derive the general expression for W (t) [Eq. (21)] valid for an arbitrary time dependence of ' (t) and then discuss the lim its of linear and (multi-) periodic perturbations.

2. Description of the form alism . Quantum dynam ics of time-dependent unitary random matrices can be conveniently described by the nonlinear K eldysh – m odel derived in Ref. [3]. The eldysh ective action (with the weight e $^{\rm S}$)

is a functional of the Q eld acting in the K eldysh (P auli m atrices i) and time spaces. In Eq. (4) the operators \hat{E} and ' have the m atrix elements $\hat{E}_{tt^0} = i_{tt^0} e_{t^0}$ and ' $_{tt^0} = _{tt^0}' (t^0)$, and C_u (0) is the level velocity autocorrelation function de ned by Eq. (3) with = 2.

The saddle point of the action (4) is given by

where we denoted = $C_u(0)$.

The whole manifold of the Q matrices can be parametrized as

where the matrices U are unitary, so that P is a Herm itian eld, whereas all non-Herm iticity is located in the matrices




Fig.1. Two-loop diagram s for the distribution function F, corresponding to the term s of Eq. (15). Solid lines denote the di usons.

[in particular, the standard saddle point (5) corresponds to P = 3].

For perturbative calculations we choose the standard rational parameterization of the P matrix,

which has the unit Jacobian @P = @V = 1. The matrix V anticommuting with ₃ is given explicitly by

with the matrix dacting in the time space only. Its bare correlator inferred from the Gaussian part of the action has the form :

where we have denoted $t = t = 2, t^0 = t^0$ = 2, and introduced the free di uson propagator [1, 2, 10, 4]

Physical quantities are contained in the average M_{R}^{0} i $Q \in {}^{S [Q]} D Q$. Due to causality, $M_{tt^{0}}$ i shares the structure of the Eq. (5) but with the saddle-point distribution $F^{(0)}$ substituted by the exact distribution F. The energy absorption rate can be calculated as [4]

3. Perturbation theory. Expanding the Keldysh (upper-right) block of the matrix Q in term s of the diffusons d with the help of Eqs. (7) { (10) one obtains the perturbative series:

The two-loop correction to the distribution function is given by three pairings:

shown diagrammatically in Fig. 1. The other possible pairings vanish due to causality of the theory. In Eq. (15), the vertices S $^{(m)}$ come from expansion of the action (4) to the order W m . In the rational parametrization (9) they are given by the following expressions:

The the term s not included in Eqs. (17) and (18) do not contribute to the pairings shown in Fig. 1. In writing Eqs. (16) { (18) we used the concise notations $F_{ij} = F_{t_i t_j}$, $d_{ij} = d_{it_j}$, and $'_{ij} = '(t_j)$, with integration being perform ed over all time arguments involved.

The diagram s (a) and (b) shown in Fig.1 contain a loose di uson [2] which couple d to the rest of the diagram . As a result, the corresponding correction to the distribution function $F_{t+2,t}$ =2 can be written as

where t^0 is the \center of m ass" time at the right end of the loose di uson, and $(t^0; t^{00};)$ is a complicated expression denoting the rest of the diagram. The corresponding correction to the energy absorption rate given by Eq. (13) simplifies to

where we employed Eq. (12) and used the asymptotics $F_{t,t} = 1 = (i \) at \ ! 0.$

Contrary, the diagram (c) in Fig.1 does not contain a loose di uson and cannot be represented in the form (20) with already taken derivative with respect to the external time t.

F inally, it is worth m entioning that the diagram (a) is completely canceled against the part of the diagram (b) which contains the time derivative originating from the rst term in Eq. (18).

As a result of straightforw and but rather lengthy calculation one ends up with the general expression for the two-loop correction to the K ubo dissipation rate (2) valid for an arbitrary ' (t):

(21) the term with @=@t describes the contribution of the diagram (c) while the rest is the contribution of the diagram s (a) and (b). Thought the derivatives with respect to and t can be easily calculated with the help of Eq. (12) we leave them unevaluated in order to keep the simplest form of the expression.

4. Linear case. We start the analysis of the general formula (21) with the case of a linear bias '(t) = vt. Then the dynamic di uson (12) is given by D (t_1 ; t_2) = (t_1 t_2) expf ^{3 2} (t_1 t_2)g where = (v^2)¹⁼³ is the dephasing rate due to the time-dependent perturbation [3]. Since the di uson D (t_1 ; t_2) depends only on t_1 t_2 , the integrand in Eq. (21) does not depend on t and the corresponding time derivative describing the contribution of the diagram (c) vanishes.

The product of three di usons in Eq. (21) is an even function of , hence -dependence should be taken into account only in the term s' $_{\rm ij}$. The resulting expression becomes

where we employed the symmetry between the integration variables to simplify the nalexpression.

leading to a surprising cancelation of the two-loop quantum correction in the unitary case mentioned in Ref. [3].

It is also instructive to consider the case of the linear perturbation switched on at t = 0: '(t) = (t) vt. Here

the term with @=@t in Eq. (21) is generally nonzero but it is small in the most interesting limit t 1. The tim e-dependent W (t) is then given by Eq. (22) where the region of integration is now bounded from above by the condition x + y + z < t. The correction to the total absorbed energy becomes

Thus, the two-loop quantum correction, though vanishing for a linear perturbation, leads to a long-timem = m = ory e ects near the points of discontinuity of $\ell' = \ell t$.

5. Periodic case. Now we turn to the case of periodic perturbations switched on at t = 0. To sim plify calculations we will consider rst the sim plest example of a m onochrom atic perturbation, '(t) = (t) sin !t. Then the dynamic di uson (12) acquires the form :

It is convenient to calculate the two contributions to Eq. (21), $W^{(ab)}$ (t) and $W^{(c)}$ (t), separately. Making use of Eq. (26) we get:

D is the product of three di usons in Eq. (21) evaluated at = 0, and we introduced $\#_x = y = z$, $\#_y = x = z$, and $\#_z = x + y$.

The long-time behavior of Eq. (27) is determined by the vicinities of the no-dephasing points [10] where each of the three di usons entering D is equal to 1. An analogous situation arises in the calculation of the one-loop quantum correction for the periodically driven orthogonalm atrices [4], which is dom inated by the no-dephasing points of a single dynam ic cooperon. In the present case, the no-dephasing points are given by (x;y;z) = (x;2 m = ! x;2 n = ! x) with arbitrary x and integer m and n.

In the limit $(!^{1}, 1)$ the no-dephasing points with di erent m and n do not overlap and the triple integral in Eq. (27) can be evaluated as

where we introduced y = 2 m = ! x + y and z = 2 n = ! x + z. At the no-dephasing point the factor C is nonzero whereas the factor S vanishes and should be expanded in the deviations y and z:

Though the last term of Eq. (30) is proportional to the fourth power of y and z, their smallness is com – pensated by an extra factor x;y;z t. In the limit t (! ¹, ¹) we can integrate near the no-dephasing points in the Gaussian approximation retaining only quadratic in the deviations terms in ln D:

The contribution of the diagram (c), $W^{(c)}$, can be calculated analogously. Due to the same structure of the di usons, its no-dephasing points coincide with the no-dephasing points for $W^{(ab)}$. Instead of Eq. (33) one has now :

Note a peculiar property of Eqs. (37) and (41): W $^{(ab)}(t) / t(d'=dt)^2$ and vanishes at the turning points of the perturbation, whereas W $^{(c)}(t)$ is always positive, even when d'=dt = 0. This means that they describe di erent m echanism s of absorption, with different m em ories on the past.

C om bining Eqs. (37) and (41) we get the total twoloop correction to the quasiclassical absorption rate in the harm onic case:

The time-averaged correction grows linearly with the duration of the perturbation:

Remarkably, Eq. (43) holds not only for a harm onic perturbation but for an arbitrary periodic perturbation with the period 2 =!. Form ally this follows from the fact that the level sensitivity to the external perturbation drops from Eq. (43). Then, according to Eq. (35), the factor !² in Eq. (43) m easures the inverse time separation between the no-dephasing points which is the same for all periodic perturbations of a given period.

6. Dynam ic vs. Anderson localization. It is useful to compare the two-loop result (43) for a harmonic perturbation with the analogous one-loop expression for the GOE obtained in Ref. [4]:

where $\overline{W}_0 = \frac{2}{2} = 2$ is the period-averaged absorption rate, and t = $\frac{3}{2} = 2^2$ is the localization time.

In Ref. [4] we pointed out that the weak dynam ic localization correction to the energy absorption rate of a periodically driven GOE has the sam e square-root behavior as the weak Anderson localization correction to the conductivity of a quasi-one-dimensional (ID) disordered wire. Now we see that the same is true for the case of the GUE as well: in both cases the correction is linear in time and dephasing time, respectively. Therefore it is tempting to suggest that this analogy is not a coincidence but has its roots in equivalence between the dynam ic localization for the RMT driven by a harm onic perturbation and 1D Anderson localization.

Such an equivalence is known for the case of kicked quantum rotor (KQR): in the long time limit, the KQR problem can be mapped [11] onto the 1D -m odel. On the other hand, the problem sof the -kicked KQR and of the periodically driven RMT are, to some extent, com plem entary. Both of them can be mapped on a tight-binding 1D m odel, but with very di erent structure of couplings between the sites and auxiliary orbitals [4]. In particular, the \kicked RM T " m odel with ' (t) being a periodic -function does not exhibit dynam ic localization w hatsoever [4].

In order to check the assumption about the equivalence of the driven RMT to the quasi-1D disordered wire we use the simple relationship between the timedependent energy absorption rate W (t) in the dynamic problem and the frequency-dependent di usion \cos cient D (!) in the Anderson m odel [12]:

where W $_0$ and D $_0$ are the classical period-averaged absorption rate and di usion coe cient. D (!) is known from the theory of weak Anderson localization:

Here $t_{loc} = (2_{1})^2 D_0$, and $_1$ is the 1D density of states. Then Eqs. (46), (45) give two expressions sim ilar to Eq. (44) with only one thing parameter $t = t_{loc}$. One can easily see that with the choice $t = t_{loc} = -4$ both numerical coe cients m atch exactly.

We believe that there are deep reasons for this coincidence and make a conjecture that the (period-averaged) dynam ics of the harm onically-driven RM T at time scales t (! ¹, ¹) is equivalent to the density propagation in a quasi-1D disordered wire. Employing this equivalence, we can easily calculate the energy absorption rate in the regime of well developed dynamic localization at t using the M ott-B erezinsky asymptotics of the AC conductivity, (!) / !² ln² (1=!) [13,14]. Substituting D (!) / (!) into Eq. (45) we nd that in the localized regime W (t) decays as

This dependence is not directly related to the spatial dependence of the localized wave functions which is exponential in the Anderson model. It can be seen if one considers the density-density correlator [disorder-averaged product of the retarded and advanced G reen's functions $G^{R}(x;x^{0}; + !)G^{A}(x^{0};x;)]$ whose Fourier transform can be conveniently represented as 2 $_{1}A(k;!)=(i!)$. A coording to G orkov's criterion of localization [15], A(k;0) is nite and its Fourier transform determ ines the spatial decay of localized wavefunctions. On the other hand, D (!) can be extracted from the density-density correlator as

and, according to our conjecture, should be substituted in Eq. (45) to give the absorption rate. Thus, instead of A (k;! = 0), usually studied in the Anderson localization problem, W (t) is determined by the ! dependence of $({}^{2}A(k;!)=({}^{2}k^{2})$ at k = 0, which to the best of our know ledge evaded investigation in the fram ework of the quasi-1D nonlinear sign a model.

7. C on clusion. We derived the general expression for the lowest order (two-loop) interference correction to the energy absorption rate of a param etrically-driven GUE. If an external perturbation grows s linearly with time the rst correction vanishes. For a periodic perturbation the averaged correction W (t) / t. We make a conjecture that the dynam ics of the harm onically-driven RMT at the time scales t 1=1;1= is equivalent to the 1D Anderson model. Based on this equivalence we predict that in the regime of strong dynam ic localization W (t) / ln(t)=t².
