Field-induced gap in ordered H eisenberg antiferrom agnets

H eisenberg antiferrom agnets in a strong uniform m agnetic eld H are expected to exhibit a gapless phase with a global O (2) sym m etry. In m any real m agnets, a sm all energy gap is induced by additional interactions that can be viewed as a staggered transverse m agnetic eld h = cH, where c is a sm all proportionality constant. W e study the e ects of such a perturbation, particularly for m agnets with long-range order, by using several com plim entary approaches: num erical diagonalizations of a m odel with long-range interactions, classical equations of m otion, and scaling argum ents. In an ordered state at zero tem perturb, the energy gap at rst grows as $(cH)^{1-2}$ and then m ay dip to a sm aller value, of order $(cH)^{2=3}$, at the quantum critical point separating the \gapless" phase from the gapped state with saturated m agnetization. In one spatial dimension, the latter exponent changes to 4/5.

I. IN TRODUCTION

The investigation of quantum antiferrom agnets in strong magnetic elds is currently a very active eld of research. Several rem arkable properties have been observed, such as the closing of the energy gap in spin-1 chains¹ and spin ladders² and observations of magnetization plateaux in frustrated magnets.^{3,4} W hile the broad features of these models can be explained in the fram ework of the H eisenberg model in a uniform magnetic eld, a closer exam ination of experimental data reveals deviations from theoretically predicted behavior. In particular, the supposedly gapless phases actually possess small energy gaps, which can only be explained by the presence of an isotropic interactions.

For instance, D ender et al.⁵ discovered that an applied m agnetic eld H induces in spin-1/2 H eisenberg chains a gap / H $^{0:65(3)}$. O shikawa and A eck ⁶ ascribed the gap to a staggered transverse eld arising from the staggering of the g-tensor or of the D zyaloshinskii-M oriya (D M) interaction. They suggested the elective H am iltonian

where h / H. The transverse eld h creates a spin gap / h $^{2=3}$ / H $^{2=3}$, in agreem ent with the experiment and density-m atrix renorm alization group (DMRG) calculations. 7,8

An extension of these results to higher dimension is stillat a prelim inary stage. Sato and O shikaw a⁹ studied a model of interacting chains with a staggered eld induced by the DM interactions and found that the gap scales as $/ H^{1=2}$ in a weak eld. The recent discovery³ of the Shastry {Sutherland antiferrom agnet SrC u₂ (BO₃)₂ calls for further studies in two dimensions. In particular, the presence of a staggered magnetization in the low – eld NM R signal was ascribed to a staggering of the g-

tensor and of the DM interaction.¹⁰ The direct numerical investigation of the relevant m icroscopicm odels does not seem to be possible at the moment. Indeed, to get a reliable estim ate of the small gap induced by anisotropic interactions requires to reach sizes such that the nite-size gaps, typically of order J=N for N sites, are much smaller than the physical gap. This is possible in 1D with the help of the DMRG algorithm, which by now routinely allow s one to study system s with 200 sites or more, but not in 2D.

In this paper, we present the rst system atic study of this problem in the context of the Lieb-M attis model,¹¹ wherein every spin of one sublattice is coupled equally to all spins of the other. This model is expected to provide a fair description of the long-wavelength properties of bipartite H eisenberg antiferrom agnets with long-range N eel order in the ground state. Therefore it should be relevant for m agnets in 2 and 3 dim ensions.

We pay particular attention to the high-eld regime where the uniform magnetization saturates. In the absence of a staggered eld, the saturation occurs at a critical point $H = H_c$ separating a gapless ordered phase with a spontaneously broken rotational 0 (2) symmetry from a gapped phase with fully polarized spins. The behavior of the transverse-eld spin gap near the critical eld H_c is an important problem in view of its relevance to a number of experim ental system s. Unlike the weak-eld regime, for which analytical results have been obtained, the saturation region has so far been studied only num erically.^{7,8} Curiously, the num erical data reveal a nonmonotonic dependence (H), with a pronounced minimum near the saturation eld H_c. A similar e ect was noticed earlier by Sakai and Shiba in their num erical analysis of spin-1 chains.¹²

II. THE LIEB (MATTIS MODEL

In this section, we concentrate on the Lieb-M attis m odel describing a H eisenberg antiferrom agnet on a bipartite lattice in which every spin of one sublattice is coupled through antiferrom agnetic exchange to all sites of the other sublattice. Its H am iltonian describes spins of length S in a uniform m agnetic eld H = (0;0;H) and a staggered eld h = (h;0;0) perpendicular to it:

where S_A and S_B are the total spins of sublattices A and B. The exchange constant J is norm alized by the total number of sites N to make the energy of the model an extensive quantity O (N). To relect the induced origin of the staggered eld h, we will set $h=\,cH$, where the constant c $\,$ 1 is a property of the system .

In zero transverse eld, the H am iltonian (2) has an O (2) rotational sym m etry and is readily diagonalized. The energy levels are expressed in term s of the total spins of the sublattices $S_{\rm A}$ and $S_{\rm B}$, the total spin $S_{\rm tot}$ and its projection $S_{\rm tot}^{\rm z}$ on the direction of the uniform eld H :




FIG.1: A classical ground state. The sublattice spins reside in the plane form ed by the vectors H and h.

In the ground state the sublattices are fully polarized, $S_A = S_B = N S=2$, and the total angular m om entum points along H : $S_{tot}^{z} = S_{tot}$. Excitations reducing sublattice m agnetizations have an energy gap 0 (JS). Below saturation, H $H_c = JS$, low-energy excited states are obtained by changing the quantum numbers $S_{tot}^{z} = S_{tot}$ from their ground-state values. These excitations have energy O (JS=N) and form a continuum in the limit N ! 1 . The gapless excitations are caused by spontaneous breaking of the O (2) symmetry. Indeed, for N ! 1 the sublattice spins S_A and S_B become classicalvectors with well-de ned directions in space (Fig. 1). In the absence of the transverse staggered eld h, the sublattice m om ents can be freely rotated about H . The low-energy excitations thus correspond to a slow precession of S_A and S_B when the angle deviates slightly from the equilibrium value $= \arcsin(H = JS)$.

Adding the transverse eld h breaks the O (2) sym metry explicitly and violates conservation of both S_{tot} and S_{tot}^{z} . Nonetheless, lengths of the sublattice spins $S_{\rm A}$ and $S_{\rm B}$ are still good quantum numbers. This fact greatly simpli es the num erical diagonalization of the H am iltonian (2).

A. Exact diagonalizations

Because the ground state and all low -lying excitations of the model with h = 0 are in the sector $S_A = S_B = N S=2$, we will restrict our analysis of the gap to that sector. The size of this subspace for N spins equals $(N S + 1)^2$, which is smaller than the size of the total H ilbert space, $(2S + 1)^N$. This enables us to treat system s with rather large numbers of spins. In the following, we present results for 2000 spins S = 1=2, a size clearly beyond the scope of exact diagonalizations of other H eisenberg m odels without additional conserved quantities.




FIG.2: The spin gap as a function of the transverse eld h for two values of the uniform eld: H = 0 (triangles) and $H = H_c = JS$ (squares) for N = 2000. The curves are the results of the spin-wave analysis.

We rst calculate the gap as a function of h in the absence of a uniform ekd. The results are plotted in Fig.2. By thing the data at low eld <u>h</u> ! 0, we determined that the gap vanishes as JSh, precisely as found by 0 shikawa and A eck in the approximation of noninteracting m agnons.⁶ This result is most easily understood by computing the precession frequency of sublattice m agnetizations at the classical level, as we do in the next section. The result of this calculation is plotted as a solid line in Fig. 2. An excellent agreement shows that size e ects are already negligible for N = 2000 (with the exception of a nite gap at h = 0).




FIG.3: The spin gap as a function of H at h = cH for several value of the proportionality constant: c = 0.1 (squares), 0.03 (triangles up), 0.01 (triangles down) and 0.0025 (circles). The gap has a local m inimum for c 0.03. Lines are the results of the spin-wave analysis.

Next we consider the case where the staggered eld is proportional to the uniform eld: h = cH. Typical results obtained for various values of c are plotted in Fig. 3. As H ! 0, H¹⁼² with numerical precision. The behaviour at higher elds depends on the value of the proportionality constant c. If it is small enough, c < 0.03 0.005, the gap exhibits a localminimum close to and slightly below the saturation eld. Such a dip

has been observed previously in num erical studies of 1D m odels,⁸ but no explanation has been given so far. To get further insight, we have kept the uniform eld at its saturation value H_c = JS and calculated the gap as a function of h. The results are plotted in Fig.2. They are consistent with a power-law scaling / h²⁼³. We will return to this phenom enon in the next section.




FIG.4:Uniform (lled squares) and staggered (open squares) magnetizations for N = 2000 as a function of H for c = 0.03. Solid and dashed lines are results of the spin-wave analysis. D ash-dotted lines show the behavior for h = 0.

Finally, we have calculated the uniform and staggered m agnetizations as functions of H for several values of c (see Fig. 4). As expected, the introduction of the sym m etry-breaking staggered eld rem oves the critical behavior near H = H_c = JS.

B. Sem i-classical analysis

The results of the exact diagonalizations can be understood in the fram ework of the classical equations of motion for the sublatticem on ents S_A and S_B . The frequencies of classical spin waves are identical to the energies of m agnons obtained in the lowest-order 1=S expansion, one of the m ethods em ployed by O shikawa et al.^{6,9,13} B ecause the m agnon gap is lowest at zero wavevector, we specialize to uniform solutions, and consider precession of sublattice spins S_A and S_B at maximal length N S=2.

The equilibrium canting angle (Fig.1) is determined by minimization of the classical energy:

In the absence of the transverse eld, = $\arcsin (H = H_c)$ for H $H_c = JS$ and =2 for H > H_c . For h \in 0, the kink in (H) is smoothed out.

The equations of motion for the sublattice moments $S_{\rm A}$ and $S_{\rm B}$ are:

We rewrite these equations in terms of the uniform and staggered magnetizations $m = (S_A + S_B)=N$ and $n = (S_A - S_B)=N$ and linearize them in small deviations m and n from the equilibrium values:

The equilibrium values m and n have length S cos and S sin respectively, and the resulting precession frequencies are

The slow erm ode involves the transverse components of n and the longitudinal component of m. Its frequency determ ines the energy gap: = h! . Figure 3 show san essentially perfect agreem ent between the classical analysis and the num erical diagonalization. This is not surprising: because the Lieb {M attis model has in nite-range interactions, the mean-eld solution (4) becomes exact in the therm odynam ic lim it.

Next we explain the salient features seen in the dependence (H) (Fig. 3), namely the initial increase / H $^{1=2}$ and a dip around the saturation eld H $_{\rm c}$ = JS for a sm all enough c.

1. Weak uniform eld: H JS

W ell below saturation, H $H_c = JS$, the dom inant e ect is the breaking of the axial sym m etry by the transverse eld h. To estimate the resulting energy gap, we neglect the longitudinal eld H and thus obtain the secular equation

It yields the energy gap

Spontaneous breaking of the axial symmetry implies that the staggered magnetization n attains the maximal length n = S for an arbitrarily weak staggered eld h. Therefore

as $h_p! = 0$. Recalling that h = cH we obtain the gap JScH at low elds H, in accordance with Eq. (7).

2. Uniform eld at saturation: H = JS

For smallenough c, the gap (H) has a minimum near the saturation $eld H_c = JS$. Its origin can be traced to a reduced response of the spins to the transverse staggered eld h at saturation.

Inspection of the equations of motion (5) in the absence of the staggered eld shows that the spin precession can be separated into a fast mode with $h!_+ = JS$ and a slow mode with h! = 0. This separation of scales still works in the presence of a weak transverse eld. In contrast to the phase with a spontaneously broken axial symmetry, the staggered magnetization n now vanishes as h = 0. W ith the aid of Eq. (4), we obtain $n = S \cos (2h=JS)^{3=3}S$ for a sm all h. Hence both terms in the expression of h! in Eq. (7) are of the same order since H JS sin $(1=2)(2h=JS^{2})^{=3}$, which yields the energy gap at H = JS:

C om parison of Eqs. (10) and (11) for a staggered eld h = cH shows that the gap scales as $c^{1=2}$ at weak elds H but becomes of order $c^{2=3}$ at saturation. The latter is sm aller (for a substantially sm all proportionality constant c). Therefore the initial increase of with H will be followed by a dip at H JS, provided that c is sm all enough (Fig. 3). The dip disappears when c exceeds the critical value $c_{c} = 0.03126$ (6).

III. BEYOND THE LIEB {M ATTIS M ODEL

The results presented in this paper, most importantly the dependence of the spin gap on the applied eld H, were obtained for the Lieb {M attis m odel. The special form of its Ham iltonian (2) has two important advantages. First, the existence of conserved quantities SA and S_B enabled us to determ ine the low-energy spectrum num erically for very large system s (up to N = 2000spins). Second, the in nite range of spin interactions justi ed the use of a m ean-eld approxim ation, allow ing us to derive the low-energy spectrum and explain the observed features. At the same time, one must use caution in drawing conclusions for realmagnets on the basis of the results obtained in an in nite-range model. In this section, we discuss im plications of our ndings form ore realistic models such as Eq. (1) in d = 1, 2, and 3dim ensions.

The problem of a generic H eisenberg antiferrom agnet with two sublattices in crossed uniform and staggered elds does not have an exact solution. Nonetheless, the considerations advanced in Section IIB can be extended to the general case of an antiferrom agnet with or without long-range N \approx l order. To achieve this goal, we use a eld-theoretic approach, as was done previously by O shikawa and A eck ⁶ in their work on the H eisenberg chain.

A. E ective models

Let us identify the quantum eld theory appropriate for the gapless state (h = 0) and in its vicinity (h = 0)J). The uniform eld H 6 0 breaks the rotational sym metry 0 (3) down to 0 (2) con ning the staggered magnetization $n = n(\cos ; \sin ; 0)$ to the xy plane. In $2 \dim ension s_{\ell}^{14}$ the staggered m agnetization acquires d a nonzero expectation value breaking the O (2) sym m etry. The low-energy degrees of freedom are long-wavelength uctuations of the direction of n in the xy plane, which can be thought of as a Bose condensate¹⁵ $n_x + in_y = ne^i$. The spin waves are uctuations of its phase ; uctuations of the amplitude n are gapped and for this reason can be neglected. Thus one obtains an e ective Lagrangian for the low-energy excitations:

Here $_{\rm s} > 0$ is a spin sti ness, and s is the m agnon velocity. The last term hn cos , describing the coupling to the staggered transverse eld, breaks the residual 0 (2) U (1) sym m etry and induces an energy gap. In d = 1 dim ension, long-wavelength phase uctuations destroy the condensate, hneⁱ i = 0; how ever, the low -energy theory (12) is still applicable.¹⁵

W hen the uniform eld H reaches a critical magnitude H_c, the antiferrom agnet enters a polarized phase where all spins point along the eld direction, as in a ferrom agnet. For H H_c, the equilibrium m agnitude of the staggered magetization n vanishes and the e ective eld theory (12) no longer applies: am plitude uctuations become soft at $H = H_c$. Above the critical eld, the magnon spectrum acquires a gap / H H_c and the energy dispersion switches from linear to quadratic, as in a ferrom agnet: $k = + k^2 = 2m$. In the boson language, $H = H_c$ can be viewed as the point of Bose condensation for m agnons.¹⁵ (There is, in fact, an exact mapping between spins and hard-core bosons¹⁶ in the case of S = 1=2.) The low-energy e ective theory describing universal properties of interacting bosons near the condensation point has been discussed by Fisher et al¹⁷ It has the Lagrangian

where $= n_x + in_y$. When < 0, the bosons condense, = ne^i , and the e ective eld theory reduces to that of phase uctuations (12).

Next we discuss the properties of the e ective models below and at the condensation point, with particular emphasis on the energy gap induced by the staggered transverse eld h.

B. Weak uniform eld: H H_c

W ell below the condensation point, phase uctuations are the dom inant excitations. The elective eld theory is given by the Lagrangian shown in Eq. (12). Analytical continuation to imaginary times t = 1 is yields the classical XY model in the ordered phase in d + 1 dimensions, whose properties are well known.¹⁸ In particular, the symmetry breaking eld h creates a nite correlation length $(h=_s)^{1=2}$. This translates into an energy gap $c(h=_s)^{1=2}$ in the quantum case. The scaling of the gap is the same as in the Lieb (M attis model (10).

In d = 1, the long-range order is absent. The ground state of the quantum m odel in zero transverse eld corresponds to the K osterlitz-T houless phase with power-law correlations heⁱ ^(r)eⁱ ⁽⁰⁾i C=r with a nonuniversalexponent > 0. By the standard scaling argum ent, the gap opens as / h^{1=(2 = 2)}. For the S = 1=2 H eisenberg chain in the limit of zero uniform eld, O shikawa and A eck ⁶ nd that / h²⁼³.

C. Uniform eld at saturation: H = H $_{c}$

N ear the condensation point $H = H_c$ one must use the more complete theory (13) taking into account uctuations of the condensate magnitude j j= n. This critical theory has been analyzed by Fisher et al. in the context of the super uid{insulator transition.¹⁷ A nalytical continuation to imaginary time t = i yields a classical eld theory in d + 1 dimensions; the singular part of the free energy density has a scaling form

where y and y_h are the RG eigenvalues of the \uniform eld" and the staggered eld h; z is the dynamical critical exponent.

At the saturation eld H $_{\rm c}$ (= 0), the spin gap scales as a power of the transverse eld: / h $^{\rm z=y_h}$. The exponents z and y_h are most readily obtained from the transverse spin correlation function, whose long-wavelength part has the scaling form

The transverse spin correlations can be computed exactly in the polarized phase (H H_c), where the ground state is trivial and elementary excitations are m agnons with a quadratic dispersion:

where m is the magnon mass. Hence z = y = 2 and $y_h = 2 + d=2$. The = h = 0 xed point is Gaussian in any dimension.¹⁷ The upper critical dimension is $d_c = 2$.

These considerations yield the following dependence of the spin gap at the critical value of the uniform eld $H = H_c$. In d = 1, / h⁴⁼⁵. In d d = 2, the critical exponents revert to their mean-eld values, so that / h²⁼³, as in the Lieb {M attis model.




FIG. 5: The energy gap as a function of the staggered transverse eld h in a S = 1=2 H eisenberg chain of length N = 100 in saturating uniform eld H = H_c = J. The squares are num erical results obtained by the DMRG m ethod. The straight line is the best-tting power law = ah^b with b = 0.81.

To test the validity of the eld-theoretic argument, we have computed numerically the energy gap as a function of the staggered transverse eld h in a S = 1=2 H eisenberg chain. P revious authors have examined (h) in the absence of the uniform eld H,^{7,8} but not at the saturation point H = H_c = J. We have employed the DMRG method for system sizes up to N = $100.^{19}$ The number of states kept was set at 150 for the warm up phase and 300 for the zip iteration. W ith the exception of the gapless point h = 0, size e ects are rather weak. In a chain with N = 100 sites and J = 1 we nd = $1.60h^{0.81}$ (Fig. 5). The num erical results are in reasonable agreement with the predicted gap exponent of 4/5.

As expected on physical grounds, the energy gap (h) opens more slow by at the critical uniform eld H_c than in zero eld. If the staggered eld is proportional to the uniform one, h = cH, the gap is a quantity O ($c^{l=2}$) when

H is smalland O ($c^{2=3}$) at saturation eld H_c (in d 2). Consequently, for a small enough c, the gap will have a local minimum near H = H_c, as in the Lieb {M attis model.

IV. CONCLUSIONS

The model of a Heisenberg antiferrom agnet in a uniform magnetic eld H perpendicular to a staggered magnetic elds h = cH is relevant to real magnets with a staggered g tensor or staggered D zyaloshinskii{M oriya interaction.⁵ W e have determined the low-energy specW e have determ ined that the energy gap, caused by the breaking of the O (2) spin-rotation sym m etry by the induced staggered eld, scales as (CH)¹⁼² at low uniform elds and is of order (CH)²⁼³ at the saturation eld H = H_c. The gap has a local m inim um near H_c if c is sm all enough (c < 0.03126). Such a dip has been previously observed in num erical studies of spin chains,^{7,8} but has not been explained.

Finally, we have presented scaling arguments establishing the same power laws for the gap, and hence the existence of a saturation dip at small c, to any Heisenberg antiferrom agnet in magnetic eld with long-range order in d 2 dimensions. We note that a local minimum of the spin gap near the saturation eld has been observed in SrC u₂ (BO₃)₂, a Shastry {Sutherland magnet with staggered g-factors and D zyaloshinskii-M oriya interactions.¹⁰
