U sing o -lattice noise reduction it is possible to estimate the asymptotic properties of di usionlimited aggregation clusters grown in three dimensions with greater accuracy than would otherwise be possible. The fractal dimension of these aggregates is found to be 2.50 0.01, in agreement with earlier studies, and the asymptotic value of the relative penetration depth is  $\frac{1}{R_{dep}} = 0.122 - 0.002$ . The multipole powers of the grow th measure also exhibit universal asymptotes. The xed point noise reduction is estimated to be  $\frac{1}{2}$  0.0035 meaning that large clusters can be identied with a low noise regime. The slowest correction to scaling exponents are measured for a number of properties of the clusters, and the exponent for the relative penetration depth and quadrupole moment are found to be signi cantly dimentified which is consistent with a theoretical result derived in two dimensions.

D i usion-limited aggregation (D LA) [] is an extensively studied model of di usion limited growth which appears to capture the essential features of many di erent physical growth phenom ena [2, 3, 4, 5]. However, the fractals generated have evaded a complete understanding for many years and there has recently been controversy over whether di usion-limited aggregates are truly fractal [6].

D LA is modelled [1] by allowing particles to random ly walk from a sphere surrounding the cluster, one at a time, until they contact the cluster, at which point they are irreversibly stuck. D etailed study [7] has shown that D LA grow th in two dimensions does approach true fractal scaling, but with slow ly decaying corrections to scaling of the form

$$Q_N = Q_1 + CN \tag{1}$$

where  $Q_N$  is some property of the cluster, tending towards the value  $Q_1$  as the number of particles in the cluster, N, tends to in nity. Here the correction to scaling exponent is expected to exhibit some universality whilst the constant C will not. For aggregates grown in two dimensions, it has been argued [7] that there should be no quantity whose correction to scaling is slower than that of the relative penetration depth,  $\frac{1}{R_{dep}}$ , where  $R_{dep}$ is the average radius at which new particles are deposited and is the standard deviation of the same. Here and below we take as origin the centroid of the depositing particles.

W hen studying DLA grown on a lattice, reducing the shot noise associated with the growth being by discrete particles [8] has proved valuable in understanding the

asymptotic properties of clusters, complicated by their sensitivity to lattice anisotropy [9, 10]. Using a conform alm ap from the unit circle to the boundary of a growing cluster, Hastings & Levitov [11] introduced a technique for implementing a noise reduction scheme for DLA clusters grown o -lattice. Rather than adding particles to the cluster, bum ps were added to the conform al m ap. Ballet al. [12] built on this work, allowing crescentshaped bumps to be added to DLA clusters without the need for a conform alm ap. In this approach, the particles are allowed to di use norm ally until they contact the cluster. At this point the new particle is touching the cluster, and the distance between the centre of the new particle and the centre of the particle it contacted in the cluster is equal to the diam eter of one particle. To im plem ent noise reduction, this distance is reduced by a factor A < 1, so that the new particle is deposited partially inside the cluster: the e ect is to protrude a shallow bum p of height A on the cluster perimeter. Since this method does not rely on a conform alm ap it allows the growth of noise reduced DLA clusters o -lattice in any dimension.

Most of the work on DLA has been restricted to two dimensions. Meakin pioneered work on DLA in higher dimensions, growing clusters in dimensions up to d = 8[13]. Much of that work has focused on estimating the fractal dimension of DLA clusters and the scaling of the relative penetration depth [14, 15, 16], yet m conclusions have proved di cult. There has also been som e progress m easuring the multifractal spectrum of DLA in three dim ensions [17, 18, 19]. How ever, D avidovitch et al. [20] recently claim ed that all previous attem pts to m easure f ( ) in two dimensions are poorly converged, so the early three dimensional measurements should be taken with caution. O ther work has also examined DLA on a cubic lattice in the lim it of zero noise [21], and the extension of the xed scale transform ation to 3 dim ensions [22].

In this paper we exploit the new noise reduction techniques to explore the convergence to scaling of DLA in

value Q<sub>1</sub>. The di erential is approximated by  $\frac{dQ}{d\ln (N)}, \frac{Q_{N_2} - Q_{N_1}}{\ln \frac{N_2}{N_1}}$  and the error in the di erential by

$$\frac{\mathrm{d}Q}{\mathrm{d}\ln(N)} \quad \prime \quad \frac{p - \frac{2}{2} \left(Q_{N_2}\right) + \frac{2}{2} \left(Q_{N_1}\right)}{\ln \frac{N_2}{N_1}} : \qquad (5)$$

where  $(Q_{\rm N}$  ) is the standard error in  $Q_{\rm N}$  .

To characterise the DLA clusters we measured the multipole powers, since the corresponding multipole moments provide an orthogonal set which may be used to totally describe the growing properties of the clusters. In three dimensions the multipole moments are estimated by (see [25], chapter 4)

using n probe particles which contact the cluster at  $(r_i; i; i)$  for i = 1 to n. We normalised the multipole power as

$$P_{1} = \frac{P_{1}}{(21+1)R_{0}^{21}} \frac{2}{(21+1)R_{0}^{21}}$$

where the e ective radius is in turn given by

$$\frac{1}{R_{e}} = \frac{1}{n} \frac{X}{I_{i}} + \frac{1}{r_{i}}$$

The de nition of  $R_e$  is such that it gives the radius of spherical target of equivalent absorption strength to the cluster. Note that for each m easurement we used the centre of charge as origin, meaning zero dipole moments and hence  $P_1 = 0$ ; otherwise there is confusion between cluster shape and drift of the cluster centre (albeit the latter is rather negligible).

The rst and important feature of our di erential plots is the indication of limiting asymptotic values  $Q_1$  (corresponding to  $\frac{dQ}{d\ln(N)} = 0$ ) which are universal, independent of the level of noise reduction. This is shown for the relative penetration depth in g3, multipole pow – ers,  $P_2 - P_5$  being shown in g4, and the relative variability of extrem al cluster radius in g.5. The universality of the asymptotic values of all these plots is strong indication that the limiting distribution of cluster shape is universal.

The slopes of these same plots indicate the correction to scaling exponents, which also appear to be universal with respect to the noise reduction. Figure 6 shows the m easured values of the correction to scaling exponents for each of the quantities plotted (and allmultipole moments m easured). The exponent for the quadrupole power  $P_2$ is signi cantly di erent from the exponents for  $R_{den}$  and

three dim ensions. W e grew 1000 D LA clusters o -lattice in three dimensions spanning ve dierent values of the noise reduction A = 1, 0:3, 0:1, 0:03, 0:01, and an example cluster with N =  $10^4$  particles and A = 0:1 is shown in gure 1. At regular intervals, the growth of the clusters was suspended and  $10^5$  probe particles were \ red at" the cluster: these probe particles were allow ed to di use freely, one at a time, until they contacted the cluster, at which point their location was recorded and the particle was deleted. In this way the growing properties of the clusters (such as the penetration depth and multipole moments) were estimated. The code used is a direct descendent of that of M eakin [14], which in turn builds on the computational tricks of Ball & Brady [23] to speed up computation. W hilst the code is truly lattice free, the sm allest step size that a particle was allowed to take was set equal to one particle radius. C om parisons in 2 dim ensions between this and an algorithm which uses a much smallerm in imum step size have shown that any effect that this has on the results is the sam e order as the noise in the measurements attributable to inter-cluster variability [24].

## I. FRACTAL D IM ENSION AND CORRECTION TO SCALING EXPONENTS

We calculate the e ective value of fractal dimension from the local slope of the average radius of deposition vs number of particles N according to

$$D = \frac{\ln (N_2) - \ln (N_1)}{\ln (R_{dep} (N_2)) - \ln (R_{dep} (N_1))}$$

where the properties are measured at two dimensions sizes N<sub>1</sub> and N<sub>2</sub>. For the clusters grown, the value of the fractal dimension is shown in gure2. The dimensions estimated for each value of A appear to be converging to a common value of D = 2:50 0:01 which is consistent with previous computational estimates [13]. The data for A = 0:03 and A = 0:01 are less well converged, and the results could be made more accurate with data for larger N.

We now consider the correction to scaling exponents for DLA in three dimensions. In two dimensions it has been shown that no property of the cluster has a slower correction to scaling than the relative penetration depth and suggested that all properties should show in uence of this slowest correction [7]. To measure the slowest correction to scaling exponent of a quantity, we used dimensions [12]. For some converging quantity  $Q_N$ , which displays a single correction to scaling (eq. 1), then

$$\frac{dQ_N}{d\ln(N)} = (Q_N Q_1): \qquad (3)$$

so a plot of  $\frac{dQ}{d \ln (N)}$  against Q should exhibit a straight line with slope , intercepting the x-axis at the asymptotic

 $P_3$ . There is no quantity which shows a slower correction to scaling than  $\frac{1}{R_{dep}}$ , which suggests that the result found by Som faiet al. [7] in some sense also applies to clusters grown in three dimensions.

The values of the correction to scaling exponents are least precise for the highest multipole moments, as these are most sensitive to the ne structure of the cluster. Intriguingly, the asymptotic value of the relative penetration depth for DLA clusters in three dimensions is equal within measurement error to that of the two dimensional case: see gure3 here and gure 3 in [2]. The correction to scaling exponent for  $\frac{1}{R_{dep}}$  is around  $\frac{2}{3}$  the value of the exponent for clusters grown in two dimensions, indicating that DLA clusters in three dimensions are considerably slower to mature.

## II. FIXED POINT NOISE REDUCTION

It is clear from di erential plots such as gure3 that the noise reduction \controls" the slowest correction to scaling. For low values of A this correction to scaling is strongly reduced, and we may write the behaviour of this correction as follows

$$Q_N = Q_1 + C (A)N$$
 : (9)

O ther corrections to scaling need not depend on A, but it is quite evident that the amplitude of the slowest correction to scaling is strongly a ected by it. If there is some value of A for which C (A) is zero, then this value of the noise reduction would correspond to the xed point of a renorm alisation scheme (see [10]). The plots for P<sub>2</sub> P<sub>4</sub> suggest that the xed point noise reduction is  $A^{f} < 0.01$  and plots of  $\frac{1}{R_{dep}}$ ; P<sub>5</sub> are unclear as to the value of the xed point noise reduction. Hence, one estimates that

$$A^{f}$$

The noise reduction of the xed point can also be estim ated from the asymptotic properties of DLA clusters using the Barker & Ball [10] form ula

$$= D^{2} \frac{R_{ext}}{R_{ext}}^{2}$$

where  $R_{ext}$  is the extrem al cluster radius (the radius of the furthest cluster particle from the seed particle) and  $R_{ext}$  is the cluster to cluster variability of  $R_{ext}$ . From

gure5, the asymptotic value of the relative variability of extrem al cluster radius is  $\frac{R_{ext}}{R_{ext}} = 0.032$  0.004. This leads to

$$= 0.0064 \quad 0.0016;$$

which is close to the estimated value of  $A^{f}$ .

For a noise reduction of A , one would naively assume that it would require of order N = A particles to grow a

cluster with the same radius as a non-noise reduced cluster of N particles. Our data below show that this is a system atic underestim ate, so that each value of A corresponds to a more severe noise reduction than expected. Figure 7 shows the two point correlation function for DLA clusters grown at di erent noise reductions. The graphs have been shifted vertically so that all the curves collapse to a single line. From the shift factors used, we estim ate the e ective noise reductions to be

$$A = 1 \qquad e = 1$$

$$A = 0.3 \qquad e = 0.19$$

$$A = 0.1 \qquad e = 0.05 \qquad (13)$$

$$A = 0.03 \qquad e = 0.012$$

$$A = 0.01 \qquad e = 0.0034:$$

Hence one concludes that the xed point noise reduction in equation 10 should be adjusted to

The values for f and di er by a factor of 2, dem onstrating that the identi cation process is open to some errors. If, as indicated by the results in gure6, a single slowest correction to scaling exponent does not control the scaling of all parameters, then a renorm alisation scheme which is based on a single parameter (the noise reduction) may be inaccurate and agreem ent between fand is not expected to be perfect.

## III. CONCLUSION

The growth o -lattice of noise-reduced di usionlimited aggregates in three dimensions has been considered and shown to exhibit universality with respect to noise reduction. The fractal dimension is found to be  $D = 2:50 \quad 0.01$  which agrees with previous computational [13] and mean eld 26] estimates. The penetration depth scales with the radius, and the asymptotic value of the relative penetration depth is  $\frac{1}{R_{dep}} = 0:122 \quad 0:002$ which overlaps the value found for clusters grown in two dimensions [12]. The convergence of the multipole powers provides a very strong indication that D LA cluster grow th, in three dimensions and o -lattice, converges to a universal distribution of cluster shapes.

The relative penetration depth exhibited the slowest correction to scaling, N<sup>0:22</sup> <sup>0:03</sup>, and some multipole powers and also the relative uctuations in extremal radius exhibited correction to scaling exponents which could be consistent with the same. How ever not all quantities exhibit the in uence of the slowest correction to scaling and in particular the convergence to scaling of the dipole power, P<sub>2</sub>, is signil cantly faster than that of either  $\frac{R_{dep}}{R_{dep}}$  or P<sub>3</sub>.

Reducing the input noise by factors up to 100, by growing clusters in shallow bumps, clearly reduces the am plitude of the leading correction to scaling. This supports in three dimensions the idea of Barker & Ball [10] that the intrinsic uctuation level is the physical origin of that slowest correction to scaling. We estimated the

xed point noise reduction to be f 0.0035 and this is close to the value estimated using the Barker & Ball [10] form ula in terms of relative uctuation in extremal radius.

Taken together our results support the hypothesis that isotropic DLA in three dimensions approaches a sim – ple ensemble of statistically self-sim ilar clusters, with a rather slow approach to scaling which is associated with the level of local geom etric uctuation. From this point of view, a quantitative m odel of the convergence of that

uctuation level appears to be the outstanding challenge in understanding isotropic DLA (in any dimension). Another important challenge for three dimensions, for which work is in progress, is the role which material anisotropy can play [27].




FIG. 2: The measured fractal dimension of DLA clusters, estimated by taking the local slope of  $R_{\rm dep}$ . The dimension appears to be converging to a dimension of D = 2.50 0.01, universal with respect to value of noise reduction A.




FIG.3: D i erential plot of R elative Penetration D epth  $\frac{1}{R_{dep}}$  against its own derivative with respect to ln N. The intercept with zero derivative indicates the asymptotic value of  $\frac{1}{R_{dep}}$  for in nite N is given by  $\frac{1}{R_{dep}} = 0.122$  0.002 and the common limiting slope of the plots indicates a correction to scaling exponent of = 0.22 0.03. G row that di erent levels of noise reduction A 0.03 is consistent with universal values of asymptote and exponent, whilst A = 0.01 appears to start and remain close to the ' xed point' value of  $\frac{1}{R_{dep}}$ .




FIG.4:Di erentialplots for the rst four (non-trivial) multipole moments  $P_2$   $P_5$ . Allof the plots exhibit universal asymptotic values, corresponding to the extrapolation to zero derivative, and universal limiting slope corresponding to their correction to scaling exponent. The correction to scaling exponents were estimated by eye as:  $(P_2) = 0.32$  0.02,  $(P_3) = 0.24$  0.03,  $(P_4) = 0.26$  0.06, and  $(P_5) = 0.29$  0.05, where the errors represent the maximum believable error.




FIG. 5: Dierential plot of the relative uctuation in extrem al radius,  $\frac{R_{ext}}{R_{ext}}$ . The asymptotic value is  $\frac{R_{ext}}{R_{ext}}$  = 0.032 0.004 which leads to an estimate of the xed point noise reduction of = 0.0064 0.0016.




FIG.6: The correction to scaling exponents obtained from di erential plots of di erent multipole powers, and the two other quantities marked. The exponent for the dipole power  $P_2$  is signi cantly di erent from the exponents measured for  $\frac{1}{R_{\rm dep}}$  and  $P_3$ .




FIG.7: The two point correlation function for clusters grown in three dimensions, scaled by e ective noise reduction factors, e. This noise reduction is chosen so that a data collapse is seen for sm all L.
