Third order correction to localization in a tw o-level driven system

A bstract
A general result is presented on the lack of second order corrections and on the form ofthe leading order $F$ loquet quasienergies in the high-frequency approxim ation for a two-level driven system . $T$ hen, by a perturbative approach in the high-fiequency approxim ation that uses duald yson series and renorm alization group techniques M.Frasca, Phys. Rev. B 68, 165315 (2003)], we obtain a third order correction for a sinusoidal driving eld that is the sam e obtained by Barata and W reszinski $\mathbb{P}$ hys. Rev. Lett. 84, 2112 (2000)], con $m$ ing their result that localization deviates from the zeros of the zero-th order B essel function when higher order term $s$ are taken into account. Three di erent expressions for this correction are com pared. An im portant consequence of this result is that gives com plete support to the correctness ofboth $m$ ethods. $F$ inally, the lim itation of high-frequency approxim ations is presented by com parison with num erical results for a sinusoidal driving eld.

In a recent paper by B arata and $W$ reszinski ( $B W)^{\underline{1}}$ a new $m$ ethod to solve perturbatively the driven tw o-level system was presented. These authors showed that a third order correction, for the case of a sinusoidal driving eld, appears to change the leading order $F$ loquet quasienergies, in the lim it of large frequency, in such a way to $m$ odify the naive result that one has localization in the tw o-level system at the zeros of the zero-th order B essel function.

This analytical result is in agreem ent, to a certain extent as we will see, with a work by $C$ re eld about the crossing $m$ anifolds of the localization points in this $m$ ode $\frac{2,3}{\underline{-3}}$. A di erent work by P latero, B randes and A guado ${ }^{\frac{4}{4}}$ show ed that analytical and num erical results agree fairly well taking into account the result by B arata and W reszinski.

The question of higher order corrections is a relevant one in view of the needs of w orkable two-level system $s$ to be $m$ anipulated as qubit in quantum computers. This $m$ eans that general results are im portant to know the proper way to drive a two-level system for such aim s.

In this paper we present a several results on higher order corrections to F loquet quasienergies for a driven two-level system. The approach we use has been already presented in ${ }^{5}$. The $m$ ethod given there uses the dual $D$ yson series and renorm alization group techniques. W e im prove the com putations tillthird order show ing equivalence $w$ ith them ethod ofB arata and W reszinski giving in this way fully support to both $m$ ethods in the high-frequency approxim ation.

A two-level driven system that is generally considered to im plem ent a qubit by a solid state device has the form :

being the separation betw een the two levels, $g$ the coupling constant and $f(t)=f(t+T)$ a periodicaldriving eld with period T and ! $=2=\mathrm{T}$ and ${ }_{1}$, 3 Paulim atrioes. T he highfrequency regim e is identi ed by the condition- 1. Floquet theory can be applied and from this we know that localization appears at the crossing of the quasi-energies ${ }^{6}$. Then, a proper choice of the param eters can perm it to drive a qubit. The other crucial param eter for our aim $s$ is $z=2 g=$ ! that we w ill use in the follow ing.

W e can prove a general result on the $m$ odel (1) using the $m$ ethod of dual D yson series given in Ref. ${ }^{5}$. We introduce the unitary transform ation

By introducing the Fourier series

where ${ }_{1}$ can be treated as a c-num ber, it is not di cult to $w$ rite dow $n$ the $H$ am iltonian (3) in the form

being $\mathrm{H}_{\mathrm{F} 0}={ }_{3} \mathrm{a}_{0}(\mathrm{z})+{ }_{2} \mathrm{~b}_{0}(\mathrm{z})={ }_{3} \mathrm{C}_{0}(\mathrm{z})$ the leading order H am iltonian whose eigenvalues give the leading order $F$ loquet quasi-energies. This expression is obtained by considering that the coe cients of the Fouries series depend on 1 . Then, we are able to derive an estim ation of the $F$ loquet quasi-energies through eq.(5) for any kind of driven two-level m odel.

W e can extend the above result by com puting the second-order correction to the quasienergies by the $m$ ethod of dual $D$ yson series ${ }^{5}$. The com putation $w$ ith $H$ am ittonian (6) is quite straightforw ard giving the follow ing secular contribution to the unitary evolution

where we can recognize that a second order correction cannot appear when $a_{n}=a_{n}$ and $\mathrm{b}_{\mathrm{n}}=\quad \mathrm{b}_{\mathrm{n}}$. This is precisely the case for a sinusoidal driving eld having $\mathrm{G}(\mathrm{z})=\mathrm{J}_{\mathrm{n}}(\mathrm{z})$ being $J_{n}(z)$ the Bessel functions of integer order. This m eans that eq.(29) and eq.(30) in Ref. 5 have not the second order correction and should be corrected by elim inating it. The sam $e$ is true for a square wave driving eldin $f(t)=(t) \quad 2$ ( $t \quad T=2$ ) in the interval $0 \quad t<T$. In this case we have the Fourier coe cients

and the leading order Ham iltonian $\mathrm{H}_{\mathrm{FO}}=\left(3 \cos (\mathrm{z}=2)+{ }_{1} \sin (\mathrm{z}=2)\right)$, being $=$ $\bar{z} \sin (z=2)$ and the leading order $F$ loquet quasi-energies.

A sinusoidal driving eld has $\mathrm{f}(\mathrm{t})=\cos (!\mathrm{t}) . \mathrm{F}$ loquet theor ${ }_{\frac{6}{2}}$ gives localization, as a rst approxim ation, for $\Phi(z)=0$. O ne $m$ ay ask if this result is true at any order or just as a rst order approxim ation. B arata and $W$ reszinski obtained that a third order correction given by

that is not generally zero at the zeros of $J_{0}(z)$. In a successive work B arata and Cortez? proved that the sam e correction could be w ritten as

O urm ethod given in Ref. $\frac{5}{9}$ needs the com putation of the third order term of the unitary evolution by duald yson series

starting from a generic initialtim $e t_{0}$ and being $J_{n}$ B essel functions of integer order. W ithout repeating all the procedure here, our approach gives the third order correction

that yields the com plete term with respect to eq.(31) in $R$ ef. . W e have given explicitly the rst term $w$ ith $\bar{\sigma}(z)$ that recovers the small $z$ lim it. This lim it is recovered by all the expressions B W (z), B C (z) and F (z) as it should be. A s already pointed out by B arata and C ortez? ${ }^{\text {? }}$, it is not possible to prove directly equivalence of this form ulas by analyticalm eans. The relationship does not depend on the properties of the Bessel functions. So, we need to content ourselves of a direct num erical check here.

In d1 we have com pared the three expressions above, norm alized by the factor $\frac{{ }^{3} \mathrm{~J}_{0}(z)}{4!2^{2}}$ and the result is absolutely satisfactory.

So, the BW m ethod and our $m$ ethod give both the sam e result supporting each other $w$ th respect to correctness as should be expected. To use one or the other becom es just a $m$ atter of taste. The fact that two di erent analytical approaches, in the lim it of large frequency, give the sam e result perm its us to conclude that, also by this way, it is de nitely proved that zeros of $J_{0}(z)$ are just approxim ately localization points .

O ne may ask how far this third order corrections can be pushed in the ratio =!. M ore generally, it is rather interesting to understand the lim itations of such com putations. The answ er can be obtained from $\quad g(\mathbb{Z})$ where is seen that for values of the ratio $=!\quad 0: 5$ all the high-frequency approxim ations begin to fail dem anding for higher order term s .

In order to give a proper picture of the problem s encountered in $R$ ef. ${ }^{5}$ w e note as the series we obtained in it for the F loquet quasi-energies till third order w as not correct [eqs. (29) , (30) and (31) in $R$ ef. ${ }^{5}$ ]. $R$ ather we have show $n$ here that no second order correction appears and that the third order correction deviates from the naive leading order result of localization at the zeros of the zeroth order Bessel function. These corrections $m$ ake our approach com pletely equivalent, for the results, to the $m$ ethod conceived by B arata and $W$ reszinski: It should be said that our m ethod $m$ akes the com putation of $F$ loquet eigenstates and quasienergies a com pletely algorithm ic m atter, relying all the calculations on a very sim ple recipe.

In conclusion we have given general results for a driven tw o-levelm odelgiving a m ethod to com pute high-frequency leading order $F$ loquet quasi-energies. B esides, we have proved fully equivalence betw een B arata and $W$ reszinski and our $m$ ethod to com pute a high-frequency

perturbation series. $F$ inally, the lim itation of these $m$ ethods has been pointed out by com paring them $w$ ith a num erical com putation.
