## DMRG and periodic boundary conditions: a quantum information perspective

W e introduce a picture to analyze the density matrix renorm alization group (DMRG) num erical method from a quantum information perspective. This leads us to introduce some modil cations for problem s with periodic boundary conditions in which the results are dramatically improved. The picture also explains some features of the method in terms of entanglement and teleportation.

The discovery and developm ent of the DMRG m ethod [1, 2] to treat quantum m any (body system s has enabled us to analyze and understand the physical properties of certain condensed m atter system s with unprecedent precision [3]. O riginally envisioned for 1D system s with short{range interactions at zero tem peratures, during the last years this m ethod has been successfully extended to other situations [3]. Its m athem atical foundations have been established [4, 5] in terms of the so{called m atrix product states (MPS) [6] and by now there exists a coherent theoretical picture of DMRG.

At the same time, the eld of Q uantum Information Theory (Q II ) has emerged to describe the properties of quantum many {body systems from a di erent point of view. A theory of entanglement has been established, and has allowed us to describe and understand phenom – ena like teleportation [7], and to use them in the elds of communication and computation [8]. Recently it has been shown that Q II may also shed some new light in our understanding of condensed matter systems [9, 10], and, in particular, in the DM RG method [11, 12].

In this work we analyze the standard DMRG method using a physical picture which underlies QIT concepts. The picture has its roots in the AKLT model [13] and allows us to understand why DMRG o ers much poorer results for problems with periodic boundary conditions (PBC) than for those with open boundary conditions (OBC), something which was realized at the origin of DMRG [2]. It also gives a natural way of in proving the method for problems with PBC, in which several orders of magnitude in accuracy can be gained. The importance of this result lies in the fact that physically PBC are strongly preferable over OBC as boundary e ects are elim inated and nite size extrapolations can be perform ed for much smaller system sizes.

Let us start by reviewing the simplest version of the DMRG method for 1-D spin chains with OBC, which is typically represented as B B 2, 15]. We denote by d the dimension of the H ilbert space corresponding to each spin, and by D the number of states kept by the DMRG method. We assume that the spins at the edges have dimension  $d_0$  D [14]. At some particular step the chain is split into two blocks and one spin in between. The left block (L) contains spins 1;:::;M 1, and the

right one (R) spins M + 1;:::;N. Then a set of D D m atrices  $A^s$  are determined such that the state

m inim izes the energy. The states j  $i_{L,R}$  are orthonorm al, and have been obtained in previous steps. They can be constructed using the recurrence relations

where the block  $L^0$  contains the spins 1; ...; M 2. The new matrices  $U^{M}$  <sup>[;s</sup> are determined from  $A^s$  and full

For the blocks consisting of the edge spins alone, the j i are taken as the m embers of an orthonorm al set.

In order to give a pictorial representation of the above procedure we introduce at site M two auxiliary D { level system s,  $a_M$  and  $b_M$ . The corresponding H ibert spaces H  $_{a,b}$  are spanned by two orthonorm al bases j  $i_{a,b}$ , respectively. We take L and  $a_M$  (and also R and  $b_M$ ) in the (unnorm alized) m axim ally entangled state

We can always write j  $i = P_M j i_{L,a_M} j i_{R,b_M}$ , where  $P_M$  maps  $H_a H_b ! H_M$ , with  $H_M$  the space corresponding to the M {th spin and [cf. (1)]

In fact, we can proceed in the same way at any other site  $k \in 1; M; N$  by dening two auxiliary systems  $a_k$  and  $b_k$  and a map  $Q_k$  dened as in b) but with the matrices U instead of the A. For the edge spins 1 and N we dene a single auxiliary system  $b_1$  and  $a_N$ , respectively and dene

accordingly the operators  $Q_{1,N}$  which now map  $H_{b;a}$ ! H<sub>1;N</sub>. Thus, the state is then obtained by applying the operators  $Q_1$ :::;; $P_M$ ;::: $Q_N$  to the set ofm axim ally entangled states between the auxiliary system s  $b_k$  and  $a_{k+1}$  (k = 1;::;;N 1) [see Fig.1(a)].

The DMRG procedure can be now represented as follows. At location M , one nds an operator  $B_M$  acting on the subsystems  $a_M$  and  $b_M$  by determining the matrices  $A^{\,\rm s}$ . From them , one obtains the operator  $Q_M$  and goes to the next step at location M + 1. One proceeds in the same way, moving to the right, until one reaches the location N . At that point, one starts moving to the left until one reaches the location 1 at which point it moves again to the right. The procedure is continued until a xed point for the energy is reached, something which always occurs since the energy is a monotonically decreasing function of the step number. This proves that DMRG with the B is a variational method which always converges.

The more standard scenario (B B) is represented in Fig.1(b). The operator  $P_{\rm M}~$  acts on the auxiliary subsystems  $a_{\rm M}~$  and  $b_{\rm M~+1}$  and maps  ${\rm H}_{\rm a}~$   ${\rm H}_{\rm b}$ !  ${\rm H}_{\rm M}~$   ${\rm H}_{\rm M~+1}$ . In this picture [for both con gurations, Figs.1 (a,b)] it is very clear that the two edge spins are treated on a very di erent footing since they are represented by a single auxiliary system which is not entangled to any other.

In the case of a problem with PBC a slight modi cation of the scheme is used [2]. The idea is to still separate the system into two blocks and two spins as before but now with the con guration B B. This ensures the sparseness of the matrices one has to diagonalize and thus it increases the speed of the algorithm [2]. One can draw the diagram corresponding to this procedure

in a similar way as in Fig. 1. The important point is that still there are always two sites (left most and right most of both blocksB) which are treated di erently since they are represented by a single auxiliary spin which is not entangled to any other. In our opinion, this is the reason of the poor perform ance of the DM RG m ethod for problem s with PBC.

The method we propose is very clear in term s of this picture (Fig. 2). One has to substitute at all sites k the spin by two auxiliary systems  $a_k$  and  $b_k$  of dimension D, with  $b_k$  and  $a_{k+1}$  (with  $a_{N+1} \coloneqq a_1$ ) in a maximally entangled states and nd the maps  $B_k : H_a = H_b ! H_k$  which lead to a state

with the minim alenergy. This minimization can be performed in a similar way to the one used in the standard DMRG method. Before showing how to do this in practice, we derive some form ulas in terms of these operators. We write

Thus, the problem is solved once the states ' (or equivalently, the matrices B) are determined. Note that starting from these states, it is possible to calculate expectation values of products of local observables [4], since

Thus, the main idea to perform the minimization is very simple. Given the Hamiltonian H describing the system, one chooses one site M and writes the energy as

where  $j \stackrel{M}{=} s j_s \stackrel{M}{=} i$  is a vector built by concatenating the  $s \stackrel{M}{=} a$ , and  $N_M$  and  $H_M$  are d  $D^2$  herm itian square matrices which are built using the vectors  $s^{[k]}$ at k  $\in$  M. For example, N<sub>M</sub> =  $sN_0$  is a block diagonal matrix with identical blocks N<sub>0</sub> which has matrix elements (N<sub>0</sub>)<sub>(; 0);(; 0)</sub> = (N<sub>0</sub>)<sub>(; );(0; 0)</sub>, with

Thus, at this step the operator  ${\tt P}_{\tt M}~$  is found by solving the generalized eigenvalue problem

with minimum, which in turns gives the energy at this step. Then one chooses another site and proceeds in the same way until the energy converges. At the end we have all the  $P_k$  and can evaluate all expectation values.

The above method is not very e cient numerically. First, the matrix N $_0$  may be ill conditioned. Second, one stores many matrices ( $N^2$ ) and perform smany matrix multiplications ( $N^2$ ) at each step. Now we explain how one can make the method much more e cient.

Let assume that we have a set of spins in a ring. The idea is to determ ine operators  $P_k$  in a clockwise order ( rst  $P_1$ , then  $P_2$ , until  $P_{N-1}$ ), then in prove them following a counterclockwise ordering (from  $P_N$  to  $P_2$ ), then again clockwise, until the xed point is reached. At each step, a norm alization condition similar to (3) is imposed, depending on whether we are in a clockwise or counterclockwise cycle, which makes the matrix  $N_M$  well behaved. On the other hand, at each step only the operators which are strictly needed in later steps are calculated in an elicient way and stored.

The normalization condition is based on the following fact. Given the state , characterized by matrices B, if we substitute B<sup>M</sup>];<sup>s</sup> ! B<sup>M</sup>];<sup>s</sup>X = U<sup>M</sup>];<sup>s</sup> and B<sup>M+1</sup>];<sup>s</sup> ! X<sup>1</sup>B<sup>M+1</sup>];<sup>s</sup>, where X is a nonsingular matrix, we obtain the same state. Analogously, we can substitute B<sup>M</sup>];<sup>s</sup> ! YB<sup>M</sup>];<sup>s</sup> = V<sup>M</sup>] and B<sup>M 1</sup>];<sup>s</sup> ! B<sup>M 1</sup>];<sup>s</sup>Y<sup>1</sup>. We choose X in the clockwise cycles to im pose (3) and Y in the counterclockwise ones to in pose

Thus, at the point of determ ining the operator  $P_{\rm M}$  ,

where  $Q_k$  and  $Q'_k$  are de ned as in  $\langle \! \rangle$  but with U and V instead of B, respectively. Thus, the operators X and Y are all of them m oved over, such that they are now included in those corresponding to  $P_M$ . It can be easily shown that these conditions on the operator U (V) are equivalent to imposing that  $E_1$  has the maximally entangled state j i as right (left) eigenvector with eigenvalue 1. This is immediately released in the fact that the matrix N<sub>M</sub> is better behaved, which makes the problem num erically stable.

Let us now illustrate how the procedure works with simplest nearest neighbor H am iltonian  ${k \brack z}^{[k]} {z \atop z}^{[k+1]}$ , namely the Ising M odel. Let us assume that we are running the optimization of the operators clockwise and that we want to determ ine  $P_M$ . So far, in previous steps, apart from the matrices U and V, we have stored: (a) For each k < M, the following four operators:

(b) For each k > M other four similar operators which contain products from E [k] to E [N]. W ith them, one can build H  $_{\rm M}~$  and N  $_{\rm 0}$  by few m atrix multiplications and thus determine  $P_M$  by solving (12). From it,  $Q_M$  is determ ined. Then, we construct  $r_{M + 1}$ ;  $s_{M + 1}$ ;  $t_{M + 1}$  and  $h_{M + 1}$ starting from  $r_M$ ;  $s_M$ ;  $t_M$  and  $h_M$  [16]. We continue in the same vein, nding four matrices at each step, and storing them, until we reach N. Then we start moving counterclockw ise and start constructing the corresponding four matrices at each step. Notice that in order to construct the matrices  $H_M$  and  $N_0$  we will have to use the stored m atrices (15) which were determ ined when we were moving clockwise. Thus, with this procedure we have to store of the order of 4N matrices of dimension  $D^2$  (apart from the matrices U, V and the last B's) but the number of operations per step is independent of N . At the end, when we have reached the xed point, we can determ ine the expectation value of any operator by using (8) and determining the required matrices using (9). Note that if the problem has translational symmetry, then all these evaluations are even simpler.




FIG.3: (Left) C om parison between DMRG (squares) [2] and the new method (circles) for PBC, and N = 28. For reference the DMRG results [2] for the Heisenberg chain with OBC (triangles) are also shown. (Insert) Variation of the local bond strength from the average along the chain, calculated with the new method and D = 40.

We have applied the above method to the spin 1=2 Heisenberg chain. We have plotted in Fig. 3 the energies obtained as a function of D and compared them with those obtained by the standard DMRG method with OBC and PBC. From the gure it is clear that the accuracies we obtain are comparable with those obtained with DMRG for problems with OBC but much better than for PBC. We have determ ined the errors by com - paring with the exact results [17]. In the insert of Fig. 3 we have plotted the local bond strength hS  $[k]S [k+1]_i$  as a function of k. As expected, the result is independent of the position k, as opposed to what occurs with OBC.

Finally we show that the picture introduced here m ay be valuable to understand the properties of states in terms of the language and tools developed in the eld of Q IT . First, one can easily see that the entropy of the block formed by systems ( $k_0$ ;  $k_0 + 1$ ; :::;  $k_1$ ) is bounded by 2 log<sub>2</sub> (D), as this block is connected to the rest only via  $a_{k_0}$  and  $b_{k_1+1}$ , and thus the rank of the reduced density operator for the block is bounded by the product




FIG.4: General states can be expressed in the form (6).

of the dimensions of the corresponding Hilbert spaces. Secondly, it allows us to show that any state can be written in the form (6) (MPS [4, 6]) if we choose  $D = d^{N}$ (actually,  $D = d^{b\frac{N}{2}c}$  is su cient). We consider  $a_k$  and  $b_k$  as composed of d{level subsystems,  $a_k^1$ ;...; $a_k^N$  and  $b_k^1$ ;:::; $b_k^N$ , respectively, and write j i as a tensor product of maximally entangled states d between  $b_k^1$  and  $a_{k+1}^1$ . For k = 2;:::;N, we choose the operators  $P_k = 1_{a_k^k}$  h k j where  $j_k i$  is a state for all particles but  $a_k^k$ , and contains  $j_d$  i for each pair  $a_k^1 - b_k^1$  (1> k) and  $\mathcal{D}$  i for the rest. The action of  $P_k$  is to teleport the entangled pairs such that at the end one has one entangled pairs between the st system and all the rest (Fig. 4), while leaving all the other auxiliary particles in  $\mathcal{D}i$ . Finally, the operator  $P_1$  is the product of two operators. The stacts on particles a and transform s  $Di^{N}$  ! j i. This operator ist preIn summary, we have given a pictorial view of the DMRG method and have identi ed the reason of its poor perform ance for problem swith PBC. Our picture immediately leads to a modi ed version of the DMRG method which dram atically improves the results. This is done at the expenses of no longer using sparse matrices, something which limits its applications. Nevertheless, we believe that the method may allow us to treat problems in condensed matter systems which so far have been di - cult to tackle with the standard DMRG method. In any case, the present work illustrates how the developments made in Q IT during the last years may prove useful in other branches of Physics.
