Critical adsorption and Casim ir torque in wedges and at ridges

Geometrical structures of con ning surfaces profoundly in wence the adsorption of wids upon approaching a critical point T_c in their bulk phase diagram, i.e., for $t=(T_c)=T_c$! 0. Guided by general scaling considerations, we calculate, within mean-eld theory, the temperature dependence of the order parameter prole in a wedge with opening angle < and close to a ridge (>) for T? T_c and in the presence of surface elds. For a suitably dened reduced excess adsorption (;t! 0) () tj 2 we compute the universal amplitudes (), which diverge as exponentially for ! 2 . There is evidence that, within mean-eld theory, the ratio $_+$ ()= () is independent of . We also discuss the critical C asim ir torque acting on the sides of the wedge as a function of the opening angle and temperature.

I. INTRODUCTION

Boundaries induce deviations of the local structural properties of condensed matter from their corresponding bulk values. Typically the width of such boundary layers is proportional to the bulk correlation length Near a continuous bulk phase transition at a temperature $T = T_{c}$, the correlation length diverges according to a power law (t = (T)) $T_{c} = T_{c} !$ $0) = {}_{0} \pm j$ with a universal bulk exponent and nonuniversal amplitudes $_0$ whose ratio $_0^+ = _0$ is universal, too. For the three-dimensional Ising universality class and $_{0}^{+} = _{0}$ ' 2 [1], whereas within mean-eld theory, which is valid for spatial dimensions d $4_{r} = 1=2 \text{ and}$ $_{0}^{+} = _{0}^{-} = _{0}^{p} = _{0}^{p}$. The local critical properties near planar con ning surfaces have been studied theoretically and experim entally in detail. It has turned out, that each bulk universality class splits up into three possible surface universality classes denoted as ordinary, special, and normal transitions. Each of them gives rise to distinct surface critical phenomena. The type of boundary conditions determines which surface universality class a given system belongs to. The ordinary transition requires the absence of surface elds, the special transition is characterized by the absence of a surface eld, too, but also by suitably tuned, enhanced surface couplings between the ordering degrees of freedom, and the normal transition represents systems

whose surfaces are exposed to surface elds. A sindicated by the name, the latter one is the generic case. For example the normal transition applies to one-component uids near their liquid-vapor critical point, or to binary liquid m ixtures near their dem ixing critical point. In both cases the substrate potential of the con ning container walls and the m issing interactions due to the fact that the uid particles cannot penetrate the substrate give rise to the e ective surface elds acting on the corresponding order param eter (density or concentration di erence). As a consequence, in this case even above $T_{\rm c}$ there is a nonvanishing order parameter pro le, which decays to zero T_c upon approaching the bulk, i.e., for increasing normaldistance z! 1 from the surface at z = 0. For T < Tc this pro le attains the nonzero value of the bulk order param eter for z! 1 . Following early calculations on magnetic systems by K.Binder and P.C.Hohenberg [2], this so-called critical adsorption was stexam ined in detailby Fisher and de Gennes Bland has since been analyzed for many systems both theoretically [4, 5, 6] and experim entally [7], and a fair agreem ent between theory and experim ent has been found [8, 9].

Surface order above the bulk critical tem perature can also be due to spontaneous sym metry breaking caused by enhanced surface couplings between the ordering degrees of freedom, e.g. spins in magnetic systems. The transition to this state from the disordered state is usually denoted as the extraordinary transition. Bray and Moore [10] predicted an equivalence between the normal and the extraordinary transitions that was later proved by Burkhardt and Diehl [11]. In contrast to the ordinary transition in magnetic systems, the corresponding extraordinary transition has been investigated to a lesser extent. Extending and improving earlier work [12, 13, 14, 15], Diehl and Smock [16] have carried out a eld-theoretic renormalization-group calculation in dim ensions for the extraordinary transition in sem iin nite systems belonging to the Ising universality class

[17] computing the order parameter prole to one-loop order. The results are in fair agreement with those obtained by M onte Carlo simulations [9].

These studies are devoted to the case of planar surfaces. Only very carefully treated solid surfaces are atom ically at; generically, however, they exhibit corrugations. Besides these random deviations from the at topography, there is now adays an abundance of experim entaltechniques [18] that allow one to endow solid surfaces with precise lateral geom etrical structures, ranging from the m scale down to tens of nm. Interalia, such solid surfaces are used within the context of micro uidic devices [19] in order to guide uids along such structures. The uids perfectly 11 this laterally structured environm ent and thus fully exhibit the strong structural changes associated with that. In this context it is of interest what kind of structures appear in the uid if it is brought, say, close to a dem ixing transition and is exposed to geom etrically structured substrates. If the characteristic sizes of the lateral structures are comparable with the correlation length, which in uids reaches typically up to a few thousand A close to Tc, one can expect a strong in uence on the aforem entioned critical adsorption phenom ena.

Theoretically this raises the issue of how the local critical properties depend on the shape of the boundaries. A typical m anm ade structure is a series of grooves with various shapes of the cross section, e.g. wedgelike. The rst step in their investigation is the study of a single wedge, which already shows new features and gives new insight into the in uence of geometry on critical behavior. The ordinary transition of the isotropic N-vector model at an edge has been investigated by Cardy [20] within the fram ework of mean-eld theory, the renormalization group, and -expansion. Subsequently the two-dim ensional wedge (comer geom etry) was studied by exact calculations, mainly for Ising models [21], and by conform alm apping at the bulk critical tem perature [22]. New edge and corner exponents were found that depend on the opening angle of the wedge. More recently sim ilar ndings of M onte C arlo simulations of the ordinary transition of the three-dim ensional Ising model [23] have been reported, in accordance with high temperature series expansions [24]. The angle dependence of the critical wedge exponents can be attributed to the fact that the wedge geometry lacks a length scale and thus is invariant under rescaling. The opening angle is therefore a marginal variable in a renormalization transformation, and may enter into the expressions for the exponents. The same will happen for all other scale-invariant shapes of the boundaries [25]. However, for a given opening angle, the values of the critical exponents are expected to be universal and independent of microscopic details. According to recent M onte Carlo simulations of threedimensional Ising models with edges and corners [26], angle dependent critical exponents are observed at the ordinary transition, whereas the surface transition seems to be nonuniversal. The critical exponents in this latter case appear to depend on the strengths of the local couplings, in analogy with exact results obtained for the twodimensional Ising model with defect lines [27]. Critical adsorption has also been studied in general dimensions d on curved surfaces [28].

Since critical adsorption changes the composition of a binary liquid mixture close to its surface, mechanical properties, such as the local viscosity and the mutual di usion coe cient will also vary in space. So we expect various phenomena, such as ow properties in porous media, the spreading properties of droplets, surface chemical reactions, the permeability of membranes etc. [29], to be in uenced signicantly by critical adsorption.

Critical adsorption in a wedge has been studied by Hanke et. al. [30]. Within mean-eld theory the order parameter prole was calculated exactly at the critical point. Through an interpolation scheme between exact results in d=2 and the mean-eld results corresponding to d=4, angle dependent critical exponents of the order parameter and those governing the decay of two-point correlation functions were obtained for d=3 as well. The present study extends these investigations into various directions.

First, we analyze the tem perature dependence o criticality for critical adsorption in a wedge. General scaling properties for the order parameter prole and the excess adsorption are discussed and the corresponding scaling functions are calculated within mean—eld theory. This analysis is carried out above and below $T_{\rm c}$, including a system atic study of the dependence on the opening angle of the wedge. This covers also the case $\;\;>\;\;$ describing critical adsorption near a ridge.

Second, as a new feature, we study the Casim ir torque acting on the sides of the wedge or ridge. The con nement modi es the uctuation spectrum of the critical uctuations and the order param eter pro les. This leads to a dependence of the free energy of the critical medium on the shape of and the distance between the con ning boundaries, which results in an e ective force acting on them . Thus the physical origin of this force, originally predicted by Fisher and de Gennes [3] for two parallel plates im m ersed into a binary liquid m ixture near its continuous dem ixing transition, is analogous to the C asim ir force acting on conducting plates in vacuum due to the con nem ent of quantum m echanical vacuum uctuations of the electrom agnetic eld [31]. The Casim ir force is governed by universal scaling functions [32] and is superim posed on the noncritical background forces, which in the case of uids are given by dispersion forces. Recent experim ents [33] have con m ed corresponding theoretical predictions for the plate geometry [34]. For curved surfaces the critical Casim ir force plays an important role in the occulation of colloidal particles suspended in a solvent undergoing a continuous phase transition [35]. In the present context the free energy of the criticalm edium depends on the opening angle ; its derivative with respect to am ounts to the critical Casim ir torque acting on the sides of the wedge or ridge. If the substrate form ing the wedge or ridge is composed of soft materials like,

e.g., m em branes, this critical C asim ir torque is expected to give rise to elastic deform ations. It m ight also be experim entally accessible by suitable force m icroscopy w ith m oveable sidewalls of a wedgelike structure.

The paper is organized as follows. In Sec. II we discuss the general scaling properties of the order parameter proles and the excess adsorption. The scaling functions are determined within meaned theory and analyzed in detail in Sec. III. Section IV focuses on the free energy of the conned uid and the critical Casimir torque resulting from its angle dependence. Section V sum marizes our ndings. In the Appendix we discuss how the excess adsorption in a wedge or at a ridge decomposes into surface and line contributions with two possible experimental realizations.

II. GENERAL SCALING PROPERTIES OF ORDER PARAMETER PROFILES AND EXCESS ADSORPTION

Since uids can lla container of arbitrary shape, in the present context of critical systems exposed to substrates shaped as wedges we consider uids close to their bulk critical point $T_{\rm c}$. This can be either a liquid-vapor critical point or a dem ixing critical point in the case of binary liquid m ixtures. The interaction of the container walls with the uid particles results in a spatial variation of the number densities close to the boundaries. The deviation of the density of the uid, or of the concentration of one of its two components in the case of binary liquid m ixtures, from the corresponding bulk value at $T_{\rm c}$ is chosen as the local order param eter describing the phase transition.

The order parameter pro $\mbox{le m}^{1}$ =2 (;t) near a planar interface and close to the critical temperature T_c takes the following scaling form [8, 9, 14, 16, 36]:

for distances & perpendicular to the interface and sufciently large compared to a typical microscopic length . (t! 0) = $_0$ jj is the bulk correlation length above (+) or below () $T_{\rm c}$, and are the standard bulk critical exponents, and t is the reduced temperature. The scaling functions P 1 = 2 (= =) are universal once the nonuniversal bulk amplitudes a and $_0$ are xed, where a is the amplitude of the bulk order parameter m 1 = 2 (= 1 ;t! 0) = a j j = m $_{\rm b}$ (t). With the prefactors $_0$ xed as those of the true correlation length dened by the exponential decay of the bulk two-point correlation function in real space, one $\operatorname{nds} P^{1}$ = 2 (1) = 1, P_{+}^{1} = 2 (1) = 0, P_{-}^{1} = 2 (1) = 0, P_{-}^{1} = 2 (1) = 0, so that

Any other choice for the de nition of the correlation length leads to a rede nition of the scaling functions $P^{1=2}$ such that all observable quantities remain unchanged. This underscores that the scaling functions are universal, but that their form depends on the denition of the correlation length. The amplitudes of the scaling functions are xed by the requirement $P^{1=2}(1)=1$. A coordingly the numbers care universal surface amplitudes which are denition-dependent [8].

C lose to $T_{\rm c}$ the total enrichm ent at the interface of, say, the A particles as compared to the B particles of a binary liquid m ixture is given by the excess adsorption, which is an experimentally accessible integral quantity. For a planar surface, one has

The scaling behavior of 1 =2 (t) has been discussed in Ref. [8] in detail. The integration can be split into the intervals > and 0 , and for large the order parameter pro $\lim_{n \to \infty} ^{1} = 2$ (;t) can be replaced by Eq. (1), which gives

U pon approaching T_c the $\;$ rst integral rem ains $\;$ nite and yields a nonuniversal constant, which is subdom inant to the diverging second term . The second integral leads to the well known power-law singularity of 1 =2 (t ! 0) for d < 4:

where the numbers g are universal with their values depending on the denitions of the bulk order parameter and the correlation length. In d=4 one nds upon inserting the mean-eld expression for $P^{1=2}$ (see Ref. [16]) into Eq. (4) that $I^{1=2}$ (t) diverges logarithm ically. This result can be reconciled with Eq. (5) by noting that $I^{1=2}$ actually needs additive renormalization leading to [8]



In the wedge or ridge geom etry (Fig. 1) the order param eterpro le depends on the radial distance r from the apex, on the polar angle , and on the opening angle , so that the variation of the pro le is two-dim ensional w ith



nonuniversal bulk am plitudes a and $_0$ are xed, where a is the am plitude of the bulk order parameter and the am plitudes $_0$ are prefactors of the true correlation length as in the case of the in nite planar wall. One nds [30] with r=r= that P(r=1;)=1, $P_+(r_+=1;)=0$, $P_+(r_+=1;)=0$, and

where = $r \sin$ (see Fig. 1). The amplitudes of the scaling functions are again xed by the requirement P (r=1;) = 1. The numbers c are the universal surface amplitudes of the scaling function of the in nite planar wall Eq. (2)], and c (;) are universal functions. Both c and c depend on the de nition of the correlation length. The scaling functions also re ect the

We do not the excess adsorption for this geometry conned by surfaces of linear extensions s in the plane perpendicular to the edge and s_k in the translationally invariant directions (see Fig. 1) as

where the integral is taken over a m acroscopic volum e V occupied by the liquid. A coording to the Appendix this excess adsorption decom poses into a surface contribution that scales with the actual surface area of the conning walls (s? $s_k^{(d\ 2)}$) and a line contribution that scales with the extension in the invariant directions ($s_k^{(d\ 2)}$, i.e., a line in d = 3) [37]:

While the surface term is determined solely by the order parameter prole of a semi-in nite binary mixture exposed to a at substrate, the line contribution is the special contribution arising from the change of the order parameter prole caused by the edge. Due to the symmetry of the system one can determine the amplitudes and for the wedge and the ridge explicitly by considering only one half of the wedge or the ridge [see Eq. (9)], and by suitably subtracting and adding the order parameter prolem 1 = 2 (= rsin; t) of a uid in contact with an in nite planar wall in the integrand of Eq. (10) (compare Eqs. (3)-(6) and the Appendix):

proportional to ___ as __ 1 = 2 does (compare Eq. (6)). As one can see from Eqs. (6) and (14), the subdom inant line contribution to the excess adsorption carries a more singular temperature dependence than the leading planar surface term. Thus the scaling properties of the order parameter pro le completely x the functional form of the excess critical adsorption up to the dependence of the universal amplitudes __ () on the opening angle. Since this dependence cannot be inferred from general scaling arguments, it must be determined explicitly. This will be carried out within mean—eld theory in the following section. This is possible because as stated above __ () is nite for d = 4.

III. SCALING FUNCTIONS W ITH IN MEAN-FIELD THEORY

A. Order param eter pro les

The standard G inzburg-Landau Hamiltonian for describing critical phenomena in conned geometries is [4,5]

with a scalar order parameter eld (r), supplemented by the boundary condition =+1 at the surfaces of the wedge (ridge) corresponding to the critical adsorption xed point [11]. The parameter is proportional to the reduced temperature t, u is the coupling constant, and the integration runs over the volume $V_{w\ (r)}$ of the wedge (ridge) (see Fig. 1). Within mean-eld theory $=t=(\frac{1}{0})^2$ for $T>T_c$, and $=\frac{1}{2}$ tip ($_0$) for $T<T_c$ with $_0^+=_0$ = $\frac{p}{2}$.

where m=m (r; ; ;). Since the scaling functions in Eq. (1) have the limiting behavior shown in Eq. (2), where ==1=2 within the mean-eld approximation, in order to derive a boundary condition for the numerical calculation of the order parameter close to the surfaces of the wedge, i.e., ! 0 for r xed, we seek a solution for Eq. (B (r;) 0, D (r;) 0). This result agrees with the direct expansion of the mean-eld pro le obtained for = 0 [30]. In terms of the scaling functions P this implies [see Eq. (8)]:

We use a numerical method [35, 38] to minimize Eq. (16) with respect to the order param eterpro le at a xed tem perature, which is then subsequently varied. For com putational purposes we choose suitably shaped nite volum es $V_{w(r)}$ for dierent opening angles of the wedge (w) or ridge (r). We refrain from describing this choice of volum es here, because it does not matter in the calculation of the universal amplitude functions (). The choice of the volume is relevant only for that line contribution to the excess adsorption that depends only on the order parameter pro le close to an in nite planar wall and thus is independent of the opening angle of the wedge (see the Appendix). As the temperature is changed we rescale the size of the volum e $V_{w\ (r)}$ in accordance with the change of the correlation length = $_0$ t . This way we control the nite size e ects caused by the niteness of $V_{w(r)}$ dictated by computational necessity. The nite size e ects manifest them selves even close to those boundaries of the chosen volume that are far away from the walls of the wedge because of using approximate boundary conditions at these boundaries (see below). By e ectively increasing the rescaled volum e upon approaching T_c , the values of the proles at xed spatial points within this rescaled volum e converge to a lim iting value.

We choose a two-dimensional grid (i, j) and calculate the deviation of the order parameter prole from the known prole at $T=T_{\rm c}$ at the given grid points. The prole near the conning surfaces of the wedge (ridge) is xed according to Eq. (19). (The grid points are lined upparallel to the walls of the wedge.) At the surfaces of the nite volume $V_{\rm w\ (r)}$ that are further away from the walls of the wedge, we prescribe initial values of the pro-

le. K exping these values xed we then calculate new values of the pro le inside the volume using the method of steepest descent. Having obtained the new values for the pro le close to these surfaces, we change the pro le at these surfaces proportionally to the change in their neighborhood, if it changes signicantly in the direction perpendicular to the surfaces (the general case), or set it equal to that in neighboring layers if the pro le is approximately constant close to these surfaces (for example far away from the edges of the wedges parallel to the conning walls of the wedge). The rules for the iteration

is a convergence parameter. With this method it is not necessary to calculate the H am iltonian itself but only its derivative. The method has been described in detail in Refs. [35] and [38], so here we only want to point out that the divergence of the pro le close to the walls of the wedge causes a divergence in the derivative of the Hamiltonian, too. This can be avoided, if one takes into account the known form of the divergence of the pro le close to the edges of the wedge [see Eq. (19)]. To this end we write a_{ij} as a product of two term s_{ij} one of which we choose to be such that when multiplied by the pro le close to the boundaries (in the calculation of the derivative) it cancels the divergences of the proles [see Eq. (19)], yielding a smooth gradient in the parameter space. We approximate the integrand of the gradient of H f g [see Eq.(16)] by a sum of delta-functions positioned at the grid points, so that the integral reduces to a simple sum over these points; for each opening angle is optim ized separately for best convergence.




FIG .2: The scaling function P+ of the order parameter prole in a wedge of opening angle = =2 w ith the edge located at the back of the gure at $x^0==0$ fx $^0=r\cos$, = rsin [see Figs.1 and 14 (a) lg. The positions of the walls of the wedge coincide w ith the coordinate axes as indicated here w ith broad lines. The values of P+ at which contour lines are drawn are multiples of 0:1 and range from 0:1 to 1:0.

The scaling function of the order parameter pro le in a wedge [see Eqs. (7)-(9)] with an opening angle of 90 is shown in Figs. 2-5. One can easily see that the contour




FIG. 3: Projection of the contour lines of the scaling function P_{+} of the order parameter pro le in a wedge of opening angle = =2 onto the $(x_{+}^{0}\;;\;_{+}\;)$ plane. The edge is located at $x_{+}^{0}\;=\;_{+}\;=0$. The curves correspond to values of $P_{+}\;$ ranging from 0:1 to 0:6 w ith an increment of 0:1 from top to bottom . The inset shows that the maximal curvature of the contour lines, occurring on the bisector (), depends linearly on the values of $P_{+}\;$ corresponding to the contour lines w ithin the range of $P_{+}\;$ values considered here.

lines quickly become parallel to the walls of the wedge as we move away from the edge (see Figs. 2 and 3). This is especially apparent as we approach the walls. As one moves along the bisector of the wedge, the maximal curvature of the contour lines decreases sharply (Fig. 3). This underscores that in terms of the rescaled vari-

ables, to a good approximation the elects of the edges are spatially localized. Them aximal curvature depends linearly on the values of P_+ corresponding to the contour lines within the range of P_+ values analyzed in Fig. 3.




FIG. 4: The scaling function P_+ of the order parameter as a function of the distance r_+ from the edge of a wedge of opening angle = =2. The curves correspond to values of ranging from 5 to 25 with an increment of 5 from top to bottom .




FIG. 5: The scaling function P_+ of the order parameter along arcs of dierent radii r_+ centered at the edge of a wedge of opening angle = =2. The curves correspond to values of r_+ from 1 to 5 with increments of 1 from top to bottom . The curves are symmetric around = =2 = =4 and diverge as $(c_+ r_+^-)^-$ for ! 0. For r_+ = 1 the comparison with the asymptotic behavior c_+ $(r_+ \sin)^-$ for < =2 and c_+ $[r_+ \sin)^-$ for > =2 is shown as a dashed curve [see Eq. (8)].

A long radial directions, i.e., for = const: (Fig. 4) the scaling function exhibits a power law limiting behavior close to the walls in accordance with Eq. (8) and the paragraph preceding it. For large r the behavior crosses over into an exponential decay: P_+ (r_+ ! 1;;) = A_+ (;) $e^{r_+ \sin}$, P_- (r ! 1;;) 1 = A_- (;) $e^{r_- \sin}$, where near the walls A_- reduce to the amplitudes of the exponential decay away from an in nite planar wall: A_+ (! 0;) = $\overline{8}$ and A_- (! 0;) = 2. The dependence of A_- (;) on is weak. The latter values are valid for . 30, beyond which the prefactors of the exponential functions increase with . Upon approaching the walls of the wedge vertically, i.e., for ! 0 or with r xed [see Eq. (8) and Fig. 5] the divergence of the prole has a power law form .

The limiting behaviors of the scaling functions P close to the edge of the wedge (r ! 0) are described by the amplitude functions e (;) [see the paragraph following Eq. (7) and Fig. 4]:




Fig. 6: The amplitude functions c (; = =2) = P (r;) r in a wedge of opening angle (t > 0:+, t < 0:). The solid line corresponds to the function c+ (sin) = (t > 0) [see Eq. (8)] and the dotted line to c (sin) = (t < 0), which are valid in the asymptotic regime ! 0, but provide a surprisingly good description throughout the whole angle range 0 < < =4 $^{\prime}$ 0:785.

These functions are plotted for = =2 in Fig. 6. According to Eq. (8), close to the walls of the wedge, i.e., for ! 0 these functions are given by c (! 0;) = c (\sin) = .




FIG.7: The scaling function P_+ of the order parameter prole at a ridge of opening angle $=260\,$ with the edge perpendicular to the $(x_+;z_+)$ plane and located at $x_+=z_+=0$ [see Figs. 1 and, c.f., 14(b)]. The positions of the walls of the ridge are indicated here with broad lines. The values of P_+ at which contour lines are drawn are multiples of 0:1 and range from 1:0 to 0:1 (top to bottom).




FIG. 8: Projection of the contour lines of the scaling function P_+ of the order param eter prole in a ridge of opening angle = 260 onto the $(x_+;z_+)$ plane. The projection is shown only on one side of the bisector of the ridge, which coincides here with the z_+ axis. The wall of the ridge is indicated with a broad line. The edge is located at $x_+ = z_+ = 0$. The curves correspond to $P_+ = 0.1$, 0.5, and 1.0 from top to bottom. The inset shows that the maximal curvature of the contour lines occurring on the bisector is a linear function of P_+ within the range considered here.

The scaling function of the order parameter prole at a ridge [see Eqs. (7)-(9)] with an opening angle of 260 is shown in Figs. 7 and 8. One can easily see that the contour lines rapidly become parallel to the walls of the ridge as one moves along them further away from the edge. As one moves along the bisector of the ridge away from the edge, the maximal curvature of the contour lines decreases (Fig. 8). depends linearly on the values P characterizing the contour lines and thus has similar limiting behaviors close to the edge of the ridge and far from it as a function of r, at least within the range studied in the inset of Fig. 8.

Comparing the order parameter proles in a wedge or at a ridge with the prole near a planar wall, one can visualize the wedge or ridge as being formed by breaking the planar wall into two halves, which in the case of a wedge are brought closer to each other, and in the case of the ridge are taken further apart. Close to the edge of the wedge this increases the values of the proles, while close to the edge of a ridge these values are decreased as compared to the prole near a planar wall.

B. Excess adsorption

The presentation of the full order parameter distribution requires to keep track of four variables: r; ;t, and .

Therefore it is advantageous to consider also the excess adsorption in wedges and at ridges, which is experimentally relevant and provides reduced information depending only on tand [Eq. (10)]. We are particularly interested in the line contribution [see Eqs. (11) and (13)] characterizing the elect of the wedge (ridge) geometry via its universal amplitude functions [Eq. (15)]. In order to calculate this quantity we use the fact that the integral in Eq. (15) can be rewritten as




FIG. 9: Contour levels of the integrand of the integral that determ ines the am plitude of the reduced excess adsorption for $T>T_{\rm c}$ [see Eqs. (15) and 24] in a wedge of opening angle = =2 with the edge located at the back of the gure at $x^0==0$ ($x^0=r\cos$, = $r\sin$). The walls of the wedge, indicated by broad lines, coincide with the coordinate axes. The values of \overline{P}_+ at which contour lines are drawn increase with multiples of 0:1 and range from 0:05 to 1:05.

where F $\overline{(P)}$) is the area enclosed by the contour lines of $\overline{P} = P (r; ;) P^{1=2} ((r;)) (see Fig. 9). Based$ on these areas one is left with a one-dimensional integration to obtain num erically. Furtherm ore, exploiting the observation that the geom etrical shapes formed by the contour lines are sim ilar to one another for sm all and large areas, respectively, and using the lim iting behavior of the scaling functions, we approxim ate F $\overline{(P)}$) for small values of \overline{P} in terms of \overline{P} , and for large \overline{P} in term of powers of $\ln \overline{P}$). These approximate power laws are calculated based on di erent intervals in P chosen as ever narrowing slices of that interval in P which the num erical data lie. The narrowing intervals approach the small and large P lim it, respectively. W ith these power law approximations for dierent intervals in we obtain a series of approximate integrals for those

intervals, for which due to practical lim itations there are no num erical data (for small and large values of \overline{P}), and take the lim it. This enables us to carry out the integral in Eq. (24) num erically for the whole range from $\overline{P}=0$ to $\overline{P}=1$.




FIG. 10: The amplitude of the line contribution to the excess adsorption for t>0 Eqs. (14) and (15)] as a function of the opening angle . The full line is a tthrough the data (+). The inset shows that over a wide range $\frac{1}{2}$ () = 1:62=(=). $\frac{1}{2}$ + () = 0 by de nition. Note that $\frac{1}{2}$ + () < $\frac{1}{2}$ + (2

- This integration leads to the universal amplitudes () as shown in Fig. 10. For small opening angles




FIG. 11: The amplitude $\frac{w}{+}^{r}$ of the line contribution to the excess adsorption of the basic unit of one wedge of opening angle w and one ridge of opening angle w and one ridge of opening angle w in an array of e ectively independent wedges and ridges as a function of (v = w) = 0, which characterizes the roughness of the surface (see, c.f., Fig. 13). The dashed lines are ts. The insets show the behaviors in the limiting cases on a loglog scale and a log-linear scale for sm all and large roughness, respectively. They indicate that $\frac{w}{v} ((v = w) + 0) (v = w)^2$ and that $\frac{w}{v} (v = w) = 0$ in creases as $\frac{w}{v} (v = w) = 0$ in the limiting cases of v = w.

they diverge as (! 0) 1=, vary linearly close to = for , and their absolute values increase rapidly for > . Num erical evidence suggests that this latter increase is exponential (but no divergence [see Fig. 11]).

Strikingly, the reduced excess adsorption $_+$ () above the critical tem perature appears to be proportional to the reduced excess adsorption $_-$ () below the critical

tem perature. We have calculated their ratio for seven opening angles ranging from 20 to 240 and found

i.e., their ratio appears to be independent of .

Ratios of the amplitudes of the excess adsorption above and below T_c have been investigated for the case of a planar wall theoretically [8], experimentally [7], and using M onte Carlo simulations [9]. The values obtained experimentally for the ratios of the amplitudes for the planar case (mean value: 1:19 0:04) agree rather well with the result of the M onte Carlo simulations (1:11); the corresponding mean eld value is $1=\frac{1}{2}$ [8].

The angular dependence of the reduced excess adsorption shows that for large angles, i.e., for a ridge, the absolute values are larger than for small angles, ie., for a wedge: () < j (2)); One can calculate the excess adsorption at a periodic array of wedges and ridges (see, c.f., Fig. 13) if their edges are su ciently far apart from each other so that their in uences do not interfere (see part B of the Appendix). The result expressed by Eq. A5 in the Appendix shows that in this limiting case the line contribution to the excess adsorption, which captures the e ect of the wedges and ridges, is the sum of the contributions of single wedges of opening angle w and of single ridges of opening angle $_{\rm r}$ = 2 $_{\rm w}$ sharing the same temperature dependence tij 2 . Thus the amplitude of the combined contribution of one wedge and a neighboring ridge form ing the basic building block of the array is given as as $(_{\rm w})$ + $(_{\rm r})$. This quantity may be viewed $2_{w} = 2(\frac{w}{w})$, which as a function of $_{r}$ $_{w} = 2$ characterizes the roughness of the surface. $^{"}_{+}$ ($_{r}$ is plotted in Fig. 11 for (t > 0). One can see that all values are negative, i.e., the total excess adsorption (relative to a planar substrate with the same area as the actual one of the corrugated surface) is decreased by the line contribution. This demonstrates that the decrease in adsorption for a ridge with r = 2w dominates the increase due to the corresponding wedge with opening angle $_{\rm w}$ (see Fig. 10). The amplitude $_{+}^{\rm wr}$ varies quadratically for small roughness and exponentially for large roughness.

In Ref. [28] the total excess adsorption has been calculated for curved surfaces. For a curved membrane with both sides exposed to a uid near criticality, the sum of the excess adsorptions on the two sides per unit area was found to be larger for spherical regions of the membrane and smaller for cylindrical regions as compared to that for at regions. Since the cylindrical regions may be viewed as rounded wedges and ridges, this latter inding exhibits the same qualitative trend as found here for the periodic array of wedges and ridges.

IV. FREE ENERGY OF THE CONFINED FLUID AND CASIM IR TORQUE

In the previous chapters we have investigated structural properties, i.e., order parameter proles of critical uids in wedges and close to ridges. In the followings we comment on their thermodynamic properties based on the free energy of such systems.




FIG. 12: One choice for the volume V of integration in the de nition of the excess adsorption $\mathbb{E}q$. (10)] with its cross section in the plane perpendicular to the invariant directions.

The volume V () of the system shown in, c.f., Fig. 12 (for another possible choice see, c.f., Fig. 14) is bounded by the walls of the wedge or ridge, which in turn end in the linear edge forming the vertex. A coordingly in the them odynam ic lim it the total free energy F decomposes into a bulk, a surface, and a line contribution:

where $f_b\left(T\right)$ is the bulk free energy density, $f_s\left(T\right)$ is the surface free energy density, and $f_1\left(T\right;$) is the line free energy density. S is the total surface area of the wall in contact with the uid, L is the length of the edge. Each of the three terms in the free energy and thus the total free energy itself are sums of a singular part $(f_{\rm sing}^{(b;s;l)}\left(t;\right))$, which contains the therm odynam ic singularities in the vicinity of the bulk critical point $t=(T-T_c)=T_c!$ 0, and an analytic background contribution $(f_{\rm back}^{(b;s;l)}\left(T\right;\right))$.

The leading singular part of the total free energy can

be written in the form (see, e.g., Refs. [5], [46], and [47]):

Here '0:11 is the bulk specie cheat exponent, $_{\rm S}$ = + , $_{\rm 1}$ = +2 , and $_{\rm b}$ and $_{\rm a}$ are universal bulk and surface amplitudes. The bulk contribution depends trivially on via the geometry V (), whereas the surface contribution is independent of . The line contribution carries a nontrivial dependence on via the universal amplitude functions $_{\rm a_1}$ ().

The background contribution takes on the form

W ithin mean-eld theory 2 $_1$ = 1 so that the singular line contribution becomes indistinguishable from the analytical background contribution. Thus our present approach renders only the sum of these two contributions without the possibility to isolate the amplitude functions a_1 (). As indicated by the pole $\frac{1}{1-1}$ for d! 4, inclusion of Gaussian uctuations beyond the simple meaneld theory is expected to generate a term to the resonance of the singular contribution $\frac{1}{1}t^2$ with an analytical background term t [52]. The am plitude of the singular term tln tjwould allow one to retrieve at least the mean-eld expression for a (). However, this technically challenging inclusion of Gaussian uctuations is beyond the scope of the present work.

A suitable approach to obtain the change of the free energy upon varying the opening angle of the wedge or ridge involves calculating the eld theoretical stress tensor. A nalogously to the free energy density, the corresponding torque requires additive renormalization up to second order in temperature [53]. We have followed this route within the present mean—eld theory without iso—

lating the critical C asim ir torque. We have found that this combined torque diverges as M $_{\rm }$ 1= 2 for sm all , and it appears to be a linear function of 1= 2 w ithin the angle range between $_{\rm }$ = 20 and $_{\rm }$ = 280 .

V. SUMMARY

In the present study of critical adsorption in wedges and close to ridges (see Fig. 1) we have obtained the following main results:

- (1) We have discussed the scaling properties of the orderparam eterpro lem (r;t;) = ajtjP (r=;;) in terms of the bulk correlation length = 0 jtj above and below the critical point T_c with t = $(T T_c) = T_c$. The universal scaling functions P (r=;;) diverge according to a power law close to the walls of the wedge or ridge, and decay exponentially far away from the walls Eq. (8)].
- (2) In the therm odynam ic lim it the excess adsorption $(s_?;s_k;t;)$ Eq. (10)] for volum es with linear extensions $s_?$ and s_k (see Figs. 12 and 14) decomposes into a surface contribution that scales with the actual surface area of the conning walls $(s_!,s_k^{(d-2)})$ and a line contribution that scales with the extension in the invariant directions $(s_k^{(d-2)})$ [see Eq. (11)] as described in detail in the Appendix. The line contribution is the specie contribution arising from the in uence of the edge on the

order parameter pro le. Its amplitude $_1$ (t;) has the scaling form $_1$ (t;) = a $_0^2$ jtj 2 () with the universal amplitude functions () Eq. (15)] carrying the dependence on the opening angle .

- (3) We calculate the above scaling functions within mean—eld theory [see Eqs. (16) and (17)] using a numerical algorithm both above and below the critical temperature (for a wedge see Figs. 2-5, for a ridge see Figs. 7 and 8). The amplitude functions of the power law divergence of the prolecules to the walls Eq. (8)] are shown in Fig. 6.




FIG.13: A uid is bounded by a substrate shaped as a periodic array of wedges and ridges with a nite depth D. The total volume of the uid $V_{\rm tot}$ can be naturally decomposed into subvolumes of the type shown in Fig.12.

- (4) Our num erical calculation also yields the experim entally relevant excess adsorption within mean-eldapproximation. The universalam plitudes + () are shown in Fig. 10. For small opening angles they diverge as + (! 0) 1= , vary linearly close to = and their absolute values increase rapidly for > . Num erical evidence suggests that this latter increase is exponential, but without divergence [see Fig. 11]. The reduced excess adsorption + () above the critical tem perature appears to be proportional to the reduced excess adsorption () below the critical temperature with $_{+}$ ()= () = 1:137 0:006. We have considered a wedge and a ridge together as forming the basic unit in a periodic array (see Fig. 13). The total excess adsorption relative to that of a planar substrate with the same area as the actual one of the corrugated surface Eq. (A 6)] is decreased by the line contribution (see Fig. 11).
- (5) The variation of the free energy of the system with the opening angle of the wedge or ridge gives rise to a torque acting on the sidewalls Eq. (29)]. The free energy decomposes into a singular contribution exhibiting scaling [see Eq. (27)], and an analytic background contribution Eq. (28)]. In d = 3 the critical Casim intorque varies as a₁ (); i) with universal amplitude functions a₁ (). This cusplike temperature singularity is expected to be experimentally accessible via suitable force microscopy. The theoretical calculation of the corresponding amplitude functions remains as a challenge.

APPEND IX A:DECOMPOSITION OF THE EXCESS ADSORPTION

In this appendix we discuss how the excess adsorption in a wedge or at a ridge decomposes into surface and line contributions [see Eqs. (11)–(13)]. In the denition of the excess adsorption [Eq. (10)] one considers a nite volume V of integration that is enlarged to lithe total volume of the wedge or ridge in the therm odynamic limit.

As shown below for two examples, the expression for the line term (such as Eq. (13)) actually depends on the choice of the shape of the volume V.

In the following we rst analyze the excess adsorption for a single macroscopic wedge or ridge (A 1), which will be followed by a discussion of the excess adsorption for two possible experimental realizations (A 2 and A 3).

- 1. A single m acroscopic wedge or ridge
- a. First choice of the volume of integration

Our rst choice for V is shown in Fig. 12 for the case of a wedge. This choice is inspired by the idea that the single wedge or ridge considered here is ultim ately a member of a periodic array. With this polygonal cross section and a similarly constructed one for the ridge, one can cover the total volume $V_{\rm tot}$ of a uid in contact with a surface formed as a periodic array of wedges and ridges in a natural way (see Fig. 13). All the formulas explicitly stated below for the wedge are valid for the ridge, too.

The volume V is symmetric with respect to the bisec-

torplane of the wedge, which allows us in the following

to consider only one half of the wedge, and multiply the corresponding expression by a factor of two.

As indicated in Fig. 12 the volume V in Eq. (10) is nite and thus the integral is nite, too. As a 1st step in carrying out the them odynam ic limit we keep the shape of V but shift the upper boundary z=const to in nity. Since m approaches m b exponentially, this extension of V increases by an exponentially small amount and thus does not contribute to the two leading terms under consideration in Eq. (11). (In the spirit

of the therm odynam ic lim it one rst increases V before one can possibly consider the lim it $t \cdot t \cdot t \cdot t$. Therefore these arguments are not in paired by a power law decay of m (z ! 1; t = 0) in the therm odynam ic lim it.) For the resulting sem i-in nite strip Eq. (10) can be rewritten in the following form by adding and subtracting the order parameter pro $\lim_{t \to 0} t^{-2}(t - t \cdot t) = t$ of a uid in contact with an in nite planar wall in the integrand (see Figs. 1 and 12):

where $x^0 = r\cos = z\cos(=2) + x\sin(=2)$ is the coordinate m easured from the apex parallel to the nearest wall of the wedge and $= r\sin = z\sin(=2) - x\cos(=2)$ is the normal distance from the nearest wall of the wedge (see Fig. 12).

In the inner integral of the st term the upper integration lim it can be shifted to in nity, i.e., $s_1!+1$, with an addition of only exponentially small corrections to the integral, because mapproaches m^{1-2} exponentially for $x^0!+1$ at xed. Thus the st term in Eq. (A1) approaches a constant for $s_2!+1$ and this constant involves an unlimited integral over the whole half of the wedge. Expressed in terms of cylindrical coordinates this term yields the line contribution $s_1!$ (t;) $s_k^{(d-2)}$ in Eqs. (11) and (13).

As the integrand of the second term in Eq. (A1) does not depend on x^0 , the inner integration $\sin p \ln y$ yields a factor $s_2 = 2$. The outer integral then yields $x^0 = 2$ in Eq. (3). Together with Eq. (12) this veri es Eq. (11).

b. Second choice of the volum e of integration




FIG. 14: A second choice for the volume V of integration in the denition of the excess adsorption Eq. (10)] for a wedge (a) and a ridge (b) with its cross section in the plane perpendicular to the invariant directions.

Our second choice of the shape of the volume V as shown in Fig. 14 (a) corresponds to the one used in Ref. [37], where liquids con ned by two opposing structured walls have been studied; in this geometry one cannot in nitely extend the volume in the +z direction. On the other hand in the case of the ridge as shown in Fig. 14 (b), starting out from a nite volume V, the upper boundary of the volume (z = const) can be shifted to +1 as well as the two vertical boundaries (x = const) to 1 with only exponentially small corrections to the integral in Eq. (10), because in the directions z ! 1 and x ! 1 for z = const are the order parameter attains

its bulk value exponentially. As for the previous choice also for the present geom etries Eq. (10) can be rewritten by adding and subtracting the order parameter prole ${\rm m}^{1}$ =2 (= r sin ;t) of a uid in contact with an in nite

planar wall in the integrand (see Fig. 14):

The inner integral in the second term can be carried out, because the integrand is independent of x^0 . This yields a prefactor $\frac{s_2}{2}$ $\tan\frac{1}{2}+\frac{1}{\tan\frac{1}{2}}=\frac{1}{2}$ so $\frac{1}{2}$ so $\frac{4}{\sin}$. The rst term of this prefactor gives rise to the surface contribution in Eqs. (3), (11), and (12), if one shifts the upper integration \lim it of the integration to in nity with the addition of exponentially small corrections. After multiplying this prefactor by two, its second term gives rise, however, to another line contribution with the amplitude

where the upper lim it of integration has also been shifted to in nity with an exponentially small correction. We note that this additional line term depends on the order parameter prole at a planar substrate only. Due to the extra factor in the integrand, the integral in Eq. (A3) is nite for d=4 in spite of m^{1-2} (! 0) m^{1} in this case, i.e., m^{1-2} does not carry a factor proportional to m^{1-2} as m^{1-2} does (compare Eq. (6)).

Thus in the therm odynam ic lim it the two choices of the integration volume V yield the same surface contributions $_{\rm s}$ to the excess adsorption but dierent subdom inant line contributions $_{\rm l}$:

with S = $s_{?} \; s_{k}^{d \; 2}$, L = $s_{k}^{d \; 2}$, and $\hat{\ }_{1}$ given by Eq. (A 3). Experiments cannot be carried out for in nitely deep wedges. Instead they can be carried out for either a periodic array of wedges or for a single wedge of nite depth carved out from a wide planar surface. In both cases additional ridges must be form ed giving rise to their own adsorption properties. Therefore experiments on such systems give access only to certain combinations of wedge and ridge excess adsorptions, whose corresponding line contributions carry the relevant additional inform ation about the nonplanar substrate geom etry. The actual choice of the corresponding integration volume depends on the actual experimental setup (compare, e.g., Fig. 13; see Subsecs. A 2 and A 3) The results of this subsection show that the line contributions depend on such details even in the therm odynam ic lim it.

2. Periodic array of wedges and ridges

In this subsection we consider a substrate with a periodic series of edges and wedges as depicted in Fig. 13. There is a variety of experimental techniques to create such kind of surface morphology. If the opening angle of the wedges is , the opening angle of the ridges is 2. Here we focus on the limiting case that the depth of the wedges $D = s_2 \cos(-2)$ is su ciently large, so that the deviations of the proles close to the edges of the wedges and ridges, respectively, from the prole of a uid exposed to an in nite planar substrate do not in uence each other. As apparent from Figs. 12 and 13, this case

corresponds to the st choice of the volume of integration for the single wedge or ridge and thus leads to the following decom position of the excess adsorption [see Eq. (A4b)]

with the total surface of the substrate $S_{tot}=N\ s_{?}\ s_{k}^{d\ 2}$, where $N=N_{w}+N_{r}$ is the number of segments of length $s_{?}$, $_{s}$ (t) = $^{1\ =2}$ (t) [see Eq. (3)], L = $s_{k}^{d\ 2}$, $N_{w}=N_{r}$ are the numbers of wedges and ridges, respectively, and

where $_{\rm w}$ is the opening angle of the wedge, and $_{\rm r}$ = 2 $_{\rm w}$. This is in accordance with Eqs. (32)-(36) of Ref. [37], where a dierent coordinate system was used [54].

3. A single wedge em bedded into a planar wall




FIG. 15: A uid is bounded by a substrate shaped as a wedge carved out of an in nite planar wall. The total volume of the uid can be decomposed into the numbered subvolumes that emerge naturally due to subvolumes 3 and 5 used for describing a single ridge (rst choice of the volume of integration (Ala)) and a single wedge (second choice of the volume of integration (Alb)), respectively.

In this subsection we consider a single wedge of opening angle carved out of a planar surface, thus producing also two ridges of opening angles (3)=2 (see Fig. 15). Due to the symmetry of the con guration we consider

only half of the wedge and focus on the case that $s_?$ is su ciently large so that the ridges and the wedge do not in uence each other. One half of the total volume of the uid is decomposed into six numbered subvolumes as shown in Fig. 15. We calculate the excess adsorption Eq. (10)] separately for each one of the subvolumes by adding and subtracting the prole of a uid exposed to an in nite planar wallm $^{1-2}$ in the integral of the order

param eter as in Subsecs. A 1 and A 2.

For the $\,$ rst volume there is no line contribution resulting from the integral over the dierence of the actual problem from that in front of an ininite planar wall m 1 =2, because this dierence is exponentially small in the thermodynamic limit. There is also no surface term, because this $\,$ rst volume touches the substrate only at one point. However, following similar considerations as for a single wedge or ridge, this volume gives rise to a line contribution [see Eq. (A 4a)] to the excess adsorption [Eq. (10)] due to the deviation of m 1 =2 from m $_{\rm b}$ with amplitudes:

where we have shifted the z = const boundary to +1 with an exponentially small correction to the integral.

In the therm odynam ic lim it (s?; $\mathbf{s}_{?}^{0}$! 1) the adsorption pro lem in the second volume will tend exponentially to that of a uid exposed to an in nite planar wall m 1 =2 . Thus it supplies a surface term with the amplitudes $_{s}$ (t) = 1 =2 (t) [see Eq. (3)] for the area $\mathbf{s}_{?}^{0}$ sk d 2 W e note that this subvolume two when extended to in nity in the +z direction overlaps with the other half of the wedge, but this results in only an exponentially small correction to the excess adsorption, because the prolem approaches the bulk valuem $_{b}$ exponentially with the distance from the wall. The subvolume two does not generate a line contribution.

The third volume gives the same contributions Eq. (A 4a)] to the excess adsorption as a single ridge of opening angle (3)=2 with the rst choice of volume of integration shown in Fig. 12, i.e., a surface term with the amplitudes $_{\rm s}$ (t) = 1 =2 (t) for an area s_? $\rm s_k^{d}$ 2 [see Eq. (3)] and line term amplitudes $_{\rm lr}$ (t; $_{\rm r}$ = (3)=2) [see Eq. (A 6)]. Note that the volume of integration can be extended to in nity in the direction parallel to the bisector of the ridge even though in this case there is an over-

lap with the other half of the wedge, because this results in only an exponentially small correction to the excess adsorption as the prolem approaches the bulk value m $_{\rm b}$ exponentially in this direction further away from the ridge.

Sim ilarly to subvolum e one, subvolum e four does not generate a line term resulting from the integral over the di erence of the actual pro le m from m 1 =2. There is also no surface term, but sim ilar considerations as for a single wedge or ridge show that this subvolum e gives rise to a line contribution to the excess adsorption with amplitudes of the form:

once we have shifted the x = 0 boundary to +1 with an exponentially small correction to the integral.

The ffh subvolume together with its counterpart at x>0 gives the same contributions Eq. (A4c] to the excess adsorption as a wedge of opening angle with the second choice of the volume of integration shown in Fig. 14(a), i.e., a surface term with amplitudes $_{\rm S}$ (t) = 1 =2 (t) [see Eq. (3)] for the area s₂ s $_{\rm k}^{\rm d}$, and the line term amplitudes $_{1:II}$ (t;) from Eq. (A4c).

Finally the subvolume six yields only an exponentially small contribution to the excess adsorption.

Adding up all contributions to the excess adsorption in this geometry one obtains

As in the case of a periodic array of wedges and ridges the line contribution to the excess adsorption contains a combination of wedge and ridge terms. Since dierent combinations thereofenter into the excess adsorption of a periodic array and of a single embedded wedge, measurements of both of them provide independent information. However, these conquirations do not allow one to access

the ridge and wedge contributions individually. In the case of a single embedded wedge the line contribution to the excess adsorption contains in addition the rst moment of the order parameter prole of a semi-in nite planar system, which can be determined independently from the knowledge of m $^{1\ =2}$ ().
