## Topological O rder in G utzw iller P rojected W ave Functions for Q uantum A ntiferrom agnets

W e study the topological order in RVB state derived from G utzw iller projection of BCS-like m ean eld state. W e propose to construct the topological excitation on the projected RVB state through G utzw iller projection of m ean eld state with inserted  $Z_2$  ux tube. W e prove that all projected RVB states derived from bipartite e ective theories, no m atter the gauge structure in the m ean eld ansatz, are positive de nite in the sense of the M arshall sign rule, which provides a universal origin for the absence of topological order in such RVB state.

It is widely believed that the strongly correlated system sm ay exhibit exotic ground state structures and support exotic excitations. The study of variational wave functions provide a unique way to uncover such exoticness. In the two dimensional quantum antiferrom agnet(2D Q AF), it is proposed that a featureless quantum spin liquid state called resonating valence bond (RVB) state m ay be realized[1]. The RVB state is a coherent superposition of spin singlet pairs and can be written as

in which (ij) =  $\frac{1}{2}$  (i " j # i # j ") is a spin singlet pair(valence bond) between site i and j. It is argued that the RVB state may support fractionalized excitation of spin  $\frac{1}{2}$  spinon [2, 3].

A system atic way to generate the RVB state is through Gutzwiller projection of BCS-like mean eld state[]. Such kind of projected RVB states are now widely used in the variational study of undoped and doped quantum antiferrom agnet [4, 5, 6, 7]. An important issue on the projected RVB state is to characterize its structure and understand its excitation in physical term s. This issue is addressed at the e ective theory level by W en who introduced the notion of quantum order[8]. However, an understanding at the wave function level is still lack and it is unclear to what extend is the prediction of e ective theory applicable to projected wave functions. Fortunately, the projective m ethod to generate the variational ground state also provides a system atic way to generate the low energy excitations. A variational wave function for low energy excitation is simply generated by Gutzwiller projection of mean eld excited states[]. Such a procedure has been followed by a num ber of authors to study quasiparticle excitations [6, 9, 10, 11, 12] and topologicalexcitations[13, 14] on projected RVB wave functions.

In this paper, we use such a projective construction to study the topological excitation and topological order on the projected RVB wave functions.

The concept of topological order is the key notion to describe the structure of a RVB state and to understand the fractionalization of excitation on  $\pm$ [3, 16, 18, 19]. The topological order can be de ned as the rigidity of a system against topological excitation (dubbed vison) in the bulk of the system . On a multiply connected manifold, the topological order manifests itself as the topological degeneracy of the ground state, in which case the ground state has a num ber of locally sim ilar but globally distinct partners that di er by whether or not a vison threads each hole of the manifold [8, 13].

These ideas can be illustrated by the sim ple exam ple of quantum dimermodel[3, 16, 17]. In the quantum dimer model(QDM), the Hilbert space factorizes into even and odd topological sectors by the number of valence bonds that intersect a cut line which starts at the center of vison and ends at the boundary of the system (or in nity). A vison can be generated sim ply by reversing the sign of the amplitudes of odd sector dimer con gurations[6]. The vison de ned in this fashion behaves as a ux tube for an unpaired spin. Thus the topological order is intim ately related to the coherent motion of fractionalized spin excitation in the RVB background.

At the G aussian level, the projected RVB states are described by the slave B oson e ective theories [8, 18, 20]. A coording to the slave B oson e ective theory, a system with  $Z_2$  gauge structure in the mean eld ansatz has topological order and supports fractionalized excitations, while a  $Z_2$  ux tube plays the role of the vison[9].

In their pioneering work, Ivanov and Senthil conjectured that a  $Z_2$  gauge structure in the mean eld ansatz is also essential for the corresponding projected RVB state to show topological order[13, 14, 15]. Based on the phenom enological  $Z_2$  gauge theory of the underdoped cuprates[19], they proposed that a vison can be con-

structed by projecting BCS state containing a superconducting vortex. They nd num erically that RVB states derived from certain e ective theory with U (1) gauge structure, more speci cally, the nearest-neighboring dwave RVB state (NND state), does not exhibit topologicalorder. This is taken as evidence for their conjecture, since the vison - vortex analog is ill de ned when the pairing term is gauged away in a U (1) e ective theory.

In this paper, we try to relate the topological order of projected RVB state to their phase structure in the Ising basis. We nd the absence of topological order in the NND-type RVB states can be more naturally attributed to the Marshall sign rule of the wave function in the Ising basis, rather than the U (1) gauge structure in the mean eld ansatz.

The Marshall sign rule is a well known property of the antiferrom agnetic Heisenberg model on bipartite lattice[22, 23]. According to the rule, the wave function of the ground state is real in the Ising basis and its sign is given by  $(1)^{N_{\#}^{even}}$ , in which  $N_{\#}^{even}$  is the num ber of down spins in the even sublattice. In this paper, we prove that all RVB states derived from bipartite slave Boson mean eld states satisfy such a sign rule, no matter what is the gauge structure of the mean eld ansatz. At the same time, we show a vison can be constructed by projecting a mean eld state containing a  $Z_{2}$ 

ux tube, rather than a superconducting vortex used by Ivanov and Senthil. Combining these two points allow us to show that RVB states derived from all bipartite mean eld states, such as the NND state, do not support topological order. Thus the Marshall sign rule provides an universal origin for the absence of topological order for RVB state de ned on bipartite lattices [25], while a Gaussian level e ective theory fails for such a state.

In the slave Boson theory of RVB states [8, 18, 20], Ferm ionic slave particles fi are introduced to represent the SU (2) spin variable as  $S_1 = \frac{1}{2}$ fi f<sub>i</sub>. These slave particles are subjected to the constraint of

 $f_i^y f_i = 1$  to be a faithful representation of the spin algebra. At the saddle point level, a RVB state is given by a BCS-like mean eld ansatz for the slave particles

ij denote the mean eld RVB order parameters, while i are the Lagrangian multipliers introduced to enforce the mean eld constraint. The uctuation of the RVB order parameters are treated by e ective gauge theories[8]. W hen the gauge symmetry of the mean eld ansatz is broken to  $Z_2$ , the e ective theory is a  $Z_2$  gauge theory [18, 19]. Since the  $Z_2$  gauge uctuation is gapped at the Gaussian level, it is believed that a Z<sub>2</sub> e ective

theory describes a phase with truly fractionalized excitations.

The ground state of the mean eld Ham iltonian has the form of Cooper pair condensate [21],

in which a<sub>ij</sub> is the wave function of a Cooper in real space. The RVB state is given by Gutzwiller projection of the mean eld ground state,

(4)in which  $P_G = Q_i (1 n_{i''} n_{i\#})$  and N is the number of lattice site.

The topological order can be checked by exam ining on a tours the orthogonality of the RVB states that di ers in the num ber of trapped visons in the holes of the torus. Here, we propose a more transparent way to construct the vison wave function. In the e ective theory context, a vison is nothing but a Z<sub>2</sub> gauge ux tube. Hence, we propose to construct the vison wave function through Gutzwiller projection of mean eld state with an inserted  $Z_2$  gauge ux tube. The only e ect of the inserted Z

ux tube is to reverse the sign of mean eld RVB order parameters ij and ij on bonds that intersect the cut line de ning the vison, which am ounts to changing the boundary condition across the cut line from periodic to anti-periodic (or vice versa). In Ivanov and Senthil's work, the role of a trapped superconducting vortex is also to change the boundary condition across the cut line. Thus our construction is equivalent to theirs but is applicable in more general situations.

Now we show that the absence of topological order in the NND -type RVB state can be attributed the M arshall sign rule. The NND theory belongs to the general class of U (1) bipartite e ective theory, which contains a U (1) gauge structure in the mean eld ansatz and is bipartite in the sense that ij and ij only connect sites in opposite sublattices. Below we show that the RVB states derived from such theories satisfy the M arshall sign rule. Since a U (1) bipartite theory is still U (1) bipartite with the insertion of a  $Z_2$  ux tube, the RVB state with a trapped vison also satisfy the M arshall sign rule and will not be orthogonal to the RVB state with no trapped vison in general case [25]. Thus RVB states in this class are unlikely to exhibit topological order.

For convenience's sake, we work in the gauge with only hopping term ,

The mean  $\;$  eld ground state of  $H_{\!M\,F}\;$  is given by

in which  $f_m^y = {P \atop i'm}$  (i)  $f_i^y$  denotes the eigenstate of  $H_{MF}$  of eigenvalue m. For a bipartite H am iltonian, the eigenvalues appear in plusm inus pairs. The corresponding eigenfunctions are

in which  $r_{m}^{e}$  (i) and  $r_{m}^{o}$  (i) are the components of the eigenfunctions in the subspace of even and odd sublattices. From the orthonormality of  $r_{m}$  (i), it is easy to show that  $r_{m}^{e}$  (i) and  $r_{m}^{o}$  (i) form complete and orthonormalbasis in their respective subspaces. Thus, the eigenvectors with m < 0 su ce to expand the subspaces of each sublattices. This property of the bipartite H am iltonian is the key to establish the M arshall sign rule in the projected RVB states.

In the basis expanded by  $\sum_{k=1;\frac{N}{2}} f_{j_k}^{Y} f_{j_k \#}^{Y}$  jDi, the am – plitude of the above RVB state is given by the following Slater determ inant

For convenience's sake, we de ne a reference spin con guration in which all up (down) spins sit in the even (odd) sublattice. The amplitude of this spin con guration is given by

Since the row vector ( $\ell_m^e(i_1) = m_m^e(i_2)$ ) form complete and orthonorm albasis in the subspace of even sublattice, the column vector ( $\ell_1^e(i) = m_2^e(i)$ )<sup>T</sup> also form a com – plete and orthonorm albasis. The same is true for the odd sublattice.

Now consider a general spin con gurations. With no loss of generality, we consider the spin con guration derived from the reference con guration through exchange of the rst k up spins and the rst k down spins. One easily veri esthat the inner product of the am plitudes for these two con gurations,  $_{\rm k \ ref}$ , is given by the square m odulus of a k-th order determ inant

in which  $s(j_{l}; i_{n}) = \prod_{m=1; \frac{N}{2}}^{P} {n \choose m} (j_{l})^{\prime} m^{e} (i_{n})$ ,  $i_{n}$  and  $j_{l}$  denote the coordinates of the exchanged k up spins and k down spins.

Thus, the amplitude of the RVB state derived from Eq.(5) is positive de nite up to a global phase. Taking into account the sign change due to Ferm ion exchange, we arrive at the conclusion that the projected RVB states derived from U (1) bipartite theories satisfy the M arshall sign rule and thus are very unlikely to exhibit topological order. However, it is not clear whether the U (1) gauge structure or the bipartite nature of the theory is responsible for the absence of topological order. To clarify this point, we exam ine the phase structure of projected RVB state derived from an arbitrary bipartite e

The mean eld ansatz for an arbitrary bipartite theory is given by

in which <sub>ij</sub> and <sub>ij</sub> connect sites on di erent sublattices and are otherwise arbitrary (note other details of the lattice, such as its dimension, spatial symmetry and topology, are all irrelevant for our discussion). The Lagrangian multipliers are set to zero since the theory is particle-hole symmetric. To facilitate the proof, we make a particle-hole transform ation on down spins[4],

in which i = 1 for i 2 even sublattice and i = 1 for i 2 odd sublattice. The transform ed H am iltonian reads

The eigenvector of this Ham iltonian is given by  $\int_{n}^{y} = \int_{1}^{1} (u_n (i) f_{i^{*}}^{y} + v_n (i) f_{i^{*}}^{y})$ . Since the Ham iltonian is bipartite, its eigenvalues appear in plus-m inus pairs. The corresponding eigenvectors are given by

tions of the eigenvectors in the even and odd sublattices. For a bipartite H am iltonian, these sublattice projections form complete and orthonorm albasis in their respective subspaces. At the same time, since the system is spin rotational sym m etric, the eigenvalues are two fold degenerate. Speci cally, if  $(u_h (i); v_m (i))$  is an eigenvector of the H am iltonian, then  $(v_m (i); u_m (i))$  is a eigenvector of the H am iltonian with the same eigenvalue. Thus, the mean eld ground state of the H am iltonian can be written as

in which  $_m$  denotes the eigenvalue, and 0 denotes the vacuum of  $f_{i^{*}}$  and  $f_{i^{\#}}$ . The prime on the product indicates that the product is taken over the eigenvectors with negative eigenvalues.

We now project the wave function into the subspace of no double occupancy. At half lling, the up spins and the holes of the down spins should occupy the same set of lattice sites in the projected wave function. Thus a general spin con guration can be expressed in the Fock basis as  $m = 1, \frac{N}{2}$   $f_{i_m}^y$ ,  $m = 1, \frac{N}{2}$   $f_{i_m}^y \# 0$ . The amplitude of the projected RVB state for this con guration is given by the following Slater determinant

Following essentially the same steps that we have detailed in the U (1) case, one can show that the column vectors,  $(u_1(i_e) = \frac{1}{2}(i_e); v_1(i_e) = \frac{1}{2}(i_e))^T$  and  $(v_1(i_e) = \frac{1}{2}(i_e); u_1(i_e) = \frac{1}{2}(i_e))^T$  for  $i_e$  2 even sublattice, and  $(u_1(i_o) = \frac{1}{2}(i_e); v_1(i_o) = \frac{1}{2}(i_o))^T$  and  $(v_1(i_o) = \frac{1}{2}(i_e); u_1(i_o) = \frac{1}{2}(i_o))^T$  for  $i_o$  2 odd sublattice, form complete and orthonormal basis in their respective subspaces. From this orthogonality, one can show that k = ref is still given by Eq.(7), with the matrix element now given by  $s(j_1; i_n) = m = 1; \frac{N}{2}$  ( $u_m(j_1)u_m(i_n) + v_m(j_1)v_m(i_n)$ ). A sbefore, refdenotes the amplitude of the reference spin con guration with all up spins occupying the even sublattice, while k denotes the amplitude of a general spin con guration with

notes the amplitude of a general spin conguration with k up spins occupying the odd sublattice.  $i_n$  and  $j_l$  denote the coordinates of the exchanged k up spins and k down spins.

Thus, the amplitude of the RVB state derived from Eq.(8) in the basis expanded by  $\int_{k=1,\frac{N}{2}} f_{i_k}^{y} f_{i_k \#}^{y} 0$  is

also positive de nite up to a global phase. It is easy to check that the M arshall sign rule has been built into this basis. Thus projected RVB state derived from an arbitrary bipartite e ective theory satis es the M arshall sign rule and are very unlikely to show topological order, no m atter the gauge structure of the mean eld ansatz. Since the topological order is directly responsible for the existence of fractionalized excitations, our result also in plies that the M arshall sign rule provides a universal origin of con ning force for fractionalized excitations on bipartite lattice.

O ur proof of the M arshall sign rule m akes it clear that a  $Z_2$  gauge structure in the mean eld ansatz alone is not su cient for the derived RVB state to show topological order. To illustrate this point, we have checked the topological order in the RVB state derived from a  $Z_2$  bipartite theory with the following mean eld ansatz on square lattice




FIG. 1: Overlaps between the RVB state with periodicantiperiodic boundary condition and the RVB state with antiperiodic-periodic boundary condition on a torus of size L.(a)  $Z_2$  bipartite case, (b)U (1) non-bipartite case.

in which 1; 2 and 3 denote the three Pauli matrices. In Figure 1a, we plot the overlap between the state with periodic-antiperiodic boundary condition and that with antiperiodic-periodic boundary condition on a torus. The result show sclearly the absence of topological degeneracy in such an RVB state. On the other hand, since the de - nition of vison is now independent of the gauge structure of the e ective theory, neither is a  $Z_2$  gauge structure in the mean eld ansatz necessary for the projected RVB state to show topological order. To illustrate this point, we have checked the topological degeneracy in the RVB state derived from a U (1) nonbipartite theory with the following mean eld ansatz

This ansatz describes a U (1) RVB state on anisotropic triangular lattice. The isotropic version of this ansatz is found to be a good approximation for the ground state of the Heisenberg model on triangular lattice [24]. The overlap for this RVB state is shown in Figure 1b. The result indicates that the RVB state derived from such a U (1) theory exhibits topological degeneracy. Thus the gauge structure in the mean eld ansatz seems to be not a good teller for existence of the topological order in the projected RVB state.

In sum mary, we have proposed a new way to construct topological excitation on projected RVB states. We nd the M arshall sign rule provides a universal origin for the absence of topological order for RVB states derived from bipartite e ective theories. This indicates that a G aussian level e ective theory is insu cient for RVB states de ned on bipartite lattices.
