N egative superdi usion due to the inhom ogeneous convection

Fractional transport of particles on a comb structure in the presence of an inhom ogeneous convection ow is studied. The large scale asymptotics is considered. It is shown that a contam inant spreads superdi usively in the direction opposite to the convection ow. Conditions for the realization of this new e ect is discussed in detail.

A realization of superdi usion on a subdi usive media, e.g. on a comb structure [1], is an example of the fractional transport due to the inhom ogeneous convection. These studies of the space{time evolution of an initial pro le of particles in a speci c m edia due to the inhom ogeneous convection ow are arisen in a variety of applications such as transport of external species (pollution) in water owsthrough porous geological form ations [2, 3], problem s of di usion and reactions in porous catalysts [4] and fractal physiology [5]. The conditions for the inhomogeneous convection which is responsible for the superdi usive spreading of an initial packet of particles have been found in [1]. A classi cation of possible scenarios of the space{time evolution of a contam inant in the presence of the inhom ogeneous convection on the comb structure is presented there. The external forcing has been taken in the power{law form for the convection current $j_x(t;x;y) = vx^s(y)G(t;x;y)$, where a distribution G (t;x;y) describes the evolution of the initial pro le, while vx^s (y) is the inhom ogeneous convection velocity. W hen s < 0 subdi usion is observed 6, 7]. W hen s > 0 it is superdi usion. The hom ogeneous convection with s = 0 corresponds form ally to the norm al di usion, but the e ective di usion coe cient is determ ined by the external forcing v [1]. The frontier case with s = 1 corresponds to the log{norm ald istribution of transport particles, where one deals with not a sum of independent random variables but with theirm ultiplication [8]. W hen s > 1 the fractional transport corresponding to superdi usion possesses speci c features. This case is the main subjective for the investigation in the present Letter. W e consider both the fractional transport on the com b structure, where the num ber of transporting particles is not conserved, and the continuous tim e random walk (CTRW) with conservation of the total number of particles (transporting or not). This case of s > 1 di ers essentially from those with s 1 where the transporting particle move in the direction of the convection current j_x [1]. Unlike our previous consideration [1] in the present study we observed analytically that an asymptotic solution for the transporting particles corresponds to superdi usion in the direction opposite to the convection ow current _{xj}. This is a result of an irreversible relaxation process [9] which is \inevitable" process in the di usion transport phenom ena.

First, we will describe the superdi usion on the comb structure due to the inhom ogeneous convection described by the 2D distribution function G = G(t;x;y) and the current

where D (y) and D are the di usion coe cients for the x and y directions correspondingly, while the inhom ogeneous convection velocity is $v(x;y) = v_i x_j^2$ (y).

The comb m odel is known as a toy m odel for porous m edia used for the exploration of low dimensional percolation clusters [10] and an electrophoresis process [11]. For v = 0 subdi usion have been observed [2]. A special transport behavior on the comb structure is that the displacement in the x {direction is possible only along the structure x-axis, say at y = 0, according to Eq. (1). B oth the di usion coe cient and the convection ow are highly inhom ogeneous in the y-direction. There is also di usion in the y{direction with a constant di usion coe cient D. Therefore the Liouville equation

with the Fokker{Planck operator of the form

The initial condition is G(0;x;y) = (x)(y), and the boundary conditions on the in nities have the form G(t; 1; 1) = 0 and the same for the 1st derivatives with respect to x and $y G_x^0(t; 1; 1; 1) =$ $G_y^0(t; 1; 1) = 0$. The function sgn(x) equals to 1 for x > 0 and 1 for the opposite case. The transport of particles along the structure x-axis is described by the function G(t;x;y = 0) = g(x;t). It should be underlined that the tails of the distributions are the most interesting for applications. Therefore, we are studying here the large scale asymptotics when jxj = 1. In the Laplace{Fourier (LF) space (p;k) Eq. (2) is transformed to the following fractional equation for the function g = g(p;k) = LF[g(t;x)]

Here the fractional Reisz derivative is the result of the Fourier transform [9, 13]

The large scale asymptotics $j_{k,j} = 1$ corresponds to $j_{k,j} = 1$ in the Fourier space. Therefore, the statem in β) can be omitted at the condition

This approximation depends on the form of singularity of the the convection velocity in the limit $x \mid 1$. It means that the asymptotic solutions of the hom ogeneous part of Eq (3) for jkj 1 depends on the exponents in the power law jkj [14, 15]. A fler performing the inverse Fourier transform, one obtains the asymptotic of $x \mid 1$ solution that corresponds to the hom ogeneous part of Eq. (3). It reads

This solution describes asymptotic transport of any initial profer. To obtain the time (dependent solution one carries out the inverse Laplace transform $g(t;x) = L^{-1}[g(p;x)]$. The necessary condition theorem needs the negative sign of the function in the exponential in Eq. (5). It depends only on s and the sign of v. When s < 1, the initial profer of particles moves in the directions of the convection ow, namely, in the direction of v = jvj for x > 0, and v = -jvj for x < 0. It is usual superdiffusive acceleration of diffusion due to the inhom ogeneous convection. This case together with s = 1 was considered in detail in [1].

W hen s > 1 the situation ismuch interesting and leads to the absolutely new e ect. Indeed, for s > 1, the necessary condition to perform the inverse Laplace transform is v = yj when x > 0 and v = jvj when x < 0. Hence, the inverse Laplace transform gives

W hen jxj 1 and t is large enough to put the exponential to the unite, one obtains the distribution for superdi usion of particles

All moments of x higher than 2s 2 are equal to the in nity. It also should be underlined that the ux on the in nities is vanishing. The important feature of this superdi usion is that it occurs in the direction opposite to the inhom ogeneous convection current. This new phenom enon is related to the relaxation process or it is due to di usion, where the K olm ogorov conditions (see §]) are necessary for the inferring of the Fokker(P lank equation (FPE). In the absence of the convection the solution of the FPE gives that at any m om ent t > 0 the particles are spread over the all x {axis from the m inus in nity to the plus in nity with the exponentially sm all tails. It is correct not only for the norm ald i usion but for the subdi usive relaxation on the com b structure, as well [2]

This behavior is dominate for smallx even in the presence of the inhom ogeneous convection. But for the asym ptotically large x the inhom ogeneous convection in the direction opposite to the spreading of particles changes the shape of the tail of the packet from the exponential to the power law in according with Eq. (7). We call this solution the negative superdi usion solution or the negative superdi usion approximation (N SA).

The total number of transporting particles on the structure axis decreases with time

Therefore, the distribution function (6) describes the NSA when the number of particles hG i is not conserved. The form ulation of the NSA problem with conservation of the total number of particles is equivalent to the case with a continuous distribution of the delay times [8], where the total number of particles is described by the function $G_1(t;x) = {1 \atop 1} G(t;x;y) dy$. It is simply to show from Eq. (2) that

Taking this into account, one obtains the equation for G_1 by integrating Eq. (2) with respect to the y variable. It reads in the Laplace space for G_1 (p;x) = L [G_1 (t;x)]:

It is simply to see from Eq. (2) or Eq. (3) that

Substituting this in Eq. (10), one obtains that

A first substitution of this relation in Eq. (10), the CTRW equation in the Laplace space is

We introduce the Riem ann [Liouville fractional derivatives (see, for example, [7, 16]) $\frac{\theta}{\theta t} f(t)$ by means of the Laplace transform (0 < < 1):

that also implies [1]=0t = 0 [16]. Using this de nition, we write down the CTRW equation which corresponds to the comb model desribed by Eq. (2)

Here the initial condition is $G_1(0;x) = (x)$. For the asymptotically large scale x = 1 (or x = 1), we neglect the inhom ogeneous term together with the second derivatives with respect to x in Eq. (11) to obtain the following equation

with the NSA related to the CTRW by

In the rest of the Letter we infer the NSA in the fram ework of the Liouville (G reen asymptotic solution for linear di erential equations [5]. We show that the perform ed approximation due to the condition (4) is satisfactory good and corresponds to the Liouville (G reen (LG) approximation also called the W KB approximation [17]. The CTRW equation (13) in the generalized form reads

where 0 < < 1. Hence, for x 1, we obtain the hom ogeneous part (lhs) of Eq. (11), where the item $p^{1=2}$ is substituted by p. It reads

The term in the st derivative is removed from the equation by the substitution

The LG approximation for w, that satis es to the accepted boundary conditions (see Eq. (2)), is

where B is a constant. A nalogously, we obtain the LG solution for the negative x 1. Therefore, taking $B = \frac{2D}{|y|}$ and = 1=2, we obtain that Eq. (18) co-incides exactly with the solution (14). It means that rem oving the second derivatives from \hat{L}_{FP} or, the same, the term k^2 in the Fourier space in the limit k ! 0 corresponds to the Liouville (G reen approximation for the Fokker (P lanck equation with inhom ogeneous (superdiffusive) convection. This asymptotic solution is superdiffusive transport of particles in the direction opposite to the convection current, namely it is the NSA.
