B im odal energy relaxation in quasi-one-dim ensional com pounds with a commensurate modulated ground state

We show that the low tem perature (T < 0.5 K) time dependent non-exponential energy relaxation of quasi-one-dimensional (quasi-ID) compounds strongly dier according to the nature of their modulated ground state. For incommensurate ground states, such as in (TMTSF)₂PF₆ the relaxation time distribution is hom ogeneously shifted to larger time when the duration of the heat input is increased, and exhibits in addition a scaling between the width and the position of the peak in the relaxation time distribution, w² In (m). For a commensurate ground state, as in (TMTTF)₂PF₆, the relaxation time spectra show a bim odal character with a weight transfer between well separated slow and fast entities. Our interpretation is based on the dynamics of defects in the modulated structure, which depend crucially on the degree of commensurability.


Non exponential relaxation is the ngerprint of disorder in a system subject to an external perturbation [1]. It is the consequence of a broad distribution of relaxation times. The question of determ ining the nature and spatial extent of correlated objects responsible for slow dynamics in spin glasses and glasses, has been debated for several decades. In spin glasses, the memory and chaos experiments [2] give information about excitations in real space. In glasses there is a consensus that structural relaxation occurs on correlated dom ains of a nanom eter size [3]. In colloidal suspensions, a direct three dim ensional (3D) in aging of the cooperative motion in structural relaxation has been obtained on microm eter scales [4]. A general fram ew ork for describing spatial and tem poral heterogeneities in aging system s has been proposed in Ref. [5]. A new class of mesoscopic glass, with characteristic scales of microm eters, has been recognized am ong quasi-one-dim ensional (quasi 1D) systems [6]. Heat relaxation at very low temperature T, below 0:5 K, in these systems, has been shown to be non exponential and to exhibit aging [6] in which the entire wide spectrum of relaxation times is shifted to longer tim es with increasing the duration of the very sm all heat perturbation. W e suggest here on the basis of heat relaxation experiments that the formation of correlated objects in m odulated quasi-1D systems, is qualitatively different in commensurate and incommensurate systems.

Q uasi 1D system s exhibit a variety of modulated electronic ground states at low-temperature both in the charge channel, such as charge density wave (CDW), and in the spin channel, such as spin density wave (SDW), spin-Peierls (SP) or antiferrom agnetic ground state. Extensive investigations of the low-T therm odynamical properties [6, 7, 8, 9] have shown that all of these system s dem onstrate w ell-known universal features of glasses regardless the actual ground state. This in-

volves an extra contribution to the speci c heat C $_{\rm p}$ com – ing from low energy excitations, and non exponential heat relaxation dynam ics for T < 0.5 K (T -range dom – inated by these excitations). \Aging" e ects are also involved, where heat relaxation and correspondingly C $_{\rm p}$ depend on the duration of a sm all heat perturbation (a few mK) [6, 7, 8]. Extrem ely long relaxation times (up to 10^4 s) show that these excitations are only weakly coupled to the phonon heat-bath [8], contrary to conventional glasses.

The origin of these excitations can be inferred from the low frequency dynam ics of collective excitations in the charge channel. Low frequency dielectric response of CDW [10], SDW [11] which also has CDW component [12], all having a modulated charge density, is characterized by an overdam ped (relaxational) m ode slow ing dow n with decreasing temperature. This has been recognized in the case of CDW and SDW (DW) as the sign of a glass transition at the level of electronic superstructure. Freezing is naturally generated by screening e ects and occurs if there are not enough free carriers to screen efciently elastic DW phase deform ations. Consequently, the characteristic scale of a DW glass is given by the phase coherence length, which is of the order of a m. Below the glass transition temperature T_g the low frequency dynam ics and therefore the low energy excitations are governed by the rem aining degrees of freedom { topological or plastic deform ations such as solitons, domain walls or dislocation loops.

In this Letter we contrast two isostructural systems, $(TMTSF)_2PF_6$, which has an incommensurate mixed SDW-CDW ground state below 12 K, and $(TMTTF)_2PF_6$, which exhibits a charge order transition with a ferroelectric behavior at 70 K [13], and a spin-Peierls transition at 12 K, both being commensurate to the underlying lattice (in the following we use






FIG.1: How ogeneous broadening and shift of the heat relaxation with increasing t_p (aging) for SDW PF_6 . a) Relaxation $T = T_0$ vs. logt with corresponding stretched exponential t exp(t=), b) S(t) = d(T = T_0)=d(lnt) tted to a Gaussian function G(lnt) with a width w. The direct estimate of width at half height shown in b) is 2:17 decades in agreement with 1= = 2:15 and w = 2:1.

the notation SDW $-PF_6$ and SP- PF_6 respectively). We will show how the degree of commensurability a ects the very low-T dynamics and discuss these indigs in view of the properties of solitonic excitations.

We have measured the low-T heat capacity by standard relaxation method. The system is rst stabilized at a temperature T_0 . Then a small power is fed to the sample during a pumping time t_p . The temperature is increased to the new, slightly higher value $T_0 + T$ ($T=T_0 < 0.05$). Att= t_p the power is switched o and heat relaxation from the sample to the cold source towards equilibrium at T_0 is recorded as a function of time. For all the CDW and SDW systems studied previously, below 1 K relaxation starts to deviate from exponential on lowering T and also exhibits a strong dependence on t_p [6,7] (Fig. 1). A better characterization of non exponential relaxation can be obtained by the relaxation rate S (t) = d(T=T_0)=d(lnt). T (t)=T_0 can be written in terms of a distribution of relaxation times P (ln) as

$$\frac{T(t)}{T_0} = \int_{\ln_0}^{L_1} P(\ln) \exp(t - d\ln; (1))$$

where $_0$ is the microscopic time. Since P (ln) varies slowly with we replace the exponential by a step function, from what we deduce S (t) = P (lnt) [14]. Like in

spin glasses there is a \hom ogeneous" broadening and shifting of the relaxation peak with t_p (see Fig. 1-(b)). However, since our system eventually reaches therm odynamic equilibrium at $T_0 + T$ for su ciently long t $_p$ [7], aging is then interrupted [15].

Non exponential relaxation can be tted by a $T = T_0$ \stretched exponential" exp [(t=)] [6], while the relaxation rate S(t) can be tted_p by a Gaussian distribution in Int: G(Int) = $(1=\frac{1}{2} \times 1) \exp(\ln^2(t=m)=2\pi^2)$, centered on $\ln m$ and with a width w. Indeed, the logarithm ic derivative of a stretched exponential d (exp ((t=)))=d (ln t) is alm ost a Gaussian with m and 1=w , as shown in Fig. 1. The same w can also be extracted directly from S (t) curves as the width at half height.

W hile the stretched exponential has no known justi – cation other than phenom enological [1, 3], C astaing and Souletie [16] argued that a G aussian distribution in lnt can be justi ed in a fram ework that associates a hierarchical criterion and a usual scaling approach in the renormalization of distances. Similarly to turbulence they use a cascade of events to relate the macroscopic and microscopic scales. A fler iterating the renormalization group dynamical scaling takes the form $=_0$ ($=_0$)^z, where z is the dynamical exponent. The time scale distributions are log-normal: P (ln) G (lnt) is G aussian.




FIG.3: B im odal relaxation with redistribution of the spectral weight and saturation for t_{eq} 10² s for the spin-Peierls compound SP-PF₆. The values of t_p are indicated on the gure

The variance w^2 scales with the most probable value $\ln (t=_{\rm m})$ [17] following the central limit theorem . It is dem onstrated in Fig. 2 for SDW -PF6 in therm odynam ical equilibrium [9] for three tem peratures chosen below 0:5 K. This yields im mediately the tem perature depenт, dence of the stretched exponential exponent (T) 1=w $1=\frac{1}{\ln m}$ (Fig. 2b), so that $\ln m$ 1=T as indicates a therm ally activated process with activation energy $E_a = 1.7$ K. At this point we do not intend to go deeper into the di erent models related to (T) for T ! 0 (see ref. 6 and references therein). W e stress that the w² In m scaling is quite convincing in the range of interest, and also for TaS3, a prototype CDW system, for which as well as for SDW -PF₆ a glass transition has been found at higher T [10].

However, in the case of $SP - PF_6$ [9] heat relaxation, while still non exponential, exhibits quite di erent properties. Instead of the hom ogeneous broadening and shift of the spectra of $SDW - PF_6$ as in a real \aging" effects, $SP - PF_6$ demonstrates \discrete bands" of relaxation times. Their distributions are narrower and the relaxation times are smaller than in $SDW - PF_6$ (i.e. saturation of aging is reached within a few tens of m inutes as compared to days in rst system at a similar T). Fig. 3 shows a bim odal redistribution of the relaxation spectrum indicating that heat perturbation m odi es di erent parts of the spectrum in contrast to the hom ogeneous shift of the entire spectrum as in Fig. 1.




FIG. 4: a) An \inverted" A mhenius plot, 1=T vs. log m, obtained for the relaxations in them odynam ical equilibrium of the spin-Peierls com pound SP-PF₆, together with a representation of corresponding relaxation rates for slow and fast processes and their ts, with $E_{a;s} = E_{a;f} = 1.0$ K b) The w² ln m scaling does not work for the total relaxation, how ever it m ight work for each deconvoluted process.

Even in therm odynam ical equilibrium the S (t) curves are not symmetric, indicating at least two di erent relaxation processes. However the total w (Fig. 4) can be obtained, but the variation w^2 ln m is very peculiar. We have successfully deconvoluted S (t) in two dynam ically distinct G aussian contributions, represented by dashed lines in Fig. 4a. At higher T, the fast contribution plays the dom inant role in the dynam ics, but the

relative weight of slow modes in the dynamics grows on decreasing the temperature. A similar behavior occurs at a xed temperature if we change the duration t_p of the heat perturbation (Fig. 3). There is an evident weight transfer from one to the other subsystem as therm odynamic equilibrium is approached. However, without the fast entities, there would be almost no response within 10^2-10^3 seconds at the lowest T. The distribution of fast modes is pushed to 10^3 seconds at 85 m K, and the apparent activated behavior (Fig. 4a) turns into a saturation indicating possible tunneling e ects (not included in Fig. 4).

There are drastic consequences on the proper de nition and determ ination of the speci cheat C_p in these systems as it becomes strongly nonlinear [8]. From the deconvoluted entities in therm odynamic equilibrium (Fig. 4a), it is possible to calculate the corresponding C_p , fast and slow. Their participation changes progressively from approximately 100 % for the fast modes at 650 mK to alm ost 90% for the slow modes below 400 mK.

It appears that the incom mensurate CDW compound o-TaS₃ shares all its properties related to the shift of the dynamics with SDW $-PF_6$. Both are nom inally <u>incommensurate</u> systems. On the other hand, (TMTTF)₂Br shares its multimodal dynamics properties with $SP - PF_6$ [9]. $(TM TTF)_2Br$ being the brother compound of $SP - PF_6$ is a <u>commensurate</u> antiferrom agnet. We conclude our Letter by proposing an explanation to these distinctly di erent dynamics. The models generalizing R efs.[18, 19, 20] are investigated in more details in R ef. [21].

As proposed by Larkin [18] and Ovchinnikov [19], the local deform ations of the DW in the strong pinning lim it are bisolitons, obtained by minimizing the elastic and pinning energies, and characterized by a ground state at energy E_0 , separated from another state at energy $E_0 + E$ by a \bounce" state at energy $E_0 + V$, therefore de ning an e ective two-level system . A s a qualitative di erence between com m ensurate and incom m ensurate system s[21], one has E = 0 in the commensurate case [22] and E > 0 in the incom mensurate case, so that the populations of the e ective two level system does not couple to temperature variations in the commensurate case. W e suggest here that, in addition, the degeneracy of the classical ground state in the commensurate case is lifted by quantum uctuations that restore a nite heat response. The long time dynamics in the incommensurate case is due to collective e ects, as suggested by the w^2 In m scaling on Fig. 1, in agreem ent with Ref. [21]. The issue of the long time dynam ics in the commensurate case, involving both quantum and collective e ects, is mainly an open theoretical question.

To explain why the spectrum of relaxation time is bim odal in the commensurate case we note that experimentaldata suggest that in the commensurate system there exist two entities that relax with approxim ately the sam e energy barrier but with values of the \m icroscopic tim e" di ering by one order of magnitude. Possible candidates for these two entities would be (i) the dipole solitonic excitations generated by the strong pinning impurities; and (ii) self-induced disorder due to 2 -solitons between m icro-dom ains separating the two spin-Peierls ground states. A lternatively one may observe that $SP - PF_6$ has a charge gap $_{\rm C}$ ' 200 K coexisting with a spin gap s ' 20 K, deduced from the spin-Peierls transition tem perature from the mean eld approximation. The coherence length in the charge channel $_{\rm C}$ = $_{\rm VF}$ = $_{\rm C}$ ' 10a $_0$ is thus much smaller than the coherence length in the spin channel $_{\rm S}$ = $\sim v_{\rm F}$ = $_{\rm S}$ ' 100a₀ (where a₀ is the lattice parameter and v_F the Fermi velocity). The two channels are weakly coupled so that the charge soliton, being smaller, relaxes faster than the spin soliton. The pinning potential and thus the energy barriers are identical in the two sectors so that the activation energies are identical but the m icroscopic times are dierent, in agreem ent with Fig. 4.

In conclusion we have shown manifestations of correlated objects interpreted as the collective dynamics of a disordered soliton lattice inherent to the modulated electronic ground state of DW. We demonstrated that a simple scaling feature of the parameters of the relaxation time distribution is well obeyed for the hom ogeneously broadened response for incom mensurate systems. By contrast the heat response of commensurate systems is bim odal. We stress that our results should be also compared to other experiments on the dynamical heterogeneity in the relaxations of supercooled liquids or spin glasses [24, 25, 26], and to the case of bim odal relaxation [23] observed in a fragile glass former at the approach of a glass transition. However, the microscopic picture is di erent, in spite of a similar phenomenology.
