Dynamics of porcelastic laments

We investigate the stability and geom etrically non-linear dynam ics of slender rods m ade of a linear isotropic porcelastic m aterial. D in ensional reduction leads to the evolution equation for the shape of the porcelastica where, in addition to the usual terms for the bending of an elastic rod, we nd a term that arises from uid-solid interaction. Using the porcelastica equation as a starting point, we consider the load controlled and displacem ent controlled planar buckling of a slender rod, as well as the closely related instabilities of a rod subject to twisting m om ents and com pression when em – bedded in an elastic m edium. This work has applications to the active and passive m echanics of thin lam ents and sheets m ade from gels, plant organs such as stem s, roots and leaves, sponges, cartilage layers and bones.

1 Introduction

Poroelasticity is the continuum theory used to describe the behaviour of a biphasic material in which uid ow is coupled to the elastic deformation of a solid skeleton (see Selvadurai (1996), W ang (2000) and references therein). The rst applications of this theory were to geological problems such as consolidation of saturated soil under a uniform load (B iot 1941). Since then the theory has grown to cover many and varied applications, some of which are displayed in Table 1.

If a medium having interstitial uid of viscosity is forced to oscillate with a characteristic time $\,$, the Stokes' length of the motion, $L_S =$, w ill characterise the range of in uence of the solid into the uid. If Ls l_o (the pore length scale) the uid within the pores moves out of phase relative to the solid. On the other hand, if L_S 1, the uid will only move relative to the solid when the volum e fraction of solid m atrix changes locally. This lim it l_p) was rst considered by Biot (1941) for an isotropic porcelastic (Ls m aterial. Later work using averaging techniques led to equations of the sam e form as well an understanding of how the microstructure of the material in uences the constitutive equations of the material (Auriault & Sanchez-Palencia 1977, Burridge & Keller 1981, Mei & Auriault 1989, Lydzba & Shao 2000).

W hereas geological applications are concerned primarily with bulk behaviour, many engineering, physical and biological applications have extrem e geometries which allow for the application of asymptotic methods to reduce the dimension of the problem. Some examples include the active and passive mechanics of thin laments and sheets made of gels, plant organs such as stems, roots and leaves, sponges, cartilage layers, bones etc.

In this paper we use the constitutive behaviour of a linear isotropic porcelastic solid to investigate the stability and dynam ics of slender rods m ade of this m aterial. In x2 we give a physically m otivated derivation of the constitutive equations for a porcelastic material. In x3 we use the bulk porcelastic constitutive equations to determ ine the equation for the time dependent bending of a slender porcelastic rod subject to an externally applied compressive force P. D in ensional reduction leads to the equation for the porcelastica, where in addition to the usual terms due to the bending of an elastic rod we nd a term due to the uid resistance. It arises from the uid-solid interaction and has a form similar to that in a Maxwell uid (Bird, Arm strong & Hassager 1987). In x4 we solve the problem of load controlled buckling. Although the porcelastic nature of the material does not change the buckling threshold or the nal stable shape, it governs the dynamics of the system as it evolves from the unstable to the stable state. Both the short and the long time lim it are investigated investigated using asym ptotic methods. We then use numerical methods to corroborate our asymptotic approaches and follow the non-linear evolution of the porcelastica. In x5 we treat the problem of displacement controlled buckling and compare the results of the porcelastica with those of the classical elastica under sim ilar loading conditions. In x6 we consider the linear instability of a slender porcelastic lament em bedded in an in nite elastic medium, when it is subjected to an axial twisting moment and an axial thrust. Finally,

in x7, we sum m arise our results and discuss possible applications to such problem s as the m echanics of cartilaginous joints and rapid m ovem ents in plants.

2 G overning equations for poroelastic m edia

W e begin with the equations for a hom ogeneous, elastic isotropic poroelastic m aterial in the lim it where the Stokes' length, $L_s = \frac{p}{1 - 1}$ is much larger than the system size l_m and further that l_m is much larger than the pore size l_p . W e will also neglect inertial e ects in the solid and liquid phases. In this lim it the viscous resistance to uid ow in the pores is balanced by the pressure gradient so that the momentum balance in the uid yields

where v is the uid velocity with characteristic scale V, is the uid density, r and r $_{\rm l_p}$ denote gradients on the system scale and the pore scale respectively, p is the macroscopic pressure driving the ow, and p_p is the microscopic pressure in the pore. W hen the pore scale and system size are

well separated $(l_p=l_m 1)$ (2.1) gives the following scaling relations

Thus the dom inant contribution to the uid stress in the medium arises from the pressure. The simplest stress-strain law for the composite medium then arises by considering the linear superposition of the dom inant components of the uid and solid stress tensor. A ssum ing that the elastic behaviour of the solid skeleton is well characterised by Hookean elasticity (i.e. the strains are sm all), we can write the following constitutive equation for the poroelastic medium (see Appendix A for a derivation using the method of multiple scales):

Here is the stress tensor, u is the displacement eld, $e = (r u + r u^T)=2$ is the linearised strain, and are the eld ective Lame coeccients of the material (dependent on the material properties and the microstructure), is related to the uid volume fraction, but includes a contribution from the pressure in the surrounding uid (see Appendix A), and I is the identity tensor in 3 dimensions. These material parameters can be derived using microstructural information (see Appendix A). In the limit when inertia can be neglected, the equations of equilibrium are

M ass conservation and continuity requires that the rate of dilatation of the solid is balanced by the di erential motion between the solid and uid in a porcelastic solid. This yields (see Appendix A for a derivation using the method of multiple scales)

where the solid skeleton is composed of a material with bulk modulus $(+ 2 = 3 \text{ since the lame coe cients} and are for the composite material and take into account the microstructure, while <math>^1$ is independent of the microstructure) and k is the uid permeability tensor of the solid matrix. In words, (5) states that the ux of uid into a material element is balanced by the change in solid volume due to the bulk compressibility of the matrix. For a rigid incom pressible skeleton, = 0. We will assume that the solid skeleton is isotropic so that k = kI; how ever, many structured




Figure 1: Schem atic diagram of (a) a bent rod, where (x) is the angle between the deform ed and undeform ed tangent vector, x; y and z are bodyxed coordinates in the reference fram e of the rod; (b) the circular cross section.

and biological materials are an isotropic and one may need to revisit this assumption. Equations (3), (4) and (5) when subject to appropriate boundary conditions describe the evolution of displacements u and uid pressure p in a porcelastic medium. The typical values of the parameters for a soft gel are 1, $10^{12} \text{ m}^2 = \sec P a$.

3 Equations of motion for a slender lament

We consider a naturally straight slender circular rod of length L and radius R L with a tangent to the centre line that makes an angle with the horizontal (see Figure 1). At its ends an axial force P is applied suddenly at time t = 0. We will further assume that the lateral surfaces of the

lam ent are free of tractions. This assumption could break down when the solid m atrix is very dilute, so that interfacial forces become comparable to the internal forces in the lam ent, but we will not consider this case here. The slenderness of the lam ent in plies that the axial stresses vary rapidly across the cross-section and much more slow ly along it, so that we can use an averaging procedure to deduce low -dimensional equations that describe the motion of the lam ent. This long-wavelength approximation can be form alised using an asymptotic expansion in the aspect ratio of the lam ent R=L 1. Here, we will proceed directly by noting that since the rod is slender, bending it is easier than stretching or shearing it (Love 1944). At the level of scaling, geometry in plies that the out-of-line (bending) displacement of the centre line scales as R while the axial displacement scales as R²=L.

At the surface of the lament no stress is applied. Since the lament is thin this implies that yy = zz = 0. For a displacement eld $u = (u_x; u_y; u_z)$ equation (3) yields

Equations (3) and (8) give the axial stress

M ore speci cally, when an in nitesim al axial element of the rod of length dx is bent so that locally the centreline curvature is Q_x , bres that are parallel to the neutral axis (coincident with the centre line for a hom ogeneous circular cross-section) and at a perpendicular distance y from the neutral plane (de ned by the neutral axis and the axis of bending) will be either extended or contracted by an amount yQ_x dx, so that the elastic strain $Q_x u_x = yQ_x$. This leads to an elastic stress that varies linearly across the cross-section; in addition there is a uid pressure that is determined by (5). We insert (8) into (5) and nd the evolution equation for the uid pressure

To make the equations dimensionless we use the following de nitions for the dimensionless primed variables:

and the immediately drop the primes, referring exclusively to dimensionless variables from now on. We note that the axial stress, the compressive force




Figure 2: Schem atic of the local torque balance in a bent rod under an externally applied compression P. We balance torques about the point O, x;y and z are the coordinates in the body- xed fram e with O as the origin. Let M (x) denote the total m om ent due to internal stresses generated in part by bending the elastic skeleton and in part by the uid pressure eld. Balancing torques gives: M (x + dl) M (x) + dl P = 0. In the limit dl ! 0, $@_xM + P \sin = 0$. The total m om ent M = $E_pI@_x + pydA$, where E_p is the elastic modulus of the porcelastic skeleton and I is the m om ent of inertia of the cross section.

and the pressure are scaled to re ect the dom inance of bending deform ations over all other m odes, and the time is scaled to re ect the dom inance of radial di usion over axial di usion.

Then the stress in the lament, given by equation (9), can be written in dimensionless form as

Here, the rst term rejects the purely elastic contribution well known from the theory of beams (Love; 1944), while the second term is proportional to the uid pressure in the pores. The dimensionless parameter $=\frac{4}{(2+3)[(+)+2]}$ 0 (1) for most materials denotes the ratio of the uid and solid stress.

In the long wavelength approximation, it is preferable to use the stress resultant $F = \sum_{xx} dA$ and the torque resultant $M = \sum_{xx} dA = \sum_{xx} dA + \frac{1}{4}$ ypdA = $M_e + M_f$; as the variables of interest. Here M_e is the elastic torque and M_f is the uid torque that arises due the transient elects of a pressure gradient across the lament. Then, local force and torque balances, which can be derived from (3), (4) and (9), or equivalently directly (Figure 2), yield the dimensionless equations

The rst of these equations can be integrated in m ediately to yield F = P with P a constant determined by the boundary conditions. The second equation combines the e ects of the elastic and uid stresses that arise due to the uid pressure, and requires the solution of the continuity equation (10). For a rod with a circular cross-section, there is rotational symmetry in the problem . Choosing the the axis of bending to coincide with the z axis, we rewrite (10) in polar coordinates (r;) using dimensionless variables as

We see that the pressure in the uid arises from the extensional and compressional stresses in the lam ent due to bending. The boundary conditions for the pressure can be deduced using the following considerations: (a) the centre line of the rod does not su er any deform ation, and is sym metrically disposed, and (b) the pressure at the surface is determined by the permeability of the surface layers and the ux through it. Then

where $Bi = \frac{R}{k}$, and characterizes the ux through the surface for a given pressure drop (the am bient external pressure is assumed to be zero). The second boundary condition in (15) on the pressure states that the ux of uid through the surface is proportional to the pressure drop across the surface. Bi = 1 corresponds to a freely draining rod, where there is no pressure jump across the surface, and Bi = 0 corresponds to a jacketed rod, which allows no ux through the surface. For a sponge, $B \ge 1$, while for a plant (root, stem or leaf) Bi < 1 since it is designed to retain water.

Expanding p in terms of the hom ogeneous solutions of (14), we write

where A_{mn} and B_{mn} are constants, J_m is the Bessel function of orderm, and $_{mn}$ is determined by the boundary conditions. Inspection of the inhom ogeneous term on the RHS of equation (14) yields m = 1 so that $A_{1n} = A_n$, $B_{mn} = 0$, and $_{1n} = _n$. Since the boundary condition is a linear combination of p and e_rp we are guaranteed to have a complete basis. We therefore look for a solution to the inhom ogeneous equation (14) of the form


Then (12) allows us to write the total axial stress $_{xx}$ at a cross-section as

where $_{n} = \frac{R_{1}}{n} r^{2} J_{1} (r^{p} - n) dr$. Substituting the result into the equation for torque balance (13) yields the dimensionless equation for the porcelastica (see Figure 2)



F igure 3: M echanical analogue of the bending resistance of a porcelastic rod. For rapid displacements, the dashpot will not move and the uid resistance due to the instantaneous pressure yields a response similar to a sti (uid) spring in parallel with an elastic spring. Eventually the dashpot will move to relieve the stress in the spring and the uid resistance gradually decays, leading to a purely elastic steady state.

The rst two terms correspond to the usual terms in the classical elastica (Love 1944) for the bending of a rod with a circular cross section, while the nalterm is due to the instantaneous uid pressure not being equilibrated across the cross section. The in uence of the uid is to create a material with \mbox{memory} , so that the current state of the lament is determined by its entire history. The kernel in the memory function for the uid resistance is e n (t t⁰) so that the uid resistance is analogous to that of a M axwell uid (B ird, A rm strong and H assager 1987) with relaxation times 1 = n which measure the rate of decay of the lament e_{xt} . A mechanical analogue of the resistance of a porcelastic lament is presented in Figure 3 and shows the connection to simple viscoelastic models.

The dynam ics of a porcelastic rod are then determ ined by the solution of the equation for local torque balance (26), subject to the boundary condition on the uid pressure at the surface (18) which determ ines the decay constants $_n$, and additional boundary conditions on the ends of the rod, which we now consider in some speci c cases.

4 Planar load controlled buckling

W hen an initially straight rod that is simply supported at either end is subject to a constant compressive force P applied suddenly at t = 0, the boundary conditions at the ends are

The complete time evolution of the rod is then given by the solution of the integrodi erential equation (26) subject to the boundary conditions (27), the initial conditions (28) and the condition (18) which determ ines the rate constants $_{\rm n}$.

4.1 Short time behaviour, t 1

Expanding the solution about the initially straight state = 0, we write

Here the separation constant $= (P ^{2}) = ^{2}$ is the relative di erence between the applied load P and the dimensionless buckling load, $P_{c} = ^{2}$ for a purely elastic rod that is simply supported at its ends. The function f (t) satis es




Figure 4: G row th rate s of the de ection as a function of the dimensionless external load P; $P_c = {}^2$ is the critical compression above which a simply supported purely elastic rod buckles. Here the surface permeability param – eter $B \doteq 0.1$. When $\frac{P P_c}{P_c} = \frac{1}{4}$ the grow th rate becomes in nite and one must consider inertial e ects, which are neglected here. For comparison, we show the numerical results obtained by solving (26) with initial conditions (0) = 0.001 cos x, (dt) = 0.001 edt cos x, where s is the theoretically calculated exponent, with dt = 0.001, dx = 0.01.

The grow th rate at the onset of the dynam ic buckling instability is therefore given by the largest s that satis es (35). In Figure 4, we plot the grow th rate s as a function of the rescaled external load $- = \frac{P}{P_c}$, with $P_c = 2$, obtained by solving (32) and (35). When s < 0 we do not have an instability, corresponding to the case when $P < P_c$. In the porcelastic regime, when $P_c < P < P_c(1 + \frac{1}{4})$, uid ow s across the lament in response to the stress gradient in the transverse direction, and the phenom enon is qualitatively di erent from the buckling of a purely elastic rod. Since the time it takes uid to ow across the lament is longer than it takes a bending wave to propagate the length of the lament, porcelastic buckling is sometimes called creep buckling (B iot 1964).

We now turn to the dependence of the buckling transition on the surface permeability parameter Bi. Substituting a pressure eld of the form $p(x;r; ;t) = h(r) \mathfrak{G}_x$ (x) sin e^{st} and $= e^{st}$ (x) into (14) yields

Thus (36) yields $\lim_{s! 0} h = 0$ and $\lim_{s! 1} h = r$ corresponding to the case of in nitely slow and in nitely fast grow th rates respectively. Consequently, for in nitely slow buckling the uid supports no load. In the case s! 1




Figure 5: The radial variation of the uid pressure at the onset of buckling, h(r), (a) for grow th rate s = 1 and various values of the surface perm eability parameter Bi (larger Bi corresponds to a more perm eable surface) and (b) for Bi = 1 and various s.

near r = 1 a boundary layer emerges where the internal solution (h = r) is matched to the boundary condition (37) at r = 1. Balancing the rst two terms of (36) the length scale of the boundary layer l_{bl} $1 = \overline{s}$ or in dimensional terms l_{bl} $\frac{(+)k}{s[(+) + 2]}$.

To complement these asymptotic results, we solve (36-37) numerically and plot the radial variation in the pressure. In Figure 5a we show h(r) for s = 1 and various Bi and in Figure 5b we show h(r) for Bi = 1 and various s. As expected, we see that as the surface permeability increases (i.e. Bi increases) for a given grow the rate of the instability (corresponding to a given bad) the pressure variations across the lament decrease. On the other hand, as the grow the rate increases, a boundary layer appears in the vicinity of the free surface of the rod to accome modate the slow permeation of uid in response to the stress gradients.

Having considered the onset of porcelastic buckling we now turn to the

transition from poroelastic to inertial dynam ics which occurs for very large compressive loads when the uid cannot move rapidly enough to keep up with the elastic deform ations. For large s the condition that determ ines the grow th rate (35) reads

We have computed $P_{n-n} = 1=4$ for integrals of Bessel functions. U sing the de nition of the separation constant = $P=P_c$ 1 we solve equation (8) for the growth rate:

show ing that it indeed diverges when $\frac{P - P_c}{P_c}$! $\frac{1}{4}$ consistent with Figure 4.

4.2 Long time dynam ics t 1

In the long time limit 1, i.e. when the uid has enough time to di use across and along the lament, the shape of the lament approaches that of the ideal elastica. To capture the dynamics of this process, we linearise (26) about the steady state solution by letting




Figure 6: As the solution approaches the equilibrium shape the di erence between the current and equilibrium shape decays exponentially with a rate , which is plotted against the applied compression. = 1, Bi = 0.1, dx = 0.01, dt = 0.01. The num erical computation is begun with $= 0.9_0$.

W e observe that the poroelastic solution approaches the elastic steady shape exponentially fast at late times. In Figure 6, we plot the exponent = 1 = (1 + 1) versus (P P_c) = P_c and see that the larger the value of P the faster the solution approaches the nal shape.

4.3 Interm ediate tim e dynam ics

For interm ediate times we have to solve for the shape of the porcelastica num erically. Our arguments in the previous section allow us to neglect the contributions from the higher modes so that a good approximation to (26) is given by

For ease of solution, we convert the integrodi erential equation to a partial di erential equation by multiplying (47) by e^{1t} and di erentiating with respect to time, so that




Figure 7: (0;t) for P = 11, = 1, $B \doteq 0.1$, dx = 0.01, dt = 0.001 and $(x;0) = (x;dt) = 0.01 \cos x$. The short time asymptotic is for a growth rate s(P) found from equation (35). The long time asymptotic is of the form A e t + 0, where is the rate of decay to the equilibrium angle 0, and A is a tting parameter.

We solve equation (48) subject to the boundary conditions (27) using a C rank-N icolson nite di erence scheme in space and we extrapolate the non-linearity using the previous two time steps. This gives us a scheme with second order accuracy in time. For a time step dx = 0.01 and a space step dt = 0.001 the di erence between the num erical and analytical initial grow th rate is 0.2% (see Figure 4). In Figure 7 we show the variation of the angle (0;t) determ ined using the num erical simulation for the case when the dimensionless buckling load is slightly larger than the threshold for the porcelastic buckling, with (P P_c)=P_c 0:17. For comparison, we also show the asymptotic solutions for short and long times determ ined in the previous sections, and nd that they agree well with the num erical solution. To determ ine the shape of the lament we use the kinem atic relations




Figure 8: Shape of the buckling lament X (t), Y (t) for P = 11, in the laboratory frame as a function of time for P = 11, = 1, B \doteq 0.1, dx = 0.01, dt = 0.001 and (t = 0) = (t = dt) = 0.01 cos x.

where X (x;t) and Y (x;t) are the position of the centreline. Figure 8 shows the shape of the lament as it evolves from the initially unstable straight shape to the nalelastic equilibrium via a transient overdam ped route. In sharp contrast, a purely elastic rod subject to the same initial and boundary conditions would vibrate about the nalestate forever (in the absence of any dam ping).

5 D isplacem ent controlled planar buckling

In many problems involving instabilities, there is a qualitative di erence between load controlled and displacement experiments. To understand the di erence we consider the problem of displacement controlled buckling of a porcelastic lament and compare the results with those of the previous

section. Since the centre line of the lam ent is assumed to be inextensible, the change in the end-to-end distance is given by

to allow us to ramp up the displacement to a maximum amplitude max at a characteristic rate $\frac{1}{2}$ max. The shape of the porcelastica is now determ ined by the solution of (48), (50) and (51); the unknown load P (t) is now determ ined at every time step by using an iteration method to enforce (50). For an initial guess to start this procedure, we note that after the onset of buckling when P > P_c, for sm all amplitudes = cos x (1) is a solution of (48) and (27). Substituting into (50) gives




Figure 9: $\frac{P}{P_c}$, where P is the load and P_c is the critical load required for buckling, corresponding to a change in end to end displacement (t) 0:1[1+ tanh at], for various a. For some later times the more quickly applied displacement corresponding to larger a requires a lower compressive force. The graphs correspond to the following parameter values: dx = 0:01, dt = 0:002, B \doteq 0.1, = 1, (3) = (3 + dt) = 2 (3) cos x.




Figure 10: Maximum compressive load, P_{max} , for displacement controlled buckling, where the displacement eld is given by (t) 0:1[1 + tanh at]. Bi = 0.1, = 1, dt = 0:01, dx = 0:01.

C om paring this with the short time behaviour of a porcelastic lam ent considered in x44.1 we see that exponential grow th of sm all angles corresponds to a constant compressive force seen in Figure 9. A similar argument holds for late times, when the system relaxes to its purely elastic equilibrium. For intermediate times, the load can be larger than that for the case of a purely elastic lam ent. The di erence in the loads is due to the uid resistance in the porelastica. A way of visualising this is shown in Figure 10. For slow ly applied displacement elds P_{max} is alm ost the same for the elastic and

porcelastic cases; how ever, for rapidly applied displacements, corresponding to large values of a, the compressive force in the porcelastic case is larger due to uid resistance arising from the pressure gradients across the bending lament.

6 Filam ent embedded in an external medium and subject to axial torque and axial thrust




Figure 11: Schem atic diagram of a rod buckling under an applied twist and compression in an external medium. Y (x;t) and Z (x;t) are the displacements of the centre line in the y and z directions respectively. The dotted line denotes the axis of symmetry.

We nally turn to the case of a rod embedded in an external medium subject to an axial moment, K, and a compressive force P (see Figure 11). The presence of the twist causes the instability to become non-planar, and the

lam ent adopts a helical conform ation; the presence of an external medium typically causes the instability to manifest itself with a higher wave number than otherwise. Letting the displacements of the centre line in the y and z directions be Y (x;t), Z (x;t) respectively, we scale the kinematic variables accordingly to de ne the dimensionless displacements

Hookean solid. In light of the analogy between linear elasticity and Stokes ow, we can use the results of classical slender body theory in hydrodynam ics (B atchebor 1970, C ox 1970) and write the vector of dimensionless external forces on the lament as $F_{external}^{0} = (0; EY=4; EZ=4)$, where the dimensionless parameter E is given by

where $_{m}$ is the Lam e coe cient of the surrounding medium. This approximation is valid when R=L 1, a condition consistent with the geometry of a thin lam ent. W e will further assume that the lam ent is free to rotate in the medium, i.e. there is no torque resisting this mode of motion, which varies in any case as R² and is thus negligible in most situations.

To derive the evolution equation for the shape of the lam ent we use the constitutive equation (3) to write down equations for the balance of forces in the y and z directions as for the planar lam ent. A fler dropping primes this leads to

where, since equation (14) is linear, we have superposed the two solutions for bending in the y and z directions. Taking = Y + iZ equations 5(7)

which is the same as equation (45) for the temporal part of the solution for planar buckling. Thus, once the separation constant is found, equation (35) yields the growth rate s(P;K;E;;Bi) as a function of the loading parameters and the material constants (see Figure 4).

As an example of how the in uence of an external medium can lead to higher modes becoming unstable at lower compressions than the fundam entalmode we consider equation (61) in the case K = 0

W e see that the critical buckling load for a given mode number n increases as the stiness of the environment E increases. Furthermore, for large E ,




Figure 12: For the case of an applied compression P and axial twisting moment K, we show the three short time regimes (stable, porcelastic, and inertial) as in Figure 4. E = = 1.

the chosen m ode shape does not correspond to the fundam entalm ode n = 1, since $@P_c = @n = 0$ yields $n = \frac{1}{2}E^{1=4}$ for an in nite rod. Physically this occurs because short wavelength m odes do not deform the sti elastic environm ent as much, while the penalty associated with a higher curvature is not too much of a price to pay.

For the case when K \notin 0, we cannot solve the eigenvalue problem analytically, and present the results using a phase diagram shown in Figure 12. We not three distinct regimes: for s < 0 the system is stable; for 0 < s < 1 we have the porcelastic regime where the system buckles on the same time scale as the uid pressure di uses; nally, we have the elastic regime where the system buckles so fast that the uid does not move and all the deformation occurs in the solid skeleton.

7 D iscussion

The usefulness of porcelastic theory is limited to a range of time scales. The porcelastic time scale associated with decay of pressure elds is $p = \frac{2R^2}{k}$, recalling that is the uid volume fraction, R is the smallest macroscopic length scale of the system (R $\frac{1}{p}$), is the elective Lame coelient of the composite material, and k $\frac{\frac{1}{p}}{2}$ is the matrix permeability. If the time scale of the forcing, p the uid will not move relative to the solid and Hookean elasticity and the elects of inertia are su cient to describe

the system adequately. If p, the uid pressure will equilibrate with the surroundings and once again classical elasticity su ces to describe the system, albeit with di erent Lame coe cients. However, if p the dynam ics will be governed by porcelasticity.

Biological systems are composed mainly of uid, so porcelasticity will be applicable at some time scale (see Table 2 for estimates). Furtherm ore, they are characterized by extrem e geom etries (e.g. beam s, plates and shells), which led us to consider in detail the dynam ics of slender porcelastic objects, and particularly the buckling of a planar lament. Biological materials are usually an isotropic and we expect the permeability and elasticity tensors to re ect this feature. Taking k1 to be the perm eability in the axial direction, we can neglect axial di usion if $\frac{k_1 R^2}{k_1 L^2}$ 1. The opposite lim it, where $\frac{k_1 R^2}{k_1 L^2}$ 1, has been studied by Cederbaum et al. (2000). The dynam ical behavior of these objects is separated into two di erent regimes, one governed by fast inertial e ects, and the other by the slow dynamics of uid ow. These regim es are of course well known in bulk materials (Biot 1957), but here they appear in a slightly di event guise due to the e ect of the slender geometry of the system. The onset of planar porcelastic load controlled buckling was rst considered by B iot (1964). In this paper we broaden and deepen the understanding of this phenom enon. An important outcom e of our studies is the porcelastica equation, which is a simple integro-di erential equation with one time constant that describes the dynamics of a porcelastic

lam ent under a compressive load. The bending resistance of the lam ent is analogous to a (ctional) M axwell m aterial, where the time constant is the rate at which the pressure eld decays (determ ined by the m aterial param eters and the geometry). We then used this equation to study not only the onset of buckling, but also the entire dynam ics up until saturation for both load controlled and displacem ent controlled buckling.

A series of three-point-bending experiments (Scherer 1992; Scherer 1996) have shown that the mechanical response of a silica gel rod immersed in acetone or ethanol can be described using porcelastic theory. The theory developed by Scherer (1992) applies only to situations where the displacement is applied much faster than the porcelastic time scale and is a special case of the more general theory presented in this paper. The lack of experiments on slender porcelastic laments being deformed on the porcelastic time scale prevents us from testing our predictions quantitatively. Since our results are relevant to swollen polymer networks, gel actuators and sensors, the mechanics of cartilaginous joints, and the physics of rapid movements in plants, an important next step is the quantitative experimental study of

*Appendix A : Derivation of the porcelasticity equations

The derivations of the equations of porcelasticity have been m any and varied. Partly this has been because several qualitatively di erent parameter regim es containing distinct leading order force balances exist. We focus here on the equations which govern the second row of Table 1, namely where the Stokes' length is much larger than the pore size, i.e. L_s lp. The m ethods used to derive equations for this region of parameter space can be classified into three categories: physical argum ents and superposition (B iot 1941, B iot & W illis 1957), m ixture theory (B arry & Holm es 2001), and m icro structural derivations (A uniault & Sanchez-Palencia 1977, B unridge & Keller 1981, M ei & A uniault 1989). First, we show in detail a version of the m icro structural derivations, which uses ideas from both B unridge & Keller (1981) and M ei & A uniault (1989).




Figure 13: Typical porous medium illustrating the separation of length scales, where l_p is the pore scale and l_m is the system scale.

Equations (A-92), (A-98) and (A-99) are the equations of poroelasticity, identical in form to the equations written down by Biot (1941).
