A nalytic theory of correlation energy and spin polarization in the 2D electron gas

A bstract

W e present an analytic theory of the pair distribution function and the ground-state energy in a two-dimensional (2D) electron gas with an arbitrary degree of spin polarization. Our approach involves the solution of a zero-energy scattering Schrodinger equation with an elective potential which includes a Ferm i term from exchange and kinetic energy and a Bose-like term from Jastrow-Feenberg correlations. The form of the latter is assessed from an analysis of data on a 2D gas of charged bosons. We obtain excellent agreement with data from quantum M onte C arlo studies of the 2D electron gas. In particular, our results for the correlation energy show a quantum phase transition occurring at coupling strength $r_s = 24$ from the paramagnetic to the fully spin-polarized uid. D evelopm ents in techniques of m olecular beam epitaxy and chem ical vapor deposition have allowed since the m id 1970's the fabrication of sem iconductor structures in which the carriers can form a low-density uid moving in low dimensionality [1]. M any of the electron-electron interaction e ects become increasingly important as carrier density and dimensionality are reduced and the hom ogeneous electron gas – an assembly of fermions interacting by the $e^2 = r$ law and moving in a uniform neutralizing background – provides a primitive model for their study [2]. The model is characterized at zero temperature and magnetic eld by the carrier density or equivalently by the coupling-strength parameter r_s , which measures the mean interparticle distance in units of the B ohr radius a_B .

A crucial role in the theory is played by the particle pair distribution function g(r), which determ ines the groundstate energy of the assembly and hence its quantum phase diagram. This function has been the object of several num erical studies by quantum M onte C arb (QMC) m ethods, starting from the early work of C eperley and A lder [3] on the three-dimensional (3D) electron gas. In the two-dimensional (2D) case these studies have predicted the critical density for W igner crystallization at r_s 35 [4,5] and a weakly rst-order transition to a fully spin-polarized uid state at r_s 25 [6,7].

In a previous work we have presented an analytic theory of g(r) and other ground-state properties of the 3D electron gas [8]. The theory was based on a Ferm i hypermetted chain approximation (hereafter indicated by the FHNC/O acronym) and yields quantitative agreement with QMC data up to at least $r_s = 20$. The object of the present work is to extend the theory of g(r) and the correlation energy to the 2D electron gas. As we shall see, much higher sophistication is needed to attain a quantitatively useful theory in lowered dimensionality. We shall have to dwell on terms beyond the FHNC/O, which come from low-order elementary diagram s and from three-body Jastrow-Feenberg correlations. These e ects have been studied theoretically in boson uids [9,10] and it is natural within our theoretical scheme to draw on the 2D gas of charged bosons in dealing with the 2D gas of charged ferm ions. An important role will be played below by the new ly available QMC data on the 2D charged-boson gas [1].

O ur starting point is the energy functional E [n (r)] for an inhom ogeneous density pro le corresponding to the distribution of particles n (r) around an average particle. That is, n (r)= ng(r), where n = $(r_s^2 a_B^2)^1$ is the average particle density, and the corresponding "external" potential is v (r) = e^2 =r. As usual, the energy functional is the sum of an ideal kinetic energy term and of three potential energy term s given by the interaction with the "external" potential and by the H artree and exchange-correlation contributions. As in Ref. [8] we split the ideal kinetic energy functional into the sum of the von W eizsacker - H erring term (h²=8m) dr jr n (r) j² = n (r) and a residue T [n (r)], and m in ize the energy by m eans of the H ohenberg-K ohn variational principle. The result is a di erential equation for $p = \frac{1}{g(r)}$,

This equation is form ally exact and describes a zero-energy two-body scattering problem in the many-body uid, in accord with 0 verhauser's interpretation of g(r) [12].

In writing the "scattering potential" in the form used in Eq. (1) we are in plicitly thinking of the many-body wave function as the product of a Slater determ inant times a Jastrow-Feenberg correlation factor. The Ferm i potential W_F (r) derives from the functional derivative of T [n (r)] and from exchange, and would vanish in a Bose uid. The Bose-like potential W_B (r) contains the elects of correlations (including the long-range Hartree term) and by itself would determ ineg(r) in a Bose uid. We turn to the latter in order to assess the form of W_B (r).

2D uid of charged bosons. The FHNC/0 and its HNC/0 equivalent for a Bose uid take

where W_B (k) is the Fourier transform of W_B (r), de ned according to the general expression FT [F (r)] = $\binom{R}{R}$ n drF (r) exp (ik r). In Eq. (2) S (k) is the structure factor of the uid, de ned so that S (k) = 1 + FT [g (r) 1]. U sing Eq. (2) in Eq. (1) with W_F (r) = 0 and self-consistently solving Eq. (1) for g (r), we nd quantitative agreement with the QMC data of Ref. [11] at $r_s = 1$ and discrepancies already emerging at $r_s = 5$.

Improvements on Eq. (2) can be sought in two directions for a Bose uid [10,13]. The HNC may be transcended by the inclusion of low-order elementary diagrams, and three-body Jastrow-Feenberg correlations may be included. The contribution from the rst elementary diagrams to the elective Bose potential is

where $"_4$ (k) is given by a fourfold integral (in 2D) over m on entum space. The contribution of three-body correlations is given by a two-fold integral,

where p = (q + k), "(k) = $h^2 k^2 = [2m S(k)]$ and, with the denition X (k) = 1 S¹ (k), we have $v(q;p;k) = (h^2 = m) [k pX(p) + k qX(q) + p qX(p)X(q)]$ and

The papers of Sm ith et al. [13] and of A pa ja et al. [10] should be consulted for detailed derivations of these equations, in which $u_3(q;p;k)$ is the irreducible three-body vertex.

The elective scattering potential as self-consistently determ ined in these approximations for the 2D uid of charged boson at $r_s = 20$ is shown in Fig.1. In all cases the structure in g(r) which is present in the QMC data of Ref. [11] is underestimated at such strong coupling. We have therefore tried to take into account the higher-order term s that are missed in these approaches at strong coupling by assuming that they lead to corrections in the scattering potential that have roughly the same shape as the low-order term s reported above. In particular, we have found that the choice

leads to a satisfactory account of the QMC data on the 2D Bose gas. Here the parameter is determined by tting the QMC data on the ground-state energy [11] with a relative precision of 10³. This yields




FIG.2. The pair distribution function g(r) of the 2D uid of charged bosons as a function of distance r (in units of $r_s a_B$) at $r_s = 10, 20$, and 50. The theoretical results (full lines) are compared with QMC data by DePalo et al. [11] (dots). The dased lines show the results obtained in the HNC/0 scheme. The results have been shifted upwards by 0.4 and 0.8 for clarity.

The corresponding form of the scattering potential at $r_s = 20$ is also shown in Fig.1, while Fig.2 reports a comparison of our results for g(r) with the QMC data up to $r_s = 50$. We have clearly achieved fully quantitative agreement over this whole range of coupling strength. It may be remarked that nothing is to be gained by further increasing the relative precision of the t of the QMC ground-state energy, possibly because of errors due to the niteness of the QMC sample.

2D uid of charged fermions. We carry over Eqs. (4) and (6) in our calculations of the Bose-like term in Eq. (1) for the 2D electron gas. With regard to the Fermitterm W_F (r) in Eq. (1), we adopt the same criteria in determining its form as in Ref. [8]. An important requirement is that Eq. (1) should give the exact fermion fermion distribution function when one goes to the weak-coupling limit r_s ! 0, when g(r) becomes the Hartree-Fock pair distribution function g_{HF} (r). The Fermitterm in the scattering potential is then determined by the Hartree-Fock structure factor S_{HF} (k) according to

where = 1 denotes the electron spin, = $j_{h^{m}}$ $n_{\#} j_{=}n$ is the spin polarization, $k_{F} = \frac{p}{2} [1 + sgn()]^{j=2} = (r_{s}a_{B})$ and is the Heaviside step function. The rationale behind Eq. (8) is as in Ref. [8]: the rst term on the RHS ensures that the Hartree-Fock limit is correctly embodied into the theory, and the second and third term ensure that the Bose-like scattering potential is suppressed for parallel-spin electrons at weak coupling [14].

O ur num erical results for the pair distribution function of the 2D electron gas in the param agnetic state (= 0) and in the fully spin-polarized state (= 1) are compared with the QMC data of Ref. [15] in Fig. 3. We have clearly achieved fully quantitative agreement with the QMC data up to large values of the coupling strength r_s .

We can then con dently calculate the ground-state energy " $(r_s;)$ of the 2D electron gas as a function of r_s in these two states of magnetization, using an integration over the coupling strength according to the expression

(in Rydberg units). The results are compared with the QMC data of Attaccalite et al. [7] in Fig. 5. There cleary is a discrepancy with the data in the absolute values of the energy, but this a ects in essentially the same manner the two phases so that we nd a transition from the param agnetic to the fully spin-polarized uid at r_s 24, in excellent agreement with the QMC data. As to the nature of the phase transition, within the accuracy of our calculations it could be either a weakly rst-order one or a continuous transition occurring in an extrem ely narrow range of values of r_s . This is shown in Fig. 4, where we also report our results for the ground-state energy as a function of r_s at several values of the spin polarization .


C onclusions. In sum mary, we have presented a model which quantitatively predicts the two-body correlations in both the 2D charged-boson uid and the 2D electron gas using as the only input the QMC data for the ground-state energy of the boson uid as a function of the coupling strength r_s . The essential physical idea that underlies the model is that di erences arising from the statistics are disappearing as the ferm ionic or bosonic uid is brought into the strong coupling regime, where the C oulomb repulsions suppress close encounters of pairs of particles [16]. How ever, exchange between parallel-spin ferm ions must be properly accounted for in the weak-to-interm ediate coupling regime.

The model has allowed us to reproduce the quantum phase transition that has been found to occur in the QMC studies of the 2D electron gas, essentially starting from the basic C oulom b H am iltonian. W ithin the accuracy of our model the transition could be either a weakly discontinuous transition or a continuous one occurring in a very narrow range of coupling strength. The latter type of quantum phase transition is found to occur in the 3D electron gas [17].




FIG.3. The pair distribution function g(r) of the 2D electron gas at $r_s = 1, 5, 10$, and 20 in the param agnetic state (top panel) and in the fully spin-polarized state (bottom panel), as a function of distance r (in units of $r_s a_B$). The theoretical results (full lines) are compared with QMC data by G ori-G orgi et al.[15] (dots). The dashed lines show the results obtained in the FHNC/0 scheme. The results have been shifted upwards by 0.4, 0.8 and 1.2 for clarity.




FIG.4. The ground-state energy of the 2D electron gas (in Rydberg units, referred to the M adelung energy $"_{M} = 2.2122 = r_{s}$ and multiplied by $r_{s}^{3=2}$) as a function of the coupling strength r_{s} . The full lines show the theoretical results for the param agnetic state and the fully spin-polarized state, while the dots report QMC data from Attaccalite et al. [7]. The other three curves are theoretical results for states of partial spin polarization, as indicated in the gure.
