On the interpretation of the equilibrium magnetization in the mixed state of high- T_c superconductors.

Abstract

We apply a recently developed scaling procedure to the analysis of equilibrium m agnetization M (H) data that were obtained for T $\frac{1}{2}Ba_2CaCu_2O_{8+x}$ and $B\frac{1}{2}Sr_2CaCu_2O_8$ single crystals and were reported in the literature. The tem perature dependencies of the upper critical eld and the magnetic eld penetration depth resulting from our analysis are distinctly di erent from those obtained in the original publications. We argue that theoretical models, which are usually employed for analyses of the equilibrium m agnetization in the mixed state of type-II superconductors are not adequate for a quantitative description of high-T_c superconductors. In addition, we dem onstrate that the scaled equilibrium m agnetization M (H) curve for a T 1-2212 sam ple reveals a pronounced kink, suggesting a phase transition in the mixed state.

M easurements of the equilibrium magnetization in the mixed state of type-II superconductors are often used for studying conventional and unconventional superconductivity. This is particularly true for high- T_c (HTSC) superconductors, because of the extremely wide range of magnetic elds in which their magnetization is reversible. The physically meaningful information is not straightforwardly accessible, however, and, in order to estimate critical magnetic elds or characteristic lengths from magnetization measurements, theoretical models have to be invoked. Below we consider several theoretical approaches which are usually employed for the interpretation of corresponding experimental results, and show that the resulting temperature dependencies of the upper critical eld H_{c2} and the magnetic eld penetration depth still leave space for improvement.




Fig. 1. The tem perature dependence of the norm alized upper critical eld resulting from our scaling procedure for T 1-2212 sample studied in Ref. [4]. The solid line is the best linear t to the data points for T 90 K. The data points for two underdoped YBCO samples, investigated in Ref. [27], were taken from Ref. [24]. The upper inset shows the M (T) curve measured at H = 10 O e. The short vertical line indicates the position of T_c as evaluated by the linear extrapolation of h_{c2} (T) to $h_{c2} = 0$. The bottom inset shows H_{c2} (T) as obtained in Ref. [4] by employing the Hao-C lem m odel.

The Hao-Clem model [1,2] is most widely used for evaluating essential superconducting parameters, such as the upper critical eld H_{c2} and the G inzburg-Landau parameter of HTSC's from magnetization data. Because this model takes into account the spatial variation of the order param eter it is, no doubt, a better approximation to the Abrikosov theory of the mixed state 3] than previously used approaches. Nevertheless, the (T) curves obtained by employing the Hao-C lem model practically always exhibit a rather strong and unphysical increase of with increasing temperature $[4\{16]$.¹ An instructive example of this behavior is provided by Figs. 3(a) and 3(b) in Ref. [4] where equilibrium magnetization data of a $T_{B}Ba_{2}CaCu_{2}O_{8+x}$ (T ± 2212) single crystal were presented and analyzed. The quoted gures reveal a rather strong increase of with increasing temperature and, as a consequence, a very unusual tem perature dependence of the upper critical eld H_{c2} , which is shown in the bottom inset of Fig. 1. As may be seen, H $_{\rm c2}$ (T) resulting for this particular sample is temperature independent below T 73 K and exhibits an unphysical divergence at higher tem peratures. A very sim ilar behavior of the H_{c2} (T) curve, resulting from the same type of analysis, was also reported for Bi₂Sr₂CaCu₂O₈ (Bi-2212) samples [6]. More recent theoretical work [19{21] was intended to avoid these inadequacies by taking into account some speci c corrections to the sample magnetization that are not accounted for in the Abrikosov theory. However, as we argue below, the situation concerning the tem perature dependencies of H_{c2} and may be improved even further by em ploying a recently established scaling procedure [22].

O ur analysis of original data that were presented and discussed in Refs. [4,6,20] is based on a scaling procedure developed in Ref. [22]. It was shown that if the G inzburg-Landau parameter is temperature independent, the equilibrium m agnetizations in m ised state of type-II superconductors at two dimensional temperatures are related by

$$M (H = h_{c2}; T_0) = M (H; T) = h_{c2} + c_0 (T) H$$

with

$$c_0(T) = {(n) \atop eff} (T) {(T_0) : (2)}$$

In Eqs. (1) and (2) h_{c2} (T) = H_{c2} (T)= H_{c2} (T₀) represents the normalized upper critical eld and $_{eff}^{(n)}$ (T) is the eld ective magnetic susceptibility of the super-conductor in the normal state. T₀ is an arbitrary chosen temperature within

the covered range of tem peratures. The st term on the right-hand side of Eq. (1) is universal for any type-II superconductor, while the second is introduced o account for the tem perature dependent paramagnetism of HTSC's in the normal state. In practice, this second term often also includes a nonnegligible contribution arising from the sample holder. In the following we use $M_{eff}(H) = M$ (H;T₀) to denote the magnetization calculated from measurements at T for T₀ using Eq. (1). The adjustable parameters h_{c2} (T) and c_0 (T) may be established from the condition that the M eff curves, calculated from measures onto a single M eff (H) curve which represents the equilibrium magnetization at T = T₀ (see Ref. [22] for details).

There are two adjustable parameters in our scaling procedure whereby the upper critical eld H_{c2} represents the natural norm alization parameter for all m agnetic characteristics of the m ixed state and, as stated, c_0 (T) is essential to account for any tem perature dependence of the param agnetic susceptibility of HTSC's in the norm al state. An important advantage of our scaling approach is that no particular eld dependence of the m agnetization has to be assumed a priori and therefore, this procedure m ay be used for any type-II superconductor, independent of the pairing type, the absolute value of , the anisotropy of superconducting parameters, or the sample geom etry. However,




Fig. 2. The scaling parameter c_0 as a function of 1=T.

because M (H) is not postulated, the scaling procedure m ay only provide the relative tem perature variation of H $_{c2}$ given by the scaling parameter h_{c2} (T). The success of the scaling procedure described by Eq. (1) in data analyses of a number of dimension of H TSC materials was demonstrated in previous work [22{26]. In addition to the tem perature dependence of the normalized upper critical eld, also the superconducting critical tem perature can be evaluated by extrapolation of the h_{c2} (T) curve to $h_{c2} = 0$. The T_c values evaluated in this way are always consistent with low eld M (T) curves [22,24].

The norm alized upper critical eld h_2 (T), obtained via the scaling of M(H) data for a T H2212 single crystal presented in [4], is shown in Fig.1.A sm ay be seen, h_{c2} (T) for this sample varies linearly with T above $0.8T_c$ 82 K. This linearity allows for a quite accurate evaluation of the critical temperature T_c by extrapolating the h_{c2} (T) curve to $h_{c2} = 0$. The inset of F ig.1 demonstrates that the value of $T_c = 103.0$ K resulting from this extrapolation, is well in agreem ent with the temperature dependence of the low – eld m agnetization of the sam e sample. A sm ay be seen in Fig. 1, h_{c2} (T= T_c) for this T H2212 sample is practically identical with the h_{c2} (T= T_c) curves, presented in Ref. [24], for two underdoped Y B a_2 C u_3 O $_{7-x}$ (Y B C O) sam ples thus supporting our previous suggestion [24] concerning the universality of the temperature dependence of H_{c2} (T) for HTSC's.

The temperature dependence of the scaling parameter c_0 , which is shown in Fig. 2, demonstrates that the paramagnetic contribution to the sample magnetization obeys a Curie-type law in a rather extended temperature range with some deviations at temperatures below 55 K, as well as at temperatures very close to T_c .




Fig. 3. The scaled magnetization M $_{eff}$ calculated for $T_0 = 94$ K. The solid and the broken lines are meant to emphasize the change of the slope.

The dependence of M_{eff} on $H = h_{c2}$ (T) that results from our scaling procedure is shown in F ig. 3. Because of the high quality of the experimental data presented in Ref. [4] and the extended covered range of magnetic elds, the scaling is nearly perfect. The M_{eff} (H) data points, calculated from the measurements at dienent temperatures, combine to a single curve with virtually no scatter. The remarkable feature of this curve is a pronounced kink at $H = h_{c2}$ 20 kO e. This kink clearly indicates a signing cant change in the properties of the mixed state. Unfortunately, the measurements in Ref. [4] are limited to magnetic

elds H 20 kO e.O n ly a limited number of data points, measured at T 96 K and H = 20 kO e combine to the M $_{eff}$ (H) curve above the kink. This is why, on the basis of the available data, no de nite conclusions concerning this observation can be made. O n ly additional measurements in higher elds can clarify the situation. If this feature is con med by a more detailed study, the kink would de nitely reject some kind of phase transition.

If the G inzburg-Landau parameter is temperature independent, as it is assum ed in our approach, the magnetic eld penetration depth (T) is inversely proportional to the square root of the upper critical magnetic eld, i.e.,

$$(T) = (T_0) = {}^{q} \frac{1}{H_{c2}(T_0) = H_{c2}(T)};$$




Fig. 4. The norm alized tem perature dependence of calculated from the h_{c2} (T) curve. The two (T) curves presented in R ef. [4] are shown for comparison. The inset shows the norm alized vs 1= (1 T=T_c) on Log-scales; the straight line corresponds to expectations of the G inzburg-Landau theory.

The temperature dependence of the normalized penetration depth calculated in this way is shown in Fig. 4. As may be seen in the inset of Fig. 4, for $T = 0.75T_c$ the resulting temperature dependence of is well in agreement with the prediction of the G inzburg-Landau theory. At lower temperatures, Eq. (3) is not applicable for the evaluation of (T) and therefore it is not

suprising that (T) deviates from the G inzburg-Landau type behavior. The plots in Fig. 4 also demonstrate that our (T) curve is quite di erent from those calculated in Ref. [4] by employing either a modi ed London model (nonlocal theory) [21] or the Bulaevskii-Ledvji-K ogan approach (BLK theory) [19]. These di erences are particularly pronounced in the tem perature range where our (T) curve m atches the G inzburg-Landau theory.




Fig. 5. H $_{c2}$ (T)=H $_{c2}$ (35K) as a function of tem perature. These results are obtained by di erent analyses of the sam e m agnetization curves for a B i_2 Sr₂C aC u_2 O $_8$ sam ple which was experimentally investigated in R ef. [6].

Next we consider another example to support our arguments. We apply our analysis procedure on experimental (H) data for a single crystal of $B_{12}Sr_2CaCu_2O_8$, published in Ref. [6]. These results were previously analyzed in Ref. [20] and we compare our results with those presented in [20]. In Fig. 5 we show a comparison of the temperature dependence of the normalized upper critical eld obtained from the same experimental data by employing three di erent approaches.

The plots in Figs. 1, 4 and 5, demonstrate that employing our scaling procedure for the analysis of the equilibrium magnetization data results in conventional temperature dependencies of H_{c2} and which are rather di erent from those obtained by invoking other, previously considered approaches [1,2,19{ 21]. The models discussed in [20,21] were specially invented in order to explain the failure of the Hao-C lem model in handling magnetization data for layered HTSC compounds, as exemplieed by the bottom inset of Fig. 1, and to im – prove the interpretation of experimental results. The enhancement of H_{c2} at high temperatures was explained in Ref. [20] by the in uence of thermal uctuations on the sample magnetization, which are not accounted for in the

Hao-C km model. The temperature independence of H $_{c2}$ at lower temperatures was interpreted in Ref. [21] in terms of non-local elects. It is argued in [21] that due to elects of non-locality, which are expected to be important at temperatures well below T_c, the upper critical eld H_{c2} in the expression for the sample magnetization should be replaced by another eld H₀ which depends on temperature much weaker than H_{c2}. The results of our analysis give no support to any of these two assumptions. A swas demonstrated above, the sample magnetization can be scaled by simply invoking H_{c2} (T) in a wide temperature range without signi cant corrections from thermal uctuations or other sources.

Because the in uence of them al uctuations on the magnetization of HTSC's in the mixed state is often overestim ated in the literature, we discuss this point in more detail. As may clearly be seen in Fig. 3, if the experimental magnetizations are corrected for the temperature dependence of $_{\rm eff}^{(n)}$, the M $_{\rm eff}$ (H) data points, corresponding to di erent temperatures, merge onto exactly the same curve. The obvious conclusion is that uctuation e ects do not produce a considerable contribution to the sample magnetization in this rather wide temperatures range. It should be noted, how ever that, as may be seen in Fig. 2, the c_0 (T) data points for the three highest temperatures (T 97 K) deviate from the straight line corresponding to the Curie law. It is possible that these deviations are indeed due to thermal uctuations² At still higher

² As was pointed out in R ef. [22], at tem peratures close to T_c , the term c_0 (T) H m ay also account for uctuation e ects. However, because the uctuation-induced con-

tem peratures T 100 K $0.97T_{c}$, the m agnetization data presented in Ref. [4] cannot satisfactorily be scaled using Eq. (1). We consider this failure of the scaling procedure as evidence for the increasing role of uctuations with increasing tem perature. We also note that in Y-123 com pounds the impact of uctuations e ects is even weaker and in some cases our scaling procedure could successfully be employed up to tem peratures as high as $0.99T_{c}$ [22].

At present, it is di cult to identify the exact reason for the failure of the Hao-Clem model, an approximation to the Ginzburg-Landau theory of the mixed state, in treating experimental magnetization data. A few possibilities are mentioned below.

1.A coording to R ef. [29], the H ao-C lem m odelsu ers from general inaccuracies in corresponding calculations. It is also quite possible that the contribution to the sample m agnetization due to the norm al-state param agnetism of H T SC 's is not accounted for with su cient accuracy in the calculations.

2. Not all the assumptions of the model are satis ed in experiments. In particular, the assum ed conventional s pairing [1,2], also the basis for num erical calculations of B randt [30,31], is not compatible with the now accepted d pairing in HTSC's.

3. M ore general reasons for the disagreem ent between the calculated and the experim entalm agnetization curves cannot be excluded. The argum ent is based on results of recent m agnetization m easurem ents on single crystals of NbSe₂ [32], a conventional superconductor without any expectation of unconventional pairing. Because the upper critical eld for this superconductor is not very high, the param agnetic contribution to the sam ple m agnetization m ay easily be established and accounted for. For m agnetic elds H > 0:6H_{c2} (below 0:6H_{c2} the M (H) curves are irreversible) the experimentalm agnetization M (H) curves are linear if plotted versus ln H. Very accurate num erical calculations of B randt [30,31] for this m agnetic eld range result in M (H) curves that vary linearly with H, however.

In conclusion. by invoking published results of magnetization measurements on T \pm 2212 [4] and B \pm 2212 [6] samples we demonstrate that our analysis of equilibrium magnetization data results in temperature variations of H $_{c2}$ and

which are rather di erent from those obtained by employing theoretical approaches that are traditionally used for the interpretation of magnetization measurements in HTSC's [1,2,19{21]. In view of the successful scaling of the magnetization data which is based on a minimum of a priori assumptions and whose validity was convincingly demonstrated in Refs. [22,24,25,32,33], we are condent that the resulting temperature dependencies of the normalized

tribution to the sam ple m agnetization is not linear in H , it m ay only approximately be accounted for.

upper critical eld presented in Figs. 1 and 5 correctly describe the H_{c2} (T) curves for these HTSC compounds. We also argue that therm al uctuations have a much weaker in pact on the mixed-state magnetization of HTSC 's than is usually believed.
