# Spectra of pinned charge density waves with background current

#### Abstract

W e develop techniques which allow us to calculate the spectra of pinned charge density waves w ith background current.


## I. INTRODUCTION

The problem of a quantum m echanical particle whose motion is govemed by a random tim e-independent H am iltonian has been discussed in the literature for several decades. B ecause of its relevance to the electrons' m otion in disordered conductors, the H am iltonian which consists of a kinetic energy and a random scalar potential is probably the $m$ ost fam ous exam ple of such a problem. It is now well established that som e of the wave functions of such $H$ am iltonians are localized, the phenom enon usually referred to as A nderson localization (1]. A wealth of new types of behavior was discovered once random H am iltonians constrained by certain sym m etries were studied. For exam ple, the m ost general random H am iltonian would be com plex herm itian. C onstraining it to be real (in other words, im posing tim e reversal invariance) changes the localization properties of its w ave functions. A $n$ electron $m$ oving in a disordered conductor is described by a real random H am iltonian. Tuming on a magnetic eld $m$ akes the $H$ am iltonian herm itian. T his $m$ ade the study of the crossover betw een real and herm itian random $H$ am ittonians easily accessible experim entally, and a sub ject of intense theoretical investigations [2].

Furtherm ore, it w as discovered that a num ber of other sym $m$ etries can also be im posed on random $H$ am iltonians, which change their behavior yet again. A ltogether, there are ten sym $m$ etry classes of random $H$ am iltonians, distinguished by nine di erent constraints im posed on them [3, 4].

Yet other types of random $H$ am iltonians arise when they are constrained not by a sym $m$ etry but by certain requirem ents their spectra $m$ ust satisfy. T hem ost prom inent exam ple of that w ould be system sw ith bosonic excitations [5]. To be speci c, consider an energy functional $E[(x)]$, where $(x)$ is som e fiunction, which has the form

Eq. (2) is a random Schrodinger-like equation. Yet it is not equivalent to a particle $m$ oving in an arbitrary random potential. $\varrho^{2} h(o(x) ; x)$ is a random function of $x$, but it is not an arbitrary random function. It is clear, for example, that $n \quad 0$ for all $n$, which tells us that $@^{2} h(o(x) ; x)$, although random, has to be constrained in such a way that all its eigenvahes are positive.

In m ost applications ofEq. (1), h( ;x) is chosen to be a $s m$ ooth function of and a rough fiunction of $x$. For example, $h(; x)=A(x) \cos (\quad(x))$, where $A(x)$ and
$(x)$ are random functions of $x$ uncorrelated at di erent $x$, and $(x)$ is uniform ly distributed betw een 0 and 2 . $T$ his leads to the two point correlation function

U nder this de nition ofh ( $; x$ ), the problem described by Eqs. (1) and (2) has been extensively studied in the context ofpinned charge density waves [6]. K now ing the spectrum ofEq. (2) allow $s$, for exam ple, to calculate the AC conductance of the charge density wave. It was rst deduced in Refs. [7] and [8] that the density ofstates ( ) ofEq. (2) is given by ()$=\frac{3}{2}$ if $\quad c$ and if $o(x)$ is a globalm inim um of the energy functionalEq. (1), where

A m ore detailed approach to the problem speci ed by Eq. (2) was developed in Ref. [9]. It was shown in that work that the potential $@^{2} h(0(x) ; x)$ of the \Schrodinger" equation Eq. (2) can alw aysbe represented as

and $!{ }_{n}^{2}=n \cdot N$ ow $H$ is an exam ple of a $H$ am ittonian constrained by a sym m etry and can be solved by techniques developed in that context. T he sym $m$ etry of $H$ is usually referred to as chiral sym m etry. It is expressed
by the relation ${ }_{3} \mathrm{H}_{3}=\mathrm{H}$, which holds true for any random $V(x)[3]$. H ere 3 is the usualP aulim atrix.

The full solution of Eq. (2), w th the help of the $m$ apping to Eq. (3), dem onstrated that there indeed exists the crossover energy scale $c$. At $n \quad c$ all the eigenfunctions $n(x)$ are localized w ith the localization length $n \quad c^{\frac{1}{2}}$, which is independent of $n$. At $n \quad c$, the eigen fiunctions are still localized, but w ith the localization length which increases with $n$ as $n \quad n$. The density of states at ${ }_{n} \quad c$ is given by ( ) ${ }^{\frac{1}{2}}$. Finally, the density of states at ${ }_{n} \quad c$ is given by ( ) $\quad \frac{3}{2}$ if $0(x)$ is a globalm inim um of Eq. (1) and by ( ) if $\quad(x)$ is a localm inim um of Eq. (1).

In this paper we would like to show that the same techniques which proved useful in solving Eq. (2) can also be used to solve another related problem, which we form ulate below. C onsider an equation

$w$ here $j$ and are som e param eters. If $=0$, then this equation is equivalent to the $m$ in im ization condition of the energy Eq. [1]. If, on the other hand, $>0$, then this de nes a new problem. Eq. (5) was suggested in $R$ ef. [10] to describe pinned charge density waves with background current. N orm alm odes ofoscillation sofsuch pinned charge density w ave are given by

where $0(x)$ is a solution to Eq. (5). In this paper we are going to present the solution to the problem de ned by Eq. (5) and Eq. (6).
$T$ he operator in the square brackets of Eq . (6) is nonherm itian. A s a result, the eigenvalues $n$ do not have to be real. It is well know n, how ever, that the eigenvalues of equations of the type Eq. (6) alw ays lie along one dim ensionalcurves in the com plex plane [11]. In this paper, we show that these curves take the shape depicted on $F$ ig. 1. The fork point f cannot be found exactly. H ow ever, it is still possible to de ne the crossover scale c. All the states w th energy less than chave the sam e localization length . A s the energy is increased past ${ }_{c}$, the localization starts to grow and eventually diverges at f (which is always bigger than c). The states corresponding to com plex values of energy are delocalized.

W e introduce the technique which allow s to com pute $c$ and . We calculate them in the regime where $=(j)^{1=3} \quad 1$ and nd them to be $c={ }^{2}=4 j$ and
$=2^{2}=. W$ e also calculate the density of states along the part of the curve depicted on $F$ ig. 1 w hich lies on the real axis and nd it to be ( ) .
$T$ he rest of th is paper is organized as follow s . In section II we m ap the problem de ned by Eq. (6) to a random chiral H am iltonian. In section $\Pi$ the localization length of norm alm ode oscillations willbe derived in the lim it of large background current and in section IV th is resultw ill

be com pared w th the usual Larkin length of the problem. Section $V$ contains the calculation of the density of the low lying states. Finally, in Section V I we discuss the response of a pinned charge density wave w ith background current to an electric eld using the form alism developed here.

## II. MAPPING TOACHIRALHAMILTONIAN

The rst step of the solution is to m ap Eq. 6) to a m ore tractable form of a random chiral Ham iltonian. Follow ing the general guidelines of $R$ ef. [g], we treat Eq. (6) as the equation of $m$ otion of a particle $w$ ith coordinate , $m$ oving in tim $e x$, in the presence of viscous forces given by the term. W e then pass from the Lagrangian to Eulerian description of the $m$ otion. Introducing the velocity function $u(0(x)) \quad Q_{x} \quad(x)$ the equation of $m$ otion Eq. (6) becom es

$T$ he equation thus obtained is sim ilar to the equation of $m$ otion of a one dim ensional uid w thout pressure, usually referred to as B urgers equation. H ow ever, it also features the $u$ term, which can be intenpreted as a kind of viscous friction. T he Burgers equation $w$ th this term is novel and has not been considered in the literature before.

Thus we m apped our equation into an eigenvalue problem for a H erm itian operator. This operator can also be rew rilten in the form sim ilar to Eq. (3),

H ow ever, as argued by H atano and Nelson , the transfor$m$ ation Eq. (12) is valid only as long as $\sim_{n}$ decays asym ptotically as $\exp \left(\dot{j} \dot{F}^{\sim}\right)$, w ith the localization length $\sim<2 j=$. For $\sim_{n}$ whose localization length obeys this condition, Eq. (11) is equivalent to Eq. (13), and therefore, $n$ is real and positive. For other eigen functions $\sim_{n}$ whose localization length is larger than $2 j=$, Eq. (13) is no longer equivalent to Eq. (11).

N otice that the localization length $\tilde{n}_{n}$ of $\sim_{n}$ is related to the localization length $n$ of $n$ as in

III. THE LOCALIZATION LENGTH
$R$ andom chiral Schrodinger equations of the form (13) have been investigated by A. C om tet, J. D ebois, and C. $M$ onthus [13]. It w as determ ined that the im portant param eter for these equations is $!_{c}={ }^{P} \bar{j} h V(x)$ i, and correspondingly c $!_{c}^{2}$. For all wavefunctions whose energy $!_{n}<!_{c}$, the localization length is constant and is given by ${ }^{\sim}=1=h V(x)$ i. For $!_{n}>!_{c}$, the localization length quickly increases, being asym ptotically proportionalto ! ${ }_{n}^{2}$.

The crucial test for our theory is, therefore, whether $h V(x) i$ is bigger or sm aller than $=2 j$. A s w ew ill see below, hV (x)i> $=2 j$. A s a result, Eq. (13) is equivalent
to Eq. (11) and consequently, to Eq. (6), at < c. Thus at < c all the eigenvalues of Eq. (6) are real and positive. On the other hand, there exist some $e_{\mathrm{f}}>\mathrm{c}$ where the localization length of $\sim_{n}$ becom es equal to $2 j=$. At that point, the w ave functions $n$ becom e delocalized, in accordance w ith Eq. (14). At Re $>$ f, the eigenvalues of Eq. (6) are no longer real and come in com plex con jugate pairs. This justi es the picture presented on F ig. 1 .

In what follow S , we proceed to calculate c . In term s ofV (x), Eq. (9) becom es

If $=0$, then the ground state energy, together w ith its derivative w th respect to , can be estim ated sim ply from dim ensional analysis as ${ }^{1=3}=j^{2=3}$, to give $!_{c} \quad{ }^{1=3}=j^{1=6}$. This agrees with Ref. [G]. If $>0$, then dim ensionalanalysis is of no help, since $!_{c}$ can now depend on the dim ensionless ratio $=(j)^{1=3}$. The only way to nd ! c and thus the localization length of the low lying states is by nding the ground state energy $\mathrm{E}_{0}$.

By a suitable rescaling $v=y^{1=3}=j^{2=3}, E^{N}=$ $E j^{2=3}={ }^{1=3}$, we can bring the Schrodinger equation to the form

In general, it is not possible to nd the ground state energy ofthis Schrodinger equation exactly. W e are going to nd it only in the lim it when c 1. The potential in Eq. (21) has two m inim a. Them inim um at positive x is the globalm inim um and is located at

To add quantum uctuations to the problem, we have to consider the Schrodinger equation (21) evaluated around the $m$ inim um Eq. (22). Approxim ating the potential of Eq. (21) by a quadratic potential around the point $x_{m}$ in we nd the oscillator ground state energy to be

In principle, the cubic and quartic term in the expansion of the potential around the $m$ inim um also contribute to the ground state energy, but these only have dependence upon at the O (c ${ }^{5}$ ) leveland thus do not contribute to hV i at low er orders.

W e see that hV i> $=2 j$, and the localization length of the low lying herm itian states $\sim_{n}$ is consequently sm aller than $2 j=$. This allow susto deduce that Eq. (6) is indeed equivalent to Eq. (13) at $n<c$. The localization length of $n$ at ${ }_{n}<c$ can be deduced from Eq. (14) to be

states persist at all values of we need to show that hV i is always greater than $=2 j$. This am ounts to show ing that in the Schrodinger equation Eq. (21) the follow ing relation alw ays holds true

H ere $0(x)$ is the ground state $w$ ave function ofE $q$. (21), at $=1$. W e do not know how to show this analytically. W e investigated Eq. (21) num erically. F ig. 2 show s the values of $\mathrm{E}_{0}=\mathrm{d}=$ hy $i$, at $=1$, plotted versusc. We see that Eq. (25) does seem to hold.

## IV. THE LARKIN LENGTH

In the analysis of Eq. (5) it is custom ary to introduce the notion of Larkin length $L$. L is de ned as size of a box in which the average ${ }^{2}$ becom es of the order of 1 . Thus at distances bigger than $L, 0(x)$ becom es rough, while at shorter distances it can be thought of as sm ooth. We are now going to see that in our problem the localization length of low lying states of Eq. (6) is of the order of Larkin length.

To calculate the Lark in length, we follow the procedure described in Ref. [10]. W e consider the equation Eq. (5) . Let us assume that is sm all and neglect the dependence of $h$. In Fourier space this equation ofm otion is

At leading order $L$ tums out to be proportional to the localization length obtained above Eq. (24). This coincides w ith the behavior of the pinned charge density waves w ithout the background current [9]. H ow ever, the localization length and the Larkin length have di erent functional dependence on in lower orders.

## V. DENSITYOFSTATES

In this section we calculate the density of low lying states for our problem. D ue to the form of the potential Eq. (17) which does not contain a cubic term, the density of low lying states $m$ ay be easily calculated using the $m$ ethods of ref. [5]. This is not im $m$ ediately obvious, so in this section wew ill repeat the argum ent.

At energies below an energy of the order of hV i the energy eigenvalues are real. A bove, the eigenvalues trace out a one-dim ensional spectrum in the com plex plane, Fig. [1. Let us concentrate on low lying states $n<c$, which are all real. To calculate their density of states
( ) we use the equivalence of Eq. (6) and Eq. (13) in this regim e.
$T$ he integrated density of low -lying states can be found using the discussion in Ref. [6] as

At large ', $S()$ is independent of ' as $w i l l$ be argued below. W e assum e in the follow ing that a certain value
of ' $m$ axim izes the probability of observing a uctuation of size $\quad \log !$. This is justi ed, since due to the form of the potential $U(V)$, Eq. (17), it is not very likely to observe a very large negative uctuation, and it is $m$ ore likely to see a sm aller negative uctuation, which exists over a longer interval of $x$. W e now approxim ate $N(!)$ by its value at the saddle point, determ ined from

W ewould like to com pare this w ith the result obtained for the pinned charge density $w$ ave problem $w$ th $=0$. There (!) ! if 0 is a global minim um of the energy functional Eq. (1) and (!) ! ${ }^{3}$ if the $m$ inim um is local. At $>0$, how ever, Eq. (5) is no longer a m inim ization condition of any functional and the notion of globalm inim um no longer exist.
VI. DRIVEN PINNED CHARGEDENSITY
WAVESW ITH BACKGROUND CURRENT

Consider a pinned charge density wave driven by an electric eld at frequency ! o (see e.g. Ref. [14] for a review ),

The properties of $n, n$ found in this paper help to deter$m$ ine the response of the charge density $w$ ave to a sm all extemal electric eld. For example, if the electric eld $E(x)$ is uniform in space, we can use the results of this paper which show that at $n<c$, the wave functions $\mathrm{n}(\mathrm{x})$ are all lpcalized w th the sam e localization length . Therefore, $\mathrm{dx} \mathrm{n}_{\mathrm{n}}(\mathrm{x}) / \mathrm{P}$ - and is independent of n , as long as $n<c$. On the other hand, the wave functions which correspond to ${ }_{R}$ large $R e_{n}$, are delocalized and oscillate fast, so that $d x \quad n(x)$ goes to zero w th increasing $n$ quickly. Therefore, the current reduces to

## VII. CONCLUSIONS

W e have dem onstrated how the problem of norm al $m$ ode oscillations of the one dim ensional pinned charge density waves w ith background current $m$ ay be solved by $m$ apping into chiral random $H$ am iltonians. U sing the $m$ ethods of $C$ om tet et al [13] we have determ ined the $10-$ calization length of the low lying nom alm odes. This localization length tums out to be proportional to the Larkin length of this system. The density of the lowest
lying states has also been obtained, giving the pow er law
(!) ! ${ }^{3}$. This result di ers from the result (! ) $!^{4}$ ofR efs. [], [] due to the fact that tuming on background current rem oves the notion of a global ground state.
