Spectra of pinned charge density waves with background current

We develop techniques which allow us to calculate the spectra of pinned charge density waves with background current.

I. IN TRODUCTION

The problem of a quantum mechanical particle whose motion is governed by a random time-independent Ham iltonian has been discussed in the literature for several decades. Because of its relevance to the electrons' m otion in disordered conductors, the H am iltonian which consists of a kinetic energy and a random scalar potential is probably the most famous example of such a problem. It is now well established that some of the wave functions of such Hamiltonians are localized, the phenom enon usually referred to as Anderson localization [1]. A wealth of new types of behavior was discovered once random Ham iltonians constrained by certain symmetries were studied. For example, the most general random Ham iltonian would be complex herm itian. Constraining it to be real (in other words, im posing time reversal invariance) changes the localization properties of its wave functions. An electron moving in a disordered conductor is described by a real random Hamiltonian. Turning on a magnetic eld makes the Hamiltonian hermitian. This m ade the study of the crossover between real and herm itian random Hamiltonians easily accessible experimentally, and a subject of intense theoretical investigations [2].

Furtherm ore, it was discovered that a number of other symmetries can also be imposed on random Hamiltonians, which change their behavior yet again. A ltogether, there are ten symmetry classes of random Hamiltonians, distinguished by nine dierent constraints imposed on them [3, 4].

Yet other types of random Ham iltonians arise when they are constrained not by a symmetry but by certain requirem ents their spectra must satisfy. Them ost prominent example of that would be system swith bosonic excitations [5]. To be specic, consider an energy functional E [(x)], where (x) is some function, which has the form

Here h ((x); x) is a random function whose form will be specified below. Suppose $_0$ (x) is a minimum (local or global) of this functional. We would like to study the normal modes $_n$ of oscillations around that minimum, described by the equation

Eq. (2) is a random Schrodinger-like equation. Yet it is not equivalent to a particle moving in an arbitrary random potential. $\ell^2 h(0, x)$; x) is a random function of x, but it is not an arbitrary random function. It is clear, for example, that $\ell^2 h(0, x)$; x), although random, has to be constrained in such a way that all its eigenvalues are positive.

In most applications of Eq. (1), h (;x) is chosen to be a smooth function of and a rough function of x. For example, h (;x) = A(x)cos((x)), where A(x) and (x) are random functions of x uncorrelated at dierent x, and (x) is uniformly distributed between 0 and 2. This leads to the two point correlation function

Under this de nition of h (;x), the problem described by Eqs. (1) and (2) has been extensively studied in the context of pinned charge density waves [6]. Knowing the spectrum of Eq. (2) allows, for example, to calculate the AC conductance of the charge density wave. It was rst deduced in Refs. [7] and [8] that the density of states () of Eq. (2) is given by () = $\frac{3}{2}$ if $_{\rm C}$ and if $_{\rm O}$ (x) is a global m inim um of the energy functional Eq. (1), where $_{\rm C}$ is the crossover scale. If, on the other hand, $_{\rm O}$ (x) is but a local m inim um of Eq. (1), then ()

A more detailed approach to the problem specied by Eq. (2) was developed in Ref. [9]. It was shown in that work that the potential $\ell^2 h(0)(x)$; x) of the \Schrodinger" equation Eq. (2) can always be represented as

where V(x) is some new random function. As a result, Eq. (2) is equivalent to

and $!_n^2 = _n$. Now H is an example of a Ham iltonian constrained by a symmetry and can be solved by techniques developed in that context. The symmetry of H is usually referred to as chiral symmetry. It is expressed

by the relation $_3H$ $_3$ = $_3H$, which holds true for any random V (x) [3]. Here $_3$ is the usual Pauli matrix.

The full solution of Eq. (2), with the help of the mapping to Eq. (3), demonstrated that there indeed exists the crossover energy scale c. At n c all the eigenfunctions n (x) are localized with the localization length n c $^{\frac{1}{2}}$, which is independent of n. At n c, the eigenfunctions are still localized, but with the localization length which increases with n as n n. The density of states at $\frac{1}{2}$ Finally, the

eigenfunctions are still localized, but with the localization length which increases with $_n$ as $_n$ $_n$. The density of states at $_n$ $_c$ is given by () $^{\frac{1}{2}}$. In this paper we would like to show that the same techniques which proved useful in solving Eq. (2) can also be used to solve another related problem, which we form ulate below. Consider an equation

where j and are some parameters. If = 0, then this equation is equivalent to the minimization condition of the energy Eq. (1). If, on the other hand, > 0, then this de ness a new problem. Eq. (5) was suggested in Ref. [10] to describe pinned charge density waves with background current. Normalmodes of oscillations of such pinned charge density wave are given by

where $_0$ (x) is a solution to Eq. (5). In this paper we are going to present the solution to the problem de ned by Eq. (5) and Eq. (6).




FIG. 1: The eigenvalues $_{\rm n}$ of the Eq. (6) lie on this curve in the complex plane.

The operator in the square brackets of Eq. (6) is non-herm itian. As a result, the eigenvalues $_{\rm n}$ do not have to be real. It is well known, however, that the eigenvalues of equations of the type Eq. (6) always lie along one dimensional curves in the complex plane [11]. In this paper, we show that these curves take the shape depicted on Fig. 1. The fork point $_{\rm f}$ cannot be found exactly. However, it is still possible to dene the crossover scale $_{\rm c}$. All the states with energy less than $_{\rm c}$ have the same localization length . As the energy is increased past $_{\rm c}$, the localization starts to grow and eventually diverges at $_{\rm f}$ (which is always bigger than $_{\rm c}$). The states corresponding to complex values of energy are delocalized.

We introduce the technique which allows to compute c and . We calculate them in the regime where = (j) $^{1-3}$ 1 and nd them to be c = 2 =4j and = 2^2 = . We also calculate the density of states along the part of the curve depicted on Fig.1 which lies on the real axis and nd it to be () .

The rest of this paper is organized as follows. In section II we map the problem dened by Eq. (6) to a random chiral Hamiltonian. In section III the localization length of normal mode oscillations will be derived in the limit of large background current and in section IV this result will

be compared with the usual Larkin length of the problem . Section V contains the calculation of the density of the low lying states. Finally, in Section VI we discuss the response of a pinned charge density wave with background current to an electric eld using the form alism developed here.

II. MAPPING TO A CHIRAL HAM ILTONIAN

The rst step of the solution is to map Eq.(6) to a more tractable form of a random chiral Hamiltonian. Following the general guidelines of Ref. [9], we treat Eq.(6) as the equation of motion of a particle with coordinate , moving in time x, in the presence of viscous forces given by the term. We then pass from the Lagrangian to Eulerian description of the motion. Introducing the velocity function u($_0(x)$) $_{x_0}(x)$ the equation of motion Eq.(6) becomes

The equation thus obtained is similar to the equation of motion of a one dimensional uid without pressure, usually referred to as Burgers equation. However, it also features the uterm, which can be interpreted as a kind of viscous friction. The Burgers equation with this term is novel and has not been considered in the literature before.

Perform ing a derivative on Eq. (7) with respect to results in

We do not the gradient of the velocity along the solution to Eq. (5), $_0$, as F (x) @ u ($_0$ (x);x). F (x) can be related to h (;x) with the help of Eq. (8)

The operator on the left-hand-side of Eq. (11) is not Hermitian. This may be remedied by using a trick due to Hatano and Nelson [12]. Writing

Thus we mapped our equation into an eigenvalue problem for a Herm itian operator. This operator can also be rewritten in the form similar to Eq. (3),

However, as argued by Hatano and Nelson, the transform ation Eq. (12) is valid only as long as $\tilde{\ }_n$ decays asymptotically as exp($j_{k}j_{n}^{-}$), with the localization length $\tilde{\ }<2j_{n}^{-}$. For $\tilde{\ }_n$ whose localization length obeys this condition, Eq. (11) is equivalent to Eq. (13), and therefore, n_{n} is real and positive. For other eigenfunctions $\tilde{\ }_n$ whose localization length is larger than $2j_{n}^{-}$, Eq. (13) is no longer equivalent to Eq. (11).

Notice that the localization length $\tilde{\ }_n$ of $\tilde{\ }_n$ is related to the localization length $\ _n$ of $\ _n$ as in

III. THE LOCALIZATION LENGTH

Random chiral Schrodinger equations of the form (13) have been investigated by A.Com tet, J.Debois, and C.M onthus [13]. It was determ ined that the important param eter for these equations is $!_c = \frac{1}{2}hV(x)i$, and correspondingly $_c = \frac{1}{2}$. For all wavefunctions whose energy $!_n < !_c$, the localization length is constant and is given by $^{\sim} = 1 = hV(x)i$. For $!_n > !_c$, the localization length quickly increases, being asymptotically proportional to $!_n^2$.

The crucial test for our theory is, therefore, whether hV (x) i is bigger or smaller than =2j. As we will see below, hV (x) i > =2j. As a result, Eq. (13) is equivalent

to Eq. (11) and consequently, to Eq. (6), at < c. Thus at < c all the eigenvalues of Eq. (6) are real and positive. On the other hand, there exist som e $_{\rm f}$ > c where the localization length of $^{\sim}_{\rm n}$ become sequal to 2 j= . At that point, the wave functions $_{\rm n}$ become delocalized, in accordance with Eq. (14). At Re > f, the eigenvalues of Eq. (6) are no longer real and come in complex conjugate pairs. This justi es the picture presented on Fig. 1.

In what follows, we proceed to calculate $_{\text{c}}$. In terms of V (x), Eq. (9) becomes

In the present case, we are interested in the probability of observing a particular value for V(x) together with the probability that a particular solution V(x) of Eq. (5) is chosen. The relevant quantity describing this joint probability is

The Feynman path integral formulation of the Schrodinger equation Eq. (16) allows us to nd the average of V using

where E_0 is the quantum mechanical ground state energy for a particle whose classical action is given by Eq. (19) and whose Schrödinger equation reads

If = 0, then the ground state energy, together with its derivative with respect to , can be estimated simply from dimensional analysis as $^{1=3}=j^{2=3}$, to give ! $_{c}$ $^{1=3}=j^{1=6}$. This agrees with Ref. [9]. If > 0, then dimensional analysis is of no help, since ! $_{c}$ can now depend on the dimensionless ratio = (j) $^{1=3}$. The only way to nd! $_{c}$ and thus the localization length of the low lying states is by nding the ground state energy E $_{0}$.

By a suitable rescaling $v=y^{1=3}=j^{2=3}$, $E^*=E\ j^{2=3}=^{1=3}$, we can bring the Schrödinger equation to the form

In general, it is not possible to nd the ground state energy of this Schrodinger equation exactly. We are going to nd it only in the lim it when c 1. The potential in Eq. (21) has two minima. The minimum at positive x is the global minimum and is located at

To add quantum uctuations to the problem, we have to consider the Schrodinger equation (21) evaluated around the m in in um Eq. (22). Approximating the potential of Eq. (21) by a quadratic potential around the point \mathbf{x}_{m} in we not the oscillator ground state energy to be

In principle, the cubic and quartic term in the expansion of the potential around the minimum also contribute to the ground state energy, but these only have dependence upon at the 0 (c 5) level and thus do not contribute to W i at lower orders.

We see that hV i> =2j, and the localization length of the low lying herm it in states $^{\sim}_n$ is consequently smaller than 2j= . This allow sus to deduce that Eq. (6) is indeed equivalent to Eq. (13) at $_n$ < $_c$. The localization length of $_n$ at $_n$ < $_c$ can be deduced from Eq. (14) to be

The calculation presented here justi es Fig. 1 at large . In order to see that the picture of low lying localized




FIG. 2: hy i in the ground state of Eq. (21) as a function of c. The dots represent hy i evaluated numerically at various values of c. The solid line is hy i calculated in the harmonic approximation to the potential in Eq. (21). The dash-dotted line represents the rst two terms of the perturbative calculation $c + \frac{1}{8c^2}$. Finally, the dashed line is a straight line of the slope 1, which demonstrates that hy i > c.

states persist at all values of $\ we need to show that hV i is always greater than =2j. This amounts to showing that in the Schrodinger equation Eq. (21) the following relation always holds true$

Here $_0$ (x) is the ground state wave function of Eq. (21), at = 1. We do not know how to show this analytically. We investigated Eq. (21) numerically. Fig. 2 shows the values of $dE_0 = d = hyi$, at = 1, plotted versus c. We see that Eq. (25) does seem to hold.

IV. THE LARK IN LENGTH

In the analysis of Eq. (5) it is custom any to introduce the notion of Larkin length L. L is de ned as size of a box in which the average 2 becomes of the order of 1. Thus at distances bigger than L, $_0$ (x) becomes rough, while at shorter distances it can be thought of as smooth. We are now going to see that in our problem the localization length of low lying states of Eq. (6) is of the order of Larkin length.

To calculate the Larkin length, we follow the procedure described in Ref. [10]. We consider the equation Eq. (5). Let us assume that is small and neglect the dependence of h. In Fourier space this equation of motion is

At leading order L turns out to be proportional to the localization length obtained above Eq. (24). This coincides with the behavior of the pinned charge density waves without the background current [9]. However, the localization length and the Larkin length have dierent functional dependence on in lower orders.

V. DENSITY OF STATES

In this section we calculate the density of low lying states for our problem . Due to the form of the potential Eq. (17) which does not contain a cubic term, the density of low lying states may be easily calculated using the methods of ref. [5]. This is not immediately obvious, so in this section we will repeat the argument.

At energies below an energy of the order of hW i the energy eigenvalues are real. Above, the eigenvalues trace out a one-dimensional spectrum in the complex plane, Fig. 1. Let us concentrate on low lying states $_{\rm n}<_{\rm c}$, which are all real. To calculate their density of states () we use the equivalence of Eq. (6) and Eq. (13) in this regine.

The integrated density of low-lying states can be found using the discussion in Ref. [5] as

At large ', S () is independent of ' as will be argued below . We assume in the following that a certain value

of 'm axim izes the probability of observing a uctuation of size $\log !$. This is justified, since due to the form of the potential U (V), Eq. (17), it is not very likely to observe a very large negative uctuation, and it is more likely to see a smaller negative uctuation, which exists over a longer interval of x. We now approximate N (!) by its value at the saddle point, determined from

We would like to compare this with the result obtained for the pinned charge density wave problem with = 0. There (!) !4 if $_0$ is a global minimum of the energy functional Eq. (1) and (!) !3 if the minimum is local. At > 0, however, Eq. (5) is no longer a minimization condition of any functional and the notion of global minimum no longer exist.

VI. DRIVEN PINNED CHARGE DENSITY WAVES WITH BACKGROUND CURRENT

Consider a pinned charge density wave driven by an electric eld at frequency $!_0$ (see e.g. Ref. [14] for a review),

The properties of $_n$, $_n$ found in this paper help to determ ine the response of the charge density wave to a small external electric eld. For example, if the electric eld E (x) is uniform in space, we can use the results of this paper which show that at $_n$ < $_c$, the wave functions $_n$ (x) are all localized with the same localization length . Therefore, dx $_n$ (x) / and is independent of n, as long as $_n$ < $_c$. On the other hand, the wave functions which correspond to R large Re $_n$, are delocalized and oscillate fast, so that dx $_n$ (x) goes to zero with increasing n quickly. Therefore, the current reduces to

VII. CONCLUSIONS

We have demonstrated how the problem of normal mode oscillations of the one dimensional pinned charge density waves with background current may be solved by mapping into chiral random Ham iltonians. Using the methods of Comtetet al [13] we have determined the localization length of the low lying normal modes. This localization length turns out to be proportional to the Larkin length of this system. The density of the lowest

lying states has also been obtained, giving the power law (!) $!^3$. This result diers from the result (!) $!^4$ of Refs. [7, 9] due to the fact that turning on background current rem oves the notion of a global ground state.
