Perturbation A nalysis of Superconductivity in the Trellis-Lattice H ubbard M odel

W e investigate pairing sym metry and transition temperature in the trellis-lattice H ubbard m odel. W e solve the E liashberg equation using the third-order perturbation theory with respect to the on-site repulsion U.We nd that a spin-singlet state is very stable in a wide range of parameters. On the other hand, when the electron number density is shifted from the half-lled state and the band gap between two bands is small, a spin-triplet superconductivity is expected. Finally, we discuss a possibility of unconventional superconductivity and pairing sym metry in Sr_{14} $_{\rm X}$ C $a_{\rm X}$ C u_{24} O $_{41}$.

KEYW ORDS: trells lattice, quasi-one-dimensional superconductors, pairing symmetry, transition temperature, third-order perturbation theory

1. Introduction




Fig. 1. (a) Schem atic gure of the lattice used in this calculation. t_i (1 i 3) is the hopping integral. The region enclosed by a rectangle is a primitive cell. The primitive cell topologycally composes a triangular lattice. (b) The Ferm i surfaces for electron number density per ladder site n = 0.80 and the hopping integrals $t_2 = 1.0$, $t_3 = 0.15$ are shown by the solid lines for "(k) + V (k) and by the dashed line for "(k) V (k), respectively. Since the lattice is topologycally triangular lattice, the B rillouin zone is hexagonal. (c) The Ferm i surface for n = 0.80, $t_1 = 1.0$, $t_2 = 0.40$, $t_3 = 0.10$. In this case, the band gap is sm all.

Quasi-one-dimensional superconductors have been studied and attracted our attention. Today, some quasi-one-dimensional superconductors, such as $-Na_{0:33}V_2O_5$, were discov- $(TMTSF)_2 X^{1,2}$ and ered, and their superconductivity has been investigated. In 1996, a superconducting transition in Sr_{14} _x $Ca_xCu_{24}O_{41}$ was discovered at the transition tem perature T_c ' 12K under high pressure of approxin ately 3GPa for $x = 13:6^{(4)}$. This material possesses a quasi-one-dimensional lattice structure called trellis lattice, which is C u network connected by O orbitals sim ilar to high- T_c superconductors as shown in Fig. 1(a). Actually, this material shows quasi-one-dimensional m etallic behavior in an electric resistivity experiment.⁵⁾ The ratio of the resistivities a = c is approximately 80 at ambient pressure, and is reduced approximately 30 under 3.5 GPa at T ' 50K for x = 11.5. Here, the Cu valence in this ladder can be changed from +2:07 (x = 0) to +2:24 (x = 14) by substituting Ca for Sr.⁶

Recently, an NMR experiment has been performed in this material for x = 12 by Fujiwara et al.⁷⁾ From this experiment, an activated T dependence of $1=T_1$ is observed at temperatures higher than 30 K, and it suggests that the spin gap is conformed.Below 30 K, $1=T_1T$ keeps constant and shows the Fermi liquid behavior. Moreover, $1=T_1$ has a sm allpeak just below T_c . It indicates that the superconducting gap structure is a fully gapped state in this material. On the other hand, the K night shift does not change above and below T_c . It suggests that a spintriplet state is realized.But, since the paramagnetic contribution of K night shift should be sm allowing to the effect of spin gap conformed at rather high temperatures, it m ight be di cult to detect the shift at T_c within the experimental accuracy.

The theoretical investigations for the possibility of unconventional superconductivity have been reported in the quasi-one-dimensional superconductors, such as $(TM TSF)_2X$, $-Na_{0:33}V_2O_5$ and $Sr_{14} \ _xCa_xCu_{24}O_{41}$. The superconductivity in $(TM TSF)_2X$ has been in-

vestigated within the uctuation-exchange approximation (FLEX)⁸⁾ and the third-order perturbation theory (TOPT).⁹⁾ The superconductivity in $-Na_{0:33}V_2O_5$ has been investigated within TOPT.¹⁰⁾ Also, on the basis of the calculation within FLEX for the trellislattice Hubbard model, Kontani and Ueda indicated that a spin-singlet and fully gapped state is stable in $Sr_{14} \ _xCa_xCu_{24}O_{41}$.¹¹⁾ In this paper, by using the third-order perturbation theory,¹²⁾ we investigate in detail unconventional superconductivity in the trellis-lattice H ubbard model, keeping $Sr_{14} \ _xCa_xCu_{24}O_{41}$ in m ind. In particular, we point out that the fully gapped state can be realized for unconventional superconductivity, and the spin-triplet state can be realized in a range of parameters.

2. M odel

Now, let us consider the lattice structure and the band structure in $Sr_{14} \ _xCa_xCu_{24}O_{41}$. We can consider the lattice structure with the Cu network called trellis lattice shown in Fig.1(a). The unit cell is a thick-line rectangle,

Here, we investigate in detail the nature of superconductivity in such a situation.We consider the quasi-onedimensional two band repulsive Hubbard model.

Here, A_k ; and B_k ; (A_k^y) and B_k^y ;) are the annihilation (creation) operator for the electron at A and B site, respectively. To obtain two bands, we transform $A_{k;}^{(y)}$, $B_{k;}^{(y)}$ into $a_k^{(y)}$; $b_k^{(y)}$ as

Thus, we obtain two bands, "(k) + V(k) and "(k) V(k). W e use $t_1 = 1.0$ as an energy unit. In the previous calculation within FLEX, $f^{(1)}$ t₂ = 1:0 and t₃ = 0:15 are used to t the band structure calculated within the local-density approximation.¹³⁾ In the calculation, the electron num ber density per ladder site n = 1:0 is assum ed. It m eans that the valence of Cu is + 2:0.0 n the other hand, we use the hopping integrals t_2 , t_3 and electron num ber density per ladder site n as a parameter in this calculation. t₂ is a measure of the band gap between two bands, and t_3 is related to one-dimensionality. We show typical quasione-dimensionalFermisurfaces in Fig.1(b) and (c).We show the Fermi surface for $t_2 = 1.0$, $t_3 = 0.15$, n = 0.80in Fig. 1(b), and for $t_2 = 0:40$, $t_3 = 0:10$, n = 0:80 in Fig. 1 (c), respectively. A ctually, the band gap is sm all in Fig.1(c).




Fig. 2. The diagram s in the norm alself-energy. The solid and the broken lines represent G $^{(0)}$ (k) and U, respectively.

3. Form ulation

W e apply the third-order perturbation theory with respect to U to our model. The diagram s in the norm al self-energy are shown in Fig. 2. The norm al self-energy is given by




Fig. 3. The diagram s of pairing interaction part. The diagram s enclosed by the dashed line are called the RPA -like term s. The other diagram s are the vertex corrections.

W e also expand the e ective pairing interaction up to the third order with respect to U. The diagram sofe ective pairing interaction are shown in Fig.3. For the spinsinglet state, the e ective pairing interaction is given by




Fig. 4. A contour plot of m_{ax} as a function of t_2 and t_3 in the case of T = 0.01, n = 0.80 and U = 4.0. In the right hand side region of the thick line, a spin-singlet state is stable, and in the left hand side region of the thick line, a spin-triplet state is stable.

Here, $V_{;}^{\text{RPA Singlet (Triplet)}}(k;k^0)$ is called the RPA-like terms and $V_{;}^{\text{Vertex Singlet (Triplet)}}(k;k^0)$ is called the vertex corrections. Near the transition point, the anom abus self-energy (k) satis es the linearized E liashberg equation,

¹⁵⁾ where, V ; $\circ \circ \langle k; k^0 \rangle$ is $V_{j}^{\text{Singlet}} \langle k; k^0 \rangle$ or $V_{j}^{\text{Triplet}} \langle k; k^0 \rangle$. Here, F $\circ \circ \langle k^0 \rangle$ is anomalous G reen's function, and max is the largest positive eigenvalue. Then, the temperature at max = 1 corresponds to T_c. By estimating max, we can determ ine which type of pairing symmetry is stable. For numerical calculations, we take 128 128 k-m eshes for twice space of the rst B rillouin zone and 2048 M atsubara frequencies.

4. Num erical results

4.1 Dependence of m_{ax} on the parameters t_2 and t_3 Fig. 4 is a contour plot of m_{ax} as a function of t_2 and t_3 in the case of T = 0.01, n = 0.80 and U = 4.0. In the dark region, the state is stable. In the right hand side region of the thick line, a spin-singlet state is stable, and in the left hand side region of the thick line, a spin-triplet state is stable. When t_2 is large, a spinsinglet state is very stable. On the other hand, when




Fig. 5. Temperature dependence of m_{ax} for a spin-singlet (or spin-triplet) state in the case of $t_2 = 1.0$, $t_3 = 0.15$, n = 0.80 and U = 3.2. The line with black circles (squares) is the temperature dependence for the spin-singlet (spin-triplet) state obtained using the third-order perturbation theory. The spin-singlet state is more stable than the spin-triplet state in this case.




Fig. 6. Tem perature dependence of m_{ax} for spin-singlet (or spin-triplet) state in the case of $t_2 = 0.40$, $t_3 = 0.10$, n = 0.80 and U = 4.1. The line with black circles (square) is the result for the spin-singlet (spin-triplet) state obtained using the third-order perturbation theory. The spin-triplet state is more stable than the spin-singlet state in this case. The line with the white circles (square) is the result for spin-singlet (spin-triplet) state without the third-order term s of the pairing interaction.

 t_2 is small, a spin-triplet state is stable. Therefore, a spin-triplet state is stable when the band gap between two band is small. We discuss this result later in Sec. 5. For $t_3 < 0.1$, the mass enhancement factor is much smaller than unity. Therefore, reliable numerical calculations in this framework can not be obtained in the range of $t_3 < 0.1$.

4.2 Tem perature dependence

In Fig.5, we show temperature dependences of $_{max}$ in the case with $t_2 = 1.0, t_3 = 0.15 \text{ n} = 0.80$ and U = 32. Also, in Fig. 6, we show temperature dependences for $_{max}$ in the case with $t_2 = 0.40, t_3 = 0.10, n = 0.80$ and U = 4.1. W ith decreasing temperature, $_{max}$ increases. In Fig. 5, the spin-singlet state is stable. On the other hand, in Fig. 6, the spin-triplet state is stable. These




Fig. 7. A contour plot of m_{ax} as a function of t_2 and n in the case of $t_3 = 0.15$, T = 0.01 and U = 4.0. In the right hand side region of the thick line, a spin-singlet state is stable, and in the left hand side region of the thick line, a spin-triplet state is stable.

states possess almost the same transition temperature, $T_{\rm c}$ ' 0:003, respectively. If we assume that the bandwidth W $_{\rm C}$ corresponds to 2 eV, then $T_{\rm c}$ $_{\rm 10\,K}$ is obtained in almost accordance with the experimental value for Sr_{14} $_xCa_xCu_{24}O_{41}$. In Fig. 6, we also show the results for $_{\rm m\,ax}$ obtained without the pairing interaction due to the third-order term s.W e can see that the vertex corrections are important for stabilizing the spin-triplet state from the comparison.

4.3 Dependence of m_{ax} on the parameters t_2 and n

Fig. 7 is a contour plot of \max_{max} as a function of t_2 and n in the case of $t_3 = 0.15$, T = 0.01 and U = 4.0. W hen t_2 is large, a spin-singlet state is very stable like the above case in Sec. 4.1. On the other hand, if t_2 is small and n is shifted from the half-lled state, a spintriplet state is stable. Thus, the spin-triplet state is suppressed in the vicinity of the half-lled state, and it is stable rather far from the half-lled state. This tendency is a general property. The pairing interaction important for the spin-triplet state originates from the third-order term s which vanishes in the case with the particle-hole symmetry. Therefore, \max_{max} is reduced due to approxim ate particle-hole symmetry near the half-lled state.

4.4 Dependence of m_{ax} on the parameters t_2 and U

Fig. 8, is a contour plot of \max_{max} as a function of t_2 and U in the case of $t_3 = 0.15$, T = 0.01 and n = 0.80. W hen t_2 is large, a spin-singlet state is very stable like the above case in Sec. 4.1. On the other hand, when U becomes large, \max_{max} becomes large. But the stable symmetry does not depend on the magnitude of U so much in this strongly correlated region. On the other hand, from the result of renorm alization group approach¹⁶⁾ for $t_3 = 0$ and U ! 0^+ , the spin-singlet state is stable for any values of t_2 and n. It does not contradict this result within the perturbation theory. When U is very small, the vertex corrections are negligible which is important for the stabilization of the spin-triplet state. Therefore, when U is very small, the spin-singlet state seems to be




Fig. 8. A contour plot of m_{ax} as a function of t_2 and n in the case of $t_3 = 0.15$, T = 0.01, and U = 4.0. In the right hand side region of the thick line, a spin-singlet state is stable, and in the left hand side region of the thick line, a spin-triplet state is stable.

dom inant from the results without the third-order term s of the pairing interaction. However, num erical calculation is di cult since the eigenvalue is very sm all in this case.

4.5 Momentum dependence of the anomalous selfenergy

From eq. (5), anom alous G reen's functions on the two bands are given by



Therefore, anom alous self-energies on the two bands are given by




Fig. 9. (a), (b) Contour plots of the anom alous self-energy (k) = 0 for the spin-singlet state in the case of $t_2 = 1:0, t_3 = 0:15$, T = 0.01, n = 0.80 and U = 4.0. The thick lines represent the Ferm i surfaces. The spin-singlet state is a fully gapped state. (c),(d) Contour plots of the anom alous self-energy (k) = 0for the spin-triplet state in the case of $t_2 = 0.4$, $t_3 = 0.10$, T = 0.01, n = 0.80 and U = 4.0. The thick lines represent the Ferm i surfaces. The spin-triplet state is a fully gapped state.

In Fig. 9, we show contour plots of the anom alous selfenergy in the case of T = 0.01, n = 0.80 and U = 4.0. In Fig. 9 (a) and (b), a spin-singlet case for $t_2 = 1:0$, $t_3 = 0.15$, and in Fig. 9 (c) and (d), a spin-triplet case for $t_2 = 0:40$, $t_3 = 0:10$ are shown. The thick lines represent the Ferm i surfaces. For the spin-singlet state, the momentum dependence of the anom alous self-energy on the Ferm i surface is a fully gapped state, and the signs of the anom alous self-energy on the Ferm isurface for the two band are di erent.W e discuss this result later in Sec. 5. For the spin-triplet state, the momentum dependence of the anom alous self-energy is also a fully gapped state.

5. D iscussions

In this section we consider the physical origin of the results in Sec. 4. Hereafter, we only consider the RPAlike terms to understand the mechanism of stabilization for the spin-singlet state. E liashberg equation is written

Therefore, ${}^{(0)}_{intra}(q)$ is the average of the bare susceptibility of the intra bands and ${}^{(0)}_{inter}(q)$ is the bare susceptibility of the inter bands.




Fig. 10. (a) A contour plot of ${}^{(0)}_{intra}(q;0)$ ${}^{(0)}_{AA}(q;0) + {}^{(0)}_{AB}(q;0)$ in the case of $t_2 = 1.0$, $t_3 = 0.15$, n = 0.30 and T = 0.01. (b) A contour plot of ${}^{(0)}_{inter}(q;0)$ ${}^{(0)}_{AA}(q;0)$ ${}^{(0)}_{AB}(q;0)$ in the case of $t_2 = 1.0$, $t_3 = 0.215$, n = 0.30 and T = 0.01. (c) A contour plot of ${}^{(0)}_{intra}(q;0)$ ${}^{(0)}_{AA}(q;0) + {}^{(0)}_{AB}(q;0)$ in the case of $t_2 = 0.40$, $t_3 = 0.10$, n = 0.30 and T = 0.01. (d) A contour plot of ${}^{(0)}_{intra}(q;0)$ ${}^{(0)}_{AA}(q;0) + {}^{(0)}_{AB}(q;0)$ in the case of $t_2 = 0.40$, $t_3 = 0.10$, n = 0.30 and T = 0.01. (d) A contour plot of ${}^{(0)}_{inter}(q;0)$ ${}^{(0)}_{AA}(q;0)$ ${}^{(0)}_{AB}(q;0)$ in the case of $t_2 = 0.40$, $t_3 = 0.10$, n = 0.30 and T = 0.01. When the band gap between two band is large, ${}^{(0)}_{intra}(q;0)$ is sm all like the case (a). On the other hand, when the band gap between two band is sm all, ${}^{(0)}_{intra}(q;0)$ is large like the case (c). The spin-singlet state is unstable in the case (c).

Fig. 10 is contour plots of $_{intra}^{(0)}(q;0)$ and $_{inter}^{(0)}(q;0)$ in the cases of $t_2 = 1.0, t_3 = 0.15, n = 0.80, T = 0.01$ and for $t_2 = 0.40$, $t_3 = 0.10$, n = 0.80, T = 0.01, respectively. Since the Ferm i surfaces have nesting property, they have quasi-one dimensional peaks. Since $\binom{0}{\text{intra}}$ (q;0) is the average of the bare susceptibility of the intra bands, it is usually sm aller than $\binom{0}{\text{inter}}(q;0)$. But when the band gap between two bands is small, two nesting vectors of intra band become alm ost same. Therefore, $\int_{intra}^{(0)} (q;0)$ with small band gap is large compared with the case where the band gap between two bands is large. A ctually, in Fig 10, when the band gap between two bands is large, $^{(0)}_{intra}(q;0)$ is small like the case (a). On the other hand, when the band gap between two bands is sm all, $\stackrel{(0)}{_{intra}}$ (q;0) is large like the case (c). By using the results in Fig. 10, we can understand the superconducting gap structure in Fig. 9 (a), (b) and the suppression of max in the case where the band gap between two bands is small, as we explain in the following. From the structure in the E liashberg equation, when $\int_{intra}^{(0)} (q;0)$ is much smaller than ${}^{(0)}_{inter}(q;0)$, in order to obtain a posit is favorable that signs of (k) on

one band are di erent from its sign on another band. The structure of (k) in Fig. 9 (a), (b) just becomes so. But, when the band gap between two bands is small, two nesting vectors of intra bands are alm ost same. Therefore, ${}^{(0)}_{intra}(q;0)$ becomes large and the spin-singlet state is suppressed by the con ict of the peaks of ${}^{(0)}_{intra}(q;0)$ and ${}^{(0)}_{inter}(q;0)$. A ctually, in Fig. 10, when the band gap between two bands is large, ${}^{(0)}_{intra}(q;0)$ is small and the spin-singlet state is very stable like the case (a). On the other hand, when the band gap between two bands is large and the spin-singlet state is unstable like the case (c).

Finally, we discuss the pairing symmetry in $Sr_{14} \ _xCa_xCu_{24}O_{41}$. From this calculation, we can see that the spin-singlet and fully gapped state is very stable and is consistent with the calculation within FLEX.¹¹⁾ On the other hand, when the electron number density is shifted from the half-lled state and the band gap between two bands is small, the spin-triplet and fully gapped state is stable. We cannot unfortunately determ ine the electronic structure under the pressure at present. In both cases, the fully gapped state is not

contradict to the experim ent of $1=T_1$. On the other hand, the Knight shift does not change above and below T_c. It suggests that a spin-triplet state is realized. But, since the param agnetic contribution of Knight shift should be small owing to the e ect of spin gap conformed at rather high temperatures, it might be dicult to detect the shift at T_c within the experimental accuracy. Here, we discuss the ratio of hopping integrals. The ratio $t_1 = t_2$ may be considered to be unity from almost equivalent spacings of the leg and the rung in this ladder. Experim entally, however, the ratio of the spin exchange coupling constant $J_{leq}=J_{runq}$ is about twice for related compounds. $^{17,\,18)}$ Here, $J_{\textrm{leg}}$ and $J_{\textrm{rung}}$ are related to t_1 and t_2 , respectively. M oreover, the pressure m ight change the ratio $t_1 = t_2$. Therefore, we can expect a exible value for the ratio $t_1 = t_2$.

6. Conclusion

In conclusion, we have investigated the pairing sym m etry and the transition temperature on the basis of the trellis-lattice Hubbard model. We have solved the E liashberg equation using the third-order perturbation theory with respect to the on-site repulsion U. We nd that the spin-singlet state is strongly stable in a wide range of parameters. On the other hand, when the electron number density is shifted from the half-

led state and the band gap between two bands is small, the spin-triplet state is expected. Thus, we suggest the possibility of unconventional superconductivity in $Sr_{14} \ _xCa_xCu_{24}O_{41}$.
