## Vanishing Spin-Hall Conductivity in 2D disordered Rashba electron gas

For the two-dimensional ideal electron gas with the Rashba spin-orbit interaction and in the presence of non-magnetic short-ranged potential in purities the spin-Hall conductivity  $_{\rm SH}$  is found by direct microscopic calculation. W ithin the sem iclassical approximation h=  $_{\rm F}$  and  $_{\rm F}$  the value of  $_{\rm SH}$  is zero for arbitrary ratio of the spin-orbit splitting and the inverse elastic scattering time 1= .

Recently it has been proposed<sup>1</sup> that a dissipation less spin current can be generated in response to an electric eld in sem iconductors with the spin-orbital interaction. For the case of an ideal two-dimensional (2D) electron gas with the Rashba coupling, Sinova et al.<sup>2</sup> have found a spin-Hall current of the transverse (z) spin component as a response to an in-plane electric eld E, j<sup>z</sup> = <sub>sH</sub> E, with the \universal" (independent upon the spin-orbital band splitting ) spin-Hall conductivity  $_{\rm sH}$  = e=8 h. In the presence of disorder and for the sim plest standard m odel it was dem onstrated a cancellation of the spin-Halle ect even in the case of arbitrary week disorder.<sup>3,4,5,6</sup>. In this communication we provide a fully m icroscopic calculation of the spin-H all conductivity for the generalized model of non-parabolic spectrum and arbitrary momentum dependence of the Rashba velocity (1), within the sem iclassical theory of disordered conductors, i.e. in the lim it h= F.We F/ show, that  $_{sH} = 0$  independently upon the parameter =h sim ilarly to the case of the parabolic spectrum Ref. 3,4,5,6.

2D isotropic R ashba gas is an electron system with the broken inversion symmetry. In this case an electric eld perpendicular to the plane could arise. It has no e ect on the electron orbitalm otion but it couples to the electron spin via a relativistic spin-orbit interaction known as the R ashba term. The H am iltonian of an electron consists of the kinetic energy term and the R ashba term :

where (p) is the Rashba velocity, i (i = x;y;z) are the Paulim atrices and ; are the spin indices. The Ham iltonian (1) can be diagonalized by the unitary matrix:

where '  $_{\rm p}$  is the angle between the momentum p of the electron and the x-axis, with the eigenvalues:

The eigenvalues = 1 of the chirality operator and p constitute the quantum numbers of an electron state

(p; ). Ferm i circles of the Rashba gas with the di erent chiralities are split:  $p_F = p_F$  (1)  $(p_F) = v(p_F)$ , where Ferm imomentum  $p_F$  solves the equation:  $(p_F) = ,$ where is the chemical potential; v(p) = d(p)=dp is the band velocity of the electron. The electron velocity in the chiral state is  $(p) = (p \cdot W \in assume (p_F))$  $v(p_F)$ , and neglect corrections of the order =v. The spin-orbital splitting is then: =  $2p_F$  ( $p_F$ ). The density of states on the two Ferm icircles diers as: =  $_{\rm F}$  (1  $_{\rm F} = V_{\rm F}$ ), where  $_{\rm F} = p_{\rm F} = 2 v (p_{\rm F})$ . Contrary to the case of the parabolic spectrum and Rashba velocity independent on the momentum, for the generalized model (1) the Ferm i velocities are di erent on the two Ferm i circles:  $v_{F\,+}$ 

 $v_F = 2_F \frac{p_F}{m v_F} - 1 - 2p_F \frac{d}{dp}_F$ . In the following we use the units where h = 1.

W e consider the 2D ideal (non-interacting electrons) Rashba electron gas with the Ham iltonian:

at zero tem perature.  $a^{y}$  (p) and a (p) are the electron creation and annihilation operators. Electrom agnetic vector potential  $\tilde{A}$  couples to the orbital motion of the electron according to the transformation:  $p ! p \in \tilde{A} = c$ , in the H am iltonian (1). Variation of the H am iltonian (4) with respect to  $\tilde{A}$  gives the electric current operator:  $\hat{J} = \int_{p} a^{y}$  (p)  $(\hat{J})$  a (p), where the one-particle current operator reads (it is actually a velocity  $\hat{J} = e^{\phi}$ ):

with = x;y being the spatial index and <sup>zi</sup> is the 3D totally antisymm etric tensor.

Under the non-uniform SU (2) electron spinor transformation: a (x) 7 U (x)a (x), the Ham iltonian (4) becomes dependent on the SU (2) \spin electrom agnetic" vector potential  $\hat{A} = A^{0 \ 0} + A^{i \ i}$ , where  $A^{0}$  coincides with the physical electrom agnetic potential and  $A^{i} = iTr(iU^{+}@U)=2$ . Although this latter potential is a pure gauge and has no physical consequences, variation of the Ham iltonian (4) with respect to it denes the spin current of i-component of the spin along the direction :  $\hat{J}^{i} = \int_{p}^{P} a^{y}(p)(\hat{J}^{i}) = a(p)$ , where the one-particle spin current operator reads:

O ur de nition of the spin current (6) coincides with the de nition followed in Ref. 8:  $\hat{J}^{i} = (\hat{v}^{i} + {}^{i}\hat{v})=2$ , but di ers from the de nition followed in Refs.<sup>1,2,3</sup> by a factor 2, which makes our value of the spin-H all conductivity being twice as big as that in the literature.<sup>1,2,3</sup>

The interaction of electron with short-ranged non-magnetic impurities at positions  $R_i$ , numerated by the index i, is described by the impurity Hamiltonian:

where u(r) is a short-range in purity potential. We assum e it to be su ciently weak in order for the Born approximation to be valid. In this lim it the impurity model (7) is equivalent to the model of the Gaussian random potential. W e expand the electron G reen function averaged over the realizations of the disorder potential purturbatively in power of the Ham iltonian (7) using the diagram matic procedure<sup>9</sup>. It is a sum of diagram swhere a chain of electron bare G reen functions is separated by im purity \crosses". Two \crosses" are connected by the averaged in purity line:  $n_{\,\rm im\,\,p}\,u^2$  = 1=2  $\,$  , where  $n_{\,\rm im\,\,p}$  is the density of impurities, and is the scattering mean free time. A \cross" does not change the electron spin and the electron frequency since the electron scattering o in purity is elastic. Therefore the in purity line carries zero frequency. D iagram s with crossings of two or m ore in purity lines are sm all as powers of the ratio 1 = F1. The averaged G reen function is a two by two matrix in the spin space and it is a solution of the D yson equation:

It can be conveniently transformed into the chiral basis by the unitary matrix U (p) (2). The retarded and the advanced averaged G reen functions are diagonal in the chiral basis:  $G_{\circ}^{(R;A)}(;p) = G^{(R;A)}(;p) \circ$ , and the solution to the D yson Eq. (8) reads<sup>9</sup>:

where is explicitly independent of the chirality. The advanced G reen function is a complex conjugate of the retarded one:  $G^{A}(;p) = fG^{R}(;p)g$ . The G reen function in the spin basis is a non-diagonal two by two matrix:

where (om itting for a m om ent the frequency and m om entum notations):

with the chiral G (R; A) being de ned in Eq. (9).

In order to calculate the current, induced in the electron system by an electric eld, we use the Keldysh technique<sup>10</sup>. Our result given by the Eq. (14) is well known but we derive it here for consistency. The averaged Keldysh G reen function is a four by four matrix G (p; ) that can be conveniently factorized into a two by two Keldysh matrix whose elements are matrices in the spin space them selves:

where the electron distribution N ( ) is proportional to the unit matrix in the spin space.

We choose the gauge for the uniform electric eld E (t) = E () e <sup>i t</sup> to be a time dependent vector potential A (t) = A () e <sup>i t</sup>, where A () = idE () = . Using the K eldysh technique<sup>10</sup> we average the spin current operator over the electron state perturbed by the electrom agnetic H am iltonian:  $\hat{H}_{em} = \frac{1}{c} d^2 r_{J}^{2}(r) A$  (t), in the rst order of the perturbation theory. The spin-H all conductivity sH is then found from the relationship:  $\hat{h}_{J}^{2}$  ()i = sH ()E (), as:

where <sup>z</sup> is the four by four matrix given by the direct product of the Paulimatrix <sup>z</sup> in the K eldysh space and the unit matrix in the spin space, the current operators in Eq. (13) are the direct product of matrices (5, 6) and the unitary matrix in the K eldysh space. Tr in Eq. (13) operates only in the spin space whereas the indices of +element corresponds to the K eldysh space. Substituting the G reen function Eq. (12), we obtain:




FIG.1: The spin-Hall conductivity is given by a one-bop diagram .




FIG.2: The vertex correction to the spin-Hall conductivity is given by a sum of non-crossing ladder diagram s.

where the brackets indicate averaging over the disorder. In the non-crossing approximation the average in Eq. (14) is given by the sum of the one-loop and the ladder diagram s shown in Figs. 1, 2.

First, we calculate the one-loop diagram Fig. 1 and denote this part of the spin-H all conductivity as  $^{0}_{SH}$ . It corresponds to the Eq. (14) with all G reen functions being substituted by the averaged G reen functions (9). The second line in Eq. (14) contains the in aginary part of the G reen function  $G^{R}$  (+ ;p) and the corresponding integral is convergent, therefore we change to in this second line. At T = 0 the Ferm i-D irac distribution function reads: N () = (). We take the integral over and in the zero-frequency lim it ! 0 we nd:

where S (x) = arctan (x=2), = (p) p (p) and = (p) + p (p) . In the large volume limit we substitute  $\frac{1}{V} p! \frac{d^2p}{(2)^2}$ , and then evaluate the integral over p in (15) in the limit of large Ferm i circle ;1=. This procedure, known as the sem iclassical approximation, expresses the momentum p in terms of the quasiparticle energy :

where R (p) = p  $v^{1}$  (p) m  $p^{1}$  (p) m  $v^{2}$  (p). The result reads:

with the rst and the second term s corresponding to the rst and the second term s of Eq. (15), respectively.

A n important observation is that the result (17) coincides exactly with the result obtained from those terms in Eq. (14) that contains one retarded and one advanced G reen functions. These two terms are proportional to dN()=d=() and all integrals are explicitly conned to the vicinity of the Ferm i circle. Therefore the spin-H all conductivity unlike the usual H all conductivity is determined by the quasi-particles around the Ferm i circle and not by the entire Ferm i disk.

The ladder diagram s shown in Fig.2 represent the vertex corrections to the current. Additional in purity lines in prove the convergence of the integral in Eq. (14). As a consequence, vertex corrections to the term s in Eq. (14)with the two advanced or with the two retarded G reen

functions vanish as  $\max(1=;)=F$  1. Therefore we consider only the vertex corrections to the terms with one advanced and one retarded G reen's functions as it is shown in Fig.2. For these diagrams the sem iclassical approximation (16) is valid.

The sum of ladder diagram swith  $n = 1;2; \dots$  in purity lines is given by the expression:

where the sum of n = 1::1 vertex corrections to the current  $\hat{J}_y^z(p)$  (with at least one in purity line) is denoted by the matrix  $J_y^z$ . In the spin basis and for short-ranged in purity potentials it does not depend on the electron momentum p and satis as the transferm atrix equation:

where the G reen functions G<sup>(R;A)</sup> are given by Eq. (10). The \full" spin current operator with all vertex corrections included:  $\hat{J}_y^z(\mathfrak{g}) + J_y^z$ , is represented diagram – matically in Fig. 3. In the equations for the current operators (5, 6) we expand the electron velocity  $v(\mathfrak{g}) = v(\mathfrak{g}_F) + =(v(\mathfrak{g}_F)\mathfrak{m}(\mathfrak{g}_F))$ , where  $\mathfrak{m}^{-1}(\mathfrak{g}) = dv(\mathfrak{g})=d\mathfrak{g}$ , to the rst order in the deviation from the Fermi circle: =, small in the semiclassical approximation. We also expand the spin-orbital splitting:  $\mathfrak{g}(\mathfrak{g}) = (\mathfrak{g}_F)(\mathfrak{g}_F + (1 + (\mathfrak{g}_F = F)d = d\mathfrak{g}_F) = v_F)$ , in the Green functions W e then evaluate Eq. (19) in the semiclassical

functions. We then evaluate Eq. (19) in the sem iclassical approximation (16) neglecting odd powers of :

where B =  $\frac{1}{2}$  1+ ( )<sup>2</sup><sup>1</sup>. From the rst two lines of Eqs. (20) we nd:  $(J_y^z)_{**} = (J_y^z)_{\#\#}$ , whereas from the last two lines we nd:  $(J_y^z)_{\#*} = iv(p_F) = ($  ) and  $(J_y^z)_{*\#} = iv(p_F) = ($  ). The integrand of Eq. (18) does not depend on the diagonal elements of them atrix  $J_y^z$  and

therefore we set them to zero:  $J_y^z = {}^y v (p_F) = .$  As it was expected the vertex corrections are proportional to the scattering rate. Integrating Eq. (18) in the sem iclassical approximation (16) over , we nally not the ladder part of the spin H all conductivity (Fig.2):

Remarkably all derivatives of (p) and v (p) over p have canceled out.

The spin-Hall conductivity is the sum of Eqs. (17, 21) and is zero:

It explicitely does not depend on the in purity scattering time . But, we observe a discontinuity between the spin-Hall conductivity in the clean system  $_{\rm SH}$  = e=8 h and the spin-Hall conductivity Eq. (22) in the presence of the in nitely smallam ount of non-magnetic scatterers. As it was shown in Ref. 6, this discontinuity is related to the dissipation in the system, which gives rise to the dissipative part in the spin-Hall conductivity  $_{\rm SH}^{\rm D}$  = e=8 h, which cancels the reactive part  $_{\rm SH}^{\rm R}$  = e=8 h.

In an analogous calculation, for the generalized m odel (1), we not the m agneto-electric e ect - m agnetization induced by the electric eld:

where  $\hat{S} = 1=2^{P}_{p} a^{y} (p)^{a}$  a (p) is the total spin operator and the total magnetization  $h\hat{S}^{y}i$  is in agreem ent with Ref. 4,11,12. One should notice that the steady in-plane magnetization (23) is a consequence of the zero spin-Halle ect (22).

N on-zero spin H all conductivity would result in a nonsteady in-planem agnetization. This follows from the evolution equation of the total spin of the system  $\hat{S}$  and the commutation relationship:

where =  $x;y; \hat{J}^z$  is the total spin current operator, dened in (6). Remarkably, Eq. (24) is valid for an electron system with any non-magnetic disorder and any electronelectron interaction. Moreover, valid is a more general equation for the local spin density evolution:

where = x;y;z; in derivation of Eq. (25) we considered the standard m odel of parabolic spectrum. If the last term were zero then the above Eq. (25) would be the spin conservation equation. But in the Rashba m etal neither com ponent of the spin is conserved.

To conclude, we have extended the result of Inoue et al. Ref. 3  $_{\rm sH}$  = 0 for the case of the arbitrary electron dispersion, arbitrary strength of disorder and arbitrary m om entum dependence of the Rashba velocity (p). Our result agrees with Ref. 4,5,6.
