# Density pro le of a harm on ically trapped ideal Ferm igas in arbitrary dim ension

#### Abstract

C losed form analytic expressions are derived for the density pro le of a harm onically trapped noninteracting Ferm i gas in d dim ensions. Shell structure e ects are included to leading order in $1=\mathrm{N}$, where N is the num ber of particles. These corrections to the local density approxim ation scale as $\mathrm{n}=\mathrm{n} \mathrm{N}$, where $=(1+1=\mathrm{d})=2$.

E xperim ents on quantum degenerate Ferm iatom shave
 erties of zero and nite tem perature noninteracting term lons in inhom ogeneous potentials. H ere we derive closed form analytic expressions for the ground state density of a harm onically trapped Ferm igas in d dim ensions.

Theoretical studies of noninteracting particles are crucial ff derstanding experim ents on nonresonantFerm i gases A typical length scale for interactions is $r_{0} \mathrm{~nm}$, and a typical interparticle spacing is $n^{1=3}$
$m \quad r_{0}$. Thus, even in $m$ ultiple com ponent gases, $w$ here s-w ave collisions are allow ed, the interaction energy per particle $E$ int $\quad h^{2} r_{0} n=m$ is sm all com pared $w$ ith the Ferm i energy $E_{f} \quad h^{2} n^{2=3}=m$. Therefore the interactions can be ignored for calculating gross features of the ground state structure. This separation of energy scales is even $m$ ore dram atic in a spin-polarized gas, where $s$ w ave collisions are forbidden, and therefore p-w ave collisions dom inate. The cross-section for $p$-w ave collisions is dow $n$ by a factor of $\left(k_{f} r_{0}\right)^{4}$ relative to $s-w$ ave.

A though our calculations are for arbitrary dim ension, $d$, a particularly im portant case is $d=1$ w here theoretical predictions about nen-teracting ferm ions can be applied to hard-core bosons

M ost experim ents are perform ed in harm onic traps, so it is natural to consider the density pro le of a gas of $N$ ferm ions in a potential $V(r)=m!^{2} r^{2}=2$. Since we ignore interactions, each spin com ponent is independent, and it su ces to consider the spinless (or spin-polarized) case. The simplest expression for this density pro le com es from the local density ( $T$ hom asFerm i) approxi$m$ ation, where the trap potential gives a spatially dependent chem ical potential $(\mathrm{r})=\mathrm{k}_{\mathrm{f}}^{2}(\mathrm{r})=2 \mathrm{~m}=0 \quad \mathrm{~V}(\mathrm{r})$, and the localdensity is derived from the relationship betw een density and chem icalpotential in a d-dim ensional hom ogeneou system, $n=\left(k_{f}=2^{P-}\right)^{d}=(d=2+1)$, resulting in a density pro le,

where $R_{t f}^{2}={ }^{2}=2(d \mathbb{N})^{1=d}$ is the radius of the cloud, and ${ }^{2}=h^{2}=m!^{2}$ is the oscillator length. A though this is
an excellent approxim ation to the true ground-state density pro le, it misses \shell e ects" resulting from the statistical correlations in an idealFerm igas. T hese shell e ects give rise to corregations on top of th is sm ooth prole which are analogous to the Friedel oscillations which occur the density of a uniform Ferm igas near an im purity Aswe show below, these corregations scale as $\mathrm{n}=\mathrm{n} \quad \mathrm{N}$ where $=(1+1=\mathrm{d})=2$. These deviations are therefore only signi cant for sm all num bers -f...-icles. D espite their sm all size, previous estim ates suggest that these deviations are experim entally observable.

Several authors have quanti ed ${ }^{n}$ density uctuations. In one dim ension, H usim $j$ derived a simple closed-form expression for the exact density pro le in term s of H em te polynom ials. Further discu and applications of this approach can be found in . U s. a com pletely independent form alism, V ignolo et al. recently derived an e cient num erical technique for calculating this pro le. V ignolo and M inguzzi later eralized their num ericalapproach to highen ensior A lso in higher dim ensions, B rack and Zy. derived an analytic expression for the exact density pro le in term $s$ of a sum over Laguerre polynom ials. B rute force num erical calcu ${ }^{\text {7.inns }}$ of three dim ensional shelle ects can be found in including som e discussion of corrections due to interactions.

Unlike these prior works, we will not attem pt to derive an exact expression for the density pro $l e$, rather we will produce an asym ptotic series in powers of $1=\mathrm{N}$. C onsequently we are able to derive sim ple analytic form ulae. Near the center of the trap Mr results agree w ith th derived by G leisberg et a: and B rack and M urthy . O ur expressions m atch the exact density pro le throughout the cloud, even for surprisingly sm all num bers of particles: $\mathrm{N} \quad 1$.
D ensity Generating Function: The single particle states of a d dim ensional harm onic oscillator are described by the quantum numbers $\mathrm{fn}_{1} ;::: ; \mathrm{n}_{\mathrm{d}} \mathrm{g}$, corresponding to a real-space wavefunction of the form

polynom ial. This single-particle state has energy E = $h!j_{j}\left(n_{j}+1=2\right)$. The ground state of $N$ ferm ions in a ham onic trap is only unique if an integral num ber of shells are lled, requiring

where $M=0 ; 1 ; 2 ;:::$ indexes the shell. The Thom asFerm iradius is then $R_{t f}^{2}={ }^{\prime 2}=2 \mathrm{M}+(1+\mathrm{d})+\mathrm{O}_{\mathrm{P}}(1=\mathrm{M})$. The exact density $w \underset{P}{\text { inll be denoted }} \underset{M}{(d)}(r)=\underset{m=1}{P} \underset{m}{(d)}(r)$,
 the density contribution from the $m$ 'th shell. In the rem ainder of this paper, we scale all lengths by '.

W e will extract the large M structure of the density from the generating fiunction, $G(r ; t)=P_{M}^{(d)}(r) t^{M}$. W e construct $G$ by noting that the $H$ erm ite polynom ials obey

To construct expressions involving the density contribution from each orbital, $\left.j_{j}(x)\right\}^{q}$, we need a generating function for $\mathrm{H}_{\mathrm{j}}(\mathrm{x})^{2}$. W e therefore introduce

The generating function for the contribution to the density in d dim ensions from the $M$ 'th shell is the product

The density for M led shells then obey

which shows (aswould be expected from sym m etry) that the density is only a function of the distance $r=j r j$. A sym ptotic Expansion: The relationship is inverted by perform ing a contour integralaround the origin in the com plex t plane,

D eform ing the contour to follow the path of steepest descents, the large M asym ptotics are calculated from the portion of the integral which passes over saddle points $T$ he path of steepest descents is ilhustrated in gure For four di erent regin es: A : $r^{2}=R_{t f}^{2}<R_{t f f}^{4}$; $\mathrm{B}: \mathrm{R}_{\mathrm{tf}}{ }^{4}<\mathrm{r}^{2}=\mathrm{R}_{\mathrm{tf}}^{2}<1 \quad \mathrm{R}_{\mathrm{tf}}{ }^{4=3} ; \mathrm{C}: \mathrm{jr}^{2}=\mathrm{R}_{\mathrm{tf}}^{2} \quad 1 \mathrm{j}^{<} \mathrm{R}_{\mathrm{tf}}{ }^{4=3}$; and $D: r^{2}=R_{t f}^{2} \quad 1^{>} R_{t f}^{4=3}: T$ hese regim es are distinguished by the num ber and locations of the saddle points which are found on the steepest descents contour.

In all cases the integral is dom inated by a single saddle point on the realaxis at $t=t_{0} w$ ith $0<t_{0}<1$. For $r=R_{t f}<1 \quad O\left(R_{t f}^{4=3}\right)$, this saddle point approaches the pole at $t=1$ as $t_{0}=1+O(1=M)$, and one cannot use the standard saddle-point form ulae to evaluate its contribution. H ow ever, straightf analysis show $s$ that for a su ciently well behaved function $f(t)$, one can approxim ate

plus term s of relative order $1=\mathrm{M}$. The integral is taken on a contour from $t=$ il to $t=+$ il $w$ ith $\operatorname{Re}(t)<1$. $N$ ear $t=1 . G(r ; t)=t^{M} \quad 1$ has the sam $e$ form as the integrand in $\quad$ w th $M f(1)=(d=2) \log (2)$ and $M f^{0}(1)=$ $\left(R_{t f}^{2} \quad r^{2}\right)=2+O\left(M^{0}\right)$, where $R_{t f}^{2}=2 M+1+d$. $T$ hus the leading order behavior coincides w ith the $T$ hom as $F$ erm i result in equation

The other saddle points are found br sotting the logarithm ic derivative of the integrand in equal to zero. The resulting cubic equations yields tw $O$ additional saddle points, denoted $t$. In region $A, t!1$; in $B, t$ are isolated saddle points with $\dot{j} 1$; in $C$ all three saddle points converge at $t=1$, and the contour of steepest descents no longer passes through $t$; and in D, all

three saddle points lie on the realaxis, and $t_{0} m$ oves aw ay from $t=1$,becom ing an isolated saddle point. In the last tow regions wem ust explicitly consider the corrections to $N$ ote that $m$ ost of the cloud lies w ithin region $B$ and we therefore rst consider the Friedel oscillations in this regim $e . W$ e then $m$ ove on to regions A, D, and C. This order is chosen so that we can sequentially use previous results.
$R$ egion $B$. Integrals passing over isolated saddle points can be evaluated through the standard form ula,

$w$ here $s$ is the saddle point, characterized by $f^{0}(s)=0$, and the integralon the left represents the contribution to the integral along the path of steepest descents near the s. To sim plify the algebra we change variables, letting $t=e^{2 i s}$. Setting the logarithm ic derivative of $G$ equal to zero, one nds that the saddle points $t$ correspond to $s=\arccos (r=R+c)+O(1=M)$ Tn this new variable, the integral in $m$ aps onto with $M f(s)=$ $i r^{2} \tan s \quad \operatorname{isR}_{t f}^{2} \quad(\mathrm{~d}=2+1) \log (\mathrm{r}) \quad(\mathrm{d}=2) \log (2 \cos (\mathrm{~s}))$ $(1+d=2) \log (2 i \sin (s))$. A dding the contributions of these tw o saddle points, one arrives at out central result: aw ay from the center and edges of the trap, the leading order form of the density oscillations is

By exam ining Eq. one sees that scales as $1 \stackrel{p}{=} \bar{M}$ for large M, while the Thom asFerm i density scales as $M^{d=2}$. The accumacy 0 is illustrated by the exam ples shown in gur

Region A. W hen r! 0 the polest approach one another at $t=1$, and no longer contribute as isolated saddle points. The width of each saddle point scales as $(s)^{2} \quad R_{\text {tf }}^{3}=r$ as $r!0$, while the distance betw een the saddle points ( $s_{+} \quad s \quad \arccos \left(r=R_{t f}\right)$ ) approaches zero as $r=R_{t f}$. Therefore the isolated saddle point approxim ation breaks down when $r^{2}<R_{t f}^{2}$.

To analyze this lim it, we expand G for small r and $u=t+1$. The leading order behavior for is

This result was pously found in d dim ensions by $B$ rack $d M$ urthy and in 1 dim ension by $G$ leisberg et al. By considering the long distance asym ptotic behavior of the Bessel fiunction $J(z) \quad \overline{2=} \operatorname{zos}(z$

$R$ egion D. As one $m$ akes $r$ larger, the saddle points which contribute to follow the circle $\mathrm{Jj}=1$, and as $r$ ! $R_{t f}$ they approach the pole at $t=1$. For $r>R_{t f}+O\left(R_{t f}{ }^{1=3}\right)$ all three saddle points $m$ ove onto the real axis; two with $t>1$ and one with $0<t<1$. $T$ he path of steepest descents only passes over the last of the saddle points. The $T$ hom as Ferm i approxim ation has no applicability here, so we calculate the fiulldensity, rather than the deviation from $T$ hom asFerm i. Since the relevant saddle point is ionlated, we can use the standard form ula from equation Sim ilar to our approach in region $B$, we change vamables, setting $t=e^{2 w}$, so that the density is

C om paring the width of the saddle point $w$ th the distance betw een $w_{0}$ and the pole at $w=0$, one nds that this expression is valid when $r^{>} 1+R_{t f}{ }^{4=3}$.
$T$ he density pro le in this region can also be estim -1-n from a m odi ed G ross $P$ ittaevskii type functional

H ow ever, such an ach can lead to unphysical interference predictions
$R$ egion $C$. Betw een regions $B$ and $D \quad\left(1 \quad 1=R_{t f}^{4=3}<r^{2}<\right.$ $1+1=R_{t f}^{4=3}$ ) all three saddle points are in close proxim ity to $t=1(w=0$ in the variables used to discuss region $D)$. Linearizing about $w=0$, one nds to leading order,

By introducing a sm all param eter, $=\left(3^{1=3} \mathrm{r}^{2=3}\left(\mathrm{R}_{\mathrm{tf}}^{2}\right.\right.$ $\left.r^{2}\right)$ ); and changing integration variables to $v=r^{2} w^{3}=3$, we can w rite the integrand in a pow er series in term can be integrated by using a variant ofequation yielding

This expansion is rapidly convergent when $<1$, corresponding to $1 \quad 1=R_{t f}^{4=3}<r^{2}<1+1=R_{t f}^{4=3}$. Sum $m$ ary: $W$ e have analytically calculated the density pro le for $N$ noninteracting spin-polarized ferm ions in a d-dim ensional harm onic trap. Four di erent expressions are needed to describe allparts of the cloud. T he results from all four regim es are all sketched in gur or the
case often particles in tw o dim ensions (corresponding to four lled shells).
