Density pro le of a harm on ically trapped ideal Ferm i gas in arbitrary dim ension

C losed form analytic expressions are derived for the density pro le of a harmonically trapped noninteracting Ferm i gas in d dimensions. Shell structure e ects are included to leading order in 1=N, where N is the number of particles. These corrections to the local density approximation scale as n=n N, where = (1+1=d)=2.

Experim ents on quantum degenerate Ferm i atom shave motivated a series of theoretical studies of the basic properties of zero [1, 2, 3, 4, 5, 6] and nite [7] temperature noninteracting ferm ions in inhomogeneous potentials. Here we derive closed form analytic expressions for the ground state density of a harmonically trapped Fermigas in d dimensions.

Theoretical studies of noninteracting particles are crucial for understanding experiments on nonresonant Fermi gases [8]. A typical length scale for interactions is  $r_0$  nm, and a typical interparticle spacing is  $n_0$   $n_0$ 

m  $r_0$ . Thus, even in multiple component gases, where s-wave collisions are allowed, the interaction energy per particle  $E_{\rm int}$   $h^2r_0n$ =m is small compared with the Ferm i energy  $E_{\rm f}$   $h^2n^{2=3}$ =m. Therefore the interactions can be ignored for calculating gross features of the ground state structure. This separation of energy scales is even more dramatic in a spin-polarized gas, where s-wave collisions are forbidden, and therefore p-wave collisions dominate. The cross-section for p-wave collisions is down by a factor of  $(k_{\rm f} r_0)^4$  relative to s-wave.

A lthough our calculations are for arbitrary dim ension, d, a particularly in portant case is d=1 where theoretical predictions about noninteracting ferm ions can be applied to hard-core bosons [9].

M ost experim ents are perform ed in harm onic traps, so it is natural to consider the density pro le of a gas of N ferm ions in a potential V (r) = m!^2r^2=2. Since we ignore interactions, each spin component is independent, and it su ces to consider the spinless (or spin-polarized) case. The simplest expression for this density pro le comes from the local density (Thomas-Ferm i) approximation, where the trap potential gives a spatially dependent chemical potential  $(r)=k_{\rm f}^2\,(r)=2m=0$  V (r), and the local density is derived from the relationship between density and chemical potential in a d-dimensional homogeneous system , n =  $(k_{\rm f}=2^{p-1})^{\rm d}=({\rm d}=2+1)$ , resulting in a density pro le,

$$n_{\rm tf}(r) = \frac{(R_{\rm tf}^2 - r^2)^{d=2}}{2^{d-d=2} (d=2+1)^{d}}$$

where  $R_{tf}^2 = ^{v^2} = 2 (dN)^{1-d}$  is the radius of the cloud, and  $^{v^2} = h^2 = m!^2$  is the oscillator length. A lthough this is

an excellent approximation to the true ground-state density pro le, it misses \shell e ects" resulting from the statistical correlations in an ideal Fermigas. These shell e ects give rise to corregations on top of this smooth prole which are analogous to the Friedeloscillations which occur in the density of a uniform Fermigas near an inpurity [10]. As we show below, these corregations scale as n=n N where = (1 + 1=d)=2. These deviations are therefore only signicant for small numbers of particles. Despite their small size, previous estimates [1, 11] suggest that these deviations are experimentally

Several authors have quanti ed these density uctuations. In one dimension, Husim i [12] derived a simple closed-form expression for the exact density prole in terms of Herm ite polynomials. Further discussion and applications of this approach can be found in [13]. Using a completely independent formalism, Vignolo et al. [1] recently derived an elicient numerical technique for calculating this prole. Vignolo and Minguzzi later generalized their numerical approach to higher dimension [2]. Also in higher dimensions, Brack and Zyl [3] derived an analytic expression for the exact density prole in terms of a sum over Laguerre polynomials. Brute force numerical calculations of three dimensional shell elects can be found in [14], including some discussion of corrections due to interactions.

Unlike these prior works, we will not attempt to derive an exact expression for the density pro le, rather we will produce an asymptotic series in powers of 1=N. Consequently we are able to derive simple analytic formulae. Near the center of the trap, our results agree with those derived by G leisberg et al [5] and B rack and M urthy [6]. Our expressions m atch the exact density pro le throughout the cloud, even for surprisingly sm all numbers of particles: N 1.

Density Generating Function: The single particle states of a d dimensional harmonic oscillator are described by the quantum numbers  $fn_1; :::; n_d g$ , corresponding to a real-space wavefunction of the form  $(x_1; :::; x_d) = \sum_{\substack{n_1 \ p}} (x_1) \sum_{\substack{n_d \ p}} (x_n)$ , where  $j(x) = \lim_{\substack{n_d \ p}} (y) e^{y^2 = 2} = (2^j j!^{\frac{p}{p}})^{1=2}$  is the eigenfunction of the one-dimensional harmonic oscillator, the dimensionless length is y = x = 1, and  $H_j(y)$  is the j'th Hermite




FIG. 1: (color online) Contours of steepest descents in the complex tplane for regions A,B,C,D (see text). Poles (at t=0;1) are represented by red squares, saddle points by yellow discs, essential singularities (at t=1) by blue triangles, and branch cuts (extending to 1 from t=1) by green wiggly lines. The dashed circle corresponds to t=1.

polynom ial. This single-particle state has energy  $E=h! \int_{j} (n_{j}+1=2)$ . The ground state of N ferm ions in a harm onic trap is only unique if an integral number of shells are lied, requiring

where M = 0;1;2;::: indexes the shell. The Thom as-Ferm iradius is then R  $_{\rm tf}^2$ =  $^2$ = 2M + (1+d)+O (1=M ). The exact density will be denoted  $_{\rm m}^{\rm (d)}$  (r) =  $_{\rm m=1}^{\rm M}$   $_{\rm m}^{\rm (c)}$  (r), where  $_{\rm m}^{\rm (d)}$  (r) =  $_{\rm n_1+::+\,n_d=m}^{\rm m}$  j  $_{\rm n_1}$  (x<sub>1</sub>)  $_{\rm n_d}$  (x<sub>d</sub>) $_{\rm j}^2$  is the density contribution from the m 'th shell. In the remainder of this paper, we scale all lengths by '.

We will extract the large M structure of the density from the generating function, G  $(r;t) = {P \choose M} {(d) \choose M} (r)t^M$ . We construct G by noting that the Herm ite polynom ials obey

To construct expressions involving the density contribution from each orbital,  $j_j(x)_j^2$ , we need a generating function for  $H_j(x)^2$ . We therefore introduce

A simple rescaling then gives

The generating function for the contribution to the density in d dimensions from the M 'th shell is the product

The density for M led shells then obey

which shows (as would be expected from sym m etry) that the density is only a function of the distance r = jrj. A sym ptotic Expansion: The relationship (7) is inverted by performing a contour integral around the origin in the complex tplane,

D eform ing the contour to follow the path of steepest descents, the large M asymptotics are calculated from the portion of the integral which passes over saddle points. The path of steepest descents is illustrated in gure 1 for four di erent regimes: A:  $r^2=R_{\rm tf}^2 < R_{\rm tf}^4$ ; B:  $R_{\rm tf}^4 < r^2=R_{\rm tf}^2 < 1$   $R_{\rm tf}^{4=3}$ ; C:  $jr^2=R_{\rm tf}^2$   $1jr < R_{\rm tf}^{4=3}$ ; and D:  $r^2=R_{\rm tf}^2$   $1^2 > R_{\rm tf}^{4=3}$ : These regimes are distinguished by the number and locations of the saddle points which are found on the steepest descents contour.

In all cases the integral is dom inated by a single saddle point on the real axis at  $t=t_0$  with  $0 < t_0 < 1$ . For  $r=R_{\rm tf} < 1 \quad 0 \ (R_{\rm tf}^{4=3})$ , this saddle point approaches the pole at t=1 as  $t_0=1+0$  (1=M ), and one cannot use the standard saddle-point formulae to evaluate its contribution. However, straightforward analysis shows that for a su ciently well behaved [15] function f (t), one can approximate

plus term s of relative order 1=M . The integral is taken on a contour from t= i1 to t= +i1 with Re(t) < 1. Near t= 1, G (r;t)=t^M 1 has the same form as the integrand in (9), with M f (1) = (d=2) log(2) and M f 0(1) = (R  $_{\rm tf}^2$  r)=2+0 (M 0), where R  $_{\rm tf}^2$  = 2M + 1+d. Thus the leading order behavior coincides with the Thom as Ferm i result in equation (1).

The other saddle points are found by setting the logarithm ic derivative of the integrand in (8) equal to zero. The resulting cubic equations yields two additional saddle points, denoted t. In region A, t! 1; in B, t are isolated saddle points with t j 1; in C all three saddle points converge at t = 1, and the contour of steepest descents no longer passes through t; and in D, all




FIG. 2: Density pro le of one-dimensional noninteracting ferm ions in a harm onic trap with frequency ! . Pro les with N=1 to N=11 particles are shown. Density pand position rare measured in units of the trap length '= h=m!. Thick gray lines: exact result; thin black lines: Eq. (11). The exact and approxim ate results lie on top of one another except near the edge of the cloud.

three saddle points lie on the real axis, and  $t_0$  m oves aw ay from t = 1, becoming an isolated saddle point. In the last two regions we must explicitly consider the corrections to (9). Note that most of the cloud lies within region B and we therefore rst consider the Friedel oscillations in this regime. We then move on to regions A, D, and C. This order is chosen so that we can sequentially use previous results.

Region B. Integrals passing over isolated saddle points can be evaluated through the standard formula,

where s is the saddle point, characterized by  $f^{0}(s) = 0$ , and the integral on the left represents the contribution to the integral along the path of steepest descents near the s. To simplify the algebra we change variables, letting  $t = e^{2is}$ . Setting the logarithm ic derivative of G equal to zero, one nds that the saddle points to correspond  $arccos(r=R_{t.f}) + O(1=M)$ . In this new variable, the integral in (8) maps onto (10) with M f (s) =  $ir^2 tan s isR_{+f}^2 (d=2+1) log() (d=2) log(2 cos(s))$ (1+ d=2) log (2isin (s)). Adding the contributions of these two saddle points, one arrives at out central result: away from the center and edges of the trap, the leading order form of the density oscillations is

scales as  $1 = \frac{p}{M}$ By exam ining Eq. (11), one sees that for large M , while the Thom as-Ferm idensity scales as  $M^{d=2}$ . The accuracy of (11) is illustrated by the examples shown in gure 2.

Region A.When r! O the poles tapproach one an-1, and no longer contribute as isolated saddle points. The width of each saddle point scales as (s)  $^2$   $R_{+}^3$ =rasr! 0, while the distance between the saddle points (s. S arccos(r=R<sub>t.f</sub>)) approaches zero as r=R tf. Therefore the isolated saddle point approxim ation breaks down when  $r^2 < R_{ff}^2$ .

To analyze this lim it, we expand G for small r and u = t + 1. The leading order behavior for

with w = M + 3=2 + d=4  $R_{++}^2=2$ . By deforming the contour, this integral m  $\mbox{ay}_{R}\,\mbox{w}\,\mbox{ritten}$  in terms of a Bessel function,  $J(z) = (2 i)^{-1} du u^{-1} \exp(z(u 1=u)=2)$ ,

This result was previously found in d dimensions by Brack and Murthy [3], and in 1 dimension by Gleisberg et al. [5]. By considering the long distance asymptotic behavior of the Bessel function J (z)

=4)  $(1 + 0 (z^2))$ , one sees that for  $R_{tf}^2$  $R_{\text{+f}}^{2=3}$  the solutions  $_{A}$  and  $_{B}$  coincide.

Region D. As one makes r larger, the saddle points which contribute to follow the circle tj = 1, and as r !  $R_{tf}$  they approach the pole at t = 1. For  $r > R_{tf} + O(R_{tf}^{1=3})$  all three saddle points move onto the real axis; two with t > 1 and one with 0 < t < 1. The path of steepest descents only passes over the last of the saddle points. The Thom as Ferm i approxim ation has no applicability here, so we calculate the full density, rather than the deviation from Thomas-Ferm i. Since the relevant saddle point is isolated, we can use the standard formula from equation (10). Similar to our approach in region B, we change variables, setting  $t = e^{2w}$ , so that the density is

where =  $R_{tf}^2 w + r^2 \tanh w$  $(1 + d=2) \log \sinh(w)$ (d=2) log cosh w . To leading order, the saddle point is at  $w_0 = \operatorname{arccosh}(r)$ , yielding a gaussian decay,

Comparing the width of the saddle point with the distance between  $w_0$  and the pole at w = 0, one nds that this expression is valid when  $r > 1 + R_{+f}^{4=3}$ .

The density pro le in this region can also be estimated from a modied Gross-Pittaevskii type functional [16].




FIG. 3: Density pro le of four lled shells (M=3, N=10) of non-interacting ferm ions in a two dimensional harmonic trap. Top and bottom panels respectively show density and deviation from a Thomas-Fermipro le. For clarity, the various approximate solutions are shown only on the left or right half of the graph. Thick gray line: exact; solid black line (right): Eq. (11); dotted line (right): Eq. (23); dashed line (left): Eq. (17); dot-dashed line (left): Eq. (19).

However, such an approach can lead to unphysical interference predictions [17].

R egion C.Between regions B and D (1  $1=R_{\rm tf}^{4=3} < r^2 < 1+1=R_{\rm tf}^{4=3}$ ) all three saddle points are in close proximity to t= 1 (w = 0 in the variables used to discuss region D). Linearizing about w = 0, one nds to leading order,

By introducing a small parameter,  $= (3^{1-3} r^{2-3} (R_{tf}^2 r^2))$ ; and changing integration variables to  $v = r^2 w^3 = 3$ , we can write the integrand in a power series in . Each term can be integrated by using a variant of equation (9), yielding

This expansion is rapidly convergent when  $\,$  < 1, corresponding to 1  $\,$  1=R  $_{\rm tf}^{4=3}$  < r² < 1+ 1=R  $_{\rm tf}^{4=3}$  .

Sum m ary: We have analytically calculated the density pro le for N noninteracting spin-polarized ferm ions in a d-dimensional harm onic trap. Four dierent expressions are needed to describe all parts of the cloud. The results from all four regimes are all sketched in gure 3 for the

case often particles in two dim ensions (corresponding to four led shells).
