## Status of the Ferm i surface in m ixed com posite boson - com posite ferm ion quantum H all states

We argue that the naively expected singularities of the Ferm i surface, in the mixed composite boson-composite ferm ion states proposed [S H.Sim on et al., PRL 91, 046803 (2003)] for the evolution of = 1 bilayer quantum H all system with distance, are obliterated. Our conclusion is based on a careful analysis of the momentum distribution in =  $\frac{1}{2}$  single-layer composite ferm ion state. We point out to a possibility of the phenom enon hitherto unknown outside K ondo lattice system s when, in a translationally invariant system, Ferm i-liquid-like portion of electrons enlarges its volum e.

] The nature and physics of the transition in the bilayer = 1 quantum Hall (Q H) system [1] between the wellestablished phases: one characteristic for the distances between the layers of the order of or sm aller than m agnetic length, som etim es described as \111" state, and the other for larger distances, described by two separate Ferm iliquid-like states of composite ferm ions (CFs) attracted recently the attention of experim entalists [2] and is the focus of several theoretical papers [3, 4, 5, 6]. Only references [4] and [5] m ake a prediction for a coexistence region between two phases, with a unique property, sem icircle law for the longitudinal and Hall drag resistance that was revealed in the experiments [2]. The reference [5] introduces a form of the ground state of the system that may continously interpolate between the 111 state, usually described by composite bosons (CBs), and the two seperate Ferm i-liquidlike states of CFs. The ground state proved to be a good variational ansatz when compared with the exact solution in num erical studies [5]. The form of the variational state for certain distance between the layers may be described as one in which classically speaking some of the electrons are in the 111 state (they make CBs) and the others participate in two Ferm i seas of CFs. Gradually the number of CFs increases as the distance becomes larger. Therefore the description easily accounts for the continous nature of the transition as observed in the experiments [2]. On the other hand the proposal that came st, based on a phase separated picture, [4], in which percolating puddles of one phase are in the other, well enough exibits the transport properties measured in the experiments. The advantage of the hom ogenous model ([5]), which accounts for the sam e transport properties, is that it also accounts for the strong 111 (interlayer) correlations that occur even deep in the CF region [2].

Here we study the Ferm i surface singularities in the proposed wave functions [5]. Naively they are expected at the Ferm im on enta directly related to the number of CFs in the particular partition of the overall number of electrons into CFs and CBs. The analysis begins with a careful study of the  $=\frac{1}{2}$  CF problem, so that the relationships found can be readily applied to the m ixed state case. We found that the CF m om entum distribution near the naively expected Ferm im om enta depend analytically on the distance to the Ferm im om enta, therefore showing no signature of the Ferm i surfaces.

Soon after Halperin, Lee, and Read [7] proposed their theory for  $=\frac{1}{2}$  fractional QH e ect Bares and W en [8] considered ferm ions in low dimensions interacting via a long range  $\frac{2}{j_{H}j}$  interaction. They used as a good ansatz for the ground state, a wave function of the Feenberg-Jastrow type,

where  $_{FS}$  denotes a Slater determ inant of lled Ferm i sea of free single-particle states. If m = 2 this construction is the RezayiRead [9] ground state, in the representation of CFs and when the projection to the lowest Landau level (LLL) is neglected, found to correctly captures the physics at  $=\frac{1}{2}$ . By doing a calculation of a random phase approximation (RPA) type on (1) Bares and W en found that the leading singularity of the momentum distribution near  $k_F$ , in two dimensions, is

where  $k = \mathbf{\tilde{x}} \mathbf{j} \quad k_F$  and  $n_k^\circ$  denotes the free-Ferm i-gas momentum distribution. They also remarked that if we interpret the rhs of (2) as the rst term in an expansion in powers of m we can write (near  $k_F$ )

W hat they did not emphasize is that if m = 2 and although we have a Luttinger-liquid type of expansion near  $k_F$  [10] there is no nonanalytic behavior due to the odd power of  $jk = k_F$  j and all trace of the Ferm i surface has been elim inated.

We can come to the same expressions employing the weakly-screening plasm a analogy [11], which in considering quantum mechanical expectations in the state, Eq.(1), m in ics Laughlin's plasm a approach [12]. In the Laughlin approach there is the perfect screening of the classical C oulom b plasm a, when interaction  $\frac{2}{\Re\beta}$  becomes screened as

where m is from  $=\frac{1}{m}$ , lling factor;  $=\frac{2}{m}$  is the plasma inverse tem perature, and  $s_o(k)$  is the static structure factor of the noninteracting particles, in this case bosons, so that  $s_o(k) = -$ particle density, and hence a perfect screening. M ore precisely it can be found [13] that the expansion in small m of classical statistic averages (to which quantum expectations correspond) is wellde ned, gives the results that can be found by other m ethods, and allow s continuation to larger than m = 1 values. In this context the screening is captured by the accustom ed in nite sum m ation of a geom etric series described by Eq.(4) and symbolically can be represented by the sum of diagram s as in Fig. 1

In the case of the weakly-screening plasm a analogy due to the presence of the free-ferm ion Slater determ inant in (1), the rst sum mation, (4), that is done while organizing diagram s, gets modiled, having for s<sub>o</sub> (k) the static structure factor of free ferm ion gas, which in two dimensions for small k can be found to be  $s_o^f(k) = \frac{3}{4}\frac{k_p}{2}k$ . This leads to not so perfect screening of the long-range interaction which becomes as  $\frac{1}{r}$  instead of lnr in real space. The approach introduced parallels the RPA calculation in Ref. [8] in getting (2) when Fig. 1 corresponds to an RPA sum mation with the value of the bubble equal to  $s_o^f(k)$  m<sup>2</sup>.

We want to see in more detail how the equal-time CF propagator can be found, and, possibly, which additional diagram s in its calculation would lead to the conjectured expression for the CF occupation number. It is instructive to rst consider how we can get the equal-time CB correlator i.e. G irvin -M acD onald correlations [14] in the Laughlin case using the diagram atic expansion [13]. As introduced by G irvin and M acD onald we in fact in the plasm a language have to deal with two in purities of charge  $\frac{m}{2}$  each, which do not interact directly. Therefore we have

where Z  $(z;z^{\circ})$  is the partition function of the classical 2D plasm a with inverse temperature  $=\frac{2}{m}$ , each particle with charge m, as before, and two impurities with charge  $\frac{m}{2}$  each at the locations z and  $z^{\circ}$ . (Z (z;z) is the partition function with one impurity of charge m at an arbitrary location because the value of the partition function does not depend on z.) W hat we expect is that the ratio will have the following form,



where f(z;z') represents the di erence in the free energy between the two con gurations. Indeed we can nd doing the simple expansion in m that the term right after the rst term (of value one) is

 $(=\frac{1}{2 \text{ m}})$ , which represents an elective screened interaction between two impurities and extract to minic (6), contributions of disconnected V<sub>eff</sub> (jz z<sup>0</sup>) parts that follow so that for the nalexpression we get




FIG.2: E ective diagram contribution

Therefore we can conclude that in calculating  $G_B(z;z')$  we have to exponentiate the value of the diagram shown in Fig. 2, and get, due to the screening, the fam ous algebraic decay.

Sim ilarly, applying the same type of approximation we can get in the CF case

where (the screening bubble is proportional to the static structure factor of free ferm ions and)  $G_F^{\circ}(z;z^{\circ}) = P_{\tilde{\mathcal{K}} \ltimes_F} e^{i \mathbf{k} (z - z^{\circ})}$  is the equal-time correlator of free Ferm i gas. To x the normalization we demand that the to-tal number of CFs is the same as of noninteracting particles so that

and  $G_{F}^{\circ}(0) = G_{F}(0)$  follows. Therefore

And indeed by taking  $n_k = e^{i\kappa r} G_F$  (r) and considering the rst nontrivial contribution in the expansion of the exponential in (11) we get

exactly the same expression as Eq.(86) of Ref. [8]. Once we specify that k is near  $k_F$ , assume a at Ferm i surface and neglect the contribution of the (weakly) screened interaction in (12) we can get, as in [8], the leading singularity in  $n_k$  given by Eq.(2).

But unfortunately after a suitable regrouping of free-Ferm i-gas occupation numbers we can prove that the second nontrivial contribution in the expansion of the exponential (with the neglect of the screened interaction) is equal to zero. That does not mean that the conjectured contribution (Eq.(3)) is absent. Here we have very likely the situation that due to the nonanlytic nature of the attempted expansion in the CF case we can not generate corrections to the term s linear in m. That conclusion supports also the nding [13] that when the same expansion was applied in the calculation of the static structure factor of the CF state a rst correction to the RPA result could not be generated although it was expected on the grounds that the correction would have made the infered LLL-projected static structure factor positive de nite what by its de nition it should be.

Therefore, very likely the exponential prescription (used to get Eq.(3)) is a valid one although there is no straightforward expansion to prove it. Once we accept the prescription we are left to wonder where is the expected nonanalyticity at  $=\frac{1}{m}; \frac{m}{2} = \text{odd}$  integer (see Eq.(3) for that case). A trace of the real Ferm i-surface nonanalyticity at  $\frac{m}{2} = \text{odd}$  integer may be seen in the expansion only if we take into account the screened interaction (second part) in Eq.(12). As an elective contribution from this part we have

where  $s_o = \frac{3}{4} \frac{k_F}{2}$ . If we apply the exponential prescription again, taking also into account this second contribution, we have, with  $\frac{1}{2 m s_o}$  c and, for  $\frac{m}{2} = 1$ , for the contribution in the vicinity of  $k_F$ ,

Here a (weak) nonanalyticity is retained. Namely, in Eq.(14) we have singular (at  $k_F$ ) the second derivative of j kjexpfcj kjln j kjg with respect to j kj. Therefore, a trace of the Ferm isurface at  $=\frac{1}{m}; \frac{m}{2} = 1$ , is present because of the found nonanalytic behavior. (Such a behavior exists also for  $\frac{m}{2} = \text{odd} > 1$  but is weaker having singular higher derivatives.)

In the following we will give an example where aforem entioned mechanism for getting the Fermi surface (nonanalyticity) does not work due to strong correlations of the CFs with other particles of the system. This is the case of the mixed CB - CF quantum Hall states proposed in [5] to describe the evolution of the bilayer = 1 QH system with distance between layers.

If we neglect the LLL projection again and assume that for our purposes we can also neglect the overall antisym – metrization between CB and CF parts that makes the mixed state completely antisymmetric and an electronic wave function, we can write it in the quasiparticle representation as

where  $z_*$  and  $z_{\#}$  denote CB coordinates and  $w_*$  and  $w_{\#}$  denote CF coordinates with arrows specifying to which layer quasiparticles belong. The total numbers of bosons are equal as well the total numbers of ferm ions, and  $n = \frac{m}{2} = odd$  integer.

W e want to nd out (the asymptotic behavior of) the equal-time correlator of a CF (belonging to one of the layers). It is not hard to conclude that in this case with assumptions similar to the ones done in the single-layer case, we get  $G_F(w;w^{\circ})$  by simply taking for the value of the \polarization" bubble -

instead of  $m^2 s_0^f (k)$  only in Eq.(11), where b denotes the total (up plus down) density of bosons and in  $s_0^f (k)$  we have to take  $k_F = \frac{1}{4} \frac{1}{f}$  where f is the density of ferm ions of one layer only. In this case we work with a completely screened interaction between the two in purities which does not produce nonanalytic contributions.

Therefore we nd that at the total llings of bilayer at which we can expect bose-ferm im ixed states,  $=\frac{2}{m}$ ; m = 2;6;::: the naively expected Ferm i surface(s) can not exist due to our analysis. This outcome rem ind us of the similar disappearance of the sm all (naively) expected Ferm im omentum in the K ondo lattice system s [15, 16] due to the Luttinger theorem [17]. In the case considered in the paper we do not know for sure if we deal with (overall) Ferm i-liquid-like states and a complete analogy (in which CBs and CFs play the roles of of localized spin 1=2 local m om ents and conduction electrons respectively) is still m issing. Further insights into the physics of the m ixed states are necessary.
