## Quantum impurity approach to a coupled qubit problem

A bstract. { We consider a system of two qubits at the ends of a nite length 1D cavity. This problem is mapped onto the double-K ondo model which is also shown to describe the low energy physics of a nite length quantum wire with resonant levels at its ends. At the Toulouse point the ground state energy and the average populations and correlations of the qubits or resonant levels at zero tem perature are computed. These results show that the e ective interactions between the qubits or resonant levels can be used to probe their associated K ondo length scale.

C avity quantum electrodynamics (Q ED) concerns the study of atom s coupled to discrete quantized electrom agnetic modes in a high-Q cavity. Recent experiments performed with Rydberg atoms in a microwave cavity have shown how Q ED can be used to create and manipulate entanglement between atoms and the quantized electrom agnetic eld (see [1] for a review). Experiments performed on a variety of Josephson devices have demonstrated their potentialities as articial two-level systems suitable for quantum state engineering (see [2] for a review). These considerations motivated a recent proposal [3] for a Q ED-type quantum computing architecture based on C coper pair boxes embedded in a super-conducting transmission line.

A llthese of ED schemes consider the coupling of a single quantum electrom agneticm ode to the qubits and the theoretical analysis is performed using the Jaynes-Cummings Hamiltonian which relies on the rotating wave approximation. However, in a su ciently large cavity a large number of modes exist. Whereas in the weak coupling regime the single-mode approach and the rotating wave approximation are expected to give correct results, this is not the case when the qubits are strongly coupled to the transmission line. For instance, Leclair et al. showed [4,5] that the exact spectrum of a single qubit coupled to an in nite transmission line is considerably richer than the spectrum of the Jaynes-Cummings Hamiltonian. In the same model the average population and uctuations of the qubit at zero temperature have also been studied [6]. But so far, very little is known on the correlations between several qubits strongly coupled to such an environment. In this regime, neither the Jaynes-Cummings Hammiltonian nor perturbation theory in the qubit/cavity coupling are expected to work. The purpose of

this letter is to study these correlations in the strong coupling regime using techniques and concepts developed in the context of quantum impurity problems.

In this letter, we consider the coupling of two qubits through a transm ission line of length L (see g. 1). U sing a mapping onto the double-K ondo m odel we study the correlations between the two qubits induced by their interaction via the transm ission line. At the Toulouse point of the double-K ondo m odel we obtain an explicit description of the ground state and low energy excitations of the system. The inter-qubit correlations at T = 0 K are computed exactly and shown to depend on intrinsic length scales associated with each qubit (K ondo lengths). D epending on the ratio of these K ondo lengths to L the system ows from a K ondo regim e where each qubit renorm alizes to a conform ally invariant boundary condition and is not in uenced by the other to a correlated regim e where the degrees of freedom of the qubits get dressed and coupled by the transm ission line. This crossover occurs when the K ondo lengths associated with each qubits are com parable to the size L of the system . K ondo cloud physics in a nite system with a single quantum in purity has recently received attention [7]. W e point out that any system described by the double-K ondo m odel provides a way to probe the interplay between K ondo cloud physics and interactions in a nite size system with two quantum in purities.

O riginally introduced in string theory within the context of tachyon instabilities [8] the double-K ondo model not only describes the two-qubit problem but may also be relevant in m esoscopic physics. We show that it describes the low energy behavior of a nite length 1D quantum wire coupled by tunnel junctions to two resonant levels (see g. 2). The quantities of interest are the average occupation numbers of each resonant level and their correlations. The device of g. 2 m ay be realized using conventional lithography techniques. We think that it could provide a complem entary route to explore the physics of coupled quantum in purities underlying the system of g. 1.

The quantum circuit of g. 1 consists of two Josephson charge qubits built from Cooper pair boxes in the charge regime [2] capacitively coupled to a quantum transmission line. For convenience, each qubit is labelled by its position along the transmission line: j = L or 0. In the continuum limit the quantum transmission line is described in terms of a free bosonic eld

(x) and its conjugated eld (x) ( L x 0) related to the charge and current densities along the line:

where  $v = 1 = \frac{p}{lc}$  is the wave velocity along the transmission line and  $R = \frac{p}{lc}$  is the resistance of the sem i-in nite line both expressed in terms of the line's capacitance c and inductance lper unit of length. The low-energy elective H am iltonian of the system depicted on g.1 is then:

where the st term represents the bare qubit H am iltonian [2]. The elective magnetic eld  $B_j^z = 2e^2(1 \quad 2n_j^G) = (C_j^J + C_j^G)$  depends on the externally controlled gate voltage  $V_j^G$   $(n_j^G = C_j^G V_j^G = 2e)$ . Here  $C_j^J$  and  $C_j^G$  respectively denote the Josephson junction and gate capacitances of qubit j. The Josephson energy  $E_j^J$  can be controlled by applying an external ux through the loop of the SQUID device. The second term in (2) is the free transmission




Fig. 1 { Two Cooper pair boxes capacitively coupled to a quantum transmission line (equivalent circuit). The electric charge stored in the dashed box is conserved.

line H am iltonian. The third one couples the qubits to the transm ission line with dimensionless coupling constants

This Ham iltonian is a generalization of the M axwell-B loch Ham iltonian which has been used for modelling the interaction of two-level atom s with radiation [4]. Using the polaronic transformation,  $U = \int_{j}^{j} \exp(i j) (\int_{j}^{z} + 2n_{j}^{G}) (1) = 2$ , (2) can be transformed into the double-K ondo Ham iltonian:

Here  $B_j^z = 4E_j^c (1 - 2n_j^G)$  where  $E_j^c = e^2 = 2(C_j^J + C_j^G + C_j)$  is the charging energy of the qubit j. This model should not be confused with the two in purity K ondo model where the two magnetic in purities are in an in nite environment [9].

In the present physical situation, the total charge stored in the transmission line and the coupling capacitances is zero (see g. 1). Assuming for simplicity  $_0 = _L =$ , this xed charge constraint reads in the K ondo form ulation:

U sing bosonization and taking care of K lein factors, the double-K ondo H am iltonian with the same constraint can be shown to describe the low-energy physics of a 1D quantum wire of length L with resonant levels at its ends (see g. 2). The elective low-energy theory of an isolated nite length Luttinger liquid [10] is characterized by a renorm alized Ferm i velocity v and a dimensionless interaction parameter g (g = 1 for the Ferm i liquid). This interaction parameter is related to by  $^2 = -g$ . The Josephson energies are then proportional to the tunneling am plitudes between the wire and the resonant levels:  $E_j^J / t_j = P_a$  where a is a m icroscopic length scale (UV cuto ). The magnetic elds  $B_j^z$  are related to the resonant level chem ical potentials. The xed charge condition (5) is obtained by working in the canonical ensemble: the total number N of electrons in the wire plus the resonant levels is xed. In this case, the rhs. of (5) is equal to N + 1 where  $e^{2i} = e^{i(L_a - 0)}$  and j denotes the phase relating right to left moving fermions at the wire's ends: R (j) =  $e^{ij}$  L (j).

The one-channel single in purity K ondo model consisting in a spin 1/2 coupled to a free boson on the half line has been shown to be integrable [11,12]. Following [15] we conjecture

that the double-K ondo problem is integrable for  $_0 = _L$ . This opens the door to a general study of the therm odynam ical properties of the double-K ondo m odel using integrable eld theory techniques [13,14] as done for the double sine-G ordon theory [16]. Such a study would go beyond the scope of the present letter and we shall therefore restrict ourselves to the Toubuse point where the problem can be treated in terms of ferm ions.

Ferm ionization of (4) is achieved by unfolding the free non-chiral boson onto a chiral boson  $_{R}$  (x) living on an interval of length 2L and, for  $^{2}$  = , introducing the free chiral ferm ion  $e^{2i}$   $_{R}$  on  $[_{L};L]$ . Then, taking d  $_{L}$  =  $^{+}_{L}$ , d<sub>0</sub> = (1)<sup>n L</sup>  $^{+}_{0}$  and  $_{R}$  (x) = (1)<sup>n + n</sup>  $_{L}$  (2 a)  $^{12}e^{i\frac{\pi}{4}}$   $_{R}$  (x) (n<sub>j</sub> = (1  $_{1}^{z})=2$ ) de ness a Jordan W igner transform ation which turns the boundary spins into ferm ionic degrees of freedom anti-commuting with the chiral ferm ion  $_{R}$ . Because of the xed charge condition, the ferm ionic eld picks up a phase between L and L which depends on the gate voltages:  $_{R}$  (x + 2L) =  $e^{2i} = \frac{1}{R}$  (x) where  $r_{D}^{G} + n^{G}_{L} + 1=2$  (m od 1). The ferm ionized form of (4) is then:

Boundary interactions H  $\frac{0}{1}$  are given by:

where N denotes the total number of fermions in the system. Because of the (1)<sup>N</sup> operator in H<sup>@</sup><sub>L</sub>, we are not yet dealing with free fermions. The xed charge contraint (5) simply means that the total number of fermions is xed as well as the phase. Therefore (1)<sup>N</sup> is a phase that can be absorbed in a rede nition of d<sub>L</sub>. But as we shall see, (5) leads to unexpected subtleties in the computation of the therm odynam ical properties of the system as functions of the physical parameters of the original qubit problem.

Since we are now dealing with free ferm ions, the ground state energy can be computed by summing one-particle energies up to the appropriate Fermilevel. These are determined by the stationary wave condition:

where  $R_j(k) = (k \quad k_j \quad i_j^{-1}) = (k \quad k_j + i_j^{-1})$  denotes the rejection matrix at boundary j. It can be expressed in terms of the boundary parameters  $j = 4 \sim^2 v^2 = a (E_j^{-1})^2$  and  $k_j = B_j^{-2} = v$ . As seen from  $R_j(k)$  expression, each qubit in uences the modes of the line around  $k_j$  on a momentum scale  $j^{-1}$ . Up to a numerical factor, v = j is the energy scale associated with the K ondo boundary interaction  $\binom{1}{2}$  ( $\sim !_B$  in [5]). At zero temperature, the nite frequency conductance of a Luttinger liquid with an impurity as well as the spectral function in dissipative quantum mechanics are functions of the variable  $!=!_B$  [17]. Moreover, the enveloppe of Friedel oscillations in a Luttinger liquid at g = 1=2 is a function of the variable  $!_B x=v_F$  [18]. In this sense, j may be viewed as the K ondo length associated with each qubit.

W e used the technique developed by Chatterjee for the 2D Ising m odel [19] to obtain an integral representation for the free energy of the system and therefore for its ground state

energy. The nalresult is:

where X  $(k) = e^{2i(kL}) R_0(k)R_L(k)$ . The rst term, proportional to L is an extensive bulk contribution which does not depend on the qubit parameters. The second one is a boundary contribution which involves one boundary at a time. It will therefore not contribute directly to the correlations between the two qubits. Nevertheless, it contributes to the average population giving back the expected contribution for a resonant level connected to a sem i-in nite Ferm i liquid [20]. Correlations between the qubits are contained in the third term.

Equation (10) should how ever be taken with care. It corresponds to the energy of a ground state where only negative eigenstates are lled. But then, each time a one-particle energy level crosses zero, eq. (10) undergoes a discontinuity of its rst derivative. On the other hand, the xed charge constraint (5) tells us that the physical ground state of the system corresponds to a D irac sea lled up to a Ferm i level that varies with the physical parameters of the problem without crossing any one-particle energy levels. The physical ground state energy that incorporates the xed charge condition should indeed be an analytical function of the qubit parameters. This is very sim ilar to the analytical continuation introduced in [15] for the double sine-G ordon theory. U sing the sam e m ethod as for the ground state energy (10) integral representations for the populations and correlation of the qubits can be obtained and evaluated num erically, taking into account the xed charge condition. Results depicted on gures 3 and 4 are obtained by this procedure.

Let us now discuss the results on correlations between the qubits induced by the transm ission line. They are expected to depend on the ratios of  $_{\rm L\,;0}$ =L.Naively, strong correlations may be expected when at least one of these lengths becomes comparable or larger than L, meaning that both qubits belong to the same large K ondo cloud. But indeed, only states whose wave vectors k satisfy jk  $k_{\rm j} j_{\rm j}$ . 1 are significantly localized on the site associated with qubit j. Therefore strong correlations only occur when both K ondo lengths are comparable to L. For the same reason, it is also necessary that the two qubits in uence the same modes of the line. This criterion should be seen as a variant of the exhaustion principle introduced by N ozieres. Finally, strong correlations occur when both  $_{\rm j}$  are much larger than L and near degeneracy points B  $_0^2$  B<sup>2</sup> L.




Fig. 3 { A verage population  $h_0 i$  and correlation  $C = h_0 ihn_L i h_0 : n_L i$  in the symmetric case  $E_0^J = E_L^J$  such that  $_0 = _L = 200 L$ . For the correlation, only the part with  $k_0 \quad k_L$  has been represented since, in this case, C is an even function of  $k_0 \quad k_L$ .




Fig. 4 { The correlation C for L = 0 = 20, 0 = L = 200.

For  $_0$  L and  $_L$  L the stationary wave condition (9) has two solutions that tend to  $k_0$  and  $k_L$  with vanishing Josephson energies. Correlations appear when one of these special one-particle states is lled. Fig. 3 displays the average population of the x = 0 qubit and the inter-qubit correlation C =  $m_0 \lim_{L} 1$   $m_0 : n_L i$  as a function of the di erence  $k_0 = k_L$  and of N i + in the regime  $_0 = L$  L. Fig. 4 shows the inter-qubit correlation in terms of the same variables but for di erent K ondo lengths illustrating the in uence of asymmetry ( $_0 \in L$ ): C still reaches its maximal value 1=4 but in a narrower zone. The two one-particle states close to  $k_0$ ;  $_L$  give rise to an elective two-level system for the two lowest energy states of the system. Its elective H am iltonian can be computed for  $^2 < 2$  using perturbation theory on the double-K ondo H am iltonian  $\binom{2}{}$ . This approach is valid as long as  $LE_j^{J} = -v$   $^2(L=a)^{2=2}$ . At degeneracy  $B_0^{Z} = B_L^{Z} = B_L^{Z}$  and for 0 < u < 1, where u = 3=2  $(m_0^6 + n_L^6) + B^z L = ^2$ , the elective H am iltonian in the space generated by j'''' if  $(m_0^6 + n_L^6) + B^z L = ^2$ , the elective H am iltonian is of the space generated by z''' + z''.

The correlation is then equal to C = 1=4(1 + X<sup>2</sup>) and the energy separation between the ground state and the rst excited state is given by 2  $1 + X^2$ . For  $E_0^J = E_{L}^J$ , the two-qubit entanglement is maximal and the ground state is given by  $\frac{1}{2}$  (j"#i+ j#"i) j ( $r_0^G$  +  $n_{L}^G$  1); f0gi. Note that nevertheless entanglement is bst when going back to the original qubit problem because of the orthogonality e ect induced by the polaronic transformation: qubit states j#"i and j"#i get correlated to di erent states of the transmission line whose scalar product goes as (a=L)<sup>2=</sup>. As expected, entanglement can appear in the original qubit problem for small<sup>2</sup>: for  $E_j^c$ ;  $E_j^J$  ~v=L integration over the modes of the line gives an e ective static coupling of the form (v<sup>2</sup>=4L)  $_0^z$   $_L^z$ . This is the regime usually considered for quantum computation.

W hen one of the j is much smaller than L, the corresponding qubit renormalizes onto a conformally invariant boundary condition. This regime is reached in the limit of very large Josephson energy and corresponds to the strong coupling limit of the K ondo problem. The corresponding quantum in purity is totally screened and therefore is not seen by the other one. Then, when either  $0 ext{ L or } L ext{ correlation C}$  is expected to vanish (K ondo regime). This is con med by our exact results but we can also study the crossover where one of the j is much larger than L and the other varies. For L L and 0 L, our analysis for  $2 ext{ predicts a maximum}$  absolute value of correlation between the qubits decaying as 1=4(1 + L = 0). Fig. 5 displays the maximal C as a function of L =  $0 ext{ and } L = 1$ .

To sum marize, we have described a com mon approach to the problem of two qubits coupled via a nite length quantum transmission line and to the problem of two resonant levels at the ends of a nite length quantum wire. These two problem s can be mapped to the double-K ondo model with a xed charge constraint. At its Toulouse point, we have solved the model exactly enabling an explicit analysis of the correlation between the quantum in purities (qubits or resonant levels) through their com m on environment. The emergence of correlations is related to the overlap of the in uence zones (K ondo clouds) of each quantum in purity in reciprocal space. We stress that the same techniques can be extended to obtain results on dynam ical correlation fonctions. This gives a direct access to the absorbtion spectrum of the system

when excited by a microwave radiation sent on one of the available gates. The correlations between the charge of each qubit and the charge density along the line can also be obtained exactly as well as the Friedel oscillations induced by the resonant levels at the ends in the quantum wire problem. These correlations provide a direct insight into the K ondo cloud in real space.

Based on our study at the Toulouse point and on the perturbative approach at  $^2 < 2$ , our conclusions on the role of K ondo lengths on inter-qubit correlations should hold for  $^2 < 2$ . This remains to be fully con med by analytical computations in the non perturbative regime away from  $^2 =$ . From an experimental point of view, the quantum wire design is suitable for exploring the region around the Toulouse point. Since transmission line impedances are in the current status of technology bounded by a few hundred 0 hm s, the qubit design is unfortunately limited to . 0:3 but both schemes provide complementary ways to explore the same physics.
