equilibrium dynamics in the 3d-XY system

Abstract. We investigate through M onte C arlo simulations the non-equilibrium behaviour of the threedimensional XY-m odel quenched from a high temperature state to its ferrom agnetic and critical phases. The two-times autocorrelation and response functions are determined in the asymptotic (scaling) regime, from which the nonequilibrium exponents and critical ^c are extracted. The form of the scaling function is in agreement with the prediction of local scale-invariance. The so-called limit uctuation-dissipation ratio X₁ is shown to vanish in the ordered phase and to reach a constant value around 0:43 for the critical quench.

1 Introduction

A fler the investigations on aging in glass models, [1,2,3] e orts have been concentrated on the study of nondisordered model systems since it was soon realized that some of the basic aspects of aging are present in sim – ple systems too with some caracteristic features. [4,5] In most studies, special attention is put on pure ferrom agnetic models undergoing a second order phase transition. Typically, one cools down a sample initially prepared in its high temperature phase to its ordered phase. A stime is running, domains start to grow with a linear size $1 t^{1=z}$. In the therm odynamic limit, equilibrium is never reached which im plies an in nite relaxation time.[6] In order to probe aging, which im plies a full dependence on the past evolution, it is useful to com pute two-times correlations:

where is the order parameter, t the observation time and t_w the waiting time (t).

U sually, at a coarse-grained level, the dynamics of such system s is described by a Langevin equation:[6]

where H is the free-energy functional, i(t) is a thermal gaussian noise at site i with:

A sm entioned above, the breakdown of time translation invariance in plies that the two-time functions do not merely depend on t t_{w} but explicitly on t and t_{w} . On the bases of general scaling arguments, one postulates the follow-ing scaling laws for the autocorrelation and autoresponse functions:

In the asymptotic limit, where t t t 1, f_c and f_R decay algebraicly:

where z is the dynam ic exponent and $_{C,R}$ are respectively the correlation [7] and response exponents.[33]

A consequence of the breakdown of time-translation invariance is the violation of the uctuation-dissipation theorem (FDT) which relates for equilibrium systems the response to the correlation function via:

W hen the system is not at equilibrium $R(t;t_w)$ and $C(t;t_w)$ both depend on t and t_w , and the FDT (8) does not hold anym ore. One introduces a new function X (t;t_w) de ned by:[5]

which m easures the deviation from equilibrium. In some mean-eld theory of glassy systems, where it was rst formulated, the uctuation-dissipation ratio (FDR) X ($t_i t_w$) depends on time only through a functional dependence on C (t;t_w),[2] that is X = X (C (t;t_w)). In this case, integrating (9) with respect to t_w , one gets T $\sum_{c \ (t, r_w)}^{\infty} X \ (C^0) dC^0$, so that the slope of the param etric plot susceptibility versus the correlation function C will give the FDR. In the asymptotic regime, for such pure ferrom agnetic models, the FDR reaches a constant value X_{1} after an initial quasi-equilibrium regime where X = 1(FDT valid). It was argued that this asymptotic constant is universal and characterises the non-equilibrium process.[11] W hen a ferrom agnetic system is quenched toward its ferrom agnetic phase, the long-time dynam ics is governed by the di usion of dom ain walls and the coarsening of domains. This coarsening leads to a vanishing FDR $X_1 = 0$. [5,8,9,10]. The scaling functions de ned previously are full lling this requirem ent. In the case of a critical quench, that is exactly at the critical tem perature, several studies on various systems have given some insights. In that case, the reason for aging is related to the developm ent of the spatial correlations over a length scale that grows as $t^{1=z_c}$ where z_c is the critical dynam ic exponent. So the system is still disordered over a length scale larger than (t), while it looks critical in regions smaller than (t). In the therm odynam ic lim it, the equilibration is unaccessible since the system is of in nite size so

inde nitely increases. For a fully disordered initial state, one has in the kinetic sphericalm odel $X_1 = 1$ 2=d for 2 < d < 4 and $X_1 = 1=2$ ford 4,[11] in the 1d G lauber-Ising model $X_1 = 1=2.[11,12]$ For algebraic initial correlations, it was shown on the kinetic sphericalm odel that there exists a rich kinetic phase diagram, depending on the space-dimension d and the algebraic decay exponent !,[33] where the lim it value X_1 is either vanishing or depending on d and !. In the 1d G lauber-Ising m odel, it was shown that X_1 is independent on !.[13] A system atic eld-theoretical approach was developped to calculate the lim it FDR [14] and applied to several models, ferrom agnetic system s at criticality, dilute Ising m odel, model C dynam ics.[15,16,17] Simulations in 2d system s gave $X_1 = 0.34$ for the Ising model, [31,18] $X_1 = 0.41$ for the three states Potts model, X = 0.47 for the 4states Pottsm odel.[32] In 3d, $X_1 = 0.40$ was obtained for the Ising model.[11] Recently, performing a Monte Carlo simulations with G lauber dynamics, we found from the susceptibility versus correlation function slope a continuously varying FDR in the 2-d XY model quenched below the Kosterlitz-Thoulesspoint.[19] But in this case, one has to use with great care this slope, since the actual de nition of the FDR X₁ leads to a logarithm ically vanishing result. In this paper, we present the results obtained on the 3-d XY model quenched onto criticality and below.

2 The 3d XY-m odel

The XY-model is one of the most popular theoretical models. As it is well-known, in the two-dimensional case

there is no nite magnetization at non-zero temperature, but nevertheless there is indeed a topological phase transition occuring at nite temperature due to vortex pairing.[20,21] In three dimensions, the scenario is more conventional since the additional dimension permits the existence of an ordered phase at nite temperature. Thus, the 3d-system presents a second-order phase transition which is probably related to the density of vortex-strings [22,23]. The ham iltonian reads:

where i, j are nearest neighbour sites on a cubic lattice and the S_i are two-dimensional classical spins whose length is set to unity. From high-temperature series analyses, the predicted critical inverse temperature is [24]: $_{\rm c} = 1 = T_{\rm c} = 0.4539$ 0.0013. In our simulations, we use the value $_{\rm c} = 1 = T_{\rm c} = 0.4542$ obtained from a Monte C arb study [25]. The critical exponents have been estimated by renormalisation group techniques and - expansions.[26,27] In our study we take the values of the critical exponents obtained in ref.[28] from a numerical approach:

Simulations on the three-dimensionalXY model with periodic boundary conditions have revealed that the critical dynam ics exponent z_c is close to 2 [29,30]. For a quench below the critical temperature, that is in the ordered phase, one has z = 2.[6]

3 N um erics

We simulate the dynamics through a single spin- ip algorithm of G lauber like form where the transition rates p related to the single ip f $_{i}g! f_{i}^{0}g$, where the same the angular variables of the X Y model, reads:

with the inverse temperature. One may notice here that the M etropolis algorithm, with transition rate $p = m \ln [1; exp(E)]$, leads to the same time evolution of the autocorrelation and susceptibilities, as we have checked it.

The two-times autocorrelation function is calculated via

C (t; t_w) =

where the brackets h i stand for an average over initial con gurations and realisations of the therm alnoise.

The two-times linear magnetic susceptibility (t;t_w) can be computed by the application of a random magnetic eld. The amplitude of the eld has to be small in order to avoid nonlinear e ects. The ZFC -susceptibility is usually computed utilising a random distributed eld via:[8]

where the line stands for an average over the eld realisations. Indeed, here we concentrate on a di erent approach which is based on the lines of ref.[31]. By de nition, the linear autoresponse function R ($t;t_w$) is

Following ref.[31], we can reexpress the linear response function in the form :[19]

where $\cos \frac{w}{i}$ and $\sin \frac{w}{i}$ are the components of the local W eiss magnetisation:

where $Z_i = \exp((H(_i;h)) + \exp((H(_i^0;h)))$ is the local partition function in the eld. Finally the uctuation dissipation ratio is calculated via

4 Results


4.1 Quenches below T_c

W e present the results obtained on system s of linear size L = 50, with periodic boundary conditions, quenched in the low-temperature phase from an in nite-temperature initial state. The averages are performed with the use of more than 5000 samples. The expected behaviour of the two-times autocorrelation function for coarsening processes is at su ciently long times [6]:



where $M_{eq}(T)$ is the equilibrium magnetisation at the tem perature T. In order to check this behaviour, we have simulated quenches at two dimensterm peratures, T = 0.9 and T = 1.5, using the G lauber like dynamics. The results are shown respectively on gure 1 and 2.

For small time separations, we clearly see that the correlations rapidly decay to the expected plateau values M $_{\rm eq}^2$ (T), here estimated numerically by the use of an independent W ol algorithm simulation.[34,35] For large time separations, the system enters in a scaling region where the correlation functions are described by a scaling function $f_{\rm C}$ of the variable x = t=t_w . As expected, the aging scaling function nally decays algebraicly in the asymptotic limit with an exponent $_{\rm C}$ roughly about 1:7 0:1. However, we clearly see that as the temperature is increased the nite-size e ects become stronger.

If one accepts the value $_{\rm C}$ = 1:7, since it is very close to the free eld value $_{\rm C}^0$ = d=2 = 1:5, one can expect a scaling form of the two-times autocorrelation function not too far from the free-eld form :[36]

A coordingly, we have replotted in the inset of gure 2 the two-times autocorrelation as a function of the scaling variable $y = \frac{(x+1)^2}{4x}$. Within this new scaling variable, the power-law form, with $_{\rm C} = 1.7$, is remarkable.

In the low-temperature phase, the behaviour of the two-times response function had been conjectured to be (see Ref. [4] for a review):



where the scaling function $f_R(x) = x = z$ at x = 1. Furtherm ore, if one assumes that the response function transforms covariantly under local scale-transform ations, one expects for the scaling function f_R [37,38]

where r_0 is a norm alization constant. For a disordered initial state we expect [36] $_R = _C = , w$ ith the nonequilibrium exponent bounded by [39,7,40]: d=2 d, where d is the euclidian dimension of the system.


We have computed the autoresponse function at tem – peratures T = 0:9 and T = 1:5. On gure 3 and g-ure 4 (left), assuming that a = 1=z = 1=2,[41] the rescaled response function is plotted as a function of t=t_w. The

collapse of the di erent waiting tim e curves is quite good. The value a = 1=2 had been already found numerically and analytically in the 3D G lauber-Ising model [38,9] and the 3D kinetic sphericalm odel [33,11]. We have perform ed an analysis at xed ratio t=t_w that corroborates the power law prefactor in (21) with a close to 1=2 at large t=t_w as seen on gure 4. In fact, numerically we obtain a value which is slightly larger than 1=2, around 0.6 but the tendency when increasing t=t_w is toward the decrease of the e ective a value.

Due to important thermal uctuations the algebraic regime x $R^{=Z}$ is hardly accessible. However, our datas seem to validate the relation C = R as it can be seen on gure 3 and gure 4 for T = 0.9 and T = 1.5 respectively. Moreover, as it can be seen from gure 3 and 4, the scaling

form (22) predicted from local scale invariance is perfectly reproduced by our datas with $r_0 = 0.18$.




Fig. 5. Rescaled Fluctuation-Dissipation ratio X t_w^a for a quench in the ferrom agnetic phase at T = 0:9. The inset is a parametric plot of X versus correlation function.

As discussed in the previous section, the asymptotic value of the uctuation-dissipation ratio X_1 is expected to vanish in the low temperature phase. A sum ing that $_{\rm C}$ = $_{\rm R}$, the uctuation-dissipation ratio evaluated from the asymptotic behaviour of (19) and (21) vanishes as:

where $f_x(x)$ is a scaling function related to $f_c(x)$ and $f_r(x)$ with $\lim_{x \le 1} f_x(x) = \text{const}$; a time-independent

constant.On gure 5 we have plotted the rescaled FDR obtained numerically at T = 0:9, assuming a = 1=2, for di erent waiting times as a function of t=t_w. We see a very good collapse of the di erent waiting time datas. The solid line is the expected scaling form obtained from the de nition of the FDR together with the scaling functions f_C and f_R assuming the local scale prediction with $r_0 = 0.18$. A symptotically, the scaling function f_X reaches a constant value:

which is close to 0:08 at T = 0:9. In the inset graph of gure 5, we have represented the FDR X (t;t_w) as a function of the autocorrelation function C (t;t_w) for di erent waiting times, where we see the vanishing of the X ratio as the correlation decay.

4.2 Critical quench

We focus now on the critical quench starting from a high-tem perature initial state. In the vicinity of the critical point, the magnetisation at equilibrium behaves as $T_c j_{eq} = and$ with $e_q = t_e^{1=z_c}$, one expects for the two-times autocorrelation function the form :

The expected scaling for the autoresponse function is given by


The scaling functions $f_{C,R}^c$ are expected to decay algebraicly at large time separation with the same exponent ${}_R^c = {}_C^c$, how every dimension of the low-temperature one.

The numerical calculations have been performed on periodic cubic lattices of linear size up to L = 50 and the physical quantities have been averaged over 5000 noise realisations. On gure 6 we have plotted the rescaled twotim es autocorrelation functions for di erent waiting times. The collapse of the rescaled functions is very good, in agreement with the form (25). Moreover, at large t=tw we clearly see a power-law behaviour from which by an algebraic two extracted the exponent ${}_{\rm C}^{\rm c}$ =z_c ' 1:34 that full lis the scaling bounds d=2 ${}_{\rm C}^{\rm c}$ d (remember that z_c is close to 2). A nalysing more carefully the datas, we obtain a serie of estimates for the exponent ${}_{\rm C}^{\rm c}$ =z_c that are represented on gure 7.0 ur nalestimate is

We have also explored the nite-size e ects in more details. For that purpose we have studied the time evolution of cubic systems of linear sizes L = 10;20;30 and 40.Assum ing that





Fig.7.E ective exponent $_{\rm C}^{\rm c}$ =z_c for di erent waiting times as a function of t obtained from system s of size L = 50.

with b = L we obtain the scaling form


On gure 8, we have plotted F for di erent sizes at xed ratio x $t_w = L^{z_c} = 0$:1 as a function of $t=L^{z_c}$. Taking into account (25) and (29), we expect that the scaling function F has an algebraic decay with the exponent $_c^c = z_c$ for t not too large. The collapse of the curves is quite good. For earliest times the system is still in quasi-equilibrium and for biggest times the growth of correlated domains is limited by the size of the system . The num erical datas seem to validate the scaling assumption (29).

We focus now on the autoresponse functions com puted with form ula (16). The quantities are quite noisy since them al uctuations are of the same order as the am plitude of the response at long times. From (6), one should have a = b and $C_{R}^{c} = C_{C}^{c} = C$ since the initial state is

fully disordered.On gure 9, the rescaled autoresponse is represented as a function of t=t_w for several waiting times t_w.We see that the decay of the autoresponse function is compatible with the algebraic assumption with $_{p}^{c} = z_{c} = -c = z_{c} ' 1:34$.


As stated previously, the out-of equilibrium behaviour is somehow characterised by the FDR X (t;t_w), calculated numerically via (18). Assuming the scaling forms of the two-times autocorrelation and response functions, the FDR is supposed to be a function of the ratio t=t_w only. This behaviour is well reproduced on gure 10, where we have plotted the FDR X (t;tw) as a function of tw =t calculated on a system of linear size L = 30, and for di erent waiting times. In the long time limit tw =t ! 0, the FDR approaches a constant value, around 0:4, but due to the numerical noise, basically related to the numerical derivative of C (t;tw), it is di cult to give a more precise value. How ever, if one supposes an asymptotic linear form

In ref. [15], the limit FDR was calculated in an expansion. The two-loop expansion leads to a value $X_1 = 0.416(8)$ that perfectly ts, within the error bars, our estimate.

5 Conclusion and outboks

W e have studied the relaxation behaviour of the 3D XY – m odel quenched from its high temperature state to its ferrom agnetic phase and at criticality. Through M onte C arlo sin ulations, we have computed the autocorrelation function and its conjugate response function on cubic lattices of maximal linear size L = 50. From our datas, we have com med the general scaling scenario at and below criticality. The autocorrelation non-equilibrium exponent $_{\rm C}$ below T $_{\rm c}$ was found to be around 1:7. The scaling analysis of the linear autoresponse function commed

the equality $_{\rm R}$ = $_{\rm C}$ = , expected for quenches from a fully disordered initial state. At criticality, we have con-

m ed that the correlation and response function behave as: C (t;t_w) = $t_w^{b} f_c^{c}$ (t=t_w) and R (t;t_w) $t_w^{1} f_R^{c}$ (t=t_w), with a = b = 2 = z_e . This conclusion has been supported by a nite-size analysis on system s of linear sizes L = 10;20;30;40 and 50. From the datas on the correlation function we extracted the value $c=z_c$ ' 1:34 for the nonequilibrium critical exponent and checked its com patibility with the response function datas. One may notice that this value is very close to that obtained in the 3d-Ising model, that is c ' 2:8.[7] It is remarkable to notice that the local scale-invariance prediction for the response function is very nicely ful led either at criticality and below . A though at criticality eld-theoretical approach [14] showed a deviation from the local scale invariance prediction, [15] it is very di cult to see num erically this very small discrepancy. In the ordered phase, since the nonequilibrium exponent is very close to the free-eld value d=2, we have shown that the autocorrelation function has a scaling form which is very close to that of the free-eld: C (t; t_w) = M $_{eq}^2 y$ = with the scaling variable $y = (x + 1)^2 = (4x)$ where $x = t = t_w$. The direct calculation of the FDR X ($t_i t_w$) showed that, as expected, in the low temperature phase it vanishes like X_1 (t;t_w) = t_w af_X (t=t_w) where f_X is a scaling function simply related to the local scale-invariance scaling functions f_C and f_R . The same analysis at the critical point gave a limit FDR $X_1 = 0:43$, which is in agreement, within the error bars, with the eld theoretical value obtained in ref.[15] To conclude, we have studied the 3d XY m odel in the context of aging and showed that the results obtained are consistent with the general picture usually drawn.M oreover, we have given a new veri cation of the local scale-invariance predictions, the rst for a non-scalar order param eter.
