## D issociation of ultracold m olecules with Feshbach resonances

Ultracold molecules are associated from an atom ic Bose-E instein condensate by ramping a magnetic eld across a Feshbach resonance. The reverse ramp dissociates the molecules. The kinetic energy released in the dissociation process is used to measure the widths of 4 Feshbach resonances in <sup>87</sup>Rb. This method to determ ine the width works remarkably well for narrow resonances even in the presence of signi cant magnetic eld noise. In addition, a quasi-mono-energetic atom ic wave is created by jumping the magnetic eld across the Feshbach resonance.

The eld of ultracold molecules has seen impressive progress over the course of the last year. A recent landmark achievement was the creation of a Bose-Einstein condensate (BEC) of m olecules [1{4]. Presently, several experim ents are exploring the crossover regime between BEC and BCS (Bardeen-Cooper-Schrie er) super uidity [4[8]. W hile these experiments associate bosonic dimers from ferm ionic atoms (see also Ref. [9]), there is also considerable interest in dimers associated from bosonic atom s [10{13]. Ultracold molecules are created by rst cooling atom s to ultracold tem peratures and then associating them to molecules using either photoassociation or a Feshbach resonance. In the latter case, the molecules are typically created by slow ly ram ping the magnetic eld in the appropriate direction across the Feshbach resonance.

In this paper, we investigate the dissociation of molecules by ramping the magnetic eld back through the resonance. The kinetic energy released in the dissociation depends on ram p speed and on the width of the resonance. This was previously used to determ ine the width of a fairly broad Feshbach resonance in Na [14]. W e now used this method to determ ine the widths of four Feshbach resonances in <sup>87</sup>Rb. W e discuss, why the widths of narrow Feshbach resonances can be determ ined with this m ethod even in the presence of signi cant m agnetic-eld noise. Indeed, three of the resonances investigated here are so narrow that their widths are not accessible otherwise. In addition, an outgoing quasi-m ono-energetic atom ic wave is created by jumping the magnetic eld across the resonance instead of ram ping linearly in time. In this case, the atom s y apart on the surface of a hollow sphere.

We start with a brief summary of the theoretical background [14{16]. A Feshbach resonance arises when a closed-channel bound state crosses an open-channel dissociation threshold when varying the magnetic eld. Near this crossing, the bare states are coupled to dressed states. The energy of the bare molecular state with respect to the dissociation threshold depends to a good approximation linearly on the magnetic eld B so that  $= (B B_{res})$ , where the slope is the di erence in

the m agnetic m om ents between a m olecule and a dissociated atom pair, and B  $_{\rm res}$  is the position of the Feshbach resonance.

A long-lived m olecule can only exist for < 0.0 therwise, the molecule dissociates spontaneously into a pair of unbound atoms due to the resonant coupling to the continuum of atom ic pair states above the dissociation threshold. W hen a molecule at rest with > 0 dissociates, the energy is released as kinetic energy of the two atoms. Since total momentum is conserved and both atom s have equal mass, the atom s have equal kinetic energy (E = -2 each) and precisely opposite momentum vectors. The decay rate mol of the molecules can be obtained from Ferm i's golden rule, yielding [14]

for > 0, and  $m_{ol} = 0$  otherwise. Here, B is the width of the Feshbach resonance, m is the mass of an atom, and  $a_{bg}$  is the background value of the s-wave scattering length. A lternatively, Eq. (1) can be obtained from scattering theory, see e.g. Eqs. (25) and (42) in Ref. [17] with  $m = h_{mol}$ .

Consider a magnetic-eld ramp that is linear in time with d = dt > 0. In this case, the molecule fraction f decays as [14]

for > 0, and f = 1 otherwise. The mean kinetic energy of a single atom after the dissociation is then [14, 15]

where is the Eulergam mafunction with  $\frac{5}{3}$  0:903. This relation makes it possible to determ ine the width B of a Feshbach resonance from a measurement of hE i, because  $a_{bg}$  is typically known with much better accuracy than B. Unlike previous methods, this method of measuring B does not depend on know ledge of the initial atom ic density distribution.

The probability density D for the velocity v of the dissociated atom s is easily obtained from Eq.(2), yielding

where hE i =  $\frac{m}{2}v_0^2 - \frac{5}{3}$ . Using a time-of-ight method, this velocity distribution is converted into a position distribution, which is measured using absorption imaging.

In the experiment, the velocity distribution of the molecules before dissociation has a nite width. The result is an o set energy  $E_0$  in Eq. (3), but the shape of the velocity distribution Eq. (4) is hardly a ected, because  $E_0$  is small.

A tofEq. (4) to the absorption im ages would be cumbersom e, because no analytic solution is known for the integral of Eq. (4) along one or two coordinate axes. W e therefore t a two-dim ensional G aussian to the absorption im ages and extract hE i of the G aussian t function. In order to analyze the error m ade by this choice of the t function, we num erically integrate Eq. (4) along one coordinate axis for a speci c value of hE i and t a twodim ensional G aussian to this. The resulting best-tvalue hE i of the G aussian is a factor of 1:18 larger than the true value hE i of Eq. (4). We correct the kinetic energies in our data analysis by this factor.

An experimental cycle begins with the production of a BEC of <sup>87</sup>Rb atoms in a magnetic trap. The BEC is then transferred to an optical dipole trap and a magnetic eld of up to 1000 G is applied. The atom ic spin is prepared in the absolute ground state  $jf;m_f i = jl;1i$ . This state has many Feshbach resonances [18].

The dipole trap consists of two beams from a N dYAG laser that cross at right angels. One beam is horizontal, the other subtends an angle of 25 with the horizontal plane. The horizontal beam has a beam waist  $(1=e^2 \text{ radius of intensity})$  of 40 m and a power of 45 mW, the other beam has 55 m and 20 mW. Trap frequencies of 2 (80;110;170) Hz were measured with parametric heating.

In our previous experim ents [12, 19], an undesired reection of the horizontal beam from an uncoated inside surface of the glass cell housing the BEC caused a weak standing wave. This created a one-dimensional optical lattice with a well-depths of k<sub>B</sub> 0:6 K, which exceeds typical values of k<sub>B</sub> T and of the chem ical potential. The horizontal beam is now tilted by a few degrees with respect to the glass surface, thus eliminating this standing wave. This improves the trap loading substantially, because atom s from the wings of the trap are now free to move to the central region. Now, a BEC of typically 6 10<sup>5</sup> atoms can be held in the crossed dipole trap, with a small therm al fraction of less than 1 10<sup>5</sup> atom s. The in-trap peak density in the BEC is typically  $10^{14}$  cm  $^3$  . 5




FIG.1: Mean kinetic energy per atom as a function of the speed of the dissociation ramp. Parts (a), (b), (c), and (d) were measured at Feshbach resonances at 632 G, 685 G, 912 G, and 1007 G, respectively. The solid lines show ts of Eq. (3) to the data. The best-t values are shown in Tab.I.

Ultracold molecules are created by ramping the magnetic eld slow ly dow nw ard through one of the Feshbach resonances, as described in Ref. [12]. About 2 m s before the molecule creation, the atom s are released from the dipole trap. The fraction of the population that is converted into molecules is 10% for the broad resonances at 685 G and 1007 G, and  $\pm$  is 3% for the narrower resonances at 632 G and 912 G.W e could not detect molecules when working at even narrower resonances with a width predicted to be B 0:2 m G.We speculate that this is because the slow molecule-creation ramp might su er from magnetic-eld noise. A fter the molecule creation, a Stem-Gerlach eld is applied to separate the molecules from the remaining atoms. Next, the magnetic eld is ram ped upward through the Feshbach resonance to dissociate the molecules. Then the atom s y freely for up to 11 m s, before an absorption in age of the cloud is taken on a video cam era. The mean kinetic energy is extracted from the image as described above.

Experimental results as a function of ramp speed are shown in Fig.1 for the 4 broadest Feshbach resonances of the state 1;1i. Solid lines show ts of Eq. (3) to the data, with the width of the resonance B and the o set energy  $E_0$  as free t parameters. The best-t values are shown in Tab. I, using the theory value  $a_{bg} = 100.5$  B ohr radii for the state j; 1i from Ref. [19]. For the resonances at 632 G , 912 G , and 1007 G , the m easured widths agree well with the theoretical predictions and with a previously measured value, both also shown in Tab. I. The good agreem ent shows that the dissociation of m olecules can be used as a reliable method to determine B. The resonance at 685 G, how ever, is a factor of 2:7 narrow er than predicted. M ore recent calculations [20] predict a width of 10 m G for this resonance, which is much closer to the value m easured here.

It is surprising that a width as sm all as B = 1.3 mG can be measured with our setup, because the magneticeld noise is most likely larger than this value. The observed linewidths of microwave transitions measured with 50 m s long pulses sets an experimental upper bound on magnetic-eld noise of 4 mG (rms). An attempt to directly measure the magnetic-eld dependence of the scattering length a (B) for the 632 G or 912 G resonance would therefore most likely su er strongly from the magnetic-eld noise.

There are two reasons, why such a small B can be measured with the method presented here nonetheless. First, the dissociation process is pretty fast, e.g., 10 kHz for  $= k_{\rm B}$ 5 K at the 912 G resm ol onance. Therefore, low-frequency magnetic-eld noise m erely shifts the exact time of dissociation but has no effect on the actual ram p speed during the rather short decay time. Second, by choosing fast enough ram p speeds, the experiment is operated in a regime where the relevant decay happens at magnetic elds that are pretty far away from  $B_{res}$ . A typical decay energy of  $= k_B = 5$  K corresponds to B B <sub>res</sub> 25 m G for the 912 G resonance. Here, the magnetic-eld noise has little e ect on the molecule-decay rate.

In addition to the possibility to measure the widths of Feshbach resonances, the dissociation of molecules into atom pairs can also be used to produce a mono-energetic




FIG.2: (color online) (a) M ono-energetic spherical wave of atom s, created by dissociation of m olecules when jumping the magnetic eld across the Feshbach resonance. The atom s y apart on the surface of a hollow sphere. The absorptionim aging beam integrates the three-dimensional density prole along one direction. The observed two-dimensional im age therefore shows a ring, with a non-zero density in the center. The image was averaged over 100 experimental shots. (b) Line pro le across the center of the image. The dip in the center is clearly visible.

spherical wave of atom s. To this end, the m agnetic-eld is jumped across the resonance as fast as possible and then held at a xed value B <sub>nal</sub>. If the jump is fast enough, there will be hardly any dissociation during the jump. Therefore all m olecules dissociate at B <sub>nal</sub>, thus creating atom s with a xed am ount of kinetic energy. Hence, the atom s y apart on the surface of a hollow sphere during the subsequent free ight.

The laser beam used in absorption in aging integrates this density distribution along its propagation direction, thus yielding a two-dimensional image that shows a ring, with a non-zero density in the center. Such an image is shown for the 685 G resonance in Fig. 2a. Due to the initial momentum spread of the molecules the dissociated atom s are not perfectly mono-energetic. This smears the atom ic distribution around the ring. The contrast is still good enough to see a clear dip in the center of the line prole in Fig.2b. The data were taken with 5.5 m stime-of-ight after the dissociation and with B nal B res 40 m G corresponding to molecules the zero.

Technically, the creation of a sharp corner between the m agnetic- eld jump and the plateau at B  $_{nal}$  is di cult. The experimental requirements concerning the sharpness of this corner are more stringent with broader resonances because of the faster molecule-decay rates. We believe that this is why we were unable to observe a dip as in F ig.2b at the 1007 G resonance with the given bandwidth of the servo that controls our magnetic eld.

The scheme with the jump in the magnetic eld can be easily generalized by using an arbitrary shape of the dissociation ramp, which makes it possible to tailor the tim e and energy dependence of the outgoing atom ic wave function.

A s m entioned earlier, one expects that after the dissociation of m olecules the created atom pairs should have precisely opposite m om entum vectors, given that the m olecules had a negligible m om entum spread initially. A detection of this pair correlation m ight be an interesting subject of future investigations.

In conclusion, dissociation of m olecules with a linear m agnetic- eld ram p is a simple and reliable technique to determ ine the widths of Feshbach resonances, even in the presence of m agnetic- eld noise. W em easured the widths of 4 Feshbach resonances in  $^{87}$ Rb thereby covering m ore than 2 orders of m agnitude in B. W e also showed that dissociation of m olecules can be used to create a quasim ono-energetic atom ic wave.
