In uence of gap structures to speci c heat in oriented magnetic elds: Application to the orbital dependent superconductor, Sr_2RuO_4

We discuss in wence of modulation of gap function and anisotropy of Ferm i velocity to eld angle dependences of upper critical eld, H $_{\rm c2}$, and speci c heat, C , on the basis of the approximate analytic solution in the quasiclassical formalism . U sing 4-fold modulation of the gap function and the Fermi velocity in the single-band model, we demonstrate eld and temperature dependence of oscillatory amplitude of H $_{\rm c2}$ and C . We apply the method to the elective two-band model to discuss the gap structure of Sr2RuO $_4$, focusing on recent eld angle-resolved experiments. It is shown that the gap structures with the intermediate magnitude of minima in [100] direction for band, and tiny minima of gaps in [110] directions for and bands give consistent behaviors with experiments. The interplay of the above two gaps also explains the anomalous temperature dependence of in-plane H $_{\rm c2}$ anisotropy, where the opposite contribution from the passive band is pronounced near T $_{\rm c}$.

1. Introduction

A determ ination of its gap sym metry has been a long standing issue in a course study of unconventional superconductivity. Because of a modulation of gap amplitude, therm odynam ic properties at low temperature follow power-law behaviors, which give a hint of the structure of the gap function. How ever, this cannot determ ine an absolute direction of existing gap minima in principle. Moreover, it is rather dicult to distinguish practically higher power-law behaviors due to point nodes from exponential behaviors of isotropic gap. Recently, a powerful method has been developed to measure the modulation of gap amplitude directly. Namely,

eld angle dependences in oriented magnetic elds have shown oscillatory behaviors in thermal conductivity $^{3(8)}$ and speci cheat, depending on detail structure of the gap function.

In order to analyze the oscillatory behaviors, the socalled Doppler shift method has been used frequently, in which the energy shift in the low-energy quasiparticle (QP) spectrum due to supercurrent owing around vortices is taken into account. The method neglects the scattering by vortex cores and the overlap of the core states. 18,19) It makes the theory to be valid in lowtem perature and low - eld lim it, and it still rem ains unknown what is the range of its applicability in the (T; H) phase diagram . On the other hand, at elds near H_{c2} the analytic solution for spatially averaged quantities in the quasiclassical formalism is available with the reasonable approximation. 18,20(22) The present author extended the approximate analytic method to anisotropic singlet and unitary triplet pairings as well as multiband superconductivity. 23) Comparisons with reliable num erical calculations over all eld range at the lowest tem perature indicated that the method is competent for a sem i-quantitative analysis of experim ents in wide region of the (T; H) phase diagram .23)

The purpose of this paper is to investigate the in uence of the gap structure and the anisotropy of the Ferm i velocity to the oscillatory behaviors in H $_{\rm c2}$ and C on the basis of the approximate analytic solution. With those knowledge we discuss them ost plausible gap structures of the layered perovskite superconductor, Sr2RuO4, which has been surveyed extensively with use of the rotating magnetic elds. $^{6(10,24(27))}$

There now exists considerable evidence that $\rm Sr_2RuO_4$ pronounces the spin-triplet superconductivity (SC) with broken time reversal symmetry, for instance, the unchanged spin susceptibility in the Knight shift across $\rm T_c=1.5~K$, $^{28)}$ the intrinsic magnetization detected by SR with the onset of SC, $^{29)}$ and the absence of a coherence peak in $\rm 1=T_1T$. $^{30)}$

Another important aspect of Sr₂RuO₄ is the orbital dependent superconductivity (ODS), which comes from three quasi two-dimensional cylindrical Ferm i surfaces called , and $\frac{31,32}{1}$. The latter is almost decoupled from the formers due to dierent parity of ξ_q orbitals with respect to the conducting layer. The ODS scenario can resolve the inconsistency between the power-law tem perature dependences compatible with lines of tiny gap, and alm ost isotropic therm alconductivity under in-plane m agnetic elds. M oreover, the ODS also explains the peculiar T² dependence of the penetration depth, which is incompatible with lines of tiny gap alone. 33) Recently, Deguchi and co-workers have measured the eld-angle dependence of the speci c heat to give a direct m easure of thermally excited QP in accordance with the SC gap structure.9,10) They suggest that Sr2RuO4 exhibits the ODS and its primary SC gap in band has minima in [100] direction, while the passive , bands have tiny gaps in [110] direction.

Concerning the angle-resolved measurements, the anomalous temperature dependence of the in-plane H $_{\rm c2}$ anisotropy has been observed where its oscillatory amplitude with maximum in [110] direction (H $_{\rm c2}^{\rm [100]}$ = 1:5

T) decreases at elevated tem perature and even changes sign near $T_{\text{c}}.^{25)}$ A lithough few theoretical arguments have been made for this puzzle in terms of the tetragonal symmetry breaking of the two-dimensional order parameter, $^{34,35)}$ a direct evidence of the scenario has not been observed yet. It is important to recognize that a reasonable model should accompany corrected angle dependences with corresponding H $_{\text{c2}}$ anisotropy together with its anomalous temperature dependence.

The paper is organized as follows. In the next section, we introduce our model of the gap function and the anisotropy of the Ferm i velocity, then we give necessary form ulas to discuss eld angle dependence. In x3 we demonstrate the in uence of the gap structure and the anisotropy of the Ferm i velocity to the eld and the tem perature dependence of oscillatory amplitude of H $_{\rm c2}$ and C in the single-band model, keeping the primary band of $\rm Sr_2RuO_4$ in mind. In x4 we discuss the most plausible gap structures for $\rm Sr_2RuO_4$ shedding a light on recent eld angle-resolved experiments. The last section summarizes the paper.

2. M odel and form ulation




Fig. 1. The angle dependence of the gap m agnitude for various R. The thin line represents the case of f wave for comparison.

Let us begin with the model of the gap function. The d vector of the triplet pairing is factorized as d $(\hat{k}) = 2$ ' (\hat{k}) , where the angle dependence of the gap function, ' (\hat{k}) is normalized as h'j (\hat{k}) j'i = 1, h ibeing to average over the Ferm i surface. Among various type of gap functions proposed so far we adopt the model proposed by M iyake and N arikiyo for band, 36)

where J_0 (x) is the Bessel function of zeroth order, is the azim uthal angle of \hat{k} , and 0 denotes the position of one of the gap m in im a (we adopt 0 = 0, i.e., [100] direction for band). Although the originalm eaning of R is the radius of the Fermicircle in unit of =a, a being the lattice constant, we regard it as a phenom enological param eter to characterize the magnitude of the gap minima. Note that the results in the present paper depends only on the m agnitude of the gap, $j'(\hat{k})j$ so that there is no dierence between isotropics wave and the chiral p-wave for exam ple. The angle dependence of the gap magnitude is shown in Fig. 1.R = 1 corresponds to the gap with line of zeros, while R = 0 is the isotropic full gap. For comparison, the dependence of f wave, $'(\hat{k}) = 2 \sin(2) e^{i}$, is also shown in Fig. 1. We will also apply the same form of eq. (2.1) to the secondary gap in the the minima in [110] direction, i.e., $_0 = -4$. The microscopic mechanism for these type of gap functions is discussed by Nomura and Yam ada using the third-order perturbation theory in the 3-band Hubbard model. 37)

Next, we introduce the in-plane anisotropy of the Ferm i velocity. The essential feature of the anisotropy w ith 4-fold sym m etry is described by




Fig. 2. The in-plane anisotropy of the Ferm i velocity

The anisotropy of $v_?$ () = $\frac{q}{v_x^2+v_y^2}$ is shown in Fig. 2. In the case of $\mathrm{Sr}_2\mathrm{R}\,u\mathrm{O}_4$, a is small positive for band, and almost isotropic, a '0, for bands. The modulation of v along z direction is approximated roughly by $v_z\left(\hat{k}\right)=v_z\,\mathrm{sgn}\left(k_z\right)$ for quasitwo-dimensional Ferm i surfaces. The two dimensionality is characterized by the ratio, = $\mathrm{lv}_z^2\,\mathrm{i=}\mathrm{lv}_x^2\,\mathrm{i}=2v_z^2-v_z^2$. The average of the Ferm i velocity is dened as v = $\frac{p}{\mathrm{lv}_x^2+v_y^2+v_z^2}\,\mathrm{i}=\frac{p}{v_z^2+v_z^2}$.

We now explain brie y the approximate analytic solution of the fundamental quasiclassical equations for weak-coupling superconductivity under magnetic elds. The solution can be obtained by the following approximations: (i) the spatial dependence of the internal magnetic eld is averaged by B, (ii) the vortex lattice structure is expressed by the Abrikosov lattice, and (iii) the diagonal element of the G reen's function is approximated

by the spatial average. A Ithough all approximations mentioned above is valid near H c2, com parisons with reliable num erical calculations suggest that the solution is competent quantitatively in wide region of the (T; H) phase diagram except in very low T and H regions. 23) For further detail we recommend the reader to refer the literature. 18,20(23) Here we only quote the expression of the free energy measured from the normal state, $^{23)}$ which is given for strongly type-II superconductors, B ' H , in the clean lim it as,

where 'is the band su x (either or), N_0 is the total density of states (DOS) in the norm al state, $n_1 =$ $N_0 = N_0$ is the partial DOS of the band ', and $!_n =$ (2n + 1) T is the ferm ionic M atsubara frequency. Here

is the interaction matrix in unit of N $_0^1$, = 0:577216 is the Euler's constant and the cut-o $!_c$ = T_c = 100 is used in the sum mation of the Matsubara frequency. The function I, is given by

= $(2jeH)^{1=2}$ is the magnetic length, u_n = 2 $!_n = v_n(\hat{k})$, and W (z) = e^{z^2} erfc(iz) is the Faddeeva function. Here $v_{\cdot ?}$ (k) is the component of v perpendicular to the eld, which is given for the in-plain $H = H (\cos_h; \sin_h; 0)$ as

Note that without the anisotropy in the velocity, a = 0, the oscillatory behaviors depend only on the relative h. In the single-band model the di erence of can be absorbed in the de nition of H_{c2} because \(\nabla_?\) appears only in the form of = v. This is not the case for multiband models where is generally dierent. Once we obtain the equilibrium free energy for given T and H by minimizing the free energy with respect to the gap magnitude , we can discuss the oscillatory behaviors of H $_{\text{c2}}$ and C .

3. Results in single-band model

Let us discuss the single-band model with the gap having m in im a in [100] direction ($_0 = 0$). At T = 0 the in-




Fig. 3. The in-plane eld angle dependence of the upper critical eld with line of zeros in [100] direction (a = 0, $_0$ = 0).

plane H $_{\rm c2}$ anisotropy due to the modulation of the gap

From this expression the minima of H_{c2} are obtained when the minima of the oscillation in the gap and in the perpendicular component of the velocity coincide. Thus, without the in-plane anisotropy in v, i.e., a = 0, the minima of H_{c2} are simply realized when the eld is parallel to the direction of the gap m in im a. On the other hand, without the gap m odulation, i.e., R = 0, the anisotropy of v gives rise to the minima of H c2 when $_{\rm h}$ k [110] ($_{\rm h}$ k [100]) for a > 0 (a < 0).




Fig. 4. The tem perature dependence of the oscillatory am plitude of H $_{\rm c2}$ with dierent size of the gap m in im um , R (a = 0, $_{\rm 0}$ = 0). The inset shows the tem perature dependence of H $_{\rm c2}$ for H k [100].

At nite temperatures we rst discuss the case of the isotropic Ferm i velocity, a = 0. Figure 3 shows the inplane eld angle dependence of H_{c2} for R = 1 at $T = T_c =$ 0,01 and 02. As we expect it shows m in im a for $_{h}$ k $_{0}$ (= 0 and =2). The oscillatory amplitude in what follows is de ned as A = A (h k [110]) A (h k [100]) where A is either H $_{\mbox{\scriptsize c2}}$ or C . The tem perature dependence of ${\rm H_{c2}}$ scaled by ${\rm H_{c2}}^{[100]}$ ([100] denotes the eld direction.) is shown in Fig. 4. The amplitude of the H $_{\rm c2}$ oscillation is a m onotonically decreasing function of T, and it becomes larger the smaller the size of the gap minimum is. The inset shows the temperature dependence of H $_{\rm c2}$ for H $\,$ k [100].




Fig. 5. The eld dependence of the oscillatory amplitude of the specicheat at $T=T_c=0$:1 (a = 0, 0 = 0). The inset shows the angle dependence of C .

The eld dependence of C at T=T=0:1 is shown in Fig. 5. As the eld decreases, the negative amplitude increases and changes sign at H . It is emphasized that even for the gap with line of zeros, R = 1, it reaches the m axim um, and again decreases toward to zero. For larger m odulation of the gap C has stronger eld dependence. The overall behavior at the lowest temperature can be understood as follows. At higher elds the in-plane Hc2 an isotropy yields the oscillation in H =H $_{\rm c2}$ since H is xed in the experim ental situation. It leads to the amplitude oscillation in , which predom inates the oscillatory behavior in C. Therefore, the oscillatory amplitude of C

has the opposite sign of H_{c2} . At lower elds H. H, the D oppler shift argument can be applied. The local QP with the momentum \hat{k} has the energy spectrum, $E_{\hat{k}} + v_s$ \hat{k} in the supercurrent owing around vortices with the velocity v_s . This energy shift gives rise to anite DOS near the gap minima if \hat{k} yj>j $(\hat{k})j$. Since v_s ? H, the number of activated gap minima becomes largest in the case of H k 0 yielding a maximum in C. In the limit of H! H0, C decreases again since the volume fraction of the locally activated QPs becomes H0.




Fig. 6. The oscillatory amplitude of specic heat at elevated temperature (a = 0, $_0$ = 0).

It should be noted that the Doppler shift argument is valid only at low temperature. At elevated temperature, positive contribution to C from the activated QPs near the gap m inim a becomes less pronounced and the negative contribution from the H $_{\rm c2}$ anisotropy predominates. This is seen clearly by the eld dependence of C at T=Tc = 0:1,0:2 and 0:3 as shown in Fig. 6. For T=Tc = 0:2 no sign changes occur in C.

Next we discuss the e $\,$ ect of the anisotropy of v. For




Fig. 7. The tem perature dependence of $\rm\,H_{c2}$ for the isotropic full gap with the anisotropic Ferm i velocity.

this purpose we consider the isotropic gap, R = 0. The tem perature dependence of $\,H_{\rm c2}$ with the anisotropy is shown in Fig. 7. The e ect of anisotropy in $\,H_{\rm c2}$ has the opposite sign of a and is monotonically decreasing (increasing) function of T for a < 0 (a > 0). Note that the oscillatory amplitude due to the anisotropic velocity can be the same order of magnitude of that due to the gap modulation.




Fig. 8. The eld dependence of C for the isotropic full gap w ith the anisotropic Ferm i velocity.

Figure 8 shows the eld dependence of C at T=T=0.1. Since there is no contribution from the Doppler-shifted QPs in this case (R = 0), the oscillatory behaviors come purely from the anisotropy of H_{c2} , which a ects the oscillatory behaviors over weak eld region. Thus, the oscillatory amplitude of C has the same sign of a and its magnitude decreases monotonically as H decreases.

As will be discussed in the next section, the oscillatory behaviors in Sr_2RuO_4 is determined roughly by the contribution from the primary band. Viewing a small positive anisotropy of vin the band, we expect that the primary gap in the band has a modulation with an intermediate size of minima in [100] direction (R 0.6{0.8, 0 = 0}) for consistency with experiments.

4. Interplay of two-band superconductivity

W ith the know ledge obtained in the previous section, let us discuss the oscillatory behaviors in Sr2RuO 4. Since the and bands have similar characters of Fermisurface and the Cooper pair scattering between them is expected not to be small, we adopt an e ective two-band m odel for $Sr_2RuO_4.W$ e use the norm alDOS, n = 0.57 and n = 0:43, based on the de Haas-van Alphen measurem ents. 24) The param eters of two dim ensionality are estim ated as $= 6.0 10^6$ and $= 3:0 10^4$ respectively, and = v^2 = v^2 = 4:0, from the experim ental value of H $_{\rm c2}^{\rm \ (c)} = {\rm H}_{\rm \ c2}^{\rm \ (a)}$ and the Ferm i surface topology. $^{24)}$ For the gap structure (R : $_{0}$) and the anisotropy of v (a·), we choose R = 0:65, $_0$ = 0 and a = 0:1 for the primary band. For the passive $_0 = -4$ and a = 0, which can exadopt R = 1, plain naturally the anom alous temperature dependence of H_{c2} as will be shown shortly.

Before discussing the oscillatory behaviors we statement the interaction parameters for Sr_2RuO_4 . This is done by the speciencheat thing at H=0. The best thing is achieved by




Fig. 9. The tem perature dependence of C at zero eld. The open circle represents the experim ental data taken from Ref. $^{39)}$ The inset shows C (T) at H =H $^{[100]}_{c2}$ = 0:1.

with $_1$ = 0.4, $_2$ = $_1$ = 0.65 and = $_1$ = 0.12, as shown in Fig. 9. The open circle represents the experimental data taken from Ref.³⁹⁾ The inset shows the results at H =H $_{\rm c2}^{[100]}$ = 0.1, which indicate that almost all the QPs in the band is already activated at this eld.




Fig. 10. The eld dependence of H_{c2} . The ratio of the two gaps at H_{c2} (T) is shown in the inset.

Figure 10 shows the tem perature dependence of the in-plane H $_{\rm c2}$ anisotropy. The behavior at low tem peratures is similar to the single band case in Fig. 4 except that the oscillatory am plitude is suppressed by the positive weak anisotropy in v. It is remarkable that the oscillatory am plitude changes its sign near T $_{\rm c}$. This can be understood as an interplay of the primary gap in band having them inimum in [100] direction with the secondary gap in band having the di erent minimum in [110] direction. The contribution from the secondary gap,

which has the opposite sign of the primary gap's, is enhanced near $T_{\rm c}$ yielding the negative amplitude in $~H_{\rm c2}$. The enhancement of the ratio of two gaps at $H_{\rm c2}$ (I) is shown in the inset of Fig. 10. This is the strong evidence that the secondary gaps in bands have the gap minima in [110] direction. The similar interplay of two-band superconductivity is observed in MgB2, in which the 3-dimensional passive band predominates over the 2-dimensional primary band showing the strong temperature dependence in $H_{\rm c2}^{(a)}=H_{\rm c2}^{(c)}$

Finally, we discuss the eld dependence of C for Sr_2RuO_4 . The contributions from each bands are separately shown in Fig. 11.8 oth the gap modulation with minima in [100] direction and the anisotropy in v with a > 0 contributes to the positive oscillatory amplitude in C at low elds. Since the passive bands give no contribution to C except in very low elds, total amplitude becomes smaller than the single-band result by a factor of n (= 0.57). It is remarkable that the contribution at low elds has positive sign. We expect naively that

the gap m odulation with minima in [110] direction gives




Fig. 11. The eld dependence of ${\tt C}$.

the negative sign of C at low elds. However, this naive expectation based on the Doppler shift argument is valid only at very low temperature. Since the passive gap is small as compared with (T) even at low elds, $T=T_{\rm c}=0.1$ is regarded electively in high temperature region. Therefore, the positive contribution from bands results as the case of $T=T_{\rm c}=0.2$ shown in Fig. 6 (note that $_0==4$ in this case). The overall behaviors of C is consistent with experiments. 9,10

5. Sum mary

We have investigated the in uence of the modulation of the gap and the anisotropy of the Ferm i velocity to the oscillatory behaviors of H $_{\rm c2}$ and C , using the approximate analytic solution of the quasiclassical form alism .

It is shown that for the single-band model the minimum direction of the in-plane H_{c2} anisotropy coincides with either the minimum of the gap modulation or the Ferm i velocity. If they are in di erent directions, the resultant am plitude becom es small due to the competing contributions from both e ects. The absolute magnitude of the H 2 anisotropy is a monotonically decreasing function of T.D ue to the H c2 anisotropy the oscillatory behavior of C at high elds shows the opposite tendency of the H_{c2} anisotropy and its magnitude increases toward H_{c2}.At low elds and low temperatures the e ect of the so-called Doppler shift plays an important role yielding the opposite oscillatory behaviors to the high-eld ones. Therefore we can safely conclude that the source of the oscillatory behaviors is the modulation of the gap, if a sign change is observed in the oscillatory amplitude of C (H). It is noted how ever that the e ect of the Doppler shift is pronounced only at su ciently low temperatures.

W ith a combination of the results above, we have discussed the gap symmetry for Sr_2RuO_4 . The oscillatory behavior of C is roughly determined by the primary gap in the band. To be consistent with experiments we conclude that the primary gap has an intermediate magnitude of minima in [100] direction. Assuming that the secondary gap in bands has line of zeros in [110] direction we have shown that the in-plane H $_{\rm c2}$ anisotropy exhibits the anomalous temperature dependence with a

sign change near T_c . This is understood by the opposite contribution from the passive bands, which becomes predominant over the band contribution near T_c . The observation that the interplay of two gaps is pronounced near T_c provides an alternative way to determine gap symmetry in passive bands, which is hardly accessible by ordinary experiments. With the assumed gap model the total behavior of C together with the band contributions is consistent with experiments.
