Power{law tail distributions and nonergodicity

We establish an explicit correspondence between ergodicity breaking in a system described by power{law tail distributions and the divergence of the moments of these distributions.

Statistical mechanics is a combination of the law of large numbers and the laws of mechanics. Since its foundation in the late 19th century, this theory has been extremely successful in describing equilibrium and nonequilibrium properties of a very large number of macroscopic systems [1]. In the last decade, however, a new class of systems that do not obey the law of large numbers has emerged [2, 3, 4]. The behavior of these systems is dominated by large and rare uctuations that are characterized by broad distributions with power{ law tails. The hallmark of these statistical distributions, commonly referred to as Levy statistics [5], is the divergence of their rst and/or second moment.

The question we address in this paper is how ergodicity is a ected in system s described by power{ law tail distributions with diverging moments. Ergodicity is a central concept in statistical physics and is usually stated by saying that ensemble average and time average of observables are equal in the in nite{time limit [6, 7]. The ergodic hypothesis has recently been investigated experim entally in two di erent systems governed by Levy statistics in time: uorescence intermittency of nanocrystal quantum dots [8] and subrecoil laser cooling of atom s [9]. Both experiments have found that Levy statistics induces ergodicity breaking. A precise understanding of the connection between divergent mom ents and nonergodicity is thus of high interest. A common feature of the systems in the above experiments is their non{ stationarity. This in in contrast to the system we propose to study, namely atom ic transport in an optical lattice, where a steady state does exist. Nonetheless, we will show that this system can exhibit nonergodic behavior.

An optical lattice is a standing wave light eld form ed at the intersection of two or more laser beams [10]. Due to the spatial periodicity of the potential, an optical lattice is sim ilar in many respects to a solid state crystal. The main advantage of an optical lattice, how ever, is its high tunability: both the period and the amplitude of the optical potential can be modiled in a controlled way. This has the interesting consequence that the exponents of the power{law distributions appearing in this system are not xed, as in most system s, but can be varied continuously, allowing the exploration of di erent regimes.

The motion of atom s in a one-dimensional optical lattice form ed by two counterpropagating laser beam swith linear perpendicular polarization can be described, after spatial averaging, by a Fokker{P lanck equation for the sem iclassicalW igner function W (p;t) [11, 12, 13],

The momentum {dependent drift and di usion coe - cients are respectively given by,

K (p) =
$$\frac{p}{1 + (p=p_c)^2}$$
; D (p) = D₀ + $\frac{D_1}{1 + (p=p_c)^2}$: (2)

The drift K (p) corresponds to a cooling force with friction coe cient, while the di usion coe cient D (p) represents stochastic m om entum uctuations and describes heating processes. It is worth noticing that for large mom entum, the range of the drift is lim ited by the capture m om entum p_{c} , while the range of the uctuations is not. The kinetic equation (1) is valid in a regime where (i) the atom ic m om entum is large, p hk, where k is the wave number of the laser eld (this de nes the sem iclassical lim it), (ii) the saturation parameter is small, s 1 (this corresponds to low laser intensity) and (iii) the kinetic energy of the atom s is large, $p^2=2m$ U_0 , where U₀ is the depth of the optical potential (this last condition allows spatial averaging). The stationary solution of the atom ic transport equation (1) which satis es natural boundary conditions, W_{s} (p! 1)! 0, is of the form,

where Z is a normalization constant. The momentum distribution (3) has an asymptotic power{law tail, $W_s(p)$ $pj^{(p_c^2)=D_0}$, with an exponent that can be expressed in terms of the potential depth U_0 and the recoil energy E_R as $(p_c^2)=D_0 = U_0=(22E_R)$ [11]. The statistical properties of the distribution (3) can therefore be easily changed from normal statistics for $U_0 = 66E_R$, to Levy statistics for $U_0 < 66E_R$, by simply modifying the depth of the optical potential. In particular, one should note that the second moment, $hp^2i = dpp^2W_s(p)$, becomes in nite when $U_0 < 66E_R$. In this regime the mean kinetic energy of the system, $E_K = hp^2i=2m$, diverges, clearly signaling unusual therm odynam ic behavior.

Transport in an optical lattice has a num ber of attractive features that m ake it an ideal case study of the therm odynam ical properties of system s described by power{ law distributions. On the one hand, the atom ic transport equation (1) has been derived from the m icroscopic Ham iltonian that describes the interaction with the laser

elds and the quantities that appear in this equation can be expressed in terms of the m icroscopic parameters of the quantum {optical problem [11]. M oreover, the regime de ned by conditions (i) to (iii) has been in plemented experimentally and the divergence of the kinetic energy below a given potential threshold has been observed [14]. Finally, Eq. (1) is an ordinary linear Fokker{P lanck equation, meaning that standard methods of stochastic calculus can be used to analyse the problem. This is in contrast to most systems with power{law distributions that are often described by nonlinear or fractional kinetic equations [15]. In particular, for the case of vanishing D₁ (which we shall consider in the sequel [16]), Eq. (1) corresponds to a random process driven by additive G aussian white noise. The fact that power{law

uctuations with in nite variance occur here in a system subjected solely to additive noise is worth emphasizing. The physical mechanism which gives rise to divergent uctuations in system swith multiplicative noise, where the noise strength is proportional to the stochastic variable, is well{known [17]: it is based on a positive feedback loop that leads to the amplication of the noise as the value of the random variable increases. On the other hand, in the present situation, where the noise intensity is independent of the random variable, a di erent positive feedback mechanism is at work, based on the steady decrease to zero of the friction force as the value of the momentum increases. The appearance of in nite momentum uctuations in this system is thus a striking illustration of the complex behavior that can result from the subtle interplay of the noise and the nonlinearity of the drift. In the following, we establish a correspondence between the divergent m om ents of the power{law distributions of the system and nonergodic behavior.

W e begin by transform ing the Fokker{P lanck equation (1) into a Schrödinger{like equation by writing W (p;t) = W $_{\rm s}$ (p)¹⁼² (p;t) [18]. The function (p;t) satisfies the im aginary{time Schrödinger equation,

with the potential V (p) = $K^{0}(p)=2 + K (p)^{2}=(4D_{0})$. For the drift coe cient (2), this potential reads

$$V(p) = \frac{p_c^2}{4D_0} \frac{p^2 (p_c^2 + 2D_0) 2D_0 p_c^2}{(p^2 + p_c^2)^2} :$$

is continuous, except for the discrete ground state $_0$ (p), in the latter. In both cases, the stationary momentum distribution is given by the square of the ground state eigenfunction, $W_{s}(p) = {}_{0}(p)^{2}$. Interestingly, we note that a real{tim e Schrodinger equation with a potential of the form (5) has recently been considered in R ef. [19]. To simplify the discussion, we now adopt rescaled variables for which $= p_c = 1$ and $D_0 = D$; the noise intensity D being then the only remaining parameter in the problem . It will also be convenient to divide momentum space into a low {m om entum region $p_j < 1$, where the drift is approximately linear, $K_1(p)'$ p, and a high {m om entum region j_{2} = 1, with a drift K₂ (p) ' 1=p. The anom alous dynam ics of the system is completely determ ined by the high {m om entum region. The eigenvalues and eigenfunctions of the H am iltonian H in this region are given by $E_k = Dk^2$ and $k(p) = p\overline{p}[c_1J(kp) + c_2Y(kp)]$, where J (p) and Y (p) are the Bessel functions of the rst and second kind of order = (D + 1)=2D. The constants $c_{1:2}$ are xed by the boundary conditions.

W hen discussing the ergodicity of a system, one is typically not interested in the trajectory in the full space{ space, but offen in the projection of the trajectory onto some subspace of relevant variables [1], in the present case m om entum. A criterion for the equality of ensem ble average and time average of a dynam ical quantity A is then provided by the condition [20]

Here $\overline{A} = t \begin{pmatrix} 1 & R_t \\ 0 & d \end{pmatrix}$ A (p()) is the time average of the observable A and hA i = dpA (p)W (p;t) denotes its ensemble average. In the in nite{time limit, the latter tends to the stationary ensemble average hA is =

 $dpA(p)W_s(p)$. A system that obeys (6) is said to be ergodic in the mean square sense. In order to determ ine the ergodicity of our system, we thus need to compute the long{tim e behavior of the covariance,

This can be done by applying the usual theory of stochastic processes [18]. The two{time correlation function hA ($p(t_1)$)A ($p(t_2)$)i is de ned by the integral

where $W_2(p_1;t_1;p_2;t_2)$ is the two{point joint probability density function. Since the Fokker{Planck equation (1) describes a stationary M arkov process (for any value of p_c), the probability distribution $W_2(p_1;t_1;p_2;t_2)$ depends only on the time di erence t_1 t_2 j and can be expressed in terms of the eigenvalues and eigenfunctions of the Schrodinger equation (4) in the form,

C om bining Eqs. (7), (8) and (9) and introducing the variable = t_2 t_2 , we arrive at

where the function $C_{\,\rm A}$ () is given by

The in nite{time limit of the covariance $\frac{2}{A}$ (t) is entirely determ ined by the asymptotic behavior of C_A (). This function depends explicitly on the observable A (p). It is worthwhile to notice that ergodicity will therefore in general depend on the dynamical variable A (p) under consideration. In the following, we take $A(p) = p^n$ and evaluate the long-time behavior of C_A () follow ing Ref. [13]. We nd C_A () with an exponent = (1 (2n + 1)D)=2D. As a result, the covariance (10) will converge to zero as t ! 1 , only if $D < D_n = 1 = (2n + 1)$. We thus obtain the important result that there is a noise threshold D_n above which ergodicity is broken. As already mentioned, this threshold depends explicitely on the parameter n, that is, on the quantity A (p): the sm aller the power n, the larger the value of D $_{\rm n}$. On the other hand, the mom ents of the stationary momentum distribution, $hp^m i =$ $dp p^m W_s(p)$, are nite for $D < D_m^0 = 1 = (m + 1)$. We can therefore conclude that there exists a direct relationship between the loss of ergodicity in the system for the variable A (p) = p^n and the divergence of the 2nth m om ent of the stationary momentum distribution.

Let us look in more detail at the value n = 0, which corresponds to the largest noise threshold $D_{n=0} = 1$. We rst mention that for $D > D_{n=0}$, the Fokker{P lanck equation doesn't have a norm alizable stationary solution anymore and the system is obviously nonergodic. Further, for n = 0, the function C_A () can be rewritten in terms of the conditional probability density P_2 (p_2 ; \dot{p}_1 ;0) as

This result is of special interest. Equation (12) shows that, unlike for the O mstein {Uhlenbeck process, the steady state is here reached in a nonexponential way. Such an asymptotic power{ law decay is usually associated with non{Markovian processes and is rather surprising for a stationary Markov process as described by Eq. (1). The origin of this algebraic behavior is of course rooted in the nonlinear drift coe cient (2).




FIG.1: Probability to be in the low {m om entum region (continuous line) and in the high {m om entum region (dashed line), in the long{time lim it, as a function of the noise strength D.

A closely related quantity is the rst{passage time distribution. The rst{passage time is de ned as the time at which the momentum of the system rst exits a certain momentum interval, given that it was originally in that interval. The rst{passage time problem for the Fokker{Planck equation (1) can again be treated using standard techniques of stochastic calculus (see for example Ref. [21]). In the high{momentum region, the Laplace transform g_2 (s) of the rst{passage time distribution obeys the follow ing backward equation,

Solving Eq. (13) with the boundary conditions g(1) = 1and g(1) = 0, we obtain

$$g_{2}(s) = \frac{K (p) (s=D)}{K (s=D)} p; \qquad (14)$$

where K (p) is the modi ed Bessel function of the second kind of order . It follows from Eq. (14), that s as s ! 0. The rst{ to leading order, g_2 (s) passage time distribution in region 2 is thus also a power{ law tail distribution and it asymptotically behaves as g₂ (t) t with an exponent $=_{\mathbb{R}} (3D + 1) = (2D)$. The corresponding m om ents $ht^n i = dtt^n g_2$ (t) converge if $D < D_n^{(0)} = 1 = (2n)$ 1). The rst{passage time distribution q_1 (t) in region 1 can be computed along similar lines and the associated m om ents can be shown to be all nite. Figure (1) shows the probability to be in region 1 and 2, in the lim it of long times, as a function of the noise intensity D. We observe that for small D, atom s are mostly located in the low {momentum region, where they experience the linear part of the drift. On the other hand, for D close to $D_{n=0}$, atom s get localized in the high {m om entum region, where the drift asym ptotically decays as 1=p. Rem arquably, atom s in this system can thus be brought in a high {energy state through the sole action of the noise. We note that this problem exhibits an interesting analogy with subrecoil laser cooling, where atom s accumulate in a low {energy state (in a so { called dark state), with in nite mean trapping time [22]. To our know ledge, loss of ergodicity in system s with divergent trapping times has been inst discussed in the context of spin {glasses [23].

We can now formulate the main result of the paper: Ensemble average and time average of the dynamical variable A (p) = p^n stop being equal in the in nite{time limit | ergodicity of the system is accordingly broken|

when the 2nth m om ent of the stationary m om entum distribution and the (n + 1)th m om ent of the rst passage time distribution in the high {momentum region become in nite. An unambiguous correspondence between the nonergodic properties of a system described power{law distributions and the divergence of their respective moments is therefore demonstrated. This con ms and extends the ndings reported in Refs. [8, 9, 22, 23]. We stress that the above result is not restricted to transport in an optical lattice and that our analysis applies to a whole class of systems described by an equation of the form (1) with a drift coe cient decaying asymptotically as 1=p. M ore generally, we conjecture that the result also holds true for other power{ law system s, even if they are not described by a simple kinetic equation like the ordinary Fokker{Planck equation (1) [8, 9, 22, 23].

Further insight can be gained by considering a discretized form of the Fokker (Planck equation (1). In doing so, we shall obtain a generalization of the Ehrenfest um model, which has played an important role in clarifying the foundations of statistical mechanics [24]. We write p = j p and t = l t and nd that the probability ! (j;l) = W (j p;lt) satis es the di erence equation,

! (j; l+1) = a(j 1)! (j 1; l) + b(j+1)! (j+1; l) : (15)

In the lim it (p; t)! 0, Eq. (15) reduces to the contin-

uous equation (1) with K (p) = p=t [a(p) b(p)] and D = (p)²=(2 t) [a(p) + b(p)]. The transition probabilities a(j) and b(j) in (15) are explicitely given by

$$a(j) = \frac{R(1+j^2)}{2R(1+j^2)}; \quad b(j) = \frac{R(1+j^2)+j}{2R(1+j^2)}; \quad (16)$$

W e recall that the Ehrenfest m odel consists of two ums containing a total of 2R balls. At regular time intervals, t, a ball is random ly chosen and m oved to the other um; w (j;l) is then the probability of having R + j balls in the rst um at time l. In the standard version of the m odel, the j^2 terms in Eq. (16) are absent and Eq. (1) reduces to the O mstein {Uhlenbeck process with linear drift. W e note that in the continuous description, the m om entum p corresponds to the num ber of excess balls j in the rst um. So, for exam ple, ergodicity breaking for n = 1 (D > 1=3) occurs when the uctuations of the num ber of balls being still nite and equal. M oreover, when D approaches one, all the balls preferentially occupy the sam e um, therefore acting as M axwell's dem on.

In conclusion, we have investigated anom abus transport in an optical lattice from the point of view of statistical mechanics and established an explicit correspondence between ergodicity breaking and the divergence of the moments of the power{law tail distributions describing the behavior of the system, both in momentum space and in time.
