### Volatility sm ile and stochastic arbitrage returns

#### A bstract

The purpose of this work is to explore the role that random arbitrage opportunities play in pricing nancial derivatives. We use a non-equilibrium model to set up a stochastic portfolio, and for the random arbitrage return, we choose a stationary ergodic random process rapidly varying in time. We exploit the fact that option price and random arbitrage returns change on dierent time scales which allows us to develop an asymptotic pricing theory involving the central limit theorem for random processes. We restrict ourselves to inding pricing bands for options rather than exact prices. The resulting pricing bands are shown to be independent of the detailed statistical characteristics of the arbitrage return. We not that the volatility \sm ile" can also be explained in terms of random arbitrage opportunities.

### 1 Introduction

It is well-known that the classical B lack-Scholes form ula is consistent with quoted options prices if di erent volatilities are used for di erent option strikes and maturities [1]. To explain this phenomenon, referred to as the volatility \sm ile", a variety of models has been proposed in the nancial literature. These includes, amongst others, stochastic volatility models [2, 3, 4], the Merton jump-di usion model [5] and non-Gaussian pricing models [6, 7]. Each of these is based on the assumption of the absence of arbitrage. However, it is well known that arbitrage opportunities always exist in the real world (see [8, 9]). Of course, arbitragers ensure that the prices of securities do not get out of line with their equilibrium values, and therefore virtual arbitrage is always short-lived. One of the purposes of this paper is to explain the volatility \sm ile" phenomenon in terms of random arbitrage opportunities.

The rst attempt to take into account virtual arbitrage in option pricing was made by physicists in [10, 11, 12]. The authors assume that arbitrage returns exist, appearing and disappearing over a short time scale. In particular, the return from the Black-Scholes portfolio, = V S@V=@S; where V is the option price written on an asset S; is not equal to the constant risk-free interest rate r. In [11, 12] the authors suggest the equation d = dt = (r + x (t)); where x (t) is the random arbitrage return that follows an 0 m stein-Uhlenbeck process. In [13, 14] this idea is reformulated in terms of option pricing with stochastic interest rate. The main problem with this approach is that the random interest rate is not a tradable security, and therefore the classical hedging can not be applied. This di culty leads to the appearance of an unknown parameter, the market price of risk, in the equation for derivative price [13, 14]. Since this parameter is not available directly from nancial data, one has to make further assumptions on it. An alternative approach for option pricing in an incomplete market is based on risk minimization procedures (see, for example, [15, 16, 17, 18, 19]). Interesting ideas how to include arbitrage were developed in [20] where the Black-Scholes pricing model was discussed in a quantum physics setting.

In this paper we follow an approach suggested in [4] where option pricing with stochastic volatility is considered. Instead of nding the exact equation for option price, we focus on the pricing bands for options that account for random arbitrage opportunities. We exploit the fact that option price and random arbitrage return change on dierent time scales allowing us to develop an asymptotic pricing theory by using the central limit the-

orem for random processes [21]. The approach yields pricing bands that are independent of the detailed statistical characteristics of the random arbitrage return.

### 2 Modelwith random arbitrage return

Consider a model of (S;B;V) market that consists of the stock, S, the bond, B and the European option on the stock, V. To take into account random arbitrage opportunities, we assume that this market is a ected by two sources of uncertainty. The rst source is the random uctuations of the return from the stock, described by the conventional stochastic dierential equation,

where W is a standard W iener process. The second source of uncertainty is a random arbitrage return from the bond described by

$$\frac{dB}{B} = rdt + (t)dt;$$

where r is the risk-free interest rate. G iven that there are random arbitrage opportunities, we introduce here the random process, (t); that describes the uctuations of return around rdt: The same mapping to a model with stochastic interest rate is used in [11, 12, 13]. The characteristic of the present model is that we do not assume that (t) obeys a given stochastic dierential equation. For example, in [11, 12, 13] (t) follows the 0 mstein-Uhlenbeck process [22].

It is reasonable to assume that random variations of arbitrage return (t); are on the scale of hours. Let us denote this characteristic time by  $_{\rm arb}$ : This time can be regarded as an intermediate one between the time scale of random stock return (in nitely fast Brownian motion uctuations), and the lifetime of the derivative T (several months):  $0 << _{\rm arb} << T$ . In what follows, we exploit this dierence in time scales and develop an asymptotic pricing theory involving the central limit theorem for random processes.

Now we are in a position to derive the equation for V: Let us consider the investor establishing a zero initial investment position by creating a portfolio consisting of a long position of one bond, B;  $\frac{\partial V}{\partial S}$  shares of the stock, S; and a short position in one European option, V; with an exercise price, K; and a maturity, T: The value of this portfolio is

The B lack-Scholes dynam ic of this portfolio is given by two equations, @=@t=0; and =0 (see [1]). The application of Ito's formula to (3) together with (1) and (2) with (t)=0; leads to the classical B lack-Scholes equation:

The natural generalization of @=@t=0 is a simple non-equilibrium equation:

where  $_{arb}$  is the characteristic time during which the arbitrage opportunity ceases to exist (see [10]).

By using a self-nancing condition,  $d = dV = \frac{eV}{eS} dS + dB$ ; and Ito's lemma, one can derive from (1) and (2) the equation involving the option V (t;S) and the portfolio value (t;S),

Note that this equation reduces to (4) when = 0 and (t) = 0:

To deal with the forward problem we introduce the non-dimensional time

This parameter plays a very important role in what follows. In the limit "! 0; the stochastic arbitrage return becomes a function that is rapidly varying in time. It is convenient to use the following notation, - (see [4]). It follows from (5) that the value of the portfolio; decreases to zero like exp(t="T): Thus, one can assume that = 0 in the limit"! 0:We and from (6) that the associated option price, V "(;S); obeys the following stochastic PDE

for a call option, where K is the strike price. Here, for simplicity, we keep the same notations for the non-dimensional volatility and the interest rate r: The same PDE is used in [11, 12], but with the O mstein-Uhlenbeck process for :

## 3 A sym ptotic analysis: pricing bands for the options

To analyze the stochastic PDE (9), we have to specify the statistical properties of the random arbitrage return. Suppose that () is a stationary ergodic random process with zero mean, () >= 0; such that,

is nite. The key feature of this paper is that we do not assume an explicit equation for () unlike the works [11, 12, 13], where the random arbitrage return follows the Omstein-Uhlenbeck process.

A coording to the law of large numbers, V''(;S) converges in probability to the B lack-Scholes price,  $V_{BS}(;S)$ ; as "! 0:0 ne can split V''(;S) into the sum of the B lack-Scholes price,  $V_{BS}(;S)$ , and the random eld Z''(;S); with the scaling factor  $v_{BS}(;S)$ ; with the scaling factor  $v_{BS}(;S)$ .

Substituting (12) into (9), and using the equation for  $V_{BS}$  (;S), we get the following stochastic PDE for Z "(;S),

Our objective here is to not the asymptotic equation for Z "(;S) as "! 0:One can see that Eq. (13) involves two stochastic terms proportional to  $(\frac{1}{\pi})$  and "  $^{1=2}$   $(\frac{1}{\pi})$ . Ergodic theory in plies that the rst term in its integral form converges to zero as "! 0; while the second term converges weakly to a white Gaussian noise () with the correlation function

where the intensity of white noise, D; is determined by (11) (see [21] and Appendix A). Thus, in the limit "! 0; the random eld Z"(;S); converges weakly to the eld Z (;S) that obeys the asymptotic stochastic PDE:

with the initial condition Z(0;S) = 0. This equation can be solved in term softhe classical B lack-Scholes G reen function,  $G(S;S_1;;_1)$ ; to give

It follows from (16) that since (t) is the Gaussian noise with zero mean, Z (;S) is also the Gaussian eld with zero mean. The covariance

with R (0;S;Y) 0 (see Appendix B). The pricing bands for the options for the case of arbitrage opportunities can be given by

The variance U (;S) quanties the uctuations around the classical Black-Scholes price. It should be noted that it is independent of the detailed statistical characteristics of the arbitrage return. The only parameter we need to estimate is the intensity of noise D which is the integral characteristic of random arbitrage return (see (11)). One can conclude that the investor who employs the arbitrage opportunities band hedging sells the option for

One can see from (15) or (23) that the large uctuations of Z (;S) occur when the function  $S\frac{\theta V_{BS}}{\theta S}$   $V_{BS}$  takes the maximum value. That is,  $S\frac{\theta^2 V_{BS}}{\theta S^2}=0$  (the G reek = 0).

#### 4 Numerical results




Fig. 1: Variance, U (;S), with respect to asset price, S, and time . The option strike price K is 20, the volatility is 0:4, the interest rate r is 0:1, and the constant D is 0:1.




Fig.2: E ective option price (dashed line) and B lack-Scholes price (continuous line). Here "=0:1; and constants K , ,r, and D are taken as in Fig.1.

To determ ine how the random arbitrage opportunities a ect the option price, we solve equation (19) num erically. Figure 1 shows a graph of the variance, U (;S) = R (;S;S), as a function of both time, , and asset price, S. From this graph, we observe that the uncertainty regarding the option value is greater for deep-in-them oney options. This nding is consistent with the empirical work given in [23]. In Figure 2, we plot thee ective option price given by (22) for " = 0:1, and compare it with the B lack-Scholes price. Note that deep-in-them oney options deviate them ost from the B lack-Scholes option price. As we move near at-the-money options the deviation decreases.

Now we are in a position to discuss the "smile" e ect, that is, the implied volatility is not a constant, but varies with strike price K and time: Let us denote the implied B lack-Scholes volatility by "(K;): The formula (22) for the elective option price implies




Fig. 3: \Sm ile" curve: the implied volatility " (K; ) as a function of the strike price K. Here " = 0:1 and constants , r, and D are taken as in Fig. 1.

This equation can be solved for "(K;) with S and "xed. It follows from (22) that "(K;)! as"! 0:Fig.3 illustrates the 'smile' e ect, when in plied volatility "(K;) increases for deep-in and out-of-them oney options. Similar results are given in [24] where the characteristic time  $_{arb}$  depends on moneyness  $_{K}^{S}$ . Numerical results give a similar smile curve where the implied volatility becomes greater as we move away from at-themoney.

### 5 Conclusions

In this paper, we investigated the implications of random arbitrage return for option pricing. We extended previous works by using a stationary ergodic process for modelling random arbitrage return. We considered the case where arbitrage return uctuates on a dierent time scale to that of the option price. This allowed us to use asymptotic analysis to not option pricing bands rather than the exact equation for option value. We derived the asymptotic equation for the random eld that quantities the uctuations around the classical Black-Scholes price and showed that it is independent of the detailed statistical characteristics of the arbitrage return. In particular, we showed that the risk from the random arbitrage returns is greater for deep-in and out-of-the money options.

This gives an explanation of the \sm ile" e ect observed in the market in terms of the random arbitrage return.
