# On the correspondence between a screw dislocation in gradient elasticity and a regularized vortex

#### A bstract

We show the correspondence between a screw dislocation in gradient elasticity and a regularized vortex. The e ective Burgers vector, nonsingular distortion and stress elds of a screw dislocation and the e ective circulation, sm oothed velocity and m om entum of a vortex are given and discussed.

## 1 Introduction

The close relationship between vortices in uid mechanics and dislocations in elasticity theory has been known for many years (see, e.g., [1,2]). Both the dislocations and the vortices have singularities at the dislocation line and vortex line, respectively. Now adays it is very popular to regularize the stress and/or strain elds of a dislocation by means of nonlocal elasticity [3,4] and gradient elasticity  $[5\{10\}]$ . In such a theory an additional parameter called gradient coe cient is introduced. On the other hand, in uid mechanics a so-called \alpha-m odel" is used to sm ooth out the velocity of a vortex and an arbitrary parameter appears  $[11\{13]$ .

The main purpose of the present letter will be to give a one to one correspondence between the eld quantities of a nonsingular screw dislocation in gradient elasticity and a smoothed vortex in uid mechanics. Som e sim ilarities between gradient elasticity and the so-called \alphamodel" will be discussed. For instance, we will see that the parameter is a kind of a gradient coe cient in such a model.

## 2 Screw dislocation in gradient elasticity

D islocations are fundam ental line-like defects in solids. W e consider a single screw dislocation contained within an in nitely extended solid body. Its dislocation line and Burgers vector

are directed along the z-direction. The Burgers vector is the measure of strength (topological charge) of a dislocation and may be expressed in elasticity as follows

where  $_{ij}$  is the elastic distortion tensor in elasticity. In cylindrical coordinates, the elastic distortion of a single screw dislocation is given by [14]

where  $r^2 = x^2 + y^2$ . Therefore, we obtain  $b_z = b$ . In gradient elasticity, one may de ne a sm oothed distortion tensor <sub>ij</sub> which has to satisfy the following inhom ogeneous Helm holtz equation

where the right hand side is given in term s of  $_{ij}$ . It is obvious that Eq. (3) m ay be rew ritten in the form of a integral relation as a convolution integral

where the two-dimensionalG reen function is given by

Here K<sub>n</sub> denotes the modi ed Bessel function of the second kind and of order n. In Eq. (3) a parameter with the dimension of an inverse length is introduced. Eventually, one may de ne a characteristic length scale " = 1.

Substituting (2) into Eq. (3), we nd for the distortion in gradient elasticity [5,8,9]

This distortion is smoothed within the dislocation core and decays like  $r^{1}$  for large r. It is zero at r = 0 and has a maximum of max' 0.399 b=[2] at r' 1:114<sup>1</sup>. The distortion (6) satisfies the condition,  $0_{j ij} = 0$ .

U sing this sm oothed distortion, the e ective Burgers vector is calculated as [8,9]

It diers from the constant value b in the region from r = 0 up to r  $^\prime$  6= . In fact, we nd  $b_z$  (0) = 0 and  $b_z$  (1 ) = b.

The dislocation density tensor is de ned by

and ful lls the Bianchi identity for the torsion

which m eans that dislocations cannot end inside the solid body. W ith (6) and (8) the dislocation density of a single screw dislocation is obtained as [8,9]

In the lim it as  $^{1}$  ! 0, Eq. (10) converts to the classical dislocation density  $_{zz} = b$  (x) (y). By m eans of the sm oothed distortion and the H ooke law

where and are the Lam e constants, the sm oothed stress tensor of the single screw dislocation has the following form  $[3, 4, 6, 8\{10\}]$

which does not possess a singularity.

#### 3 Regularized vortex

Vortices are fundamental line-like excitations of a uid. We consider a vortex in an in nitely extended uid for which the conditions of static current and of incompressibility are fulled

Here  $v_i$  denotes the uid velocity and  $!_i = _{ijk} @_j v_k$  is the vorticity vector. The vortex line lies in the z-direction. The uid velocity of such a single vortex is in uid mechanics given by [15]

which is in nite at  $r = 0_H H ere$ , denotes the circulation which is a measure of strength of the singular vortex and  $= v_i dx_i$ . Therefore, the corresponding vortex density reads

On the other hand, one m ay de ne a locally sm oothed velocity  $u_i$  by the following inhom ogeneous Helm holtz equation (see, e.g., [12,13])

and the corresponding integral relation

which is introduced in the  $\alpha$ -pha-m odel". It is interesting to note that Eqs. (16) and (17) are similar in form as Eqs. (3) and (4), respectively. For two-dimensional problem sG is given by

and the three-dim ensional G reen function reads




Figure 1: Smoothed velocity  $u_r$  of a vortex (solid curve) is given in units of = [2 ]. The dashed curve represents the classical solution.

In our case the problem has cylindrical symmetry around the vortex line and, thus, it is twodimensional. Using (16) with (14), the sm oothed velocity for a single vortex is found as

$$u_r = \frac{1}{2} \frac{1}{r} n = K_1 r =$$

This smoothed velocity is displayed graphically in Fig.1. It has no singularity. In fact, it is zero at r = 0 and the maximum value of  $u_r^{max}$  ' 0.399 = 2 ] occurs at r' 1.114. Thus, the position and the value of the maximum velocity depend on the -parameter. On the other hand, these quantities should be measured in an experiment or in a related simulation. Therefore, in this way one can determ ine the -parameter for such a single vortex.

Using Eq. (20), the e ective circulation m ay be calculated

The e ective circulation is plotted in Fig.2.0 ne can see that it di ers from the constant value

in the region from r = 0 up to r' 6. It has (0) = 0 and (1) =. Thus, one might take  $r_c' 6$  as the core radius of the vortex. Again, the -parameter can be determined by the measurement of the probe for the elective circulation.

In analogy to the dislocation tensor (10), one may de ne a smoothed vorticity or vortex density as follows

Thus, vortices cannot end inside the uid. W ith (20) the vortex density is given by

which is smeared out around the vortex line. It is interesting to note that in the lim it as ! 0,  $t_z$  approaches  $!_z$  which is given by Eq. (15).




Figure 2: E ective circulation (r) = (solid curve).

Eventually, the sm oothed m om entum vector is de ned as

where % denotes the density. For the single vortex we nd the sm oothed m om entum

It does not possess any singularity.

#### 4 Summary

We have shown a one to one relationship between a screw dislocation in gradient elasticity and a smoothed vortex. A review of the correspondence between a regularized vortex in uid mechanics and a screw dislocation in gradient elasticity is given in Table 1.0 nem athematical

distinction, however, is that the characteristic uid quantities are vectors or scalars and their counterparts in solids are second rank tensors or vectors. We have discussed the sim ilarities

between gradient elasticity and the basic equations in the \alpha-m odel". It turns out that the \alpha-m odel" may be considered as a gradient or nonlocal theory for the vortex in uid mechanics. The -parameter is the gradient parameter in the model. In addition, we have given some hints to determ ine the -parameter for a vortex in an experiment or simulation.
