Low dimensional ordering and uctuations in methanol--hydroquinone-clathrate studied by X -ray and neutron di raction

M ethanol-hydroquinone-clathrate has been established as a model system for dielectric ordering and uctuations and is conceptually close to magnetic spin systems. In X-ray and neutron di raction experiments, we investigated the ordered structure, the one-dimensional (1D) and the three-dimensional (3D) critical scattering in the paraelectric phase, and the temperature dependence of the lattice constants. Our results can be explained by microscopic models of the methanol pseudospin in the hydroquinone cage network, in consistency with previous dielectric investigations.

Reducing the dimensionality has a drastic in uence on order-disorder phenom ena, as it generally enhances uctuations. Phase transitions are shifted to lower tem peratures, or may be suppressed entirely. In the onedim ensional Ising m odel with nearest-neighbor interaction, thermal uctuations suppress ordering at any nite tem perature, independent of the strength of the interaction. Theoretical models for low-dimensional ordering and uctuations are mostly tested on magnetically interacting m aterials, where the m agnetic m om ent is well decoupled from the surrounding chem ical lattice, and the interaction is short-ranged. M aterials with low dim ensional, but long-ranged interactions like the dipoledipole interaction are rare. Due to its sm all energy scale, the magnetic dipole-dipole interaction is often negligible com pared to exchange-type interactions, m agneto-elastic interactions and anisotropies induced by spin-orbit coupling and crystal eld. The electric dipole-dipole interaction (EDD) is several orders of m agnitude larger than its magnetic pendant. The electric dipole moment is connected to polarm olecules or to displacem ents of groups of atom s against each other. U sually, the interaction with the surrounding lattice is far from being negligible. M aterials, which allow to test theoretical predictions for uctuations and ordering of "pseudospins" interacting exclusively via the EDD interaction, are extrem ely rare. In this context, clathrates with polar guest molecules provide a happy exception. They may undergo structural phase transitions driven by the interactions between the dipole m om ents of the guest m olecules, with practically no coupling of the orientational degrees of freedom to the host lattice.

The present article deals with methanol-hydroquinone clathrate, where well de ned methanol electric dipoles occupy the almost spherical hydroquinone cavities. The electric dipoles arrange in chains




FIG.1: The methanolm olecule ($CH_{3}OH$) in the quinone cage network. The atom s of the guest molecules are shown with their Van-der-W aals diameters whereas for the hudroquinone host lattice the stich-and-ball presentation is used.

and are well decoupled from the surrounding host lattice. Thus the methanol clathrate can be understood in terms of interacting point-dipoles and has been established as a model system for dipolar ordering processes^{1,2,3,4,5}.

Figure 1 shows the m ethanol m olecule, which carries a dipole m on ent of 1.69 D ebye⁶, in the hydroquinone cage. The shortest distance between the guest m olecules is along the hexagonal c-axis. The geometry of the lattice combined with EDD interaction is responsible for the form ation of ferroelectric chains along the c-axis, reected in the dielectric properties: W oll et al. have studied the dielectric response as a function of temperature and frequency^{1,2}. The static dielectric constant along the hexagonal c-axis, "cs, shows a strong deviation from the C urie-W eiss behavior already at 250 K. The temperature dependence of "cs at higher temperatures is well described by a quasione-dimensional (1D) Ising m odel with a ferroelectric coupling J_c to nearest neighbors within the chain and a mean-eld antiferroelectric inter-chain interaction with coupling constant J_2 ⁷. At lower T, "_{cs}(T) deviates from this mean-eld-Ising-behavior and nally decreases with decreasing T, indicating the onset of three-dimensional (3D) antiferroelectric inter-chain correlations. At T_c=65 K the methanol-clathrate undergoes a transition into an antiferroelectrically ordered structure.

W hile the dielectric experiments probe the macroscopic response at Q = 0, at the center of the B rillouin zone, di raction experiments give access to the corresponding underlying microscopic processes and allow to study the structural susceptibility at arbitrary points in reciprocal space. In this article, we rst present X-ray di raction results obtained in the ordered phase, which allow to develop the dipolar structure model. Then we turn to the paraelectric regime, where we studied the 1D and 3D critical scattering by X-ray and neutron di raction experiments, as well as the tem perature dependence of the lattice parameters. We compare our results to theoretical predictions and discuss them in the context of the preceding dielectric experiments.

Experim ental

Single crystals of methanol-hydroquinone clathrate have been grown from a saturated solution of quinol and m ethanolat 313 K.Com pletely deuterated sam ples were used for neutron experiments to minimize the incoherent background. Typical sample crystals were 2x2x2 mm³. At room temperature, the methanol-clathrate has a rhom bohedral R3 structure⁸. Throughout this article, we use the hexagonal notation, which is better adapted to the dielectric properties of the clathrate than the rhom bohedral. Exceptions are marked explicitly by (:::)_{rh}. The hexagonal lattice param eters at 300 K are a= 16.62 A, c= 5.56 A. For the X-ray investigations, we used monochromatic CuK radiation and a two-circle di ractom eter, equipped with a closed cycle refrigerator. The single crystalline samples were oriented with c perpendicular to the scattering plane. This allows scans within the (hk0) plane. Scanswithin planes (hkl), 1 con-1 are possible by moving the detector out stant, 1 of the di ractom eter plane. Rotating crystal exposures have also been taken. Here the crystalwas rotated about c and the incom ing beam was perpendicular to the c-axis. Diuse 1D critical scattering has been measured at the two-circle neutron di ractom eter D 23 (CEA-CRG) at the high ux reactor of the ILL in G renoble, France. Here the 1D axis, c, was mounted in the scattering plane.




FIG.2: Rotating crystal photographs taken at T = 100 K (a) and 39 K (b). The elliptical lines are due to scattering from the A l-w indow s of the cryo-refrigerator.

R esults

0 rdered phase

Rotating-crystal X-ray photographs of methanolclathrate were taken above and below the phase transition $(T_c = 65 \text{ K})$. Figure 2a) displays the photograph taken in the paraelectric phase at T = 100 K, gure 2b) in the ordered phase, at 39 K . At high tem peratures, horizontal layers of re ections (hkl) with l = 0; 1; 2; :::are visible. Below T_c, additional relections in layers with integer and half-integer values of $l_1 l = \frac{1}{2}; \frac{3}{2}; \ldots$ appear. The (hkl) values of the superlattice re ections can be determined from their position on the photograph. Careful analysis shows that modes with wave vectors $k_1 = (00\frac{1}{2})_{rh}$ and $k_2 = (\frac{1}{2}\frac{1}{2}\frac{1}{2})_{rh}$ condense at the phase transition on the boundary of the rhom bohedral Brillouin zone at the Lifshitz points F (k_1) and L (k_2) . To generate all superlattice re ections as linear com binations of k_1 and k_2 , L and two arms of the F-star are required. This means, two of the rhom bohedral lattice vectors double at T_c. Additionally, the unit cell doubles in the hexagonal c direction (as indicated by the L-type




FIG.3: Projection of the 3D ordered antiferroelectric structure onto the hexagonal basal plane: white circles: dipoles at z = 0, grey circles: $z = \frac{1}{3}$, black circles: $z = \frac{1}{3}$. +/-indicates the orientation of the electric dipole. Below T_c, two of the rhom bohedral lattice vectors double (indicated by the dotted arrows). A long c, the dipoles order ferroelectrically. The ferroelectric chains arrange in ferro-ordered (100) layers with alternating sign from layer to layer. These layers are visualized by dotted lines. Solid lines indicate the hexagonal unit cells.

vector $k_2 = (\frac{1}{2}\frac{1}{2}\frac{1}{2})_{rh}$).

The occurrence of k_1 indicates the freezing of the methanolmolecules into one of the six symmetry directions of the R3 space group. The resulting structure of the dipole system in the dielectrically ordered phase is shown in Fig. 3. The dipoles are arranged in ferroelectrically ordered chains running along the hexagonal c-axis, which are arranged in sheets of alternating sign. As a property of the EDD interaction and the lattice symmetry, the dipoles prefer an antiferroelectric arrangem ent perpendicular to the chains, which can not be satis ed for all chains, because of the triangular lattice sym m etry. As a consequence, every dipole chain is surrounded by 4 chains, which are oriented antiparallel, and by 2 parallel oriented dipole chains. The antiferroelectric interaction is thus satis ed by the majority. The 42 pattern lls the hexagonalbasalplane in a regular fashion: Every dipole has the sam e environm ent of ferro- and antiferroelectrically oriented pseudospins. This 2-k1 ground state is also obtained from M onte Carlo calculations⁹ and simple lattice sum calculations, considering the EDD interaction of the guest m olecules, only (see R ef. [10] for the case of acetonitrile).

The doubling of the unit cell along c, evidenced by the occurrence of L-type k_2 re ections, indicates an antiphase arrangement in neighboring cells along c. k_2 indicates a dimerization of the dipoles in the 1D chain, i.e. the appearance of pairs of strongly coupled pseudospins. Considering the EDD interaction in combination with a at potential in the cage center, the latter dimerization is energetically favorable, as we will discuss below. The ordering of the dipole system at T_c is connected with a structural phase transition into the triclinic space group P1, connected with a small triclinic distortion of the host lattice below T_c².

Paraelectric regim e

The 1D uctuations in the dipole chains give rise to di use scattering which is distributed in planes perpendicular to the 1D axis (and weighted by the methanol molecular form factor). The onset of 3D ordering close to the phase transition is indicated in di use scattering at the positions of the superlattice relations (of the low – T phase). The correlation length along the dipole chains, c, and perpendicular, ?, follows from the quasi1D Ising model, which has also been applied to t the dielectric data, to⁷:




FIG. 4: (a): Diuse 1D -scattering at $Q = (3 \overline{45} \overline{1} +)$ (neutron measurement) and (b) diuse 3D -scattering at $Q = (7 + \overline{3} 0.43 \overline{0.5})$ (measured with X-rays). At 65 K the superlattice rejection of the ordered low-T phase is already visible as a sharp peak. (An A +powder line has been cut around h = 6.55.)




FIG. 5: Correlation length $_{\rm c}$ (a) und $_{\rm ?}$ (b), parallel and perpendicular to the dipole chains as it was determ ined from Fig. 4. Solid lines are ts after Eq. (1) and (2). Results from neutron di raction are marked by (), X-ray results by ().

(t = (T $T_{\rm c}){=}T_{\rm c}$ is the reduced critical tem perature). Figure 4 shows di use 1D and 3D scattering as measured with X-ray and neutron di raction at di erent tem peratures in the paraelectric regime. We investigated the weak 1D scattering on a neutron di ractom eter because the contribution of the methanol molecules to the total scattering is higher in neutron scattering with deuterated samples than in the X-ray experiments. The correlation lengths c and ? follow from the width of Lorentzian peak pro les and are shown in Figure 5. The solid lines in the gure are ts after Eq. (1) and (2). The tting parameter $J_{\rm c}$ is determined to $J_{\rm c}$ = 202 K , in excellent agreem ent with the dielectric results (195 K¹). The structuraldata are welldescribed by the quasi1D Ising model. The onset of the 3D correlations close to T $_{\rm c}$ nally leads to the phase transition into a 3D antiferroelectrically ordered structure.

There is no indication of a static dimerization of the dipole chains in the paraelectric phase, i.e. no intensity at the superlattice positions of k_2 . But as a true 1D feature, the dimerization could already appear in the dynam ically ordered chain segments in the paraelectric regime, where the 1D uctuations already reach some hundreds of unit cells. We found no sign of di use scattering in planes with half-integer values of 1, as caused by uctuations of the dimerization above T_c. From calculations of the methanol structure factor¹³ where we allow ed a displacement of the dipoles along the 1D axis of = 0.25 A, the intensity of the di use scattering due to the dimerization can be estimated as being at least two orders of magnitudes maller than that of the 1D critical scattering. The corresponding correlation length spectrum spectrum spectrum as the set of the s

than c, the corresponding critical scattering as a conse-

quence broader. If the dimerization of the dipole chains already occurs in the paraelectric phase, this e ect presum ably is too sm all to be seen in standard di raction

experim ents.




FIG.6: Tem perature dependence of the hexagonal lattice param eters a (a) und c (b) of the hexagonal cell. The dotted line in part (b) is a linear extrapolation of the high tem perature linear behavior to lower T.

D iscussion

Figure 6 shows the tem perature dependence of the hexagonal lattice parameters a and c, as derived from the B ragg positions. W hilst the a-axis decreases linearly with tem perature, c shows a distinct anomaly below about 170 K.

The structure of the dipole system in the dielectrically ordered phase in methanol-hydroquinone-clathrate, as determined from the analysis of the superlattice reections below T_c , agrees well with the ground state calculated by M onte C arlo simulations⁹ and lattice sum cal-

culations. The temperature behavior of the correlation length $_{\rm c}$ and $_{?}$ is well described by the corresponding quasi 1D model by Scalapino et al.⁷. The structural investigations therefore con m them icroscopic picture for low dimensional ordering and uctuations of the methanol pseudospins in the -hydroquinone cagework, as it was deduced from the dielectric experiments.

An interesting point is the appearance of superlattice re ections of type " k_2 ", because they indicate a doubling of the unit cell in the 1D direction. The most probable explanation of this doubling is a dimerization of the dipoles in the 1D chains. Considering a 1D chain of electric dipoles on a deform able lattice (with distance d), interacting solely by the electric dipole-dipole interaction, a dimerization of the chain with respect to an alternating distance d+ and d of the dipoles is energetically favorable. Because of the rather steep r^3 potential, a dipole can lower its energy much more by approaching its neighbor by a distance than it at the same time looses potential energy by rem oving from the second neighbor in the 1D chain. The small lattice distortion at T $_{\rm c}$ (a $\,$ rst order structural transition) nally leads to a coupling of the two otherwise independent wave vectors k_1 and k_2 . The freezing of the methanol-molecule and the static dim erization of the pseudospins along the chains therefore fall together at T_c. In a system with sm aller coupling of the pseudospins to the surrounding host lattice, two successive transitions should occur. In 1D $S = \frac{1}{2}$ m agnetic chain compounds, $CuGeO_3$ is a prominent example¹¹, a structural phase transition into a statically dimerized structure is observed well above the magnetic ordering tem perature. The nature of this spin-Peierls-transition is purely quantum mechanical. The pairing of neighboring antiferrom agnetic S = $\frac{1}{2}$ spins to a S = 0 singlet leads to an energy gap thereby suppressing therm alspin uctuations and low ering the ground state energy.




FIG.7: Temperature dependence of the anom alous part of the lattice constant c (, see text for explanation) and the 1D correlation length $_{\rm c}$ (). The solid line is the t from Fig 5 after Eq. (1).

W hat is the reason for the unusual tem perature behavior of the 1D lattice parameter c? Fig. 7 shows the anom abus part of the tem perature dependence of the lattice param eter, i.e. the di erence of the lattice param eter c from Fig. 6 b) to an extrapolated linear decrease with tem perature and the measured and calculated correlation length $_{\rm c}$ from Fig. 5 in the same plot. W hen choosing the right scaling factor, the anom alous part of $c_r c_{an}$, and the correlation length c_c fallon the same curve and both are well described by the quasi 1D Ising model in Eq. (1). That suggests a coupling of the 1D uctuations in the paraelectric regime to local strains. Such a coupling, however, is forbidden in the centrosymmetric space group R 3; the coe cients of the (direct) piezoelectric e ect all vanish¹². The peculiarity of the present system is the unusual large am plitude of the paraelectric uctuations. Because of the reduced dimensionality of the interactions, the ferroelectric uctuations are strongly enhanced. The anom aly of coccurs below about 170 K, where the correlation length already reaches about 40 lattice units, $_{c}$ (170 K)=c' 40 (see Fig. 5). Coupling via higher order terms in susceptibility and strain, which

become important due to the long ranged correlations, then presum ably leads to the observed electrostriction. This e ect is likely to occur in other low-dimensional systems, but has not been reported before. We do not know, why the electrostriction leads to a dilatation of the -hydroquinone host lattice ($c_{an} > 0$) and a larger distance of the pseudospins in the 1D direction. Intuitively, a contraction along c should be energetically more favorable.




FIG.8: H exagonal lattice parameter c for the concentrations x=0.97, x=0.79, x=0.73 and x=0.50. The curves are shifted vertically, for clarity. At 270 K, the lattice parameters for all concentrations coincide.

W e investigated m ethanol-clathrates with m ethanoloccupancies less than 100 % to prove that the anom aly ofc is a true property of the EDD interaction. By low ering the fractional occupancy of the cavities, the interaction between the pseudospins is diluted and the transition into a dielectrically ordered state shifts to low er tem peratures. Sam pleswith a larger percentage x of lled cavities (x > x_c ' 0:76) show conventional ordering via a rst order phase transition into an antiferroelectrically ordered structure, whereas the others $(x < x_c)$ freeze into dipolar glasses^{1,2,3,4}. The tem perature dependence of the 1D lattice parameter c for several lling degrees down to 50 % is shown in Figure 8. Comparing the structural data with the static dielectric constant for di erent degrees of occupation, see e.g. Fig. 13 from Ref. [2], there is an analogous behavior: The anom aly ism ost pronounced for the completely led methanol-clathrate. W hen reducing the lling, the anom aly shifts to low er tem peratures and broadens.

C on clusion

The methanol clathrate can serve as a model system for dielectric ordering and uctuations and is conceptually close to magnetic spin system s. Because of the lattice symmetry and the peculiar property of the EDD interac-

tion, the latter clathrate has quasi 1D dielectric properties. From analysis of the superlattice re ections in the dielectrically ordered phase, we can con m the theoretically predicted 4.2 structure. The latter ground state can be calculated from M onte C arlo simulations and rst principles, considering the EDD interactions between the

guest molecules, only. We observe 1D and 3D critical scattering in the paraelectric regime in neutron and X-ray di raction experim ents. The tem perature dependence of the correlation lengths $_{\rm c}$ and $_{\rm a}$ is well described by the corresponding quasi1D Ising theory and agrees perfectly with results from dielectric investigations, thereby conm ing the m icroscopic picture of low dimensional ordering and uctuations of the methanol pseudospins in the hydroquinone cagework. The EDD interaction on a deform able lattice should be unstable against a dim erization of the dipoles in the 1D chains. At the dielectric ordering tem perature T $_{\rm c}$ we $\,$ nd superlattice re ections that indicate a doubling of the unit cell in the 1D direction, i.e. a static dimerization of the dipole chains. We nd no sign of di use scattering in half-integer layers of l due to uctuations of the dim erization. Below T = 170 K an anom aly in the tem perature dependence of the 1D lattice parameter coccurs. The large amplitude of the 1D uctuations in the paraelectric regime leads to a coupling of the susceptibility to local strains and a piezoelectric e ect in the otherwise centrosymmetric space group R3. This e ect is likely to be observed in low dimensional interacting system s because uctuations are strongly enhanced and long ranged.
