G rand canonical ensemble in generalized therm ostatistics

Abstract. We show that one can formulate a grand-canonical ensemble with uncertain number of degrees of freedom without making specic cassum ptions about the canonical ensemble. Several choices of grand-canonical entropy functional are considered. The ideal gas in non-extensive therm ostatistics is discussed as an application.

1. Introduction

In generalized therm ostatistics some of the assumptions, which lay at the basis of G ibbs' theory of the canonical ensemble, are not imposed. As a consequence, the equilibrium probability distribution $p_{n}(x)$, with x a point in n-particle phase space _____n, is not necessarily of the B oltzm ann-G ibbs form

Here, is inverse tem perature, $H_n(x)$ is the energy functional, and Z_n is the appropriate norm alization factor. On the contrary, $p_n(x)$ could be rather arbitrary, satisfying som e m ild constraints of therm odynam ic origin.

There m ay be several reasons why an experim ental observation yields a result which is not in agreement with (1). It is not the goal of the present paper to discuss these reasons in a systematic manner. It su ces to remark here that such situations do occur frequently. Recent examples are [1, 2, 3, 4]. Hence it is worthwhile to study generalized therm ostatistics from a theoretical point of view.

Many results of statistical mechanics do not depend on the actual choice of equilibrium probability distribution for the canonical ensemble. Offen, the reason for this independence is the result known as equivalence of ensembles, which is expected to hold for system s with many degrees of freedom. The choice of (1) is usually convenient, but not obligatory. In particular, deviations of (1) are expected when the number of degrees of freedom is limited. In the present paper is shown that a grand-canonical

ensemble with an uncertain number of degrees of freedom can be formulated without making speci c assumptions about the equilibrium distribution of the corresponding canonical ensemble.

A Itematives for the Boltzm ann-G ibbs distribution (1) are highly non-unique. P robability distributions proposed in the context of non-extensive therm ostatistics [5] are suitable to serve as examples because these distributions share m any of the properties of (1). In particular, for the distributions based on deform ed exponential functions [6, 7] therm odynam ic stability has been proved [8, 9]. All these distributions can be used as a basis to form ulate a grand-canonical ensemble in which the num ber of particles varies.

To be more speci c we discuss the model of the ideal gas of classical point particles. This model has been studied for the statime in the context of non-extensive therm ostatistics in [10]. However, this and subsequent works [11, 12, 13, 14] have treated the problem in a canonical ensemble. In such an approach the phase spaces for n = 0;1;2;particles are all taken together into one in nite dimensional phase space. This composite system is then treated in a canonical ensemble. In a quantum m echanical treatm ent the above procedure involves the construction of Fock space. Then physical states occur which are superposition of states with di erent num ber of particles. In the present paper the opposite point of view is taken. The number of particles of the gas is xed but unknown to the experimenter. Hence, uctuations in the number of particles should be treated as a classical problem of lack of inform ation involving an ensemble of possibilities (n = 0;1;2;), only one of which is realized. On the other hand, the physical system contains a nite, possibly small, number of particles. With appropriate boundary conditions, for example those of [4], it can be correct to describe such a system as being non-extensive.

Section 2 serves to x notations. In Section 3 the probability $\frac{1}{4}$ that (part of) the system contains n particles is introduced. An expression for the grand canonical entropy S is proposed. In Section 4 these probabilities z_n are determined by means of a variational principle. In Section 5 is shown that all usual therm odynam ic relations are satis ed. Sections 6, 7, and 8, treat non-extensive therm ostatistics, and the ideal gas in particular, as a special case. In Section 9 various alternatives are discussed. The nal section gives a sum m ary of results and indicates possibilities for further work. Appendix A deduces the generic form of the grand-canonical entropy. Appendix B reproduces known results about the ideal gas in non-extensive therm ostatistics. Appendix C contains an alternative treatment of the ideal gas.

2. A constant num ber of particles

The equilibrium distribution p $_{n\atop n}$ is used to calculate average energy U $_{n}$ () by

Therm odynamic stability requires that U_n () is a decreasing function of $% U_n$. There should exist an entropy function S_n (U) with the property that

is satisfied. is inverse temperature | units are used in which $k_{\rm g} = 1$. Given p $_{\rm pn}$, this entropy function can be obtained, up to an integration constant, by integrating (3).

Consider e.g. an ideal gas in dimension . Its energy functional is given by

An example of an equilibrium distribution p $_{\rm m}$, other than Boltzmann-Gibbs, is a distribution of the form

with small but positive. Such a distribution may be an appropriate tool to describe a gas enclosed in a container and kept at constant pressure by means of a piston. Energy

uctuations are then due to microscopic motions of the piston. A short calculation gives

which is the same result as in case of a Boltzm ann-Gibbs distribution. A suitable choice of entropy is then

Here, V is the volum e and L and h are constants inserted for dimensional reasons (we chose units in which $k_B = 1$). In classical mechanics h is a free scaling parameter. In quantum mechanics it is Planck's constant and is xed by the ratio between energy and frequency of a photon. The integration constant has been chosen in such a way that the standard expression for entropy of an ideal gas is obtained. As is well known, classical expressions of entropy, contrary to quantum mechanical ones, become negative and diverge when average energy U of the ideal gas tends to zero. This non-physical behavior restricts the usefulness of the ideal gas model to high energies.

3. G rand canonical averages

In the grand canonical ensemble a given number of particles n occurs with probability z_n , norm alized to

The numbers c_n are usually taken equal to 1=n!. This choice is justimed using the argument that permutation of particles is a symmetry of the system. Grand canonical averages are calculated using

However, grand canonical entropy S(;z) is not just an average of canonical entropies $S_n(U_n())$ because additional entropy originates from the uncertainty about the number of particles n. It is shown in Appendix A that in equilibrium the grand canonical entropy S(;z) must be of the form

with a function F(z) which depends on the probabilities $z_0; z_1;$ but may not depend on . This motivates the denition

O f course, other choices for the function F (z) are possible but there is no reason to take som ething else than the most obvious expression for the entropy of the probabilities z_n with a priori weights c_n .

4. G rand canonical equilibrium

The equilibrium values of the probabilities z_n are obtained by m in in ization of the free energy U (;z) TS (;z) under the constraint that the average number of particles N (z) has some given value. Equivalently, one maxim izes the Lagrange function

The resulting equilibrium values of S (;z), U (;z), and N (z) are denoted S, resp. U and N .

5. Therm odynam ical relations

The grand-canonical potential (;) is de ned by [5]

These results are of course not new. Point is that they can be derived without assuming (1). The last of equations (29) is the ideal gas law. The equation for the entropy can be written as

In this form it is known as the Sackur-Tetrode equation. This equation agrees well with experimental data | see [16], Section 5-3. The heath capacity C_v evaluates to

The rst term is half the constant of Dulong and Petit. The latter term is the contribution due to the temperature dependence of the number of particles.

6. N on-extensive therm ostatistics

In recent literature on non-extensive therm ostatistics [17, 18] average energy U_n () is calculated using the probability distribution

Note that this is the so-called escort probability distribution [17]. In particular, (2) holds for this distribution. In (32) Z_n is the norm alization

The notation $[u]_{+} = m \exp(0)$; ug is used. Note that the expression for U_n (), based on (32), is self-referential. In general, there is no guarantee that this implicit equation yields a solution U_n (). In addition, this solution should be a decreasing function of . Entropy S_n (U) is given by

W ith this de nition β) is satis ed. Hence the grand-canonical ensemble can be introduced along the lines of Sections 3, 4, 5.

For the ideal gas, one can show that the implicit equation for U_n () has a solution (See [12, 13]; For sake of completeness the calculation is reproduced in Appendix B). It is given by (6), with replaced by $_q$. A problem that now arises is that $_q$ is an increasing function of only if the condition

is satisfied (see Appendix B). We need this condition for stability reasons: energy should be an increasing function of temperature. Hence (36) must hold. But clearly, for fixed q the condition is always violated if n becomes large (0 < q < 1 is assumed the whole time). Hence our approach, involving sums over all, is not valid for the ideal gas in combination with the non-extensive probability distribution (32).

In [14] the assumption is made that $_{q} =$, instead of (34). Then the appropriate entropy for which (3) holds is

A snoted in [14], equipartition now holds in its original form (6). Expression (37) reduces to (7). Hence the grand-canonical description of the ideal gas with uctuating number of particles is described by (29). This shows that not only (5) but also (32), with $_{\rm q} =$, cannot be distinguished from (1). The question whether should equal $_{\rm q}$ or should be given by (34) is intricate and is related to the choice of canonical and m icrocanonical entropy. See the discussion in [19] and the comment on this paperm ade in [20]. Further investigations are needed to clarify this point.

7. A lternative treatm ent

In Section 3 the assumption is made that the grand-canonical entropy has two contributions, the average of entropies at xed number of particles n and a contribution due to uctuations in n. For the latter the expression of Shannon information has been used. This is the most logical choice in our approach because the variational principle is used only to deduce the ensemble with variable number of particles from the ensemble with xed number of particles. Quite often the equilibrium state at constant n is already obtained by means of a variational principle. In that case our approach consists of two subsequent optimizations of an entropy functional. O ne can prefer to do this optimization in one single step. This yields of course the same results. However, one could then argue that Shannon information is inappropriate to describe uctuations in the number of particles in case another type of entropy functional is already used at the level of a xed number of particles.

An example of an entropy functional, which can replace (14), is

Each term in this sum is essentially the entropy functional advocated by T sallis [5], with q_h replaced by 2 q_h | see [9] for an explanation why this change is made. Note that, unlike in section 6, the parameter q is made n-dependent and is assumed to be larger than 1. This assumption is made just to show that it is also possible. The entropy functional (38) is maximized under the constraints that average energy U and average particle number N should have specified values. This optimization involves Lagrangemultipliers , and , much like in (15). The resulting equilibrium probability distribution is

where $p_{n}(x)$ are equilibrium distributions at xed number of particles. However, one can show that $p_n(x)$, as given by (39), satisfies all therm odynamic relations discussed in Section 5. See Appendix C. Hence, from a therm odynamic point of view this alternative treatment is fully acceptable. Technically, this choice of entropy functional is more difficult than (14) because an analytic expression for normalization , similar to (17), is missing.

8. D iscussion

In the rst part of this paper we have given a description of a gas with a uctuating number of particles n without specifying the equilibrium distribution at xed n. Motivation for making this rather trivial extension of the standard grand-canonical description is that in many experiments the conditions for a constant temperature ensemble at xed n are not satisfied. In the extended theory standard therm odynamic relations are still satisfied provided that entropy and energy at xed n satisfy the well-known temperature relation (3). A simple example is the ideal gas model for which standard results like the ideal gas law or the Sackur-Tetrode equation are obtained without assuming a Boltzm ann-G ibbs distribution.

In the last part of the paper non-extensive therm ostatistics is considered as a special case of generalized therm odynamics. The distributions of non-extensive

them ostatistics are characterized by the fact that the probability of large energies does not decrease exponentially as is the case with Boltzm ann-Gibbs. Rather they go either with a powerlaw (called the q > 1-case) or they have a cuto energy above which con gurations have vanishing probability (q < 1-case). Point of discussion in non-extensive them ostatistics is how to de ne inverse temperature . Inherently related is the de nition of them odynam ic entropy, which is obtained by integrating the therm odynam ic relation (3). Following [17, 18], the parameter $_q$ occurring in the equilibrium probability distribution (32) is not but is related to it by (34). For the ideal gas, (34) in plies that the non-extensivity parameter q must go to 1 as the number of particles n becomes large. But, our treatment of the grand-canonical ensemble involves sum s over all values of n. It is therefore not applicable in this case, except when q = 1.

On the other hand, [14] m ade the assumption that $_q = .$ Then the equipartition law $((1=2)k_B T \text{ of energy per degree of freedom})$ still holds. W ith an appropriate choice of entropy $S_n (U_n)$ the therm odynam ic description at constant number of particles is identical with that of the extensive case. As a consequence, also the grand-canonical descriptions coincide.

O ur treatm ent of the grand-canonical ensemble is kept as simple as possible. The assumption is made that the uctuation of the number of particles is well described by a maximum -entropy principle involving Shannon's measure of information. However, many alternatives can be considered. One of them is discussed in section 7.

The present work is only a rst step in describing real gases using generalized therm ostatistics. The logically next step is a study of the virial expansion. One can expect that the virial coe cients will depend on the detailed form of the canonical equilibrium distribution.

Appendix A.Form of the grand canonical entropy

Here we show that in equilibrium the grand canonical entropy must be of the form (13). From (15) it follows that
