Local phonon density of states in an elastic substrate

The local, eigenfunction—weighted acoustic phonon density of states (D O S) tensor is calculated for a model substrate consisting of a sem i-in nite isotropic elastic continuum with a stress-free surface. On the surface, the local D O S is proportional to the square of the frequency !, as for the three-dimensional D ebye model, but with a constant of proportionality that is considerably enhanced compared to the D ebye value, a consequence of the R ayleigh surface modes. The local D O S tensor at the surface is also anisotropic, as expected. Inside the substrate the local D O S is both spatially anisotropic and non-quadratic in frequency. However, at depths large compared with v_1 =!, where v_1 is the bulk longitudinal sound velocity, the local D O S approaches the isotropic D ebye value. The results are applied to a Si substrate.

I. INTRODUCTION AND ELASTIC SUBSTRATE MODEL

A variety of surface and near-surface therm odynam ic and lattice dynamical phenomena are governed by the phonon density of states (DOS), the number of vibrationalm odes per unit frequency, per unit volum e of solid. In an inhomogeneous system, however, it is possible to distinguish between the \global" DOS, which makes reference to only to the vibrational-mode frequencies of the entire system, and a local, eigenfunction-weighted DOS. In system swith a smallmechanical surface-to-volumeratio, the volume including all parts of the system and environm ent participating in the vibrations, the global DOS is essentially unchanged from that of a bulk system. The eigenfunction-weighted DOS is interesting both because it is relevant to a variety of physical phenomena, and because it contains local, position-dependent mechanical and vibrational inform ation about the system.

In this paper, we calculate the local phonon D O S tensor for a model substrate consisting of a sem i-in nite isotropic elastic continuum with a stress-free surface, appropriate for low-frequency acoustic phonons in real solids with an exposed clean surface. The elastic continuum is also assumed to be linear and nonpolar. The free surface is taken to lie in the xy plane, with the substrate occupying the z>0 half-space. Periodic boundary conditions are applied in the lateral directions, on an area A. Normalized vibrational eigenfunctions have been obtained for this geometry in a classic paper by E zawa.

II. LOCAL PHONON DOS TENSOR

We begin by de ning the local DOS tensor g_{ij} (r;!), the quantity to be calculated in this paper. The Lagrangian density for a linear, nonpolar, isotropic elastic continuum is

where u (r;t) is the displacement eld, and where u_{ij} ($\theta_i u_j + \theta_j u_i$)=2 is the strain tensor. is the mass density, and and are the standard Lame coe cients, related to the bulk longitudinal and transverse sound velocities v_l and v_t according to $v_l = \frac{transverse}{(t+2)} = \frac{transverse}{transverse} = \frac{transverse}{transverse}$. It will also be useful to de ne an elastic stress tensor T_{ij} from the continuity equation $\theta_{t-i}+\theta_{j}T_{ij}=0$ for momentum density $\theta_{t}u$. In an isotropic elastic medium, it follows from Eq. (2) that

where the f_n (r) are vibrational eigenfunctions, de ned to be time-periodic solutions of the elasticity equation (2), in the presence of the stated boundary conditions, and normalized according to d^3r f_n $_{r}f_0 = _{nn^0}$: Here the integration is over the volume V of the system. The

vibrational eigenfunctions are assumed to be complete, so that $f_n^i(r) f_n^j(r^0) = f_n^i(r^0)$:

The quantity we shall calculate in this paper is²

where i and j are Cartesian tensor indices. This quantity weights each vibrational mode n by the square of the amplitude of the eigenfunction at position r. The trace of g_{ij} (r;!) also contains physically interesting information, namely

which is the ordinary intensive globalDOS, i.e., the number of vibrationalm odes per unit frequency per volume.

In an isotropic system with translational invariance, the local DOS is independent of position, and Eq. (8) simplifies to

where a three-dimensional system is assumed. Because there is no position dependence here, the trace of this quantity yields the global DOS [the right-hand-side of Eq. (10)].

Is the localD O S de ned Eq. (8) a quantum m echanical quantity? O ne the one hand, it does not involve h, and in that sense it is not quantum m echanical. O n the other hand, however, the normalization assumed for the f_n (r) is of quantum m echanical origin: A ssum ing the conventional bosonic commutation relations for the a_n and a_n^y appearing in the expansion of Eq. (7), the normalization condition on the vibrational eigenfunctions is required for Eq. (6) to be satised. Therefore, the localDOS de ned Eq. (8) naturally shows up in quantum mechanical calculations of the vibrational properties of inhomogeneous systems.

III. LOCAL DOS IN THE THREE-D IM ENSIONAL BULK LIM IT

In what follows it will be useful to recall the well-known D ebye DOS formula. The spectrum and normalized vibrational eigenfunctions for a three-dimensional isotropic elastic continuum, with periodic boundary conditions applied to the surface of a three-dimensional volume V, are

where m = (l;t_1;t_2) labels the longitudinal and two transverse branches, the sound velocities are the bulk values quoted in Sec. II, and the mk are unit polarization vectors forming an orthogonal basis. k is oriented in the k direction, and the mk are perpendicular to k and to each other.

Eq. (15) is the conventional three-dimensional Debye DOS tensor for acoustic phonons. Of course, in a real solid the continuum approximation breaks down at short wavelengths and the spectrum is cut oat high frequencies.

IV. LOCAL DOS IN SEM I—IN FIN ITE ELASTIC SUBSTRATE W ITH A STRESS—FREE SURFACE

The evaluation of the local DOS for our substrate m odel requires the vibrational eigenfunctions of a sem iin nite isotropic elastic continuum with a stress-free surface, which have been obtained by Ezawa. The modes are labeled by a branch index m, taking the ve values SH, +, , 0, and R, by a two-dim ensional wavevector K in the plane de ned by the surface, and by a param eter c with the dimensions of velocity that is continuous for all branches except the Rayleigh branch m = R. The range of the param eter c depends on the branch m, and is given in Table I. The frequency of mode (m; K; c) is $!_{m \ K \ C} = cK ; where K$ K j is the magnitude of the two-dim ensional wavevector. As stated above, we shall assum e periodic boundary conditions in the x and y direction applied to a nite area A.4

TABLE I: Values of the parameter c for the vebranches of vibrational modes of a sem i-in nite substrate. The Rayleigh branch m = R has a single value of c, which we denote by c_R .

The de nition of the local DOS given in Eq. (8) applies to a system with a discrete spectrum. The generalization of Eq. (8) to our model, which has a mixed discrete-continuous spectrum, is

The rst term accounts for the Rayleigh surface wave branch m=R, and these vibrational mode eigenfunctions are normalized as in Sec. II. The value of c for the Rayleigh branch, c_R ; is calculated below. The second term in Eq. (16) accounts for the four remaining branches m=SH;+;; and 0; having continuous values of c. Their eigenfunctions are instead normalized according to $d^3r f_{m K c} f_{m K c} f_{m K c} f_{m K c} (c c^0)$: Furthermore, m is the integration domain given in Table I.

We turn now to an evaluation of Eq. (16). The contribution from each branch in Table I will be discussed separately in the sections to follow.




FIG. 1: D im ensionless local D O S functions g_k (solid curve) and $g_?$ (dashed curve), de ned in Eqs. (57) and (58), for an isotropic elastic continuum model of a Si substrate. Here ! $z=v_1$: The D O S functions are essentially equal to unity for > 10.

V. APPLICATION TO SILICON

To apply these results, we shall approximate Sias an isotropic elastic continuum with longitudinal and transverse sound velocities

The velocities above follow from using the m easured elastic constants $c_{11}=1:67 \ 10^{12}$ dyn cm 2 and $c_{44}=8:01 \ 10^{11}$ dyn cm 2 at 70 K reported in Ref. [5]. A m ore precise m ethod of determ ining these velocities would be to use the actual anisotropic elastic tensor to construct a best to an isotropic one. However this only makes small changes in the nal results.

In Fig. 1, we present plots of the dimensionless DOS functions g_k () and g_i () for Si. Here ! $z=v_l$; where! is the angular frequency, z is the perpendicular distance from the surface, or depth, and v_l is the bulk longitudinal sound velocity. The dimensionless DOS has an interesting oscillatory structure when is small, and approaches unity in the large limit. When = 0,

On the substrate surface, z=0, the local DOS is considerably modi ed from the bulk Debye value, as a consequence of Eqs. (64) and (65). In particular, $g_{xx}(0;!)$




FIG. 2: Frequency dependence of the local DOS g_{xx} (z;!) = g_{yy} (z;!) (solid curve) and g_{zz} (z;!) (dashed curve) for a xed z>0, compared to the purely quadratic frequency dependence (dotted curve) of the Debye model. In all cases the DOS is given in units of (2+ 3)=6 $^2v_t^3$. The frequency is plotted in units of $v_1=z$, where v_1 is the bulk longitudinal sound velocity. E lastic param eters corresponding to Si are assumed.

and g_{yy} (0;!) are quadratic in frequency with a constant of proportionality g_k (0) times that of the Debye model. Similarly, g_{zz} (0;!) is quadratic in!, with a constant of proportionality a factor of g_2 (0) larger than in the Debye case.

The oscillatory structure in g_k () and g_2 () also m odies the frequency dependence of the local D O S inside the substrate. This is illustrated in Fig. 2, where g_{ij} (z;!) is plotted in units of (2+ 3)=6 $^2v_t^3$. In these units, the D ebye D O S is simply ! 2 , shown as the dotted line in the quire.

VI. DISCUSSION

We have calculated the local, eigenfunction-weighted acoustic phonon DOS tensor for a model substrate consisting of a sem i-in nite isotropic elastic continuum with a stress-free surface, and applied the results to Si. The local DOS on the surface is quadratic in !, with a proportionality constant that is enhanced compared to the three-dimensional bulk Debye model. The enhancement factors for Si are given in Eqs. (64) and (65). Inside the substrate the frequency dependence is non-quadratic, as illustrated in Fig. 2. At depths z large compared with $v_1\!\!=\!\!1$, where v_1 is the bulk longitudinal sound velocity, or at frequencies! large compared with $v_1\!\!=\!\!z$, the local DOS approaches the isotropic Debye value. These regimes corresponds to the large limits of g_k () and g_2 (), de ned in Eqs. (57) and (58).

As expected, the presence of the free surface signicantly changes the vibrational properties of the system when the condition z < is met, where is a characteristic bulk phonon wavelength with frequency ! . At a xed frequency, this condition reduces to a requirement on distances from the surface, whereas at xed depths it becomes a condition on frequency.
