Them alconductivity in the doped two-leg ladder antiferrom agnet Sr_{14} $_xC$ a_xC $u_{24}O$ $_{41}$

Within the t-J model, the heat transport of the doped two-leg ladder material $Sr_{14} \times Ca_xCu_{24}O_{41}$ is studied in the doped regime where superconductivity appears under pressure in low temperatures. The energy dependence of the thermal conductivity $_c(!)$ shows a low-energy peak, while the temperature dependence of the thermal conductivity $_c(T)$ is characterized by a broad band. In particular, $_c(T)$ increases monotonously with increasing temperature at low temperatures T < 0.05J, and is weakly temperature dependent in the temperature range 0.05J < T < 0.1J, then decreases for temperatures T > 0.1J, in qualitative agreement with experiments. Our result also shows that although both dressed holons and spinons are responsible for the thermal conductivity, the contribution from the dressed spinons dominates the heat transport of $Sr_{14} \times Ca_xCu_{24}O_{41}$.

recent years the two-leg ladder material Sr₁₄C u₂₄O 41 has attracted great interest since its ground state may be a spin liquid state with a nite spin gap1. This spin liquid state may play a crucial role in superconductivity of doped cuprates as em phasized by Anderson². When carriers are doped into Sr₁₄Cu₂₄O₄₁, such as the isovalent substitution of Ca for Sr, a m etal-insulator transition occurs 1;3;4, and further, this doped two-leg ladder m aterial $\mathrm{Sr}_{14}~_{x}\mathrm{C}\,a_{x}\mathrm{C}\,u_{24}\mathrm{O}_{41}$ is a superconductor under pressure in low tem peratures^{3;4}. A part from the observation of superconductivity under pressure in Sr_{14} $_{x}Ca_{x}Cu_{24}O_{41}$, the particular geom etrical arrangement of the Cu ions provides a playground for magnetic and transport studies of low-dimensional strongly correlated materials¹. All cuprate superconductors found up now contain square CuO2 planes, whereas Sr_{14} $_xCa_xCu_{24}O_{41}$ consists of two-leg ladders of other Cu ions and edge-sharing CuO₂ chains^{1;3;4}, and is the only known superconducting copper oxide without a square lattice. Experim entally, it has been shown by virtue of the nuclear magnetic resonance and nuclear quadrupole resonance, particularly inelastic neutron scattering measurements that there is a region of parameter space and doping where Sr_{14} $_xCa_xCu_{24}O_{41}$ in the norm alstate is an antiferrom agnet with commensurate short-range order^{1;6;7}. M oreover, transport m easurements on Sr_{14} $_{x}Ca_{x}Cu_{24}O_{41}$ in the same region of param eter space and doping indicate that the resistivity is linear with tem peratures⁴, one of the hallm arks of the exotic normal state properties found in doped cuprates on a square lattice⁵. These unusual normal state properties do not t in the conventional Ferm i-liquid theory8, and m ay be interpreted within the fram ework of the chargespin separation2, where the electron is separated into a neutral spinon and a charged holon, then the basic excitations of the system are not ferm ionic quasiparticles as

in other conventional metals with charge, spin and heat all carried by one and the same particles.

The heat transport is one of the basic transport properties that provide a wealth of useful information on carriers and phonons as well as their scattering processes 9 {12. In the conventionalm etals, the therm alconductivity contains both contributions from carriers and phonons9. The phonon contribution to the thermal conductivity is always present in the conventional metals, while the magnitude of the carrier contribution depends on the type of material because it is directly proportional to the free carrier density. For the underdoped cuprates on a square lattice, the phonon contribution to the therm al conductivity is strongly suppressed 13;14. Recently, an unusual contribution to the them al conductivity of the doped two-leg ladder material $\mathrm{S}\,r_{\!14}$ $_{x}\mathrm{C}\,a_{x}\mathrm{C}\,u_{24}\mathrm{O}_{41}$ has been observed 10 {12. It has been argued that this unusual contribution m ay be due to an energy transport via m agnetic excitations^{10;15}, and therefore can not be explained within the conventional models of phonon heat transport based on phonon-defect scattering or conventional phonon-electron scattering. In particular, in the doped regin e where superconductivity appears under pressure in low temperatures, this unusual contribution dom inates the thermal conductivity of Sr_{14 $\,$ x}Ca_xCu₂₄O ₄₁. This is a challenge issue since it is closely related to the doped Mott insulating state that forms the basis for superconductivity¹. W e¹⁶ have developed a chargespin separation ferm ion-spin theory to study the physical properties of doped Mott insulators, where the electron operator is decoupled as the gauge invariant dressed holon and spinon. Within this theory, we^{17;18} have discussed charge transport and spin response of $\text{Sr}_{14}\ _{x}\text{Ca}_{x}\text{Cu}_{24}\text{O}_{41}\text{.}$ It has been shown that the charge transport is mainly governed by the scattering from the dressed holons due to the dressed spinon uctuation,

while the scattering from the dressed spinons due to the dressed holon uctuation dom inates the spin response 16 . In this paper, we apply this successful approach to discuss the heat transport of Sr_{14} $_{x}\mathrm{C}$ $\mathrm{a_{x}C}$ $\mathrm{u_{24}O}$ $_{41}$. W ithin the t-J m odel, we show that although both dressed holons and spinons are responsible for the heat transport, the contribution from the dressed spinons dom inates the therm al conductivity of Sr_{14} $_{x}\mathrm{C}$ $\mathrm{a_{x}C}$ $\mathrm{u_{24}O}$ $_{41}$ in the doped regime where superconductivity appears under pressure in low tem peratures.

The two-leg ladder is de ned as two parallel chains of ions, with bonds among them so that the interchain coupling is comparable in strength to the couplings along the chains, while the coupling between the two chains that participates in this structure is through rungs¹. It has been argued that the essential physics of the doped two-leg ladder antiferrom agnet is contained in the two-leg ladder, and can be excitively described by the t-J model¹,

supplemented by a single occupancy local constraint 1, where $^{\circ} = 6x$, c_0 is the lattice constant of the two-leg ladder lattice, which is set as unity hereafter, iruns over all rungs, (= "; #) and a (= 1; 2) are spin and leg indices, respectively, C_{ia}^{y} (C_{ia}) is the electron creation (annihilation) operator, $S_{ia} = C_{ia}^{y} \sim C_{ia} = 2$ is the spin operator with $\sim = (x; y; z)$ as the Paulim atrices, and is the chemical potential. In the materials of interest $^{3;6}$, the exchange coupling J_k along the legs is close to the exchange coupling J? across a rung, and the sam e is true of the hopping t_k along the legs and the rung hopping strength to . Therefore in the following discussions, we will work with the isotropic system $J_2 = J_k =$ J, $t_2 = t_k = t$. The strong electron correlation in the t-J m odel m anifests itself by the single occupancy local constraint, and thus the crucial requirem ent is to im pose this local constraint. It has been emphasized that this dressed holon h_{ia} is a spinless ferm ion h_{ia} incorporated a spinon cloud $e^{\ i\ i}$ (magnetic ux), and then is a magnetic dressing. In other words, the gauge invariant dressed holon carries som e spinon messages, i.e., it shares its nontrivial spinon environment¹⁹. A Ithough in common sense h_{ia} is not a real spinful ferm ion, it behaves like a spinful ferm ion. In this charge-spin separation ferm ion-spin representation, the low-energy behavior of the t-J ladder (1) can be expressed as 16 ,

In this case, the kinetic part has been expressed as the dressed holon-spinon interaction, and therefore reject a competition between the kinetic energy and magnetic energy. This competition dominates the essential physics since the dressed holon and spinon self-energies are ascribed purely to the dressed holon-spinon interaction.

Now we follow the linear response theory 20 , and obtain the therm alconductivity along the ladder,

A lthough the total heat current density $j_{\mathbb{Q}}$ has been separated into two parts $j_Q^{(h)}$ and $j_Q^{(s)}$, with $j_Q^{(h)}$ is the dressed holon heat current density, and $j_0^{(s)}$ is the dressed spinon heat current density, the strong correlation between dressed holons and spinons is still included selfconsistently through the dressed spinon's order param eters entering in the dressed holon's propagator, and the dressed holon's order param eters entering in the dressed spinon's propagator. In this case, the heat currentcurrent correlation function of the two-leg ladder system can be obtained in terms of the full dressed holon and spinon Green's functions g (k;!) and D (k;!). Because there are two coupled t-J chains in the two-leg ladder system, the energy spectrum has two branches. In order to satisfy the sum rule for the correlation function $hS_{ai}^{+}S_{ai}i=1=2$ in the absence of the antiferrom agnetic long-range-order, a decoupling parameter has been introduced in the meaneld calculation, which can be regarded as the vertex correction 21 . All the above meaneld order parameters, decoupling parameter , and chemical potential , have been determined by the self-consistent calculation.

In the two-leg ladder material $Sr_{14} \times Ca_xCu_{24}O_{41}$, the most remarkable expression of the nonconventional physics is found in the doped regime where the hole doping concentration on ladders at x=8 12 is corresponding to =0.16 0.20 per Cu ladder 13 . In this doped regime, superconductivity appears under pressure in low temperatures, and the value of J_k has been estimated 6




FIG.1. The therm alconductivity of the doped two-leg ladder m aterial as a function of frequency at doping = 0.16 (solid line) and = 0.20 (dashed line) for parameter t=J = 2.5 with temperature T = 0.05J.




FIG. 2. The thermal conductivity of the doped two-leg ladder material as a function of temperature at doping = 0:16 (solid line) and = 0:20 (dashed line) for parameter t=J = 2:5. Inset: the experimental result on $Sr_{14} \times Ca_x Cu_{24}O_{41}$ with x=12 taken from $Ref.^{10}$.

as $J = J_k$ 90 m eV 1000K. Therefore in the following discussions, we focus on this doped regime. In Fig. 1, we present the results of the therm alconductivity $_{c}$ (!) in Eq. (6a) as a function of frequency at = 0:16 (solid line) and = 0.20 (dashed line) for t=J = 2.5 with T = 0.05J. Although $_{c}(!)$ is not observable from experim ents, its features will have observable implications on the observable $_{c}(T)$. Our results in Fig. 1 show that the frequency dependence of the therm al conductivity spectrum is characterized by a rather sharp low-energy peak. The position of this low-energy peak is doping dependent, and is located at a nite energy! 0:1t = 0:25Jm eV. This low-energy peak is corresponding to the peak observed in the conductivity spectrum 22;17. Moreover, we also nd from the above calculations that although both dressed holons and spinons are responsible for the therm al conductivity $_{c}$ (!), the contribution from the dressed spinons is much larger than that from the dressed holons, i.e., $_{\text{c}}^{\text{(s)}}$ (!) $_{\text{c}}^{\text{(h)}}$ (!), and therefore the therm al conductivity of the doped two-leg ladder antiferrom agnet in the hole doped regim e = 0.160:20 is mainly determ ined by its dressed spinon part (s) (!).

Now we turn to discuss the temperature dependence of the therm al conductivity c (T), which is observable from experim ents and can be obtained from Eq. (6a) as $_{c}(T) = \lim_{! = 0} _{c}(!;T)$. The results of $_{c}(T)$ at =0:16 (solid line) and = 0:20 (dashed line) for t=J=2:5are plotted in Fig. 2 in comparison with the corresponding experim ental results 10 taken on Sr_{14} x $Ca_xCu_{24}O_{41}$ (inset), where the hole doping concentration on ladders at x = 12 is = 0.20 per Cu ladder. The present results indicate that the tem perature dependence of the therm al conductivity in the normal-state exhibits a broad band, i.e., c(T) increases monotonously with increasing temperature at low temperatures T < 0:05J 50K, and is weakly tem perature dependent in the tem perature range 50K < T < 0.1J100K, then decreases for temperatures T > 0:1J 100K, in qualitative agreement with the experim ental data 10. For T 0**:**01J system is a superconductor under pressure. In this case, the therm alconductivity of the doped two-leg ladder antiferrom agnet is under investigation now.

In the above discussions, the central concern of the heat transport in the doped two-leg ladder material Sr_{14} $_{x}Ca_{x}Cu_{24}O_{41}$ is the charge-spin separation, then the contribution from the dressed spinons dominates the them all conductivity. Since $_{c}^{(s)}(!;T)$ in Eq. (6c) is obtained in terms of the dressed spinon longitudinal and transverse G reen's functions $D_{L}(k;!)$ and $D_{T}(k;!)$, while these dressed spinon G reen's functions are evaluated by considering the second-order correction due to the dressed holon pair bubble, then the observed unusual frequency and temperature dependence of the therm all conductivity spectrum of the doped two-leg ladder antiferrom agnet is closely related to the commensurate spin response $^{4;18}$. The dynamical spin structure factor of the doped two-leg ladder antiferrom agnet has been obtained

within the charge-spin separation ferm ion-spin theory¹⁸ in term softhe full dressed spinon longitudinal and transverse G reen's functions as,

where $\operatorname{Im} \ ^{(s)}_{LT}(k;!) = \operatorname{Im} \ ^{(s)}_{L}(k;!) + \operatorname{Im} \ ^{(s)}_{T}(k;!),$ $\operatorname{Re} \ ^{(s)}_{LT}(k;!) = \operatorname{Re} \ ^{(s)}_{L}(k;!) + \operatorname{Re} \ ^{(s)}_{T}(k;!),$ while Im (k;!) (Im (s) (k;!)) and Re $_{\rm L}^{\rm (s)}$ (k;!) (Re $_{\rm T}^{\rm (s)}$ (k;!)) are the imaginary and real parts of the second order longitudinal (transverse) spinon self-energy in Eqs. (8c) and (8d). The renorm alized spin excitation $E_k^2 = (!_k^{(1)})^2 + B_k^{(1)} Re_{LT}^{(s)} (k; E_k)$ in S (k;!) is doping, energy, and interchain coupling dependent. In the two-leg ladder system, the quantum interference e ect between the chains manifests itself by the interchain coupling, i.e., the quantum interference increases with increasing the strength of the interchain coupling. In the materials of interest, J? t, we have shown in detail in Ref. 18, the dynam ical spin structure factor in Eq. (12) has a well-de ned resonance character, where S (k;!) exhibits the commensurate peak when the incoming neutron energy! is equal to the renormalized spin excitation E_k , i.e., W (k_c ;!) $(!_{k_c}^{(1)})^2$ $B_{k_c}^{(1)} Re_{LT}^{(s)} (k_c;!)^2 = (!^2 E_{k_c}^2)^2$ antiferrom agnetic wave vectors $k_{\text{A}\,\text{F}}$, then the height of this commensurate peak is determined by the imaginary part of the spinon self-energy 1=Im $_{\rm L\,T}^{(s)}$ (kc;!). Since the incom ing neutron resonance energy $!_r = E_k$ is nite¹⁸, then there is a spin gap in the system. This spin gap leads to that the low-energy peak in $_{c}$ (!) is located at a nite energy ! peak 23m eV. This anticipated spin gap 23 m eV is not too far from the spin gap observed⁶ in Sr₁₄ _xCa_xCu₂₄O₄₁. Therefore the commensurate spin uctuation of the doped two-leg ladder m aterial Sr_{14} $_{x}Ca_{x}Cu_{24}O_{41}$ is responsible for the heat transport, in other words, the energy transport via magnetic excitations dom inates the therm al conductivity 10. Based on the simple theoretical estimate¹¹, the large therm al conductivity observed in the two-leg ladder ma $terial Sr_{14}Cu_{24}O_{41}$ has been interpreted in terms of the m agnetic excitations in the system 11.0 ur present expla-

To conclude we have discussed the heat transport of the two-leg ladder material $\mathrm{Sr_{14}}$ $_{x}\mathrm{Ca_{x}}\mathrm{Cu_{24}}\mathrm{O}_{41}$ within the t-J ladder in the doped regime where superconductivity appears under pressure in low temperatures. It is shown that the energy dependence of the thermal conductivity spectrum $_{c}(!)$ shows a low-energy peak, and the position of this low-energy peak is doping dependent, and is located at a nite energy. The temperature dependence

nation is also consistent with theirs 11.

dence of the therm al conductivity $_{\rm c}$ (T) is characterized by a broad band. $_{\rm c}$ (T) increases monotonously with increasing temperature at low temperatures T < 0:05J, and is weakly temperature dependent in the temperature range 0:05J < T < 0:1J, then decreases for temperatures T > 0:1J. Our result of the temperature dependence of the thermal conductivity is in qualitative agreement with the major experimental observations of Sr_{14 x}Ca_xCu₂₄O₄₁ in the normal-state¹⁰. Our result also shows that although both dressed holons and spinons are responsible for the thermal conductivity, the contribution from the dressed spinons dominates the heat transport.
