# D ependence of the superconducting critical tem perature on the num ber of layers in hom ologous series of high-T\_c cuprates

We study a model of n-layer high-temperature cuprates of homologous series like  $H gB a_2 C a_n \ _1 C u_n O_{2+2n+}$  to explain the dependence of the critical tem perature  $T_c$  (n) on the num ber n of Cu-O planes in the elementary cell. Focusing on the description of the high-tem perature superconducting system in terms of the collective phase variables, we have considered a sem i-m icroscopic anisotropic three-dimensional vector XY model of stacked copper-oxide layers with adjustable param eters representing m icroscopic in-plane and out-of-plane phase sti nesses. The m odel captures the layered composition along c-axis of hom ologous series and goes beyond the phenom enological Law rence-D oniach m odel for layered superconductors. Im plan enting the spherical closure relation for vector variables we have solved the phase XY model exactly with the help of transfer matrix m ethod and calculated  $T_c$  (n) for arbitrary block size n, elucidating the role of the c-axis anisotropy and its in uence on the critical tem perature. Furtherm ore, we accomm odate inhom ogeneous charge distribution among planes characterized by the charge im balance coe cient R being the function of num ber of layers n. By making a physically justi ed assumption regarding the doping dependence of the m icroscopic phase sti nesses, we have calculated the values of parameter R as a function of block size n in good agreem ent with the nuclear magnetic resonance data of carrier distribution in multilayered high-Tc cuprates.

### I. IN TRODUCTION

Characteristic common structure of high-tem perature superconducting cuprates has been puzzling researchers since the discovery of the phenom enon by Bednorz and Muller.<sup>1</sup> It is now accepted that all relevant carriers of both spin and electricity derive from the hybridized antibonding orbitals in the Cu-O planes.<sup>2</sup> Obviously, the interlayer structure cannot be ignored.<sup>3</sup> In the norm al state, due to huge anisotropy, coherent transport in the direction perpendicular to Cu-O planes is blocked. However, it is observed that T<sub>c</sub> is strongly dependent on the interlayer structure, which means that threedim ensional (3D) coupling of planes must play an im portant role in the onset of superconductivity.4 It suggested to apply the Law rence and Doniach model (LD) to cuprates, which originally was proposed for layered superconductors and is based on the G inzburg-Landau description with neighboring layers coupled by the Josephson tunneling.<sup>5</sup> This approach was pursued to study Josephson plasm a resonance,  $^{6}$  an isotropy of critical elds  $H_{c1}$  and  $H_{c2}$ ,<sup>7,8</sup> vortex m atter behavior.<sup>9</sup> However, the biggest disadvantage of the LD model is that it is based on mean-eld approximation, which neglects the role of phase uctuations, the latter playing a profound role in cuprates.10

There is a signi cant evidence that in cuprates the Cu-O planes are Josephson coupled and the anisotropy of c-axis to ab-planes penetration depth can vary from 5 to even 250 in various high- $T_c$  compounds. This gave rise to interplane theories e.g. interlayer tunneling m odel (ILT) by Anderson,<sup>11</sup> which assumed that carriers were incoherent between layers in the normal phase, how - ever coherent transport of Cooper pairs in a form of

Josephson tunneling in superconducting state was allowed. Unfortunately, the original version of the ILT theory by Anderson is no longer considered as a viable m odelofhigh-T<sub>c</sub> m aterials, since it provides no m ore than 1% of the condensation energy in certain cuprates.<sup>12,13</sup> However, the Josephson coupling between Cu-O planes is still believed to play an important role in cuprate oxides.<sup>14</sup> In the process of synthesis of high-T<sub>c</sub> m aterials it is possible to control (to some extent) the distances between copper-oxide planes or the content of the regions that separate them . It allows to study, how such changes in uence observed properties of these com pounds like critical tem perature or electrical resistivity and elucidate the role of the inter-layer coupling.<sup>15,16</sup> In m ono- or bi-layered high-T<sub>c</sub> m aterials (like LSCO or YBCO compounds), all copper-oxide planes are equivalent, which means that charge carriers are distributed hom ogeneously am ong copper-oxide planes. However, multi-layered high-T<sub>c</sub> m aterials are characterized by the existence of crystalographically inequivalent outer (OP) and inner (IP) Cu-O planes, which give rise to inhom ogeneous carrier distribution among them . This, in turn, may have a profound in uence on the critical temperature, which is know to be strongly doping dependent. For exam ple, high-tem perature superconducting hom ologous series, like H gB  $a_2$  C  $a_n$   $_1$  C  $u_n$  O  $_{2+2n+}$  , are m aterials sharing the sam e charge reservoir, but di ering by the num bern of Cu-O planes in the unit cell.<sup>17,18</sup> They also have the same characteristic dependence of the critical tem perature as a function of n with a maximum for n = 3or n = 4. A though, these groups of cuprates have been extensively studied, the origin of this extrem um is still not fully understood.<sup>19,20,21</sup>

Recently, Chakravarty et al. have argued that the ex-

istence of the competing order parameter that is nucleated by charge in balance is ultim ately responsible for the critical tem perature downturn with n.<sup>22</sup> They present a mean-eld theory for a single block of n superconducting layers, how ever neglecting the inter-block coupling. M oreover, they use phenom enological G inzburg-Landau theory at zero-tem perature to anticipate the values of the critical tem perature  $T_c$  (n), based on the magnitude of the T = 0 superconducting order parameter. Charge im balance is introduced as a competing order parameter, e.g. d-density wave.<sup>23</sup> It depresses the critical temperature for n > 2, thus experim entally observed shape of  $T_c$  (n) is obtained. However, as the authors note, the phase uctuations, which are not taken into account, might depress  $T_c$  for n = 1 even m ore than for n = 3. A lthough, it should correct the results for 1 < n < 3, it is not obvious, whether the maximum of  $T_c$  (n) can be observed at all.

It is well known that binding of electrons into pairs is essential in form ing the superconducting state, how ever, its rem arkable properties { zero resistance and M eissner e ect { require the phase coherence among the pairs as well. In conventionalBCS superconductors the phase order is unimportant for determining of the value of the transition temperature Tc. However, in superconductors with low carrier density such as high-T<sub>c</sub> oxide superconductors, phase uctuations may have a profound in uence on low tem perature properties.<sup>10</sup> In particular, for cuprate superconductors, the conventional ordering of binding and phase sti ness energies appears to be reversed. Thus, the issue how pairing and phase correlations develop is a central problem of high-T<sub>c</sub> superconductivity. The m easurem ents of the frequency dependent conductivity, in the frequency range 100-600G H z, show s that phase correlations indeed persist above T<sub>c</sub>, where the phase dynam ics is governed by the bare m icroscopic phase sti nesses.24

In the present paper we propose a sem i-m icroscopic model of n-layer cuprates, which is founded on microscopic phase sti nesses that set the characteristic energy scales: in-plane  $J_k$ , inter-plane (in-block)  $J_2$  and inter-block  $J_2^{^{\scriptscriptstyle 0}}$  couplings. W e em ploy an approach that goes beyond the mean eld level and is able to capture both the e ects of phase uctuations and huge caxis anisotropy on the superconducting phase transition. We show that the depression of the critical tem perature for n > 3 can be obtained naturally without invoking any competing (hidden) order. Since superconducting carriers are located in Cu-O planes, the in-plane phase stiness must naturally be doping dependent. As this dependence can be simply deduced from the established phase diagram for cuprates, introduction of charge  $T_{c}$ im balance via the doping dependence of m icroscopic inplane phase sti ness allow s us for explanation of  $T_{\rm c}$  (n) as a function of block layers n in perfect agreem ent with experimental ndings.<sup>17</sup>

The outline of the rem inder of the paper is as follows. In Section II we analyze a single-layer system . We con-

struct an anisotropic three-dim ensionalXY model, which will be solved in the spherical approximation to explicate the dependence of critical tem perature on the anisotropy =  $J_2 = J_k$  along c-axis. Subsequently, in Section III we elaborate on a model of stacked n-block layers relevant for high-tem perature superconducting hom ologous series. W e m ap the system onto a spherical XY m odel, which is solved exactly for arbitrary n with the help of the transfer matrix method. In Section IV we determ ine the critical tem perature  $T_c$  (n) as a function of number of layers n. In Section V we incorporate the inhom ogeneous charge distribution in hom ologous series by introducing doping dependent in-plane phase sti nesses  $J_k$  ( ) for the separate n layers in the block structure. W e found that the maximum of the phase coherent superconducting transition will be a bell-shaped curve as a function of n with a maximum for n = 3 for appropriate values of outer  $(_{\rm op})$  and inner  $(_{\rm ip})$  planes dopings within a block. Finally, in Section VI we sum marize the conclusions to be drawn from our work. Som e supplem entary material is relegated to the Appendix.

### II. SINGLE LAYER CUPRATES

In underdoped high-tem perature superconductors, two tem perature scales of short-length pairing correlations and long-range superconducting order seem to be well separated<sup>10</sup>. We consider the situation, in which local superconducting pair correlations are established and the relevant degrees of freedom are represented by phase fac-',  $(r_{\rm i})$  < 2 , where  $r_{\rm i}$  numbers lattice sites tors 0 within '-th ab plane. The system becomes superconducting once U (1) symmetry group governing the '  $\cdot$  (r<sub>i</sub>) factors is spontaneously broken and the non-zero value of  $e^{i' \cdot (r_i)}$  appears signaling the long-range phase order. The dependence of critical tem perature on the spatial caxis anisotropy is of param ount im portance for cuprate systems, in which two-dimensional physics predominate. First, we consider a single-layer system described by the following Hamiltonian:

where  $J_k > 0$  and  $J_2 > 0$  are in-plane and inter-plane m icroscopic phase sti nesses, respectively. The factors  $\prime$  ,  $(r_i)$  are placed in sites of a three-dimensional cubic lattice, where i = 1;:::;N\_k with N\_k being the number of sites in a plane,  $\prime$  = 1;:::;N\_?, where N\_? denotes the number of layers and N = N\_kN\_? is the total number of sites. The partition function of the system reads:

 $S \cdot (r_i)$  variables runs only over the values, which satisfy the unit length condition  $S^2$ ,  $(r_i) = 1$ . Unfortunately, the partition function in Eq. (5) cannot be evaluated exactly. However, replacing of the rigid length constraint in Eq. (5) by a weaker spherical closure relation<sup>25,26</sup>

renders the model in Eq. (4) exactly solvable. The relation in Eq. (6) means that the unit length of the  $S \cdot (r_i)$  vectors is maintained on average. The spherical constraint can be conveniently implemented with the help of D irac-function and the partition function in Eq. (5) becomes:

Furthermore, the -function can be conveniently represented in a spectral form by the appropriate integral  $(x) = {1 \atop 1} d = 2$  iexp ( x), which introduces the Lagrange multiplier . Consequently, Eq. (7) can be written as:

To evaluate the free energy of the system  $f = f(_0)$  we diagonalize the H am iltonian from Eq. (4) by introducing Fourier transform of  $S \cdot (r_i)$  variables:

where  $k = (k_x; k_y)$  with  $\frac{-}{a} < k_x; k_y < \frac{-}{a}$  are wave vectors within ab-planes, while  $\frac{-}{c} < q_z < \frac{-}{c}$  is wave vector along c-axis. For one (1D) and two-dimensional (2D) systems with short-range interactions the ordered phase exists only in the zero temperature limit, hence for dimensions d 2 the spherical model does not exhibit phase transition with  $T_c > 0$ , in agreement with Mermin-Wagner theorem  $.^{25}$  For d = 3 the critical temperature is nite




Figure 2: Superconducting critical tem perature  $T_{\rm c}$  as a function of anisotropy for crossovers from isotropic 3D to 1D or 2D anisotropic systems in logarithm ic scale for  $% T_{\rm c}$ .



The results are presented in Fig. 2 and in Table I. W hen the in-plane interactions are reduced, the critical tem perature drops quite rapidly as a function of compared to the isotropic system and for  $= 10^{5}$  is less than 1% of the isotropic value. However, in the case of the reduced coupling along c-axis (weakly coupled planes), even for an isotropy parameter as small as = 10<sup>6</sup> the critical tem perature is still about 30% of the isotropic three-dimensional value. This result is very in portant as it proves that even very sm all inter-planar coupling (som etim es too sm all to be directly observed experim entally) renders the phase transition in the 3D universality class,<sup>14</sup> with the critical tem perature decreas-1=log . This result raises serious ing slow ly like T<sub>c</sub> doubts whether the outcom e of intercalation experim ents in cuprates,<sup>15</sup> which show small changes of the critical tem perature with increase of the inter-layer distance can be interpreted as an argument in favor for a purely 2D nature of high-T<sub>c</sub> superconductivity.

### III. M ULTILAYERED SYSTEM

To describe superconducting cuprates of hom obgous families, we modify the model presented in Sec. II to include the presence of the n-layer block structure. To this end, we group every n consecutive layers in blocks. The intra-layer (in the ab planes) interactions are given by  $J_k > 0$ , while the plane coupling along c direction



Furtherm ore, we make use of the spherical closure relation in Eq. (6). However, the direct in plem entation of the Eq. (6) is obstructed by the lack of complete translational sym metry: grouping of layers within blocks breaks translational sym metry along caxis, since the interplane coupling varies with period of n, when moving from one plane to another. As a result, the three-dimensional Fourier transform of the  $S \cdot (r_i)$  variables in Eq. (11), used to diagonalize single-layer H am iltonian in the previous Section, cannot be perform ed. To overcom e this difculty, we implement a combination of two-dimensional Fourier transform for in-plane vector variables




and transfer matrix method for one-dimensional decorated structure along c-axis.<sup>28</sup> This operation diagonalizes all terms in the H am iltonian in Eq. (29) with respect to k, leaving the dependence on layer index `unchanged. Therefore, the partition function can be written in the form :




Figure 4: (C olor online) C ritical tem perature vs. number of Cu-O layers within block for  $J_2 = J_k = 0.1$  and  $J_2^0 = J_k = 0.01$  (blue lled circles). Empty circles (green) denote the critical tem perature dependence  $T_c$  (n) =  $T_c$  (1)+0.28 (1 1=n), from R ef. 20 (factor of 0.28 was chosen to t the results of the present paper). D iam onds (red) represent results from M onte-C arbo (M C) simulations of the classical X Y m odel (C arlson, et al., R ef. 29). The data of R ef. 29 is scaled by overall factor of 0.277 to accommodate the nite size e ect of M C simulations.

The dependence of the critical temperature on the number of layers n in a block was presented in Fig. 4. Phase sti nesses  $J_k$ ,  $J_2$  and  $J_2^0$  were chosen to satisfy




Figure 5: (Color online) C ritical tem perature  $T_c$  (n) for n = 4 as a function of c-axis phase sti nesses  $J_{?}$  and  $J_{?}^{\circ}$ .

stiness J<sub>k</sub> and inter-layer (intra-block) phase stiness  $J_2$  is greater than inter-block coupling  $J_2$ . We found that the critical temperature increases monotonically with n. This has a simple explanation: for n = 1 (singlelayer system ) with the xed phase stiness  $J_k$  , the criticaltem perature is determ ined by  $J_2^{"}$ , see Fig. 2.0 n the other hand, in the lim it of n! 1, n-layer blocks are of in nite size and inter-block coupling J, is e ectively replaced by  $J_{?}$  . Because  $J_{?}$  >  $J_{?}^{`}$  , according to the result from the previous Section,  $T_c$  (n = 1 ) >  $T_c$  (n = 1). For interm ediate values on n, one can expect a monotonic increase of the T<sub>c</sub> (n) with increasing n, as depicted in Fig. 4. In this respect, our ndings are similar to the results from Ref. 20, where the increase of the critical tem perature of identically doped m em bers of the same hom ologous series due to the interlayer C oulom b interaction was found to be




Figure 6: Critical temperature  $T_{\rm c}$  (n) as a function of c-axis phase sti nesses  $J_{\rm ?}$  and  $J_{\rm ?}^{^0}$  for various values of n as indicated in the inset.

Similar results were obtained by Monte-Carlo simulations,<sup>29</sup> where  $T_c$  (n) was computed numerically by means of the Binder parameter<sup>30</sup> for system s 24 24. Additionally, we present of size up to 24 the in uence of inter-planar coupling constants J? and  $J_2^\circ$  on  $T_c$ , see Figs. 5 and 6. For a bilayer system the role of both interaction constants is identical. For systems with n 3 the in uence of the inter-block coupling  $J_2$  is less visible, however  $J_2 = 0$  suppresses the critical temperature to zero, since for nite n the isolated stack of n coupled layers is e ectively quasi. Therefore, we conclude that the two-dimensional. change of the number n of layers within block cannot alone lead to the appearance of the maximum in the critical tem perature T<sub>c</sub> as a function of n for xed values




Figure 7: In-plane phase stiness  $J_k$ , from Table II, as a function of number of layers n.

of the microscopic phase sti nesses. It is necessary to introduce another factor, which acts com petitively to the e ective increasing of inter-layer coupling (for  $J_2 > J_2$ ) triggered by increase of n. As in hom ologous series of superconducting cuprates in-plane lattice parameters and distances between Cu-O planes are constant am ong dierent members of the family (see, Ref. 18), one can expect that the change of n will mainly a ect  $J_k$ coupling parameter. Without assuming any specic mechanism or introducing a competing (hidden) order, one can calculate values of  $J_k$  for given  $J_2$  and  $J_2$ leading to dependence of critical temperature on n, which is in agreement with experimental ndings. The result is presented in Fig. 7 and in Table II. It is visible that for n = 2; 3 depicted dependence changes from rising to falling. This coincides with the fact that for n = 3 layers lose their equivalence i.e. they split for two groups: outer, lying on block surfaces and inner. Because, in realmaterials, within block of Cu-O planes c-axis redistribution of charge is possible, one can expect that the nonequivalence of the planes within a block may lead to renorm alization of the in-plane phase sti nesses of the respective layers.

# V. CHARGE RED ISTRIBUTION

In this section, using the result of the previous paragraphs, we present a phenom enological theory for the downtum of the  $T_c$  (n) with increasing number of layers in multilayer materials and compare it against the observed system atics, providing support to the presented theory. The idea is simple: it is well known that a superconductor is characterized by a global phase sti ness, which is proportional to the condensate density. In high- $T_c$  cuprates the global phase sti ness is strongly doping dependent and this dependence has a universal character

as evidenced experim entally by the dom e-shaped dependence of the critical tem perature as a function of doping. Phrased in the language of the presented model with phase variables and microscopic phase sti nesses, it means that the parameters of this model have to be changed substantially with doping, since the global phase sti nesses (i.e. the condensate) builds on microscopic phase sti nesses and phase variables. The dependence of the phase sti nesses on doping obviously cannot be found in the presented model, since they are treated as e ective values to be determined, in principle, from the (yet unavailable) microscopic theory. How ever, assuming that all of them share the same doping dependence:

Using the data for the critical temperature  $T_c$  (n) for optim ally-doped m ercuro-cuprates<sup>17</sup> for  $n = 1; 2, w \in can$ determ ine  $J_k$  and the ratio  $J_2^{"} = J_2$ . Unfortunately, the estim ates of the values of couplings along c-axis  $\mathbb{J}_2^\circ$  and  $J_2^{'}$  are di cult to m ake. H ow ever, using the relation between zero-tem perature c-axis and abpenetration depths and bare phase sti nesses:<sup>32</sup>

found in cuprates.<sup>33</sup> In this way all the phase sti nesses can be xed; we found that  $J_k = 19.1 \text{m eV}$  (see, Table II), while  $J_2 = 0.26 \text{m eV}$  and  $J_2^0 = 0.00036 \text{m eV}$ . A lthough, the estimates of c-axis phase sti nesses in general can substantially vary their in uence on the critical temperature is rather weak, as shown in Section II.

In the multi-layer systems (n 3) the planes are not equivalent any more and charge redistribution within blocks is possible.<sup>34,35</sup> Therefore, in-plane phase sti ness of every layer 'becom es  $J_k$  (.). Since our model does not contain independent values of  $J_k$  for di erent planes (which would com plicate theoretical considerations considerably { given the lack of the translational sym m etry along c-axis), we modify Eq. (67) and use the average over n layers in the n-layer block:




Figure 8: (Color online) Schematic representation of charge redistribution leading to overdoping of outer and underdoping of inner layers, respectively.

However, nuclear magnetic resonance (NMR) measurements show that charge distribution among inner planes is almost constant.<sup>34</sup> Therefore, we characterize charge distribution by two parameters: we assume that the doping of inner and outer planes is given by  $_{\rm ip}$  and  $_{\rm op}$ , respectively, see Fig. 8. U sing Eq. (78) we can determ ine the charge in balance parameters R as a function of number of layers n for a given set of experimental data for the critical tem – perature  $T_c$  (n). For this purpose we use the dependence of the superconducting critical tem perature on number of layers reported by K uzem skaya, et al., R ef. 17. The procedure reads as follow s:

(i) For n = 1 and n = 2 by de nition R = 1 and consequently  $J_k^{av}(n;R) = J_k^{av}$ . Using the value of  $T_c(1)$  from experiment, we can determ ine the in-plane  $J_k^{av}$  and  $J_2^{o} = J_2^{o}$  (for n = 1) phase sti nesses using Eq. (56) for the critical temperature  $T_c(n = 1)$  and the supplementary equations (70) and (71).

(ii) For n = 2 we determ ine in-block  $J_{?}^{\circ}$  phase sti ness using Eq. (56) for  $T_{c}$  (n = 2), while keeping  $J_{k}^{\circ}$  and  $J_{?}^{\circ}$  unchanged. In this way all the energy setting parameters  $J_{k}^{\circ}$ ,  $J_{?}^{\circ}$  and  $J_{?}^{\circ}$  are xed.

(iii) For n>2, with the computed parameters  $J_k$ ,  $J_?$  and  $J_?^{^{0}}$ , by making use of Eq. (56) for theoretical  $T_{\rm c}$  (n), we calculate the values of R, using  $T_{\rm c}$  (n) as an input from experiment.




Figure 9: Critical tem perature T<sub>c</sub> vs. num ber of layers n that ts the experim ental data from Ref. 17 and the calculated values of parameter R describing the ratio of doping of outer to inner planes. Dashed line is only guide for the eye.




Figure 10: Doping of inner ip and outer op planes vs. num ber of layers n that corresponds to the data from Fig. 9.

The obtained values of the ratio R are presented in Fig. 9, while resulting dopings of inner and outer planes are shown in Fig. 10. From these results we can infer that for n = 1; 2; 3 the critical tem perature is rising due to the increased inter-layer (intra-block) phase sti ness  $J_2 > J_2$ , while the charge redistribution for n = 3 is rather sm all. For values of n > 3 the critical tem perature is very sensitive to charge redistribution and we have a decrease from  $T_c = 135K$  for n = 3 (R = 1:35) to  $T_c = 125K$ for n = 4 (R = 1.82). The calculated values of R are in good agreement with experimental results based on NMR measurement of  $HqBa_2Ca_4Cu_5O_v$  compound by Kotegawa, Ref. 34. Interestingly, the obtained param eters R for n = 3; 4 are much smaller than those found in Ref. 35 (R = 4.5 and R = 9, respectively) calculated using simplied considerations based on competition between electrostatic and band energy estimates. However, in the realm aterials charge depletion in the inner layers m ay be high enough to destroy the superconductivity in these layers, i.e. doping of one type of planes m ay be well outside superconducting region. This scenario have also been con med experimentally by NMR studies of velayer compound  $HgBa_2Ca_4Cu_5O_y$ .<sup>36</sup> Only outer Cu-O planes are superconducting with  $T_c = 108K$ , while inner planes exhibit a static antiferrom agnetic ordering with

 $T_N = 60K$ . This suggest possible extension of ourm odel to include independent in-plane phase sti nesses of the inner and outer layers.

### VI. SUMMARY AND CONCLUSIONS

We have considered a model of n-layer hightem perature cuprates of hom ologous series like to study the dependence  $H gB a_2 C a_n \ _1 C u_n O_{2+2n+1}$ of the critical temperature  $T_c$  (n) on the number n of Cu-O planes in the elementary cell. We focus on the \phase only" description of the high-tem perature superconducting system motivated by the experimental

evidence that the ordering of the phase degrees of freedom is responsible for the emergence of the superconducting state with long-range order. To this end, we have proposed a three-dimensional sem im icroscopic XY model with two-component vectors that involve phase variables and adjustable parameters representing microscopic phase stinesses. The model fully im plem ents com plicated stacked plane structure along c-axis to capture the layered composition of hom ologous series. This allows us to go well beyond widely used phenom enological Law rence-D oniach m odel for layered superconductors. Im plem enting spherical closure relation we have solved the phase XY model exactly with the help of transferm atrix m ethod and calculated  $T_{\rm c}$  (n) for chosen system parameters and arbitrary block size n. In this way we were able to elucidate the role of the c-axis anisotropy and its in uence on the critical tem perature. Furtherm ore, by making a physically justi ed assum ption regarding the doping dependence of the microscopic phase stinesses we were able to calculate the bell shaped curve of  $T_c$  (n) as a function of block size n with a maximum at n = 3 by electively accommodating inhom ogeneous charge distribution among planes. The success of our approach suggests to us that at least for the superconducting phase transition properties studied, one does not need to invoke any competing \hidden" order param eter that appear in other approaches.<sup>22</sup> In the present work, the vanishing of the superconductivity with underdoping can be understood by the reduction of the in-plane phase sti nesses and can be linked to the manifestation of M ott physics (no double occupancy due to the large C oulom b on-site repulsion) that leads to the loss of long-range phase coherence while moving toward half-led limit ( = 0). For doping = 0, the xed electron number in plies large uctuations in the conjugate phase variable, which naturally translates into the reduction of the microscopic in-plane phase sti nesses
