M ean eld dynamics of super uid-insulator phase transition in a gas of ultra cold atom s

A large scale dynamical simulation of the super uid to M ott insulator transition in the gas of ultra cold atom splaced in an optical lattice is performed using the time dependent G utzw iller mean eld approach. This approximate treatment allows us to take into account most of the details of the recent experiment [N ature 415, 39 (2002)] where by changing the depth of the lattice potential an adiabatic transition from a super uid to a M ott insulator state has been reported. Our simulations reveals signicant excitation of the system with a transition to insulator in restricted regions of the trap only.

I. INTRODUCTION

A theoretical suggestion [1] of a possibility to realize one of the standard models for interacting particles – the Bose-Hubbard (BH) model [2, 3] in a cold gas placed in an optical lattice has been followed soon by a seminal experiment [4]. The reported realization of a quantum phase transition between super uid (SF) and Mott insulator (MI) phases showed convincingly that it was possible to control experimentally parameters of the model practically at will. This triggered several studies involving Bose condensate [5, 6, 7, 8, 9, 10] as well as, more recently Ferm i-Bose mixtures [11, 12, 13] placed on the optical lattices (the reference list must be not complete bearing in mind that more than 70 papers with \optical lattice" in the title are listed in the cond-mat archive last year only).

At the sam etim e a num ber of groups [14, 15, 16, 17, 18] tried to understand the details of the very st experim ent [4] to check the underlying physics. To im agine the di culty in modeling the experiment let us recall that it involves about 10^5 interacting atom s (bosons) placed in the harm onic trap and the three dimensional (3D) lattice potential. Such a system is well described by a Bose-Hubbard model with position dependent chemical potential [1]. Even nding the ground state of the system for that number of particles and 65 65 lattice sites is a form idable task. State of the art quantum Monte Carlo (QMC) [14, 15, 17] calculations aimed at the ground state properties include up to 16 sites in 3D [14], m ore sites m ay be included in one (1D) or two (2D) dim ensional models [15, 17]. These studies, while interesting on their own, can shed little light on the dynam ics of the system when its parameters are varied. Except for special exactly solvable models, the e cient simulation of time-dependent properties of interacting many-body system remains an open problem although recently quite a progress has been obtained for 1D system s [20, 21].

It seems, therefore, that the only reasonable and tractable way of analyzing the dynamics of the discussed experiment is using approximate methods. To this end

we shall use an approach based on the time dependent variational principle with Gutzwiller ansatz. That will allows us to model the details of the 3D experiment [4]. The prize for it is similar to that paid in other approximate treatments—one may always question the extend to which the approximations allow to describe the properties of the systems studied. We hope to convince the reader that the numerical results are at least mutually consistent and thus may provide considerable insight into the dynamics of the experiment.

The discussion of the dynam ics is postponed to Section III since we discuss in the next Section the static mean eld solutions for the ground state for experimental parameters. Here a comparison with available exact QMC results is possible at least. This shall give us some condence about the applicability of the mean eld approach yielding, at the sametime, the initial state for the dynamics studied later.

II. STATIC MEAN FIELD FOR THE BOSE-HUBBARD MODEL

The Bose-Hubbard Hamiltonian describing the system takes the form [1]

where $n_i = a_i^y a_i$ is an occupation number operator at site i (with a_i being the corresponding annihilation bosonic operator), U the interaction energy, J the tunneling coefcient and W_i the energy of set at site i. $\langle i,j \rangle$ denotes a sum over nearest neighbors. Both J and U are functions of the lattice potential and m ay be easily expressed in terms of integrals of the W annier functions of the lowest energy band for cold atoms implementation of the

Consider rst the standard hom ogeneous situation in which all W $_{\rm i}$'s are equal. The last term in (1) becomes proportional to the (conserved) number of bosons and

model [1].

m ay be dropped. The only rem aining param eter of the m odel is the ratio of U=J. When tunneling dominates the system in its ground state is super uid while in the opposite case it becomes the Mott insulator. The borderline between the two phases depends on the chemical potential . The M ott insulator state is incompressible and is characterized by an integer mean occupation of sites. In e ect starting from the super uid at small U=J and a non integer ratio of N = M (N denotes the number of atom s while M the number of sites) and increasing U=J the ground state remains super uid up to highest values of U=J at xed boson density. On the other hand the range of values corresponding to the commensurate lling increases with U=J. In e ect, the separation line between a M I and a SF forms characteristic lobes [2, 3, 16],

For a detailed discussion of the BH model see [2, 16]. As we are interested in the mean—eld approximation, let us just quote Zwerger [16] saying "In two and three-dimensional lattices, the critical value for the transition from a M I to a SF is reasonably well-described by a mean—eld approximation". In one dimension the mean—eld approximation is much worse [16].

In the presence of the additional potential, e.g. the harm onic trap, local energies W $_{\rm i}$ depend on the sites location. Then the electric chemical potential at each site becomes $_{\rm i}=$ W $_{\rm i}.$ As pointed out already in [1] this will lead for large U=J to a shell like structure with M I phases with dierent integer occupations (highest in the middle assuming attractive binding additional potential) separated by SF regions. This picture has been nicely commed in quantum M onte Carlo calculations both in 1D [15] and in 3D [14].

The latter exact results are of particular interest for us since they allow for a comparison with the mean eld approximation. In [14] a 3D 16 16 16 lattice is considered with dierent values of U and J parameters as well as the harm onic trap. To not the mean eld ground state we minimize

The number of parameters $f_n^{(i)}$ depends on the number of sites (here 16^3) as well as the maximal occupation at a given site n_m . The average maximal occupation at the center of the trap is 2 fot the data considered in [14]. Therefore, it is suicient to take $n_m=7$. That yields a minimization procedure over 32768 parameters. Such a number of parameters must lead to a spurious local minima, unless a very good estimate exists for the initial set of $f_n^{(i)}$'s (i.e. the initial $f_n^{(i)}$). Fortunately such a guess is quite obvious and is often termed a local mean




Figure 1: M can eld particle density distribution (on-site lling factors) as a function of the distance from the center of the trap m casured in the units of the lattice constant a. Filled circles correspond to numerical results, lines are drawn to guide the eye. The parameters of the BH model match those quoted in Fig. 1 of [14], see the text for numerical values. Comparison with the latter results obtained within \exact" quantum Monte Carlo reveals the accuracy of the mean eld approximation.

eld approximation. Namely at each site i one takes a solution for $f_n^{(i)}$'s corresponding to the hom ogeneous BH m odel with the e ective chemical potential $_i=\$ W $_i.$ Provided W $_i$ changes smoothly from site to site, such an approach should be an excellent approximation to a full mean eld solution. And indeed it is, we have found for the data discussed below that the initial and nal $<\$ E > [see Eq. (2)] dier by at most 2%; the number of iterations of standard Numerical Recipes minimization packages [22] is slightly bigger than the number of parameters.

The results obtained are presented in Fig. 1 in the same form as the corresponding plot in [14] to make the comparison easier. The values of parameters correspond to those taken in [14]. The notation used by us diers slightly from that of [14], in particular the tunneling constant J is denoted as t in [14]. For the purpose of this gure all parameters are expressed in units of J, i.e. J=1. To make the comparison with notation used in [14] easier, the coecient in the term proportional to the number of atoms at a given site in (2) i.e. the dierence of the on-site energy W i and the chemical potential is expressed as W i = U_0 + U=2 + x_i^2 , where x_i is a

position vector of site i w ith x_i^2 being the square of the distance of the i-th site from the center of the harm onic trap m easured in units of the lattice constant. W ith such a de nition the parameters used in Fig. 1 take the values: panel (a): U=24; $U_0=11.08$, =0.19531; (b): U=32; $U_0=28.08$, =0.19531; (c): U=80; $U_0=65.0$, =0.97656; (a): U=80; $U_0=90.0$, =1.03062; (a): U=80; $U_0=120.08$, =2.00375; and (a): U=80; $U_0=150.0$, =1.75781. A comparison of Fig. 1 w ith Fig. 1 of [14] indicates that, as far as the average occupation at dievent agreement w ith the quantum M onte C arboresults.

Instead of the occupation at dierent sites one may take a look at the momentum distribution, i.e. the quantity closely related to that measured in the experiment (see [4] and the discussion below). The momentum distribution is given by [14]




Figure 2: The rescaled mean eld momentum distribution (in arbitrary units) in the rst Brillouin zone in the (0,0,1) direction derived from (4) for data presented in Fig. 1. The distributions are to be compared with the corresponding \exact" distributions in Fig. 2 of [14]. Observe that mean eld result diers from the exact distribution for the case (d) only { see discussion in the text.

where k is the wavevector, (k) a Fourier transform of the W annier site-function. The latter yields a broad bell-shaped background and provides merely information about the lattice. The relevant information about the atom s is contained in the Fourier transform of $< a_i^y a_i > .$ In the mean eld approximation this factorizes for dierent i_i $j < a_i^y a_j > < a_i^y > < a_j >$. Such a factorization seems quite drastic and one may expect signicant differences between the momentum distributions obtained from OMC and within the mean eld approximation. It is really not so, however, for bosons in a harm onic trap as visualized in Fig. 2 for the mean eld. That ure should be compared with QMC results presented in Fig. 2 of [14]. Observe that di erences appear only for panel (d), the exact results yield signi cantly broader momentum distribution. As discussed in [14] almost no SF fraction is present in the QMC result corresponding to panel (d). Then the factorization must a ect strongly the momentum distribution since in a vast majority of sites $< a_i > = 0$. Clearly, however, as long as some SF fraction is present in the system the mean eld momentum distribution closely resembles the exact quantum results.

This apparent quite close agreem ent between QMC results and the mean eld approximation for 16 16 16 lattice and about 10^3 atoms is very encouraging in view of realistic experimental conditions [4]. Here both the external potential changes less rapidly (the size of the lattice is now 65 65 65) and number of atoms exceeds 10^5 thus one may expect that the mean eld approximation works even better.

W hile the test described above have been taken for some chosen (by authors of [14]) values of U, J, as well as the trap frequency, to simulate the experiment we have to determ ine rst the relevant range of parameters. From now on we shall measure the quantities of dimension of energy in the units of the recoil energy of 87 Rb atoms for light with a wavelength = 2 = K = 852nm, i.e.

 $E_{\rm r}={\sim}^2 K^2 = 2 M$, where M $\,$ is the mass of ^{87}Rb atoms. The depth of the optical lattice V changes from 0 to $22 E_{\rm r}$. Finding W annier functions for dierent values of V [23] we evaluate the corresponding U (V) and J (V) values. The energy o set at each site $W_{\rm i}$ has two components in the experiment [4]. One is the harmonic magnetic trap potential (time-independent), another is due to the Gaussian intensity pro less of lattice creating laser beams. The latter may be also approximated by a harmonic term [4] the corresponding frequency is then dependent on V .

To nd the mean eld ground state for dierent V values and the num ber of atom softhe order of 105 one needs to solve a m in im ization problem over 2 106 parameters (with $n_m = 7$ as before) which is hardly manageable. One may, however, use the sym metry of the problem (cubic lattice combined with spherically symmetric trap) to signi cantly reduce that number. Let i; j; k count the sites in x;y;z directions, respectively with each index taking the values from $32 \text{ to } n_s = 32 \text{ (yielding 65 sites)}$ in each direction). Due to the ground state sym metry it is enough to consider only the sites with 0 i j k n_s which reduces the number of minimized parameters to about 48 thousands. Needless to say we have checked on the smaller 16 16 problem that the symmetry reduced problem yields the sam e ground state as the full m in im ization.




Figure 3: Solid lines represent mean—eld atom density distribution (on-site—lling factor - n) as a function of the distance from the center of the trap (measured in units of the lattice constant). Described lines represent the corresponding variances at dierent sites 2 $\frac{2}{i} = 2 \, (< \, n_i^2 > \, < \, n_i >^2)$. The total number of atoms and the SF factor $_{\rm SF}$ (see text) for each plot are (a): $V = 9E_{\rm T}, N = 99771, _{\rm SF} = 0.95$; (b): $V = 13E_{\rm T}, N = 99502, _{\rm SF} = 0.40$; (c): $V = 16E_{\rm T}, N = 95408, _{\rm SF} = 0.11$; (d): $V = 22E_{\rm T}, N = 94172, _{\rm SF} = 0.01$. Small indents seen in the lines in panels (c) and (d) are due to anisotropy induced by a cubic lattice in an isotropic (harmonic) trap, for further details see text.

The results obtained are presented in Fig. 3 and are practically indistinguishable from the initial guess i.e. a wavefunction coming from local mean eld approximation discussed above. The chemical potential has been adjusted (for each case) to have the average number of atom s N = < \hat{N} > = $\frac{1}{i}$ < n_i > around 10 5 . This leads to more than two atoms (on average) per site in the center of the trap. To characterize whether the state is closer to being super uid or Mott insulator we de ne the superuid factor $SF = 1 = N^{-} < a_i > < a_i^y > .$ This factor is zero for pure M I state (when $< a_i > = 0$ as each node is in a Fock state) and reaches unity for Poissonian statistics at each node. W hile obviously it is not a \proper" order param eter for the phase transition, it seems to be convenient for characterizing the states obtained. Using this factor we can quantify states shown in Fig. 1, noting rst a general qualitative agreem ent with experim ental ndings [4]. The case $V = 9E_r$ seems almost fully super uid (with, however, strongly subpoissonian statistics [24] at each site), the case $V = 13E_r$ shows straces of insulator phase (integer occupation of sites with vanishing variance, the transition is completed for signi cant fraction of sites at $V = 16E_r$ while for the deepest lattice $V = 22E_r$ SF fraction is restricted to very narrow regions separating di erent integer occupations. A careful reader m ay notice sm all indents visible in lines in panels (c) and (d) of Fig. 3. They are due to anisotropy induced by a cubic lattice in an isotropic harm onic trap. The data, presented necessarily as a function of the radial distance contain occupations along the axes, the diagonals, and other not equivalent directions in the cubic lattice. The sm allness of the indents indicates that the sym m etry of

the trap is dom inant.

III. TIM E-DEPENDENT MEAN FIELD DYNAMICS

The results obtained for mean eld ground state in realistic situations, shown in the previous Section, seem quite encouraging. Yet, in them selves they can say little about the dynamics of the system when the lattice depth V is varied. In an attempt to address this important issue we shall use a time-dependent version of the mean eld approximation. To this end we employ the time-dependent variational principle [8] looking for the minimum of

with H (t) being now the time dependent H am iltonian. The time dependence is implicit via the dependence of the B H H am iltonian H on U; J and W $_{\rm i}$, that in turn depend on V . The chemical potential becomes also time dependent when system parameters are varied. $_{\rm i}$ G (t) >, the variational wavefunction, is assumed in the standard G utzw iller-type form (3), with $_{\rm in}$ G (t) now being time-dependent. The very same approach has been successfully applied recently to the formation of molecules [8, 9], the treatment of the disordered optical lattices [10] as well as for determining the phase diagram in Bose-Ferminix-tures [13].

The m in imization of (5) yields the set of rst order di erential equations for $f_h^{(i)}$ (t):

where $_{i}=^{r}$ < G (t) ja_{j} jG (t) > (the sum , as indicated by subscript in brackets is over the nearest neighbors) bors only). The nice feature of the evolution resulting from equations (6) is that the average number of particles N = $\langle \hat{N} \rangle$ is an exact constant of the motion [8]. Naturally when the param eters of the BH model, e.g. U and J, change the chemical potential corresponding to the mean eld solution with a given number of particles N also changes. The dynamics of cannot be obtained from (6) only. One can nd it, however, following the evolution of two states f_{3} > and f_{3} > with slightly different average num ber of particles N₂ = < G₂ \Re \Im \Im \Im > = $N_1 + N = \langle G_1 \uparrow \hat{N} \uparrow G_1 \rangle + N$. The chemical potential at given t m ay be then approxim ated by (t) = (< $G_2(t)H(t)G_2(t) >$ $< G_1(t) H(t) G_1(t) > = N and$ adjusted at each time step [13]. This is the approach used in the num erical results presented below.




Figure 4: The experimental time prole (solid line) of the lattice potential depth V measured in the recoil energy E $_{\rm r}$ units. The initial exponential increase with a time constant = 20 m s is followed by a at part and a subsequent decrease to V $_{\rm f}$ = 9E $_{\rm r}$ with a linear ram p with varying slope. Dashed line corresponds to the exponential time constant = 40 m s, dash-dotted = 80 m s. Thin dotted lines indicate particularly interesting values of time and V { see text for discussion .

Since we want to follow as closely as possible the experiment [4] let us recall its main features. The experiment has three stages after loading the harm onic trap with Rb condensate – compare Fig. 4. Firstly, the optical lattice depth V (t) was increased in 80 ms (using exponential ramp with time constant = 20 ms) from the initial zero value (when the harm onic trap was present only) to $V_{max} = 22E_r$, where E_r is the recoilenergy of Rb atom s. The sample was then held for $20m \text{ sat } V_{max}$. Finally V (t)

was decreased with the linear ram p to $V_f=9E_r$ with different speed. At any stage the experiment could be interrupted by rapidly switching of all laser beams building up the lattice as well as the magnetic trap. The freely expanding atom ic cloud, after some delay, was recorded by a destructive absorption imaging, yielding the signal which rejects the momentum distribution [14, 16]. Since the absorption images are taken along two orthogonal axes the quantity measured is in fact the integrated momentum distribution [14]:

For clouds released from low optical lattices when tunneling dom inates and the super uid behavior is expected the signal rejects B ragg peaks due to interferences of atoms coming from different lattice sites. At increased lattice depths above $13\rm E_r$ the interference maxima become immersed in an incoherent background disappearing practically at $20\rm E_r$. This behavior was associated with the quantum phase transition from SF to M I phase [4]. Most interestingly the coherence of the sample may

be rapidly recovered when the lattice depth is decreased (third stage of the experim ent) as m easured by the width of the central interference peak which decreases almost to its original value at V = $9E_{\rm r}$ in about 4m s.

In the form erapplications of the time-dependent meaneld approach [8, 9, 10, 13] the time-dependence of system's parameters was assumed to be sulciently slow to assure adiabaticity. In elect the meaneld ground state has been followed by applying the time-dependent equations for $f_n^{(i)}$ (t)'s (6). Here we have a similar situation since it is claimed [4] that the changes in time of V (t) are made sulciently slow to keep the system in the many-body ground state. Having the meaneld ground states for dierent V values we can (within the mean approximation) test this adiabaticity assumption.

Looking again at the time prole depicted in Fig. 4 one may notice that the ram p used in the experiment leads indeed to a very slow increase of V (t) initially, however changes of V (t) become relatively rapid about and above $V = 9E_r$, i.e. in the region where the transition from SF to M I is supposed to take place. Taking as the initial state the mean eld ground state at $V = 9E_r$, our simula-

tions show that to assure adiabaticity a sm all change of V on the super uid side (say from V = 9E_r to V = 9:1E_r) requires about 20m s (one needs 40 m s for a loop from V = 9E_r to V = 9:1E_r and back to keep the overlap on the initial state of the order of 99 percent). That strongly indicates that a much longer time is needed to traverse adiabatically the whole interesting region from V = 9E_r to V = 22E_r. And that change is realized in about 20m s in the experiment.




Figure 5: A tom density distribution (on-site lling factor) after a mean eld evolution starting from the mean eld ground state at $V = 9E_r$ at the nalvalue of $V = 22E_r$ for dierent V (t) time dependence. (a) corresponds to the exponential time scale of 20 ms, (b) to 40 ms, (c) to 80 ms. The longer the time scale, the slower the change of V (t) in the considered range as can be seen in Fig. 4. Thick dashed lines in (a) to (c) present twice the variance of the on-site occupation showing that the insulator regions in (b) and (c) are much larger than in (a). Panel (d) repeats, after Fig. 3, the mean eld ground state at $V = 22E_r$ for comparison. Observe that indents in the lines for dynamically evolved wavefunctions are much more pronounced than in the static (d) case. As before these indents are due to dierent sym metries of the cubic lattice and sperically harmonic isotropic trap. The conjection icting sym metries lead to anisotropic excitations in the dynamical situations when the potential parameters are varied. Those excitations are responsible for the indents.

To test the adiabatic issue further we shall concentrate in the following on the regime above $V = 9E_r$ containing the quantum phase transition. Starting again from the Gutzwiller mean eld ground state at $V = 9E_r$ we $sim ulate the time evolution up to V = 22E_r$ (with experim ental time pro le). We may compare the dynam ically obtained wavefunction plotted in Fig. 5(a) with the mean eld ground state at $V = 22E_r$ (bottom right panel (d) in the gure). While the ground state has an insulator character almost everywhere in the trap with $_{\rm SF}$ = 0.01, the dynam ically evolved wavefunction, by comparison, seems to reect an excited wavepacket and it has rather small regions where the occupation of sites is close to integer with vanishing number variance. The corresponding SF = 0.12 con m s the presence of a relatively large super uid region.

To show that the e ect is really due to the too fast increase of the lattice depth we have modi ed the experim ental time pro le slightly, by changing the exponential constant from 20 m s to 40m s (or 80 m s). That

makes the initial rise of the laser intensity (and the lattice depth) more uniform in time - compare Fig. 4. Observe that while the full duration of the rst stage remains the same, the interval of time spend on the increase of the lattice depth from $V = 9E_r$ to $22E_r$ increases from below 20 m s (experim entalpro le), to about 30 m s (for = 40m s) or about 37 m s (for = 80 m s). Starting again from the mean eld ground state at $V = 9E_r$ we obtain the atom density pro les shown in Fig. 5 (b) and Fig. 5 (c), respectively. Observe that the regions of insulator behavior for both cases are much larger than observed previously. The corresponding super uid factors are SF = 0.062 for = 40m s and $_{\text{SF}}$ = 0.048 for = 80m s. W hile the nal distributions still show signs of signi cant excitations, the insulator character becomes dominant for (c) and also for (b) case.

Keeping the overall duration of the laser intensity turnon at 80 ms and enlarging the nal stage comes at the price that the initial rise from $V = 0E_r$ to $V = 9E_r$, very sm ooth in the experiment [4] for = 20 m s, becomes (com pare Fig. 4). Thus larger sharper for larger m ay lead to some excitation at the initial creation of the lattice, not apparent in our simulations since we start from the ground state at $V = 9E_r$. Trying to keep the total duration of the experim ent as short as possible (to avoid, for exam ple, the decoherence) one can still in agine a slightly more sophisticated pulse rise with say ms initially up to say $V = 9E_r$ and further increase with a larger time constant, say 40 ms. While the duration of the experiment increases by 10% only, the degree of the excitation of the nalwavepacket becomes much smaller and the insulator character much more pronounced.

In the experim ent [4] the atom ic density distribution is not measured directly. The presence of the M ott insulator layer has been detected by observing the resonance in the excitation spectrum around the interaction energy U . Clearly the size of the corresponding peak is related to the number of atoms in the insulator layers. Our results indicate that an appropriate suggested change in the time prole of V (t) should increase the size of insulator regions and thus enhance the resonant peak in the excitation spectrum .

Let us mention also that qualitatively similar results to that depicted in Fig.5 are obtained starting the evolution from dierent value of V say V = 8E_r as long as the initial V is succiently big but smaller than the beginning of the SF-M I transition regime (around V = $13E_{\rm r}$). In the experiment the lattice depth is increased from the initial zero value but for that case the Bose-Hubbard Hamiltonian (1) is not a good model to describe the cold atoms physics. This discrete lattice model is appropriate [1,16] when the atoms have to remain in the lowest vibrational state at each site that is for a succiently deep lattice.




Figure 6: Integrated momentum distributions (7) for states shown in Fig. 5 (panels match one another). The cut N (k_x ;0) along k_y = 0 is shown only. Observe that for the time prole of the experiment no narrow peak is visible, in agreement with the experiment. For more adiabatic time scale { panel (c), as well as for the ground state { (d) { the narrow peak in the momentum distribution is clearly visible. For a further discussion see text.

It is most interesting to compare the integrated momentum distributions (7) corresponding to the position distributions shown in Fig. 5. The cuts along $k_y=0$ are presented in Fig. 6. In contrast to Fig. 2 we include now the Fourier transform of the W annier function

[com pare eq. 4)] so the quantity plotted m atches the experim ent (for a better quantitative picture, we prefer the cut along $k_v = 0$ instead of the three-dim ensional color plot used oroginally to represent the experim ental data). Panel (a) corresponds to the experim ental pro le. 0 bserve that the integrated momentum distribution consists of a broad peak in a very nice agreem ent with the experim ent [4]. Note, however, that for other, \m ore adiabatic" time pro les the narrow central structure em erges [com pare (b)] becoming quite pronounced both for (c) as well as for the mean eld ground state momentum distribution { depicted in panel (d). The absence of the narrow Bragg peak in the experiment seems to be, therefore, not related to the transition to insulator phase as suggested in [4]. The persistence of the narrow peaks in Mott regime has been already noted in [14] in a model static quantum M onte Carlo study on a smaller lattice. Result presented in (d) indicates that the conclusion of the authors [14] concerning the ground state mom entum distribution extends also to a realistic sample. The dynam ical results presented in Fug. 6 suggests that fading of the B ragg peaks and the appearance of the broad integrated m om entum distribution can be associated with a signi cant excitation of the sample rather than the transition to M ott insulator regime.

The reliability of the dynam ical mean—eld approach may be tested further in an attempt to reproduce \restoration of coherence" part of the experiment [4]. In the experiment, after reaching V = 22E $_{\rm r}$ the lattice depth is kept constant for 20m s and then decreased back to V = 9E $_{\rm r}$ with a linear ram p of durationt. It is shown that the time needed to restore the narrow interference pattern in the integrated momentum distribution is of the order of 4m s. This phenomenon is associated with restoring the coherence in the sample.

This interpretation is in contradiction with results already presented in Fig. 6 { the existence (or the lack of it) of the narrow peaks seems not to be solely related to the coherence of the sample but also to its excitation. The question, however, remains whether the dynamical

mean eld calculation can reproduce the results of the experiment, i.e. the dependence of the width of the interference pattern on the time duration of lowering the lattice.




Figure 7: Half-width of the central interference peak for different ram p down times $t_{\rm r}$ obtained by a lorentzian tof the integrated momentum distribution (compare (7). Filled circles are connected by a line to guide the eye. Dashed line is a single exponential decay with a time constant = 1:45 ms.

To answer this question we make a simulation (the results are shown in Fig. 7), starting from the static solution in the SF regime (taken for the convenience at $V = 9E_r$ again) increasing exponentially the lattice height as in the experim ent [4], the subsequent delay of $20 \text{ m s at V} = 22E_r$ and a linear ram p-down with various slopes. Note that the shape of the curve as well as the time scale of restoring the narrow interference pattern is in quite good agreem ent with the experim ent. While the experim ental data could be twith a double exponential decay with two time scales, our mean eld data are reasonably reproduced with a single exponential decay with = 1:45 ms. This nicely corresponds with time scale the shorter time scale of the experiment (0.94 ms). The obtained time scale is also of the order of a typical single tunneling time (1=J in appropriate units) to the nearby site. Our num erical data fail to reproduce the second experim ental time scale. This points out to the possibility that it can be associated indeed with a long range correlation between sites. Such a a long range correlation should not manifest itself in our mean eld simulations

The observed quite good agreement of the obtained widths of the momentum distribution with the experiment [4] seems to be quite a spectacular success of the dynamicalmean eld simulation bearing in mind its simplicity. The fact that the mean eld approach works so well may be, in our opinion, attributed to the fact that the dynamics takes place in the regime where super uid fraction remains signicant. Then the mean atomic eld idoes not vanish allowing for semiclassical (mean-eld) description. Our results suggest that the system has quite a long memory and remembers that it was originally a SF. This to nicely with the excited wavepacket-like character of dynamically obtained wavefunction clearly visible in Fig. 5(a).

IV. CONCLUSIONS

To sum marize, it has been shown that the mean eld Gutzwiller approximation allows one to simulate a dynamics of inhomogeneous Bose-Hubbard model taking into account realistic experimental conditions. The accuracy of the approximation cannot be controlled which

is the major drawback of the present approach (a comparison with exact dynamics for small systems will lead us nowhere since then the mean eld approach is known to fail). On the other hand a comparison with the avail-

able data seems quite encouraging. A coepting mean eld predictions we may con m that indeed the transition from super uid to M ott insulator takes place (albeit in a small part of the sample) in the experiment [4]. On the other hand the claim that the rst stage of the experiment is performed adiabatically assuring that the system remains in its many body ground state (and thus a genuine textbook quantum phase transition [3] is realized) seems questionable. We con m the suggestion of [14] that fading of narrow peaks in the momentum distribution should not be associated with the transition to the Mott insulator regime. Rather it is a dynamicale ect.

We suggest that optim ization of the lattice depth time dependence (i.e. laser intensity pro le) may help to enlarge the insulator regions making the transition more adiabatic. That may be detected by measuring the size of the peak in the excitation spectrum of the system.

Lastly, let us m ention, that a very recent preprint [25] reports a study of exact dynam ics of the m odel using the m ethod of [20, 21]. However, the results consider at most 49 atoms in 40 sites of 1D lattice.
