Random walks, liquidity molasses and critical response in nancial markets

Abstract

Stock prices are observed to be random walks in time despite a strong, long term memory in the signs of trades (buys or sells). Lilb and Farmer have recently suggested that these correlations are compensated by opposite long ranged uctuations in liquidity, with an otherwise permanent market im pact, challenging the scenario proposed in Q uantitative F inance 4, 176 (2004), where the impact is transient, with a power-law decay in time. The exponent of this decay is precisely tuned to a critical value, ensuring simultaneously that prices are di usive on long time scales and that the response function is nearly constant. We provide new analysis of empirical data that con rm and make more precise our previous claims. We show that the power-law decay of the bare impact function comes both from an excess ow of limit order opposite to the market order ow, and to a system atic anti-correlation of the bid-ask motion between trades, two e ects that create a liquidity molasses' which dam pens market volatility.

1 Introduction

The volatility of nancial assets is well known to be too much large compared to the prediction of E cient M arket Theory [1] and to exhibit intriguing statistical anom alies, such as intermittency and long range memory (for recent reviews, see [2, 3, 4, 5]. The availability of all trades and quotes on electronic markets m akes it possible to analyze in details the intim atem echanism s leading to these anom alies. In a previous paper [6], we have proposed, based on empirical data, that the random walk nature of prices (i.e. the absence of return autocorrelations) is in fact highly non trivial and results from a ne-tuned competition between liquidity providers and liquidity takers. In order not to reveal their strategy, liquidity takers must decompose their orders in small trades that are diluted in time over a several hours to several days. This creates long range persistence in the 'sign' of the market orders (i.e. buy, " = +1 or sell " = 1) [7, 8, 6, 9]. This persistence should naively lead to a positive correlations of the returns and a super-di usive behaviour of the price [6, 9]. However, liquidity providers act such as to create long range anti-persistence in price changes: liquidity providers m ake their proton the bid-ask spread but losem oney when the pricem akes large excursions, in which case they sell low and have to buy high (or vice versa) for inventory reasons. Both e ects rather precisely compensate and lead to an overall di usive behaviour (at least to a rst approximation), such that (statistical) arbitrage opportunities are absent, as expected. We have shown in [6] that this picture allows one to understand the tem poral structure of the market im pact function (which measures how a given trade a ects on average future prices), which was found to rst increase, reach a maximum and nally decrease at large time, re ecting the mean-reversion action of liquidity providers.

The above picture was recently challenged by Lillo and Farm er [9]. A lthough they also nd long memory (i.e., non sum mable power-law correlations) in the sign of market orders, they claim that the compensating mechanism that leads to uncorrelated returns is not the slow, mean-reverting in uence of liquidity providers suggested in [6]. Rather, they argue that long range liquidity uctuations, correlated with the order ow, act to suppress the otherwise permanent in pact of market orders and make the price di usive.

The aim of this paper is to explain in more details the di erences and sim ilarities between these con icting pictures, and to present new data that support our original assertions [6]. While our previous paper mainly discussed on the case of France-Telecom, we also present a more system atic account of our main observables for a substantial set of stocks from the Paris Bourse. We also give a much more precise qualitative and quantitative description of the way liquidity providers manage, on average, to mean-revert the price by monitoring the ow of lim it orders. We therefore argue that liquidity providers create a kind of liquidity molasses' that stabilises the volatility of nancial markets, which is indeed the traditional role given to market makers.

2 The impact of trades on prices

2.1 Form ulation of the problem

In the following, we will consider follow the dynamics of prices in trade timen (i.e. each distinct trade increases n by one unit) and de ne prices p_n as the midpoint just before the nth trade: $p_n = (a_n + b_n)=2$, where a_n and b_n are, respectively, the ask price and the bid price corresponding to the last quote before the trade. We assume that the price can be written in general as:

where G describes the impact at time n of a trade at time n⁰, of sign and volume $"_{n^0}; V_{n^0}$, knowing that the order book at time n⁰ is in a certain state S_{n^0} (specified by the list of all prices and volumes of the limit orders). The assumption we made in [6] is that the impact function G can be decomposed into an average, system atic part in the direction of the trade, plus uctuations:

where the function G was furtherm ore assumed to by time translation invariant¹ and factorisable as: G $(n;n^{0}j_{N_{n}0}) = f(V_{n})G_{0}(n n^{0})$. The last assumption is motivated by theoretical and empirical results [10, 16, 6], where f(V) is found to be a power-law with a small exponent f(V) = V [14, 15] or a logarithm $f(V) = \ln V$ [16, 6]. The noise term $(n;n^{0})$ is uncorrelated with the " $_{n^{0}}$ and has a variance $(n n^{0})D$. The nalform of the model proposed in [6] therefore reads:

The main noting of [6] is that the bare impact function G_0 (') must decay with the time lag in order to compensate for the long range correlation in the ", in other words that the impact of a single trade is transient rather than perm anent. In their recent work, Lilb and Farm er [9] argue that it is rather the uctuations in liquidity (encoded in the instantaneous shape of the order book S_{n^0}), that are crucial. Their model amounts to write p_n as:

with = 0.3 and where is the instantaneous liquidity of the market. The di erence between V³ and $\ln V$ is actually not relevant; rather, the crucial difference between Eq. (3) and Eq. (4) is that the impact is transient in the form er

case and perm anent (but uctuating) in the latter case, a point on which we will com m ent later.

The argument of ref. [9] in favor of the second model, Eq. (4) goes in two steps: nst, they propose, as a proxy of the instantaneous liquidity $_n$, the volume v_n at the best price (i.e. ask for buys and bid for sells): see [9] section VIB. They then study the time series of $r_n = "_n V_n = v_n$ and nd that linear correlations have nearly completely disappeared, at variance with the unrescaled series $"_n V_n$ that exhibit the problem atic long range correlations. Their conclusion is therefore that \the inclusion of the time varying liquidity term apparently rem oves long-memory". Here, we want to refute this interpretation based on three independent sets of arguments: a) we show that Eq. (4) has less explicative power than Eq. (3); b) Eq. (4) leads to an average response function (see [6] and below) that signi cantly increases with time lag, at variance with data and c) the absence of linear correlations observed in r_n is an artefact coming from the very large uctuations of the volume e at the best price. Note that our data concerns stocks from Paris Bourse rather than the LSE stocks studied in [9]. However, we do not expect m a jor qualitative di erences between the two markets.

2.2 Response functions

We ist start by recalling the de nition of the average response function, as the correlation between the sign of a trade at time n and the subsequent price dierence between n and n + [6]:




Figure 1: Response function R (') (in Euros) for Carrefour in the periods 2001 and 2002.




Figure 2: Response function R (') (in Euros) for stocks from Paris Bourse in 2002. From top to bottom: EN, EX, FTE, ACA, CGE. (See Table 1 for the stocks code). Note that for some stocks R (') increases for all ' (see e.g. CGE), whereas for other stocks R (') reaches a maximum before becoming negative (see e.g. ACA). The dotted line correspond to R (') = 0.




Figure 3: Response function R (') (in Euros) for other stocks from Paris Bourse in 2002. From top to bottom : FP, BN, GLE, MC, CA, V \equiv . (See Table 1 for the stocks code). Note that for some stocks R (') increases for all ' (see e.g. GLE), whereas for other stocks R (') reaches a maximum before becoming negative (see e.g. CA, for '> 5000).

The quantity R (') measures how much, on average, the price moves up conditioned to a buy order at time 0 (or how a sell order moves the price down) a time 'later. Note that because of the tem poral correlations between the "'s, this quantity is not the above market response to a single trade G_0 (') [6]. This quantity is plotted in Fig. 1 for Carrefour in 2001, 2002. As emphasized in [16, 6], R (') is found to weakly increase up to a maximum beyond which it decays back and can even change sign for large ' (see Figs. 2, 3). For other stocks, or other periods, the maximum of R (') is not observed, and R (') is seen to increase (although always rather mildly, at most by a factor 3) with ': see Figs. 2,3. A swill be clear below, this di erence of behaviour can actually be understood within our model.




Figure 4: Four di erent 'response functions' R ('), R $_{\rm V}$ ('), R $_{\rm LF}$ (') and R $_{\rm LF}$ ('), (see text) in Euros for BN in 2002. This plot shows (a) that the Lillo-Farm er variable r_n has a weak explicative power (see R $_{\rm LF}$ { dashed line) and (b) that their perm anent in pact m odel leads to a considerable over-estimation of the true response function (see R $_{\rm LF}$ { dashed-dotted lines, showing a 30 times increase with ').

In Fig. 4, we also plot three other, sim ilar quantities. The st is the (normalized) correlation between the price change and $"_n \ln V_n$:

which has a similar shape but is distincly larger than R itself, showing that, as expected, the variable " $_n \ln V_n$ has a larger explicative power than " $_n$ itself.

In order to test the Lillo-Farm er model, we have also computed two further quantities. One is the normalized correlation between the Lillo-Farm er variable $r_n = "_n V_n = v_n$ and the empirical price change:

This quantity m easures the explicative power of r_n , and can be directly compared to R and R_V. As can be seen in Fig. 4, R_{LF} (') is in fact a factor 3 sm aller than R_V (') (see also the quantity Z in Table 2, last colum n).

The second interesting quantity is:

The quantity measures a ctitious average response function, which would follow if the price dynamics was given by Eq. (4). We see in Fig. 4 that R_{LF} ('), at variance with the true R ('), sharply grows with ', as a consequence of the correlation of the "'s which are not compensated by a uctuating liquidity. As we have mentioned in [6], the response function R (') is a very sensitive measure




Figure 5: Sign correlations C (') for BN, showing a long range, power-law decay, and comparison between the smaller and faster decaying correlation of the r_n and the $1=v_n$, showing that the form er is dom inated by the weak correlations between smallorder volumes, and not by a compensation between market order ows and limit order ows.

of the dynam ics of prices that allows one to reveal subtle e ects, beyond the simple autocorrelation of price changes (see also below).

Finally, we show in Fig. 5 the rapid fall of the autocorrelation of the variables r_n , that was argued by Lillo and Farm er to be a strong support to their model [9]. Unfortunately, this e ect is not relevant and is due to the fact that the volume at the best price has large uctuations. For example, in the case of FTE, the distribution of v is found to be well-t by P (v) / v⁻¹ exp(v=v) with > 1, so that the most probable values correspond to v - 1, whereas the mean value is - 3000 [11]. Since v appears in the denom inator of r_n , it is clear that the r_n correlations are dom inated by times where the volume at bid/ask is particularly sm all; these sm all values show little autocorrelations (see Fig. 5).²

2.3 The bare impact function and price di usion

W e conclude from F ig. 4 that although the variables r_n are indeed close to being uncorrelated, they do not provide an adequate basis to interpret the dynam ics of real price. Our transient in pact model, on the other hand, allows one to reconcile the absence of autocorrelations in price changes with the observed non




Figure 6: P lot of the sign correlations C (') for a selection of four stocks, showing the long-ranged nature of these correlations. See also Table 3.

m onotonous shape of the average response function, provided the bare in pact function $G_0(')$ is chosen adequately. In [6], it was shown that if the correlation of the "'s decays as ', then $G_0(')$ should also decay, at large times, as a power-law ' with (1)=2. For > (1)=2, the price is subdi usive (anti-persistent) and the response function R (') has a maximum before becoming negative at large '. For < (1)=2, on the other hand, the price is superdi usive (persistent) and the response function monotonously increases (see Fig. 10 of [6]). The short time behaviour of G_0 (') can in fact be extracted from empirical data by using the follow ing exact relationship:

a correlation function that can also be measured directly (see Figs. 5,6).




Figure 7: C on parison betwen the empirically determ ined G_0 ('), extracted from R and C using Eq.(9), and the t G_0^{f} (') = $_0 = (v_0^2 + v^2)^{=2}$, used to extract the parameters given in Table 2, for a selection of four stocks: ACA, CA, EX, FP.

Eq. (9) gives a set of linear equations relating R, G_0 and C that can easily be solved for G_0 . The result is plotted in Fig. 7 for dimensional stocks. One sees that $G_0(')$ is not at or rises very slightly with 'before indeed decaying, for '1, like a power law, with given in Table 2. The tused to extract the value of is $G_0^{f}(') = 0 = ({}^{2}_{0} + {}^{2}) = 0$ which is similar, but not identical to, the one proposed in [6]. The advantage of the present t is that it matches quite well the rather at initial behaviour of $G_0(')$. We also give in Table 2 the value of other quantities such as the exponent governing the decay of the "correlations. A very similar




Figure 8: Scatter plot of the exponents ; extracted from the t of G $_0$ and C. These exponents are seen to lie in the vicinity of the critical line = (1)=2 (dotted line), as expected from the nearly di usive behaviour of prices (see Fig. 9), and [6].

shape for G_0 can be observed for all stocks; uctuations around the critical line = (1)=2 (see Fig. 8) are enough to explain the fact that R sometimes has a maximum, sometimes not.

Correspondingly, the vicinity of the critical line ensures that the price has a di usive behaviour, as is indeed con med by measuring the variance of price changes:




Figure 9: Plot of D (')=' (in Euros) vs. ' for several stocks. Apart from BN and FP (for which the tick size is large), this quantity is roughly constant with ', show ing that prices are to a very good approximation di usive, even on shortest times scales. From top to bottom : BN, FP, GLE, FTE, MC.




Figure 10: Plot of D (')=' (in Euros) vs. ' for all other (sm aller tick) stocks. From top to bottom : CA, V IE, EN, EX, ACA, CGE.

as dem onstrated in Figs. 9 and 10. The fact that D (') is strictly linear in ' is of course tantam ount to saying that price increments are uncorrelated.

2.4 E conom ic interpretation of the shape of the bare im - pact

The econom ic interpretation of the non monotonic behaviour of G_0 is as follows. Suppose that you are a liquidity provider, making prots on the bid-ask spread and losses on large price excursions, and that you see a low of buy orders coming. In the absence of news and for typical buy volumes,³ the natural strategy is, on short times, to biais the ask price up to be able to sell higher while there are

clients eager to buy. However, you now have a net short position on the stock that you want to eventually shift back to zero. So you would like to buy back, in the near future, at the cheapest possible price. In order to prevent the price from going up, you can/should do two things: a) create a barrier to further price rises by placing a large number of sell orders at the ask, o which the price will bounce back down b) place bid orders as low as possible. Both e ects act to create a liquidity m classes that m can revert the price towards its initial value. Both these e ects can actually be observed directly on the data.

a) One observes a strong correlation between a buy (resp. sell) market order moving the price up and the subsequent appearance of limit orders at the ask (resp. bid) [17, 9]. If a 'wall' of limit orders appears at the ask while the bid remains poorly populated, the probability that the price moves down upon the arrival of further market orders becomes larger than the probability to move up. One can visualize this e ext more clearly by separating the total price change into two components: price variations due to market orders, $_{\rm M}$ p_n, corresponding to the change of mid-point between the quote immediately prior and the quote immediately posterior to the n-th trade, and price variations due to limit orders, $_{\rm L}$ p_n corresponding to changes of mid-points in-between trade n and trade n + 1. By de nition,

O ne can then m easure the response function restricted to price changes due to m arket orders:




Figure 11: M ain gure: Comparison between the full response R (circles) and the response restricted to market order induced price changes R_M (squares), for FTE in 2002. Inset: Integrated correlation functions, corresponding to $h_M p_n_M p_{n+1}$, i (full line), and $h_M p_n_L p_{n+1}$, i (dotted line). The former is clearly positive, and is compensated by the negative correlation between market orders induced shifts and subsequent changes in the mid-quotes.

and compare it (see Fig. 11) to R ('). We observe for all stocks that R_M (') and R (') have the same overall shape. For FTE, for example, R_M (') also bends down and becomes negative for large '. But since by de nition $_M p_k = "_k G_k$ with $G_k = 0$ (a buy market order can only move the price up or leave it unchanged), the fact that R_M (') decreases in plies that G_k is anticorrelated with $"_n "_k$. In other words, sell orders following buy orders in pact the price more than buy orders following buy orders, as expected if the order book lls in more on the ask side than on the bid side after a buy market order (and, of course, sim larly for the sell side).

b) there is an anticorrelation between buy orders and the subsequent m otion of the bid-ask in-between trades. This is seen both from the fact that R_M (') > R (') for 'not too large (see Fig. 11), in plying that the response function restriced to limit orders is negative. Furtherm ore, one can study the correlation between a market order induced price change __M p_n and a later limit order price change __L p_{n+'}, which is found to be negative (as

also reported in [6, 9]). This compensates the positive correlations between $_{\rm M} p_{\rm n}$ and $_{\rm M} p_{\rm n+}$, (and between $_{\rm L} p_{\rm n}$ and $_{\rm L} p_{\rm n+}$,), that would otherwise lead to a superdi usion in the price.

In order to make our point even more clearly, it is useful to emphasize the antagonist forces present in nancialmarkets:

The ideal world for liquidity providers is a stable, xed average price that allow s them to earn the bid-ask spread at every round-turn. Volatility is the enem y^4 , liquidity m olasses is the solution: a vanishing long term im pact (i.e. $G_0(1) = 0$) is a way to lim it the volatility of the market and to increase the liquidity provider gains. Reducing the volatility of nancial markets is in fact the traditional role given to market makers in non electronic markets. Note that we do not assume any kind of collusion between liquidity providers: they all, individually, follow a perfectly reasonable strategy.

⁴ Insider inform ation is also the liquidity provider enemy, but this situation is rather rare on the scale of the thousands of trades happening every day on each single liquid stock. How ever, creating a liquidity wall is indeed risky for the liquidity provider in the case where some true inform ation motivates the market orders. In that case, the insider can use his inform ation without impacting the price.

Conversely, perm anent in pact is what the liquidity taker should hope for: if the price rises because of his very trade but stays high until he sells back, his impact is not really a cost. On the other hand, if the price de ates back after having bought it, it means that he paid to much for it.⁵ The correlations created by splitting his bid in sm all quantities also help keeping the price up.

These are the basic ingredients ruling the competition between liquidity providers and liquidity takers. The subtle balance between the positive correlation in the trades (measured by) and the liquidity molasses induced by liquidity providers (measured by) is a self-organized dynamical equilibrium. Its stability comes from two counter-balancing e ects: if the liquidity providers are too slow to revert the price (< (1)=2), then the price is superdi usive and liquidity providers lose money on average [21]; therefore they increase . If the mean reversion is too strong (> (1)=2), the resulting long term anticorrelations is an incentive for buyers to wait for prices to come back down to continue buying. Liquidity takers thereby spread their trading over longer time scales, which corresponds to smaller values of .

A dynamical equilibrium where (1) = 2 therefore establishes itself spontaneously, with clear economic forces driving the system back towards this equilibrium. Interestingly, uctuations around this critical line leads to uctuations of the local volatility, since persistent patches correspond to high local volatility and antipersistent patches to low local volatility (see also [22] for a similar mechanism). Extrem e crash situations are well-known to be liquidity crisis, where the liquidity molasses e ect disappears tem porarily, destabilising the market (on that point, see the detailed recent study of [12, 18]).

Finally, the mean-reverting nature of the response function is of crucial im – portance to understand the in uence of volum e and execution time on the actual impact of trading on prices (on this point, see [19, 20]).

3 Summary and Conclusion

The aim of this paper was to challenge Lilb and Farm er's suggestion that the strong m em ory in the signs of trades is compensated by liquidity uctuations, with an otherwise permanent market impact, and con m the more subtle scenario proposed in our previous paper [6], in which the impact is transient, with a power-law decay in time. The exponent is precisely tuned to a critical value, ensuring simultaneously that prices are di usive on long time scales and that the response function is nearly constant. Therefore, the seem ingly trivial random walk behaviour of price changes in fact results from a ned-tuned competition

between two opposite e ects, one leading to super-di usion { the autocorrelation of market order ow; the other leading to sub-di usion { the decay of the bare in pact function, re ecting the mean-reverting nature of the limit order ow . We have shown that mean reversion comes both from an excess ow of limit order opposite to the market order ow, and to a system atic anti-correlation of the bid-ask motion between trades. Note that in the above picture, the random walk nature of prices and their volatility are induced by the trading mechanism s alone, with no reference to real news. These of course should also play a role, but probably not as in portant as pure speculation and trading that lead to excess volatility (see the discussion and references in [6]).

The above ne tuning is however, obviously, not always perfect, and is expected to be only approximately true on average. Breakdown of the balance between the two e ects can lead either to large volatility periods and crashes when the liquidity molasses disappears, or to low volatility periods when meanreverting e ects are strong. The small in balance between the two e ects therefore leads to di erent shapes of R (') (m onotone increasing or turning round and changing sign). As emphasized in [6], our noting that the absence of arbitrage opportunities results from a critical balance between antagonist e ects might justify several claims made in the (econo-)physics literature that the anom alies in price statistics (fat tails in returns described by power laws [23, 24], long range self sim ilar volatility correlations [3, 5], and the long ranged correlations in signs [6,9]) are due to the presence of a critical point in the vicinity of which the market operates (see e.g. [25], and in the context of nancialm arkets [26, 27, 28]). From a more practical point of view, we hope that the present detailed picture of market m icrostructure could help understanding the mechanism's leading to excess volatility, and suggest ways to control more e ciently the stability of nancial m arkets.
