Photon energy absorption rate of a striped Hall gas

U sing sym m etries of the current correlation function, we analyze the frequency dependence of the photon energy absorption rate of a striped Hall gas. Since the magnetic translational symmetry is spontaneously broken in the striped Hall gas, a Nambu-Goldstone (NG) mode appears. It is shown that the NG mode causes a sharp absorption at the zero energy in the long wavelength limit by using the single mode approximation. The photon energy absorption rate at the NG mode frequency strongly depends on the direction of the wave number vector. Whereas, the absorption rate at the cyclotron frequency does not depend on the direction of the wave number vector in the long wavelength limit. The cyclotron resonance is not a ected in the striped Hall gas. Our result supplements the Kohn's theorem in the system of the NG mode.

I. INTRODUCTION

The two-dimensional electron system under a strong magnetic eld, the quantum Hall system (QHS), without impurities has four symmetries, that is the electromagnetic U(1), the magnetic rotation, and the magnetic translations in x and y direction. The magnetic translational symmetry in one direction and the magnetic rotational symmetry are spontaneously broken in a striped Hall gas, which is supposed to be realized at the half-lling of the third and higher Landau Level (LL)s. The striped Hall gas has an anisotropic Ferm i surface, and leads to a highly anisotropic resistivity. Since the magnetic translation is spontaneously broken in this state, a Nambu-Goldstone (NG) mode appears. Dynamicale ects of the NG mode are studied in the present paper.

There are several theoretical works which would lead to the highly anisotropic resistivity at the half-led third and higher LLs. The Hartree-Fock approximation (HFA) at the half-led lth LL predicts two solutions, a unidirectional charge density wave (UCDW) 3,4,5,6 and a highly anisotropic charge density wave (ACDW). The striped Hallgas is the UCDW which has an energy gap in one direction and no energy gap in another direction. The ACDW has an energy gap in each direction. Collective modes for the UCDW have been studied based on the edge current picture, 8,9,10,11,12 the generalized random phase approximation (GRPA), and the single mode approximation (SMA). 14,15,16 Collective modes for the ACDW have been studied in the time-dependent HFA. We use the UCDW and the SMA to study the photon absorption elect of the NG mode.

The K ohn's theorem ¹⁷ is a quite general theorem concerning the photon absorption in the QHS. It includes two statem ents on the cyclotron resonance. The rst one is that a sharp absorption of a hom ogeneous rotating m icrow ave occurs only at the cyclotron frequency. The second one is that the cyclotron resonance is not a ected by electron interactions. The implicit assumption for the rst statement is that the zero-energy excited state is absent in the long wavelength lim it. The assumption is not satisfied in the striped Hall gas.

It is an open question if a sharp absorption at the NG mode frequency occurs in the long wavelength lim it. A photon energy absorption rate is proportional to the imaginary part of a current correlation function, and is inversely proportional to the frequency! of the electrom agnetic vector potential $A_{\rm ext}=Ee^{ik} r^{+ikz} i^{!t}=i!$. Here E is the polarization vector, $(k;k_z)$ is the wave number vector and (r;z;t) is the space-time coordinate. We project the system onto the lth LL and study the contribution of the NG mode. Since the imaginary part of the LL projected current correlation function becomes zero in the kj! 0 lim it, it would appear that the photon energy absorption rate is zero. However, when! equals the NG mode frequency! $_{NG}(k)$, the denominator also becomes zero in the kj! 0 lim it. Hence, the kj! 0 lim it of the photon energy absorption rate could be nite. A ctually, we not that a sharp absorption occurs at the NG mode frequency. The photon energy absorption rate at the NG mode frequency strongly depends on the direction of k.

W ithout the LL projection, we study the cyclotron resonance in the striped Hallgas. The photon energy absorption rate at the cyclotron frequency does not depend on the direction of k in the jkj! 0 lim it. Then we not that the cyclotron resonance is una ected in the striped Hallgas phase. The second statement of the Kohn's theorem is intact.

This paper is organized as follows. In Sec. II, the symmetries of the QHS are claried and the striped Hall gas is constructed as an eigenstate of charges of unbroken symmetries. The current correlation function is computed by means of the magnetic translational invariance of the striped Hall gas in Sec. III. A trigonometric factor of the momentum and the periodic Dirac's delta function of wave number vectors appear due to the stripe periodicity. In order to investigate the current correlation function in the long wavelength limit, we also use the Hartree-Fock (HF)

solution of the striped Hallgas in Sec. III. We discuss the photon energy absorption rate of the striped Hallgas and the f-sum rule by using the SMA spectrum in Sec. IV and give a discussion and sum mary in Sec. V. Appendix A gives a de nition of the photon energy absorption rate. The cyclotron resonance is derived in appendix B.

II. BROKEN SYMMETRIES OF THE STRIPED HALL GAS

The striped Hallgas spontaneously breaks the magnetic translational symmetry of the QHS.We clarify symmetries of the QHS, and dene the striped Hallgas state in terms of conserved charges of the magnetic translational symmetry.

where (r) is the electron eld operator, ! $_{\text{C}} = \text{eB} = \text{m}$, and V (r) = $q^2 = r$ ($q^2 = e^2 = 4$, is the background dielectric constant). We do not consider impurities and a con ning potential in this paper. Noether currents of the electrom agnetic U (1), the magnetic translations in x and y directions are dened by $j = {}^{y}v$, $j_{y} = {}^{y}v$ Y + $_{x}L = \text{eB}$ and $j_{x} = {}^{y}v$ X $_{y}L = \text{eB}$. Here, $v = (1;v); v = !_{\text{C}}($;) and L is the Lagrangian density for the total Hamiltonian H . Conserved charges Q; Q_{x} ; Q_{x} for the electrom agnetic U (1) and the magnetic translations are dened respectively by $Q = {}^{2}rj_{y}^{0}$ (r), $Q_{y} = {}^{2}rj_{y}^{0}$ (r) and $Q_{x} = {}^{2}rj_{x}^{0}$ (r). These charges commute with the total Hamiltonian H and obey $[Q_{x};Q_{y}] = iQ = \text{eB}$. The electrom agnetic U (1) charge Q commutes with all conserved charges. We assume that Q is not broken and the ground state is the eigenstate of Q as Q $[Di = N_{e}]Di$, where N_{e} is the number of electrons.

The conserved charges of magnetic translations satisfy the following algebra,

where $a = \sqrt[p]{2} = B$. Those states which are periodic in one direction and uniform in another direction break the magnetic translational symmetry. Since an expectation value of the left hand side of Eq. (2.2) with respect to the states become snonzero, the states cannot be eigenstates of the conserved charge Q_X or Q_Y . Therefore the magnetic translational symmetry is spontaneously broken.

We construct the striped Hall gas state which breaks the magnetic translational symmetry in x direction and conserves the magnetic translational symmetry in y direction. The magnetic translations in x and y directions are generated respectively by exp $(i\frac{2}{a^2}xQ_Y)$ and exp $(i\frac{2}{a^2}yQ_X)$ which is derived from Eq. (22). Hence, the striped Hall gas state is an eigenstate of an in nitesimal magnetic translation in y direction, exp $(i\frac{2}{a^2}yQ_X)$, and is also an eigenstate of a stripe period magnetic translation in x direction, exp $(i\frac{2}{a^2}r_San_XQ_Y)$, where n_X is an integer and r_Sa is

III. CURRENT CORRELATION FUNCTION

First, we represent a current correlation function in terms of the magnetic translational property of the striped Hall gas. Next, the current correlation function is projected onto the lth LL, and is evaluated by including the NG mode. We use the HFA and the SMA to evaluate the current correlation function.

A. Sym m etry of the current correlation function

We set a = 1 in the following calculation for the simplicity. The current correlation function of the striped Hallgas $\mathfrak{P}_{i,0}$ is defined by

Next, we transform K_{\perp} (k;k⁰) with the use of Eq. (2.2). The delta function of k and k^0 is periodic in k_x direction because of the periodicity of the striped Hallgas. When k=0, the cyclotron resonance is derived with the use of Eq. (3.8) in Appendix B. If the magnetic translational symmetries in both x and y direction were unbroken, then the delta function would become (2) k+1 and there would be no trigonometric factor.

B. Evaluation of the current correlation function

We evaluate the current correlation function of the striped Hall gas in the half-led lth LL. The striped Hall gas state spontaneously breaks the magnetic translational symmetry in x direction and there exists the NG mode. We project the current correlation function onto the lth LL to study the contribution of the NG mode. Since the species index becomes $_0$ after the LL projection, we do not write the species index of the LL projected current correlation function in the following in the present paper. We use the UCDW in the HFA 5,6 for the ground state, and use the SM A 14,15,16 for the NG mode in order to evaluate the right hand side of Eq. (3.8).

The UCDW in the HFA and the NG mode in the SMA are discussed by using the von Neumann lattice (vNL) form alism, 18 in which the QHS is represented as a two-dimensional lattice system. In the vNL form alism, the one-electron states are expanded by the vNL basis. Let us introduce the vNL basis. A discrete set of coherent states of guiding-center coordinates,




FIG.1: Ferm isea in the magnetic BZ of lth Landau level

The mean-eld state of the striped Hallgas in the HFA has an anisotropic Ferm isea (FIG.1) which is uniform in p_x direction. The mean-eld state is constructed as $\mathfrak{D}i = N_{1-p2FS}b_1^y$ (p) jvaci. Here N_1 is the normalization constant, FS denotes the Ferm isea and jvaci is the vacuum state which is occupied up to the lath LL. The two point function is given by

The SMA is a variationalm ethod to calculate the lowest excited state, and is consistent with the GRPA in num erical calculations. The low energy excitation in the SMA is a uctuation of the density in the striped Hall gas. Given the ground state 0i, the NG mode in the SMA at k is assumed as

IV. IM PLICATIONS OF THE NG MODE

From the current correlation function of the striped Hallgas, we see in plications of the NG mode. In the subsection A, we not a sharp energy absorption at the NG mode frequency besides at the cyclotron frequency. In the subsection B, we study the dominant resonance of the density correlation function in the long wavelength limit and show that the density correlation function satis es the f-sum rule.

A. Photon energy absorption rate

When an external electrom agnetic wave is added, the striped Hall gas absorbs the photon energy. We study the photon energy absorption rate which is proportional to the current correlation function, and inversely proportional to the frequency! (see appendix A). A sharp absorption occurs at $! = !_c$ when k = 0 (see appendix B). The striped Hall gas has the NG mode! = $!_{NG}$ (k), and a sharp absorption may also occur at the NG mode frequency which vanishes in the $!_{NG}$ in it.

As a typical example, we assume that the electrom agnetic wave is propagating in the three-dimensional space (r;z) as $E=E_L$ $(e_x+ie_y)e^{ik}$ r+ikz i!t, where E_L (e_x+ie_y) is a left-handed circularly polarization vector, and k_z is a wave number vector in z direction. The photon energy absorption rate of the striped Hall gas is expressed by the current correlation function as

The ratio $(k_x^2 + k_y^2) = (A_0 \hat{k}_x^2 + B_0 \hat{k}_y^4)$ converges to a constant value when k_x and k_y approach zero in the same order or when k_y approaches zero in the higher order than k_x . In particular when we $x k_x$ and take a $k_y ! 0$, the photon energy absorption rate is obtained as follows,

This result shows a sharp energy absorption at the NG mode frequency. The same result is obtained for the right-handed circularly polarized electrom agnetic wave. On the other hand, a sharp energy absorption at $! = !_c$ with k = 0 is derived by using the current correlation function without the LL projection. The result becomes the following (see appendix B);

A sharp absorption at ! = E $_{\rm SM~A}$ (k) occurs at a small k in addition to the sharp absorption at the cyclotron frequency. For the right-handed circularly polarized electrom agnetic wave, $P_{\rm cyclotron}$ = 0.




FIG.2: B -dependence of the photon energy absorption rate with $r_s=2.474$ at l=2. The photon absorption rate $P_{NG}=\langle E_L^2 \rangle$ (! E_{SMA})) at the small k is shown by a solid curve, and $P_{cyclotron}=\langle E_L^2 \rangle$ (! $!_c$)) is shown by a dashed curve. We xalling factor as =2.5 and change a magnetic eld B [T] around 2.5 [T] where an anisotropic resistivity at =2.5 is observed. The unit of the vertical axis is $[s^2 A^2=kg\ m^2]$.

The strength of resonant peaks depends on a magnetic eld B. Fig. 2 shows the B-dependence of the photon energy absorption rate. P_{NG} and $P_{cyclotron}$ of the striped Hall gas depend on B through the cyclotron frequency $!_c$ and $a = \frac{P_{Cyclotron}}{P_{NG}}$ which has been set 1 so far. The photon energy absorption rate at the NG mode frequency in the SI units is $\lim_{E_{SMA}} P_{NG} = (E_L^2 (! E_{SMA})) = 1.810 10^9 B^{3=2} [s^2 A^2 = kg m]$ with l = 2, $r_s = 2.474$ and $l_0 = 0.351$. The value of $l_0 = 1.572$ is determined by minimizing the HF energy per unit area. The photon energy absorption rate at the cyclotron frequency in the SI units is $l_0 = 1.572 10^9 B$ [s² A²=kg m] with l = 2. The photon energy absorption rate at the cyclotron frequency.

The strength of P_{NG} depends on the incident angle of the electrom agnetic wave. When the electrom agnetic wave is tilted parallel to the stripes, the photon energy absorption rate diverges in the kj! 0 lim it. When the electrom agnetic wave is tilted perpendicular to the stripes, the photon energy absorption rate becomes nite. The anisotropy of P_{NG} is a new property of the striped Hall gas.

B. Properties of the density correlation function

In this subsection, we discuss properties of the density correlation function which is a temporal diagonal element of the current correlation function in the QHS.

When excitations have nite energy gaps, the dominant resonance of the density correlation function K $_{!}^{00}$ (k; k) occurs at ! = !c in the long wavelength limit. Since the striped Hall gas has a zero-energy excitation, there is also a resonance of the density correlation function at the NG mode frequency. We study the NG mode resonance of the density correlation function in the long wavelength limit and not that the dominant resonance occurs at the NG mode frequency.

First we derive the cyclotron resonance in the density correlation function when there is a nite energy gap. The ground state and an excited state are denoted by Di and jn i, respectively. The current conservation law gives

When there is a nite energy gap, the k-dependence of the energy dierence in the second term is negligible. Thus the largest residue of the density correlation function 0 (k^2) appears at the cyclotron frequency, and the residues of the density correlation function at the other excitations are 0 (k^3). The cyclotron resonance is dominant at a small k^{19} .

Next we discuss a resonance in the density correlation function when there is a gapless excitation. In this case, we cannot neglect the k-dependence of the energy dierence. Since the energy dierence $E_m = E_0$ approaches zero as k approaches zero and cancels k_i in the numerator of Eq. (4.6), residues of the density correlation function at gapless excitations in the second term of Eq. (4.6) may become larger than $O(k^2)$. We use the LL projected density correlation function of the striped Hallgas obtained in the previous section, and study a residue of the density correlation function

at the NG mode frequency. Inserting Eq. (3.22) into Eq. (3.6), we obtain the long wavelength limit of the density correlation function in the lth LL as

(4.8), we know that the residue of the density correlation function at the NG m ode frequency is A $\hat{f}_{y} \neq 2$), and the residue of the density correlation function at the cyclotron frequency is N_ek²=2. The density correlation function of the striped Hall gas has the largest residue at the NG m ode frequency in the long wavelength lim it. Hence, the dominant resonance of the density correlation function occurs at the NG m ode frequency.

V. SUM M ARY AND DISCUSSION

In this paper, we have studied the contribution of the NG m ode at $! = !_{NG}$ (k) to the current correlation function of the striped Hall gas. The striped Hall gas is the UCDW state which is one of the HFA solutions and has an anisotropic Ferm i surface. The striped Hall gas spontaneously breaks the magnetic translational symmetry and the magnetic rotational symmetry. The symmetry breaking causes a gapless NG mode.

We evaluated the current correlation function in the subspace of lth LL and clari ed the k-dependence of the LL projected current correlation function. Then, we found that the dominant resonance of the density correlation function occurs not at $!=!_{C}$ but at $!=!_{NG}$ (k) at the small k. The density correlation function satis es f-sum rule in the subspace of lth LL, then the SMA is reasonable. Using the current correlation function, we saw that the new highly anisotropic photon energy absorption occurs at the NG mode frequency. The photon energy absorption rate at $!=!_{NG}$ (k) depends on the incident direction of the electrom agnetic wave. An interenergy absorption occurs when the incident direction is perpendicular to the stripes. When the incident direction is parallel to the stripes, the absorbed energy diverges in the kj! 0 lim it.

When the incident direction of the electrom agnetic wave is perpendicular to the stripes, the photon energy absorption rate at $!=!_{N\ G}$ (k) is proportional to B $^{3-2}$ and is larger than the photon absorption rate at $!=!_{C}$. At B = $2.5\ [T]$ where the anisotropic resistivity at =2.5 is observed, the striped H all gas in the half-lled third LL absorbs the photon energy at the NG m ode frequency which is twice as large as the absorbed energy at the cyclotron frequency.

We used the SMA in the present paper. The SMA is one of two approaches to study the low energy excitation. The other approach is based on the edge picture in which the low energy excitations are assumed as small displacements of the edges of the stripes. At a small k, the excitation energy in the SMA is proportional to \hat{k}_y j(A $_0\hat{k}_x^2$ + B $_0\hat{k}_y^4$) where A $_0$ and B $_0$ are constants. The excitation energy based on the edge picture is proportional to \hat{k}_y jf (Y k_x^2 + K k_y^4)= $\frac{1}{3}k$ jg¹⁼² where Y and K are the compression and the bending elastic moduli^{8,9}, respectively. The SMA excitation energy is smaller than the excitation energy based on the edge picture. Hence the SMA is appropriate for the study of the NG mode, and we applied the SMA in this paper.
