M em ory D riven Pattern Form ation

Abstract

The di usion equation is extended by including spatial-tem poralmem ory in such a manner that the conservation of the concentration is maintained. The additional memory term gives rise to the formation of non-trivial stationary solutions. The steady state pattern in an in nite domain is driven by a competition between conventional particle current and a feedback current. We give a general criteria for the existence of a non-trivial stationary state. The applicability of the model is tested in case of a strongly localized, time independent memory kernel. The resulting evolution equation is exactly solvable in arbitrary dimensions and the analytical solutions are compared with numerical simulations. When the memory term o ers an spatially decaying behavior, we indialso the exact stationary solution in form of a screened potential.

I. IN TRODUCTION

There is an increasing e ort in including feedback-couplings into the underlying evolution equations. Such m em ory-controlled e ects should be a further unifying feature of com plex physical [1, 2] as well as biological systems [3] far from equilibrium. W hereas most of the papers are addressed to a purely time dependent but hom ogeneous mem ory, the present one gives an extension to spatially dependent processes. Such systems, however without memory e ects, are widely discussed in physics [4] and biology [5]. Based on our recent studies of several evolution m odels [6, 7, 8, 9], where such non-M arkovian m em ory e ects had been enclosed, and on the analysis of chemical reactions [10], we focus now on the di usive behavior with memory couplings. These e ects have an essential in uence on the long time behavior, but they have also an impact on the dynamics in an intermediate time regime. As the consequence of the interplay between conventional di usive transport and feedback we dem onstrate the occurrence of non-trivial stationary solutions form ing patterns. Our analysis should be grouped into the continuing interest in feedback couplings. A mem ory dom inated behavior is well established in analyzing the freezing processes in under-cooled liquids [11, 12], where the underlying m athem atical representation is based on a projector form alism proposed by M ori [13]. As the result of the projection procedure the irrelevant degrees of freedom, uctuating on short time and short length scales, contribute to the time evolution of the relevant degrees of freedom as well as by instantaneous and by delaycontrolled term s. Since the projection form alism is not restricted to selected system s, the modi cation of the evolution equation due to memory e ects is rather general. Here the relevant quantity m ay be the concentration of certain species or the probability density for a particle. The crucial in uence of memory e ects can be illustrated by considering a single particle moving in a disordered environment. Due to the strong disorder each member of an equally prepared ensemble makes experience by its own surrounding, which is even modied by the random walk of the single particle itself. Such a behavior can be described by a nonlinear Fokker-Planck equation with an additional memory term as had been demonstrated in [14]. The analytical results, based on a one-loop renorm alization group analysis, is in accordance with num erical simulations [6] and further analytical studies [7]. W hereas in that approach the memory e ects are believed to be originated by the inherent non-linear interaction of the many particle system them selves, i. e. the time scale of the memory

is determined by the relevant variable itself, there is a broad class of models which are subjected to external delay e ects [15, 16, 17]; for a survey and applications in biology, see [18]. Even in tracmodels such memory e ects has been discussed [19].

Recently [20] m em ory e ects in correlated anisotropic di usion are studied in nanoporous crystalline solids. Likew ise the e ects of transport m em ory are discussed w ithin the F isher's equation [21], also applicable for bacterial population dynam ics [22]. There appear a non-linear dam ping and traveling wave solutions [23]. The transport w ith m em ory, depending on the survivability of a population, is analyzed in [24].

Regarding the large variety of system s with feedback couplings it seems to be worth to study simple models, which still include the dynamical features of evolution models as conservation of the relevant quantity p(r;t) and moreover, a time-delayed coupling. In the present paper we emphasize in an analytical solvable model with spatio-temporal feedback coupling. The generic behavior of the system may be changed by those additional delay e ects. In particular, we discuss the transport behavior which is realized after a su cient accumulation time and after cumulating particles within a spatial region. We show that the processes are a ected by additional spatial and temporal correlations leading to non-trivial steady state solutions.

II. MODEL

In case the transport is realized after a spatial-tem poral accumulation process the time evolution of the probability could also depend on the history of the sample to which it belongs, i.e. the changing rate of the probability should be in uenced by the changing rate in the past. Thus the evolution of the probability p(r;t) has to be supplemented by memory terms. Such a term models, for example the way on which a seed probability at a certain time t⁰ had been accumulated by a delayed transport mechanism, originated by the surrounded environment of the particle. In general, the changing rate of pattine t is also determined by the accumulation rate at a former time t⁰ < t. In between, i.e. within the interval = t t⁰, the particles are enriched while changing the probability at t⁰. Regardless that process the available amount of particles at time t is governed by an instantaneous transport term as well as by the changing rate at former times t⁰. Consequently the conventional di usion

equation should be modi ed according to [25]

This equation is of convolution type. W hereas the operator M daracterizes the instantaneous and local processes, both operators K and L are responsible for the delayed processes. In general the operators M ;K and L m ay be also non-linear in p(r;t) and r p(r;t). They have to be specified according to the physical situation in m ind. In particular we show that the operators are restricted when p(r;t) is assumed to be conserved.

A. Conservation

In this section we specify the model, de ned by Eq. (1), under the assumption that the basic quantity p(r;t) is conserved. This condition is fulled by

To preserve p the instantaneous term M has to be related to a current, e.g. M / r j. Choosing natural boundary conditions, i.e. p = 0 at the boundary, we nd after Laplace transform ation P (t) ! P (z)

with $P_0 = P$ (t = 0). For an arbitrary polynom ialkemelk the conservation law is in general not fulled provided the operator L is simply de ned by L $\ell_t p(\mathbf{r};t)$ (the minus sign is only for convention). Making this ansatz we conclude from Eq. (3)

and consequently the conservation law is guaranteed. Physically, the assumption for L m eans, that we take into account a coupling of the rates, e.g. the evolution at the observation time t is directly coupled to the changing rate at $t^0 < t$. Processes in the past will be permanently "reevaluated" at present time. In doing so the memory kernel gives rise to a coupling of the time scales. In the vicinity of the upper limit t^0 't the memory term reads K [r;0; p(r;0)]Q_tp(r;t), i.e. a instantaneous change at the observation time t is coupled to the

value of p at the initial time t = 0. Therefore, the very past is related to the instantaneous value of p(r;t). In the opposite case, at the lower lim it t^0 / 0, the change of the quantity $p(\mathbf{r};t)$ near to the initial value $\mathcal{Q}_{t^0} p(\mathbf{r};t^0 = 0)$ is directly coupled to the instantaneous value p(r;t) via the kernel. In such a manner the memory part represents a weighted coupling of the behavior at the initial time and the observation time. Due to that coupling of the rates the long-time behavior of the system will be modied. One reason for that could be that the moving particle is embedded into an environment of all the other particles of the system . Due to the mutual interaction, the particle is released after a certain waiting timet t⁰. Especially in su ciently complex di usion-reaction systems the feedback and memory e ects should be relevant. In such system additional degrees of freedom like in exible m acrom olecules in m elts or in concentrated solutions [26], nem atic elastom er [27] or in biology [18]. In that context one is interested in the description of e uent reprocessing plants in system swith closed water circulation. A special ecosystem of aerobic and anaerobic m icroorganism s is evolved in the clari ers of such system s due to natural im m igration or due to additional allow ance. The living conditions of the microorganism s are mutually associated via the exchange of interm ediate catabolic products. Each change of the concentration of one species will be stored in the food chain and e ects the evolution of these species at a later time. Furthermore, the partial mixing in the clari ers by convection and di usion processes enlarges the e ects over the whole system, so that the m em ory integral introduced in Eq. (1) includes both, the time and the spatial coordinates. This special example may be extended also to other com plex biological, chem ical or engineering problem s with various hidden degrees of freedom, which are able to in uence the evolution of a selected component signi cantly, for instance by biological interaction with other species via the food chain or via biological competition. Such e ects which are partially observable, could contribute to the m em ory term .

B. General properties

Starting from Eq. (1) we can make some general statements for an arbitrary kernel K (r_i t; p_i r p) and the specialized term L (r_i t; p_i r p) = $\mathcal{Q}_t p(r_i$ t). As stressed before the last condition guarantees the conservation of $p(r_i$ t). A fter Fourier transformation with respect to the spatial coordinate and Laplace transformation with respect to the time, we get

from Eq. (1)

where K (\tilde{k} ; z) is the Fourier-Laplace transform ed kernel. Eq. (4) describes di usion with a modi ed di usion parameter D ! \hat{D} (r; t). A ssum ing a regular behavior of the kernel let us make the ansatz

Provided the kernel reveals a nite stationary value $\lim_{t \ge 1} K(\tilde{k};t)$ b(\tilde{k}), then p(r;t) yields a stationary solution, too. Inserting Eq. (5) in Eq. (4) we obtain

Sum marizing the results we conclude that the model, following Eq. (1) for the conserved quantity p(r;t), gives rise to a non-trivial stationary solution g(k), or equivalent g(r), if the Laplace transformed kernel K (k;z) satis as the condition

This result is a generalization of a previous one derived for a hom ogeneous system [10].

III. DIFFUSION W ITH TIME INDEPENDENT MEMORY KERNEL

In the following let us regard the evolution equation

As discussed in the previous section the conservation of the quantity $p(\mathbf{r};t)$ is guaranteed for an arbitrary kernel K. D i erent to a conventional evolution equation, in the present one $p(\mathbf{r};t)$ is related to $p(\mathbf{r};t^0)$ with $0 < t^0 < t$. Moreover, Eq. (8) o ers also a coupling between $\mathcal{Q}_{tp}(\mathbf{r};t)$ and $\mathcal{Q}_{t^0}p(\mathbf{r};t^0)$. The mixing of time scales leads, above all, to a substantial modi cation in the long time limit.

A. Spatially localized m em ory

As the simplest example we analyze a strictly spatially local, but time independent kernel

where > 0 is the strength of the m em ory. Note that in our approach spatial and tem poral variables are decoupled. In case of a coupling between space and time variable one m ay observe di erent e ects discussed elsewhere [28]. Inserting this kernel in Eq. (8 we get

Such a memory term leads to a very strong coupling of the instantaneous value to the initial value because all previous time steps are weighted equally. There appears a memory induced feedback to the initial distribution as a driving force. Note that without the coupling to the initial value $p_0(r)$, the particle would perform a discrete motion and the probability density p(r;t) would decay on the time scale ¹. Mathematically the inhom ogeneous linear equation may be solved analytically for arbitrary initial conditions and in any dimension:

From this solution one can verify that a non-negative initial distribution $p_0(\mathbf{r}) = 0$ leads always to $p(\mathbf{r};t) = 0$ provided > 0. Eq. (11) enables us to calculate the second moment s(t). It results

Notice that for ! 0 the last equation shows the conventional di usive behavior. Let us illustrate the behavior in the one dimensional case with the initial condition $p_0(x) = p_0(x)$. The exact solution reads




FIG.1: Stationary solution $p_s(x)$ and p(x;t) in d = 1 with D = 1 and $p_0 = 1$ for di erent strength ofmem ory .

where $\operatorname{erf}(x)$ is the error function and $= \stackrel{p}{=} \overline{-}$. The rst part of Eq. (13) is the solution of the hom ogeneous equation showing a temporal decay with the time constant ¹. For dierent strength of the feedback coupling = 0.5; 1; 3 the solution p(x;t) is presented in Fig. (1). The stronger the feedback strength the more pronounced are the deviations from the pure di usive behavior. In particular, the system develops a non-trivial stationary solution whenever > 0. Such a stationary solution is due the perm anent coupling to the initial distribution. We nd

where $p_s(x)$ is also included into Fig. (1). Notice that in the limiting case ! 1 the stationary solution tends to the initial distribution. Obviously our feedback o ers a kind of shape memory. The stronger the memory is the stronger is the recognition of the initial state.

The result can be generalized to arbitrary dimensions d. For the stationary solution $p_s(r)$ we obtain with r = jr j

The modi ed Bessel function K (x) can be expressed by standard functions for d = 1;3 [29]. In the two dimensional case the modi ed Bessel function o ers a logarithm ic behavior. The evolution equation for p(r;t) is integrable with

The last integral can be calculated exactly for d = 1 with the result given in Eq. (13). A symptotically we obtain

The analytical results are con med by numerical simulations.

B. Gaussian and exponential initial conditions

For an arbitrary initial condition $p_0(\mathbf{r})$ the stationary solution can be directly calculated by solving equation $r^2 p_s(\mathbf{r}) = {}^2 [p_s(\mathbf{r}) \quad p_0(\mathbf{r})] \text{ with } {}^2 = = D$. It results in




FIG.2: Stationary solution $p_s(x)$ and p(x;t) for the Gaussian initial distribution with $D = 1; d = 1; p_0 = 1; = 1$ and di event .




FIG. 3: Stationary solution $p_s(x)$ and p(x;t) for the exponential initial distribution with $D = 1; d = 1; p_0 = 1; = 1$ and di erent .

In this subsection we study di erent realizations of the initial conditions. In case of a Gaussian initial distribution $p_0(r) = p_0 e^{-x^2}$ the results for di erent strength of memory

for both p(x;t) as well as $p_s(x)$ are shown in Fig. (2). When the initial condition is an exponentially decaying function $p_0(\mathbf{r}) = p_0 e^{-j\mathbf{r}j}$, we not solutions presented in Fig. (3). Summarizing this section we have shown, that a simple feedback coupling lead to stable patterns which do not appear under a conventional di usion term.

IV. FADING DIFFUSION

Now we regard as a further realization of Eq. (1) with a conserved p(r;t) a spatially decaying memory term by choosing the kernel in the form

Perform ing Laplace transform ation we get

Inserting that result into Eq. (6) it results a non-trivial stationary solution, compare also Eq. (6),

In the hydrodynam ic lim it κ ! 0 one nds the Fourier transform ed stationary solution

U sing the asymptotic expansion for the modil ed Bessel functions [29], one concludes that the stationary solution on errs a screened C oulom b potential decaying on a length scale 1. Note that the screening length is determined by the memory strength as well as by the characteristic length 1 of the spatial memory. The screening length increases when the memory strength decreases. Let us stress that the non-trivial steady state is originated by the competition between di usion and memory and it is not driven by spatial boundary conditions. In that case there appears an additional length scale, the size of the sam ple L, which gives rise to further e ects not discussed now.

V. CONCLUSIONS

In this paper we have extended the conventional di usive transport by including non-Markovian memory terms within the frame of evolution equations. The additional terms are chosen in such a manner that the relevant variable p(r;t) is normalized. By this requirement the form of the memory term is restricted to a class where the changing rate of p at the observation time t is coupled to the changing rate of p at a form $\operatorname{ertim} e t^0$. Insofar the delay e ect o ers a long tim e m em ory due to 0 t^0 t. Further the model exhibits also a long range m em ory because the kernel K depends on $r = r^0$. Here we have considered several realizations of the memory kernel with dierent behavior. As a new result there occur non-trivial stationary solutions form ing patterns. Such patterns are absent for conventional di usion in an in nite dom ain without boundary conditions. The reason for such a new behavior is by means of the above mentioned coupling of the rates. This time accumulation is further accompanied by an additional spatial accumulation, the e ect of which is comparable to the e ect a long-range interaction forces and consequently the results are basically independent of the spatial dimensions in according to scaling arguments. These m any-body e ects are shown to change the asymptotic behavior drastically. Due to the feedback-coupling of a particle to its environment, a subsequent particle, undergoing a diffusive motion, gains inform ation from a modi ed environment. As the result there appears patterns controlled by the memory strength.
