On the de nition of a unique e ective temperature for non-equilibrium critical systems

Abstract

We consider the problem of the denition of an elective temperature via the long-time limit of the uctuation-dissipation ratio X^1 after a quench from the disordered state to the critical point of an O(N) model with dissipative dynamics. The scaling forms of the response and correlation functions of a generic observable O(t) are derived from the solutions of the corresponding Renormalization Group equations. We show that within the Gaussian approximation all the local observables have the same X^1_0 , allowing for a denition of a unique elective temperature. This is no longer the case when uctuations are taken into account beyond that approximation, as shown by a computation up to the rest order in the expansion for two quadratic observables. This implies that, contrarily to what often conjectured, a unique elective temperature can not be defined for this class of models.

I. IN TRODUCTION

The non-equilibrium dynamics of physical systems is one of the most challenging problem s in statisticalm echanics. Equilibrium statisticalm echanics has been probably one of the m ost important achievem ents during the last century. On the other hand, in nature equilibrium is more an exception rather than a rule. In view of that many e orts are currently aim ing at achieving a coherent theoretical picture of non-equilibrium phenomena: Indeed m any real system's persist out-of-equilibrium practically forever. One example is naturally provided by slow-relaxing systems, such as structural glasses and spin-glasses, whose equilibration times sometimes exceed any reasonable experimental time scale (in fact they can even evolve on the scale of geological eras). The high degree of complexity of such systems m akes the description of their dynamics really awkward, since apparently all the history of a sample has to be known in order to predict its evolution. Conversely, a useful theory should be able to provide a description of the behavior of the system in terms of few and essentiale ective param eters. The e ective tem perature, de ned on the basis of uctuationdissipation relations between correlation and response functions [1], has been proved very fruitful in this direction (at least for mean-eld models) and it is currently under intensive experim ental investigation [2].

To introduce the concept let us consider the following experiment. Prepare a system (e.g., a glass, a ferrom agnet, etc.) in an equilibrium state corresponding to a high temperature T_0 (where \high" m eans, here, greater than any critical or glass transition temperature). At time t = 0, quench the system to some temperature $T < T_0$ by taking it into contact with a therm albath at temperature T, and let it evolve. On a general basis, one expects that the relaxation towards the equilibrium state corresponding to T is characterized by two di erent regimes: (A) a transient one with non-equilibrium evolution, for $t < t_{eq}(T)$, and (B) a stationary regime with equilibrium evolution for $t > t_{eq}(T)$, where $t_{eq}(T)$ is some characteristic equilibration time of the system. During (A) the behavior of the system is expected to depend on the speci c initial conditions and both time-reversal symmetry and time-translation invariance are broken, while they are recovered in regime (B): The dynamics of uctuations is given by the \equilibrium " one. We are concerned here with those systems for which the regime (B) is never achieved during experimental times, i.e., for all practical purposes, $t_{eq} = 1$. In this case, the standard concepts of equilibrium statisticalm echanics do not apply and in particular two-time quantities, such as the response R_{0} (t;s) = $h_{h_{0}}^{0}$ (s) $i_{h_{0}=0}$ and the correlation functions C_{0} (t;s) = h_{0} (t)0 (s)i (0 is some observable and h_0 its conjugated eld, we will be more explicit later on) depend separately on s (usually called the \age" of the system, being the time spent in the phase with $t_{eq} = 1$) and t, even for long times. This behavior is usually referred to as aging [3,4]. Such a useful quantity as the tem perature T of the system is not de ned in this genuine non-equilibrium regim e. On the other hand one can address the question whether some e ective tem perature Te (in general dierent from T) can be still de ned and used to understand the physics of the system.

In equilibrium [regime (B)], correlation and response functions depend only on time dierences and the uctuation-dissipation theorem (FDT) states that

[here and in the following we assume t > s given that causality implies R_0 (t < s;s) = 0] where T is expressed in units $k_B = 1$. W hatever the regime is, one can always de ne the so-called uctuation-dissipation ratio (FDR) as [5]

As a consequence of Eq. (1), X_{\circ} (t;s) = 1 whenever t> s t_{eq} (T). Some sort of excitive temperature [1] in the aging regime $[t_{eq}]$ (T) = 1] can be defined via the long-time limit of X_{\circ} (t;s)

through the relation $T_e^\circ = T = X_0^1$ (that reduces to the therm odynam ic tem perature of the therm albath when equilibrium is asymptotically reached). Obviously this denition has to be regarded as form alas long as one is not able to establish a link between T_e and some therm odynam ic properties. Nevertheless, in Ref. [1] it has been shown that T_e plays the same role as the therm odynam ic tem perature, in the sense that it determ ines the direction of heat lows and acts as a criterion for therm alization. Moreover, a therm on eter coupled to the observable O measures (on a proper time scale) the temperature T_e° [1]. We also mention that it has been argued that X_o (t;s) establishes a bridge between the dynam ically inaccessible equilibrium state and the asymptotic dynam ics for large times [6]. (See also Refs. [7,8] for a discussion of other properties of X_o (t;s) and T_e° .)

It has been stressed several times in the literature (see, e.g., Ref. [9]) that the excive temperature can be of interest in order to devise some them odynamics for the system provided that its value is independent of the observable used to dene it. This has been explicitly verified for in nite-range (mean-eld) glass models [1]. Beyond these cases, the observable dependence of $T_{\rm e}^{\rm O}$ has been investigated analytically for the trap model [10], for the one-dimensional Ising model [11,12], and for the d-dimensional spherical model [13], whereas numerical studies have addressed the problem for supercooled liquids [14] and for the two-dimensional Ising model [11].

In this paper we discuss the problem of the observable independence of the FDR (and consequently of $T_{\rm e}^{\rm O}$) in a sim pler (com pared to glasses) class of slow-relaxing system s: C ritrical systems quenched from a high-tem perature phase to the critical point and evolving according to a purely dissipative dynam ics. In fact, soon after the introduction of the FDR Eq. (2), it was pointed out [15] that also these systems display slow-relaxation (due to $t_{\rm eq}$ $^{\rm z}$, where is the correlation length, diverging at the critical point, and z the dynam ical critical exponent [16]) and aging. The FDR of the order parameter was then determined for a G aussian model and for the random walk. Subsequent analytical and numerical calculations on realistic models con med and generalized this picture [17{42,11{13}} (for a review, see Ref. [43]). For our analysis we can take advantage of the powerful tools of Renormalization G roup (RG) and eld theory to provide analytical predictions for some FDR's in an expansion, where = 4 d and d is the spatial dimensionality of the system. This kind of study allows us to clarify once and for all whether a unique elective temperature can be defined for such systems in the long-time limit.

The outline of the paper is the following. In Sec. II we introduce the model and the eld-theoretical approach to non-equilibrium dynamics. We derive, by means of RG equations, the scaling forms of two quadratic (in the order parameter) observables. In Sec. III we argue that the FDR X_0^1 (and thus T_e^0) does not depend on the special observable 0 within the Gaussian (mean-eld) approximation. The elects of the interaction are taken into account in Sec. IV, where we show by an explicit calculation that the FDR's of two quadratic observables dier already at the lowest order beyond the Gaussian approximation. In Sec. Vour results are carefully compared with the numerical and analytic ones available in the literature. In Sec. VI we summarize the results obtained and their implications. In the Appendix we report the details of the computations of the Feynman diagrams.

II. THE MODEL

One among the simplest non-trivial models displaying slow-relaxation and aging is a lattice spin model in d dimensions with O(N) symmetry and short-range interactions evolving according to a purely dissipative dynamics after a quench to the critical point. In the simplest instance its lattice H am iltonian is given by

where s_i is a N-component spin located at the lattice site i, with $s_i^2=1$. The sum runs over all pairs hiji of nearest-neighbor lattice sites. A purely dissipative dynamics for this model proceeds by elementary moves that amount to random changes in the direction of the spin s_i (spin- ip sampling). The transition rates can be arbitrarily chosen provided that the detailed-balance condition is satistical studies the most suited are the G lauber ones [44], which allow exact solutions in the one-dimensional case [17{19,11,12}].

D espite their sim plicity, these models are not exactly solvable (for arbitrary N) in physical dimensions d=2;3, and to obtain information about the non-equilibrium critical dynamics, one has to resort to numerical simulations [20,21,11,29{33}].

To investigate analytically the dynam ical behavior in physical dimensions, we take advantage of the universality considering the time evolution of a N-component eld ' (x;t) with a purely dissipative dynamics (Model A of Ref. [16]). This is described by the stochastic Langevin equation

where is the kinetic coe cient, (x;t) a zero-mean stochastic Gaussian noise with

and H ['] is the static Ham iltonian. It may be assumed, near the critical point, of the Landau-G inzburg form

where r_0 / T is the temperature parameter, assuming its critical value $r_{0;c}$ for T = T_c ($r_{0;c}$ = 0, within the analytical approach discussed below), and g_0 is the bare coupling constant of the theory. This coarse-grained continuum dynamics is expected to be in the same universality class as the lattice models with O (N) symmetry, short-range interactions, and spin-ip dynamics [16].

The equilibrium correlation and response functions can be obtained by means of the eld-theoretical action [45,46]

Here $\[\] (x;t)$ is a N-component auxiliary eld, conjugated to the external eld h in such a way that H [';h] = H ['] $\] d^dxh'$. As a consequence, the linear response to the eld h of a generic observable O is given by

For this reason \sim (x;t) is term ed response eld.

W ithin this eld-theoretical formalism it is possible to show that the FDT holds for generic R_{\circ} and C_{\circ} . This has an illuminating derivation in a supersymmetric formulation, where the FDT's are the W and identities due to the supersymmetry [45].

The e ect of a macroscopic initial condition $'_0(x) = '(x;t=0)$ may be taken into account by averaging over the initial con guration with a weight $e^{H_0['_0]}$ where [47]

that speci es an initial state a(x) with Gaussian short-range correlations proportional to $_{\scriptscriptstyle 0}^{\scriptscriptstyle 1}$.

Following standard methods [45,46] the response and correlation functions may be obtained by a perturbative expansion of the functional weight $e^{(S \ [' \ ;^{\leftarrow}]+H \ 0 \ [' \ 0])}$ in terms of the coupling constant g_0 . The propagators (G aussian two-point functions of the elds ' and '~) of the resulting theory are [47]

The response function Eq. (11) is the same as in equilibrium. Eq. (12), instead, reduces to the equilibrium form when $q \in 0$ and both timest and sgo to in nity while = t siskept xed. In the following we will assume the Îto prescription (see, e.g., Refs. [48,45]) to deal with the ambiguities arising in form alm anipulations of stochastic equations. Consequently,

all the diagram s with loops of response propagators have to be on itted. This ensures that causality holds in the perturbative expansion [47,48,46]. From the technical point of view, the breaking of time-translation invariance does not allow the factorization of connected correlation functions in terms of one-particle irreducible ones as usually done when time-translation invariance holds. As a consequence, as it is the case when dealing with surface critical phenomena [49], all the computation has to be done in terms of connected functions only [47]. Furthermore it has been shown [47] that $_0^{-1}$ is an irrelevant variable for the RG ow a exting only the correction to the leading long-time scaling behavior we are interested in . In view of that we is it to its its xed-point value $_0^{-1} = 0$ from the very beginning of the calculation .

From scaling arguments [20], and more rigorously from the solution of RG equations [47], it is known that the zero-momentum response and correlation functions of the basic elds satisfy the scaling forms (see Ref. [43] for a review):

where a=(2, z)=z, z is the dynam ical critical exponent, the anomalous dimension of the elds [45], and the initial-slip exponent [47,48]. We single out explicitly the non-universal amplitudes $A_{R,C}$ by xing $F_{R,C}$ (0) = 1. With this normalization $F_{R,C}$ are universal scaling functions. From the previous scaling forms one deduces that

is a universal amplitude-ratio (in the sense of Ref. [50]) being the ratio of two quantities $[R_{q=0}(t;s)]$ and $[R_{q=0}(t;s)]$ that have the same scaling dimensions. Furthermore it is a function of the ratio s=t only, and not of s and t separately. In lattice simulations (especially in the literature concerning glassy systems [7,8]) response and correlation functions are often measured in the real space x, instead of in the momentum space q as done here. From the scaling forms given above one can derive the analogous ones in the real space for R_x , C_x , and then de ne $X_{x=0}$ $R_{x=0}=0$ (originally introduced in Refs. [5,15]) in analogy with $X_{q=0}$. In general one expects $X_{x=0}$ $(X_{q=0})$ Nonetheless it has been argued [25] that the long-time limit of the universal amplitude ratio

¹This is an important dierence compared to mean-eld glassy model, where, instead, it turns out that $X_{x=0}$ in the long-time regime can be written as a function of C (t;s) (see, e.g., Refs. [7,8]).

(the subscript M refers to the fact that $'_{q=0}$ / M , the average magnetization) is equal to the same limit of X $_{x=0}$. This equality was also con rmed by numerical simulations [11] (even if the numerics of Ref. [11] have been questioned [51]).

A . Scaling form s of com posite operators

We now derive scaling forms analogous to Eqs. (14) and (15) for the correlation and response functions of local composite operators, focusing on those of the form $'^m$. However, the derivation is completely general and can be easily applied to any other operators.

Let us consider an observable O (a composite operator, using the eld-theoretical term inology) having h_0 as a conjugate eld (e.g., O is the energy density and h_0 the temperature) and coupling to H according to H 7 H + h_0 O . As a consequence, the dynamical functional S changes according to S 7 S₀ = S + h_0 G, where the associated operator G is given by

where $h_{h_0^{\dagger}}$ stands for the average over the dynam ics associated with the dynam ical functional in the presence of h_0 . This generalizes Eq. (9).

To render nite the correlation functions with insertions of the operator 0, of the form

one additional renorm alization (compared to those necessary when 0 and ${\mathfrak F}$ are not inserted, evaluated in Ref. [46]) is required: $O_B = Z_0 \, O_R$. Here and in the following with the subscript B we indicate the bare quantities and with R the renormalized ones, whose correlation functions are nite upon removing the regularization [45]. In the case of operators mixing under renormalization, O has to be understood as a vector of suitable operators, while Z_0 will be in general a renormalization matrix [45]. where, on the r.h.s., $h._Rim$ eans that all the bare quantities have been replaced by the corresponding renormalized ones. Applying standard techniques it is possible to write the

RG equations by introducing appropriate RG functions [45]. For the theory de ned by S₀, in addition to the RG functions of the theory with action S, one has to introduce two new functions $%_0$ @ $\ln Z_0$ j and $%_{e}$ @ $\ln Z_{e}$ j² (is the scale at which the theory has been renormalized [45]). With j we indicate that the differentiation has to be done with xed bare parameters. In view of Eq. (22), $%_0$ and $%_e$ are related by $%_e = %_0 + (%_{\sim} %_0) = 2$ (where $%_0$ and $%_{\sim}$ are the usual RG functions for the elds). Combining dimensional analysis with the solution of the RG equations one nds that the scaling dimension of the correlation function h[0] f(F) = 1 in the (x;t)-space is given, at the infrared xed point of the theory, by

1.0 verview of the known values of the exponents

For the two speci c cases of the quadratic operators E (t) and T_{ij} (t), the exponent a_0 can be expressed in terms of more familiar critical exponents. In fact we obtained a_0 = (2 $_0$ z)=z, with $_0$ scaling dimension of the operator O . Using Eq. (27) we can express it in terms of the susceptibility exponent, given by 3 (see, e.g., Ref. [52])

where $_{\rm T}$ is the so-called quadratic crossover exponent [45,52]. The exponents $_{\rm E}$ and $_{\rm T}$ are exactly known in d = 2 [45]. Even in d = 3 they are known with very high accuracy, in fact they have been computed up to ve loops in the -expansion [53] and six (sometimes seven) loops in xed dimension d = 3 [54,52] for generic values of N (see Ref. [55] for a review). The dynamic critical exponents are currently known with a much less accuracy. In fact z has been computed up to three loops in the -expansion [56] and up to four in xed dimensions [57], whereas in known only up to two loops in the -expansion [47]. For d > 4 the mean-eld results hold: $a_0 = 1$ d=2 (for both E and T) and = 0.

III. THE GAUSSIAN APPROXIMATION

For the G aussian model the response and correlation functions are known exactly, so we can evaluate the FDR (in Ref. [15] this has been done directly in real space). From Eqs. (11), (12), and the de nition (17), properly generalized to $q \in 0$, one nds [25]

If the theory is non-critical ($r_0 \in 0$) the lim it of this ratio for $s \mid 1$ is 1 for all the values of q, in agreement with the idea that in the high-tem perature phase all the uctuating modes have a nite equilibration time, so that equilibrium is recovered and the FDT applies. In the critical theory the lim it ratio is again equal to one when $q \in 0$, whereas for q = 0 one has $X_{q=0}^0$ (t;s) = 1=2. This shows that the only mode that \does not relax" to the equilibrium is the zero mode in the critical lim it. This picture (already presented in Ref. [25]) has been con med by a one-loop computation [25].

In the case of the G aussian theory, with $g_0=0$ in the H am iltonian (7), the FDR can be easily computed for a generic observable. In particular we show that the FDR for a set of local one-point observables is always equal to 1=2 in the long-time limit. This allows for a de nition of a unique elective temperature in the Gaussian model. We consider operators of the form $O_{i,n}=\mathbb{Q}^{i,n}$. The correlation and response functions of all local operators can be written in terms of those of $O_{i,n}$.

The critical (i.e., $r_0 = 0$) response and correlation functions of the order parameter Eqs. (11) and (12) are given, in real space, by (their diagram matric representation is reported in Fig. 1 (b) and (a), respectively)




FIG. 1. Diagram matic elements: (a) correlation and (b) response functions of the or-(c) Diagram matic representation for the two-point correlation function C_x^0 (t;s) = $M_{0,n}$ (t;x) $O_{0,n}$ (s;0)i and (d) response function R_x^0 (t;s) = $M_{0,n}$ (t;x) $O_{0,n}$ (s;0)i. See the text for further explanations.




FIG. 2. Diagrams contributing to the correlation function. G_1 (t;s) and L_4 (t;s) have also symmetric counterparts that have been considered.

Note that in momentum space, at variance with the relation Eq. (64) holding between FDR in real space, only the long-time lim it of the FDR reproduces the FDR for the elds. This is in agreement with some explicit calculations we made for '2 (see below) and '3 FDR's.

Let us now take into account the e ect of the derivatives. In momentum space they amount sim ply to a multiplication by q^i and so they change the weight in Eq. (69) by a factor q^{2i} (one q^i for each insertion), not a ecting our conclusion on the long-time lim it.

Let us note that if instead we introduce some non-local operators, as e.g. e^{e^2O} (with O a local operator), the weight in Eq. (69) is no longer exponential in q^2 and the long-time lim it of FDR m ay be dierent from 1=2.

IV.TW O-LOOP COMPUTATION

Here we present the details of the two-loop (i.e., up to 0 () in the -expansion) perturbative computation of the correlation and response functions for the zero-momentum energy and the tensor operators given by Eqs. (41) and (42). The one-loop results are the Gaussian ones obtained in the previous section.




FIG. 3. Diagram's contributing to the response function.

The diagram matic contributions are reported in Fig. 2 for the correlation function C° (t;s) and in Fig. 3 for the response function R° (t;s). In Table I we list the symmetry factors of the diagrams (depending both on the global topology and on the external legs) and the corresponding color factors (depending on global topology and the index structure of the vertices).

A coordingly, in contrast to the equilibrium case, no additive renormalization has to be introduced to render nite the energy correlation function. Thus the equilibrium renormalized correlation functions for q = 0 cannot be simply recovered by taking the limit; 1 with t s xed, as usually done for eld correlation functions.

From these results we conclude that the long-time limit of the uctuation-dissipation ratio depends on the particular observable chosen to compute it.

As a nalremark let us comment on the connection between the correlation functions of '2 in Model A dynamics and those of the conserved density "in the associated Model C [16]. In equilibrium dynamics it is usually easier to compute h'2'2i in terms of h""i (see, e.g., Ref. [59]). However, this is no longer possible when studying non-equilibrium dynamics (considered in Ref. [28]) because of the connection between ' and " does not carry over to this case.

V.COMPARISON WITH OTHER RESULTS

A. The spherical model and the N ! 1 lim it

The static critical behavior of the O(N) m odel in the $\lim_{n \to \infty} I(N)$ is known to be equivalent to that of the spherical model, de ned by the Hamiltonian

where s_i are real numbers subjected to the constraint $^P_i s_i^2 = L^d$ (L being the linear dimension of the d-dimensional lattice, assumed for simplicity to be hypercubic), and the sum runs over all nearest-neighbor pairs hiji. Indeed Stanley proved [60] that the free energies of the two models are exactly the same. From this equality it follows that critical exponents, scaling functions etc. are equal. The same equivalence also holds for equilibrium critical dynamics de ned in the spherical model by means of a Langevin equation as Eq. $(5)^7$. As

⁷This equation has to be properly modiled in order to prescribe a dynamics that is compatible with the spherical constraint.

far as we are aware, this equivalence has not yet been carried over to the non-equilibrium critical dynam ics we are interested in. Let us recall that the free energies of the models in the presence of a spatial boundary (whose corresponding eld theory looks very similar to the non-equilibrium one that we are considering) are well known to be not equal [61].

The spherical model has attracted a lot of attentions, since its essential Gaussian Hamiltonian makes it exactly solvable although the resulting critical behavior is not mean-eld like because of the spherical constraint. The FDR of the magnetization was calculated by Godreche and Luck, who obtained $X_{M}^{1} = 1$ 2=d. This result is compatible with the two-loop -expansion [26] for N = 1 and, moreover, it agrees with the exact result we are going to derive. Recently Sollich [13] has determined several FDR's of quadratic (in the spin si) operators that could be compared with our results. He considered the bond energy observable $B_i = \frac{1}{2} (s_i - s_i)^2$, the product observable $P_i = s_i s_j$ (with i; j nearest neighbors) both in the real and in the momentum space, and the total energy. The exact results of his analysis are that $X_P^1 = X_B^1 = X_M^1 \in X_E^1$ (the expansion of X_E^1 close to four dimensions for d < 4 nicely agrees with our two-loop -expansion for N = 1). The scaling forms for these observables have been also derived and they agree with our equations (31) and (30) with $a_B = 1$ d=2, a = 1 d=2, and $a_E = d=2$ 3 in d < 4 (and $a_E = a_P = a_B + 2 = 1$ d=2 in d > 4). A ll these ndings agree with our calculation apart from the fact that the observable P of the spherical model cannot be naively identied with \prime 2 for N = 1 . On the other 2 agrees with the naive identication of B as the Laplacian of P in the continuum lim it.

We report now the calculation of som eFDR's for the O (N) model directly for N = 1, using the well-known property that for N = 1 the fourth order interaction term can be self-consistently decoupled g=N ('²)²! $gC_{x=0}(t)'²$ (here g_0 is replaced by g=N) [45]. Taking advantage of this decoupling the exact response function of the theory (for 2 < d < 4) has been computed [47], nding:

Now we consider, in the lim it N $\,!\,$ 1 , the scaling functions (45) and (46) of the response and the correlation of the quadratic operators. The explicit computation for 2 < d < 4 of the scaling functions, the non-universal amplitudes, and, eventually, the FDR of composite operators is not as straightforward as one could have erroneously expected. In fact, if one roughly assumes, on the sole basis of the decoupling in the large-N $\,$ lim it, that the theory




FIG. 4. Chains of bubble diagrams for the (a) correlation and (b) response function of quadratic observables. For the correlation (a), the index k runs between 1 and n.

is essentially G aussian with renormalized two-point functions given by Eqs. (86) and (87), the result $X_0^1 = X_M^1$ would follow from the argument we gave for the Gaussian M odel, that makes no use of the special correlations of the response and correlation functions.

Let us consider more closely the case of the energy E . For the two-point function hE (t)E (s)i, a family of diagram s (chains of bubble diagram s, see Fig. 4) that are of order 0 (N 0) even in the limit N ! 1 exists (although the coupling constant is of order 1=N , each bubble carries a combinatorical factor N). These diagram s are not accounted for by a simple renormalization of the two-point functions of the order parameter. This fact is well known for static observables (see, e.g., the calculation of the structure factors h' 2 (q)' 2 (q)i up to four loops in Ref. [52]). If and only if the contribution of such diagram s to X 1 vanishes (or is cancelled out) one has X 1 . The results of the previous sections indicate that this is not the case.

Note that if one considers instead of E the operator T then the chains of bubble diagram s are depressed by a combinatorical factor of order 1=N and so they do not contribute to the correlation and response functions for N = 1 . On this sole basis one concludes that in the lim it N = 1 , $X_T^1 = X_M^1$ to all order in and not only at the rst one as we have explicitly obtained (compare Eq. (83) with Eq. (84) considering the lim it N ! 1).

This analysis indicates that the observable P in the sphericalm odelhas a scaling behavior (and X 1) that is the same as that of T , contrarily to the naive expectation, suggesting instead E .

Finally let us mention that for all the quantities we considered here, the non-equilibrium dynamics of the spherical and O (1) models are exactly the same. This fact calls for a more rigorous investigation of a possible correspondence between the two models beyond the case of equilibrium dynamics.




FIG. 5. X $_0^1$ for O = M ;E;T and N = 1,2,3, and 1 . For X $_M^1$ we report the two-loop result [26]. For X $_E^1$ we report the direct estimate and those obtained by constraining at the lower critical dimensions (with linear constraint for N = 1;2;3;1 and with quadratic one for N = 2;3;1). For X $_T^1$ only the direct estimate is reported. For N = 1 we also report as \E exact" the exact result for the sphericalmodel, from Ref. [13].

B. The Ising model

Apart from the spherical model, the FDR of composite operators has been considered so far only for the one—and two-dimensional Ising models, analytically [11,12] and numerically [11].

In one dimension the several FDR's considered [11,12] turned out to equal $X_{\rm M}^{\,1}=1=2$, apart from that of the energy: $X_{\rm E}^{\,1}=0$. This fact has been interpreted in Ref. [11] as an interplay between criticality and coarsening, a peculiarity of those models (such as the one-dimensional Ising model) with $T_{\rm C}=0$. Instead, our result indicates that $X_{\rm E}^{\,1}< X_{\rm M}^{\,1}$ is a more general property, rigorously true close to four dimensions (1) and perhaps valid up to = 3.

In two dimensions, the numerical results $X_M^1 = 0.340(5)$ $X_E^1 = 0.33(2)$ apparently

indicate the equality of the two FDR's [11]. Obviously our result calls for a more precise determ ination of $X_E^1 = 0.33$ (2) to understand whether this apparent equality is due to the relatively low precision of such a measure or to the fact that d=2 is a peculiar case for some still unknown reasons. In any case, let us stress that X_E^1 from the O () result for = 2 gives a value much smaller than X_M^1 . The direct estimate (unconstrained [u]) from the two-loop series in Eq. (83) for = 2 (giving X_E^1 [u] 0.28) is probably unreliable as it was the case for X_M^1 . (X_M^1 [lloop] 0.42 [25] whereas X_M^1 [2loop]= 0.30 (5) [26].) To obtain a more reliable result (without computing the O (²) term, that seems to be a very dicult calculation, requiring the evaluation of three-loop diagrams) one can constrain linearly [1] the O () result to assume the exactly known value for d = 1 (i.e., = 3), as usually done for this kind of expression (see, e.g., Ref. [55]). A ssuming a smooth behavior in up to = 3, one can write

that has the same —expansion as Eq. (83), but it is expected to converge m ore rapidly to the correct result. From Eq. (89) we get for the two-dimensional Ising model X_E^1 [1] 0.20, that is much lower than the value that has been determined so far X_M^1 0.33 [26,29,11,30,32]. However, we stress that a robust eld-theoretical prediction for X_E^1 for the two-dimensional Ising model requires a (dicult) higher-loop computation. For the three-dimensional Ising model we obtain X_E^1 [1] 0.37, to be compared with the direct estimate X_E^1 [1] 0.39. Note that, as usual in d=3, the spreading of the dierent estimates is much smaller, signaling a higher reliability of these predictions. (We recall that, in three dimensions, the eld-theoretical estimate for the FDR of the magnetization is X_M^1 [2loop] = 0.429(6) [26].)

In Fig. 5 we report Eq. (89) for 0 < < 3 compared with the direct estimate Eq. (83) and with the two-loop FDR of the magnetization [26].

Eq. (83) allows us to provide predictions for the O (N) models with arbitrary N. So far the non-equilibrium dynamics of models with continuous symmetry (N > 1) has been numerically studied only for the XY (N = 2) model, both in d = 2 [21,31] and d = 3 [33]. The value that has been determined in d = 3, i.e., $X_{\rm M}^{\,1} = 0.43$ (4) [33] is in good agreement with the two-loop eld-theoretical prediction $X_{\rm M}^{\,1} = 0.416$ (8) [26]. The observable dependence of $X_{\rm O}^{\,1}$ has not yet been addressed in these cases.

To obtain an estimate of $X_{E;T}^1$ for the three-dimensional O(N) model we again constrain the -expansion at the lower-critical dimension $(d_{ext} = 2 \text{ in this case})$. We assume X_E^1 (d = 2) = 0 for N 2. This surely holds for N > 2, since for d = 2 these systems are in the coarsening regime. Such an assumption is instead questionable for N = 2, where it is known that a nite-temperature phase transition of topological nature takes place at $T_{K,T}$. A linear constraint would lead to

On the other hand the exact results for the spherical m odel [13] suggest that the approach to d=2 is quadratic rather than linear, so it is tempting to implement a quadratic constraint also for nite N

In Fig. 5, we report Eqs. (90) and (91) for 0 < 2 and N = 2;3;1. It is apparent that for N = 1 the approximation obtained implementing the quadratic constraint reproduces better the result for the spherical model. For the three-dimensional XY model (N = 2) we get X_E^1 '0:37 from direct estimate (no constraint, [u]), X_E^1 '0:31 from linear constraint [l], and X_E^1 '0:22 from the quadratic one [q]. For the three-dimensional Heisenberg model (N = 3) we not, instead, X_E^1 [u]'0:35, X_E^1 [l]'0:30, and X_E^1 [q]'0:21.

Even the results with constraints are rather scattered, making very dicult to provide robust estimates in d=3. However, we can surely conclude that $X_E^1 < X_M^1$ for all 2 < d < 4 and that their dierence should be large enough to be observed in M onte C arlo simulations in three dimensions. The analysis of the non-equilibrium behavior within the $\sim = d$ expansion [45] may clarify which, between the linear and the quadratic constraint, is the proper one close to d=2, even if the results for the spherical model strongly suggest the latter.

For X_{T}^{1} we note that it is very close to X_{M}^{1} , even for 1 (see Fig. 5), making the numerical detection of such a dierence probably very dicult.

VI.CONCLUSIONS

In this paper we considered the problem of the de nition of a unique e ective tem-perature via the long-time lim it of the uctuation-dissipation relation for critical systems quenched from a high-tem perature phase to the critical point and evolving according to a purely dissipative dynam ics. W ithin the eld-theoretical approach to non-equilibrium critical dynam ics and by means of appropriate RG equations, we obtained the general scaling forms for the response and correlation functions of a generic local observable O (t), from which it is possible to derive the FDR $X_{\rm O}$ (t;s).

We found that in the Gaussian approximation all the local operators have $X_0^1=1=2$, allowing for a denition of a unique elective temperature. This equality is broken already at the rst order in the expansion for the quadratic operators we considered (namely the total energy and the tensor, see Eqs. (41) and (42)). Let us point out that our results go further than those obtained for the one-dimensional Ising model [11,12] and for the spherical model [13]. In these cases $X_0^1=X_M^1$ for all the observables 0, except for the total energy. This operator is conjugated to the temperature of the bath but not to the actual one (if any) of the system. On this basis one could doubt that the energy operator is not as suited as others to dene the elective temperature, resulting in a different X_M^1 . Nevertheless we not that there is at least one further operator, namely X_{ij}^1 , having $X_{ij}^1 \in X_M^1$; $X_{ij}^1 = X_{ij}^1 = X_{ij}$

Our results for N ! 1 are always in agreement with the recent ones for the spherical model [13], calling for a proof of a possible correspondence (or for a counterexample). They instead disagree (at qualitative level) with the available numerical simulation of the Ising model [11] apparently giving $X_E^1 = X_M^1$. Probably a more accurate measure of X_E^1 is required to detect the dierence (if any) between X_E^1 and X_M^1 . We also provided theoretical predictions for the O (N) model for arbitrary N in 2 < d < 4. It should be possible to check them quantitatively in d = 3, where the expansion is expected to be more accurate. This calls for numerical simulations or real experiments in three-dimensional systems.

Let us nally comment that it would be interesting to understand how the standard scenario of e ective temperature [1,62,7] can be generalized to the case when each sector of a theory has a dierent $T_{\rm e}^{\,0}$, as our results indicate to be the case for critical systems beyond the mean-eld approximation.
