Quantum phase transition in a m in im alm odel for the K ondo e ect in a Josephson junction

We propose a minim alm odel for the Josephson current through a quantum dot in a K ondo regime. We start with the model that consists of an Anderson impurity connected to two superconducting (SC) leads with the gaps = j jeⁱ, where = L; R for the lead at left and right. We show that, when one of the SC gaps is much larger than the others $j_{L}j_{R}j_{R}$ the starting m odel can be m apped exactly onto the single-channelm odel, which consists of the right lead of $_{\rm R}$ and the Anderson in purity with an extra onsite SC gap of $_{\rm d}$ те^г. Here $_{\rm L}$ and $_{\rm L}$ are de ned with respect to the starting model, and $_{\rm L}$ is the level width due to the coupling with the left lead. Based on this simpli ed model, we study the ground-state properties for the asymmetric gap, j $_{\rm L}$ j $_{\rm R}$ j using the numerical renormalization group (NRG) method. The results show that the phase di erence of the SC gaps R L, which induces the Josephson current, disturbs the screening of the local moment to destabilize the singlet ground state typical of the K ondo system . It can also drive the quantum phase transition to a magnetic doublet ground state, and at the critical point the Josephson current shows a discontinuous change. The asym m etry of the two SC gaps causes a re-entrant m agnetic phase, in which the in-gap bound state lies close to the Ferm i level.

1. Introduction

The Kondo e ect in superconducting (SC) materials was originally studied for dilute magnetic alloys.¹⁽³⁾ In norm alm etals, the ground state of the magnetic im purity is known to be a spin singlet, as a result of the antiferrom agnetic coupling with the conduction electrons.⁴⁾ However, in the presence of the SC long-range order, the energy gap of the host m aterial disturbs the conduction electron screening of the local m om ent of the m agnetic in purities. It was shown in early years that whether the local moment is screened or not is determined by the ratio of the K ondo tem perature T_K to the SC gap The ground state becom es a doublet for T_{κ} , but it is still a singlet for $T_{\mbox{\scriptsize K}}$. In contrast to the norm al metals, for which the magnetic solution of the mean-eld theory⁵⁾ does not describe the correct ground state, in the superconducting case the bound state appearing in the energy gap causes the occurrence of a quantum phase transition to a magnetic doublet ground state.

These aspects of the K ondo physics in superconductors have been re-exam ined precisely by e cient num ericalm ethods such as the quantum M onte C arbo $(Q M C)^{6}$ and W ilson num erical renorm alization group (NRG) approaches.⁷⁽¹⁰⁾ Furtherm ore, it has also been reconsidered for novel systems such as quantum dots.^{11,12)} O ne of the new features in the quantum dot coupled to two SC leads is that the ground-state properties of the system can be controlled by the phase di erence of the two SC gaps . It induces the Josephson current ow ing through the dot, and at the same time it a ects the screening of the localm om ent. W hen the localm om ent rem ains unscreened, the spin- ip tunnelling through the m agnetic in purity causes a current owing in the opposite direction to that in the case of the norm al junctions. An explanation has been given based on the low est-order perturbation theory with respect to the spin- ip tunnelling Ham iltonian or equivalently treating the magnetic mom ent to be a classical spin.¹³⁽¹⁵⁾ However, in the Kondo regime, the quantum -mechanical nature of the moment is essential to the screening. Therefore, in order to clarify how the Josephson current and the dynam ics of the m om ent a ect each other, the higher order term s in the tunnelling matrix element must be taken into account.So far, several studies have been carried out using the noncrossing approximation $(NCA)_{I}^{16,17}$ slave-boson meaneld (SBMF) theory^{18,19)} perturbation theory in U_{r}^{20} QMC,²¹⁾ and NRG.²²⁾ Rozhkov and A rovas com pared the ground-state energy for = 0 and = to discuss the phase transition from the 0 to phase.¹⁸⁾ C lerk and Am begaoka pointed out that this transition can be explained in terms of the bound state appearing in the SC gap $_{1}^{(17)}$ as in the case of the magnetic impurity in the bulk superconductors.¹⁽³⁾ So far, mainly one special case, in which the absolute value of the two SC gaps are the same $j_L j = j_R j$ and the couplings to the two leads are equal L = R, has been examined.^{16(20,22)} However, the asymmetry in the two gaps j $_{\rm L}$ j $_{\rm R}$ j $_{\rm R}$ j and that in the mixing parameters $_{\rm L}$ ϵ $_{\rm R}$ a ect sensitively the SC proximity e ects on the impurity site. The superconducting correlations penetrating from the two leads determ ine the e ective eld that is coupled directly to the impurity. Therefore, the asymmetries in the gaps and in the mixing matrix elements, as well as the phase di erence, will also a ect the bound state and

low-tem perature properties of the impurity.

The purpose of this work is to study the interplay of the Josephson current and the dynamics of the localmoment. To this end, we start with the Anderson in purity that is connected to two SC leads. A lthough it is already a simpli ed model, it still contains a number of param eters. In the present paper we mainly consider the asymmetric gap of $j_L j_R j_R$ where one of the SC gaps is much larger than the others. We show that in the limit of $j_{L}j!$ 1 the starting model can be mapped onto a single-channel model, in which the left lead is chopped o leaving an extra onsite SC gap of L e^{i L} at the impurity site. This single-channel m odel possesses both the Josephson and K ondo aspects since the phase di erence can be de ned with respect to $_{\rm d}$ and $_{\rm R}$, and the simplication gives us a great advantage in carrying out num erical calculations. Based on this single-channel model, we exam ine the ground-state properties for $j_L j_R$ jusing the NRG m ethod. The phase diagram of the ground state is calculated for a wide parameter range of the Coulom b interaction U and the mixing strength $_{\rm R}$. The results show that the phase di erence tends to make the stability of the singlet ground state worse, and it can hold a casting vote to determ ine whether the ground state is a singlet or doublet when the other parameters are competing. Speci cally, at ' , $_{\rm L}$ ' $_{\rm R}$, and near half-lling, the bound state lies close to the Ferm i level, and it causes a re-entrant behavior of the magnetic doublet ground state.

In x2, the starting m odel and the m apping onto the single-channel m odel are described. In x3, the bound state in the noninteracting case is discussed brie y. In x4 the results of NRG calculations are presented. Sum m ary is given in x5. In Appendix, the perturbation theory for a zero-energy bound state and other related m atters are provided.

2. M apping onto a single-channel M odel

In this section we introduce the single-channelm odel, which captures the essence of both the Josephson and K ondo physics, starting from the model consisting of a single in purity and two SC leads.

The H am iltonian of the Anderson impurity connected to two superconducting leads, at left (L) and right (R), is given by

where H_d^0 and H_d^U represent the impurity part, and = L; R is the label assigned for the SC leads. The explicit form of each part is given by

The operator d_P^y creates an electron with spin at the dot, and $n_d = d^y d$. Similarly, c_k^y creates a conduction electron in the lead at , and k and are the energy and SC gap for the electrons in the lead, respectively. The tunnelling H am iltonian H_d^T connects the dot at the center and lead at . At the interface the local operator of the conduction electrons is de ned by $c = k c_k = N$. Correspondingly, the current ow-ing into the dot from the left lead J_L , and the current ow ing out to the right lead J_k , are given by

Note that we are using units $\sim = 1$ unless otherwise noted.

To discuss the superconducting properties, we use 2 - 2 m atrix G reen's function of the N am bu form ulation,

where $E_d = _d + U = 2$, and $_i$ for i = 1;2;3 is the Pauli M atrix, and $(i!_n)$ is the self-energy due to H_d^U . A lso, the G reen's function for the bulk superconductor is given by fg $_k(i!_n)g^1 = i!_n1 _k _3$. The interface G reen's function which enters in Eq. (8) is de ned by g $(i!_n) _k g_k(i!_n) = N$, and can be written as

where = j jeⁱ . When the phase di erence $_{R}$ $_{L}$ is nite, the Josephson current ow sthrough the in purity.Furtherm ore, due to the hybridization with the electrons in the SC leads, the superconducting correlation $_{d}$ $h_{R}^{1}d_{*}i$, which corresponds to the o -diagonal element of G $_{dd}$, evolves at the in purity site.

In the noninteracting case, H $_{\rm d}^{\rm U}$ = 0, the impurity G reen's function is given by

where = 1=T, and $hJ_L i^0 = hJ_R i^0$. The Coulomb interaction U disturbs the SC correlation to penetrate into the inpurity. This tendency can be seen already in an approximation of the Hartree-Fock level, through an anomalous contribution^{2,9)}

and has a di erent sign from that of the attractive interaction which drives the leads superconducting states. However, to study precisely the elects of the Coulomb interaction on the Josephson current and on the SC correlations at the impurity, the higher-order term s beyond the mean-eld theory should be taken into account. To carry out nonperturbative calculations, the present version of Anderson in purity already contains a number of parameters compared to that in the normal leads, i.e., we have j jand in addition to , d and U. Therefore, it seems to be meaningful to exam ine some special cases, at which the model can be simplified without losing the essence of Josephson and K ondo physics. In the following, we consider some such special cases.

2.1 ModelI:j_j=j_Rj

O ne of the cases that has been studied by a number of authors so far is $j_L j = j_R j($), where the absolute value of the two gaps are equal. Physically, it means that the two leads are made of the same SC material. In this case the noninteracting G reen's function can be written in the form

and thus we have only one characteristic energy scale for the superconductivity, i.e., . However, in this case the two-channel nature of the system is still preserved for nite . This feature can be seen in the functional form of $G_{dd}^{0}(i!_{n})$ in Eq. (16). It becomes equivalent to that of a single-channelm odelonly for $e^{i_{R}} = e^{i_{L}}$, when the amplitude of e coincides with , i.e., $e^{2} = {}^{2}1$. Therefore, in the case of $j_{L}j = j_{R}j$ both of the superconductors must be taken into account explicitly to investigate the Josephson elect.

2.2 ModelII:j_Lj j_Rj

The situation is dimension of the gaps is much larger than the other's, j $_{\rm L}$ j $_{\rm R}$ j. Speci cally, in the limit of j $_{\rm L}$ j! 1, the noninteracting G reen's function G $_{\rm dd}^{0}$ (i! n) can be written as

where the phase of $_{\rm L}$ is chosen to be $_{\rm L} = 0.0$ ne notable feature is that the third term in the right-hand side of Eq. (18) can be regarded as a static superconducting (19pp induced at the in purity site, and its value is given by $_{\rm L}$. This term comes from the mixing self-energy due the left lead $v_{\rm L}^2$ $_{3}g_{\rm L}$ (i!_n) $_{3}$, and in the limit of j $_{\rm L}$ j! 1 the o -diagonal SC correlation remains nite to penetrate into the in purity site while the diagonal dam ping part corresponding to the level width vanishes. Therefore, in the case of j $_{\rm L}$ j $_{\rm R}$ j the information about the left lead can be included through the o -diagonal $_{\rm L}$ 1 term of the im purity G reen's function, which can also be described by an e ective single-channel H am iltonian with an extra SC gap at the im purity site $_{\rm d}$ $_{\rm L}$,

The phase di erence de ned with respect to the starting model is described by the phase di erence between $_{\rm R}$ and $_{\rm d}$. Using the elective H am iltonian $\rm H_{e}$, one can calculate the expectation values such as the Josephson current hJ_R i and the G reen's function G_{dd} (i! n) for the interacting electrons, which coincide with that of the starting model in the limit of j L j! 1. The mapping introduced here is exact. It can be con med, for instance, using the path integral form ulation: the same e ective action for the impurity can be derived from both H and H_e after carrying out the integration over the conduction-electron degrees of freedom [see Appendix A]. The single-channel H am iltonian H_e can be regarded as a minim almodel that possesses both the Josephson and K ondo aspects of the system. This simpli cation gives us a great advantage in carrying out num erical calculations. Particularly, the NRG approach works excellently for single-channel system s, while the num erical accuracy becom es rather worse for multi-channel system s because the number of the low -lying states that should be retained in the calculation increases with the num ber of the channels. Therefore, in the present study, we mainly consider the asymmetric SC gap of j _ j _ j _ j _ r j




Fig. 1. Phase diagram of the ground state for =, $_{L} = _{R}$ (), and $E_{d} = 0$. Here j $_{L}$ j is chosen to be j $_{L}$ j j $_{R}$ j. An in nitesimalU lifts the 4-fold degeneracy caused by the zero mode to stabilize the singlet or doublet state depending on the value of j $_{R}$ j j $_{L}$ j and 1=. The results are obtained with the perturbation theory in Appendix D.

using the single-channel H am iltonian Eq. (19).

3. Bound state in the gap

The bound state appearing in the SC gap plays an important role on the ground-state properties of dilute m agnetic alloys.¹⁽³⁾ In the case of the quantum dots, the Josephson phase = $_{\rm R}$ _L also changes the energy and w avefunction of the bound state,¹⁷⁾ and it also a ects the screening of the localm om ent. To make these features of the dependence of the bound state clear, we discuss brie y about the bound state in the noninteracting case [see also Appendix B].

The bound state can exist in the gap region $j j < m in (j_L j; j_R j)$, and the eigenvalue is determined by the equation det G_{dd}^0 ()¹ = 0. For noninteracting electrons the determinant can be written explicitly as,

Here $F_1(^2)$ is a simple decreasing function of ², while the functional form of $F_2(^2)$ depends on the parameters $j_L j j_R j$ and . However, at = 0, it is given simply by $F_2(0) = {}_{L R} \cos 3$. Therefore $F_1(0) = {}_{R} 2(0)$, and the equality holds for = , ${}_{L} = {}_{R}$ and $E_d = 0$. We consider this particular case in the following, and then discuss brie y the bound state for the models mentioned in x2.

3.1 Zero mode for = , $_{\rm R}$ = $_{\rm L}$ and $E_{\rm d}$ = 0

We consider here the special case where the three conditions hold simultaneously; i) -junction = , ii) equal coupling $_{\rm L} = _{\rm R}$ (), and electron-hole symm etry $E_{\rm d} = 0$. In this case F_2 (²) is a increasing function of ², and at = 0 it coincides with F_1 (0), so that the bound state comes just on the Ferm ienergy = 0.

Thus, the ground state has 4-fold degeneracy with respect to the occupation of the zero-energy bound state by the B ogoliubov quasiparticles [see also Appendix C]. The C oulom b interaction H_d^U lifts the degeneracy. We have calculated the energy shift for an in nitesim alpositive U using the perturbation theory, the outline of which is given in Appendix D. The ground state is a singlet for $>_{cr}$, while it is a doublet for $<_{cr}$. The critical value $_{cr}$ depends on the ratio x $j_R \neq j_L$ jas shown in Fig. 1. In this gure the phase boundary is plotted in the x vs 1= plane choosing j_L jto be $j_L j = j_R j$ where the energy is scaled by $j_R j$. The critical value

cr increases with x and diverges exponentially at x = 1, and thus for $j_L j = j_R$ jthe ground state is a doublet independent of the value of . This is because in this particular case the SC correlation penetrates from the left lead and that from the right canceleach other out to m ake the net SC correlation at the in purity site 0_d to be zero. This example shows that the asym m etry in the two gaps $j_L j \notin j_R ja$ ects the screening of the m om ent crucially when the other param eters are set to be highly sym m etric. N ote that in the perturbation theory an exchange integral (Fock term) of the form Eq. (12) shifts the bound state from the Ferm i level and favors the singlet state, whereas a direct type contribution (H artree term) favors the doublet state.

3.2 Bound state for Models I $\&~ \mbox{II}$

W hen the absolute value of the two gaps are the same, j $_{\rm L}$ j= j $_{\rm R}$ j $_{\rm L}$, Eq. (23) simpli es as

Since this is an increasing function of 2 which diverges positively at 2 ! 2 , the bound state exists for any nite .

For the other m odel with the asymmetric gap j $_{\rm L}$ j j $_{\rm R}$ j the function F₂ (²) is given by

where d_{L} . In this case the behavior of $F_2(^2)$ at $^2 ! j_R f$ 2 depends crucially on the sign of the numerator, and thus whether or not the bound state exists depends on the values of the parameters.

4. NRG approach

In the rest of this paper we discuss the ground state properties of the Anderson impurity in the limit of $j_L j_J = j_R j$, where one of the SC gaps is much larger than that of the others, based on the single-channel model given by Eq. (19). As mentioned in x22, this model contains essential aspects of both the Josephson and K ondo e ects. A lso, the reduction in the num ber of the channels gives us a practical advantage in the NRG

4.1 Method

Through a standard procedure of the logarithm ic discretization,²³⁾ the conduction band can be modelled by a linear chain with the complex pair potential $_{\rm R}$ = j $_{\rm R}$ jeⁱ, and a sequence of the NRG Ham iltonian H $_{\rm N}$ is given by

Here D is the half-width of the conduction band, and f_n is an operator for electrons in the right lead. The hopping matrix elements $_n$ and \mathbf{e}_R are de ned by

where A ! 1, in the continuum limit ! $1^{23,24}$. The low-lying energy states of H $_{\rm e}$ can be deduced from that of $^{\rm (N-1)=2}$ H $_{\rm N}$ for large N . In the presence of the complex SC gap H $_{\rm N}$ does not conserve the charge, and the total spin S is the only one quantum num ber that can be used for the block diagonalization. In the two special cases, = 0 and , the H am iltonian H $_{\rm N}$ has an extra U (1) symmetry corresponding to the x-th component of the axial charge I $_{\rm X} = {P \atop n=1}^{N}$ (1)⁵ ($f_{n}^{\rm Y}$, $f_{n\#}^{\rm Y} + f_{n\#}f_{n"}$)=2 with $f_{1}^{\rm Y}$ d',²³⁾ and the SC lead can be transformed into a norm al lead with a staggered potential.⁷⁾


The ground-state average of the Josephson current can be obtained using the discretized version of Eq. (6),

where j $_{\rm N}$ i is the ground state of H $_{\rm N}$. The expectation value can be calculated successively for large N using the recursive relation among the matrix elements hJi_N and hJi_{N+1}. We have carried out the calculations retaining the lowest 500 states and taking and j $_{\rm R}$ jto be = 2:0 and j $_{\rm R}$ j=D = 1:0 10^5 . In the following, we use j $_{\rm R}$ j as the unit of the energy in most of the gures, since that is a typical energy scale for the superconductivity.

In this subsection we show the results obtained in the electron-hole symmetric case, d = U=2.W e rst of all consider the ground state for d = 0. Since the value of d is de ned to be equal to L in the original twochannelm odelEq. (1), the condition d = 0 m eans that the left superconductor is disconnected completely from the impurity. In Fig. 2, the phase diagram of the ground ground state is a spin-singlet state for large $_{\rm R}$ or small U, and it is a doublet for small $_{\rm R}$ or large U.W e note that this particular case, d = 0, has been exam ined by Yoshioka and O hashi,⁹⁾ and the phase boundary is determ ined basically by a single parameter $T_K = j_R j$ in the K ondo regim e.N evertheless, for sm allU or the electronhole asymmetric case, in which the contributions of the charge excitations still rem ain, the low-energy properties are characterized not only by the single parameter $T_{\ensuremath{K}}$, but the W ilson ratio R and the renormalized in purity level ed are necessary for a complete description.^{4,25)} Therefore, in order to see an overall picture of the ground-state properties, the phase diagram s which are plotted as a function of the bare parameters, as Fig. 2, are convenient.




Fig. 3. Phase diagram of the ground state for the equal coupling $_{\rm L}$ = $_{\rm R}$ at half-lling $_{\rm d}$ = U=2 is plotted for several values of the Josephson phase . Here $_{\rm d}$ ($_{\rm L}$) is taken to be equal to $_{\rm R}$. For = and U = 0, the phase boundary is given by $_{\rm cr}$ = 1:77064j $_{\rm R}$ j. This special behavior at = is caused by the zero mode, and an in nitesimal U stabilizes the singlet (doublet) ground state for $_{\rm R}$ > $_{\rm cr}$ ($_{\rm R}$ < $_{\rm cr}$).

When the SC gap of the impurity $_{d}$ ($_{L}$) becomes nite owing to the coupling with the left lead of $j_{L}j!$ 1, the phase di erence can be introduced at the interface of $_{d}$ and $_{R}$. We now examine how a ects the ground state in the equal-coupling case $_{L} = _{R}$. In Fig. 3 the phase diagram of the ground state is plotted as a function of U and $_{R}$ for several value of the phase di erence = 0; =2; 3 =4;. Here $_{d}$ is varied simultaneously with $_{R}$ keeping the relation $_{d} = _{R}$. We see that tends to disturb the screening of the local moment and enlarges the doublet phase in the gure. The feature of the phase diagram at $\frac{6}{5}$ is similar to that for $_{d} = 0$ in Fig. 2. However, the feature

ture is quite di erent for = . This is caused by the bound state lying just on the Ferm i level at U = 0. An in nitesim al U lifts the degeneracy to stabilize the singlet state at $_{\rm R}$ > $_{\rm cr}$, and doublet state at $_{\rm R}$ < $_{\rm cr}$. In the present model, $_{\rm L}$! 1, the critical value is given by $_{\rm cr}$ = 1:77064j $_{\rm R}$ jas described in Appendix D. For this reason, in Fig.3 the phase boundary for = starts from the nite value, $_{\rm cr}$, in the y axis.




Fig. 4. Low -lying energy levels of $(\mathbb{N}^{-1})^{=2}H_{\mathbb{N}}$ as a function of N, where the energy is scaled by j_R j and is measured from the ground-state energy at each N. The solid and open symbols are the levels for even and odd N, respectively. Only the low est eigenvalue in each subspace labeled by the quantum numbers (I_x, 2S) are shown, where I_x is the U (1)-axial charge and S is the total spin. The parameters are taken to be = , d = j_Rj_R = 1.5j_Rj_d = U=2, and = 2:0. At large N, the levels approach to the xed point values showing no even-odd dependence on N. For N & 32, the ground state is a singlet in (a) U = j_R j, while it is a doublet in (b) U = 9j_R j.

To see how the singlet or doublet ground states evolves in the successive NRG steps, in Fig. 4 the low -lying energy levels of $(N \ 1)=2$ H_N is plotted as a function of N for (a) $U = j_R j_a$ and (b) $U = 9.0 j_R j_B H$ ere the fac- $^{(\!N \ 1)=2}$ restores the original energy scale of H $_{e}$, tor and the ground-state energy is subtracted from the eigenvalue for the excited states. The param eters are taken to and $R = 1.5 j_R j$. Speci cally, the SC gap be = in the impurity site is chosen to be $d = j_R j_R$ so that the couplings are asymmetric $_{\rm L}$ ϵ $_{\rm R}$ in this parameter set. In the gure the eigenstates are labeled by the two quantum numbers $(I_x, 2S)$, where I_x is the U (1)-axial charge mentioned in the above and S is the total spin. The solid and open symbols correspond to the levels for even and odd N, respectively. For large N, the excitation energies converge to the xed point values, and have no even-odd oscillatory dependence on N, which is a typical behavior seen in the presence of the energy gap.⁷⁾ The ground state is a singlet for N & 32 in (a), while it is a doublet in the case of (b). In the gures all the low -lying levels are shown for $E < j_R j$ but not all are shown for E > j_R j. The levels below the gap j_R j can be classi ed according to the occupation of the bound state with the Bogoliubov quasiparticles, which can be inferred from the value of Ix because it is transformed into the usual charge by the Unitary transform ation described in Ref. 7. In the case of (a), where U is relatively sm all, the

rst and second excited states lie in the gap region. The occupation of the bound state in the ground, rst, and

second excited states are supposed to be empty, single, and double, respectively. In contrast, in (b) the occupation of the bound state in the ground and states are supposed to be single and empty, respectively. The doubly occupied state could not stay below the gap in (b) because of large U.




Fig. 5. The xed point value of the lowest excitation energy of $(N = 1)^{-2}H_N$ at large N as a function of U. Here $E_{S=0}$ and $E_{S=1/2}$ are the eigenvalue of the lowest singlet and double states, respectively. Therefore, the ground state is a singlet (doublet) for negative (positive) $E_{S=0} = E_{S=1=2}$. The parameters are taken to be $d = j_R j_R = 3.77697 j_R j_d = U=2$, and = 2.0.

The eigenvalues depend on the phase di erence, and particularly the xed-point energy at large N determ ines the low -energy properties. In Fig. 5, the xed-point value of the low est excitation energy $E_{S=0} = E_{S=1=2}$ is plotted as a function of U for several values of , where $E_{\,S\,=\,0}$ and $E_{N=1=2}$ are the low est eigenvalues of $(N = 1)^{-2} H_N$ in the singlet and doublet subspace, respectively. The param eters are chosen to be $R = 3.77697 j_R j_and d = R$. For U < U_C with U_C ' 25j $_{\rm R}$ j the ground state is a singlet, and the excitation energy depends visibly on . The energy separation between the two states decreases with increasing , and it means that tends to destabilize the singlet ground state. On the other hand the ground state is a doublet for $U > U_C$, and the dependence of the excitation energy is very weak. This seems to be caused by the fact that the local moment, which rem ains in the doublet ground state, makes the SC correlation length sm all, and the phase coherence between the dot and SC lead becom es weak. In the singlet state, how ever, the phase coherence is preserved, and thus the excitation energy depends sensitively on .W e can also

see in Fig.5 that the critical value U_c decreases with increasing to reduce the area of the singlet ground state in the phase diagram .




Fig. 6. Phase diagrams of the ground state in the electron-hole symmetric case $_{d} = U=2$. Here the impurity SC gap is taken to be (a) $_{d} = j_{R} j_{R} and$ (b) $_{d} = 2j_{R} j_{A} t_{R} = 0$, the phase boundary is given by $U = 2 _{d}$ from the atom ic-limit solution. For = , the bound state comes just on the Ferm i level when U = 0 and $_{R} = _{d} (_{L})$. In the case of (b), this happens in the region of $_{R} > _{cr} = 1:77064 j_{R} j$ and on the dotted horizontal line the ground state is a singlet.

For asym m etric couplings $_{\rm R}$ ϵ $_{\rm L}$, the phase diagram of the ground state has some di erent features from that of the equal coupling case seen in Fig. 3. Two typical examples for the asymmetric coupling are shown in Fig. 6 for several values of . Here the value of $_{\rm d}$ is xed to be (a) j_R j and (b) $2j_R$ j independent of the coupling $_R$. In each of the gures (a) and (b), all the lines start from the same point on the horizontal line, the position of which is given by $U = 2_d$ from the atom iclim it solution at R = 0.A re-entrant behavior seen for is caused by the bound state lying near the Ferm i level. The phase boundary for = crosses the vertical axis at $_{R} = _{d}$, at which the couplings becomes equal $_{\rm L}$ = $_{\rm R}$ and the bound state com es just on the Ferm i level. An in nitesimal U lifts the 4-fold degeneracy of the ground state as shown in Fig. 1, and speci cally in the present case, $_{\rm L}$! 1, the critical value is given by $cr = 1:77064 j_R j$ (see Appendix D). Thus the exam ples (a) and (b) represent typical cases of $_{d} < _{cr}$ and $_{\rm d}$ > $_{\rm cr}$, respectively. In (b), the ground state is a singlet on the dotted horizontal line starting from $_{\rm R}$ = d, and the transition to the doublet state occurs discontinuously at nite U at the end of the dotted line. These examples show that the quantum phase transition can be driven by if the other param eters are in the region surrounded by the lines for = 0 and that for = .




Fig. 7. The Josephson current for U = 0 and $E_d = 0$ as a function of .The currents are calculated for several values of $_R$ from Eq. (13).Here $_d$ ($_L$) is taken to be $_d = j_R j$, so that $_R$ become sequal to $_L$ for $_R = j_R j = 1:0$, where the current for $= j_{LR} p_S discontinuously.$

W enext study how the C oulom b interaction a ects the Josephson current. To this end, we start with noninteracting case. In Fig. 7 the Josephson current for U = 0, which is obtained from Eq. (13), is plotted as a function of for several values of _R. Here the parameters are taken to be _d = j_R j and thus at _R = j_R j the two couplings of the original model become equal _R = _L since _d _L. When the two couplings are close _R ' _L, the amplitude of the current becomes large, and the shape of the dependence deviates from




Fig. 8. The Josephson current as a function of for various values of U. Here the parameters are taken to be $_{\rm R}$ = 3:77697 $_{\rm R}$, $_{\rm d}$ = $_{\rm R}$, and $_{\rm d}$ = U=2. The ground state is a singlet for U. 20 $_{\rm R}$, while it is a doublet for for U & 30j $_{\rm R}$ j. For U = 25j $_{\rm R}$ j, the quantum phase transition to the doublet ground state occurs at ' 0:76 , and the direction of the current changes due to the spin- ip tunneling.¹³⁾ N ote that the current for negative is sym metric around the origin as that in Fig. 7, since the current is an odd function of with the period 2.

a simple sinusoidal form. In the gure the dotted line is the result for R = L, and it shows a discontinuous .This singularity is caused by the bound jumpat = state at Ferm i level. The NRG results of the Josephson current are shown in Fig.8 for several values of U, where the parameters are taken to be $_{R} = 3:77697 j_{R} j_{a}$ and $d = j_R j$. In this gure the results are plotted only for 0 . Then in the doublet state the current ows in the opposite direction from that in the singlet state. This change is caused by the spin- ip tunneling through the unscreened local moment. 13,14) Therefore, the Josephson current can be used to detect the quantum phase transition.




Fig. 9. The Josephson current as a function of forvarious values of $_{\rm R}$: the onsite C oulom b repulsion is taken to be (a) U = 5.0 j $_{\rm R}$ j and (b) U = 15.0 j $_{\rm R}$ j. O ther parameters are $_{\rm d}$ = j $_{\rm R}$ j and $_{\rm d}$ = U=2.

In quantum dots the coupling to the leads is a tunable parameter. We have plotted the current as a function of

in Fig. 9 for several values of $_{\rm R}$ taking U to be (a) 5.0 j $_{\rm R}$ j and (b) 15.0 j $_{\rm R}$ j. Here the gap is chosen to be

 $_{\rm d}$ = j $_{\rm R}$ j. Both in (a) and (b), the phase transition from the singlet state to doublet state occurs when $_{\rm R}$ decreases. It can be explained from the fact that the correlation e ects are enhanced for sm all $_{\rm R}$. However, the amplitude of the current depends on another factor. In Fig. 9 (a), the amplitude becomes large when the value of $_{\rm R}$ approaches $_{\rm L}$ ($_{\rm d}$). In this case, the matching condition at the interface is the dom inant factor that determ ines the amplitude of the current. On the other hand, the amplitude decreases with $_{\rm R}$ in Fig. 9 (b). In this case, the ground state is a doublet when $_{\rm R}$ becomes equal to $_{\rm L}$, and thus in the singlet state at $_{\rm R} > _{\rm L}$ the strong electron correlation dom inates the matching condition to make the amplitude of the current sm all.

4.3 Results away from half-lling

So far, we have discussed the results at half-lling $_{\rm d}$ = U=2, where the inpurity site is singly occupied in average. In that case, the magnetic correlations are enhanced, while the charge excitations are suppressed. Therefore, when the system goes away from half-lling, the magnetic doublet ground state should be destabilized. In quantum dots the impurity potential $_{\rm d}$ is the parameter that can be controlled by the gate voltages. We show in the follow ing the NRG results for the ground-state properties in the electron-hole asymmetric case.




Fig. 10. Phase diagram softhe ground state away from half-lling for several values of the phase di erence , where $d = 2.5 j_R j_R$ and $d = j_R j_R$.




Fig. 11. Phase diagram s of the ground state as a function of $_d$ and $_R$, where $_d = j_R j$ and $U = 5.0 j_R j$.




Fig. 12. Phase diagram s of the ground state as a function of $_{\rm d}$ and $_{\rm R}$, where = , $_{\rm d}$ = j $_{\rm R}$ j and U = 1:0 j $_{\rm R}$ j. N ote that the scale of the horizontal axis is di erent from that of Fig. 11.

In Fig. 10, one example of the phase diagram is plotted as a function of U and $_R$, where $_d = 2.5 j_R$ jand $_d = j_R j$. The model has the electron-hole sym m etry at U = 5.0 j_R jand the results coincide with that at the sam e U in Fig. 6(a). As expected, the region where the doublet state stabilized becomes narrow away from half-

lling. Particularly the re-entrant region of the doublet state, which is seen at half-lling, alm ost vanishes in the case of Fig. 10. At $_{\rm R} = 0$, all the lines for di erent start from $U_{\rm a} = (\frac{2}{\rm d} + \frac{2}{\rm d})=(-{\rm d})$, where the level crossing occurs in the atom ic lim it. Then, for large U, the boundaries become at W e next consider the d dependence of the ground state. In the following two gures, the phase diagram s are plotted in a $_{\rm R}$ vs d plane for two di erent values of U: it is chosen to be U = 5.0 j $_{\rm R}$ j and U = 1.0 j $_{\rm R}$ j in Figs. 11 and 12, respectively. Here the in purity SC gaps is taken to be $_{\rm d} = j_{\rm R}$ j. The gure 11 is an example of the phase diagram for large U, where the impurity is half-lled at $_{\rm d} = 2.5 j_{\rm R}$ j and the doublet phase vanishes when $_{\rm d}$ or $_{\rm d}$ + U approaches the Ferm i level at = 0. The doublet region become swider with increasing , and this tendency is

m axim ized at = .For sm allU, the re-entrant doublet region appears as an island in the phase diagram Fig.12, where the line for = is shown.The magnetic doublet state is most stable at half-lling $_d = 0.5 j_R j_L$ In this re-entrant region, the bound state lies close to the Ferm i level.




Fig. 13. The Josephson current and the number of the electrons in the impurity $h_{d}i$ as a function of $_{d}$ for (a) $_{R} = 1:7j_{R}j$ and (b) $_{R} = 0:3j_{R}j$. The parameters are taken to be = 0.5, $_{d} = j_{R}j$, and $U = 5:0j_{R}j$. The ground state is a singlet in the case (a), while in (b) the quantum transition occurs and the doublet state is stabilized around half-lling.

W e have also calculated the Josephson current and the average num ber of electrons in the impurity site hndi. In Fig. 13, the results are plotted as a function of $_{\rm d}$ for (a) $_{R}$ = 1:7j $_{R}$ jand (b) $_{R}$ = 0:3j $_{R}$ j. The parameters are taken to be = 0.5, $d = j_R j_and U = 5.0 j_R j_c$ the ground state for these parameters are shown in Fig. 11. In the case of (a), the ground state is a singlet independent of d. The current shows a maximum at half-lling $25j_Rj$ and hn_di decreases monotonically with _d = increasing d.On the other hand, in the case of (b), the quantum phase transition occurs near half- lling, where the doublet state is stabilized. The expectation values show the singular behavior at the critical point, and particularly the Josephson current becomes small and changes the direction.

5. Sum m ary

In sum m ary, we have studied the ground-state properties of a m odel for the quantum dot embedded in the Josephson junction m aking use of the NRG m ethod. To carry out precise calculations in a wide parameter range, we have introduced a simpli ed single-channel m odel that has an extra superconducting gap $_{\rm d}$ at the impurity site. This m odel captures the essence of the Josephson and K ondo physics, and can be derived from the two-channelm odelwhen one of the bulk SC gaps is much larger than the others $j_L j_R j_R$ j. This kind of asymm etry in the Josephson couplings causes the nontrivial changes in the superconducting proximity e ects on the impurity site, and it a ects the low-energy spin dynamics of the quantum in purity.

The numerical results for the simpli ed model show that the Josephson phase tends to disturb the conduction electron screening of the local moment, and destabilizes the paramagnetic singlet ground state to drive a quantum phase transition to the magnetic doublet ground state. At the transition point, the direction of the Josephson current changes discontinuously due to the spin- ip tunneling. Speci cally, when the Josephson phase is ' and the other parameters are set so that the conductance in a norm allim it $_{\rm R}$; $_{\rm L}$! O is close to the unitary lim it value, the bound state comes near the Ferm i level. This zero mode causes a re-entrantm agnetic phase transition for the asymmetric Josephson couplings.

It is known for the Anderson in purity in norm alm etals that the magnetic transition described by the mean-

eld theory is an artifact due to the approximation, i.e., quantum uctuations stabilize the singlet ground state. In the superconducting case, however, the gap changes the structures of the low-energy excitations, and makes the occurrence of the quantum phase transition possible, the phase diagrams for which are provided in the present paper. The asymmetries in the Josephson couplings and the phase dimension of the gaps add interesting varieties in the ground-state properties of the K ondo system through the changes in the bound state.
