Frequency-dependent transport through a quantum dot in the K ondo regime

We study the AC conductance and equilibrium current uctuations of a Coulomb blockaded quantum dot in the Kondo regime. To this end we have developed an extension of the num erical renorm alization group suitable for the nonperturbative calculation of nite-frequency transport properties. We demonstrate that AC transport gives access to the many-body resonance in the equilibrium spectral density. It provides a new route to measuring this key signature of Kondo physics which so far has de ed direct experim ental observation.

In the past years sem iconductor quantum dots have gained considerable attention as tunable magnetic in purities [1]. Due to their small size, electronic transport through these structures is strongly in uenced by the Coulomb blockade [2]. Quantum dots with an odd num – ber of electrons display a well-known many-body phenom enon, the Kondo e ect [3, 4], as predicted in [5]. In these systems, a single unpaired spin is screened at low temperatures, giving rise to an enhanced DC (zerofrequency) conductance at low bias voltage.

Theoretical studies have so farm ostly focused on DC transport [5]. From the di erential conductance dI=dV at nite bias voltage V one can obtain inform ation about the K ondo resonance in the spectral density. Such m easurements on a typical, symmetrically coupled quantum dot, however, access only the spectral function under non-equilibrium conditions. It is known that in this case a nite bias splits and suppresses the K ondo peak [6]. It has also been dem onstrated experim entally that a su ciently strong AC m odulation of the gate or bias voltage likewise suppresses the Kondo peak [7, 8]. Thus, it is by no means straightforward to measure the equilibrium spectral function of a K ondo quantum dot. P revious proposals to do so require either very asym m etric couplings to the leads or quantum dots in a 3-term inal geometry [9, 10].

In this Letter we point out that the K ondo resonance in the equilibrium spectral density of a generic quantum dot can be extracted from AC transport m easurem ents. W e derive a direct relation between the spectral function and the linear AC conductance through a quantum dot Eq. (5) below]. A Itematively, the K ondo peak can be measured by detecting equilibrium uctuations in the current through the quantum dot at frequencies of the order of the K ondo tem perature $T_K \quad \text{[Eq. (8) below]}$. Such m easurem ents have com e into experim ental reach with recent advances in the measurem ent of high-frequency current uctuations [11]. Conductance m easurem ents in the relevant frequency regime are challenging, mainly due to parasitic currents through hardly avoidable capacitances. One should, however, be able to extract the signal due to the current through the quantum dot from this back-




FIG.1: Single-level Anderson model with time dependent chemical potential (t) = $(eV_{ac}=2)\cos!t$ in lead 2 fL;Rg.

ground by an adiabatic change (m uch slow er than the inverse K ondo tem perature [12]) of gate voltage that drives the dot periodically into and out of the K ondo regim e.

W e apply the nonperturbative num erical renorm alization group (NRG) in combination with the K ubo form alism [13, 14] to predict the frequency-dependence of the AC conductance and the equilibrium noise. Our results are num erically essentially exact, in contrast to previous perturbative calculations [15], and generalize those of [14] to nite frequency. This allows us to access the experim entally m ost relevant regim e of frequencies of the order of the K ondo tem perature for a device that exhibits a strong K ondo e ect.

The exact correspondence between spectral function and AC conductance holds only when charge uctuations on the quantum dot are negligible. Using our rigorous NRG results, we verify that this condition is well satis ed for frequencies below the charging energy of the dot.

The setup that we study is shown in Fig. 1. At low energies, a Coulom b-blockaded quantum dot is well described by the single-level Anderson m odel

where the chemical potentials L(R) (t) =

 $(eV_{ac}=2)\cos!t$ for the left (right) lead include a timedependent bias V_{ac} . We assume that the AC perturbation does not couple to electrons in the local level d $(n_d = d^y d)$. V couples the level d to electron states o_k with momentum k and spin = 1 in lead 2 fL;Rg. In the following, D denotes the conduction electron bandwidth. $_d$ $_d$ + B =2, B = g $_B$ B, is the energy of the local level, including the Zeem an shift in presence of a magnetic eld B. U is the Coulom b repulsion of electrons on the dot.

Following [16] we relate the current I through the quantum dot to the local G reen function of the level d. For frequencies h! _c much smaller than the charge excitation energy $c = m \inf j_d j j U + d j g$, charge uctuations on the quantum dot can be neglected and the currents owing through the right and the left lead are equal to a good approximation: $I_{L} = \frac{1}{2}$. It is then advantageous to write the total current as $I = (I_L)$ $\frac{1}{2}$)=(1+), = V^2 and is the conduction where = L = R, electron density of states. Expressing the currents I_L and I_R by the G reen function of d (see Eq. (15) in [16]) and Fourier transform ing from timet to frequency !, we nd for energy-independent couplings the current

in linear response to V_{ac} . Here f() is the equilibrium Ferm i function of the leads and $G^{r}(t_{1};t_{2}) = i(t_{2},t_{2})hfd(t_{1});d^{y}(t_{2})gi$ the retarded G reen function of devaluated in equilibrium ($V_{ac} = 0$). From Eq. (2) we obtain the real (G^{0}) and in aginary (G^{0}) parts of the linear conductance,

where = $_{\rm L}$ + $_{\rm R}$ and A (!) = $\frac{1}{2}$ Im G^r(!) is the spectral function. At zero tem perature kT hj!j $_{\rm C}$ Eq. (3) is readily solved for the symmetrized spectral function A_s() = [A() + A()]=2,

In the K ondo regime $(m_d i ' 1)$, the K ondo resonance is centered almost exactly around 0, thus the K ondo peaks in $A_s(!)$ and A(!) are essentially indistinguishable. H ence, Eq. (5) allow sus to extract the K ondo peak in the equilibrium spectral function from a m easurement of the AC conductance.




FIG. 2: (a) Real and in aginary parts of the AC conductance obtained via the K ubo approach (solid lines) and from the conductance form ulas Eqs. (3) and (4) (dashed lines). Note the excellent agreement for frequencies h! < 100 k T_K ($_{\rm C}$ 600 k T_K). (b) D oniach-Sunjic tails in A (!) are responsible for the power-law behavior (dashed line) in the conductance (solid line) which is well described by G⁰ / !¹⁻² for 20 k T_K < ! < 200 k T_K [17]. (c) C om parison of the frequency-dependent conductance phase (!) in the K ondo regime (solid line) (parameters U = 0:12D, U = 6, d = U=2, T = 0) with that for a resonant level ($_{\rm d}$ = 0) of width k T_K (dotted line).

The frequency-dependent equilibrium current uctuations (Johnson-Nyquist noise)

Consequently, the spectral function can alternatively be inferred from a measurement of C (!). At zero temperature, kT hj! j $_{c}$, we arrive at

Note that at zero temperature C (!) is non-vanishing only for ! < 0, that is uctuations have to be measured by probing absorption by the quantum dot. In [11] the measurement of current uctuations at frequencies up to ! ' $100 \,\mathrm{GHz}$ has been reported. This frequency scale is of the same order of magnitude as the K ondo temperature in typical K ondo quantum dots [1]. It makes noise measurements a promising candidate for experimental studies of the K ondo peak in the spectral function of a quantum dot.

W e turn now to a discussion of the frequency dependence of AC conductance and equilibrium noise in a Kondo quantum dot with typical experimental param eters. We apply the num erical renorm alization group (NRG), rst used by W ilson to solve the Kondo problem [13]. This method is nonperturbative and does not su er from low -energy divergences com m on to scaling approaches. In particular, it provides accurate results in the most interesting crossover regime h! $< kT_{K} \cdot W$ ithin NRG we apply two independent approaches: Using the K ubo form ula, we are able to calculate the conductance in the Anderson model Eq. (1) num erically exactly. On the other hand, using Eqs. (3) and (7), we obtain conductance and noise from the single-particle G reen function of the d level, that we determ ine by NRG as well. By com paring the two approaches we shall dem onstrate the validity of the approximation underlying Eqs. (3) and (4) for frequencies of the order of the K ondo scale.

We apply the Kubo formalism following Izumida et al. [14]. We de ne an electric current from lead L to R as $\hat{\Gamma} = \frac{e}{2} \ hN_{R} i \ hL_{L} i$, where $N = \frac{P}{k} \ c_{k}^{y} \ c_{k}$ is the total number of electrons in lead and $N-=\frac{i}{h} \ H; N$]. Introducing a linear response tensor by $hN-i = (!)^{0}$, where $\int_{L(R)}^{0} = (eV_{ac}=2)\cos!t$ is the time-dependent bias applied to the left (right) lead, the total linear AC conductance takes the form

The complex response tensor can be written as $(!) = \frac{1}{1} [K (!) K (0)], where$

with ! 0^{\dagger} . h::i in Eq. (10) refers to the equilibrium expectation value with respect to the H am iltonian H with $V_{ac} = 0$. We evaluate this expression using NRG [13]. From the matrix elements of the current operator hn jf in i the imaginary part K ⁽⁰⁾ is obtained directly while the realpart K ⁽⁰⁾ can be calculated via a K ram ers-K ronig transform ation.

In Fig. 2 we can pare the conductance obtained from Eq. (3) with the result of the calculation in the Kubo form alism for $_{\rm d}$ = U=2 and B = 0. We nd excellent agreement for frequencies below the charge gap $_{\rm c}$. Moreover the large frequency (h! kT_K) asymptotes of the conductance reveal a decay of G⁰(!) !¹⁼² [Fig. 2 (b)]. This is expected as a consequence of the D oniach-Sunjic tails of the spectral function [17] together with Eq. (5). The deviation of G⁰(!) from the unitary limit (by 6%) is due to system atic num erical errors accumulating in the NRG procedure. Fig. 2 (c) shows




FIG.3: The equilibrium current uctuations C (!) depend linearly on ! for h j! j kT_K [20], as shown for various magnetic elds B. The inset shows that the uctuations are spin-independent even in presence of a nite magnetic eld B (B = $10 kT_K$, (red) crosses: = ", (black) solid line: = #). Parameters: U = 0:12D, U = 6, d = U=2, T = 0.

the frequency-dependent phase (!) of the linear conductance, G (!) = $jG(!)je^{i}$.

The frequency-dependence of the equilibrium noise obtained by a direct num erical evaluation of Eq. (6) within NRG is plotted in Fig. 3. A sone expects, the uctuations reach a maximum for frequencies h! U. The linear behavior C(!) ! at sm all ! is a manifestation of the Ferm i-liquid nature of a screened K ondo in purity. Fig. 3 also shows how a nite magnetic eld B suppresses low frequency equilibrium uctuations. The inset demonstrates that at low frequencies the noise for spin up and spin down electrons is identical, even in the presence of a magnetic eld. This is because an impurity with large charging energy _c is half-lled: \ln_{d} i+ \ln_{d} i= 1. As a consequence of the Friedel sum rule [18], the spectraldensities at the Ferm ienergy F for spin-up and spindow n electrons $A_{"=\#}(F) / \sin^2(h_{d"=\#}i)$ are then equal.




FIG. 4: Spectral function A (!) A_s (!) as extracted from the current noise C (!) via Eq. (8) (lines) compared to A (!) obtained directly by NRG (stars) for di erent values of the m agnetic eld B. Eq. (8) captures the K ondo peak in A (!) very well, including suppression and splitting in presence of a m agnetic eld B.

W e now use Eq. (8) to extract the spectral function A_s from the num erical current noise data of Fig. 3 where charge uctuations on the dot have been taken into account. The results are shown in Fig. 4. They nicely demonstrate the splitting and the suppression of the K ondo peak upon increasing the external eld B.A com parison with the spectral function directly calculated by NRG con ms that Eq. (8) does indeed work very well c. In particular, the K ondo peak for frequencies h! in the symmetrized spectral function $A_{s}(!)$ obtained by our method is essentially indistinguishable from that in the spectral function A (!) directly calculated by NRG. Due to intrinsic broadening in the NRG which a ects both A (!) and C (!), Eq. (8) becomes less accurate for nite B.

Having demonstrated that neglecting charge uctuations in deriving Eqs. (5) and (8) is very well justied,

we com m ent on another limitation of our approach. Calculating the linear response of the quantum dot, we have assumed the bias voltage in a conductance m easurement to be small. W hile this in itself is not a problem, one m ight worry, however, that due to the nite frequency of V_{ac} extra decoherence processes would make the limit of linear response very restrictive. The decoherence rate of the dot's spin due to the oscillating bias voltage for h! kT_K can be estimated [19] as

For the K ondo physics not to be disrupted by V_{ac} , we need h $^{-1}=kT_{K}$ 1. Eq. (11) shows that this condition can be easily fulled by the usual requirement eV_{ac} kT_{K} . We expect that this statement remains true for frequencies of the order of T_{K} . We conclude that transport is described accurately by our linear response conductance for voltages that are much smaller than the K ondo tem perature.

In conclusion, we have studied AC transport through a quantum dot in the K ondo regime, using the numerical renorm alization group technique in combination with the K ubo form alism. We have expressed linear conductance and equilibrium current uctuations in term softhe single-particle G reen function. This relation becomes exact at low frequencies, when charge uctuations on the dot can be neglected. It has been shown to work very well for frequencies of the order of the K ondo scale. This opens up the exciting possibility of measuring the equilibrium K ondo resonance directly in a transport measurement. [1] L.K ouwenhoven and L.G lazm an, Physics W orld 14, 33 (2001).
