## A utocorrelation exponent of conserved spin system s in the scaling regime following a critical quench

We study the autocorrelation function of a conserved spin system following a quench at the critical temperature. Dening the correlation length L (t)  $t^{d=z}$ , we not that for times  $t^0$  and the satisfying L ( $t^0$ ) L ( $t^0$ ) L ( $t^0$ ) well inside the scaling regime, the spin autocorrelation function behaves like hs ( $t^0$ ) i L ( $t^0$ ) ( $t^0$ ) (L ( $t^0$ )=L ( $t^0$ 

The quench of a ferrom agnetic spin system [1], from high temperature  $(T_0 > T_c)$  to low temperature (typically T = 0 or  $T = T_c$ ) is characterized by the growth of a correlation length scale (or dom ain length scale when dom ains can be identied), L (t)  $t^{1=z}$ . In the non conserved case, z depends on the naltem perature of the quench (z = 2 for T <  $T_c$ , while z is the dynamical critical exponent for  $T = T_c$  [2]). If the order param eter s(x;t) (possibly a vector) is locally conserved, z = 3(scalar) or z = 4 (vector) for a quench below  $T_c$  [1], [2] for a quench at T<sub>c</sub>. Another interwhile z = 4esting and fundam ental quantity is the spin autocorrelation A (t;0) = hs(x;t)s(x;0)iL (t) [3, 4, 5]. For non conserved dynamics, whatever the temperature of the quench, is non trivial (except in d = 1 [1]) and only approxim ate theories are available for T = 0 [1, 4], while for  $T = T_c [\beta]$ , the "-expansion of  $_c$  can be calculated. In the case of conserved dynam ics, it is now wellestablished that  $_{c} = = d$  for quenches at and below  $T_{c}$  [6, 7, 8]. Hence, for xed  $t^0$  and t! + 1, A  $(t;t^0)$  L  $(t)^d$ . How ever, for  $t^0$  and  $t > t^0$  both in the scaling regime (in a sense to be de ned later), several authors have observed num erically [9, 10, 11] and experim entally [12] a faster power law decay of the autocorrelation. M ore precisely, in the case of a quench of an Ising system at  ${\tt T}_{\rm c}$  (critical quench), the authors of [11] obtained num erically

in d = 1 (where form ally = 1 and  $T_c = 0$ ) and d = 2. They respectively found  ${}^0_c$  2:5 in d = 1 and  ${}^0_c$  3:5 in d = 2. They also suggested a general scaling relation

where C (x) goes to a non zero constant for x ! +1 , C (x) x  $\binom{c}{c}$  d) for x ! 0, and

As noticed in [11], this scaling implies the existence of a new relevant length scale L  $(t^0)$ , which is the crossover length between the two observed regimes. Its physical meaning has yet to be elucidated.

In the present Letter, we address the problem of the actual analytical derivation of  $_{\rm c}^0$  in the case of the O (n) m odel in the lim it of in nite n. W ithin this model, the di usive nature of this new length scale can be understood, and one nds  $_{\rm c}^0 = d + 2$  and = 2. By generalizing the interpretation of this di usive crossover length scale to any O (n) spin system, we conjecture that the result  $_{\rm c}^0 = d + 2$  holds and that = 2 = 2 = z = 2.

We rst exam ine the exactly solvable O (n) model in the lim it n ! 1 and for dimensions d > 2. This model is known to be pathological for a quench at zero tem perature, displaying multiscaling [13], whereas norm alscaling should be restored at nite n [1, 14]. However, after a quench at  $T_c$ , the structure factor obeys standard scaling even forn ! 1 [7]. In the standard Cahn-H illiard equation describing the evolution of the magnetization eld s(x;t),  $s^2(x;t)=n$  can be replaced by its average in the lim it n ! 1 . Thus, any spin component satis es

where  $k_0^2$  is a constant, (x;t) is a conserved deltacorrelated noise satisfying h (k;t)  $(k^0;t^0)i = 2T_ck^2$   $(k + k^0)$  (t  $\frac{1}{2}$ ), and hs<sup>2</sup> i has to be computed self-consistently. A lthough the derivation of the structure factor has already appeared in the literature [7], we brie y repeat it as it furnishes a useful basis for our nal derivation.

Eq. (4) can be solved in Fourier space, leading to

Assuming an uncorrelated initial condition such that hs( k;0)s(k;0)i =  $s_i^2$ , we then nd the structure factor S(k;t) = hs( k;t)s(k;t)i

We now express the self-consistent condition  $hs^2(x;t)i = R$ 

 $S(k;t) \frac{d^d k}{(2)^d}$ , where is the inverse of a lattice cuto.  $T_c$  is such that  $S(k;t! 1) k^{2+}$ , where is the usual critical exponent controlling the decay of the static correlation function ( = 0 for n ! 1). This leads to

F inally, if the above condition is satisfied, we nd that q(k;t) obeys a scaling relation for large t

$$q(k;t) = q(kt^{1-4}) = k^4t \quad Qk^2t^{1-2};$$

where  $c_d$  is a universal constant determ ined by a simple integral relation ( $c_d = 0$  for d > 4) [7], and  $q(u) = u^4$  $c_d u^2$ . We thus nd L (t) =  $t^{1=z}$ , with z = 4, in agreement with the general result z = 4 [2]. We hence reproduce the general form of the structure factor

For the O (n = 1 ) m odel, we have z = 4, = 0, and

Note the following asymptotics for F (u)

In the scaling limit, the rst term of the right hand side (RHS) of Eq. (10) is negligible compared to the second term. In real space, Eq. (10) illustrates the fact that conventional (critical) scaling is obeyed

where f is simply the inverse Fourier transform of F.

We now move to the calculation of the two-time correlation function, focusing on the case where both considered times  $t^0$  and  $t > t^0$  are in the scaling regime, a notion which will be made more precise hereafter. Using Eq. (5), and working along the line of the derivation of S (k;t), we not the following expression for C (k;t) = hs(k;t)i

For a xed t<sup>0</sup> and t! 1, the contribution of A<sub>2</sub> becomes negligible, as for large t and hence L (t), only the contribution of sm all wave vector k L (t) <sup>1</sup> m atters. U sing the result of Eq. (12), we indeed nd that that this term is of order k<sup>2</sup> L (t) <sup>2</sup>, whereas the main contribution A<sub>1</sub> in Eq. (16) is of order s<sub>0</sub><sup>2</sup> which is a constant. C ontrary to what occurs for S (k;t), it is now the term depending on the initial conditions via s<sub>0</sub><sup>2</sup> which dom inates. Hence in this lim it of xed t<sup>0</sup> and t! 1, we nd

C (k;t;t<sup>0</sup>) C (k;t;0) =

and in real space

where g is the inverse Fourier transform of G. One recovers, in the lim it t<sup>0</sup> to be m ade m ore precise later, that the large time autocorrelation exponent is  $_{\rm c}$  = d, which is observed in all conserved m odels including thermal uctuations [6, 7]. In this lim it, conventional scaling holds. However, we will now show that the contribution of Eq. (17) which has not so far been considered dom inates in a well de ned time regime, and will prompt us to introduce another autocorrelation exponent  $^{0}_{c}$ .

For general  $t^0$  and  $t > t^0$ , we now proceed to calculate the autocorrelation for a spin on a given lattice site. Dening A  $(t;t^0) = h_S(x;t^0)s(x;t)i$ , we nally nd A  $(t;t^0) = A_1(t;t^0) + A_2(t;t^0)$ , where

A fler a change of variable and noting that the region of k = L (t) <sup>1</sup> barely contributes to the integral, we nd

$$A_1 (t;t^0) = L (t)^{d} a_1 [L (t^0)=L (t)]:$$

Thus,  $A_1$  (t;t<sup>0</sup>) obeys conventional scaling for any t<sup>0</sup> and t > t<sup>0</sup>. We explicitly nd

$$a_{1}(u) = s_{0}^{2} e^{k^{4}(1+u^{4})+c_{d}k^{2}(1+u^{2})} \frac{d^{d}k}{(2)^{d}}; \quad (22)$$

where this integral is now over the entire space.  $a_1(u)$  remains bounded and of order  $s_0^2$  for any value of u = 1

L (t<sup>0</sup>)=L (t) 1. K exping the notation u = L (t<sup>0</sup>)=L (t) 1, the expression for  $A_2$  (t;t<sup>0</sup>) can be written in the rescaled form

Let us analyze the di erent asymptotics for  $A_2(t;t^0)$ . First of all, for large  $t = t^0$  (u = 1), the integral is dominated by the region of large k's. Using Eq. (8), we nd the expected result  $A_2(t;t)$   $k_0^2$ , which is the equilibrium value of  $hs^2 i$ . Note that if t  $\ell$  1, we obtain  $A_2(t;t^0) = A_2(t;t)$   $K_d(t \ell) + ..., where K_d$  is a computable constant. We now assume that 1 L(t) L( $\ell$ ) L( $\ell$ ), which ensure that u is very close to 1. In this regime, we nd that

where  $J_d$  and  $J_d^0$  can be written exactly as simple integrals. Finally, and this constitutes the central result of this Letter, we consider the regime 1  $L(t^0) = L(t)$ . In this case, u = 1, and the integral of Eq. (23) is dominated by the region of k of order unity, so that the small argument asymptotics can be taken for F (ku) in Eq. (23). We nd

Eq. (26) takes exactly the expected form of Eq. (1), with

Hence, we d that  $A_2(t;t^0)$  prevails over  $A_1(t;t^0)$  for  $L(t^0)$  L(t)  $L_0(t^0)$ , with  $L_0(t^0)$   $L(t^0)$  and = 2. For  $L(t^0)$  L(t)  $L_0(t^0)$ , the autocorrelation  $A(t;t^0)$   $A_2(t;t^0)$  is then given by Eq. (26). Moreover, Eq. (23)

 $A_2$  (t;t') is then given by Eq. (26). Moreover, Eq. (23) shows that instead of Eq. (2), the correct scaling is rather

$$A (t;t^{0}) = A (t;0) + L (t^{0})^{(d 2+)} D [L (t)=L (t^{0})]; \quad (29)$$

with D (1=u)  $u^{\circ}$  for u 1. Both scaling are equivalent only for u 1. We now present an heuristic argument based on dimensional analysis which suggests that the result  $_{c}^{0} = d + 2 m$  ay be of general validity for conserved spin systems. Indeed, the occurrence of a new length scale bigger than L (t) could have been inferred from the smallk behavior of S (k;t). In the n ! 1 limit and for k ! 0, Eq. (10) leads to

A natural momentum scale  $k_0$  (t)  $L_0$  (t) <sup>1</sup> arises by m atching the two terms of the RHS of Eq. (30), which leads to = 2 and hence  $c_c^0 = d + 2$ .

In the general case, for short-range correlated initial conditions, we expect the following general form to hold

$$S(k;t) = F_1[kL(t)] + L(t)^2 F_2[kL(t)];$$

with  $F_1(0) = s_0^2$  being a non zero constant (equal to the variance of the initial total magnetization norm alized by the volum e), while the scaling contribution should vanish for k = 0, implying  $F_2(0) = 0$ . Imposing  $F_2(p) = p$ ,




FIG.1: Illustrating the result of Eq. (29), we plot A (t;t<sub>k</sub>) A (t;0) = D [L (t)=L (t<sub>k</sub>)], for L (t<sub>k</sub>) L (0)<sup>k</sup>, with r = 1:75 and k = 1;:::;7 (40000 sam ples of length N = 5000). A lthough the initial slope is smaller ( $_{c}^{\circ}$  2:5 [11]; dotted line), the asymptotic exponent is very close to  $_{c}^{\circ}$  = 3 (dashed line t). The bottom inset shows the original data for A (t;t<sub>k</sub>) and A (t;t<sub>k</sub>) A (t;0) (dashed lines). The top inset shows L (t) A (t;t<sub>k</sub>) A (t;0)] as a function of L (t)=L (t<sub>k</sub>) (with = 3=2). Lines of slope  $_{c}^{\circ}$  1 are shown for  $_{c}^{\circ}$  = 3 (dashed line) and  $_{c}^{\circ}$  2:5 (dotted line).

is necessarily an even integer. If were not integer, the correlation function scaling function f de ned in Eq. (14) would have a power law decay for large distance, which is unphysical as such correlations cannot develop in a nite time starting from short-range ones. cannot be an odd integer as space isotropy guarantees that f should be an even function. Contrary to the case of a quench at T = 0, for which convincing theoretical arguments for d 2 [15] and experiments [16] show that  $F_2$  (p)  $p^4$ , there is no reason to expect the same for critical quenches. Generically, we expect  $F_2$  (p)  $p^2$  as found for the d = 1 conserved Ising model [6, 7], and in the present Letter for the 0 (n) model for n ! 1 . Finally, the small k behavior of the structure factor should be of the form

$$S(k;t) = s_1^2 + C_0 k^2 L(t)^4 + ...;$$

where  $C_0 > 0$  is a constant. A sum ing that the length scale obtained by m atching both terms of the RHS of Eq. (32) is the same as the crossover length between the two observed regimes for the autocorrelation, and using the general result of Eq. (3), we obtain

which implies  ${}^0_c = d + 2$ . This result also extends to d = 1 after formally taking = 1, leading to  ${}^0_c = 3$  and = 3=2. Note that the crossover scale can also be written  $L_0(t) = t^{=z} = t^{=2}$ , which is the di usion scale associated to thermal noise. At least in d = 1, this scale can be related to the equilibrium di usion of tagged spins observed in [17]. We now present simulations of the Ising m odel K awasaki dynamics in d = 1 and d = 2 after a




FIG. 2: In the bottom inset, we plot A  $(t;t_k)$  and A  $(t;t_k)$ A (t;0) (dashed lines) as a function of L (t), for L  $(t_k)$   $r^k$ , with r = 1:5 and k = 1; :::;5 (16 sam ples of size N = 500 500, L (0) = 1 = 2). The main plot shows L  $(t_k)$  A  $(t;t_k)$ A (t;0)] = D [L  $(t)=L(t_k)$ ]. A lthough the initial slope is consistent with  ${}_{c}^{c}$  3:5 [11] (dotted line), the e ective exponent certainly increases and the asymptotic slope is more com – patible with  ${}_{c}^{c} = 4$  (dashed line t). The top inset shows L  $(t)^2$  A  $(t;t_k)$  A (t;0)] as a function of L  $(t)=L(t_k)$  (with = 15=8). A lthough not as clean as in d = 1, the scaling plot is better described by the line corresponding to  ${}_{c}^{c} = 4$

quench at  $T_c$ . In the d = 1 case, we use the accelerated algorithm introduced in [7], which is faster than that used in [11] (but does not perm it to compute simply the response function as was needed in [11]). By thing A  $(t;t^0)$ in the scaling regime, the authors of [11] found  $\begin{bmatrix} 0 \\ c \end{bmatrix}$ 2:5 lower than our prediction  $C_{c}^{0} = 3$ . However, for the moderately large num erically accessible tim es, the contribution of  $A_1$  (t; t<sup>0</sup>) A (t;0) is signi cant. W hen plotting A  $(t;t^0)$  A (t;0) as a function of L (t), one actually nds 3 instead of  $^0_{\rm c}$ 2:5. Result of simulations for the d = 2 Ising model evolving with K awasakidynam ics at  $T_c$  are shown on Fig. 2. Considering the very slow grow th of L (t)  $t^{\pm 15}$ , it is dicult to obtain data spanning more than one decade in L (t). Hence, the regime L (t<sup>0</sup>) L (t) cannot be reached and the of interest 1 separation of scales properly achieved. Still, subtracting A (t; 0) from A (t;  $t^0$ ) leads to  $\frac{0}{c}$ 4, signi cantly greater than the value  $^{0}_{c}$  3:5 found in [11].

In conclusion, in view of the exact result for the O (n = 1) model, a general argument for any n and d, and convincing simulations in d = 1 (and consistent in d = 2), we have strongly suggested that  $^{0}_{c} = d + 2$  and

= z=2 generally holds. We also nd that the scaling form of Eq. (29) is more appropriate than Eq. (2). The

com pelling generalization of our heuristic argument to a quench at T < T<sub>c</sub> (in d 2, and adm itting F<sub>2</sub> (p)  $p^4$ ) leads to A (t;t<sup>0</sup>) [L (t)=L (t)]  $^{\circ}$  for L (t<sup>0</sup>) L (t) L (t<sup>0</sup>), with  $^{0} = d + 4$  and = 1 + d = 4. In d = 2, the prediction  $^{0} = 6$  is signi cantly larger than the numerical result  $^{0}$  4 [9]. However, the t in [9] was performed in the short scaling regime over less than a decade in L (t), and subtracting A (t;0) before perform - ing the t could lead to a signi cantly higher value for  $^{0}$ , as noted in the two examples treated in this Letter.
