
Relationship between and implications of the isotope and pressure e ects on transition temperature, penetration depths and conductivities.

It is shown that the empirical relations between transition temperature, normal state conductivity linearly extrapolated to the value at the transition temperature, zero temperature penetration depths, etc., as observed in a rich variety of cuprate superconductors, are remarkably consistent with the universal critical properties of anisotropic systems which fall into the 3D-XY universality class and undergo a crossover to a quantum critical point in 2D. The variety includes n-and p-type cuprates, comprises the underdoped and overdoped regimes and the consistency extends up to six decades in the scaling variables. The resulting scaling relations for the oxygen isotope hydrostatic pressure elects agree with the experimental data and reveal that these elects originate from local lattice distortions preserving the volume of the unit cell. These observations single out 3D and anisotropic microscopic models which incorporate local lattice distortions, fall in the experimentally accessible regime into the 3D-XY universality class, and incorporate the crossover to 2D quantum criticality where superconductivity disappears.

I. IN TRODUCTION




FIG. 1. a) Variation of T_c for La_{2 x} Sr_xCuO_4 . Experimental data taken from [1{9]. The solid line is Eq.(1) with T_c (x_m) = 39K.b) $_T$ versus x for La_{2 x} Sr_xCuO_4 . The squares are the experimental data for $_{T_c}$ [1,2,4,6,7] and the triangles for $_{T=0}$ [8,9]. The solid curve and dashed lines are Eq. (2) with $_{T_c,0}$ = 2 and $_{T=0,0}$ = 1:63.

E stablishing and understanding the phase diagram of cuprate superconductors in the tem perature – dopant concentration plane is one of the major challenges in condensed matter physics. Superconductivity is derived from the insulating and antiferrom agnetic parent compounds by partial substitution of ions or by adding or removing oxygen. For instance La_2CuO_4 can be doped either by alkaline earth ions or oxygen to exhibit superconductivity. The empirical phase diagram of $\text{La}_2\ _x\text{Sr}_x\text{CuO}_4\ [1\{9\}\text{ depicted in Fig. 1 shows that after passing the so-called underdoped limit (xu 0:047), Tc reaches its maximum value <math>\text{T}_c^m$ at xm 0:16. With further increase of x, Tc decreases and nally vanishes in the overdoped limit xo 0:273.

This phase transition line is thought to be a generic property of cuprate superconductors [10] and is well described by the empirical relation

proposed by P resland et al. [11]. Approaching the endpoints along the axis x, La $_2$ $_x$ Sr $_x$ CuO $_4$ undergoes at zero tem perature doping tuned quantum phase transitions. As their nature is concerned, resistivity measurements [3,12]


reveal a quantum superconductor to insulator (QSI) transition in the underdoped lim it [13{16}] and in the overdoped lim it a quantum superconductor to normal state (QSN) transition [13{16}].

A nother essential experim ental fact is the doping dependence of the anisotropy. In tetragonal cuprates it is de ned as the ratio = ab = c of the correlation lengths parallel (ab) and perpendicular (c) to CuO₂ layers (ab-planes). In the superconducting state it can also be expressed as the ratio = c= ab of the London penetration depths due to supercurrents owing perpendicular ($_{\rm c}$) and parallel ($_{\rm ab}$) to the ab-planes. Approaching a non-superconductor to superconductor transition diverges, while in a superconductor to non-superconductor transition tends to in nity. remains nite as long as the system exhibits anisotropic but genuine 3D behavior. There In both cases, however, are two limiting cases: = 1 characterizes isotropic 3D - and = 1 2D - critical behavior. An instructive model where can be varied continuously is the anisotropic 2D Ising model [17]. When the coupling in the y direction goes = $_{\rm x}$ = $_{\rm v}$ becomes in nite, the model reduces to the 1D case and $T_{\rm c}$ vanishes. In the G inzburg-Landau description of layered superconductors the anisotropy is related to the interlayer coupling. The weaker this coupling is, the larger is. The limit = 1 is attained when the bulk superconductor corresponds to a stack of independent slabs of thickness ds. W ith respect to experim ental work, a considerable am ount of data is available on the chem ical $_{ab}$ = $_{c}$) and m agnetic torque composition dependence of \cdot At T_c it can be inferred from resistivity (= $_{ab}$ = $_c$ = m easurem ents, while in the superconducting state it follows from magnetic torque and penetration depth (= c = ab)data. In Fig. 1b we displayed the doping dependence of 1 = T evaluated at T_C (T_C) and T_C = 0 (T_C). As the dopant concentration is reduced, T_0 and T_0 increase system atically, and tend to diverge in the underdoped lim it. Thus the tem perature range where superconductivity occurs shrinks in the underdoped regime with increasing anisotropy. This competition between anisotropy and superconductivity raises serious doubts whether 2D mechanisms and models [19], corresponding to the lim it T = 1, can explain the essential observations of superconductivity in the cuprates. From Fig. 1b it is also seen that $_{\rm T}$ (x) is well described by [16,18]

Having also other cuprate families in mind, it is convenient to express the dopant concentration in terms of T_c . From Eqs. (1) and (2) we obtain the correlation between T_c and T_c :

P rovided that this em pirical correlation is not m erely an artefact of La_{2 x} Sr_xC uO₄, it gives a universal perspective on the interplay of anisotropy and superconductivity, among the families of cuprates, characterized by T_c (x_m) and T_c (x_m). For this reason it is essential to explore its generic validity. In practice, however, there are only a few

additional compounds, including $H gB a_2 C uO_{4+}$ [20] and $B i_2 S r_2 C uO_{6+}$, for which the dopant concentration can be varied continuously throughout the entire doping range. It is well established, however, that the substitution of magnetic and norm agnetic in purities, depress T_c of cuprate superconductors very electively [21,22]. To compare the doping and substitution driven variations of the anisotropy, we depicted in Fig. 2 the plot $T_c = T_c$ (x_m) versus T_c (x_m) = T_c for a variety of cuprate families. The collapse of the data on the parabola, which is the empirical relation (3), reveals that this scaling form is well conomic agreement T_c (T_c (T_c (T_c (T_c)) and T_c (T_c), it gives a generic perspective on the interplay between anisotropy and superconductivity.




FIG .3. 1= $^2_{ab}$ (0) vs. T_c $^{dc}_{ab}$ (open symbols) and 1= 2_c (0) vs. T_c $^{dc}_c$ (full symbols) for various cuprates as collected by H om es et al. [29]. The straight line is 1= $^2_{ab;c}$ (0) = 52 10 5 T_c $^{dc}_{ab;c}$. The experimental data is taken from [30{35] for YBa₂Cu₃O₇ (Y-123), [32] for Pr-YBa₂Cu₃O₇ (PrY-123), [33,36] for YBa₂Cu₄O₈, [33,36] for T½Ba₂CuO₆₊, [32,37] for B½Ca₂SrCu₂O₈₊ and Y/Pb-B½Ca₂SrCu₂O₈₊, [38,39] for Nd_{1:85}Ce_{0:15}CuO₄, [29,40] for La₂ $_x$ Sr_xCuO₄ (214), and [29] for HgBa₂CuO₄₊. The arrow indicates the ow to the 2D-QSI critical point.

Furtherm ore there is the impressive empirical correlation between zero temperature penetration depths, transition temperature and normal state conductivities (extrapolated to T_c), discovered by Homes et al. [29]. In Fig. 3 we displayed this scaling behavior in terms of $1=\frac{2}{ab}$ (0) vs. T_c $\frac{dc}{ab}$ and $1=\frac{2}{c}$ (0) vs. T_c $\frac{dc}{c}$. Here $\frac{dc}{i}$ is the real part of the frequency dependent normal state conductivity $\frac{dc}{c}$ (!) in direction i extrapolated to zero frequency.

Noting that the linear relationship extends over six decades it provides unprecedented evidence for universal behavior. Indeed, the data encompasses the slightly underdoped and overdoped regime of a variety of cuprates. An important implication is that the changes T_c , $1=\frac{2}{ab_{jc}}$ and $\frac{dc}{ab_{jc}}$, e.g. induced by isotope exchange, are not independent but related by

Such scaling behavior diers drastically from the isotope elects in the so called conventional superconductors. In these materials mean—eld treatments including the BCS theory apply and for elemental superconductors T_c scales roughly as M $^{1=2}$, where M is the mass of the ions. Historically, the resulting isotope election T_c identiced the phonons as the bosons mediating superconductivity. Furthermore, the isotope election the penetration depth, entering via the electron-phonon interaction mediated renormalization of the fermi-velocity, appears to be negligibly small.

G iven the critical line T_c (x) with the 2D-Q SI and 3D-Q SN endpoints (see Fig. 1) such universal relations are not unexpected but a consequence of uctuations [14,16,41,42]. As an example we consider the universal scaling relation at the 2D-Q SI transition [13{16,43}],

which holds independently of the nature of the putative quantum critical point. $_{ab}$ (0) is the zero tem perature inplane penetration depth, d_s the thickness of the sheets and R_2 is a universal number. Since T_c / d_s = $_{ab}^2$ (0) / n_s^2 , where n_s^2 is the aerial super uid density, is a characteristic 2D property, it also applies to the onset of super uidity in 4 He $_{ab}^4$

has also been done in cuprates on the so called U em ura plot [45], revealing an em pirical correlation between T_c and $d_s = \frac{2}{ab}$ (0).

This work aim s to review the evidence that the empirical scaling relations between $_{ab;c}$ (0), T_c , d_s , $_{ab;c}^{dc}$, etc., as well as the resulting relations for the isotope and pressure elects, reject 3D-XY universality along the phase transition line T_c (x) and the crossover to the 2D-Q SI quantum critical point (see Fig. 1). Although there is considerable evidence that cuprates fall into the 3D-XY universality class [14,16,46,47], the inhomogeneity induced in the size elects [46,47] and the crossovers to 2D-Q SI and 3D-Q SN criticality make it discult to extract critical exponents unambiguously. For this reason we concentrate on the universal relations between critical amplitudes, their zero temperature counterparts and T_c , because these quantities can be measured with reasonable accuracy.

The paper is organized as follows. In Sec.II we sketch the universal relations for anisotropic type II superconductors falling into the 3D-XY universality class and undergo a crossover to 2D-QSI criticality. Expressing the critical amplitudes of the penetration depths in terms of their zero temperature counterparts, we not remarkable agreement with the plot shown in Fig. 3 and the experimental data for La_{2-x}Sr_xCuO₄ [9,45,48 [50] and Pr_{2-x}Ce_xCuO₄ [51], where the doping dependence of the quantities of interest have been studied. In this context it should be recognized that the ratio between the critical amplitudes of the penetration depths and their zero temperature counterparts is not expected to be universal. However, the impressive agreement reveals that the doping and family dependence of this ratio is rather weak. In any case, the unprecedented consistency of the experimental data with 3D-XY universality and the crossover to the 2D-QSI critical point, together with the evidence for the competition between anisotropy and superconductivity raise again serious doubts whether 2D mechanisms and models [19] can explain these essential observations.

As the isotope e ects are concerned, we con im previous scaling relations between the e ect on transition temperature and penetration depths [52,53] and derive new relations including the isotope e ect on the conductivity and Hall constant. Furtherm ore, the origin of the oxygen isotope e ects is traced back to a change of the c-axis correlation length. It in plies a change of d_s , a shift of the underdoped lim it (x_u in Fig. 1) and a reduction of the concentration of m obile carriers, accompanied by a change of the Hall constant. Noting that the change of the lattice constants upon oxygen isotope exchange is negligibly small [54,55] these isotope shifts reveal the existence and relevance of the coupling between the super uid and volume preserving local lattice distortions. Furtherm ore, we review the experim ental data for the combined isotope and nite size e ects [56]. They open a door to probe the coupling between local lattice distortions and superconductivity rather directly in terms of the isotope shift of Lo, the spatial extent of the hom ogeneous superconducting grains along the c-axis. Noting that $L_c=L_c$ is rather large this change con m s the coupling between super uidity and local lattice distortion and this coupling is likely in portant in understanding the pairing mechanism. Finally it is shown that the e ect of hydrostatic pressure on the transition temperature and the in-plane penetration depth of YBa₂Cu₄O₈ [57] is consistent with 3D-XY universality as well. Thus the remarkable agreem ent with 3D-XY scaling and the evidence for the crossover to the 2D-QSI quantum critical point single out 3D and anisotropic m icroscopic models which incorporate local lattice distortions, fall in the experimentally accessible regin e into the 3D-XY universality class, and incorporate the crossover to 2D-QSI criticality where superconductivity disappears.

II. EXPERIM ENTAL EVIDENCE FOR THE UNIVERSAL 3D-XY-AND 2D-QSI-SCALING RELATIONS AND THEIR IMPLICATIONS

It is well-established that strongly type-II m aterials should exhibit a continuous normal to superconductor phase transition, and that su ciently close to T_c , the charge of the order parameter—eld becomes relevant [58]. However, in cuprate superconductors within the—uctuation dominated regime, the region close to T_c where the system crosses over to the regime of charged—uctuations turns out to be too narrow to access. For instance, optimally doped YBa₂Cu₃O₇—, while possessing an extended regime of critical—uctuations, is too strongly type-II to observe charged critical—uctuations [14,16]. Indeed, the e—ective dimensionless charge e===1= is in strongly type II superconductors (>>1) small. The crossover upon approaching T_c is thus initially to the critical regime of a weakly charged super—uid where the—uctuations of the order parameter are essentially those of an uncharged super—uid or XY-m odel [59]. Furtherm ore, there is the—nite size e—ect due to inhom ogeneities which makes the asymptotic critical regime unattainable [46,47]. Thus, as long as the charge of the pairs is negligibly small the cuprates are expected to fall along the phase transition line T_c (x) into the 3D-XY universality class. A universality class is not only characterized by its critical exponents but also by various critical-point am plitude combinations [41]. In particular 3D-XY universality

extended to anisotropic system s [14,16] then in plies that the transition temperature T_c and the critical amplitudes of the penetration depths $_{ab0}^{tr}$ and transverse correlation lengths $_{ab0}^{tr}$ are not independent but related by [14,16]

It holds, as long as cuprates fall into the 3D-XY universality class, irrespective of the doping dependence of T_c , $^2_{ab0}$ and $_{c0}$. For this reason it provides a sound basis for universal plots. However, there is the serious drawback that reliable experimental estimates for T_c and the critical amplitudes $_{ab0}$ and $_{c0}$ measured on the same sample are not yet available. Nevertheless, some progress can be made by noting that by approaching the 2D-QSI transition the universal scaling form (9) should match with Eq. (5). This requires




FIG. 4. T_c vs. $1 = \frac{2}{ab}$ (0) for $La_2 \times Sr_x CuO_4$. D at taken from U em ura et al. [45,48] and P anagopoulos et al. [9]. The straight line is Eq. (5) with $R_2 d_s = 6.5A$ and the arrow indicates the ow to 2D-Q SI transition criticality.

holds. In Fig. 4 we displayed T_c vs. 1= $^2_{ab}$ (0) for La_2 $_xSr_xCuO_4$ taken from U em ura et al. [45,48] and P anagopoulos et al. [9]. The straight line is Eq. (5) with $R_2d_s=6.5A$ and the arrow indicates the ow to 2D-QSI transition criticality. Thus, when both T_c and 1= $^2_{ab}$ (0) increase, T_c values below $T_c=\frac{^2}{_0}R_2=6$ 3k_B $d_s=\frac{^2}{_{ab}}$ (0) (Eq. (5)) require $_{c0}$ to fallo from its limiting value $_{c0}=d_sR_2$ $^2_{ab}=f$.


The doping dependence of $_{c0}=_{ab}^{2}$ deduced from Eq. yielding the limiting value $_{c0}$ (x = 0.05) = $_{ab}^2$ 14:34A and f $_{c0}$ (x = 0.05) = $_{ab}^2$ = R₂d_s 6:5A used in Fig. 4. An essential result is that $_{c0}$ adopts in the underdoped limit (x ' 0.05) where the 2D-Q SI transition occurs and T_c vanishes its maximum value $_{c0}$ = $_{ab}^2$ 14:34A, which is close to the c-axis lattice constant c ' 13:29A. Thus, a nite transition temperature requires a reduction of $_{c0}$, well described over an unexpectedly large doping range by Eq. (12). With the doping dependence of (Eq. (2)) Eq. (8) transforms to

revealing that the doping dependence of the c-axis correlation length $_{\rm c0}$ is intimately related to the anisotropy . Hence, a nite ${\rm T_c}$ requires unavoidably a nite anisotropy .






FIG. 5. a) T_c $^2_{ab}$ (0) / $_{c0}$ = $^2_{ab}$ vs. T_c and T_c $^2_{ab}$ (0) / $_{c0}$ = $^2_{ab}$ vs. x for La_2 $_xSr_xCuO_4$. Data taken from Pangopoulos et al. [9] and U em ura et al. [48]. The solid line indicates the behavior in the underdoped and the dashed one in the overdoped regime, while the dotted line corresponds to Eq. (12) in the form T_c $^2_{ab}$ (0) = 37 | 156(x | 0.047). b) I_c I_c I_c I_c I_c I_c for the same data with I_c I_c

The lesson is, that superconductivity in La_{2-x} Sr_xCuO₄ is an anisotropic but 3D phenom enon which disappears in the 2D lim it. From the plot $1=\frac{2}{ab}$ (0) vs. $\frac{2}{ab}T_c=\frac{2}{c0}$ displayed in Fig. 5b, where according to Eq.(11) universal behavior is expected to occur, the data is seen to fall rather wellon a straight line. This is signicant, as moderately underdoped, optimally and overdoped La_{2-x} Sr_xCuO₄ falling according to Fig. 4 wello the 2D-Q SI behavior T_c / $1=\frac{2}{ab}$ (0) now scale nearly onto a single line. Thus the approximate 3D-XY scaling relation (11), together with the empirical doping dependence of the c-axis correlation length (Eqs. (12) and (13)) are consistent with the available experimental data for La_{2-x} Sr_xCuO₄ and uncovers the relevance of the anisotropy. However, the linear doping dependence of c is not expected to hold closer to the overdoped limit (x 0.27) where a 3D quantum superconductor to normal state (3D-QSN) transition is expected to occur [14,16]. Clearly, a full test of the scaling relation (11) requires independent experimental data for the critical amplitude c of the in-plane correlation length. To identify the observable probing this correlation length we note that close to 2D-QSI criticality the sheet conductivity and conductivity are related by c sheet = c ds c db so that the universal relation (5) can be rewritten in the form

where $h=4e^2=6.45k$ is the quantum of resistance and $_0$ is a dimensionless constant of order unity [60]. Away from 2D-QSI criticality $_{c0}$ can be expressed as




FIG.6. $_{ab}$ vs. x for La $_{2}$ $_{x}$ Sr $_{x}$ CuO $_{4}$ derived from the data of K om iya et al. [49] and Sato et al. [50]. $_{ab}$ is determined above T_{c} from $_{ab}$ (T) in terms of a linear extrapolation yielding $_{ab}$ = $_{ab}$ T_{c}^{+} . The solid line indicates the consistency with a nearly linear doping dependence.

with $_{ab}$ determined from $_{ab}$ (T) above T_c by linear extrapolation yielding $_{ab} = _{ab}$ (T_c^+). Up to the non-universal factor s_{ab} 1 this resistivity is expected to reject the doping dependence of the critical amplitude $_{c0}$. To demonstrate this behavior we displayed in Fig. 6 $_{ab}$ vs. x for La_2 $_xSr_xCuO_4$ derived from the data of K om iya et al. [49] and Sato et al. [50]. $_{ab}$ is derived from $_{ab}$ (T) by linear extrapolation yielding $_{ab} = _{ab}$ (T_c^+). The solid line points to a nearly linear doping dependence, consistent with the behavior shown in Fig. 5a, derived from T_c $_{ab}^2$ (0) / T_c $_{ab}^2$ (0) and T_c $_{ab}^2$ (0) and T_c $_{ab}^2$ (0) and T_c $_{ab}^2$ (0) and T_c $_{ab}^2$ (11) data for T_c $_{ab}^2$ (0) and T_c $_{ab}^2$ (12) and T_c $_{ab}^2$ (13) departments oncentrations, should then scale as

Thus, in the plot $1=\frac{2}{ab}$ (0) vs. $T_{c\ ab}$ or $T_{c}=$ ab the data should tend to fall on a straight line, while deviations are attributable to the non-universal nature of the ratio $\frac{2}{ab}=s_{ab}$. Indeed $\frac{2}{ab}=s_{ab}$ does not necessarily adopt a unique value.




FIG.7.a) T_c vs. (0) / $1=\frac{2}{ab}$ (0) for Y $_{0:8}$ C $a_{0:2}$ -123, T H-212 and T H-2201 taken from Bernhard et al. [61] and N iederm ayer et al. [62]. The solid curves indicate the ow from optim um doping to 2D-Q SI criticality and the dashed ones the crossover to the 3D-Q SN transition in the overdoped lim it. b) T_c vs. $T_c=(0)$ / T_c $\frac{2}{ab}$ (0) / $\frac{2}{c0}$ for the same data. The solid lines indicate the underdoped and the dashed ones the overdoped regim e.

To dem onstrate that this behavior is not an artefact of La_{2-x} Sr_xCuO₄ we displayed in Fig. 7a the SR data T_c vs. (0) / $1 = \frac{2}{ab}$ (0) for Y_{0.8}Ca_{0.2}Ba₂ (Cu_{1-y}Zn_y)O₇ (Y_{0.8}Ca_{0.2}-123), Tl_{0.5-y}Pb_{0.5+y}Sr₂Ca_{1-x}Y_xCu₂O₇ (T H212) and TlBa₂CuO₆₊ (T H2201) taken from Bemhard et al. [61] and N iederm ayer et al. [62]. Noting that in these materials the relationship between T_c, $1 = \frac{2}{ab}$ (0) and the dopant concentration is much less obvious, we displayed in Fig. 7b the behavior of the critical amplitude of the c-axis correlation length in terms of T_c vs. T_c= (0) / T_{c-ab} (0) / c₀. Noting that in analogy to La_{2-x}Sr_xCuO₄ (see Fig. 4) T_c vs. (0) / $1 = \frac{2}{ab}$ (0) resembles the outline of a y's wing, it becomes evident that the behavior of T_c vs. c₀, resembling the doping dependence of T_c in La_{2-x}Sr_xCuO₄ (see Fig. 5a), appears to be generic. At the 2D-Q SI transition c₀ adopts a nite value c₀ = d_sR_{2-ab}=f, it decreases with increasing transition temperature and decreases further as the maximum transition temperature is passed.





FIG.8.a) T_c vs. x for Pr_2 $_xCe_xCuO_4$;b) T_c vs. $1=\frac{2}{ab}$ (0). D at taken from K im et al. [51].

Further evidence for this behavior stems from the in-plane penetration and resistivity data of K in et al. [43] for the n-type cuprate P $\rm r_2$ $_{\rm x}$ C e $_{\rm x}$ C uO $_{\rm 4}$, which extends over the range 0:124 $\rm x$ 0:144. From Fig. 8a it is seen that in analogy to p-doping there is an insulator to superconductor quantum transition at som e $\rm x_u$. For $\rm x > x_u$ T $_{\rm c}$ increases monotonically, adopts its maximum value at optimum p-doping and decreases in the overdoped regime. Given this analogy between the doping dependence of T $_{\rm c}$ of p- and n-type cuprates one expects that T $_{\rm c}$ vs. 1= $^2_{\rm ab}$ (0) uncovers essentially the behavior of the p-type cuprates shown in Figs. 4 and 7a. A glance to Fig. 8b shows that this indeed the case. A coordingly, P r $_{\rm 2}$ $_{\rm x}$ C e $_{\rm x}$ C uO $_{\rm 4}$ is expected to undergo a 2D-Q SI transition at som e x $_{\rm u}$.




FIG.9.a) $_{c0}$ / T_{c} $_{ab}^{2}$ (0) vs.x and $_{ab}$ vs.x for Pr₂ $_{x}$ Ce $_{x}$ CuO $_{4}$ derived from the data of K in et al. [43]; b) $1=\frac{2}{ab}$ (0) vs. $T_c = ab$ for the same data. The solid lines line is $1 = \frac{2}{ab}$ (0) = 52 10 5 $T_c = ab$ and the dashed one $1 = \frac{2}{ab}$ (0) = 2.5 10 5 $T_c = ab$.

Indeed the doping dependence of $_{c0}$ / T_c $_{ab}^2$ (0) displayed in Fig. 9a is rather analogous to that in La_{2 x}Sr_xCuO₄ shown in Fig. 5a and $_{c0}$ is seen to scale as $_{ab}$, in agreem ent with Eq. (16). In this view it is not surprising that in the plot 1= $_{ab}^2$ (0) vs. T_c = $_{ab}$ shown in Fig.9b the data fall nearly on a straight line. The solid and dashed lines will be discussed later.

In any case, since Eq. (9) is universal, it holds for all cuprates falling in the accessible critical regime into the 3D-XY universality class, irrespective of the doping dependence of T_c , $\frac{2}{ab0}$, and c0. Since charged criticality is accessible in the heavily underdoped regime only [63], Eq. (9) rewritten in the form

provides a sound basis for universal plots. However, as aforem entioned there is the serious drawback that reliable experim ental estim ates for the critical amplitudes and the anisotropy at Tc measured on the same sample and for a variety of cuprates are not yet available. Nevertheless, as in the case of La2 x Srx C uO4 outlined above, progress can be made by invoking the approximate scaling form (11), by expressing the critical amplitude of the penetration depths by there zero tem perature counterparts (Eq.(10)). The universal relation (17) transform s then to

which will be used to explore the relationship between the isotope e ects on the transition temperature and the zero tem perature penetration depths. As aforem entioned a full test of this scaling form requires an independent experim ental determ ination of the critical amplitudes of the correlation lengths abo and co. We have seen that this is achieved in terms of the conductivity. Introducing i^{c} , the real part of the frequency dependent conductivity i^{c} (!) in direction i extrapolated to zero frequency at T $_{\rm c}$ [29], one obtains in analogy to Eq. (11)

because $\frac{dc}{ab} = \frac{dc}{c} = \frac{2}{a}$ and with that $s_{ab} = s_c$. To check this relation we note that the 2D-Q SI scaling form (14) yields




FIG.10. $^2_{ab;c}$ (0) T_c $^{dc}_{ab;c}$ 5:210 4 vs. 1= $^2_{ab;c}$ (0) for the data shown in Fig. 5. : c-axis; : ab-plane.

with $_{ab}$ (0) in m,T in K and $_{ab}^{dc}$ in (1 cm 1), the structure of the ab-expression is recovered. In Fig. 3 we displayed 1= $_{ab}^{2}$ (0) vs. T_{c} $_{ab}^{dc}$ and 1= $_{c}^{2}$ (0) vs. T_{c} $_{c}^{dc}$ as collected by Hom es et al. [29]. Noting that the linear relationship extends over six decades this plot represents unprecedented evidence that all these cuprates fall into the 3D-XY universality class, where the approximate scaling form (18) applies. Since the ab-plane and caxis data are well described by the same line, namely $1 = \frac{2}{ab;c}$ (0) ' $5.2 \ 10^{-5}$ T_c $\frac{dc}{ab;c}$, it follows that $\frac{2}{ab} = \frac{2}{c}$ is close

to one and $^2_{ab}$ =sab adopts a nearly unique value. Note that such line is also consistent with the 2D-QSI scaling form (21). In particular for R_{2 0} = 1:98 these lines coincide. The fact that all points of $l=\frac{2}{ab}$ (0) vs. $T_c \frac{dc}{ab}$ (open symbols) nearly fall onto a single line is signicant, as moderately underdoped, optimally and overdoped materials, which fell well of the 2D-QSI behavior $T_c / l=\frac{2}{ab}$ (0) (see Figs. 4, 7a, and 8a) now scale nearly onto a single line, in agreement with Figs. 5b and 9b. Although the agreement, extending over 6 decades in the scaling variables is impressive, the plot $^2_{ab;c}$ (0) $T_c \frac{dc}{ab;c}$ 5210 4 vs. $l=^2_{ab;c}$ (0) displayed in Fig. 10 reveals that there are deviations, ascribable to experimental uncertainties and the fact that $^2_{ab} = ^2_c$ and $^2_{ab} = s_{ab}$ are non-universal quantities of order 1. The non-universality of $^2_{ab} = s_{ab}$ clearly emerges from the data for Pr₂ $_x$ Ce_xCuO₄ displayed in Fig. 9b, pointing to $l=^2_{ab}$ (0) = 2.5 10 5 $l=^5_{ca}$ (dashed line) in contrast to $l=^2_{ab}$ (0) = 5.2 10 5 $l=^5_{ca}$ (solid line).

In any case, the overall in pressive evidence for an isotropic 3D -X Y scaling raises again serious doubts that 2D m odels [19] are potential candidates to explain superconductivity in the cuprates. Indeed, the doping or T_c dependence of the c-axis correlation length is an essential ingredient (see Figs. 5a, Fig. 7b and Fig. 9a). Furtherm ore, since both, $1=\frac{2}{ab}$ (0) and $1=\frac{2}{c}$ (0) tend to zero by approaching 2D-Q SI criticality, this plot also uncovers the ow to this quantum critical point, as indicated by the arrow in Fig. 3.

Having established the remarkable reliability of the scaling relations (18) and (20) we are now prepared to discuss the isotope elects on T_c and the zero temperature in-plane penetration depth. Since Eq. (5) is universal, it also in plies that the changes T_c , d_s and $T_c = \frac{2}{ab}$ ($T_c = 0$), induced by pressure or isotope exchange are not independent, but close to 2D-Q SI criticality related by [52]

Approaching 2D-QSI criticality m atching requires $c_0 = \frac{2}{ab} = c_0 = \frac{2}{ab}$! $d_s = d_s$. For the oxygen isotope e ect (16 O vs. 18 O) on a physical quantity X the relative isotope shift is defined as $X = X = (^{18}X)^{-16}X$. In this case the effect has been traced back to a change of the critical amplitude of the c-axis correlation length upon oxygen isotope exchange. Another implication is that the absence of a substantial isotope e ect on the transition temperature, e.g. close to optimum doping, is not of particular significance. In this case what is left is the effect on the in-plane penetration depth.

In Fig. 11 we show the data for the oxygen isotope e ect in La₂ $_x$ Sr_xCuO₄ [64,65], Y₁ $_x$ Pr_xBa₂Cu₃O₇ [65,68] and YBa₂Cu₃O₇ [65,68], extending from the underdoped to the optimally doped regime, in terms of (ab (0)) =

 $_{ab}$ (0) versus $\,T_c=T_c$. It is evident that there is a correlation between the isotope e ect on T_c and $_{ab}$ (0). Indeed, approaching the 2D-Q SI transition, as marked by the arrow, the data tends to fall on the straight line, which is Eq. (22). This yields for the isotope e ect on d_c the estimate $d_s=d_s=3.3\,(4)\%$. Approaching optimum doping, this contribution renders the isotope e ect on T_c considerably smaller than that on $_{ab}$ (0). In fact, even in nearly optimally doped YBa2Cu3O $_7$, where $T_c=T_c=0.26\,(5)\%$, a substantial isotope e ect on the in-plane penetration depth, $_{ab}$ (0) = $_{ab}$ (0) = $_{2.8}\,(1.9)\%$, has been established by direct observation, using the novel low-energy muon-spin rotation technique [68].




FIG. 11. Data for the oxygen isotope e ect in underdoped La_{2 x}Sr_xCuO₄ (: x=0.15 [65], N: x=0.08, 0.086 [64]), Y_{1 x}Pr_xBa₂Cu₃O₇ (: x=0, 0.2, 0.3, 0.4 [65{67]) and YBa₂Cu₃O₇ (H [65], [68]) in terms of (ab (0)) = ab (0) versus - T c=Tc. In the direction of the arrow the solid line indicates the low to 2D-QSI criticality and provides with Eq. (22) an estimate for the oxygen isotope e ect on d_s, namely d_s=d_s = 3.3(4)%.

Fig. 11 also shows that away from 2D-QSI criticality the experimental data does no longer fall onto the straight line. Since in the underdoped regime $c_0 = c_0^2 =$




FIG. 12. a) Data for the oxygen isotope e ect in La_{2 x} Sr_xCuO₄ (N : x= 0.086 [64], x=0.105 [65], 0.15 [69] in terms of T $_{c}$ =Tc + 2 ($_{ab}$ (0)) = $_{ab}$ (0) vs. x. For comparison we included the experimental data () for 1= $_{c0}$ / 1= Tc $_{ab}$ (0) vs. x and the solid curve is taken from Eq. (12). b) T $_{c}$ =Tc + 2 ($_{ab}$ (0)) = $_{ab}$ (0) vs. Tc of Y_{1 x}Pr_xBa₂Cu₃O₇ (N: x=0, 0.2, 0.3, 0.4) [56,70]. The experimental data () for 1= $_{c0}$ / 1= Tc $_{ab}$ (0) vs. Tc are included for comparison.

C learer evidence for this scaling behavior of the isotope e ect on the amplitude of the c-axis correlation length em erges from Fig. 12b showing $T_c=T_c+2$ ($_{ab}$ (0))= $_{ab}$ (0) vs. T_c and $1=_{c0}$ / $1=_{c0}$ $T_c=T_c+2$ ($_{ab}$ (0) vs. $T_c=T_c+2$ ($_{ab}$ (




FIG.13. $T_c^2_{ab}$ (0) vs. T_c for Y_1 xPrxBa2Cu3O7 taken from [56] and ab T_c^+ vs. T_c taken from Maple et al. [71] and D alichaouch et al. [72].

 Y_1 $_x$ P_{r_x} B_{a_2} C_{u_3} O_7 . This opens a window onto the origin of the unconventional isotope elects in the cuprates. Indeed, there is the evidence for a nearly linear doping dependence of $_{c0}$, namely $_{c0}$ d_s b (see Eq.(12)) and Figs. 5a, 6 and 9a) and the limiting behavior $_{c0}$! d_s (Eq. (16). To substantiate this point we displayed in Fig. 13 the experimental data for Y_1 $_x$ P_{r_x} B_{a_2} C_{u_3} O_7 in terms of T_c $_{ab}^2$ (0) vs. T_c [56] and $_{ab}$ (T_c^+) vs. T_c [71,72]. Apparently, the scaling relations (19) and (20), requiring $_{c0}$ / T_c $_{ab}^2$ (0) / $_{ab}$ (T_c^+) are well confirmed.

Together with the weak doping dependence of $_{c0}$ resulting from the evidence for $_{c0}$ = $_{c0}$ / 1= $_{c0}$ (Fig. 12b) these constraints in ply that




FIG.14. Schem atic sketch of the oxygen isotope e ect on the phase diagram of La₂ $_x$ Sr $_x$ CuO₄ close to the underdoped lim it where the 2D-QSI transition occurs. The solid lines are the phase transition lines T_c (x). Since the magnitude of $T_c = ^{16} T_c$ $^{18} T_c$ increases with reduced x the underdoped lim it shifts from $^{16} x_u$ to $^{18} x_u$. The arrow at xed x indicates the reduction of T_c upon complete oxygen isotope exchange (16 O! 18 O) and the dashed lines the mobile carrier concentration $^{16;18} = x$ $^{16;18} x_u$.

where = x x_u is the concentration of the mobile charge carriers. To appreciate the implications it is instructive to consider the phase diagram of La_{2 x} Sr_xCuO₄ displayed in Fig.14.

G iven the experim ental fact that x and the lattice constants do not change upon complete oxygen isotope exchange (16 O ! 18 O) [54,55], while T_c is lowered and T_c increases by approaching the underdoped \lim \pm , \inf follows that this \lim \inf shifts from $^{16}x_u$ to $^{18}x_u$. Hence, for x ed x La $_x$ $_x$ Sr $_x$ CuO $_4$ becomes in the interval $^{16}x_u$ < x < $^{18}x_u$ an insulator and the shift of the underdoped \lim \inf from $^{16}x_u$ to $^{18}x_u$ leads to a reduction of the concentration of the mobile charge carriers, as indicated in Fig. 14. The lesson then is, the unconventional isotope e ects in the cuprates stem

from the shifts of d_s and the underdoped \lim it x_u . Since the volume of the unit cell is preserved this changes in ply local lattice distortions. Consequently, the isotope shifts of T_c and $_{ab}$ (0) are not related by scaling relations in posed by 3D-XY universality only, but reveal the existence and relevance of the coupling between the super uid and volume preserving local lattice distortions.

This lesson appears to contradict interpretations based on the London formula [73]

where n_s is the number density of the super uid and m_{ii} the elective mass of the pairs in direction i. There is the experimental evidence that the lattice constants do not change upon complete oxygen isotope exchange (^{16}O ! ^{18}O) [54,55]. Furthermore, recent nuclear quadrupole resonance (NQR) studies of ^{16}O and ^{18}O substituted optimally doped YBa₂Cu₃O₇ powder samples revealed that the change of the total charge density caused by the isotope exchange is less than 10^{-3} [68]. These experimental facts have then be taken as evidence for a negligibly small isotope election on n_s [68]. However, in general the London relation is just a way of parameterizing experimental results, with no discernible connection to the carrier concentration or, e.g. the band mass. Indeed, even in conventional superconductors $1=\frac{2}{11}$ (0) is determined by normal state properties, namely the integral of the Fermi velocity over the Fermi surface. In the special case of spherical and ellipsoidal Fermi surfaces one recovers Eq. (26) in the form, $1=\frac{2}{11}$ ($1=\frac{2}{11}$ ($1=\frac{2}{11}$ or $1=\frac{2}{11}$ or

A lthough qualitative evidence for the oxygen isotope e ect on the resistivity emerges from the measurements on Y_1 $_x$ P_x B_{a_2} C_{u_3} O_7 [78], this relationship awaits to be tested quantitatively.

Further evidence for this coupling emerges from the combined isotope and nite size e ects. Recently, it has been shown that the notorious rounding of the superconductor to normal state transition is fully consistent with a nite size e ect, revealing that bulk cuprate superconductors break into nearly homogeneous superconducting grains of rather unique extent [14,46,47,56]. A characteristic feature of this nite size e ect on the temperature dependence of the in-plane penetration depth $_{ab}$ is the occurrence of an in ection point giving rise to an extrem um in d $_{ab}^2$ (T = 0) = $_{ab}^2$ (T) =dT at $_{p_c}$. Here $_{ab}^2$ ($_{p_c}$), $_{p_c}$ and the length $_{p_c}$ of the grains along the c-axis are related by [46,47,56]

Recently, the e ect of oxygen isotope exchange on L_c has been studied in Y_1 $_x$ Pr_x Ba_2 Cu_3 O_7 [56]. Note that the relative shifts of $^2_{ab}$ (T_{p_c}), T_{p_c} and L_c are not independent but according to Eq. (28) related by

which is just the nite size scaling counterpart of Eq.(23). Some estimates resulting from the nite size scaling analysis are listed in Table I. Several observations emerge. First, the spatial extent of the homogeneous domains L_c changes upon isotope exchange (16 O, 18 O). To appreciate the implications of this observation, we note again that for execution the lattice parameters remain essentially una ected [54,55]. A coordingly, an electronic mechanism, without coupling to local lattice distortions implies $L_c = 0.0$ n the contrary, a signicant change of L_c upon oxygen exchange requires local lattice distortions involving the oxygen lattice degrees of freedom and implies with Eq. (29) a coupling between these distortions and the super uid, probed by $_{ab}$ (T_{p_c}). Second, since the relative shift of T_{p_c} is very small the change of L_c is essentially due to the super uid, probed by $_{ab}$ (T_{p_c}). Third, L_c increases systematically with reduced T_{p_c} .

Table I: Finite size estimates for the relative changes of L_c , T_{p_c} and $\frac{2}{ab}$ (T_{p_c}) upon oxygen isotope exchange for Y_1 xP rxB a2C u3O 7 [56]. We have seen that the unconventional isotope shifts of T_c , ab (0) and L_c are not related by

scaling relations im posed by 3D-XY universality only, but reveal the existence and relevance of the coupling between the super uid and volume preserving local lattice distortions. Their response to isotope exchange shifts $d_{\rm s}$, $L_{\rm c}$ and the underdoped limit $x_{\rm u}$, accompanied by a reduction of the concentration of mobile carriers. These observations contradict the majority opinion on the mechanism of superconductivity in the cuprates that it occurs via a purely electronic mechanism involving spin excitations, and the lattice degrees of freedom are irrelevant.





FIG.15. a) Pressure dependence of T_c and $1 = \frac{2}{ab0}$ in YBa₂Cu₄O₈ taken from Khasanov et al. [57]. The dashed and solid lines are given by Eq. (30). b) Pressure dependence of $T_c = T_c$ and $T_c = T_c$ and

As aforem entioned the exact 3D-XY scaling relation (17) and its approximate counterpart (18) should also apply when pressure is applied. As does the isotope elect, there is a generic decrease of T_c with pressure in simplemental superconductors (Sn, Al, In, etc.). In cuprate superconductors the situation is considerably more complex because changes in both the local lattice distortions and lattice constants occur, and there are pressure-induced relaxation phenomena. In YBa₂Cu₃O₇ [79,80], Tl₂Ba₂Cu₀O₆₊ [81{83}], and other cuprates [84] the initial dependence of T_c on pressure often depends markedly on the pressure-temperature history of the sample. The relaxation phenomena responsible for this behavior are believed to originate from pressure-induced ordering of mobile oxygen defects in the lattice and the value of T_c appears to be a sensitive function of both the concentration and the arrangement of these defects. To avoid these dimensions we concentrate on YBa₂Cu₄O₈, exhibiting a spectacular increase of T_c under pressure by nearly 30K [85,86]. Furthermore, the pressure dependence of the critical amplitude abo have been studied as well [57]. The data displayed in Fig. 15a show that the pressure dependencies of T_c and T_c are initially nearly linear and positive, as indicated by the solid and dashed lines given by

As a result both $T_c=T_c$ and $1=\frac{2}{ab0}=1=\frac{2}{ab0}=2$ ab0=ab0 are positive and increase with pressure, as shown in Fig. 15b. This diers from the oxygen isotope elect where these quantities are negative (see Fig. 11). Nevertheless, the universal relation (17) in plies that these pressure induced changes are not independent but related by




FIG. 16. a) $T_c=T_c+2$ ab0=ab0 vs. p and T_c for YBa₂Cu₄O₈ derived from the data of K hasanov et al. [57]. The solid line follows from Eq. (30); b) c0 vs. p and C0 for YBa₂Cu₄O₈ derived from the data of K hasanov et al. [57] with the aid of Eq. (9). The solid line follows from Eqs. (17) and (30).

In Fig. 16a we displayed the experimental estimates for $T_c=T_c+2$ abo=abo vs. p and T_c for YBa2Cu4O8 derived from the data of Khasanov et al. [57]. For comparison we included the behavior resulting from Eq. (30). To interpret the data we invoke Eq. (9) to derive from T_c (p) and abo (p) the pressure dependence of co (p). A glance to Fig. 16b shows that co decreases with increasing pressure and transition temperature. Noting that YBa2Cu4O8 falls at zero pressure into the slightly underdoped regime this behavior can be compared with the T_c dependence of co in underdoped La2 $_x$ Sr_xCuO4 displayed in Fig. 5a. In this regime the rise of T_c in plies a reduction of co. Considering the behavior in the (co; T_c)-plane the hydrostatic pressure elect may then also be viewed as an inverse oxygen isotope elect co0. In this crossover is also related to the initial decrease of the a-Lattice constant under applied hydrostatic pressure [87]. Thus, we arrive at the following tentative scenario. If the layer is originally underdoped hydrostatic pressure enhances T_c and reduces both co0 and co0; if it is overdoped, it decreases T_c 1 increases co0 and reduces co0. This behavior can be anticipated from from Figs. 5a, 15 and 16 and uncovers again 3D-XY scaling and 2D to 3D crossover to be at work.

So far we concentrated on scaling relations emerging from the universal amplitude combination (17). There is a multitude of other combinations including the relation between magnetization, applied magnetic eld and T_c [14,88], as well as the universal relation between the critical amplitude A^+ of the specic heat singularity and the correlation volume V_c^+ [14,42]

A lthough the singular part of the species heat is small compared to the phonon contribution and inhom ogeneities set limits in exploring the critical regime [14,46] the measurements on nearly optimally doped YBa₂Cu₃O₇ [14,89] and La_{2 x}Sr_xCuO₄ [90] point clearly to 3D-XY critical behavior. Experimentally it is well established that the species heat anomaly and with that the critical amplitude A⁺ decreases dramatically by approaching the underdoped limit (2D-QSI criticality) [91{93}. Since V_c⁺ = $_{a0\ b0\ c0}$ $_{T_c}^2$ $_{c0}^3$ and $_{c0}$! d_s (see Figs. 4, 5a and 7b) while $_{T_c}^2$! 1 (see Eq. (2)) in the underdoped limit, this behavior is a consequence of the 3D-2D-crossover. Furthermore, combining the universal 3D-XY amplitude combinations (17) and (32) we obtain the universal relation

relating the critical amplitudes of specie cheat, anisotropy, in-plane penetration depth and anisotropy. Consequently, the pressure and isotope elects on these quantities are not independent but related by [53]

A lthough these universal 3D -X Y relations await to be tested experimentally they reveal again that as long as uncharged uctuations dominate these elects do not change \mathbb{T}_c only but uncover the coupling between energy-and super uid uctuations. To illustrate the dramatic decrease of the speciencheat anomally in the underdoped regime we plotted in Fig. 17 1= $\frac{2}{T=0}T_c^3$ $\frac{6}{ab}$ (0) vs. T_c for YBa₂Cu₃O₇ derived from the data of Trunin and Nefyodov [94]. In the heavily underdoped regime where T_c / 1= $\frac{2}{ab}$ (0) (see Eq. (5)) the magnitude of A⁺ is then manly controlled by the anisotropy which diverges at 2D-Q SI criticality (see Eq. (2) and Figs. 1b and 2)




FIG.17.1= $\frac{2}{T=0}T_{c}^{3}\frac{6}{ab}$ (0) vs. T_{c} for YBa₂Cu₃O₇ derived from the data of Trunin and Nefyodov [94].

A nother example is the universal relation between magnetization m, applied magnetic eld H and Tc [7,14],

for elds applied parallel (H_c) or perpendicular (H_{ab}) to the c-axis. Q_3C_3 is a universal constant [7,14]. Hence, the isotope and pressure elects on these quantities are not independent but related by

Although the isotope e ect on the magnetization is well established [64,66,77,78] these relationships await to be explored.

In sum mary, by taking experimental data for T_c , $a_{b;c}$ (0), $d_{ab;c}^c$ (T_c^+) = 1= $d_{ab;c}^c$ (T_c^+), = $c^ a_{b}^-$ of a variety of cuprates encompassing the underdoped and overdoped regimes, we have shown that these quantities are not independent but related by scaling relations rem iniscent to anisotropic systems falling into the 3D-XY universality class. They dier from the exact scaling relation by the ratio between the critical amplitudes of the penetration depths and their zero tem perature counterparts. However, the remarkable agreement revealed that the doping and family dependence of this ratio is rather weak. As the unconventional isotope e ects are concerned, the rather sparse experim ental data turned out to be consistent with the 3D-XY scaling relations, connecting the isotope e ects on To, ab (0) and the c-axis correlation length c. Guided by the doping dependence of cwe have shown that the oxygen isotope e ects are associated with a change of dy, a shift of the underdoped limit and a reduction of the concentration of m obile carriers. Since $_{\rm c}$ scales as $_{\rm c}$ / $_{\rm ab}$ (${\rm T_c^+}$) = 1= $_{\rm ab}$ (${\rm T_c^+}$) we obtained the approxim ate 3D -X Y scaling relation (4). It connects the relative isotope shifts of measurable properties and awaits together with Eq. (27), relating the shifts of Hall constant, resistivity and mobile carrier concentration upon oxygen isotope exchange, to be tested quantitatively. Qualitative evidence for the oxygen isotope e ect on the resistivity em erges from the measurements on Y_1 $_x$ P r_x B a_2 C u_3 O $_7$ [77] and on Pr-, Ca-, and Zn-substituted YBa₂Cu₃O₇ [78]. Furtherm ore, we have seen that the combined isotope and nite size e ects open a door to probe the coupling between local lattice distortions and superconductivity in terms of the isotope shift of Lc, the spatial extent of the hom ogeneous superconducting grains along the c-axis. Noting that Lc=Lc is rather large (see Table I) this change revealed the coupling between super $\,$ uidity and $\,$ local lattice distortion and this coupling is likely in portant in understanding the pairing $\,$ m $\,$ echanism $\,$.

Further evidence for 3D-XY scaling to be at work emerged from the elects of hydrostatic pressure on T_c and T_c and T_c as well as from the doping dependence of the special cheat singularity. Although the currently available experimental data of the pressure and isotope elects, as well as on the critical amplitudes are rather sparse, we have shown that a multitude of empirical correlations between T_c , magnetic penetration lengths, resistivity, conductivity, special cheat, etc. are fully consistent with the universal critical amplitude combinations for anisotropic systems falling into the 3D-XY universality class and undergo a crossover to a 2D quantum superconductor to insulator transition (2D-QSI). Not unexpectedly we have shown that these correlations are controlled by the doping or T_c dependence of the caxis correlation length T_c and the anisotropy T_c . Although much experimental work remains to be done, measuring the quantities of interest on the same sample, the remarkable consistency with 3D-XY scaling and the crossover to the 2D-QSI quantum critical point single out 3D and anisotropic microscopic models which incorporate local lattice distortions, fall in the experimentally accessible regime into the 3D-XY universality class, and incorporate the crossover to 2D-QSI criticality where superconductivity disappears.
