Large deviation techniques applied to system swith long-range interactions

We discuss a method to solve models with long-range interactions in the microcanonical and canonical ensemble. The method closely follows the one introduced by R.S. Ellis, Physica D 133, 106 (1999), which uses large deviation techniques. We show how it can be adapted to obtain the solution of a large class of simple models, which can show ensemble inequivalence. The model H am iltonian can have both discrete (Ising, Potts) and continuous (HMF, Free Electron Laser) state variables. This latter extension gives access to the comparison with dynamics and to the study of non-equilibrium elects. We treat both in nite range and slowly decreasing interactions and, in particular, we present the solution of the —Ising model in one-dimension with 0  $\,<\,1.\,$  K eywords: Long-range interactions, Large deviation techniques, Mean-eld limit.

A system with long-range interactions is characterized by an interparticle potential V (r) which decreases at large distances r slower than a power r with < d, d being the dimension of the embedding space [1]. Classical examples are self-gravitating [2] and Coulomb [3] systems, vortices in two-dimensional uid mechanics [4], wave-particles interaction [5, 6] and trapped charged particles [7]. The behaviour of such systems is interesting both from the dynamical point of view, because they display peculiar quasi-stationary states that are related to the underlying V lasov equations [8], and from the static point of view, because equilibrium statistical mechanics shows new types of phase transitions and cases of ensemble inequivalence [9]. In this paper we will restrict ourselves to the second aspect.

In long-range interacting systems, essentially all the particles contribute to the local eld: the uctuations around the mean value are small because of the law of large numbers. This explains qualitatively why the mean—eld scaling, which amounts to let the number of particles go to in nity at xed volume [10, 11], is usually extremely good. However, let us remind that for long-range interacting systems, microcanonical and canonical ensembles are not necessarily equivalent in the mean—eld limit [12, 13, 14]. Moreover, because of the non additivity of the energy, the usual construction of the canonical ensemble cannot be applied. This is the reason why the microcanonical ensemble is considered by some authors [2, 15] as the only \physically motivated one. Hence, it is extremely important to develop rigorous techniques to solve non trivial physical models in the microcanonical ensemble. One note in books the solution for the perfect gas, but generalizations to interacting particle systems are discult.

The goal of this paper is to advocate the use of large deviation techniques as a tool to explicitly derive m icrocanonical and canonical equilibrium solutions for a wide class of models. As a rst step in this direction, we will discuss here a general solution method to treat in full detail mean—eld models without short distance singularity. Large deviation techniques [16, 17] are now adays widely used. For example, Micheland Robert [18], using these techniques, rigorously derived the statistical mechanics of the two-dimensional Euler equations. The method was later used by Ellis et al. [19] to study other two-dimensional geophysical uids. The statistical mechanics of some models with discrete variables has been recently obtained using large deviation theory [9, 21, 22]. Besides presenting the solution method, we will show in this paper how it can be applied to models whose Hamiltonian depends on continuous state variables, like the so-called Hamiltonian Mean-Field (HMF) model [24, 25]; the interest being here to obtain solutions in the microcanonical ensemble of models which display a Hamiltonian dynamics, opening the possibility of studying also non-equilibrium e ects.

We will rst brie y introduce in Section I the large deviation technique. In Section II we will recall the dierent steps of the mathematical framework introduced in Ref. 19, necessary for a systematic application to long-range interacting systems: we will use the in nite range Potts model as a simple example. In a rst instance, we will then treat in nite range models with continuous variables. We will present in Section IIIA the solution of the HMF model [25] in the microcanonical ensemble and, in the following Section IIIB, we will consider the Colson-Bonifacion

m odel of Free Electron Lasers (FEL) [27], as an example of relevance for physical applications. In Section IV, we will show that these techniques can be applied also to cases where the interaction is not in nite range but distance dependent; the solution of the so-called —Ising model [28], in one dimension with 0 < 1, will be presented in full detail, allowing us to discuss also the role of boundary conditions. Finally, Section V will be devoted to conclusions and perspectives.

#### I. LARGE DEVIATION THEORY

We will present in this section the main ideas behind large deviation techniques, with an emphasis to applications. For a more rigorous mathematical treatment, we direct the reader to Refs. [16, 17].

## A. The large deviation principle

Let us consider the sam ple m ean of N  $\,$  independent real random  $\,$  variables X  $_k$  with the sam e distribution and zero  $\,$  average

The law of large numbers states that  $S_N$  tends toward the average  $x=hX_ki$ , namely 0, when N tends toward in nity. M oreover, if  $X_{ip}$  has a nite variance, since all hypotheses of the central lim it theorem are full led, the probability distribution P ( $\overline{N}S_N$  2 [k;x+dx]) converges towards a G aussian, hence the uctuations of  $S_N$  are of order  $1=\overline{N}$ . Typical questions of the large deviation theory are: W hat is the behavior of the tails of the distribution? W hat is the probability of a uctuation of order one of  $S_N$ , i.e. what is the value of P ( $S_N$  2 [k;x+dx])?

Let us be m ore speci c by discussing the usual example of the coin toss. We attribute to heads and tails of a coin the values  $X_k = +1$  and  $X_k = -1$ , respectively. The sum  $S_N$  can take (N+1) distinct x-values in the interval [-1;1]. For such values, using simple combinatorial analysis, one easily derives the probability distribution

which de nes the function I(x). M ore precisely, one can prove that for any interval  $|x_1; x_2| = [1;1]$ ,

In the language of large deviation theory, one states that  $S_N$  fulls a large deviation principle, characterized by the rate function I(x). If one interprets the coin toss experiment as a microscopic realization of a chain of N non-interacting Ising spins, it is straightforward to prove that, in the statistical mechanics vocabulary, I(x) corresponds to the negative of the Boltzmann entropy (divided by the Boltzmann constant) of a state characterized by a fraction x of up-spins. This is a rst simple example of the large deviation principle, and the main purpose of this paper is to present other examples of its use for more complicated and physically relevant systems.

#### B. Cram er's theorem

Cram er's theorem [17] allows one to derive the probability distribution  $P(S_N \ 2 \ [x;x+dx])$  in the large N-lim it, providing also a method to compute the rate function I(x). The theorem is formulated for multi-dimensional and identically distributed random variables  $X_k \ 2 \ R^d$ , d being the dimension of the space of the variables. We will formulate the theorem in an informal way, without emphasizing mathematical technicalities.

Let us de ne the function () as

where  $2\ R^d$ , \ " is the usual scalar product and h i is the average over the common probability distribution of the variables  $X_k$ . C ram er's theorem states that, if () < 1,8 2 R d, then the sample mean  $S_N$  satisfies the large deviation principle

with rate function I (x) (x 2  $\mathbb{R}^d$ ) given by the Legendre-Fenchel's transform of ln ,

The form ulation of the theorem is not restricted to discrete random variables: this will be important for our applications.

A heuristic proof of the theorem for the sim plest case  $X_k 2 R$  goes as follows. The probability of obtaining  $S_N = x_k$  with d the common probability distribution of each variable  $X_k$ , is given by

This formula can also be interpreted as the volume of the phase-space ( $X_1$ ; N; X under the microcanonical constraint that  $S_N = x$ . Using the Laplace transform of the D irac's —function, one obtains

where is a path on the complex -plane going from il to + il, which crosses the real axis at a positive value. Subsequent manipulations of this form ula lead to

where I(x) is given in formula (7) with d = 1. In the last step, a large N saddle-point approximation has been performed.

Most of the results contained in this paper will be obtained using Cram er's theorem, because the statistical variables of the models we will consider are identically distributed in space (mostly on a lattice). In all cases the function in is dierentiable, which also fulls the hypotheses of the Gartner-Ellis theorem [17].

# II. A GENERAL M ETHOD

In this Section, we will describe the use of the large deviation method to solve models with long-range interactions. As already mentioned, Michel and Robert [18] successfully used large deviations techniques to rigorously prove the applicability of statistical mechanics to two-dimensional uid mechanics, proposed earlier [29, 30]. Ellis et al. [19] have

developed and generalized this approach to solve two-dimensional geophysical systems with long-range interactions. Here, we will adopt Ellis et al.'s approach, emphasizing the dierent steps in the construction of them odynamic functions. The method will be exemplied discussing in detail the three-state Potts model with in nite range interactions. This simple example has been recently used as a toy model to illustrate peculiar thermodynamic properties of long-range systems [31]. The diluted three-state Potts model with short-range interactions has also been studied in connection with \small systems thermodynamics by Gross [32].

The Ham iltonian of the three-state Potts model is

The 1=N prefactor is introduced in order to keep energy extensive [33]. Each lattice site i is occupied by a spin variable  $S_i$ , which assumes three dierent states a, b, or c. A pair of spins gives a ferrom agnetic contribution J (J > 0) to the total energy if they are in the same state, and no contribution otherwise. It is important to stress that the energy sum is extended over all pairs (i; j): the interaction is in nite range.

The solution method consists of three steps.

Step 1: Identifying global variables

and  $!_N$  2  $_N$  be a speci c m icroscopic con guration. The rst step of the m ethod consists in associating to every m icroscopic con guration  $!_N$ , a global (coarse-grained) variable,  $(!_N)$ . Then, a new H am iltonian  $P_N$  can be de ned

If one can neglect  $R_N$  (! N ) with respect to  $F_N$  in the large N -lim it, then the H am iltonian can be expressed only in terms of the global variables. When considering the above denied in nite range Pottsmodel, the appropriate global variable is

where  $(n_a; n_b; n_c = 1 \quad n_a \quad n_b)$  are the fractions of spins in the three dierent states a; b; c. In this case, the H am iltonian expressed in terms of the global variable is

and coincides with the original Hamiltonian  $H_N$  even at nite N. In Section IV, we will discuss the -Ising model, for which  $R_N$  does not vanish.

The global variable is of nite dimension in our example, but could be of in nite dimension in other cases. For instance, could correspond to a local mass density in a gravitational system, or a coarse-grained vorticity density in 2D turbulence.

Although this type of rede nition of the Ham iltonian might appear to be possible in all cases, this is not true. For instance, in the case of short-range interactions, even after de ning a local density of a physical quantity (e.g. magnetization), when performing the large N-limit, no general argument exists to neglect  $R_{\rm N}$ . As a consequence, in such a case, the local density (e.g. the local magnetization) is not the appropriate macroscopic variable. However we will argue that such a procedure is, instead, viable in general for systems with long-range interactions on a lattice. Keeping the lattice spacing nite is important in order to regularize possible short distance singularities.

Step 2: Deriving an entropy functional for the global variables.

Because the mean-eld variables are not equiprobable, the number of microscopic congurations leading to a given value of does depend on itself. Then, one can de ne an entropy functionals (),

where the Boltzm ann constant has been set to unity,  $_N$   $_R$ ) is the number of microscopic congurations corresponding to a given value of  $_N$  I() is the rate function and  $_N$  =  $_N$  () is the total number of states. This is where large deviation theory applies; not only in proving that such an entropy functional exists, but also in providing a procedure to derive it explicitly.

If, besides the dynam ical variables which contribute to the global ones, the H am iltonian depends also on a number of variables  $n_{v}$  which is small with respect to N , it is easy to prove that these additional variables contribute to the entropy for a negligible term , proportional to  $n_{v}=N$ .

For the in nite range Potts model, it is possible to derive the entropy functionals () directly, using combinatorial arguments and the Stirling approximation in the large N-limit. However, let us follow instead the procedure given by Cramer's theorem as explained in Section IB. Expression (14) for , which is identied with x in Section IB, can be rewritten as

This variational problem can be solved exactly, giving  $\cdot = \ln n \cdot w$  ith ' = a;b;c. Hence,

Therm odynam ic entropy density is given by  $s() = I() + \ln N$ , where the normalization factor is N = 3 for the Potts model example, which recovers the result of the combinatorial approach.


Step 3: Microcanonical and canonical variational problems

To obtain the entropy as a function of energy density ", i.e. to solve a model in the microcanonical ensemble, after performing steps 1 and 2 of the solution method, one has to not the solution of the following variational problem [19]

This result is exact but it corresponds also to an \intuitive" mean-eld solution. Finally, let us notice that the total entropy density is intensive: there is no dierence in this respect with short-range interacting systems. When other conserved quantities exist, they must be taken into account when solving the variational problem in formula (23). Speci c examples will be discussed in sections (IIIA) and (IIIB).

For the in nite range Potts model (11), the variational problem is

This variational problem can be solved numerically. The microcanonical inverse temperature (") = dS=d" can then be derived: it is shown in Fig. 1 in the allowed energy range [ J=2; J=6]. Ispolatov and Cohen [31] have obtained the same result by determining the density of states. A negative specific heat region appears in the energy range [  $0.215 \, \text{J}$ ; J=6].

Let us now consider the canonical ensemble. The partition function, written in terms of the common probability distribution of the phase-space variables, is

where is the probability density of  $X_k$ . This is not the usual partition function, but diers from it only for a constant factor, which counts the number of states. Let us remark that we have also used the letter for the microcanonical

inverse tem perature. We will comment specically when the microcanonical inverse temperature diers from the canonical one due to ensemble inequivalence.

Approximating Hamiltonian H $_{\rm N}\,$  in the large N-limit with the one expressed in terms of the global variable , one gets

For in nite range models, formula (27) is exact for all N because the rest R  $_{\rm N}$  vanishes. Using formula (16), one obtains

where the \free energy" F ( ) is obtained solving the variational problem

Our \free energy" is the usual free energy multiplied by the inverse tem perature. This helps because physical states will correspond to minim a of such free energy also for negative inverse tem peratures.

In the case of the in nite range three-state Potts model, the canonical free energy can be explicitly derived solving the following variational problem

To obtain the caloric curve, one has to compute " = dF = d. Fig. 1 shows that at the canonical transition inverse temperature  $^{t}$  ' 2:75, corresponding to the energy " $^{t}$ =J' 0:255, a rst order phase transition appears, with an associated latent heat. The low energy \magnetized" phase becomes unstable, while the high energy \homogeneous" phase, which has the constant energy density, "=J = 1=6, is stabilized. In Fig. 1, the two dotted regions have the same area, respecting Maxwell's construction. At the inverse transition temperature, there is also a jump in the global variables ( $n_a$ ;  $n_b$ ;  $n_c$ ) which are the order parameters of the model.

This extremely simple example shows already ensemble inequivalence. In the microcanonical ensemble, there is no phase transition and the special heat becomes negative. On the other hand, in the canonical ensemble, there is a rest order phase transition with a latent heat. The caloric curves do not coincide. We observe that in the energy range of ensemble inequivalence, microcanonical temperatures, (dS=d") 1, do not coincide with any canonical one.

This is an example of the more general fact that entropy s(") is not always the Legendre-Fenchel transform of the free energy F (). A general discussion of ensemble inequivalence, both at the thermodynamic level and at the level of equilibrium macrostates, is provided in Refs. [19, 22], while a classication of phase transition and of ensemble inequivalence situations is reported in Ref. [23].

This concludes the general presentation of the dierent steps of the method to derive the statistical mechanics of long-range interacting systems.

## III. EXAMPLES

In this Section, we will discuss the application of the large deviation method to two examples which share the disculty of computing the entropy for a phase-space with continuous variables. When presenting the method, we

have discussed in parallelits application to a model with discrete variables, the in nite range three-state Potts model, which however could have been solved by direct states counting [31]. This latter approach cannot be used when the variables are continuous. Obtaining microcanonical entropy offen implies the solution of too complicated integrals, and indeed one does not not many examples of such solutions in the literature. On the contrary, the large deviation method is not restricted to discrete variables and we will show that it can even be simpler to use in such a case.

A. The Ham iltonian Mean Field model

The Hamiltonian Mean Field (HMF) model [24,25] is dened by the following Hamiltonian

where  $_{i}$  2 [0;2 [ is the position (angle) of the i-th article on a circle and  $p_{i}$  the corresponding conjugate variable. This system can be seen as representing particles moving on a unit circle interacting via an in nite range attractive (C < 0) or repulsive (C > 0) cosine potentialor, alternatively, as classical XY -rotors with in nite range ferrom agnetic (C < 0) or antiferrom agnetic (C > 0) couplings. The renormalization factor N of the potential energy is kept not only for historical reasons, but also because it simplies the derivation of the variational problems and makes the problem well dened. As we will see, this implies that the usual energy per particle and temperature are well dened in the N ! 1 limit. In the literature, some authors have treated the case in which the energy is not extensive. This leads to different thermodynamic limit behaviors [34, 48].

The canonical solution of this model has been derived using the Hubbard-Stratonovich transformation [25]. The microcanonical solution has been heuristically obtained, under the hypothesis of concave entropy in Ref. [35] and in a dierent form in Ref. [36]. In this section, we will derive both solutions with no additional hypothesis. We will verify that the two ensembles give equivalent predictions.

Step 1: Ham iltonian (32) can be rewritten as

By a direct inspection of H am iltonian (33), one can identify the global quantities  $u = \frac{1}{N} p_i^2$ , M  $_x$  and M  $_y$ . M oreover, since  $v = \frac{1}{N} p_i^2$  is a conserved quantity with respect to the dynamics denied by H am iltonian (32), it will be included in the global variable. Hence,

The Ham iltonian in terms of the global variable is

Step 2: The vector of local variables is  $X_k = (p_k^2; p_k; \cos_k; \sin_k)$ . The generating function is

Where  $I_0$  is the modi ed Bessel function of order 0. In the last expression, we have not reported the constant factor dpd which is nite because the domain of integration is bounded due to the niteness of the energy. The sign indicates that formula (38) is valid only at leading order; indeed, as  $\frac{1}{2}$  R [0;2], neither the Gaussian nor the Bessel functions are fully exact.

The large deviation functional is then given, apart from trivial constants, by

This variational problem can be solved for the \kinetic" subspace ( $_{\rm u}$ ;  $_{\rm v}$ ) separately from the \con gurational" one ( $_{\rm c}$ ;  $_{\rm s}$ ). The entropy as a function of the global variable is then

with =  $\frac{p}{c^2 + \frac{2}{s}}$  and  $\frac{1}{c}$  the solution of the variational problem in (42). Let us remark that Cauchy-Schwarz inequality implies that u  $v^2$ .

Step 3: It is therefore possible to derive the  ${\tt m}$  icrocanonical variational problem

We show here the solution of both variational problems in the case v=0 and C=1, for which a second order phase transition appears. Shifting v to non-vanishing values does not produce anything new, whereas the second order phase transition disappears for positive values of C.

Solving the sup condition in Eq. (42) leads to the consistency equation  $M = I_1$  ( )= $I_0$  ( ) m ( ), which determ ines the optim alvalue of ,  $\overline{\phantom{m}} = m^{-1}$  (M ). Using the energy constraint, Eq. (43) can be rewritten as

In order to determ ine the global maximum of S, let us note that in Eq. (45) M takes values in the interval [0;1[. M oreover, an asymptotic expansion shows that s  $(M;")^{M+1}$  (1=2)  $\ln(1 + M)$ , which diverges to 1 + M when M tends to 1. Thus, a global maximum of the continuous function s with respect to M exists and is attained inside the interval [0;1[. To determ ine this maximum one has set to solve the extremal condition

The unique solution of this equation is  $\overline{M} = 0$  for "> 1=4, while a non vanishing magnetization solution bifurcates from it at " = 1=4, originating the second order phase transition. One can indeed show that




FIG .2: Entropy versus energy (a) and free energy versus inverse temperature (b) for the HMF model (33) with C=1 and v=0. The dotted lines are traced at the phase transition point.

which clari es the stability change at "=1=4 of the  $\overline{M}=0$  solution. Formula (47) was also obtained in Ref. [26] in connection with the uctuations of the magnetization.




FIG.3: Inverse tem perature versus energy (a) and m agnetization versus energy (b) for the HMF m odel (33) with C = 1 and v = 0. The dotted lines are traced at the phase transition point.

Let us rem ark that (dS)=(d") is nothing but the inverse of twice the kinetic energy, which is the usualm icrocanonical temperature. Moreover, condition (46) coincides, as expected, with the consistency relation derived in the canonical ensemble [25]. In Fig. 2, we show the full dependence of the entropy on energy and the graph of the free energy versus the inverse temperature, obtained by solving numerically the consistency equation (46) in the low energy (temperature) range. In Fig. 3, we plot the caloric curve and the dependence of the order parameter on energy: the two ensembles give the same predictions because the entropy is concave.

In Appendix A, we discuss a dierent way of obtaining the microcanonical solution, which treats the kinetic part of the energy in a more traditional way, like, for instance, in gravitational dynamics [37]. The method showed in this section is of more general applicability.

#### B. The Colson-Bonifacio model for the Free Electron Laser

In the linear Free Electron Laser (FEL), a relativistic electron beam propagates through a spatially periodic magnetic eld, interacting with the co-propagating electrom agnetic wave; lasing occurs when the electrons bunch in a sublum inar beat wave [27]. Scaling away the time dependence of the phenomenon and introducing appropriate variables, it is possible to catch the essence of the asymptotic state by studying the classical Hamiltonian

The  $p_i$ 's represent the velocities relative to the center of mass of the N electrons and the conjugated variables  $_i$  characterize their positions with respect to the co-propagating wave. The complex electromagnetic eld variable,  $A = A e^{i'}$ , denote the amplitude and the phase of the dominating mode (A and A? are conjugate variables). is a

param eter which measures the average deviation from the resonance condition. In addition to the \energy" H, the total momentum  $P = \int_{j} p_{j} + N A^{2}$  is also a conserved quantity. Most of the studies of this model have concentrated on the numerical solution of H am iltonian (48), starting from initial states with a small eld A and the electrons uniformly distributed with a small kinetic energy. Then, the growth of the eld has been observed and its asymptotic value determined from the numerics. Our study below allows to not the asymptotic value of the eld analytically.

Step 1: Sim ilarly to the HMF case, Ham iltonian (48) can be rewritten as

Step 2: As rem arked in Step 2 of Section II, the contribution to the entropy of the two eld variables A, ', is negligible (of order 1=N). Hence, the function reduces to the one of the HMF model, see form ula (38). Finally, one obtains the same contributions to the kinetic and con gurational entropies, as shown in form ulas (41) and (42).

Step 3: De ning the total momentum density as = P = N, the microcanonical variational problem to be solved is

The non zero case can be reduced to the vanishing problem using the identity  $S("; ; ) = S(" ^2=2;0;$ ). From now on we will discuss only the zero momentum case, changing "+  $^2=2$ ! "and +!. This has also a practical interest, because it is the experim entally relevant initial condition [38].

The conditions for having a local stationary point are

where m  $^{1}$  is de ned in formula (46). It is clear that M = A = 0 is a solution of conditions (53) and (54): it exists only for positive ". We will limit ourselves to study its stability. It must be remarked that this is the typical initial condition studied experimentally in the FEL: it corresponds to having a beat wave with zero amplitude and the electrons uniform ly distributed. The lasing phenomenon is revealed by an exponential growth of both A and the electron bunching param eter M .

The second order derivatives of the entropy s (A; M), computed on this solution, are

The two eigenvalues of the Hessian are the solutions of the equation

The stationary point is a maximum if the roots of this equation are both negative. This implies that their sum S = (2 + = ") is negative and their product P = 2 = " 1 = " is positive. Recalling that we restrict to positive " values, the condition for the sum to be negative is "> =2 and the one for the product to be positive is "> 1=(2)with < 0. The second condition is more restrictive, hence the only region where the solution M = A = 0 exists and is stable is " > 1=(2) with < 0. When crossing the line " = 1=(2) ( < 0), a non zero bunching solution M 60) originates continuously from the zero bunching one, producing a second order phase transition. This analysis fully coincides with the one performed in the canonical ensemble in Ref. [39].

The maximum entropy solution in the region complementary to the one where the zero bunching solution is stable can be obtained [38] by solving num erically Eqs. (53) and (54). This corresponds to having a non zero eld intensity and bunching.

We have not completed in this case the study of the global stability of the dierent solutions, but we think that, in view of the possibility to map this model exactly onto the HMF model (see Appendix B), no surprise is expected and that the study presented here should fully represent all physical solutions.

## IV. THE ISING MODEL WITH 1=r INTERACTIONS

A lithe models that have been considered above are in nite range: interactions are independent of the distance and the energy can therefore be written exactly in terms of global variables. This is nomore valid for several important and physically relevant cases. Let us mention in particular the 1=r interaction law for gravity and Coulomb systems and the logarithm ic interaction for two-dimensional turbulence. A generalized 1=r interaction has been also introduced

and the resulting phase transitions have been analyzed [40]. In all these cases the interaction is singular at short-range. Interesting toy models (which generalize the HMF model) without a short distance singularity have been recently proposed [41, 42, 43, 44]. In these latter models, XY spins are put on a lattice and interact through a slow ly decreasing non integrable 1=r law ( < d). For what concerns studies in the microcanonical ensemble, is has been shown [42] that the thermodynamic behavior of these models is independent of the exponent, after one has adopted an appropriate renormalization of energy and temperature. Salazar et al. [45] have studied numerically the problem using microcanonical monte-Carlo simulations. Besides con ming the scaling properties with they have also shown that the number of states is of order exp(N). The exact solution of these models in the canonical ensemble has been obtained by Campa et al. [43] and Vollmayr-Lee and Luijten [44]. The scaling of the magnetization and of the energy curve with the exponent has been exhibited in full detail.

In this section, we will present a microcanonical solution of the one dimensional—Ising model, whose Hamiltonian is given by

where J>0 and spins  $S_i=1$  sit on a one-dimensional lattice with unitary spacing. The N<sup>-1</sup> prefactor is introduced in order to have an extensive energy. This model has been rst introduced by Dyson [28] and studied for the \integrable" case, > 1, in the canonical ensemble without the N<sup>-1</sup> prefactor. We will show that it is possible to obtain an exact microcanonical solution using large deviation theory, when 0 < 1. This solution can be easily generalized to lattices of larger dimension. In a preliminary paper [46], a microcanonical solution of this model was presented without rigorously proving the exactness of the mean-eld limit.

The study of this model will also give us the opportunity to emphasize the important role played by boundary conditions when the interactions are long-range. We will indeed consider both free and periodic boundary conditions. In the latter case, jie jj is the minimal distance along the circle where one identies the set and the (N + 1)-th lattice point.

In the solution we will adopt the same scheme described in Section II.

Step 1: The Ham iltonian H $_{\rm N}$  cannot be rewritten exactly using a nite dimensional global variable. We overcome this disculty by dening a coarse-grained function. Let us divide the lattice in K boxes, each with n = N = K sites, and let us introduce the average magnetization in each box m $_{\rm k}$ , k = 1:::K. In the limit N ! 1, K ! 1, K = N ! 0, the magnetization becomes a continuous function m(x), of the [0;1] interval. After a long but straightforward calculation, described in Appendix C, we can show that it is possible to express H $_{\rm N}$  as a functional of m(x):

The estimation is uniform on all con gurations.

Step 2: The probability to get a given m agnetization m  $_k$  in the k-th box from all a priori equiprobable m icroscopic con gurations obeys a local large deviation principle P (m  $_k$ ) / exp[ns(m  $_k$ )], with

Since the m icroscopic random variables in the di erent boxes are independent and no global constraints has yet been imposed, the probability of the full global variable (m  $_1$ ;:::; m  $_K$ ) can be expressed in a factorized form as

where  $S[m(x)] = \frac{R_1}{0} s(m(x)) dx$  is the entropy functional associated to the global variable m(x). Large deviation techniques rigorously justify these calculations [47], proving that entropy is proportional to N, also in the presence of long-range interactions. This result is independent of the specien odel considered; it applies, for instance, also to the long-range XY spin m odel studied by Salazar et al. [45].

Step 3: It is now straightforward to formulate the variational problem in the microcanonical ensemble





FIG.4: Equilibrium magnetization pro le for the -Ising model with free boundary conditions at an energy density " = 0.1 for = 0.2 (solid line), = 0.5 (dotted line) and = 0.8 (dashed line).

Let us remark that the optimization problem (62) has to be solved in a functional space. In general, this has to be done numerically, taking into account boundary conditions. In this paper, we consider only free and periodic boundary conditions. In the former case, the only available solutions are numerical. An example of a maximal entropy magnetization problem boundary conditions is shown in Fig. 4 for dierent values of . In the following of this section, we will treat the periodic boundary conditions case, for which analytical result can be obtained.

In the periodic boundary case, the distance is yj in the energy (57) is de ned as the minimal one on the circle, obtained when the two boundaries of the interval [0;1] are identied. Both entropy and free energy can be obtained in analytical form for hom ogeneous magnetization proles.

In Appendix D, we prove that for < c = (1) = (J2) there is a unique global maximum of S, corresponding to a constant zero magnetization pro le. The variational problem (62), where S is defined in Eq. (60), leads to the equation

where is a Lagrange multiplier. For > c, we restrict ourselves to solutions with constant magnetization proles, i.e. m(x) = m. We prove in Appendix D that these solutions are locally stable, i.e. close non constant proles have






FIG. 5: a) Equilibrium magnetization in the allowed energy range in the microcanonical ensemble for the —Ising model with = 0.5; the negative branch is also reported with a dotted line. b) Inverse temperature versus energy in the microcanonical ensemble (solid line). The canonical ensemble result superposes to the microcanonical one in the interval [c;1] and is represented by a dashed line for 2 [0; c]. c is then the inverse critical temperature in the canonical ensemble. In the microcanonical ensemble, no phase transition is present.

a smaller entropy. Moreover, these are the only solutions when = 0, since the right-hand-side of Eq. (63) is then independent of x. For constant proles, the relation between energy and magnetization is

where we have used  $^{R_1}_{0}$  dx jx yj = 2 = (1 ) and  $^{m}_{max}$  = 1=(2  $_{c}$ ). Hence, xing the energy in plies xing the magnetization and, consequently, the Lagrange multiplier in Eq. (63). Expressing the magnetization in terms of the energy in the entropy formula (60) allows to derive the caloric curve = dS=d". The consistency equation (63) has always a non vanishing magnetization solution in the whole energy range [0;  $^{m}_{max}$ ]: this is reported in Fig. 5(a). The caloric curve is shown in Fig. 5(b) with full line. The limit temperature  $_{c}$  is attained at zero magnetization, which is a boundary point.

In the canonical ensemble, one has to solve the variational problem (30). This leads to exactly the same consistency equation (63), where the Lagrange multiplier is replaced by the inverse temperature. Solving this consistency equation on the full positive axis, one nds a zero magnetization for < and non vanishing one for > . The caloric curve is obtained taking the derivative " = dF =d . The graph of this function is reported in Fig. 5 (b) and superposes to the microcanonical caloric curve from in nity down to  $_{\rm c}$  while it is represented by the dashed line for

It follows that in the region [0; c], the two ensembles are not equivalent. In this case, a single microcanonical state at "max corresponds to many canonical states with canonical inverse temperatures in the range [0; c]. Thus, in such a case, the canonical inverse temperature is not equal to the microcanonical one. In the microcanonical ensemble, the full high temperature region is absent and, therefore, no phase transition is present or, in other terms, the phase transition is at the boundary of the accessible energy values. The entropy is always concave, hence no inequivalence can be present in the allowed energy range, apart from the boundaries. This situation is called partial equivalence [19, 20]. This ensemble inequivalence persists for all values below one, and is removed only for [10, 10].

when  $\mathbf{w}_{\text{max}}$ ! 1 and  $\mathbf{w}_{\text{c}}$ ! 0: the phase transition is not present in both ensembles and the system is always in its magnetized phase.

The main drawback of this analysis is the di-culty to obtain analytical solutions of Eq. (63) for non-constant magnetization pro-les, which is the typical situation when boundary conditions are not periodic. However, we have shown that, for periodic boundary conditions, constant magnetization pro-les are locally stable (see Appendix D), but the proof of non-existence of generic magnetization pro-les with larger entropy, and hence the global stability analysis, remains to be done.

An advantage of the method we have exposed is its exibility and applicability to more complex models. For instance, some results of the kind presented here have been already obtained for the Blum e-Emery-Grithsmodel [9, 21].




FIG. 6: Entropy density versus energy density for the -Ising model but with periodic boundary conditions and with = 0.8. The solid curve represents the theoretical solution, whereas the dashed and dotted lines are determined by microcanonical Monte-Carlo simulations with N = 34 and N = 100, respectively (data provided by R. Salazar).

It is also interesting to check how fast one reaches the N ! 1 solution as one increases the number of spins N . Fig. 6 shows entropy density as a function of energy density for the -Ising model with = 0.8 and periodic boundary conditions. The gure emphasizes that the asymptotic result is already accurate enough for N = 100.

#### V. CONCLUSIONS AND PERSPECTIVES

In this paper we have discussed exam ples of the application of large deviation techniques to the study of the statistical mechanics of in nite-range models, at equilibrium, in the microcanonical and canonical ensembles. Besides that, we have shown how to construct a mean-eld H am iltonian for the Ising model in one dimension with 1=r interaction (0 < 1). The solution of simple toy models already shows interesting ensemble inequivalence features, like negative specic heat. A mong these simple models, one should point out those with continuous state variables, because the H am iltonian dynamics becomes accessible and one can then study also non-equilibrium features. Remarkable is also the solution of the Colson-Bonifacio model, which is believed to capture the phenomenology of the saturated state.

It is in portant to emphasize that the method proposed in this paper does not apply to all long-range interacting systems. In particular, those for which statistical mechanics cannot be reduced to a mean-eld variational problem are excluded. As presented in Section II, the method is strongly dependent on the possibility to introduce global or coarse-grained variables: examples are the averaged magnetization, the total kinetic energy, etc. The coarse-grained variables allow one to describe structures whose size is of the order of the total size of the system; however they may be insu cient to characterize the elect of short-range interaction. A typical example is the Ising model with attractive short-range interactions and repulsive long-range couplings studied by Grousson et al. [49]. The creation of large scale structures needs an in nite energy, because of the repulsive long-range component. However, the competition between repulsion and attraction can lead to interesting structures, such as alternating positive and negative magnetized stripes. Indeed, despite the long-range character of the interaction, this system is additive and these structures are therefore compatible with the predicted zero magnetization at large scale. Still in the context of canonical ensemble, worth quoting are the results of Kardar [50] who, analyzing an Ising model with both short-range and long-range interactions was able to derive the exact free energy by a minimization procedure. Obtaining similar results for the microcanonical entropy would be extremely in portant.

The application of the techniques described in this paper to more realistic N-body systems is an important issue. The extension to wave-particle interactions [6] should not be too dicult. The mean-eld description of the two-dimensional point vortices model [51] has been rigorously obtained in a series of papers [13, 52, 53]. On the contrary, due to the strong short-distance singularity, similar results for self-gravitating systems [2, 54] have not been obtained and are a challenging current issue. What is usually done is: i) in equilibrium, to conjecture the validity of the mean-eld description; ii) out-of-equilibrium, to consider the V lasov-Poisson equation as a good approximation of the short time dynamics. Once the mean-eld description is introduced at nite time (Euler equation, V lasov-Poisson equation), the statistical mechanics can be derived using large deviation techniques [18, 19]. However, it is not equivalent to the original statistical mechanics of the N-body system. Examples of this inequivalence, due to the exchange of the two limits t! 1 and N! 1, are given in Refs. [8, 38] for the HMF and the Colson-Bonifacio model.

Indeed, this expression of the entropy assumes the know ledge of the con gurational entropy s<sub>conf</sub>, which is determined by solving the extremal condition in Eq. (42), and is restricted to total vanishing momentum v = 0. Hence, the method given in the text is slightly more general.

## Appendix B: M apping the FEL model onto HMF

The microcanonical solution of the FEL model (See Eq. (48)) can be expressed in terms of the HMF Hamiltonian using the Laplace representation of the Dirac -function and a Gaussian integration. A fter performing the change of variables  $e_i = e_i$ , the microcanonical volume of the FEL is given by

The coarse-graining operator  $Y_{N,K}$  divides the lattice into K boxes of size n=N=K and de nes a locally averaged magnetization  $m_k$  in the  $k^{th}$  box  $B_k$ . The coarse-grained magnetization is then a step function, which takes a constant value

In the following, we will use free boundary conditions (The choice of periodic boundary conditions would change only some details of the calculation).

The proof relies on the long-range character of the interaction (0 < 1). It is straightforward but lengthy.

This quantity vanishes in the large N lim it if K diverges faster than N (and certainly slower than N). This is the rst point where the long-range nature of the interaction is used.

The last part, jk-1j=1, can be bounded from above by 2JN =K, which vanishes in the large N limit. The two remaining parts are symmetric, hence we treat only the case k-1>1. Since  $i2\ B_k$  and  $j2\ B_1$ , this implies that n(k-1-1)< i-j< n(k-1+1). Hence,

We would like to emphasize that throughout of this derivation, the only place where we use the Ising interaction of the model is where we bound J (1  $S_iS_j$ )=2 by J. It is then easy to realize that the method can be generalized to other models like Potts, B lume-Emery-G ri ths, XY, with spatially decaying interactions. On the contrary, the presence of the lattice is crucial, because it avoids microscopic congurations where the state variables concentrate on single point, leading to a divergence.

A ppendix D: Proof of stability of constant magnetization prolles for the -Ising model with periodic boundary conditions

We prove here the stability of constant magnetization proles for the —Ising model in the context of the canonical ensemble. This also implies stability in the microcanonical ensemble. Let us consider the free energy F[m(x)] as a functional of m(x)

Thus for  $< 2s^{(0)}(0) = (Jc_0) = c$ , one has  ${}^2F$  (m (x)) > 0. In such a case, the free energy is strictly convex, and hence its m in im um is unique. This proves the global stability of the state m (x) = 0.

For > c, we do not study global stability. Let us however show the local stability of the uniform magnetization state m  $(x) = m \cdot U \sin q Eq. (104)$ , one has

U sing again the property  $c_k$   $c_0$ , we note that all the Fourier coe cients of Eq. (108) are bounded from above by  $s^0$  (m)  $Jc_0=2$ . Observing that this latter expression is the second variation of the free energy for uniform m agnetization pro les, i.e.  $(1 \text{ m}^2 \text{ ()})^1 = c$ , the analysis of Section IV in plies that this quantity is non negative both form 60 and  $c_0$  and form  $c_0$  and  $c_0$ . This proves that close to a constant magnetization pro le, there is no non uniform magnetization pro le which gives a smaller free energy functional F [m (x)].
